FIG. 7 is a perspective view of the bookmark and glasses holder in a position of use.

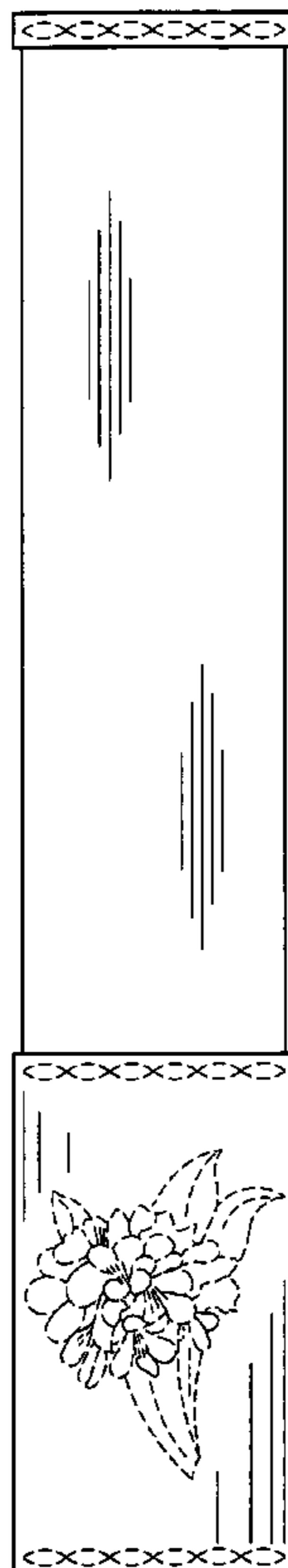
The broken lines shown in the drawings represent unclaimed portions of the combination bookmark and glasses case and also represent environmental structure and form no part of the claimed design.

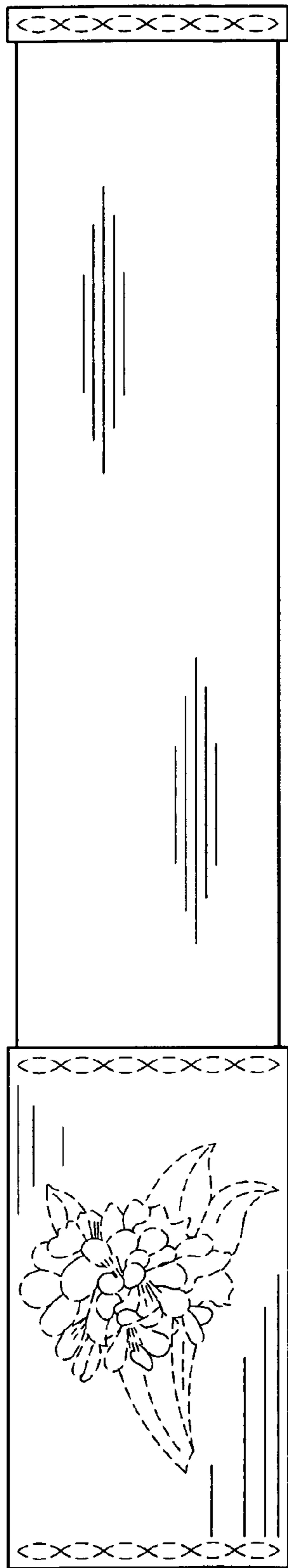

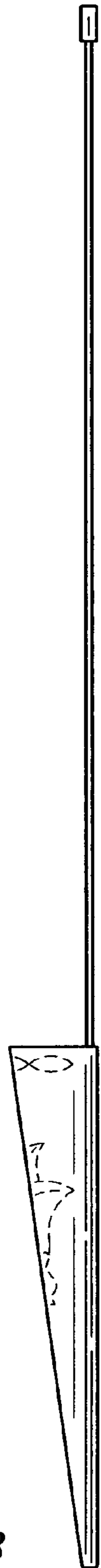

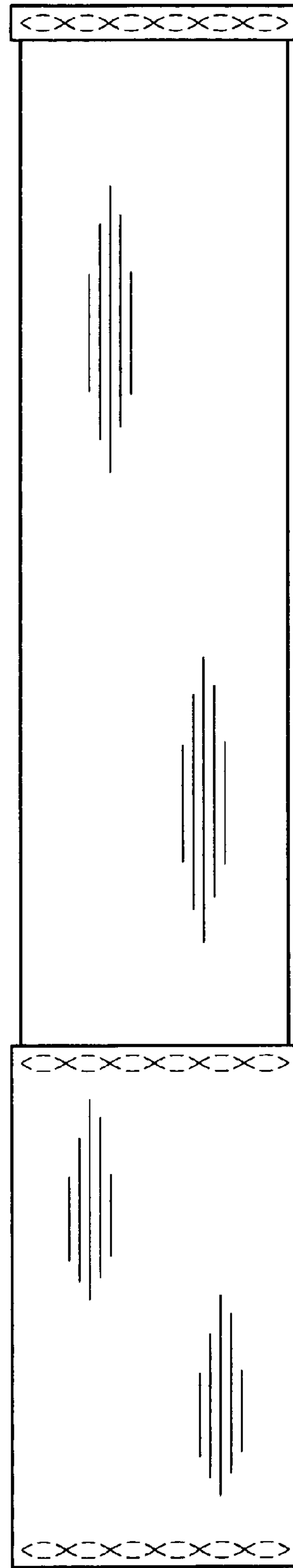

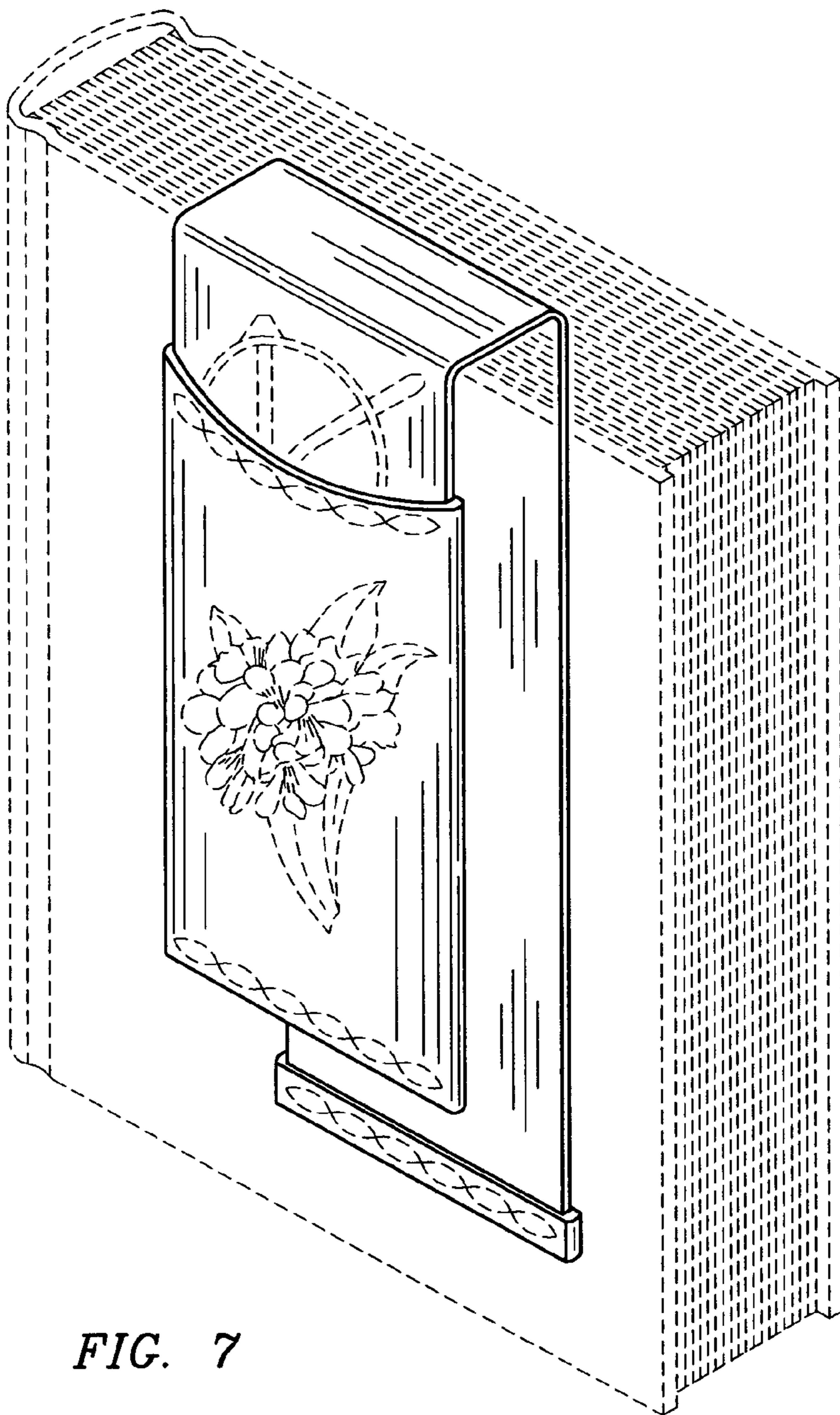

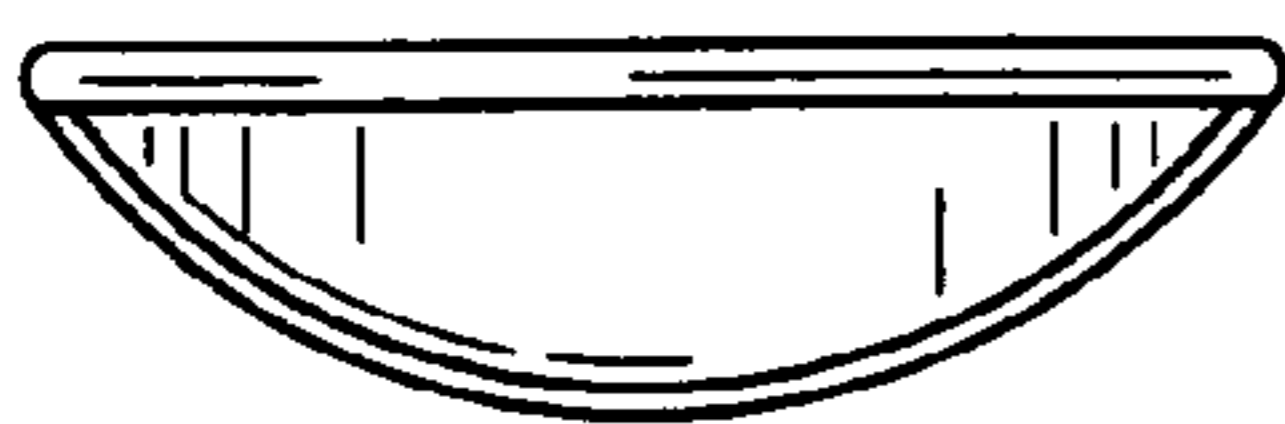

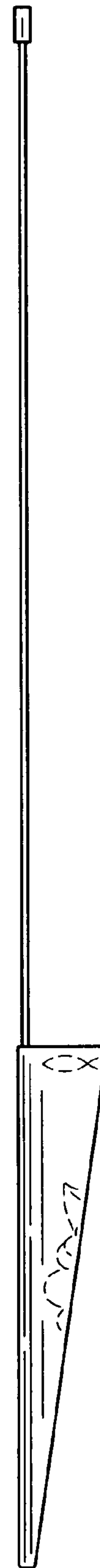
