DESCRIPTION

FIG. 1 is a perspective view of a slender action figure showing an embodiment of our new design;

FIG. 2 is a front view of a slender action figure in an alternate position;

FIG. 3 is a back view of the slender action figure of FIG. 2;

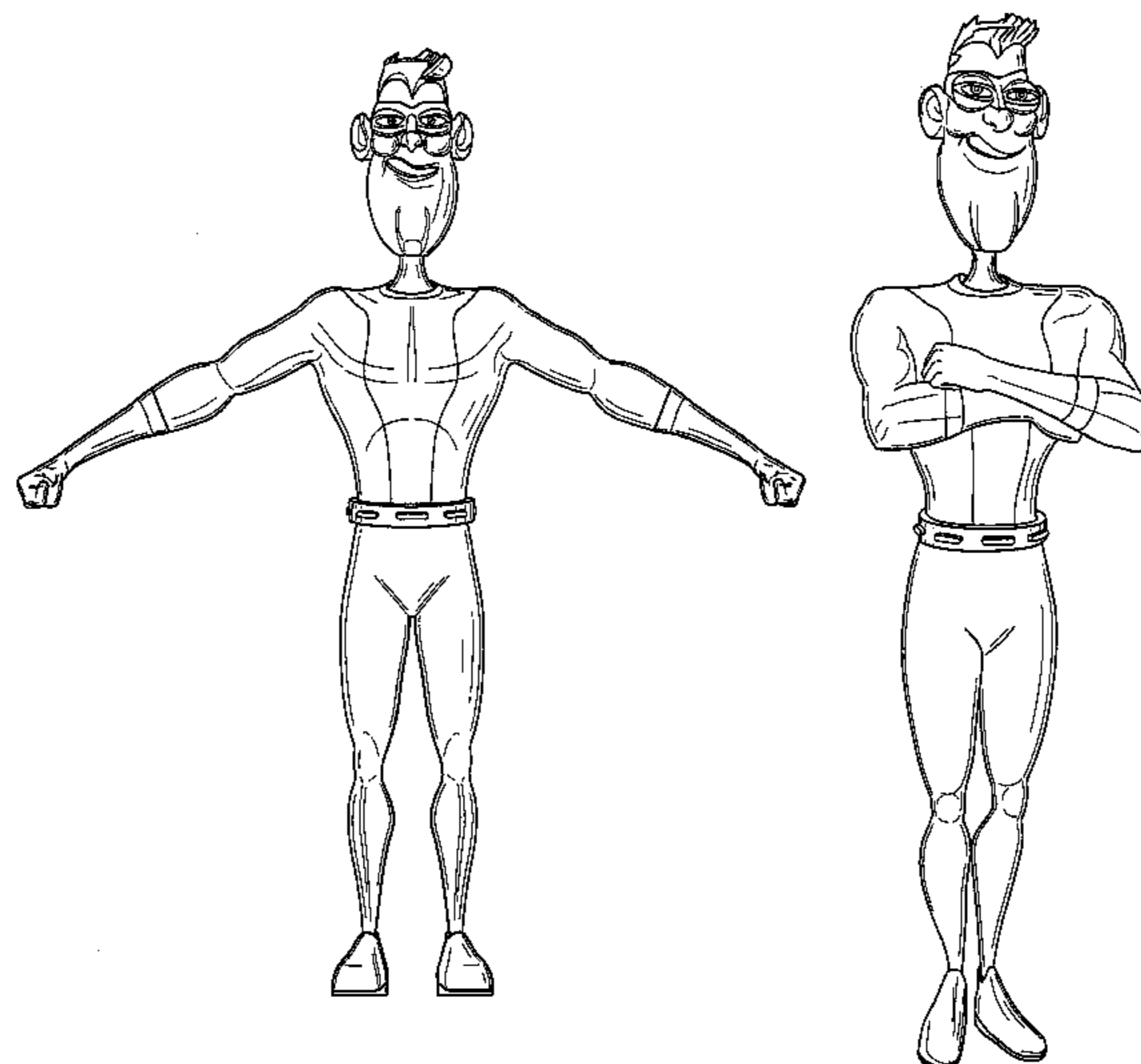
FIG. 4 is a left side view of the slender action figure of FIG. 2;

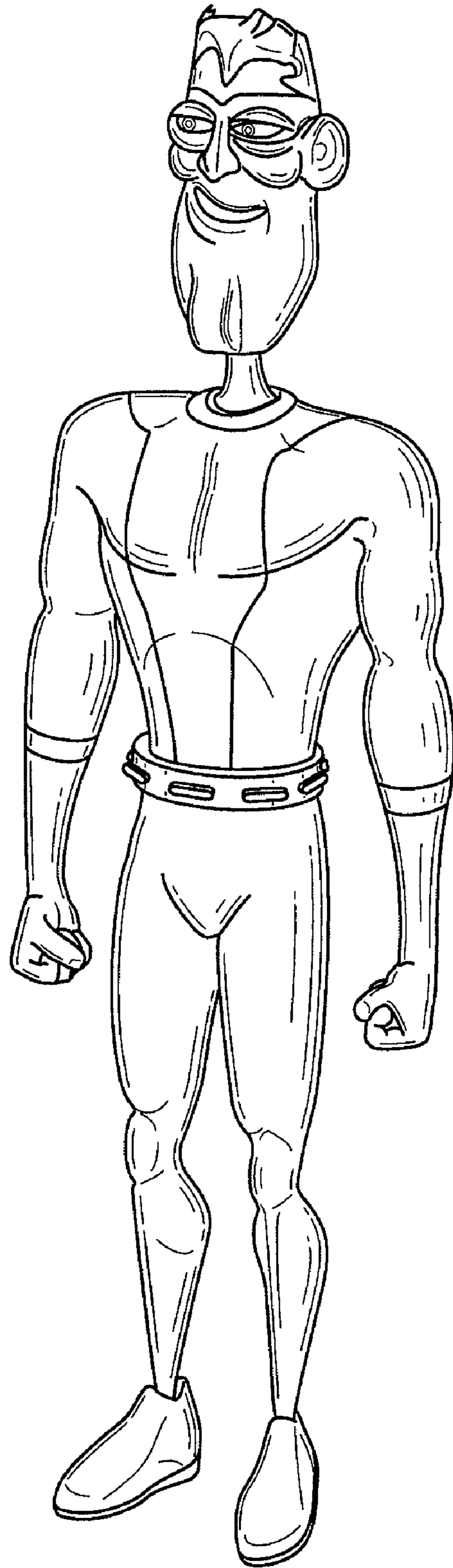

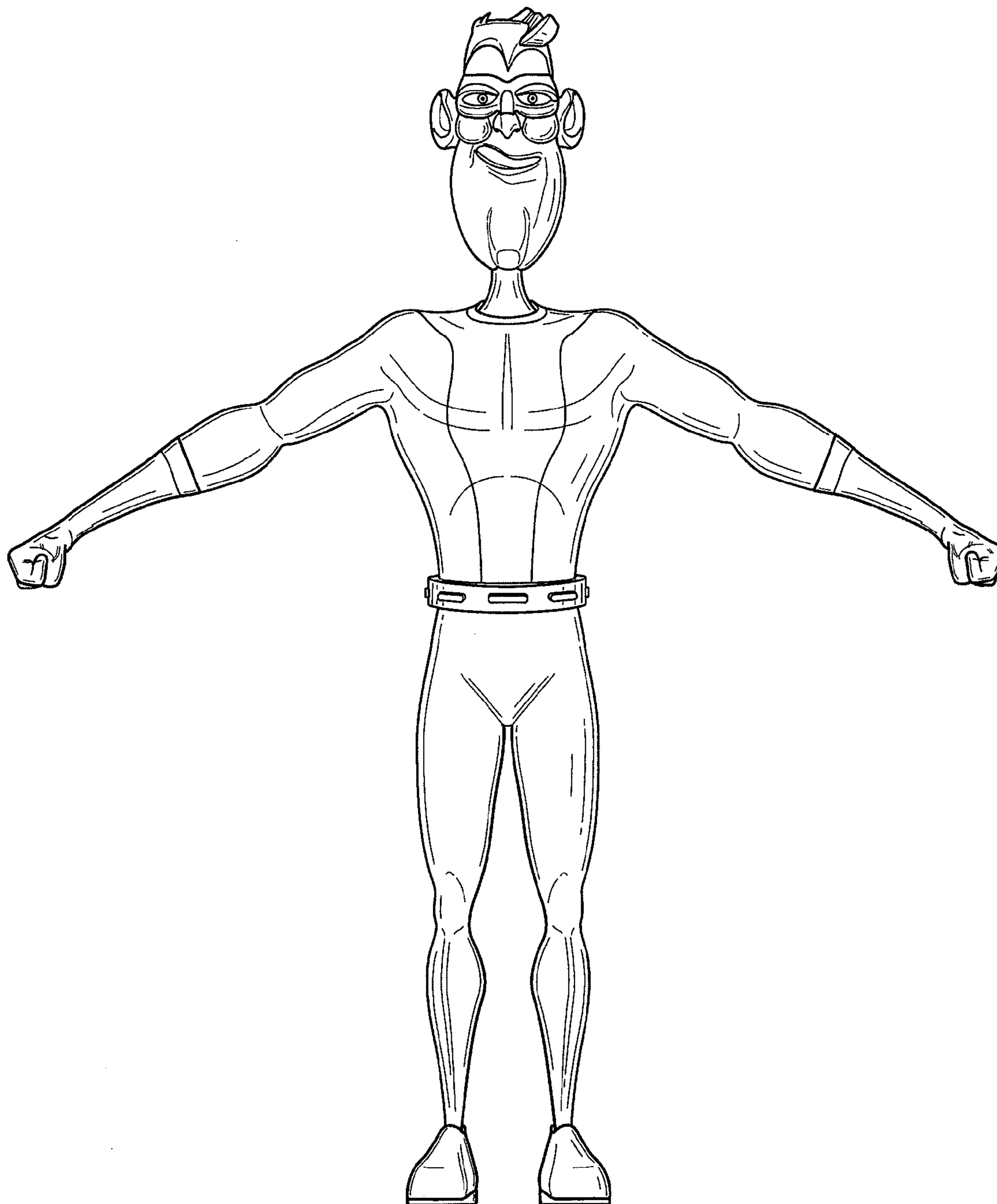

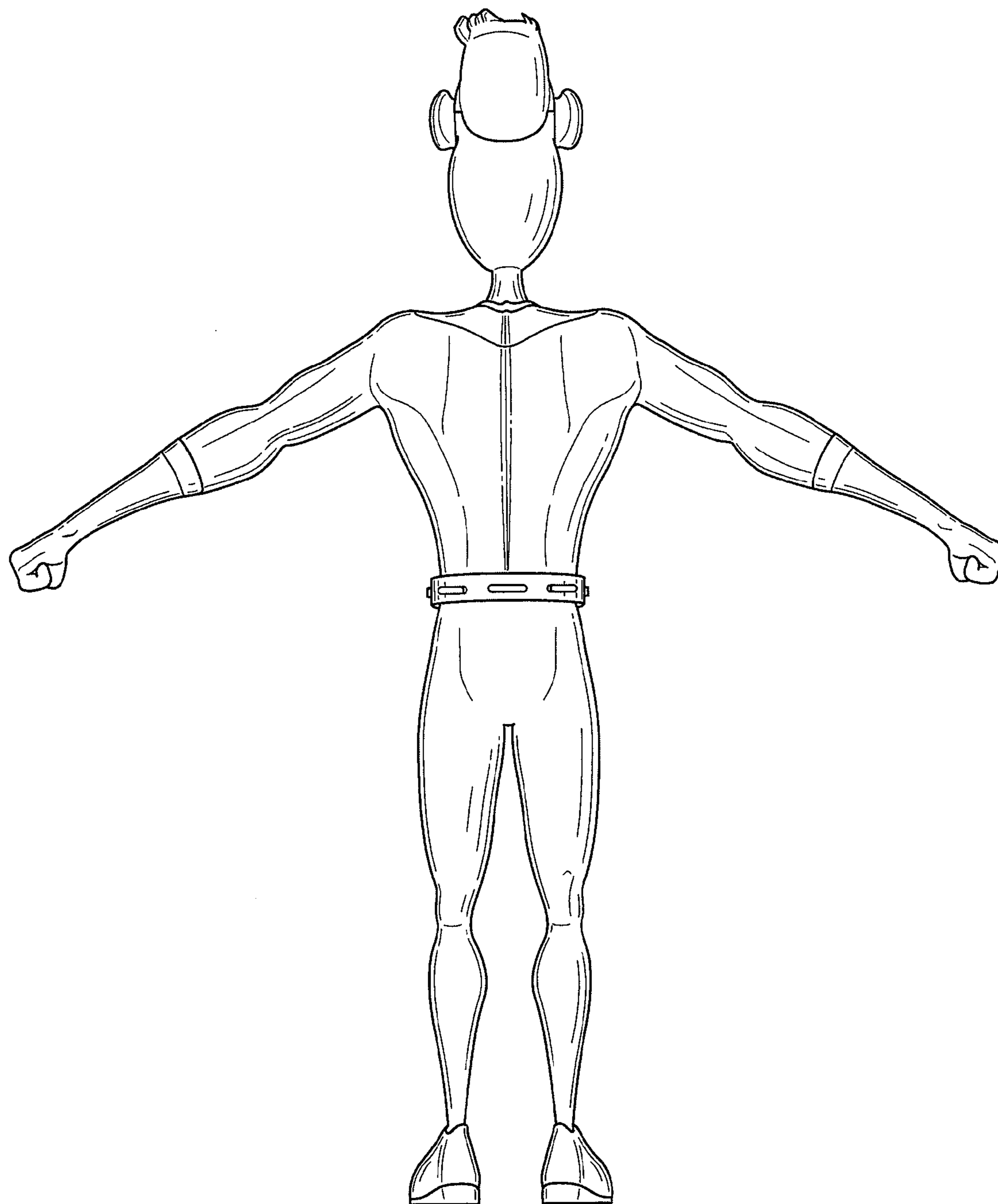

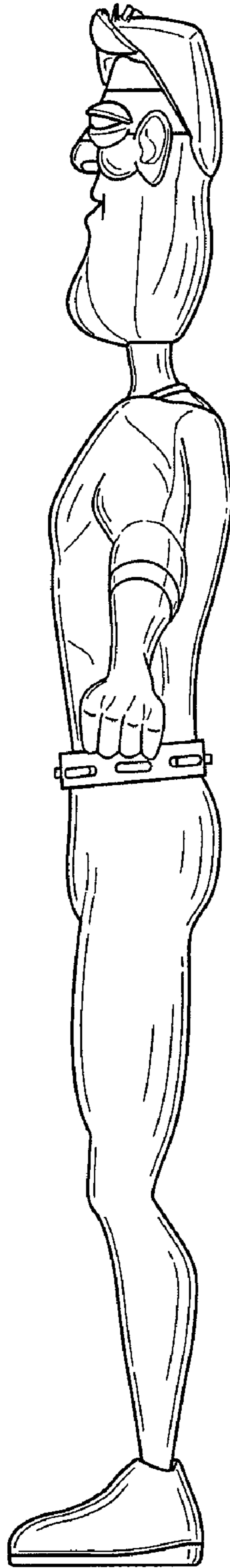

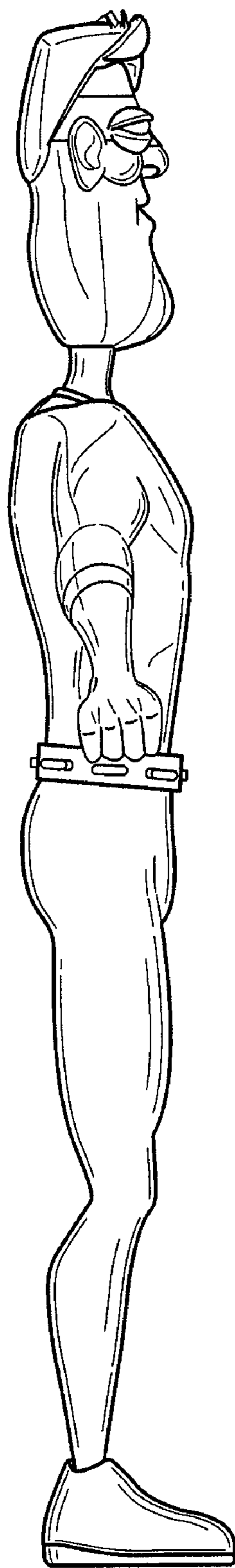

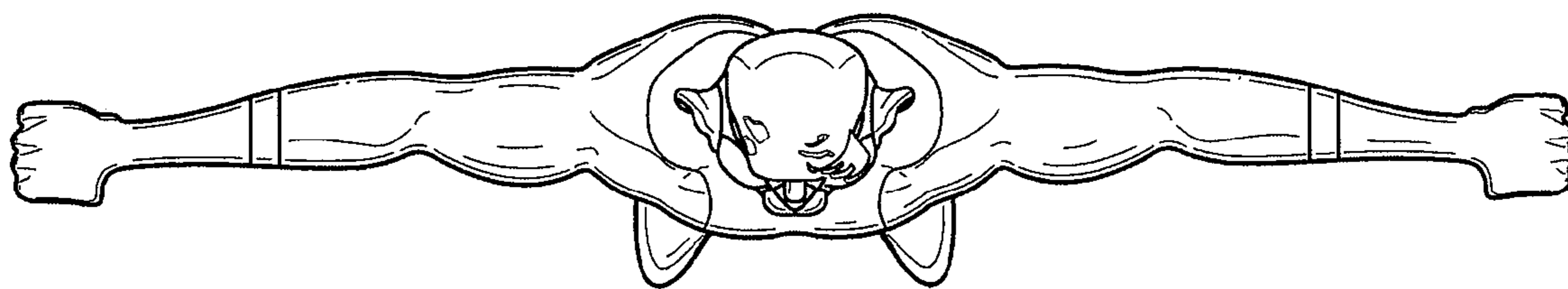

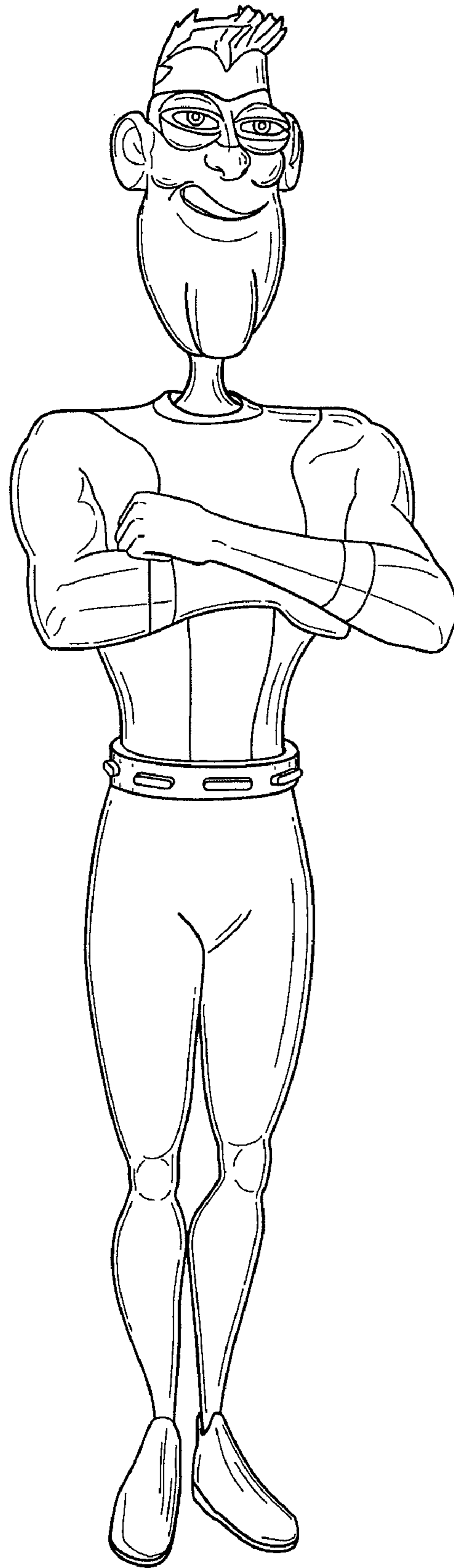
