FIG. 7 is a rear view thereof.

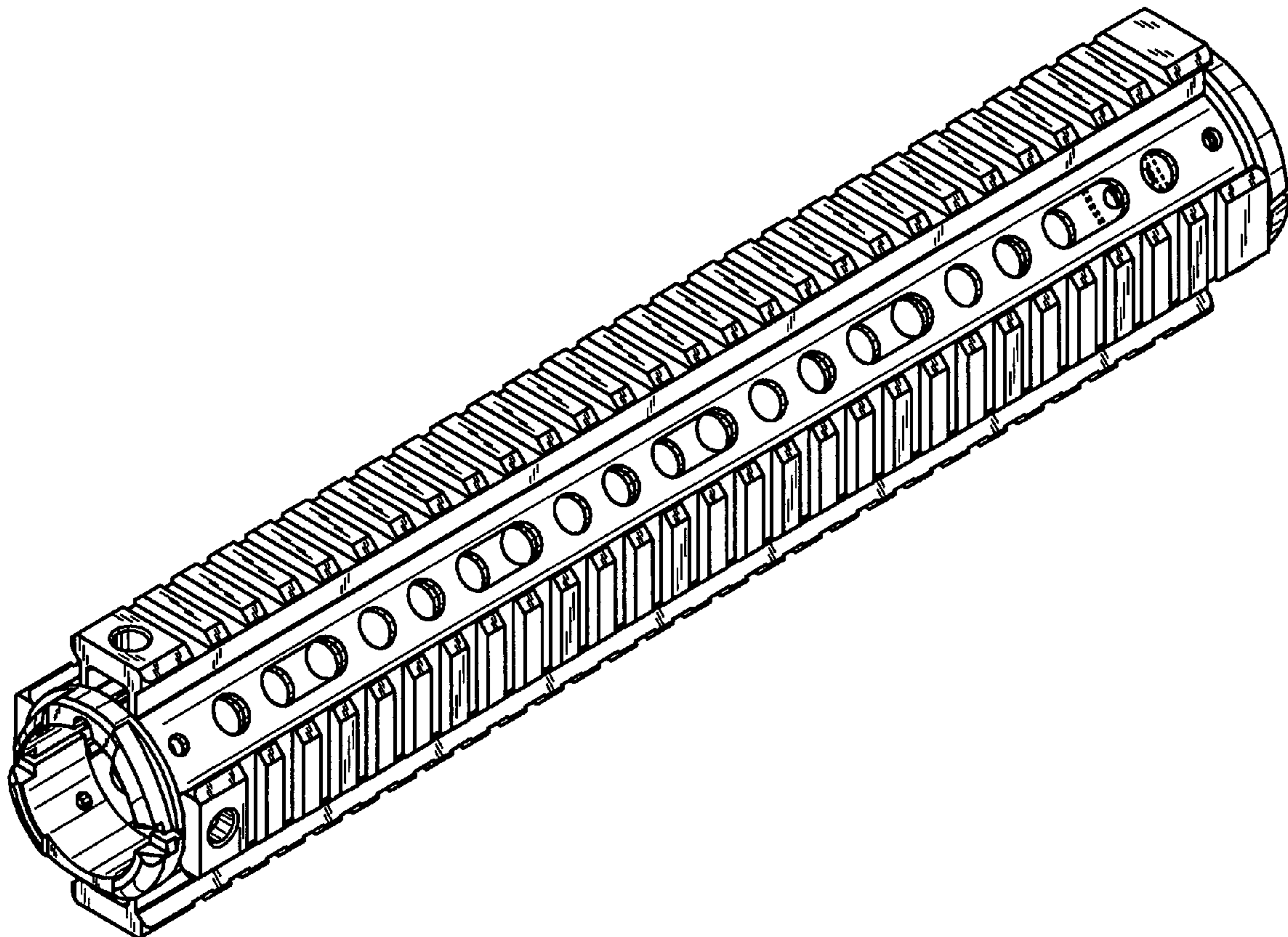
The broken line showing of portions of the rifle rail handguard with oblong cross section in FIGS. 1, 2, 4, 5 and 7 forms no part of the claimed design.

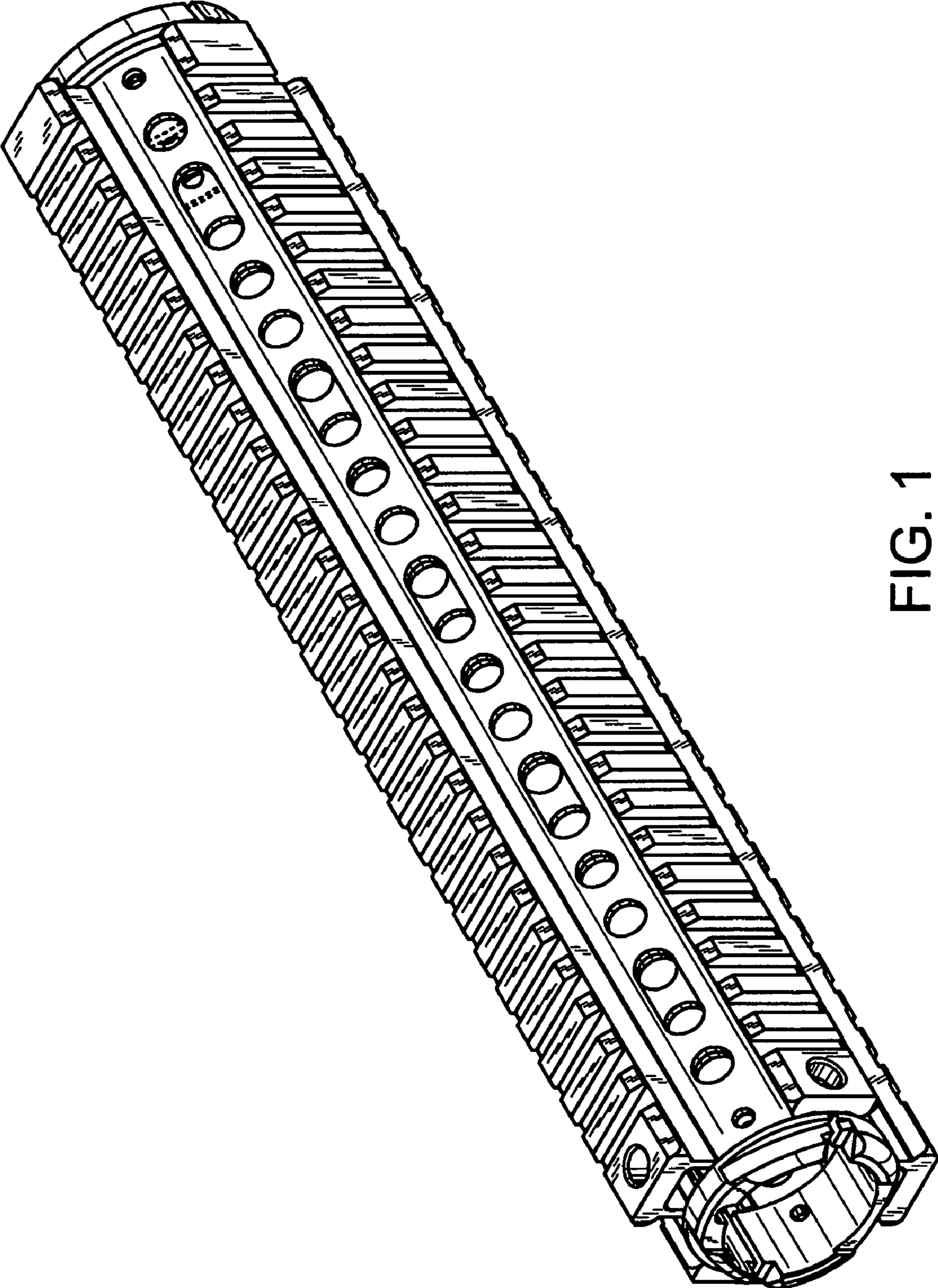

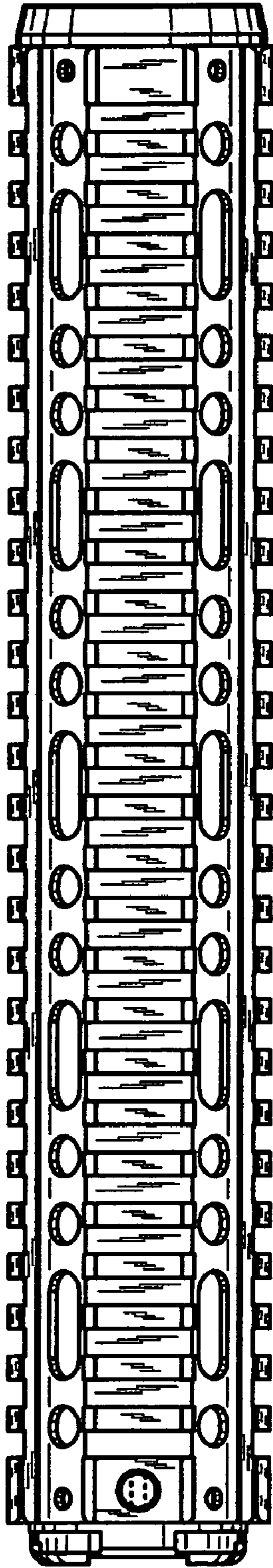

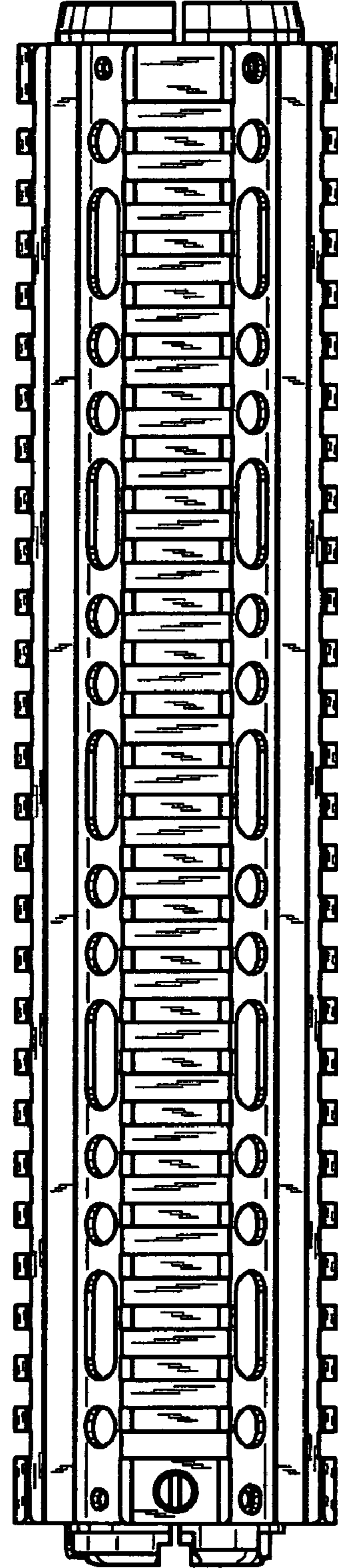

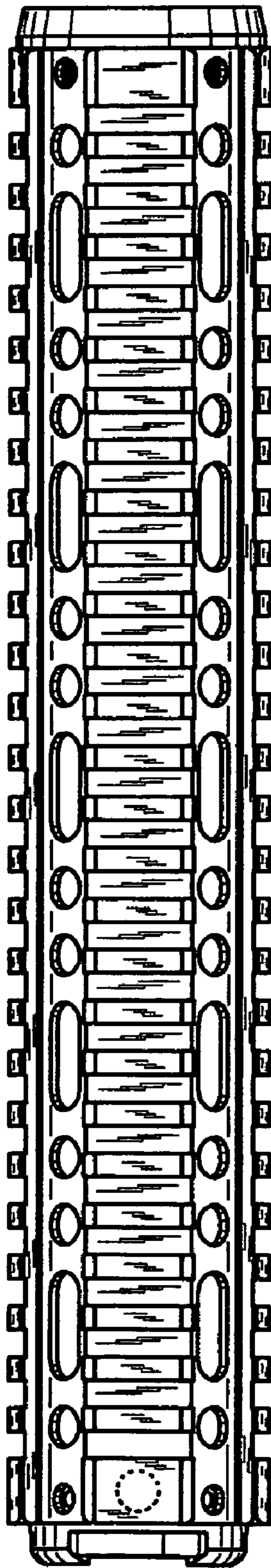

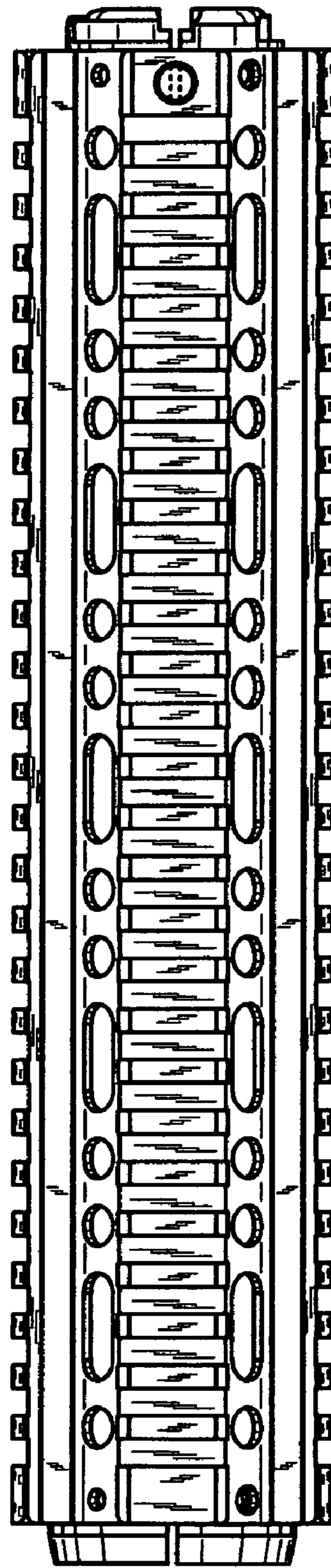

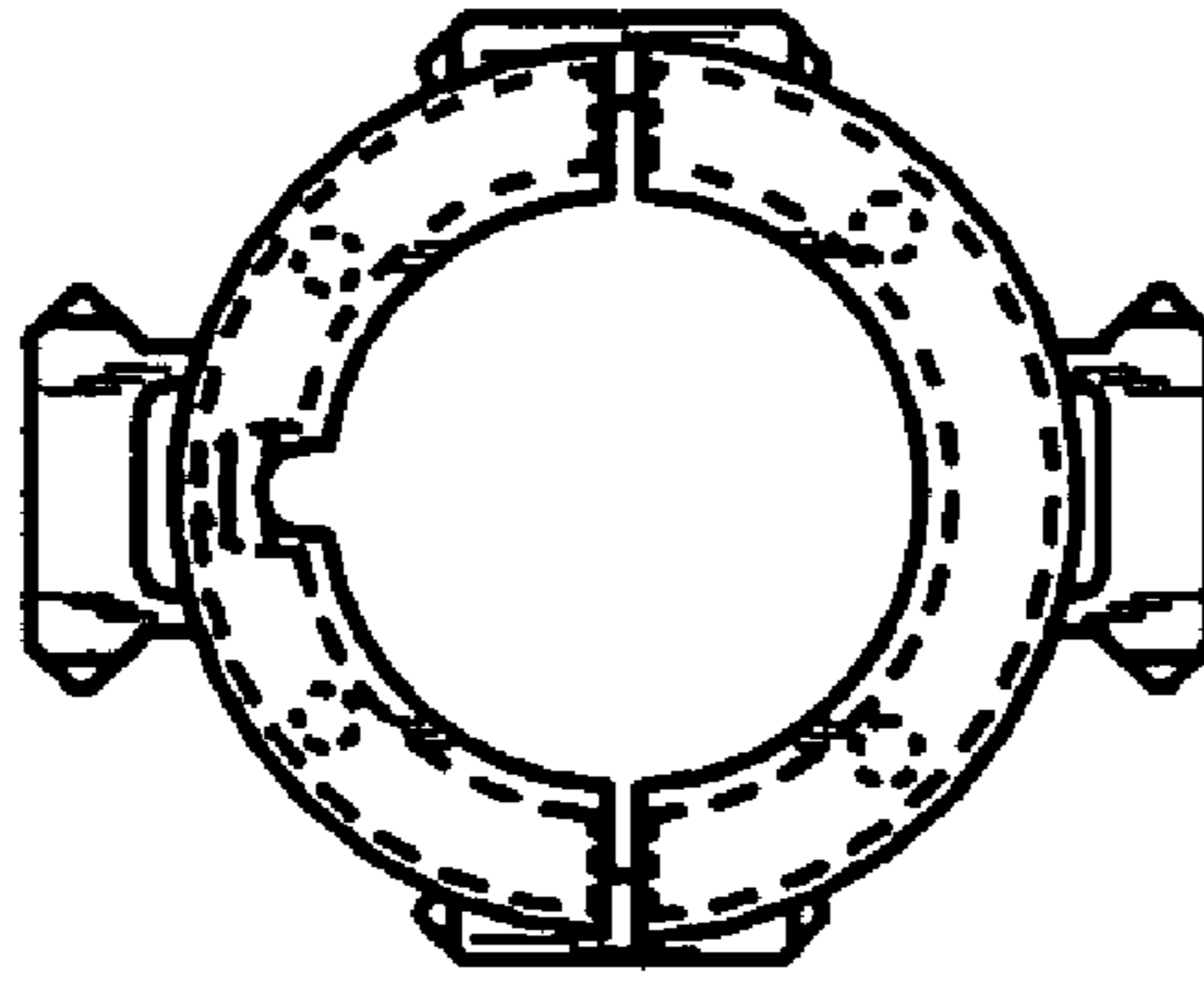

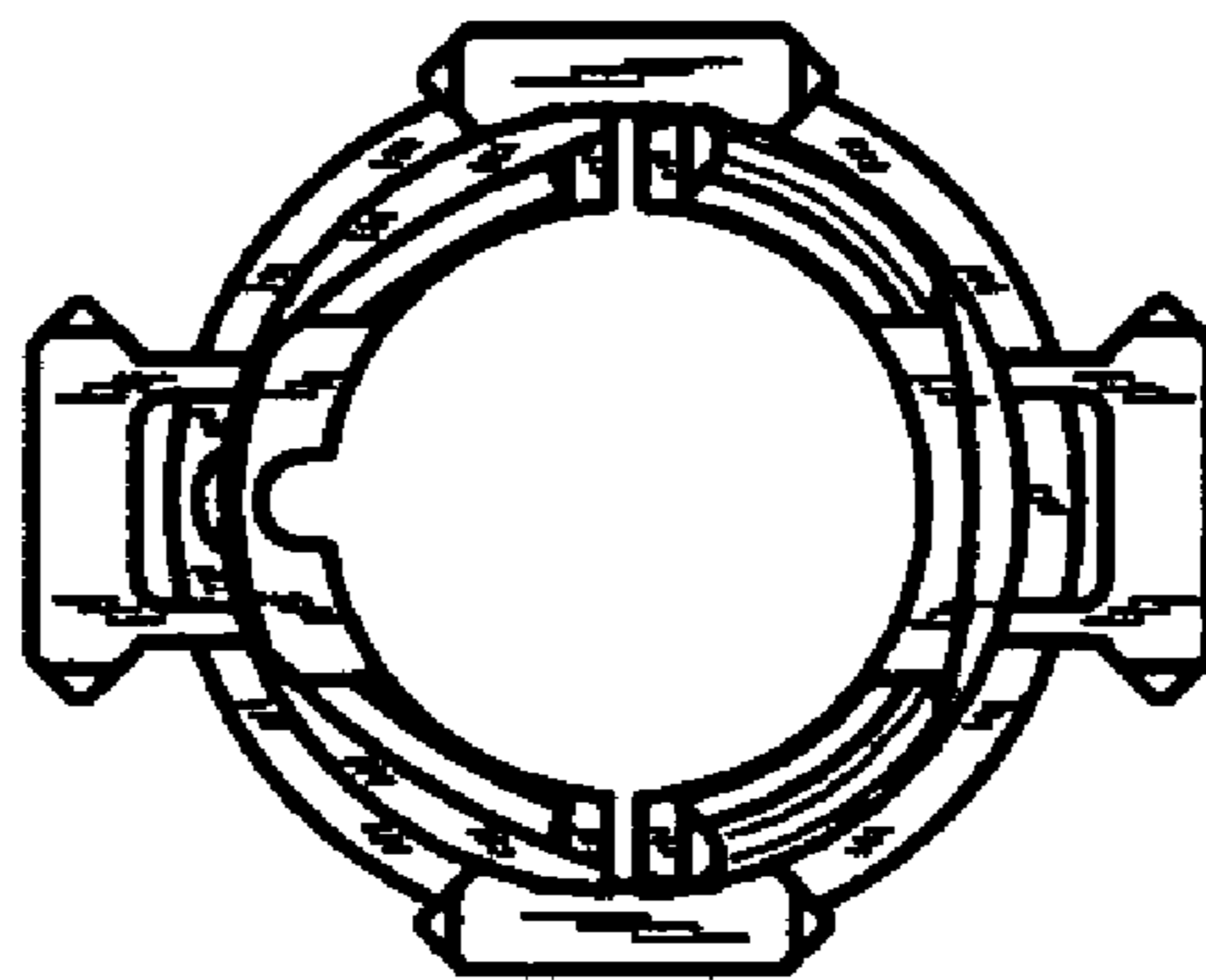
