FIG. 3 is a front elevation view thereof;

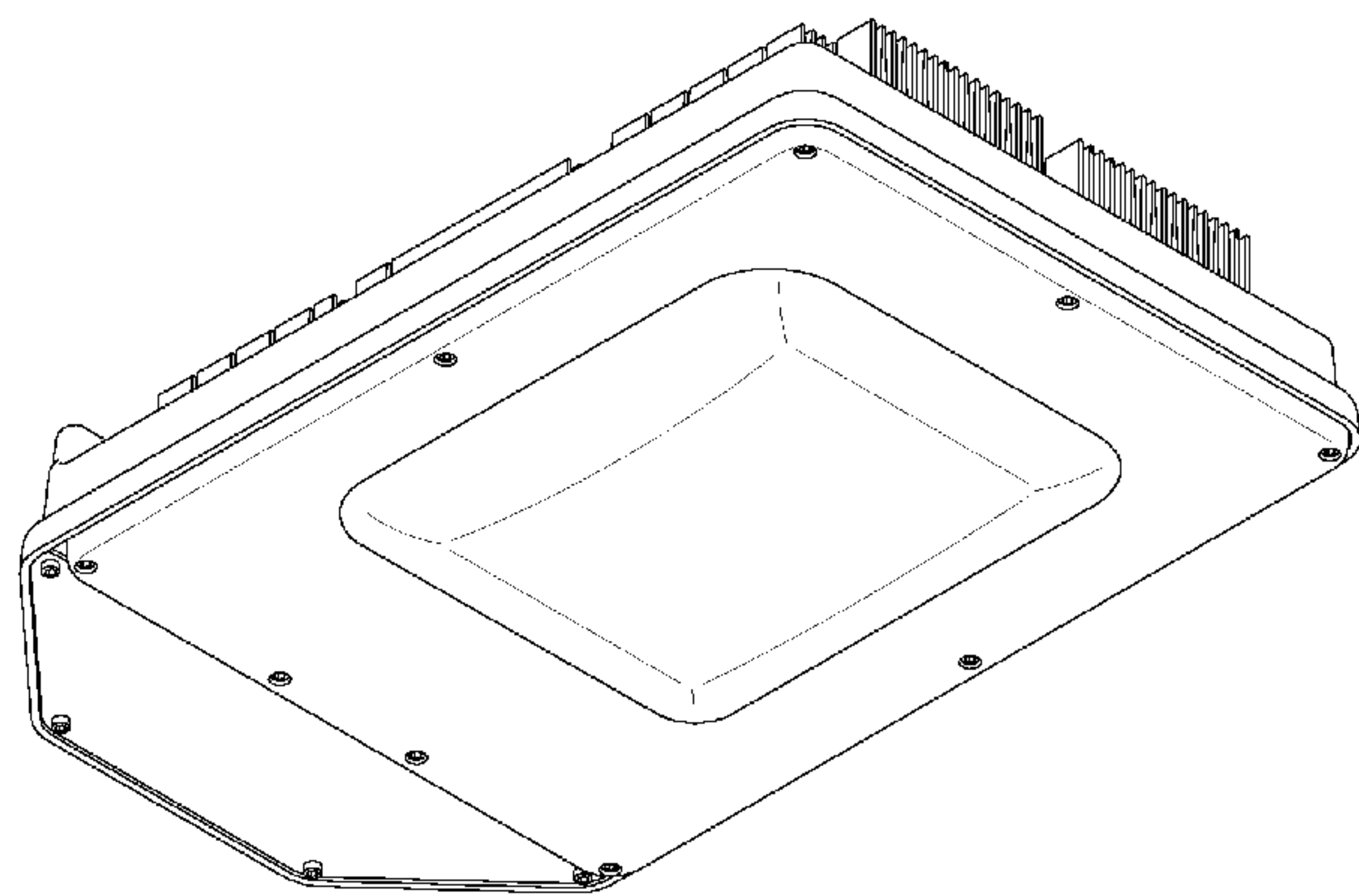
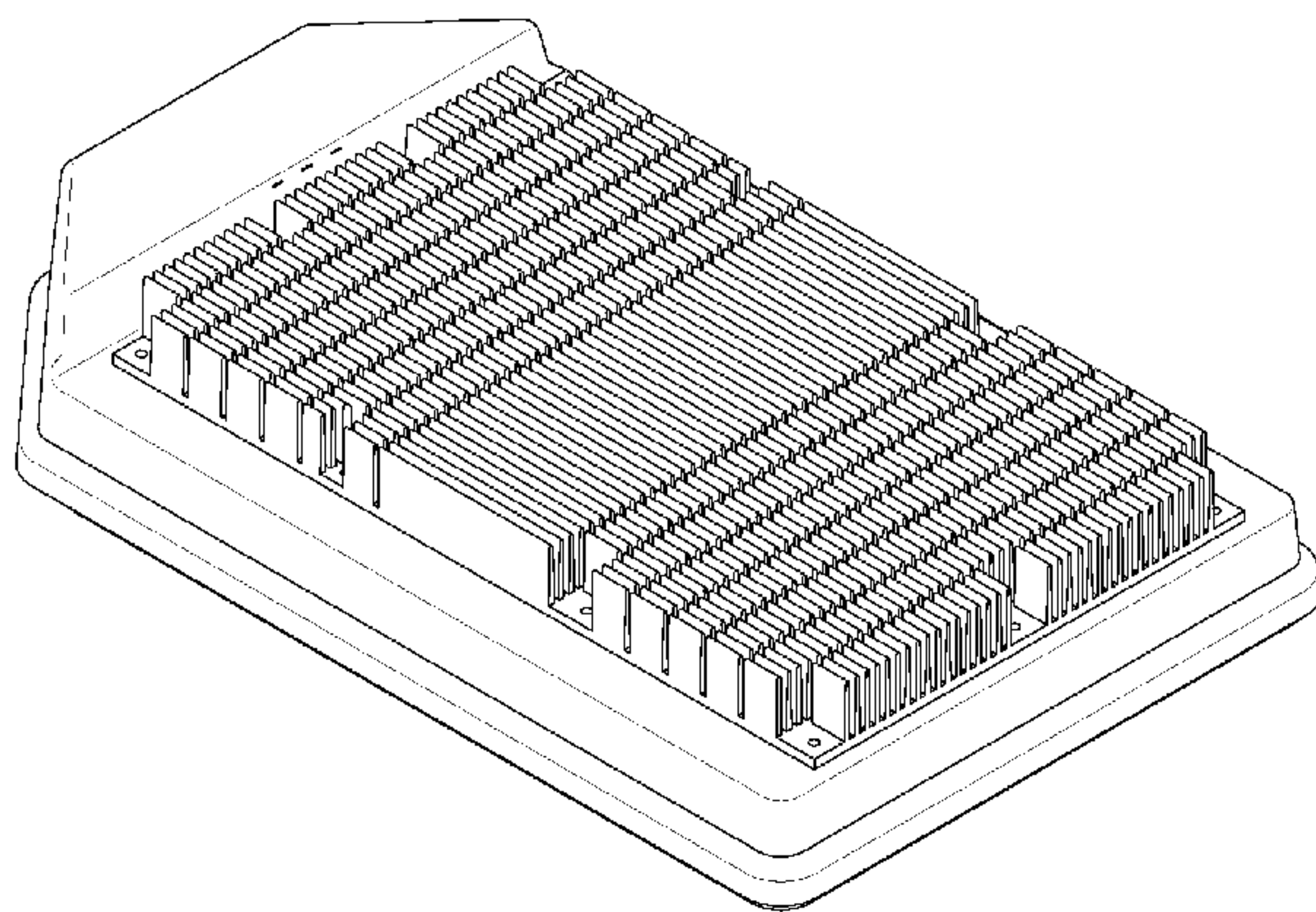
FIG. 4 is a rear elevation view thereof, wherein the broken lines illustrate portions of the illuminating Apparatus that form no part of the claimed design;

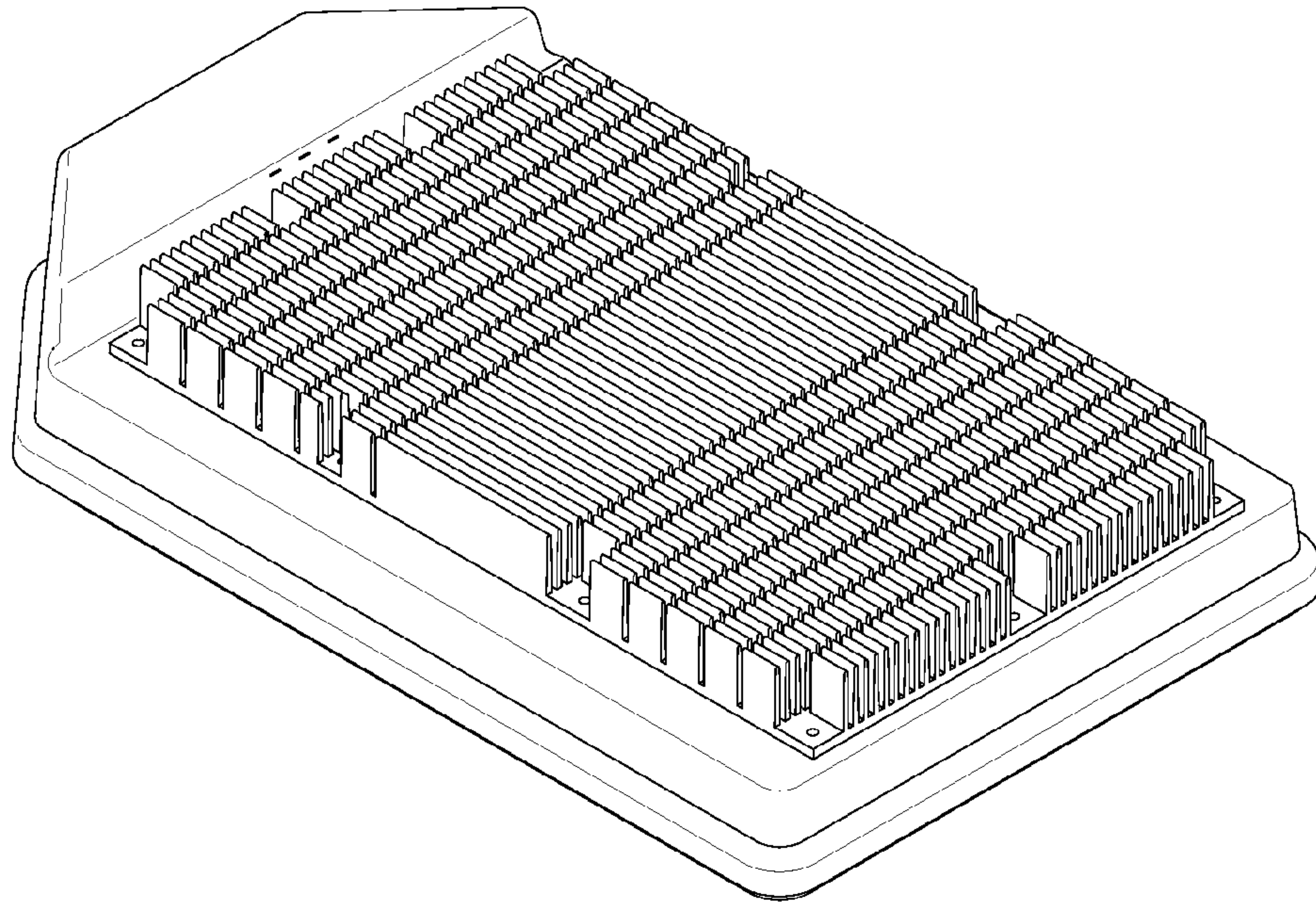

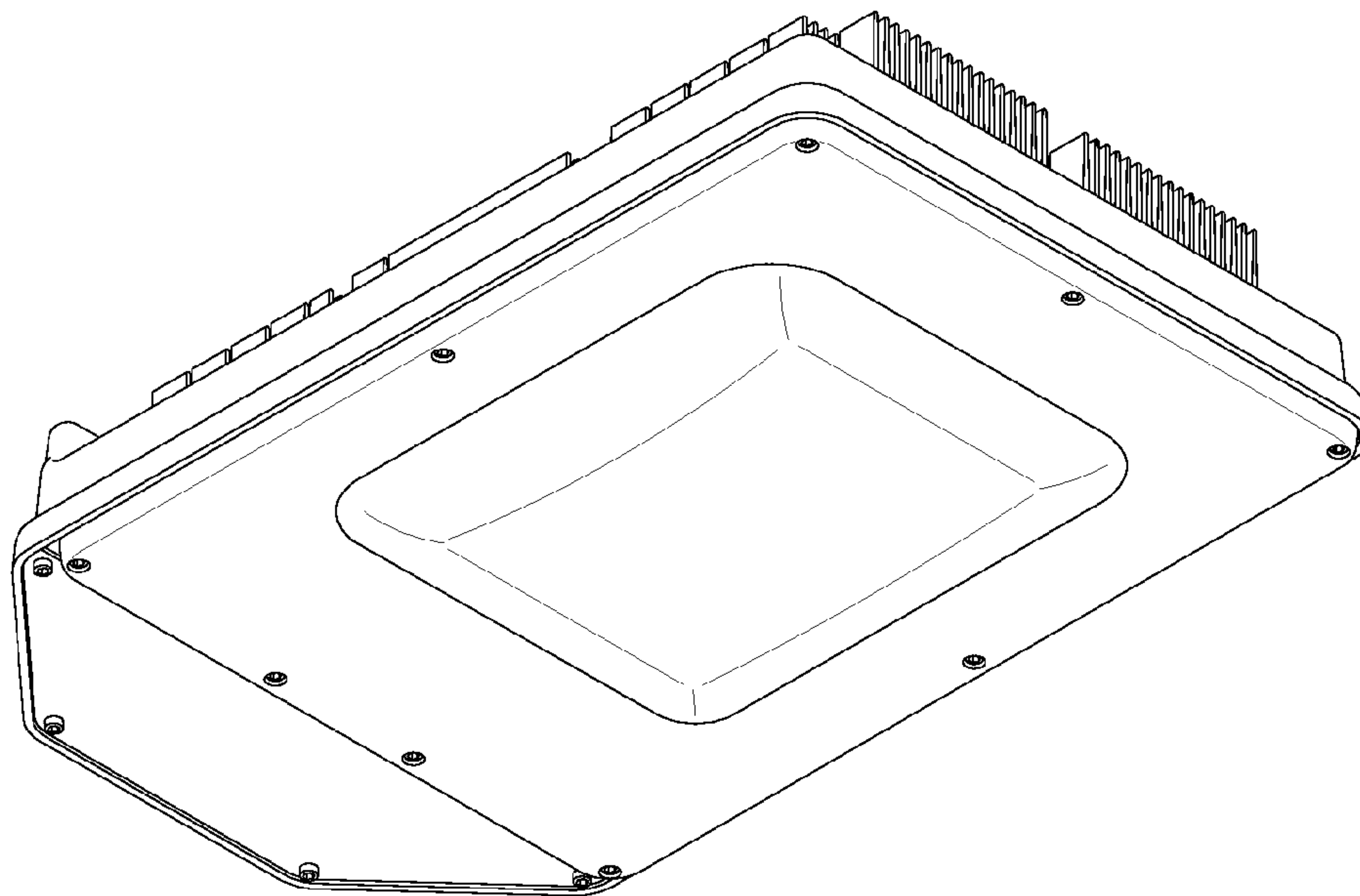

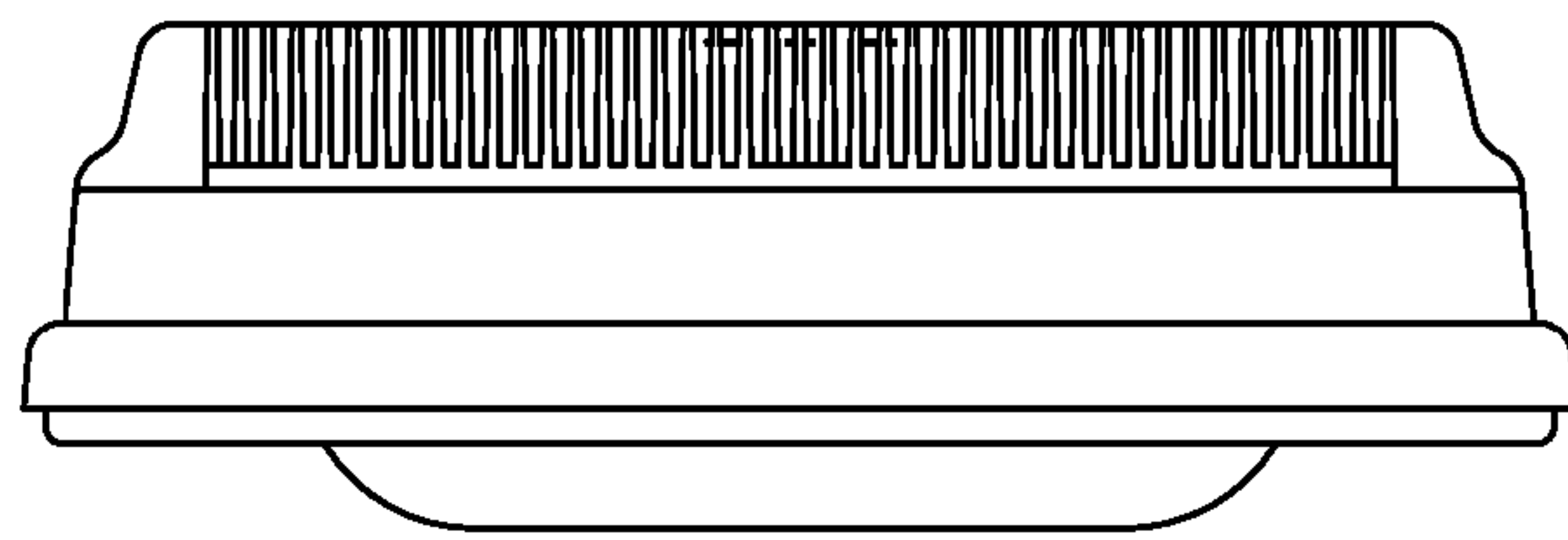

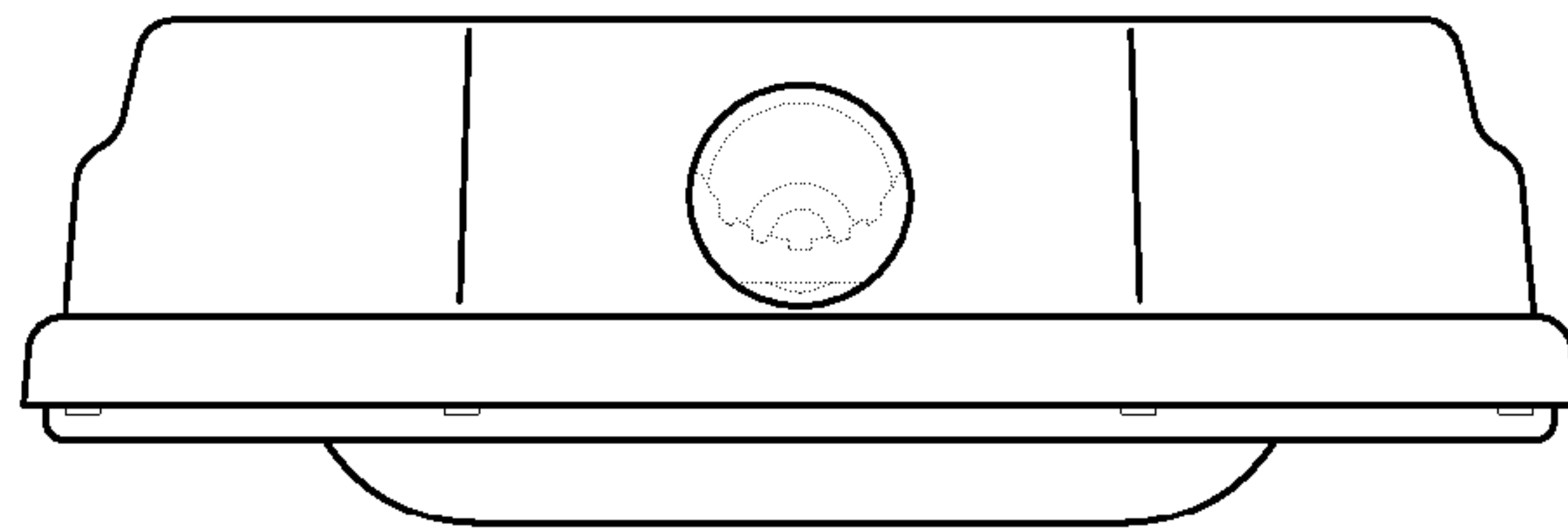

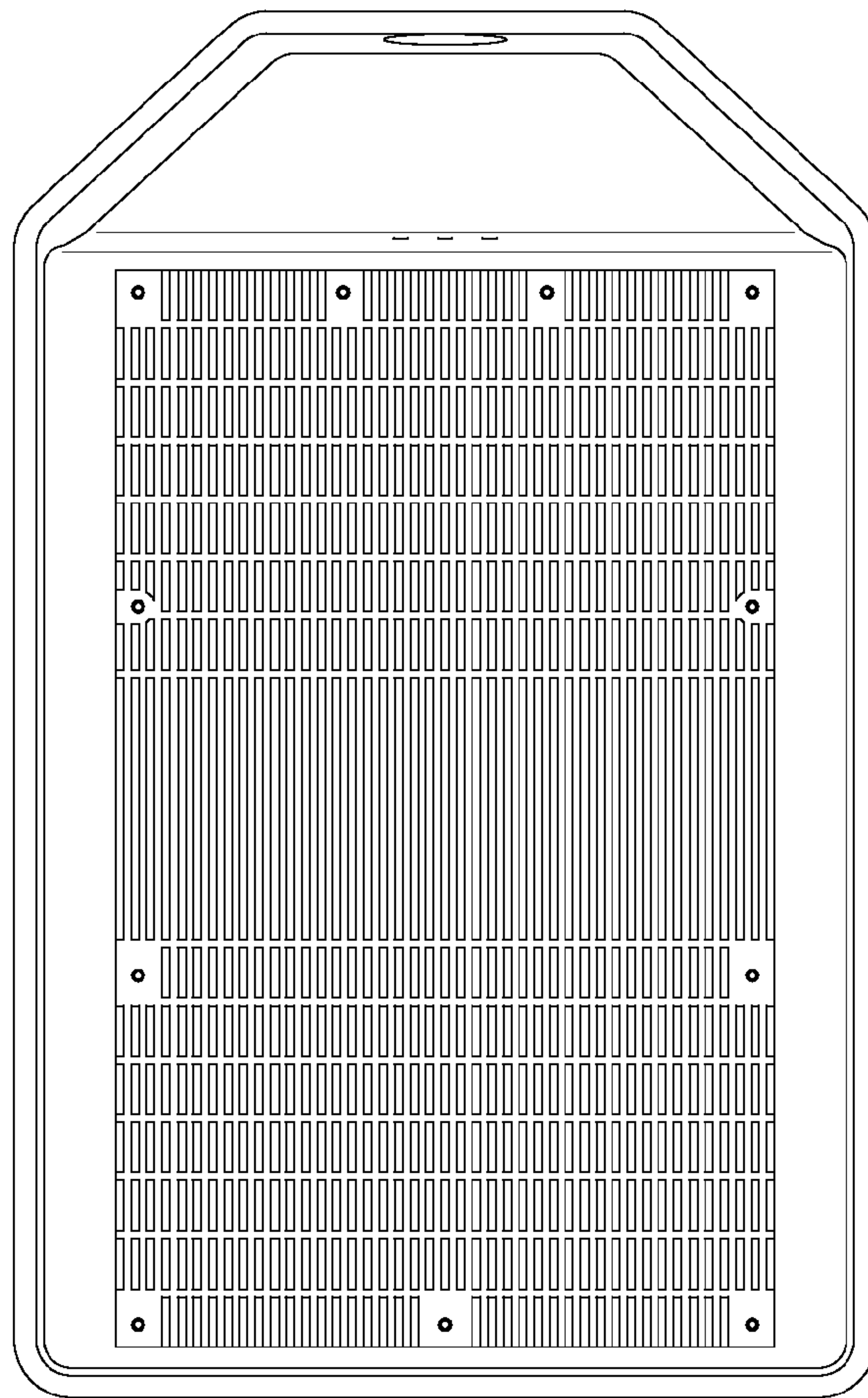

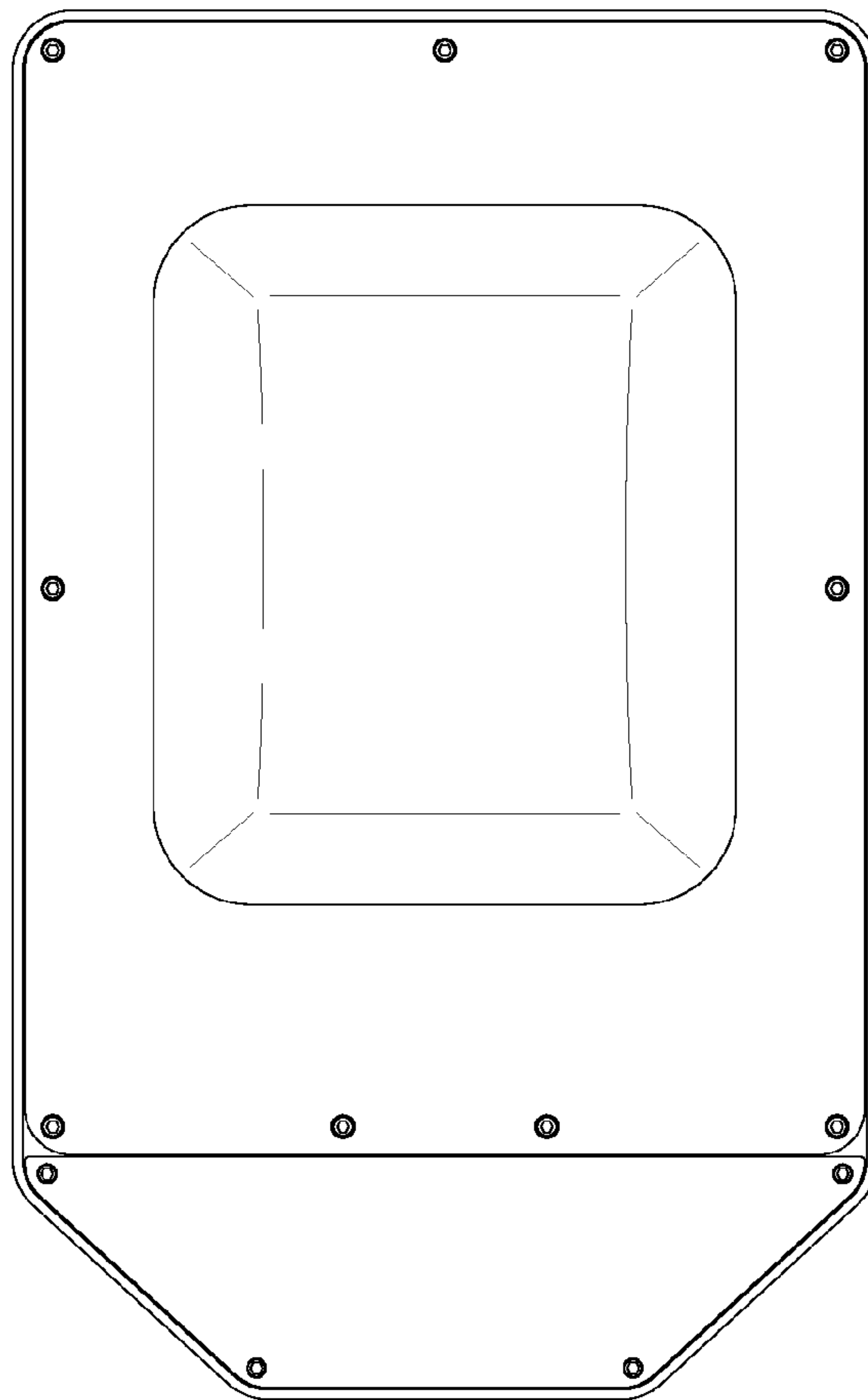

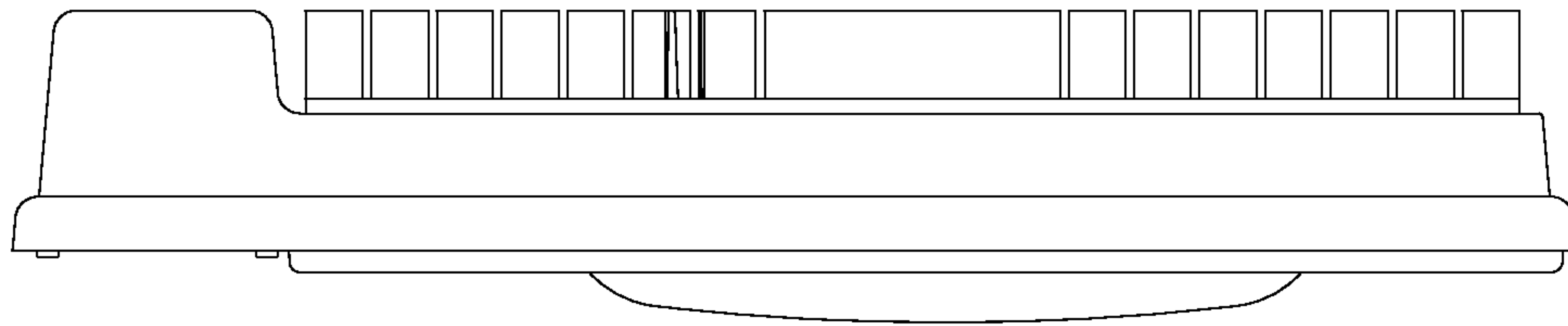
