The ornamental design for a pet collar with embedded reflectors, as shown and described.

**DESCRIPTION**

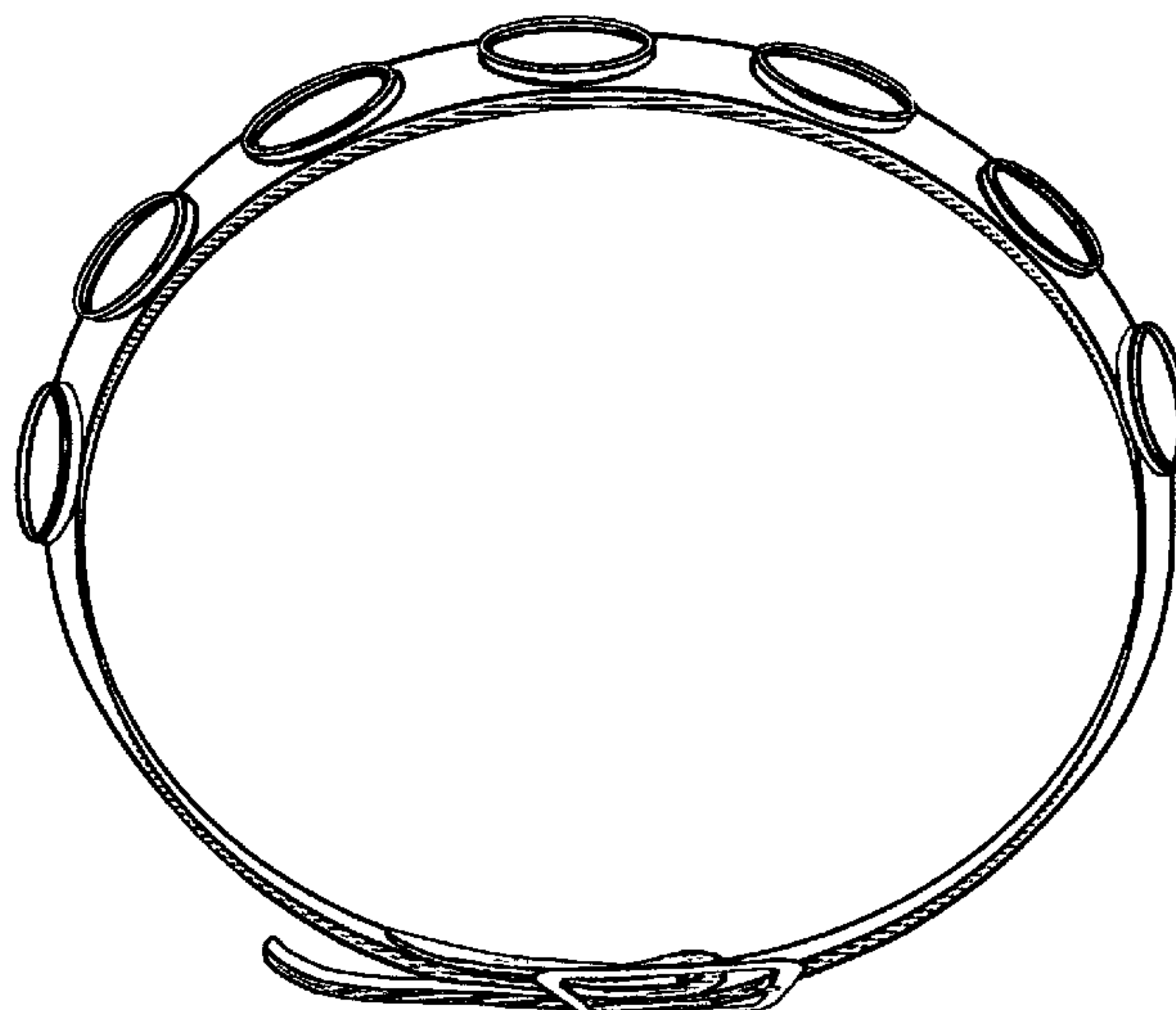
FIG. 1 is a front elevational view of a pet collar with embedded reflectors, showing my new design;

FIG. 2 is a top view thereof; and,

FIG. 3 is a perspective view of the pet collar with embedded reflectors shown in position around a dog's neck with the strap portion pointed downward. The broken line showing of a canine is for environmentally illustrative purposes only and is not claimed.

This ornamental design is for a pet collar with embedded reflectors. The intended use is for pets to wear, either during the day or night, so that they may be more easily seen due to the embedded reflectors.

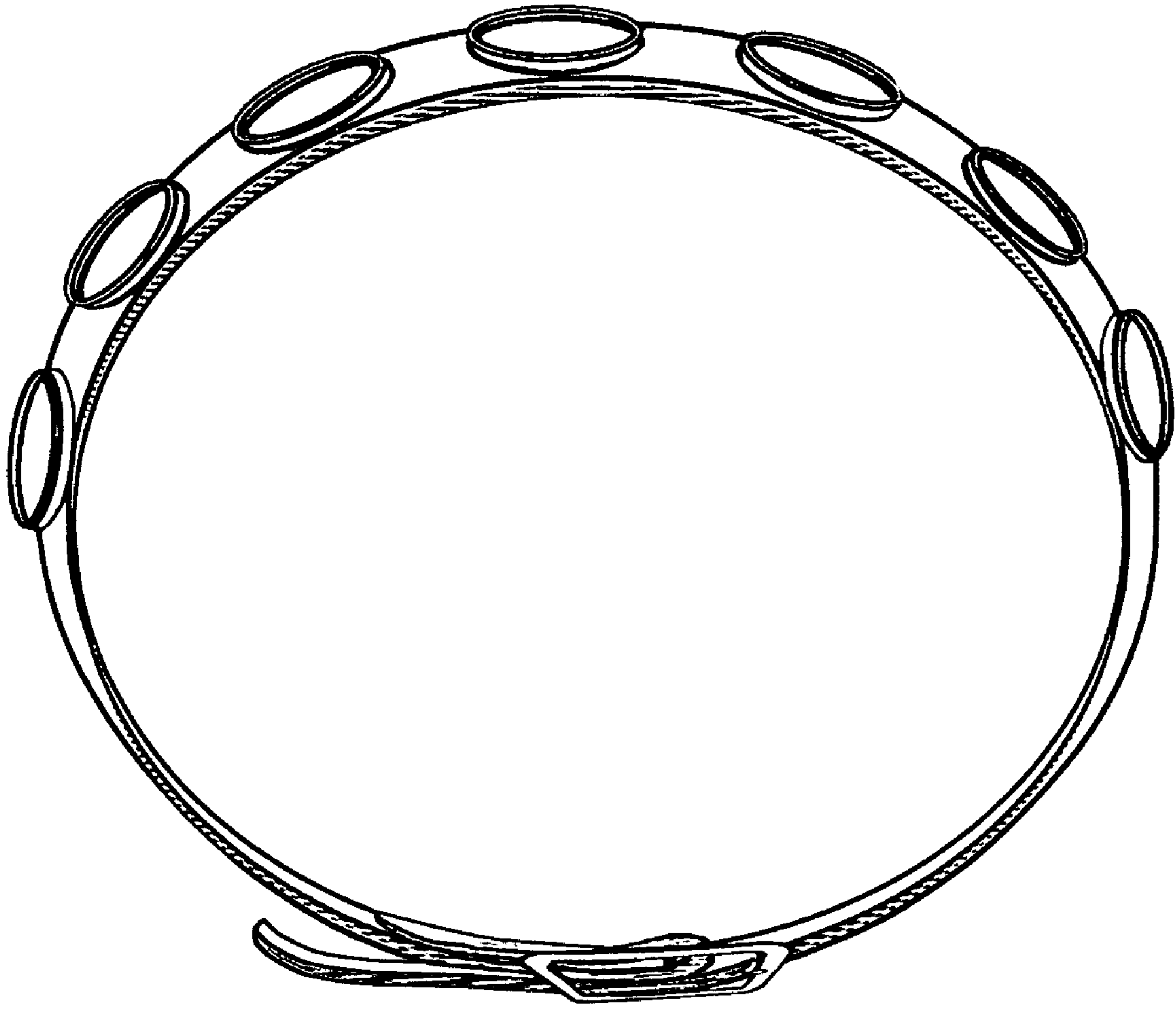

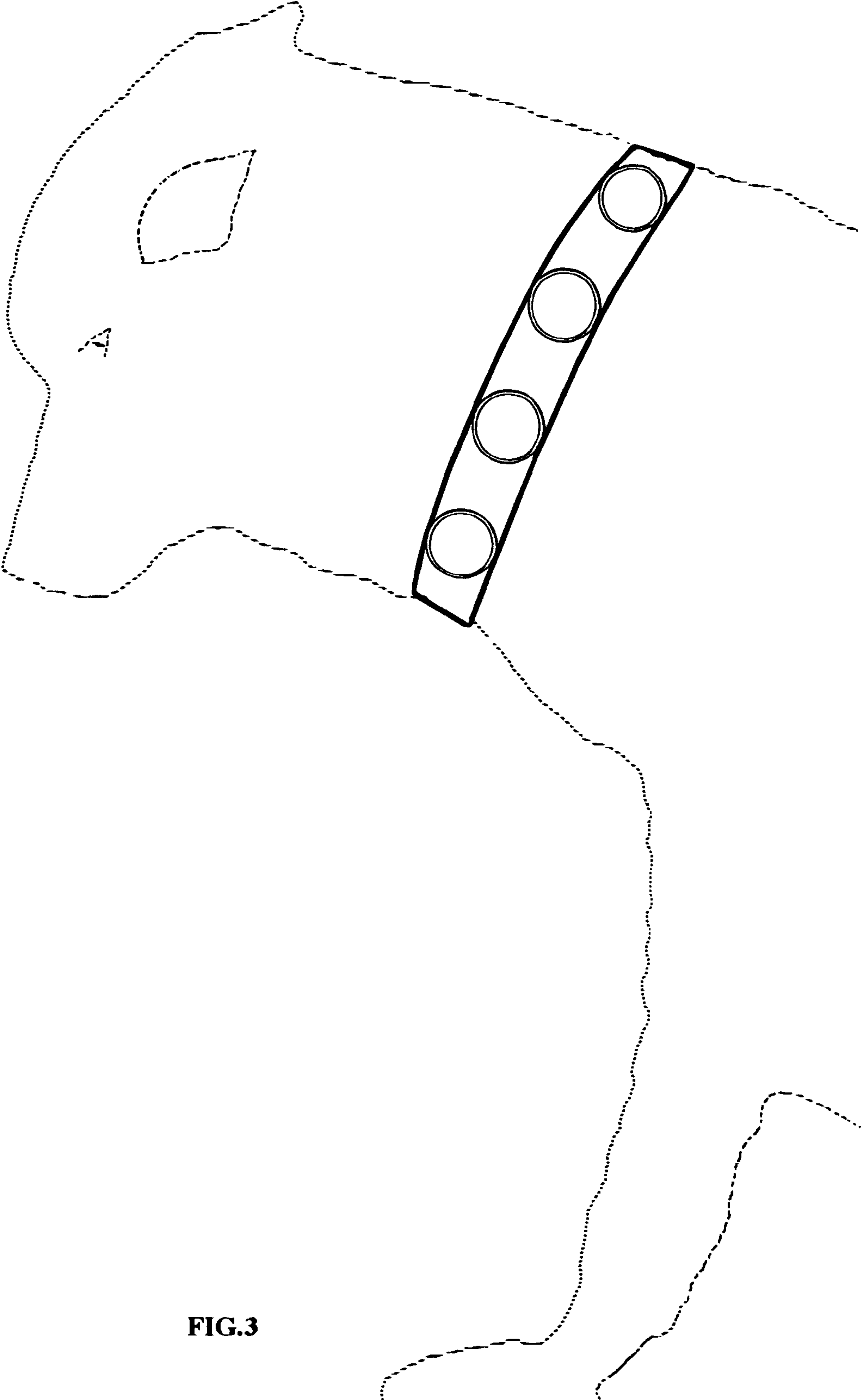
