(57) **CLAIM**

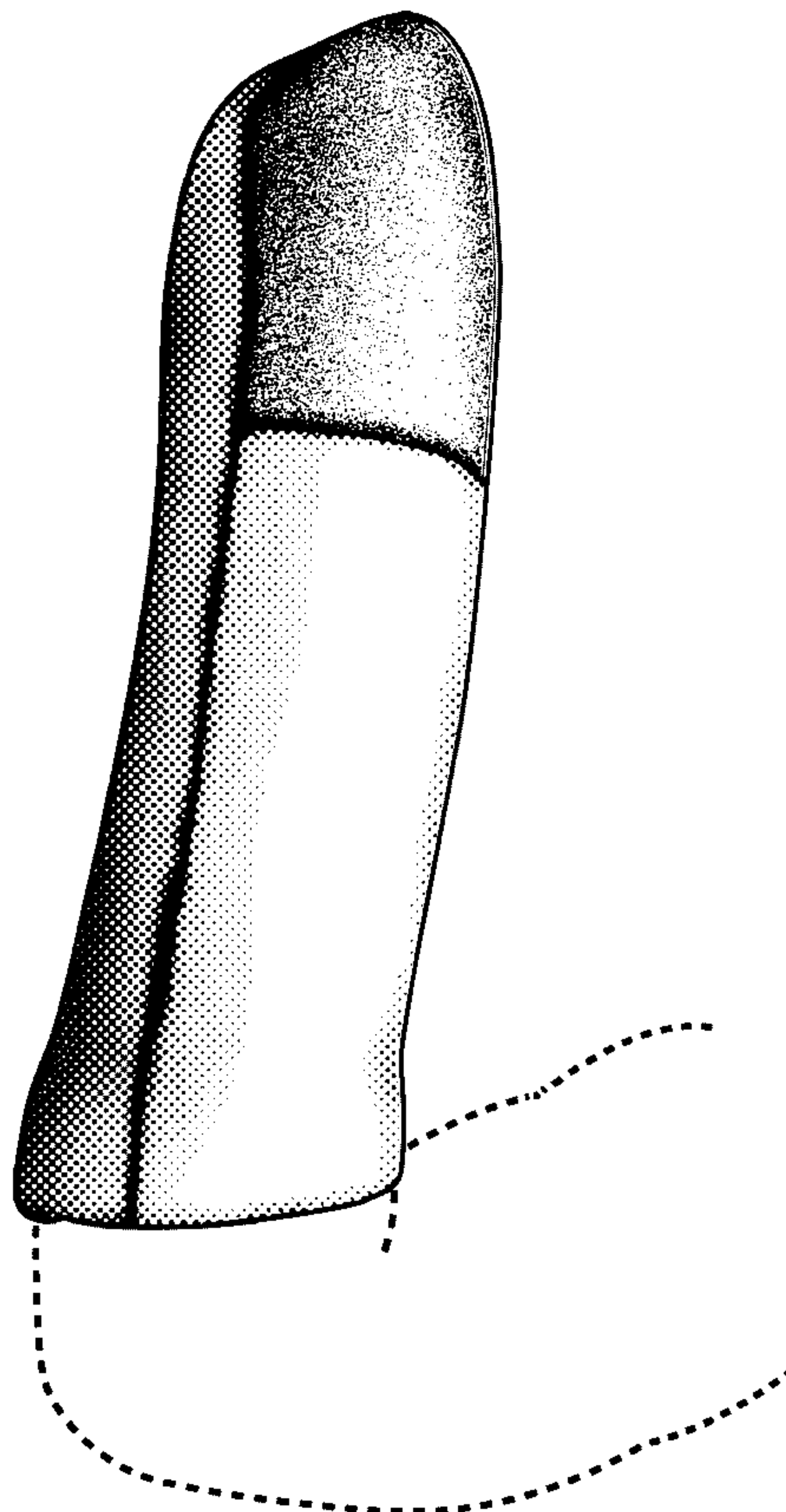
The ornamental design for infant no-scratch mitten, as shown and described.

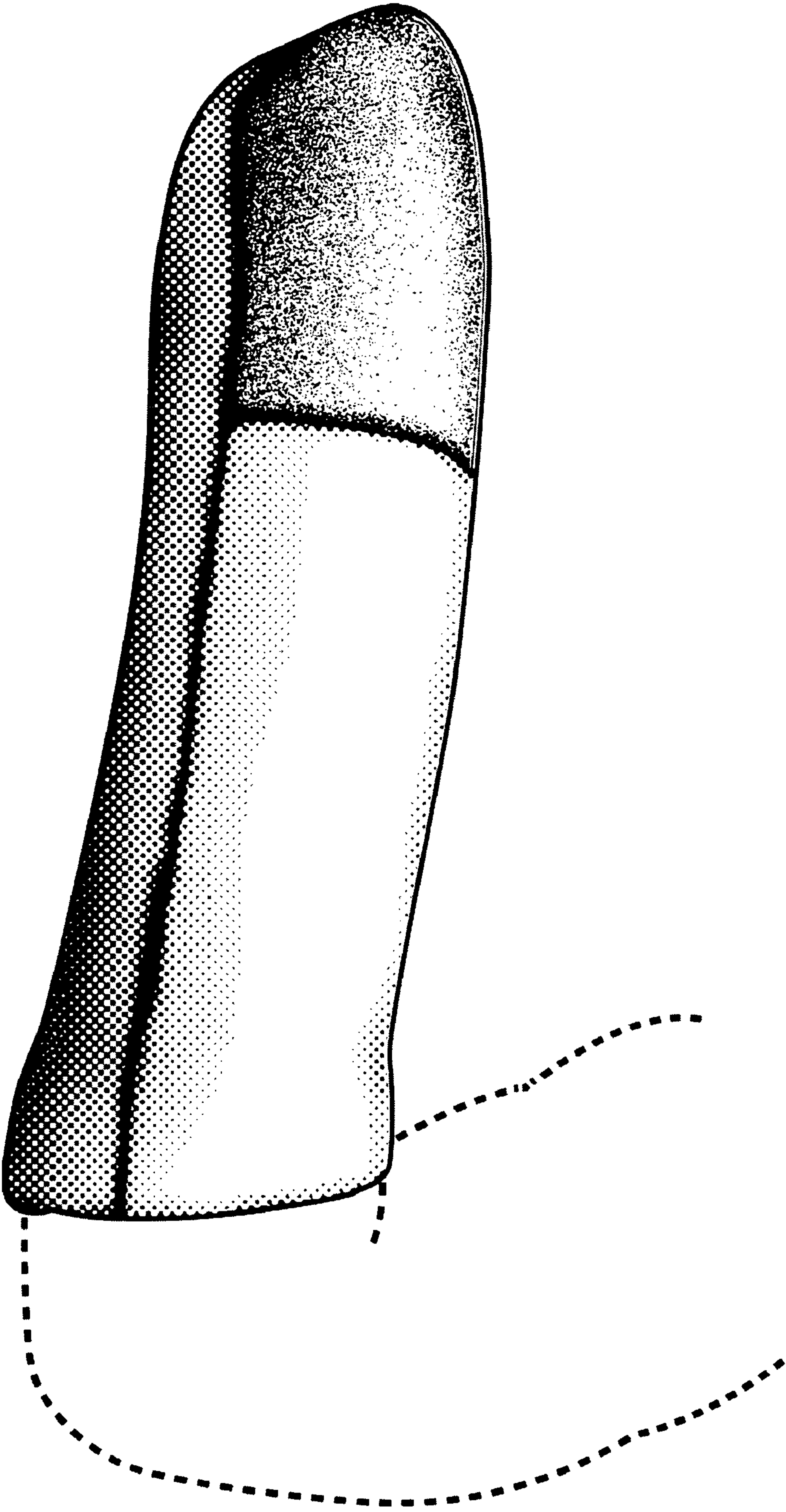

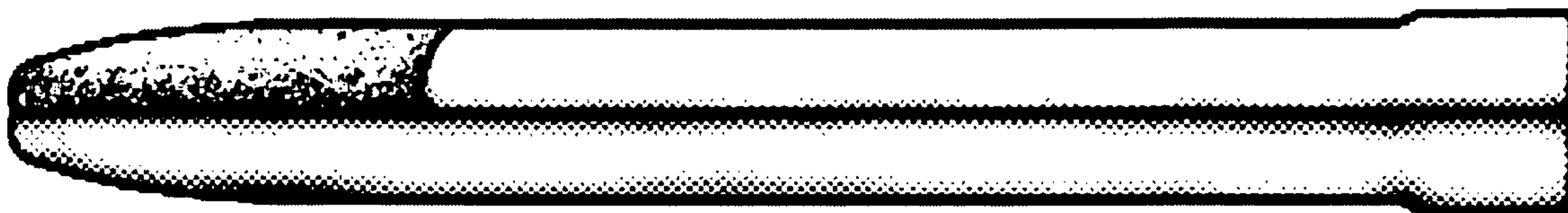

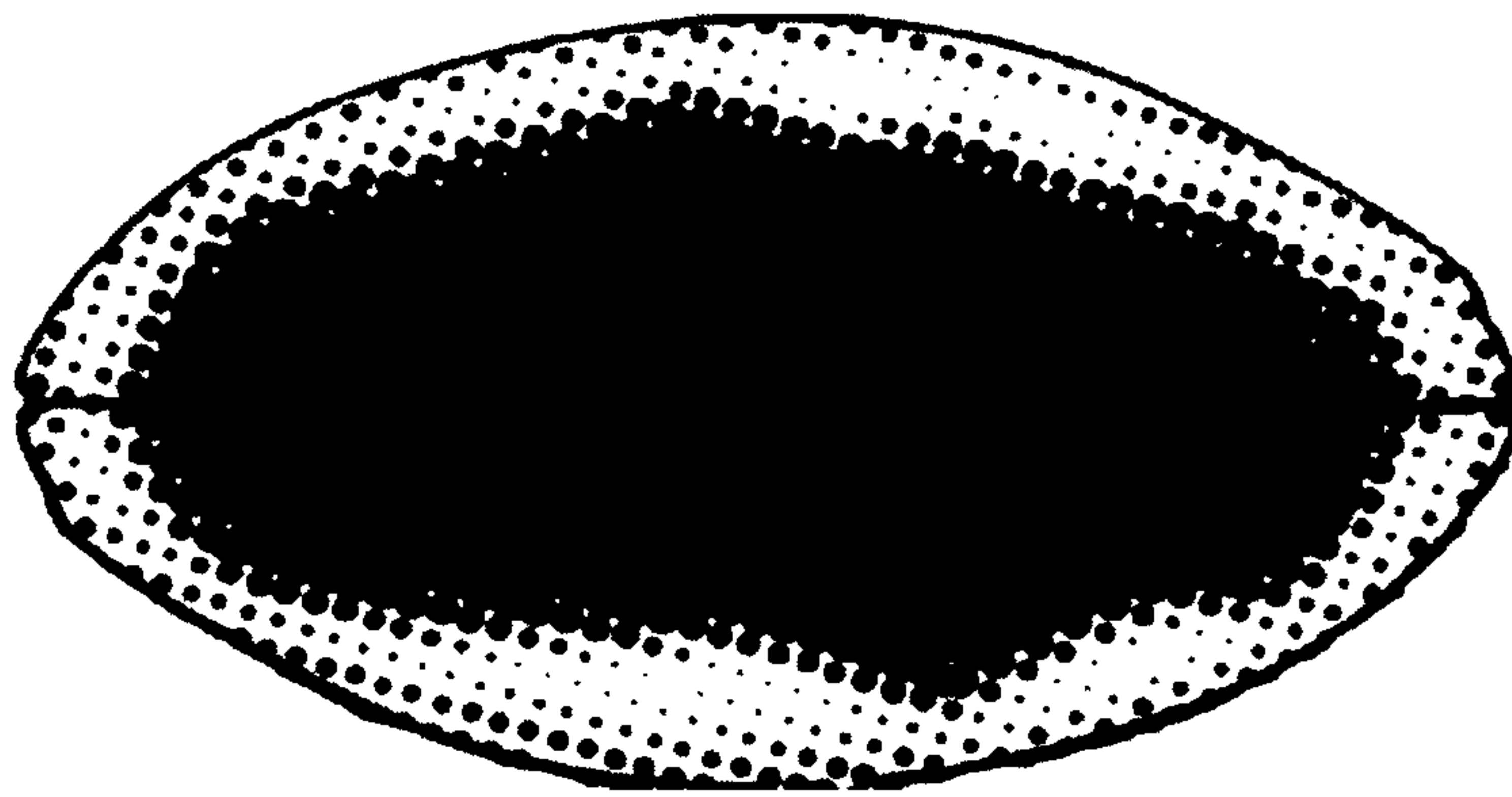

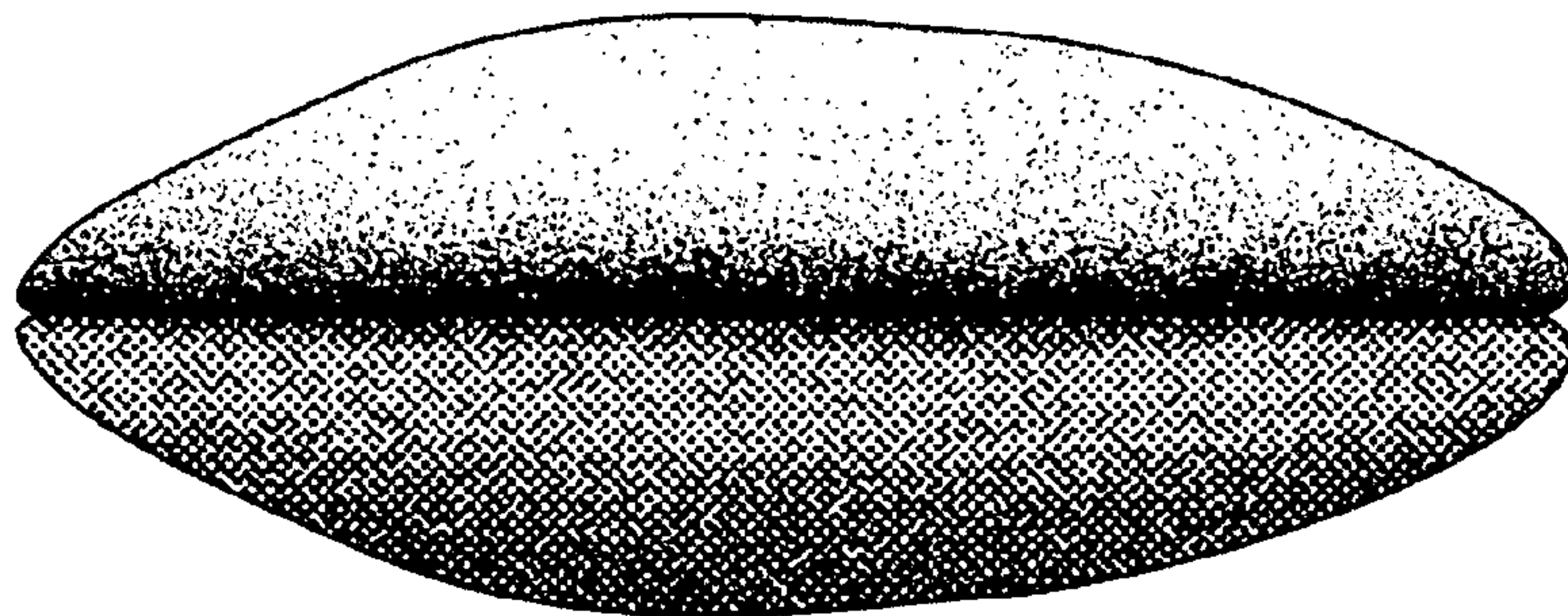

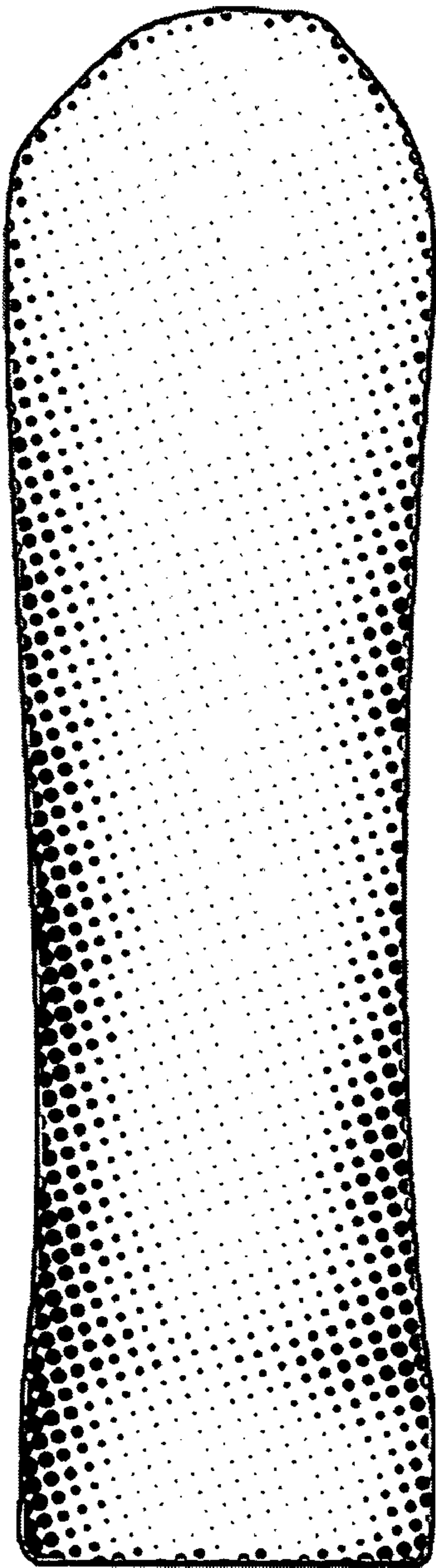

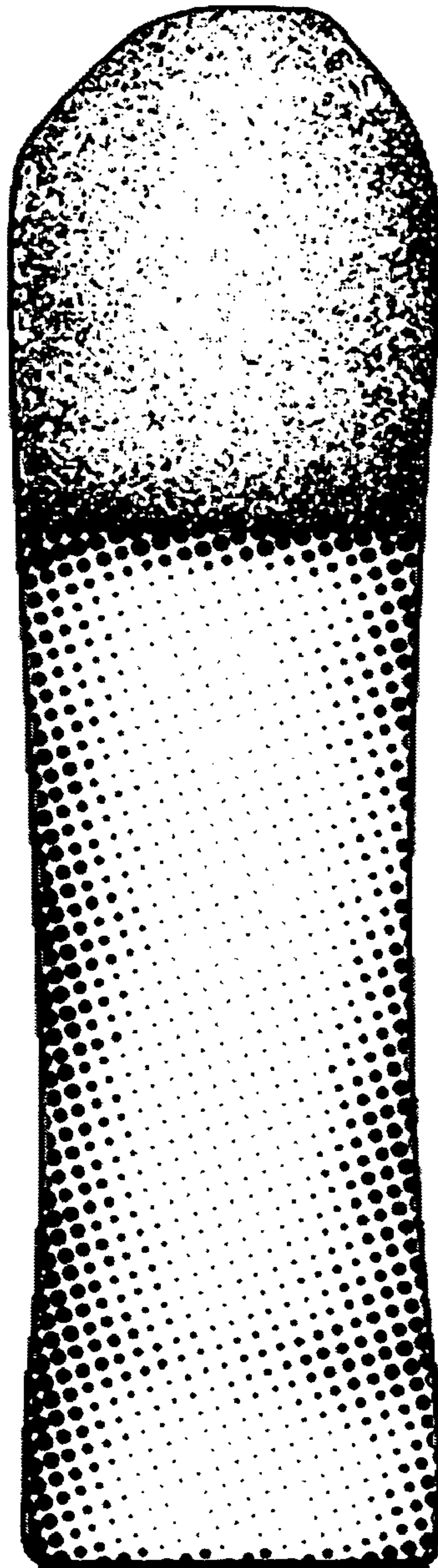
