The ornamental design for a hunter knit helmet, as shown and described.

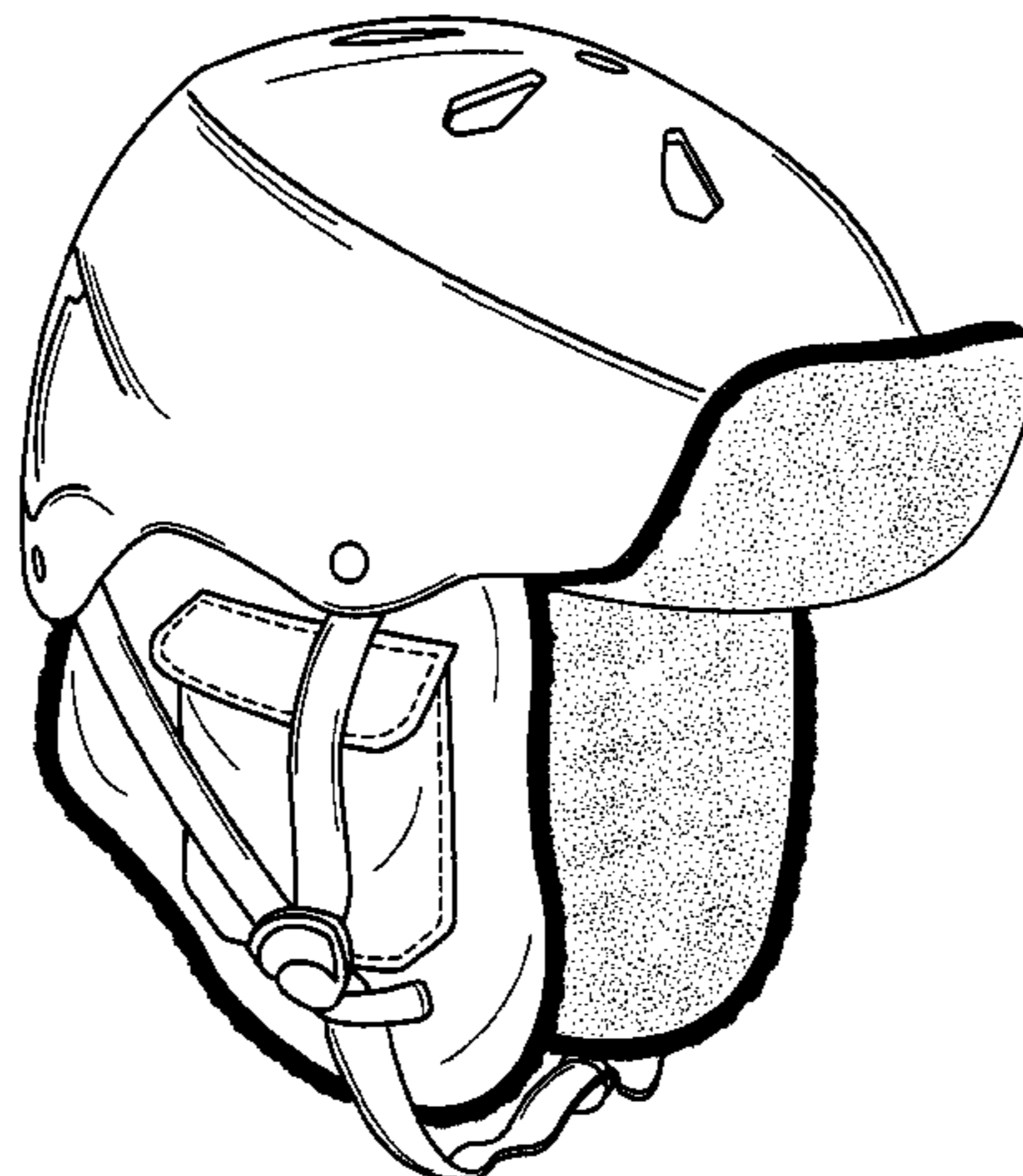
DESCRIPTION

FIG. 1 is a perspective view of the helmet;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a top view thereof.

The stippling shown on FIGS. 1–4 and 6, the material framed by the thick, black edging, illustrates texture and forms a part of the claimed design.

The broken lines around the edges of the pocket in FIGS. 1 and 2 represent fabric stitching and form a part of the claimed design.

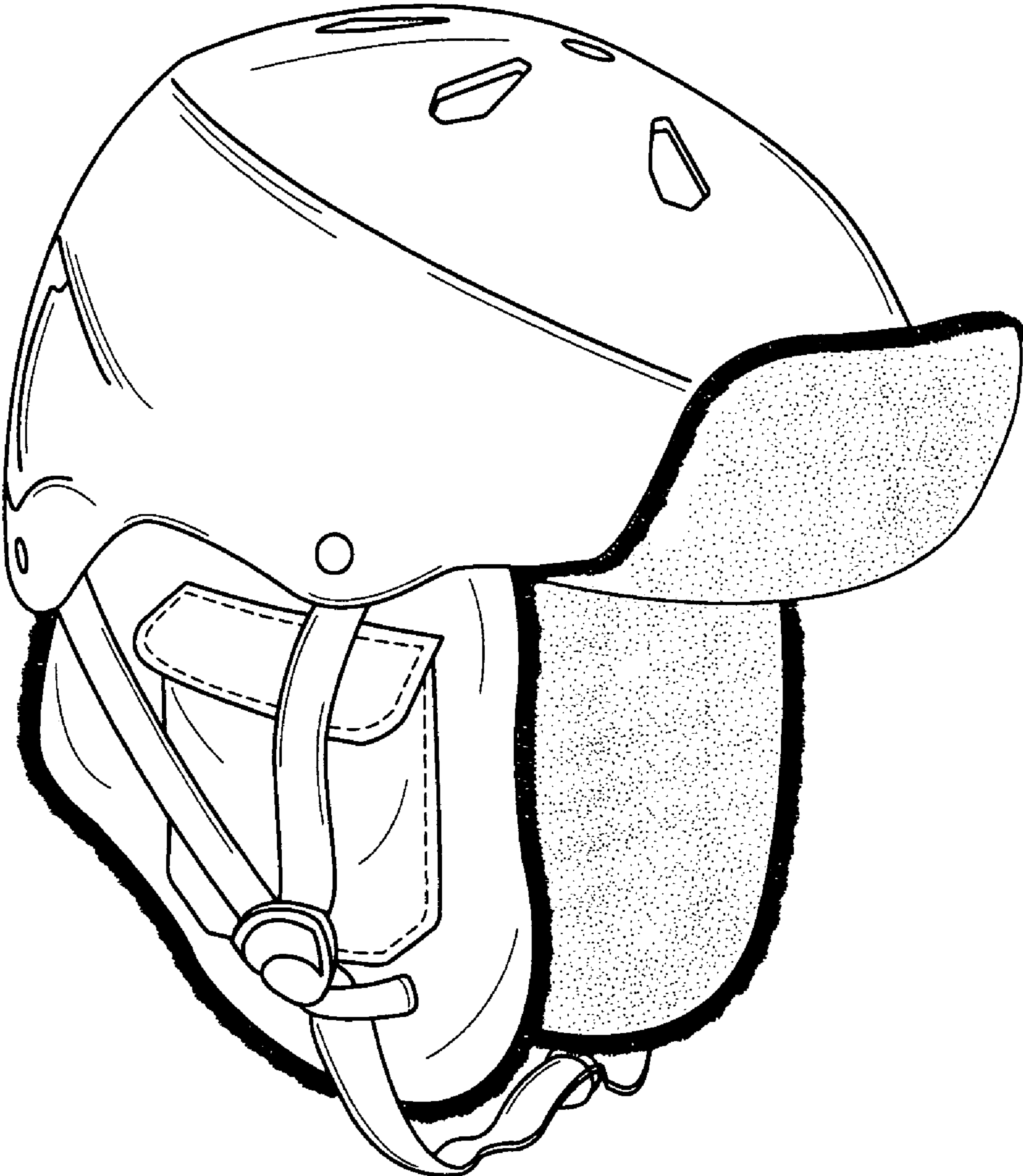

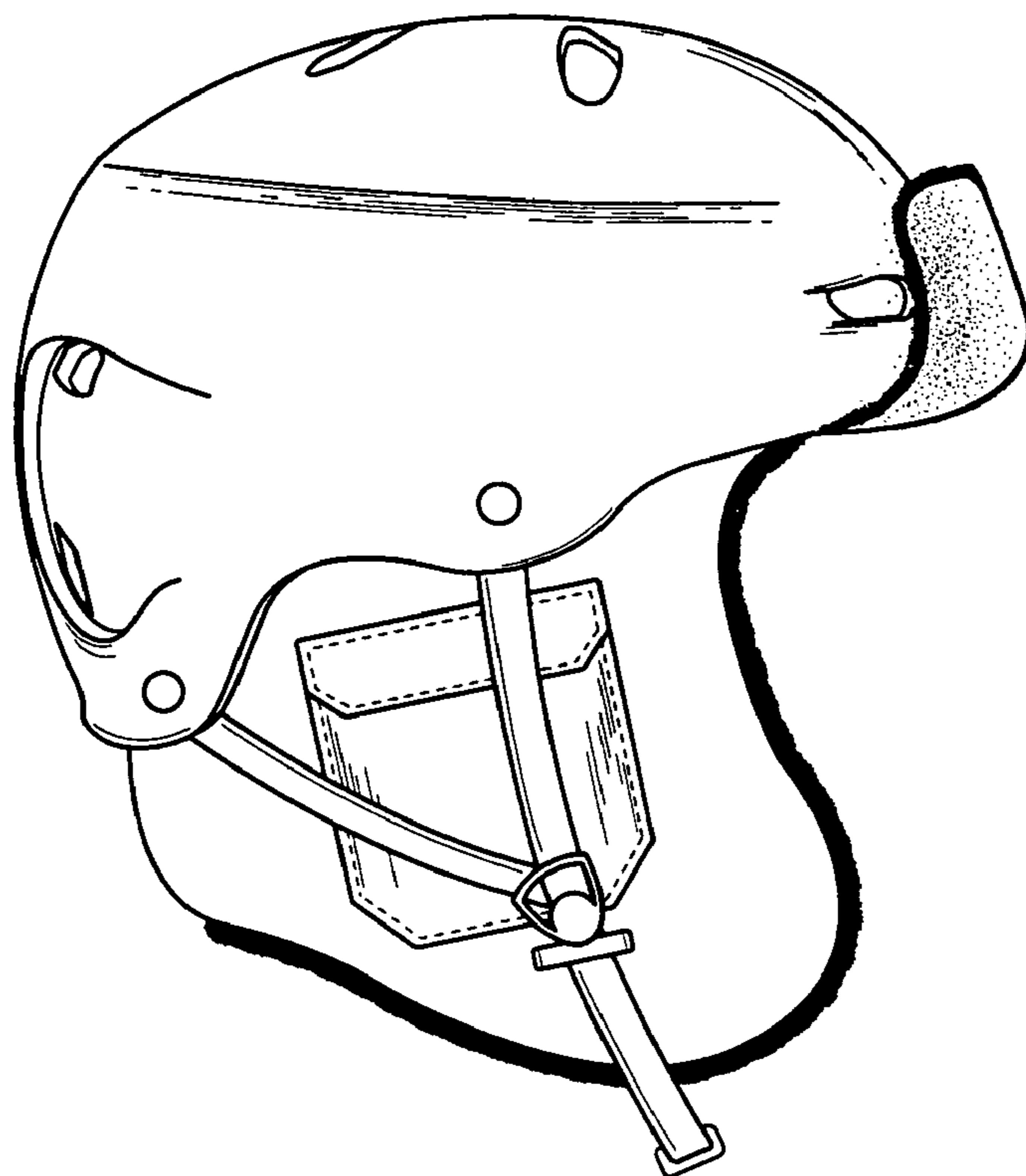

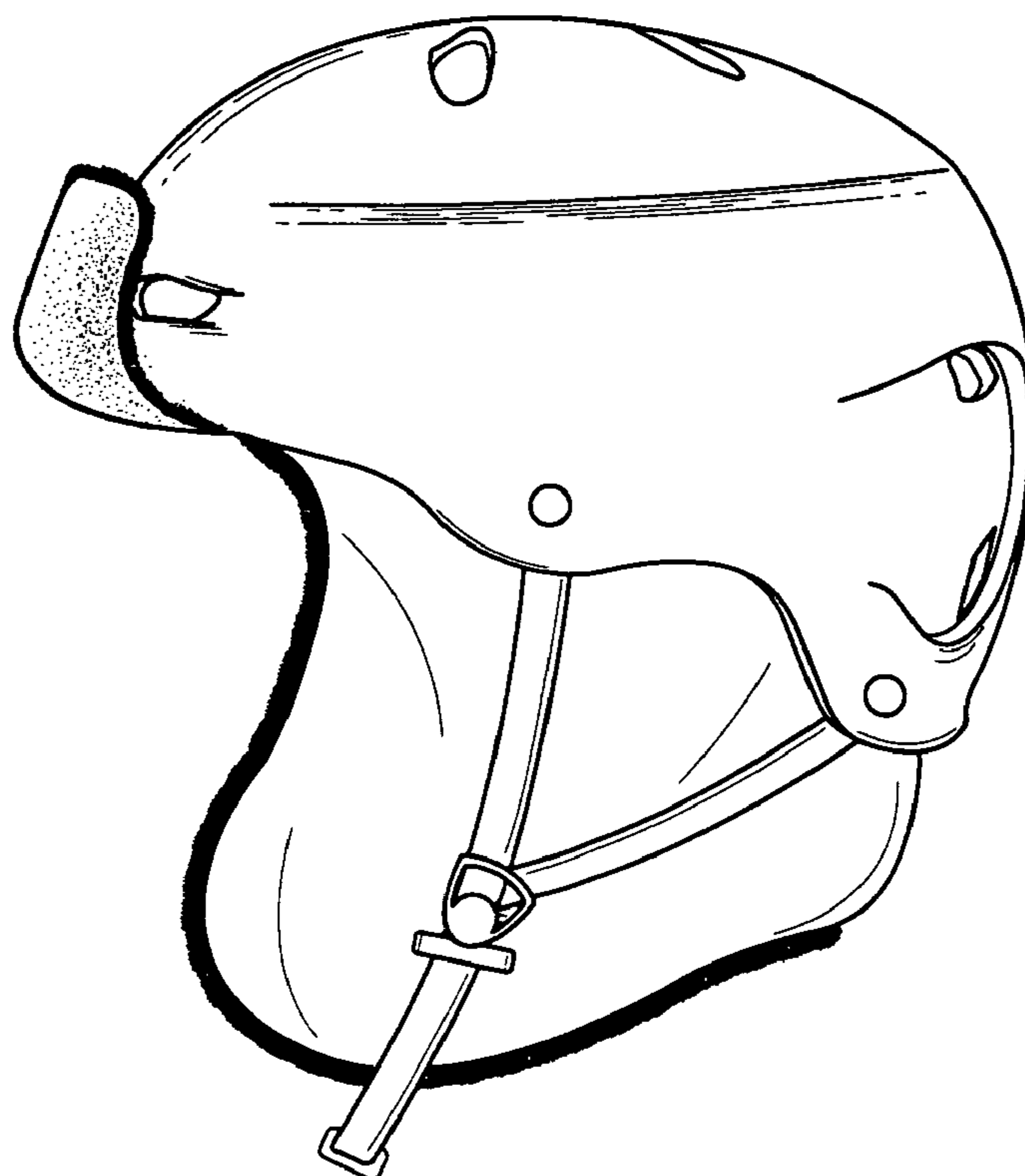

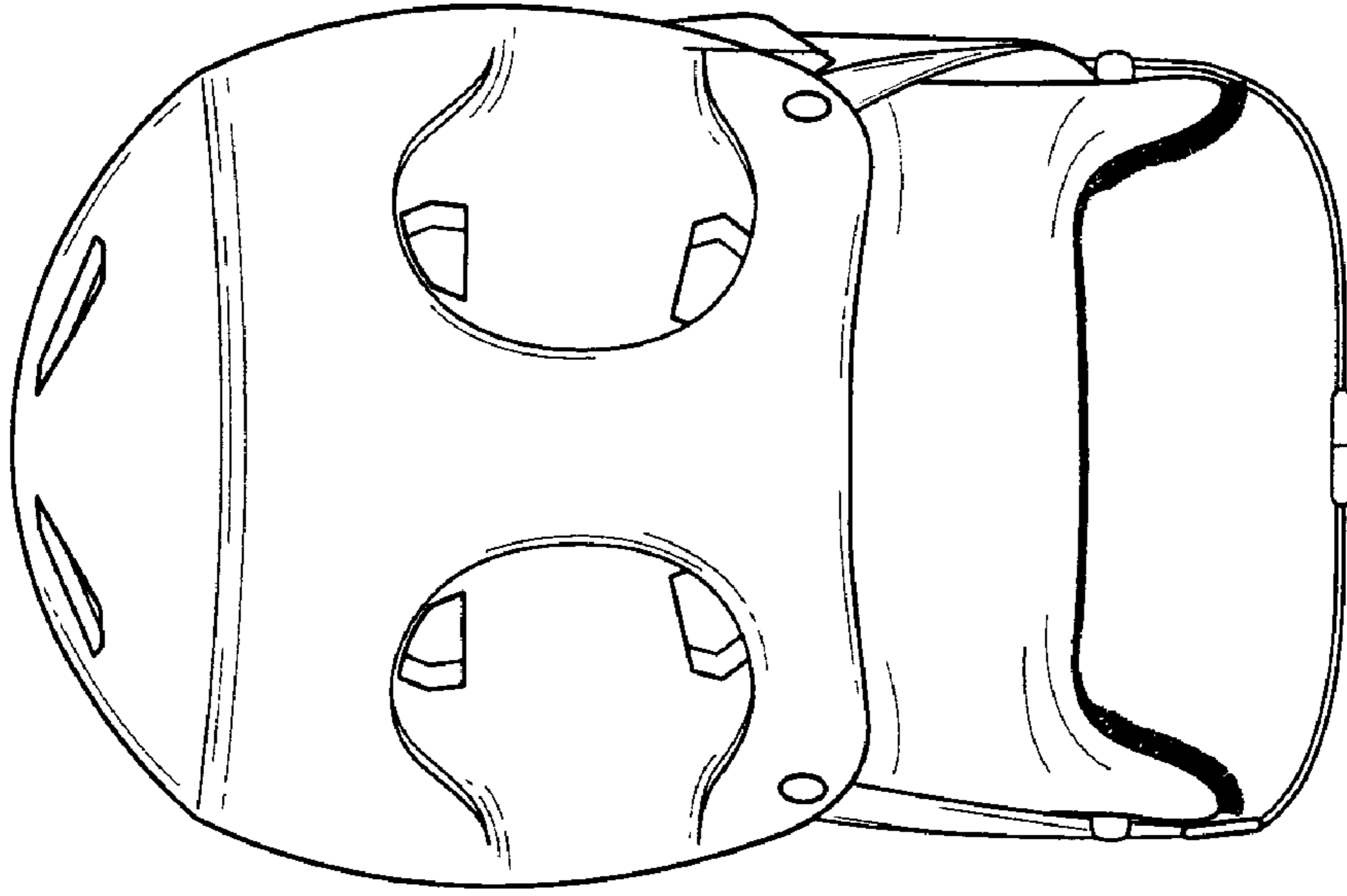

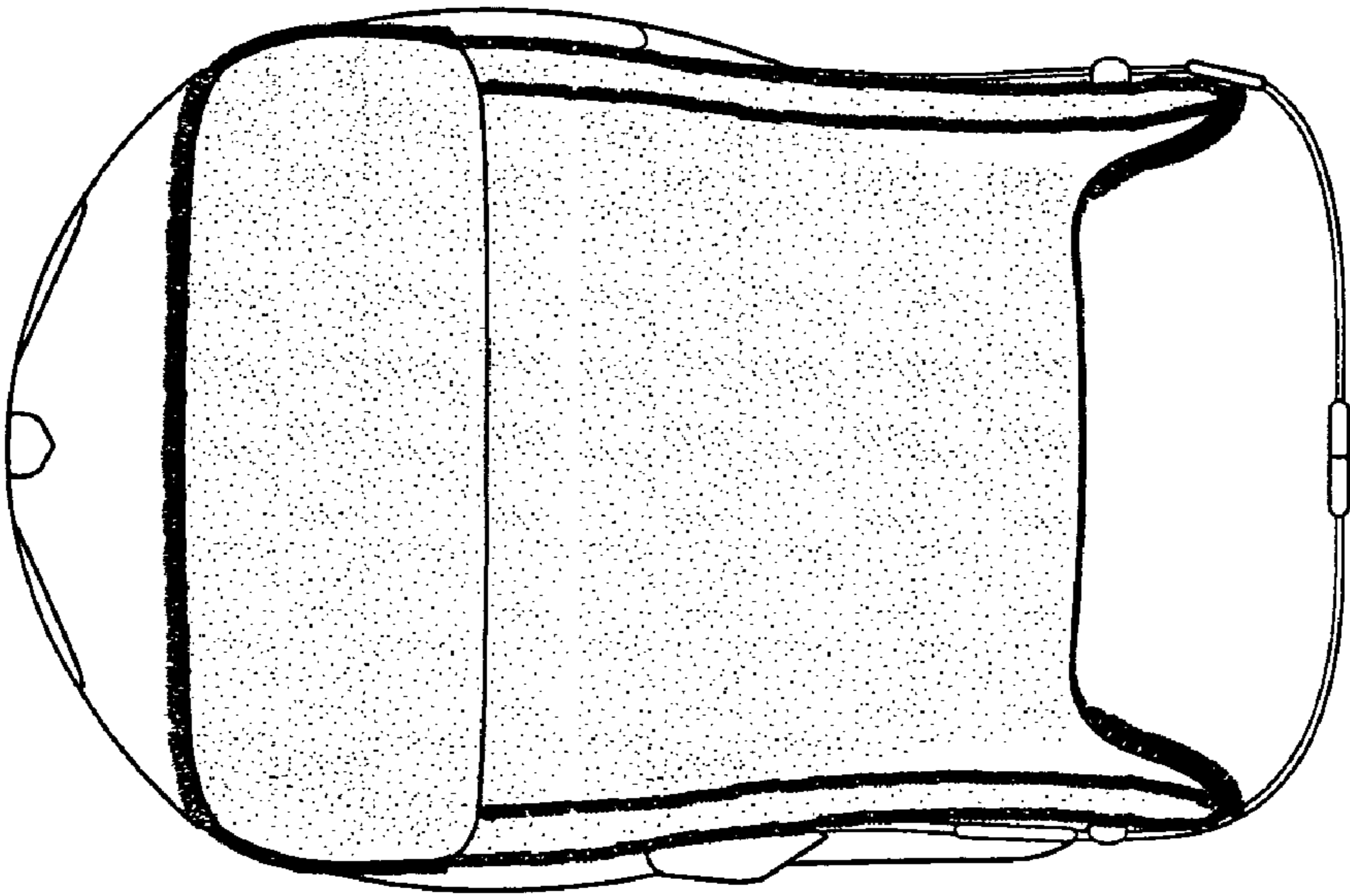

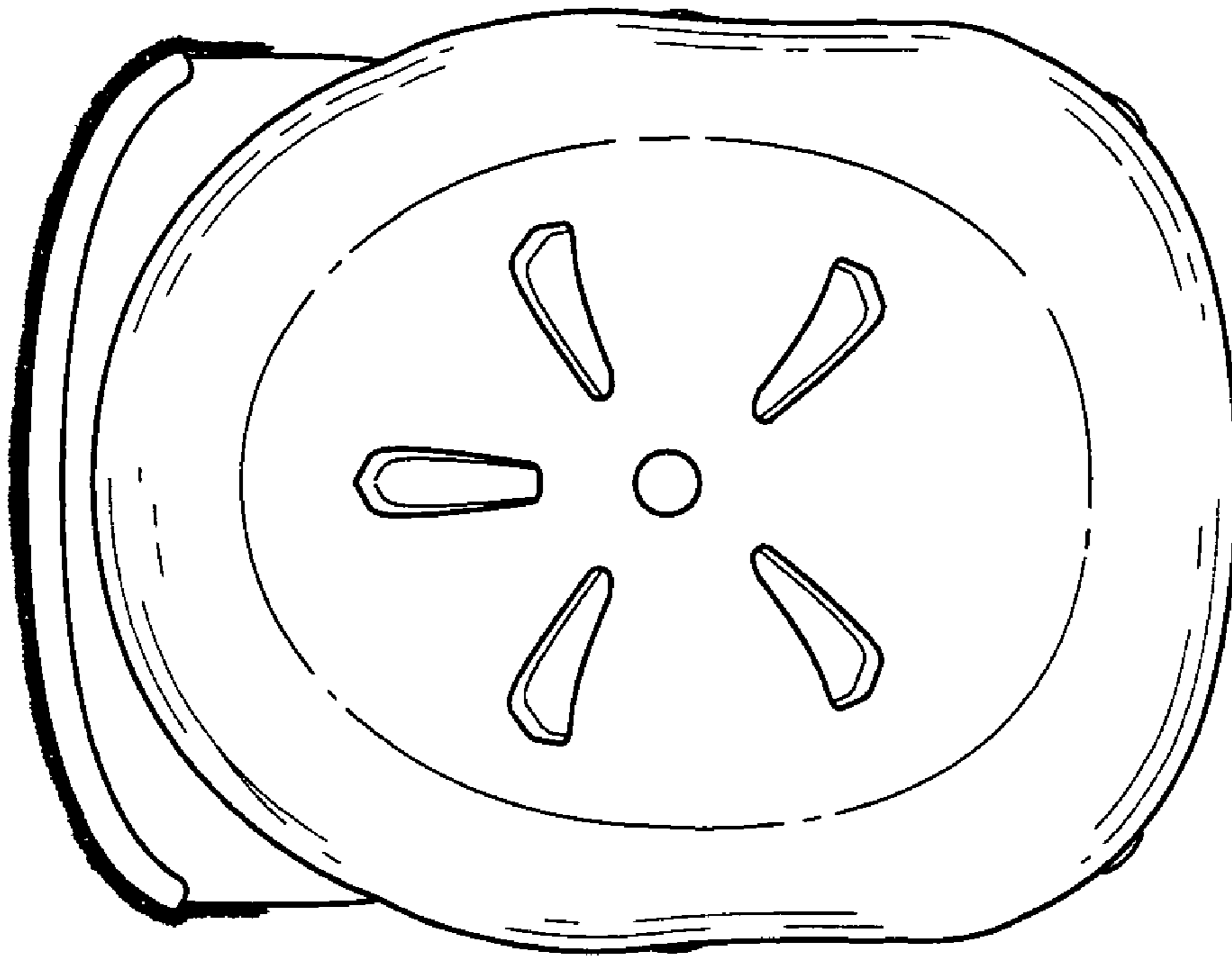

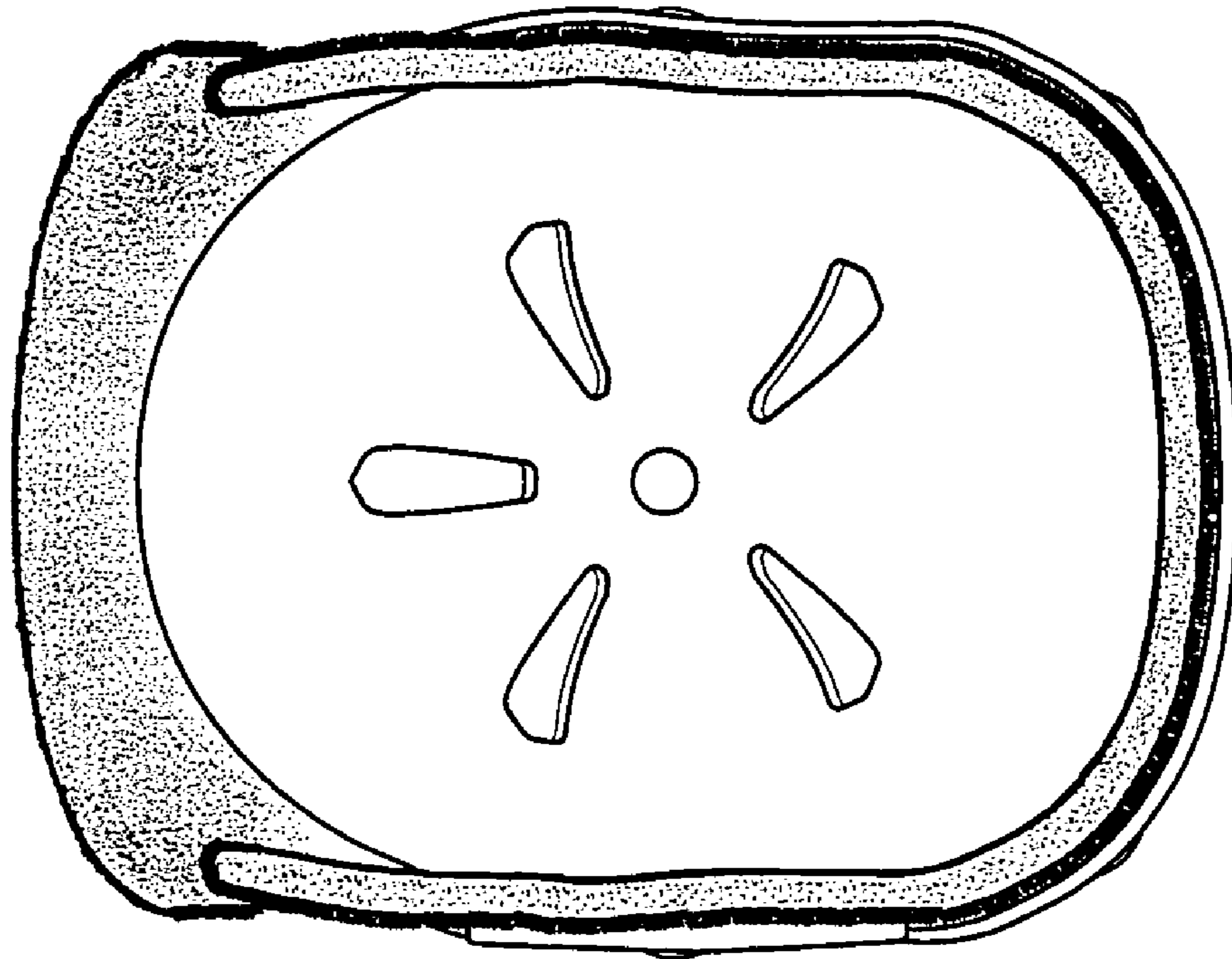
