The ornamental design for a Kufi hat/handbag, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a Kufi hat/handbag showing my new design in use as a hat;

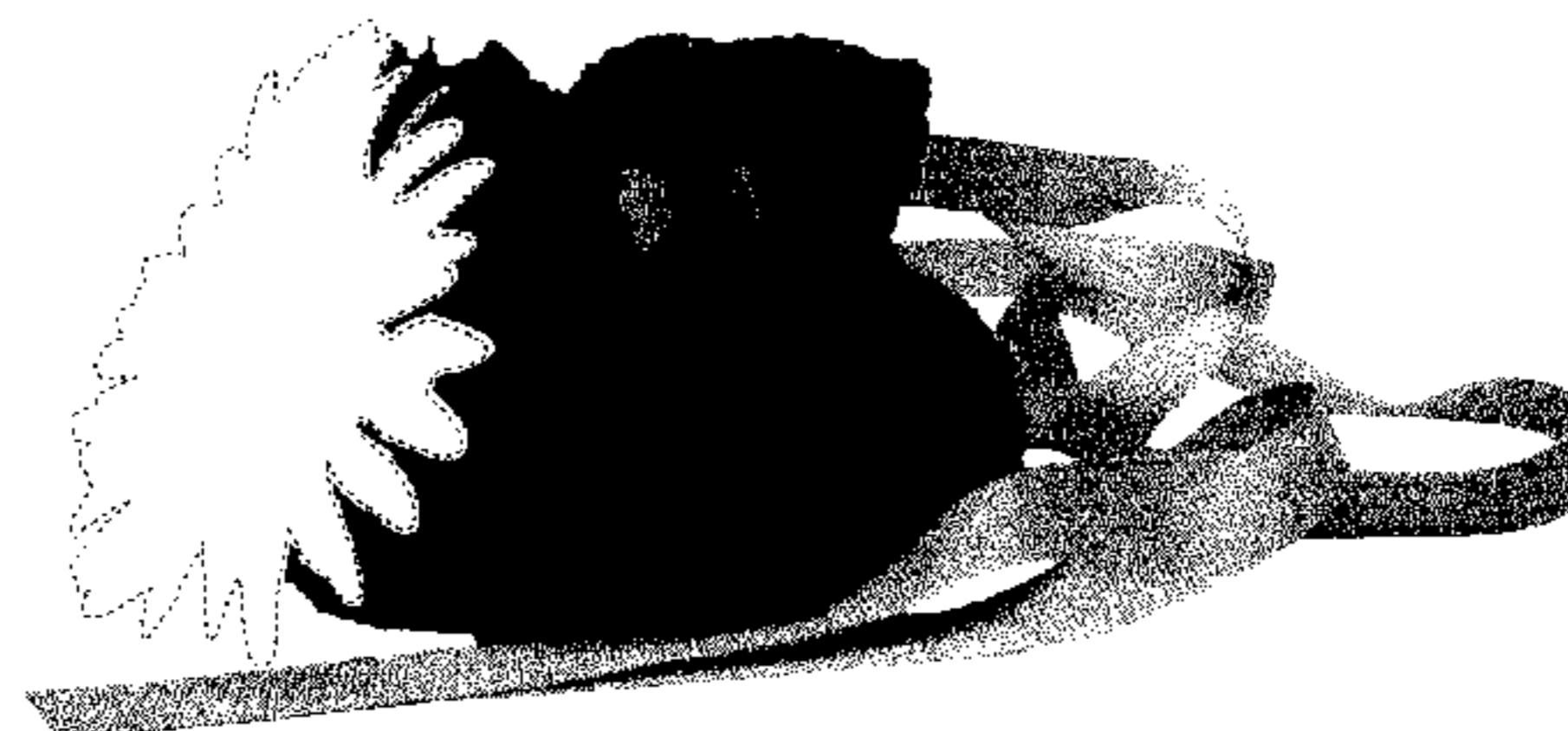

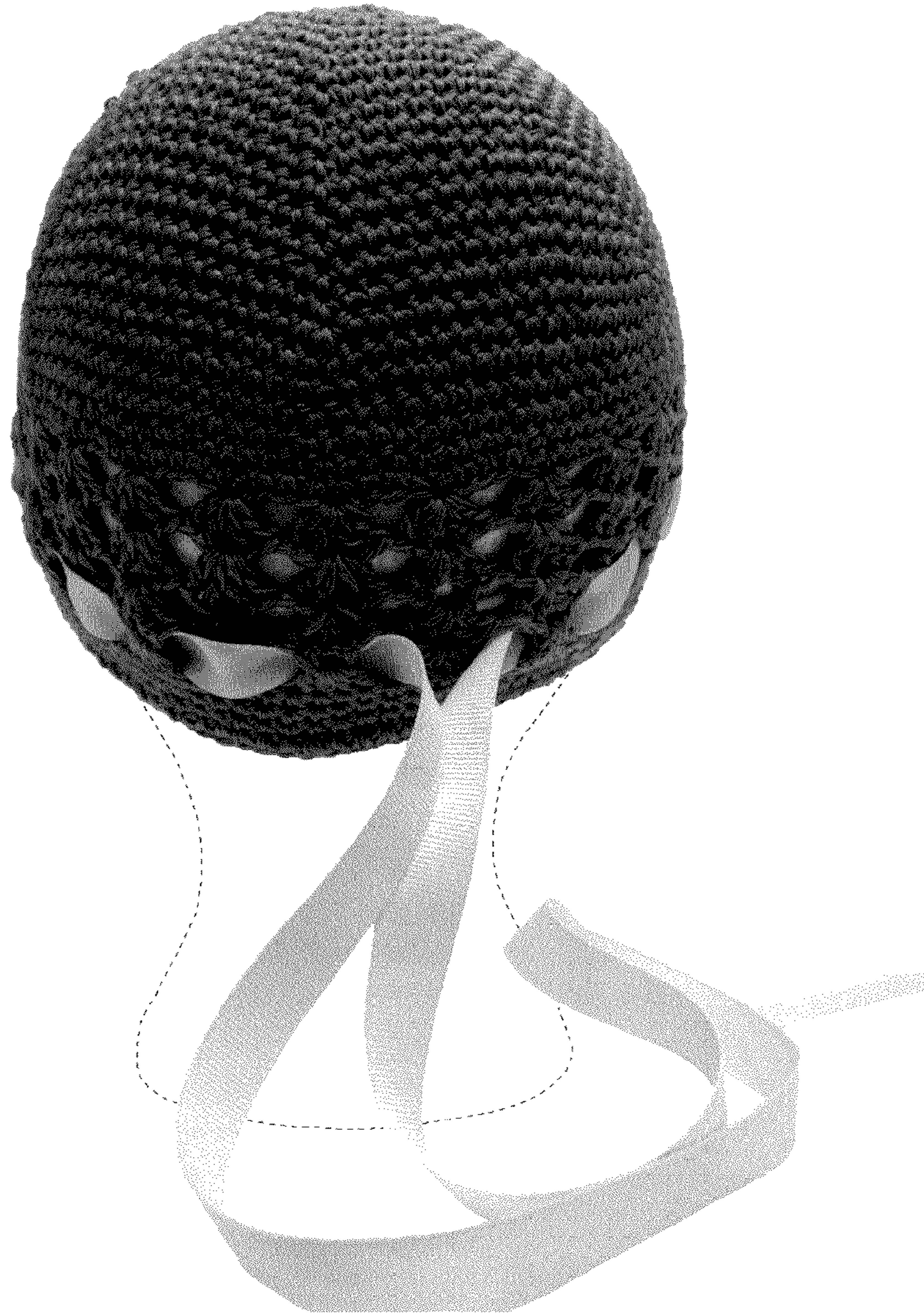

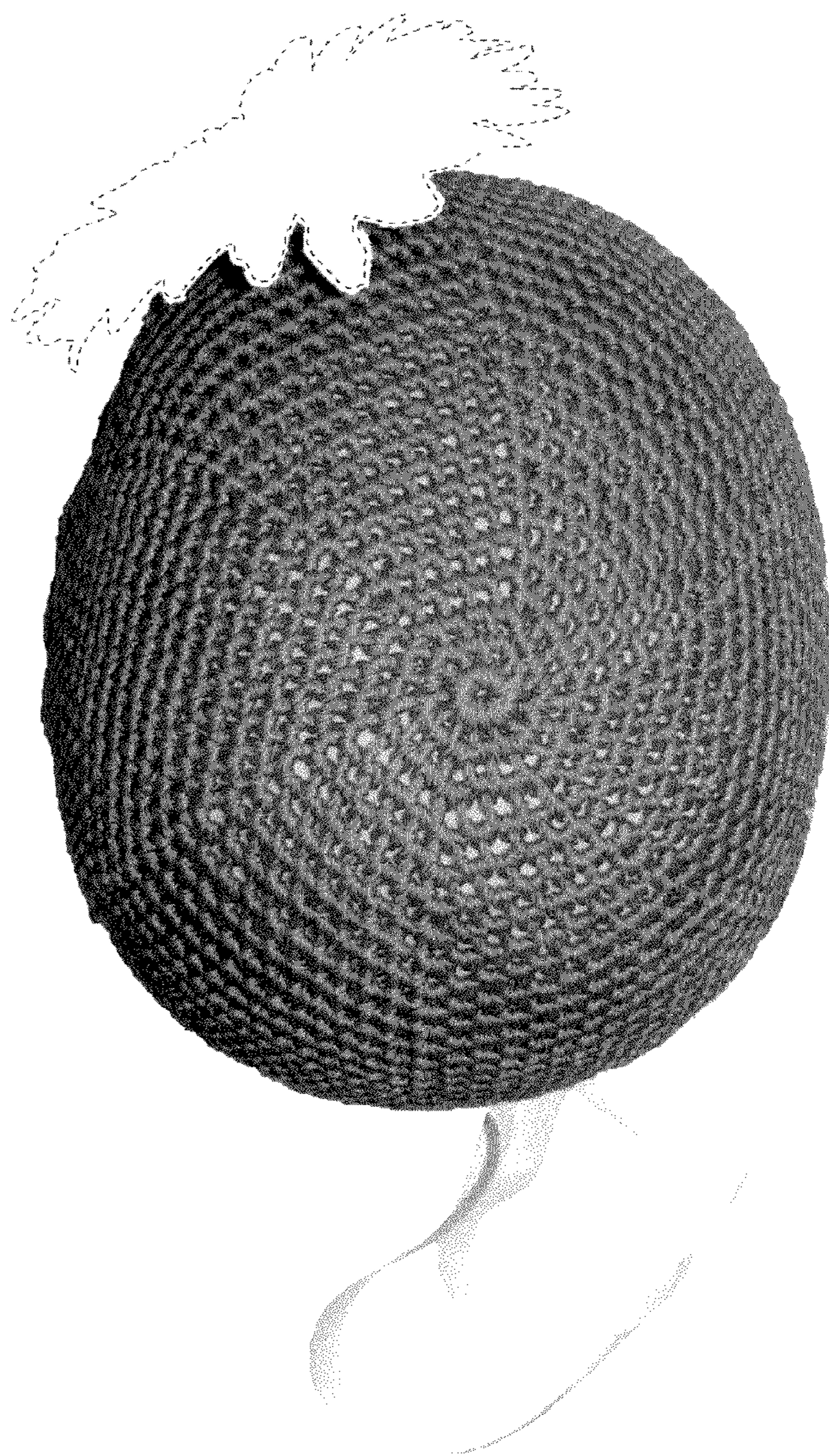

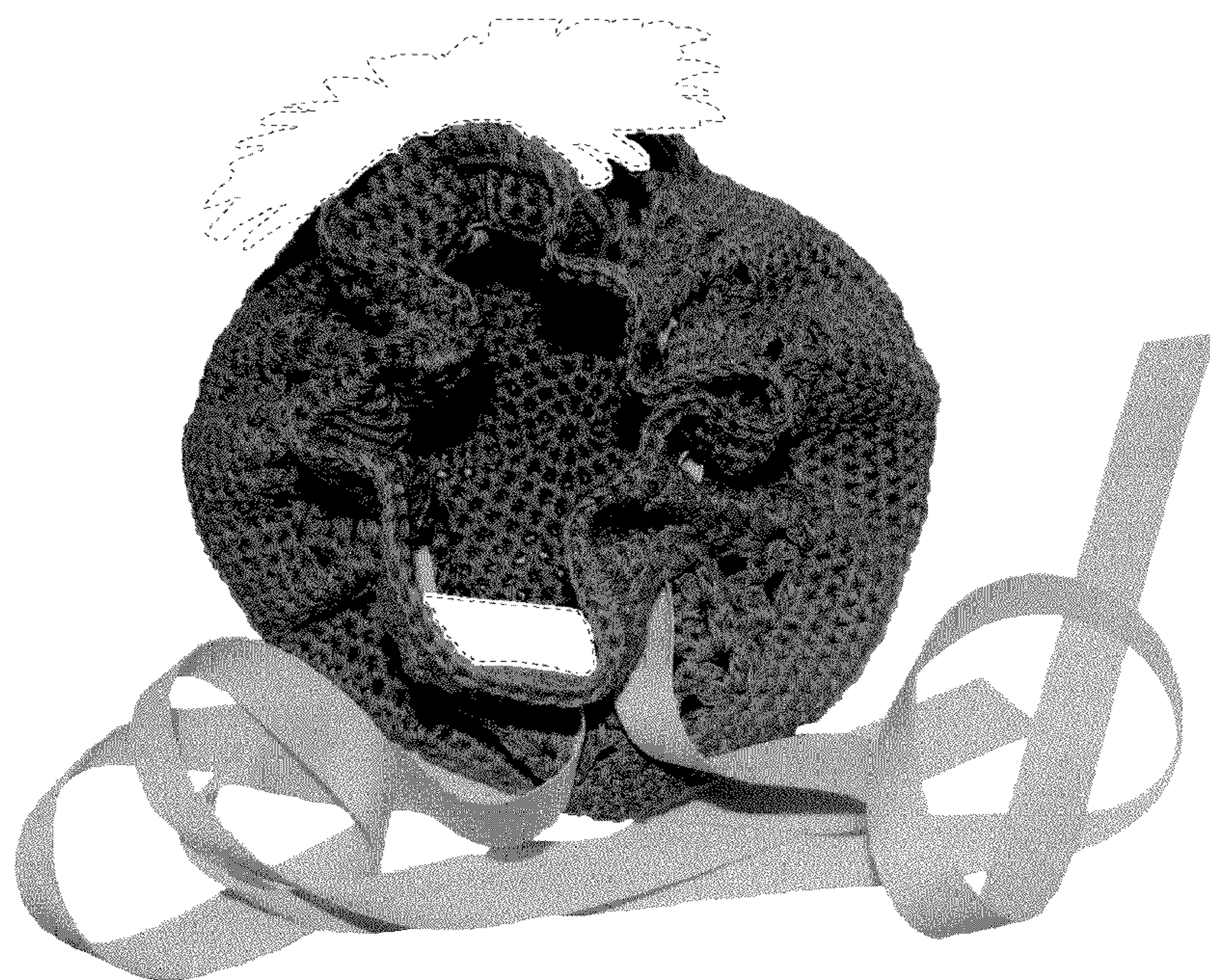
