(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front, right top perspective view showing the shoe sole of my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a rear elevation view thereof; and,

FIG. 7 is a bottom view thereof.

The broken lines showing the number, 37 and the trademark, "ecco" in FIG. 7, represent the portion of the article that forms no part of the claim.

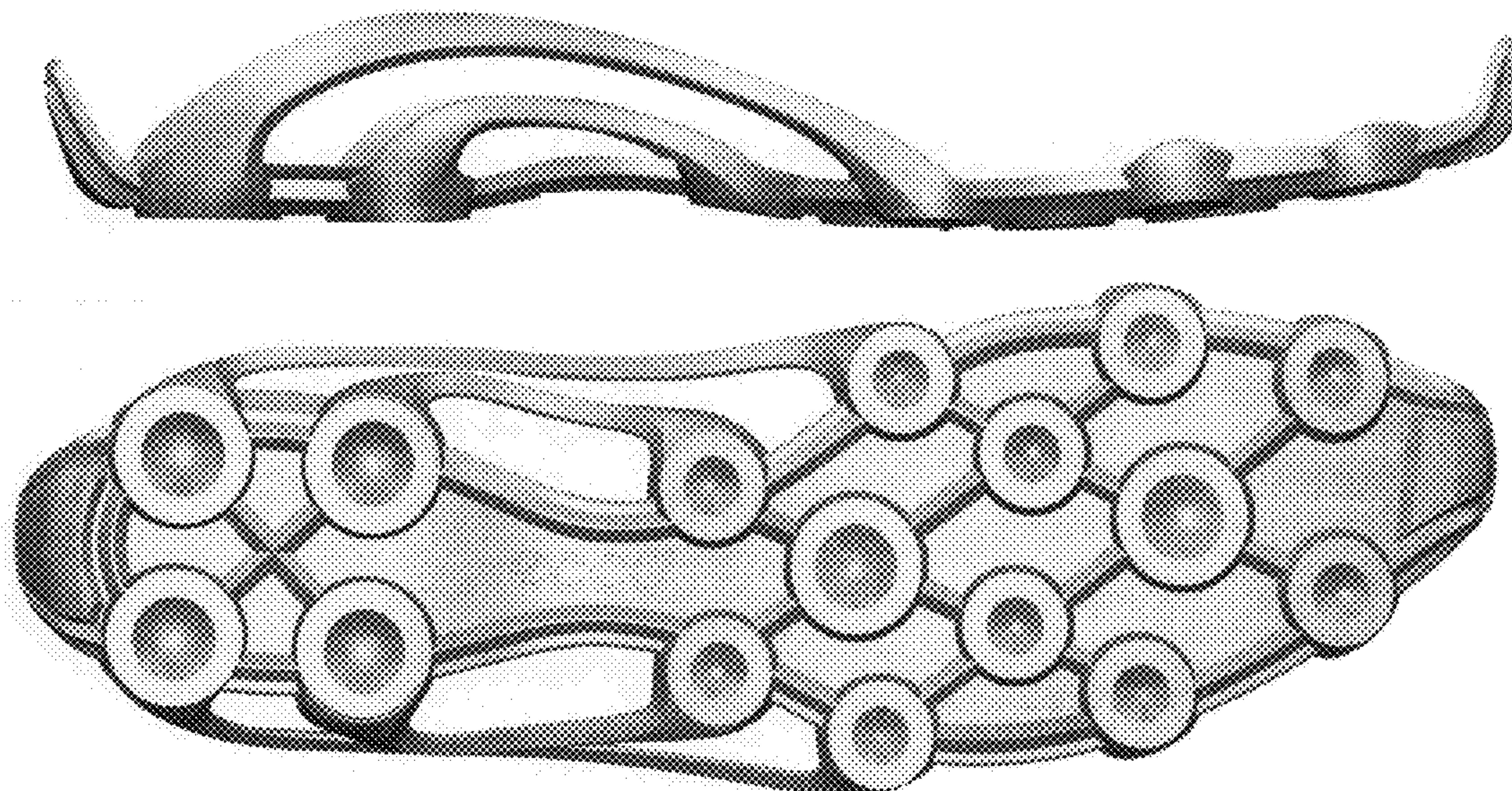

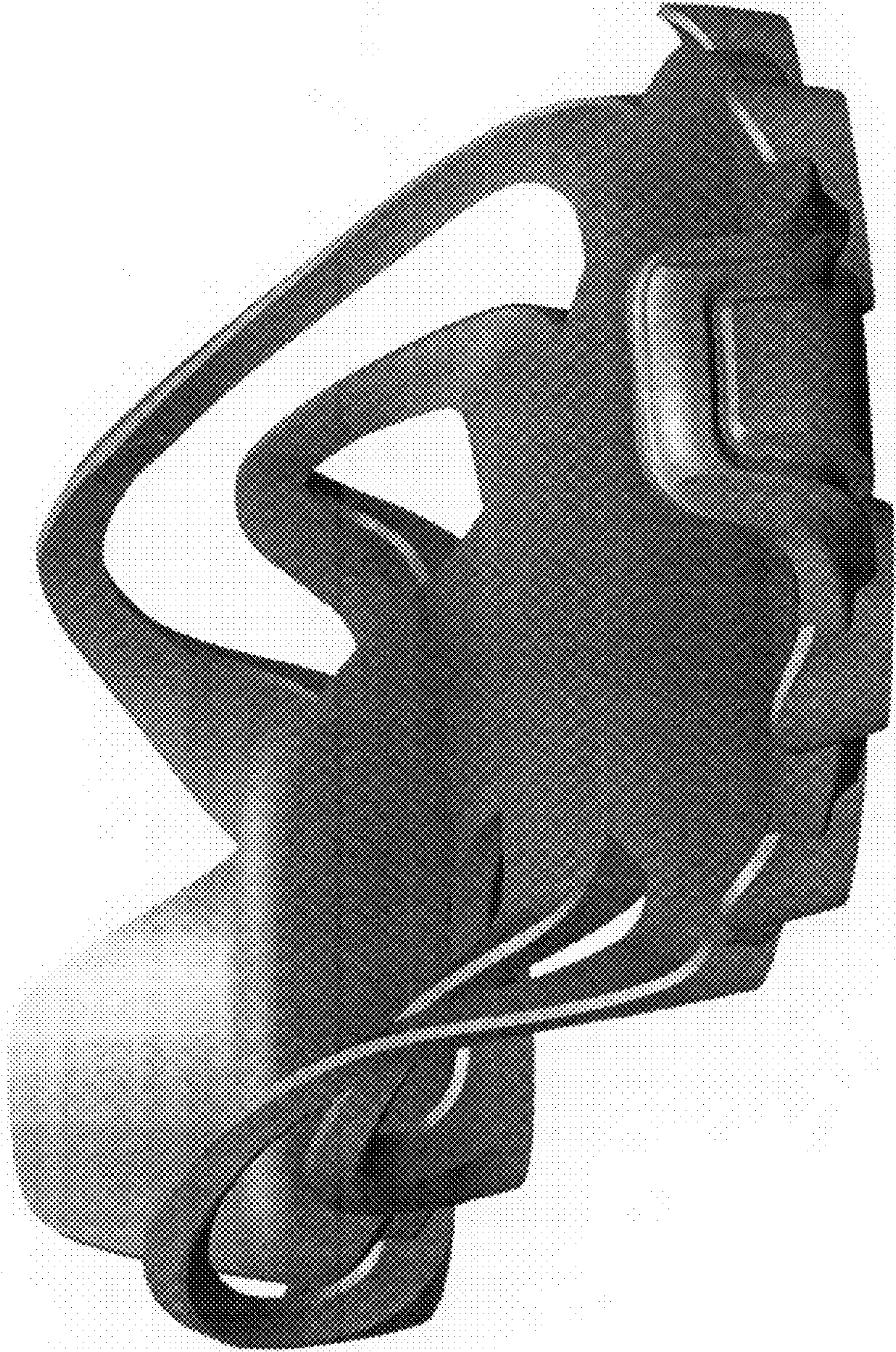

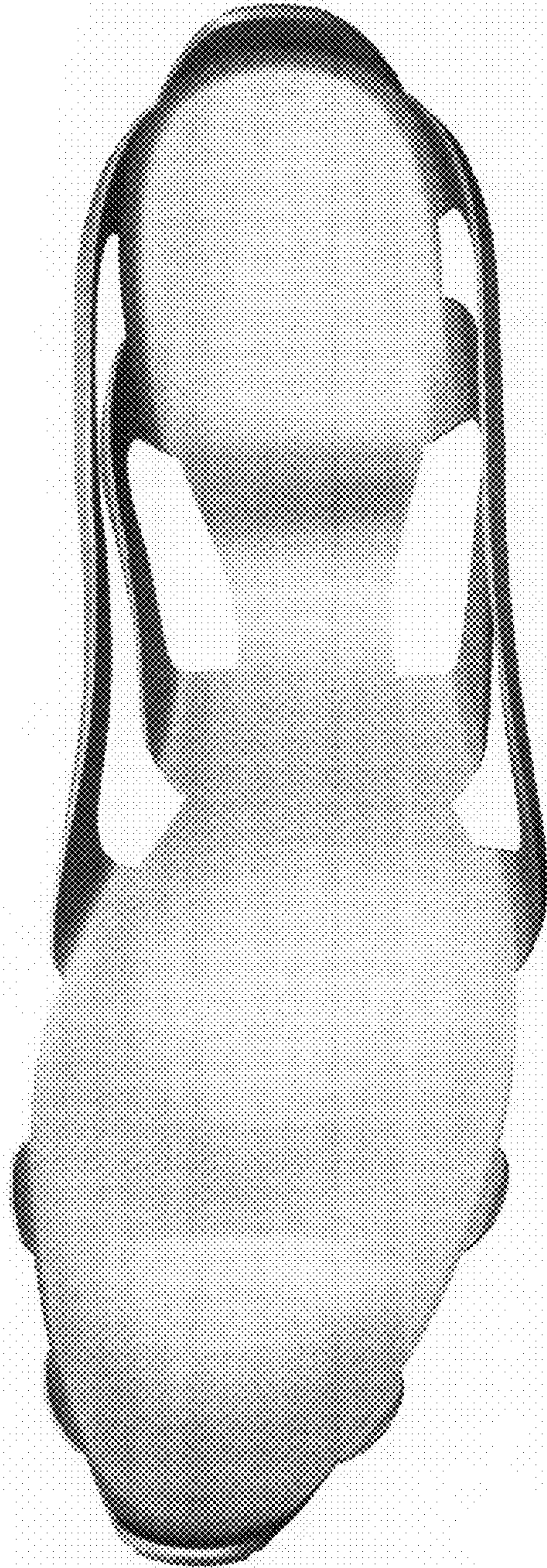

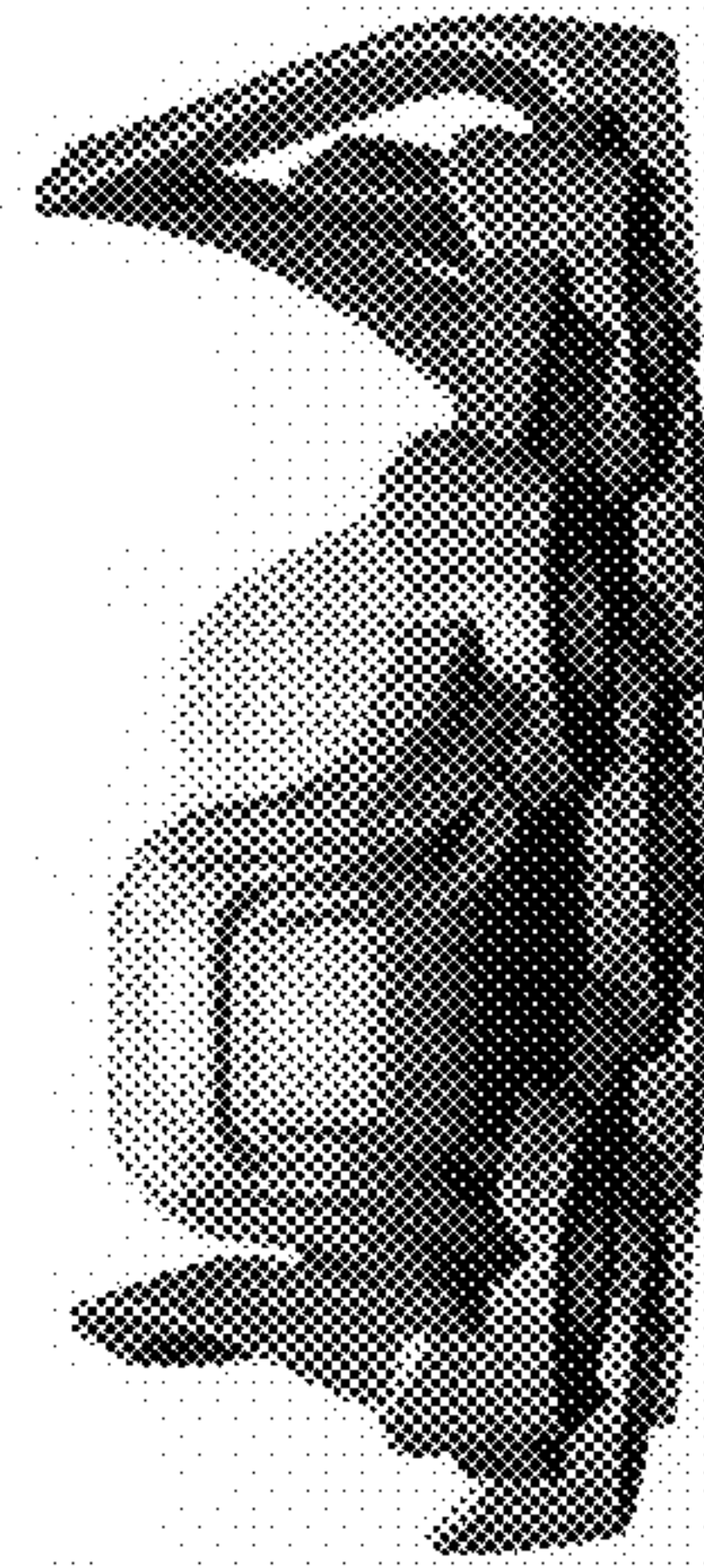

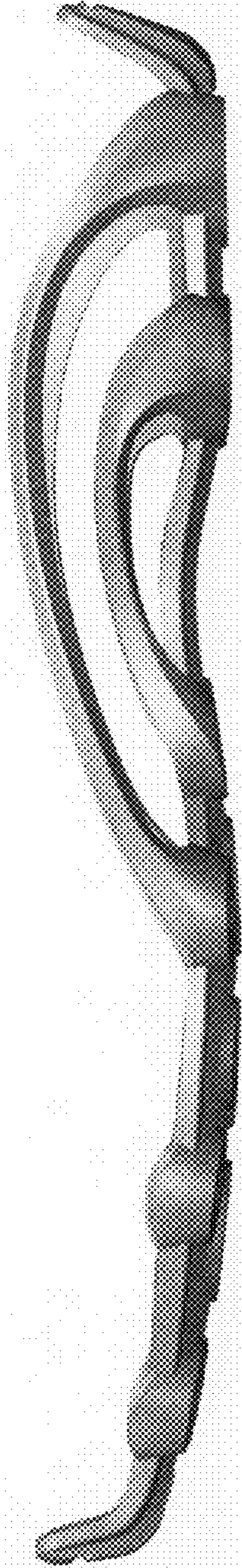

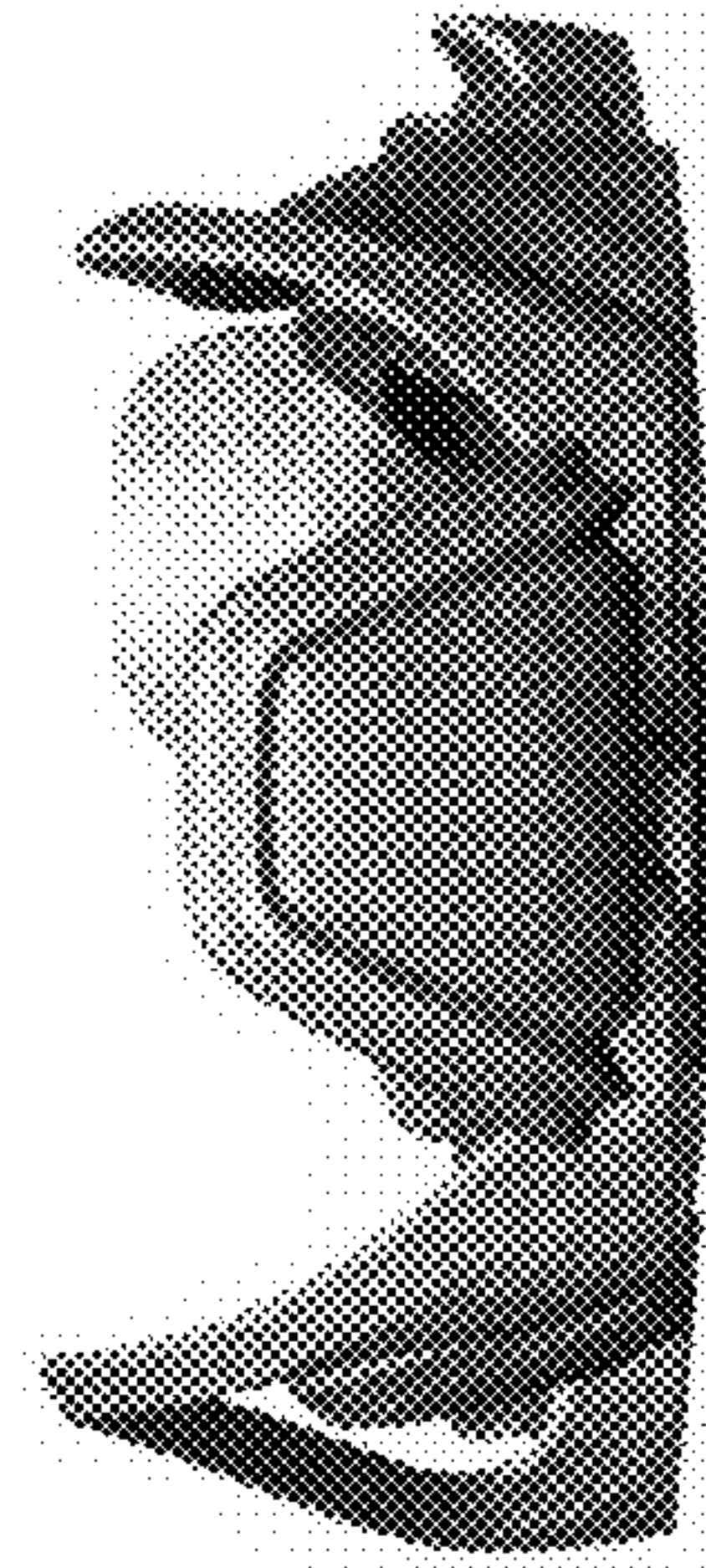

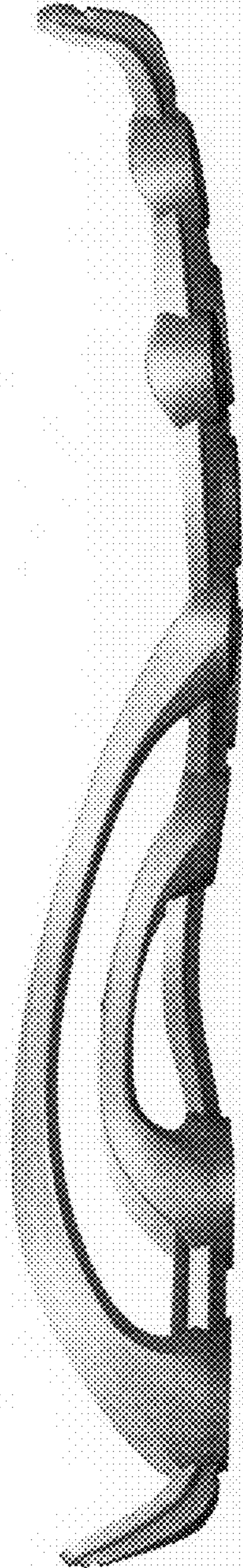
