DESCRIPTION

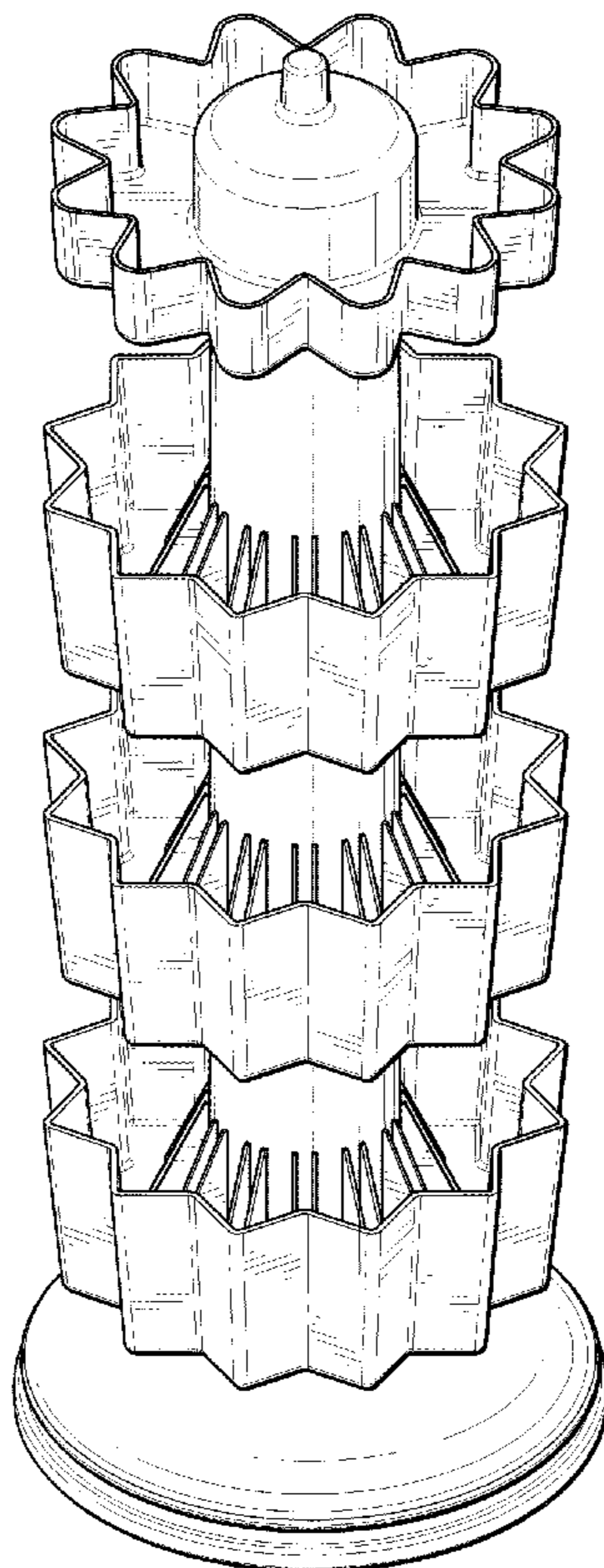
FIG. 1 is a top and side prospective view of a container showing my new design;

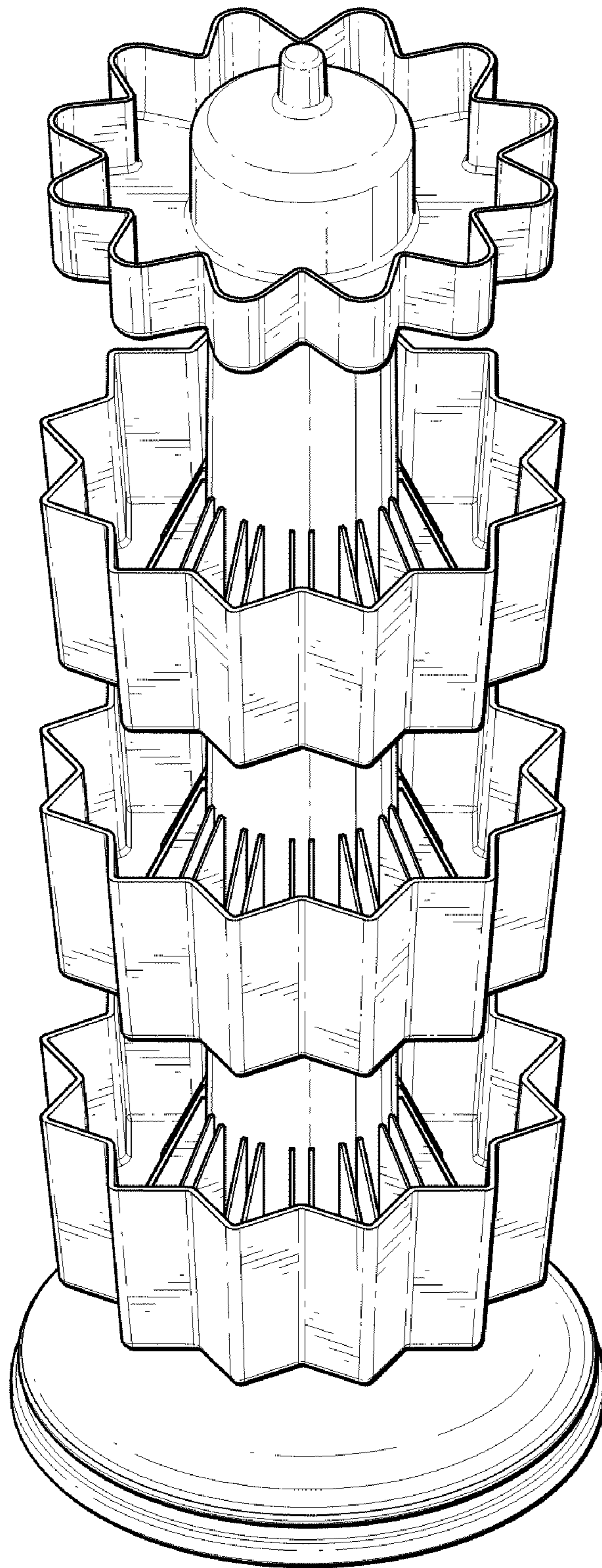

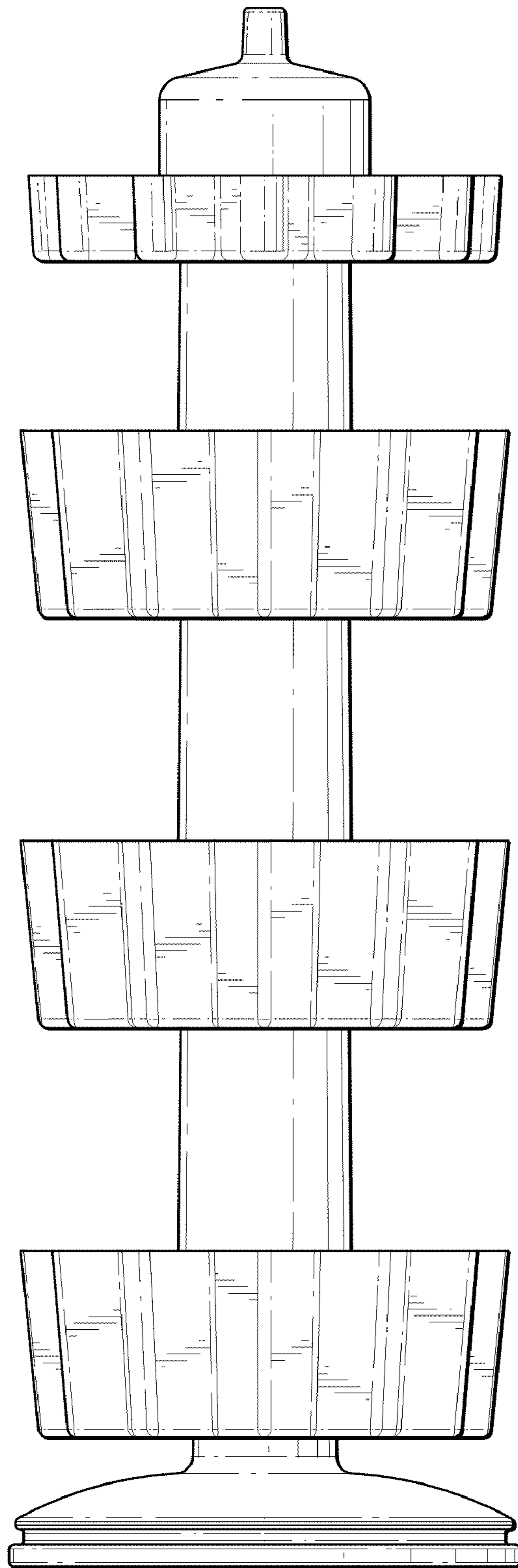

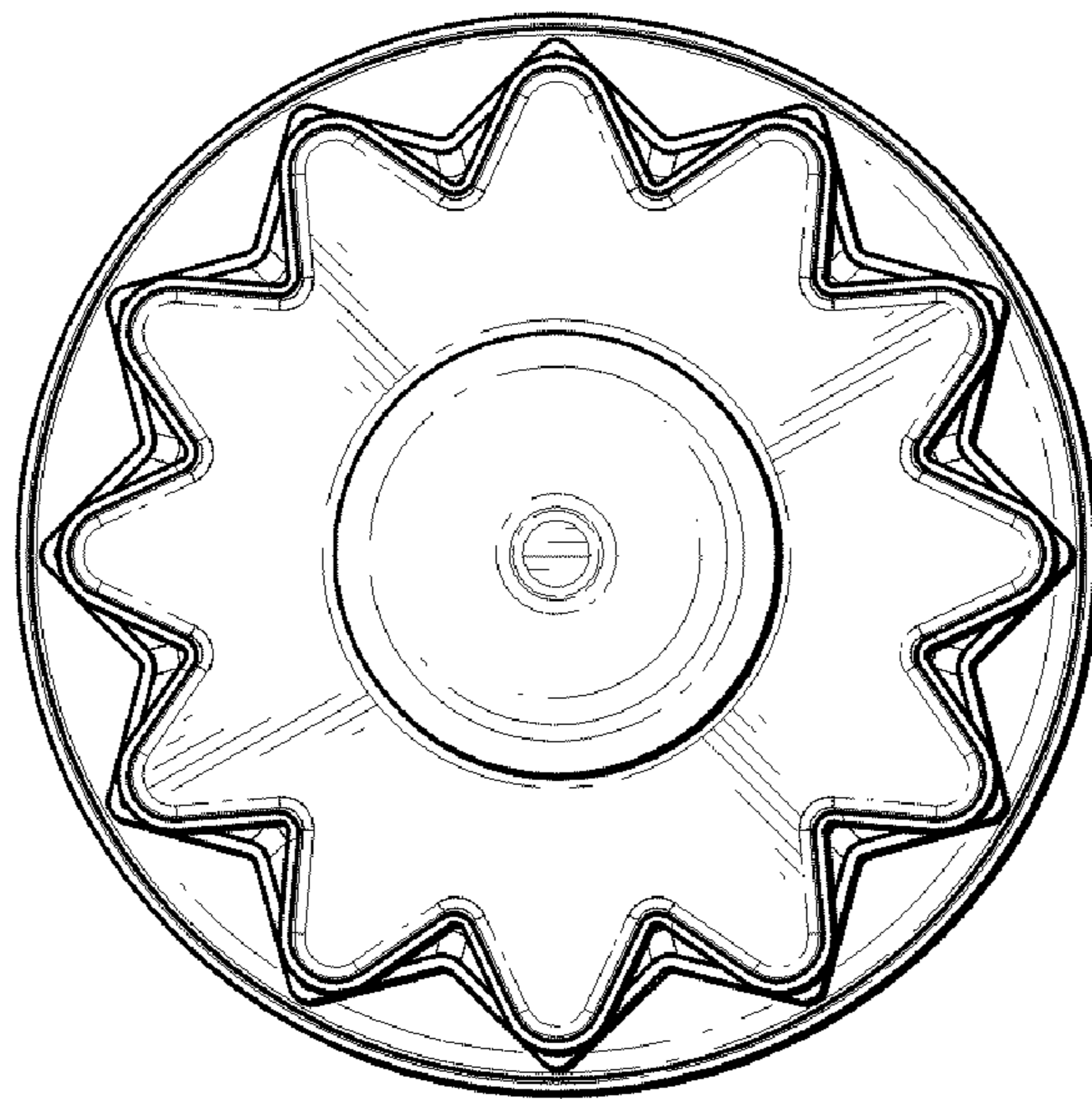

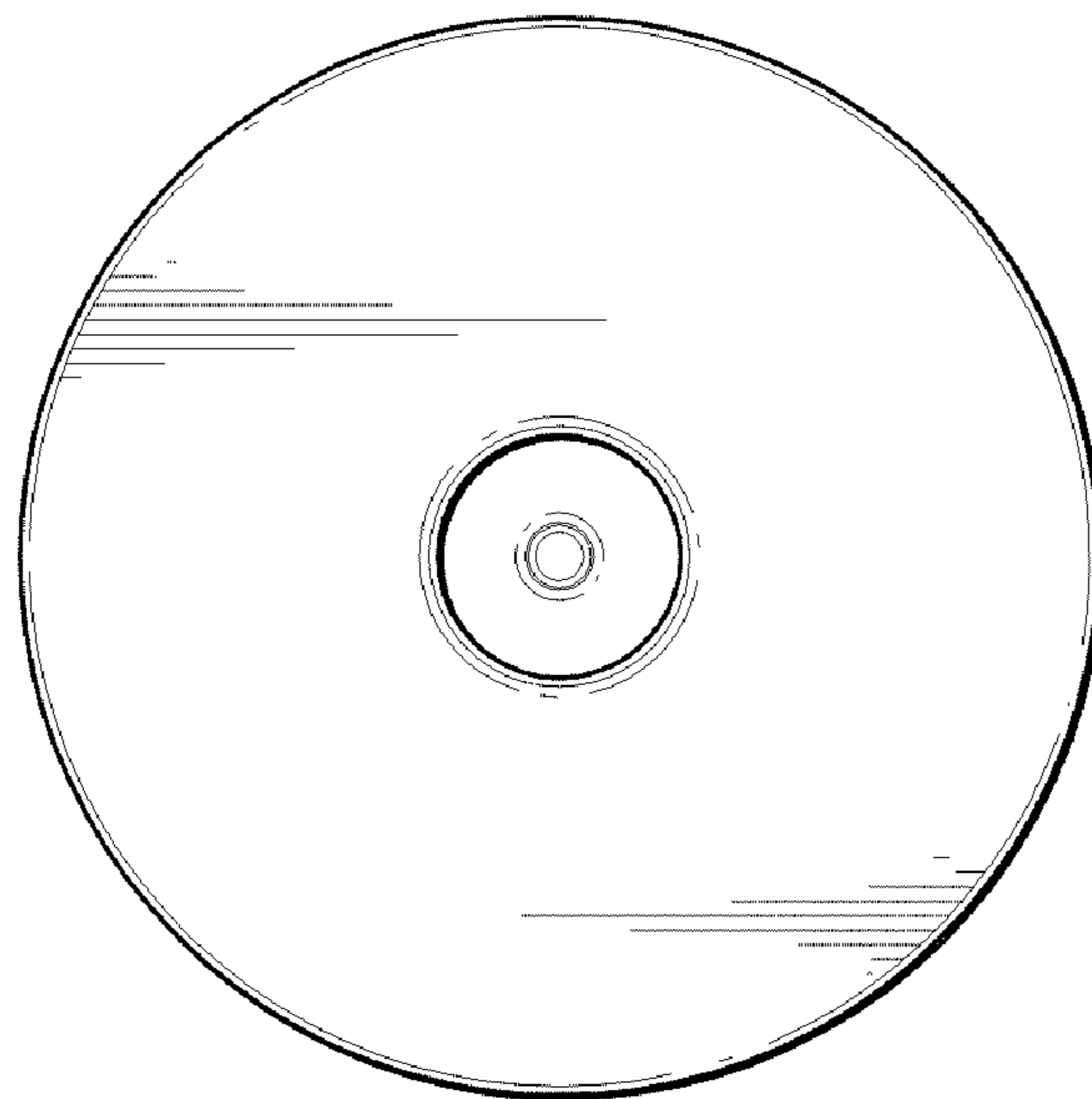
