DESCRIPTION

FIG. 1 is a perspective view of my ornamental design;
FIG. 2 is a top plan view of the ornamental design of FIG. 1;
FIG. 3 is a bottom plan view of the ornamental design of FIG. 1; and
FIG. 4 is a right side elevation view of the ornamental design of FIG. 1; and,
FIG. 5 is a left side elevation view of the ornamental design of FIG. 1.

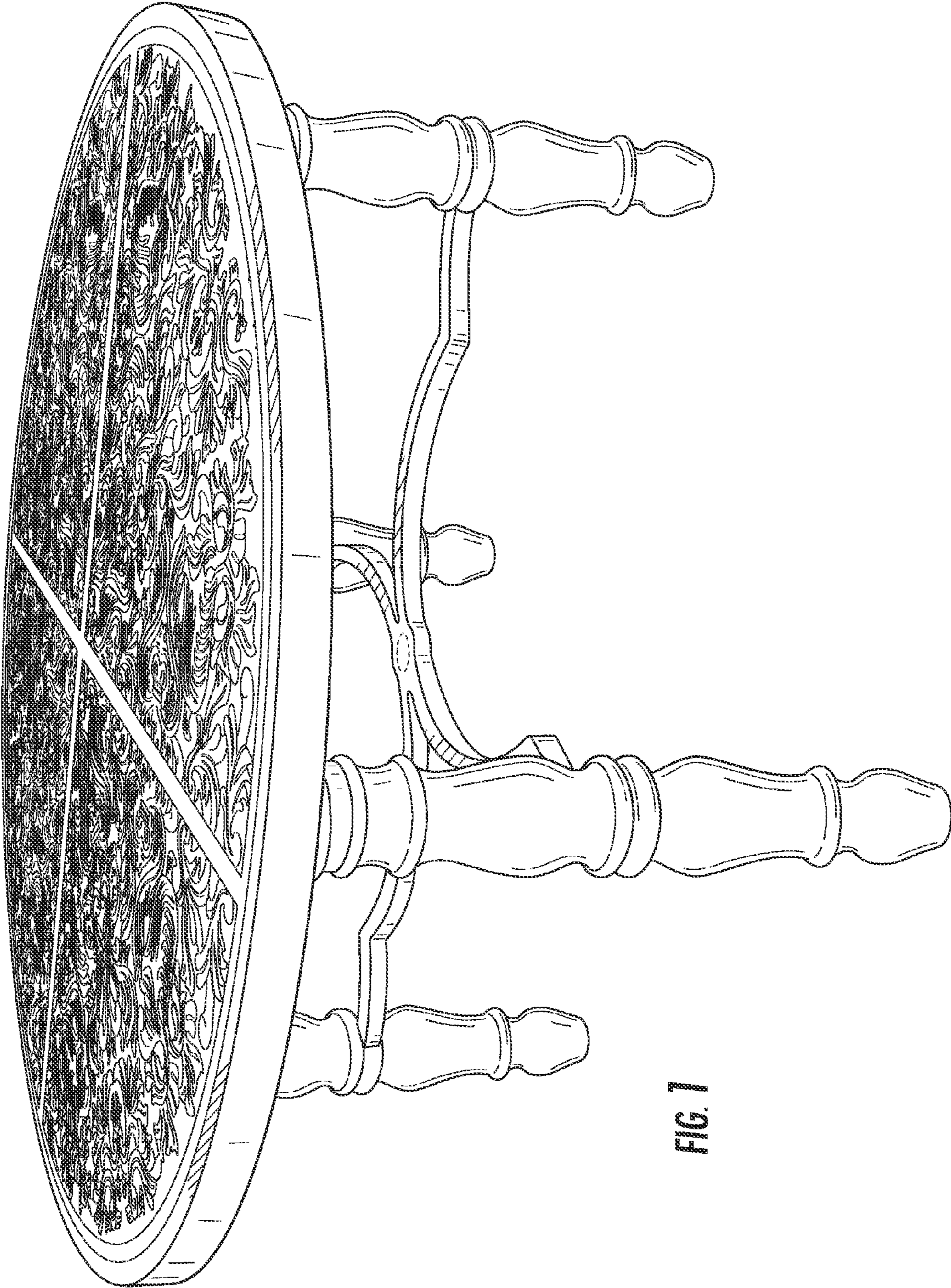

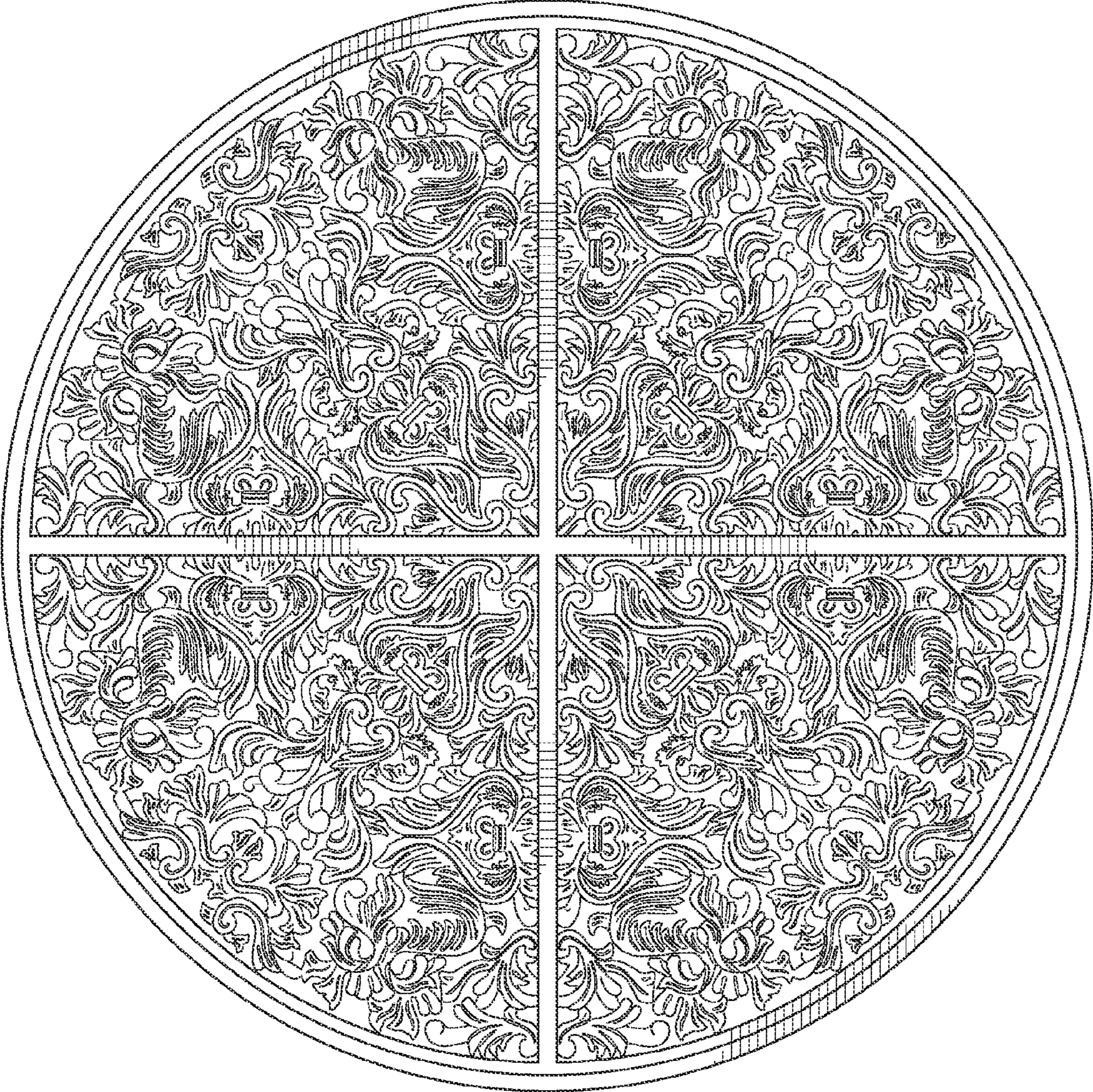

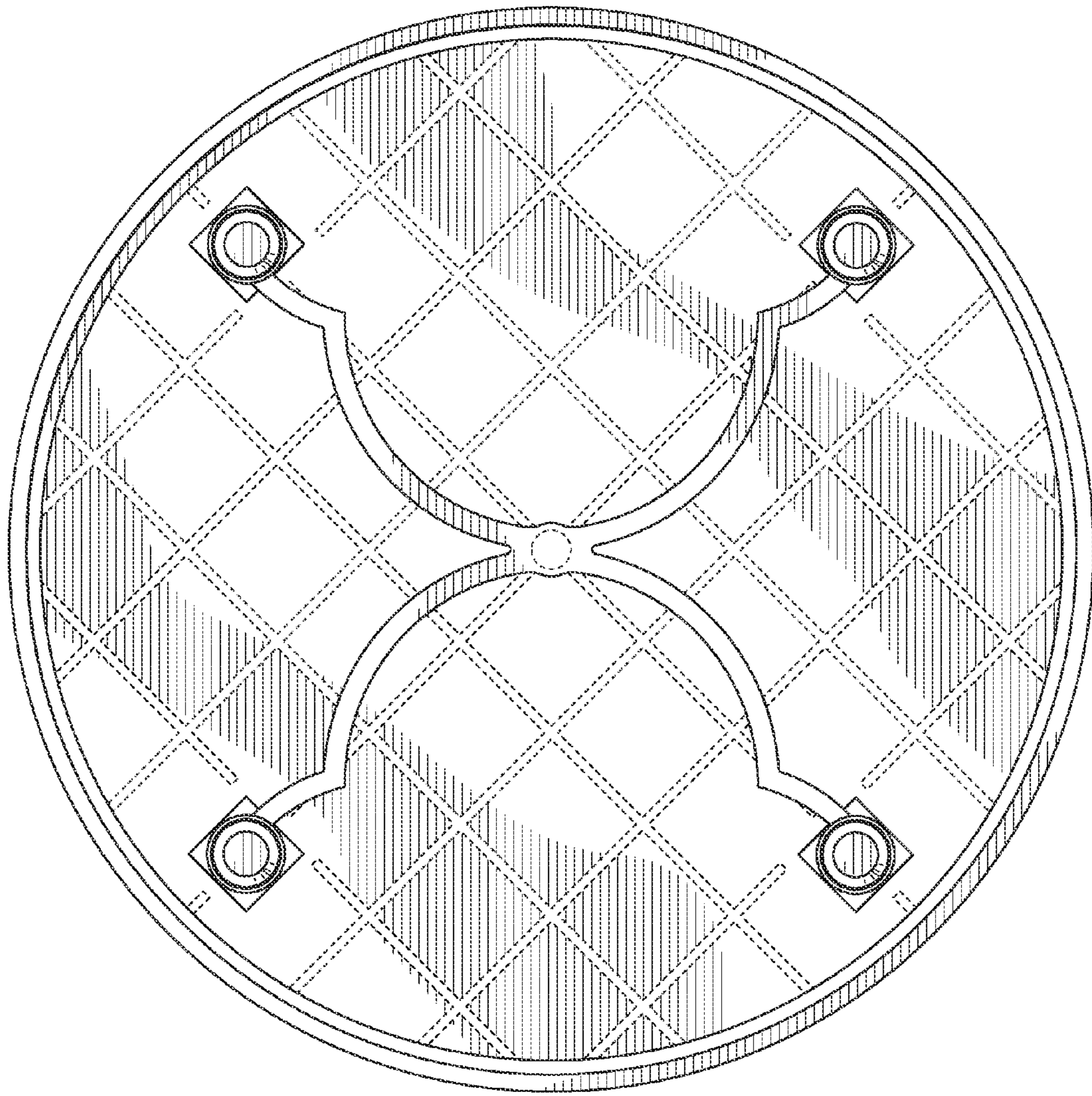

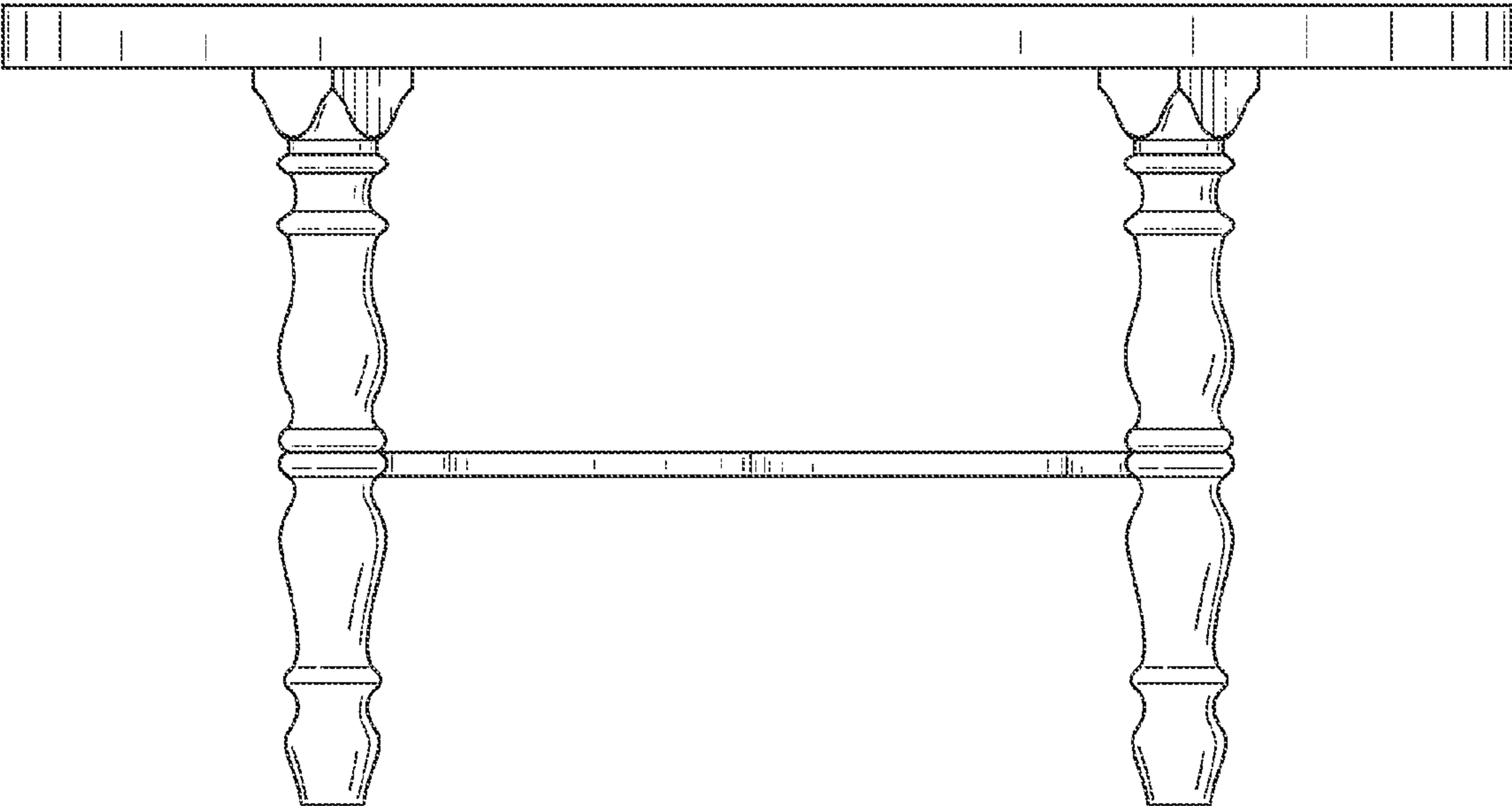

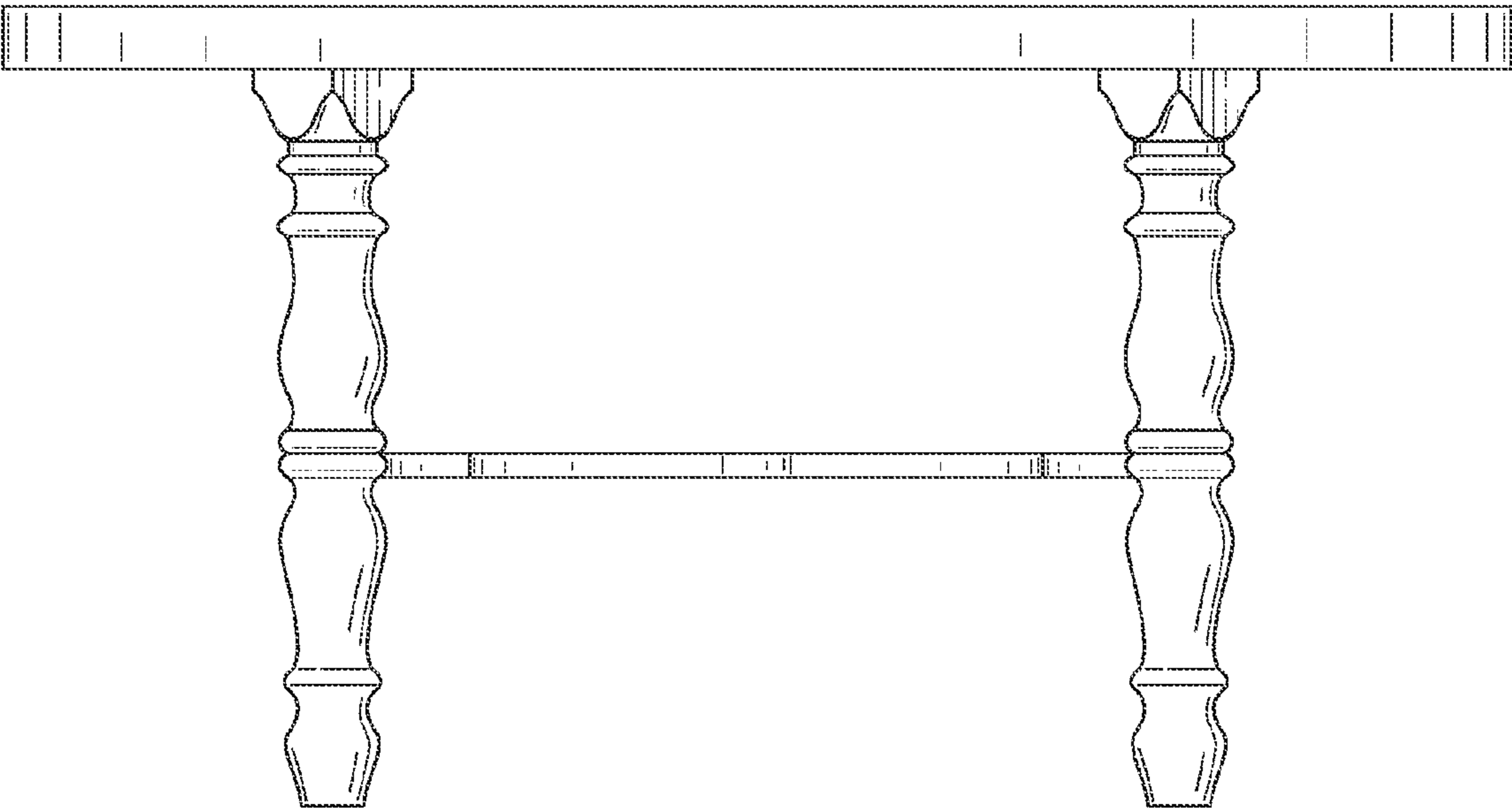
