**DESCRIPTION**

FIG. 1 is a perspective view of a mail and key ring holder showing my new design;  
FIG. 2 is a front elevational view thereof;

FIG. 7 is a top plan view thereof.

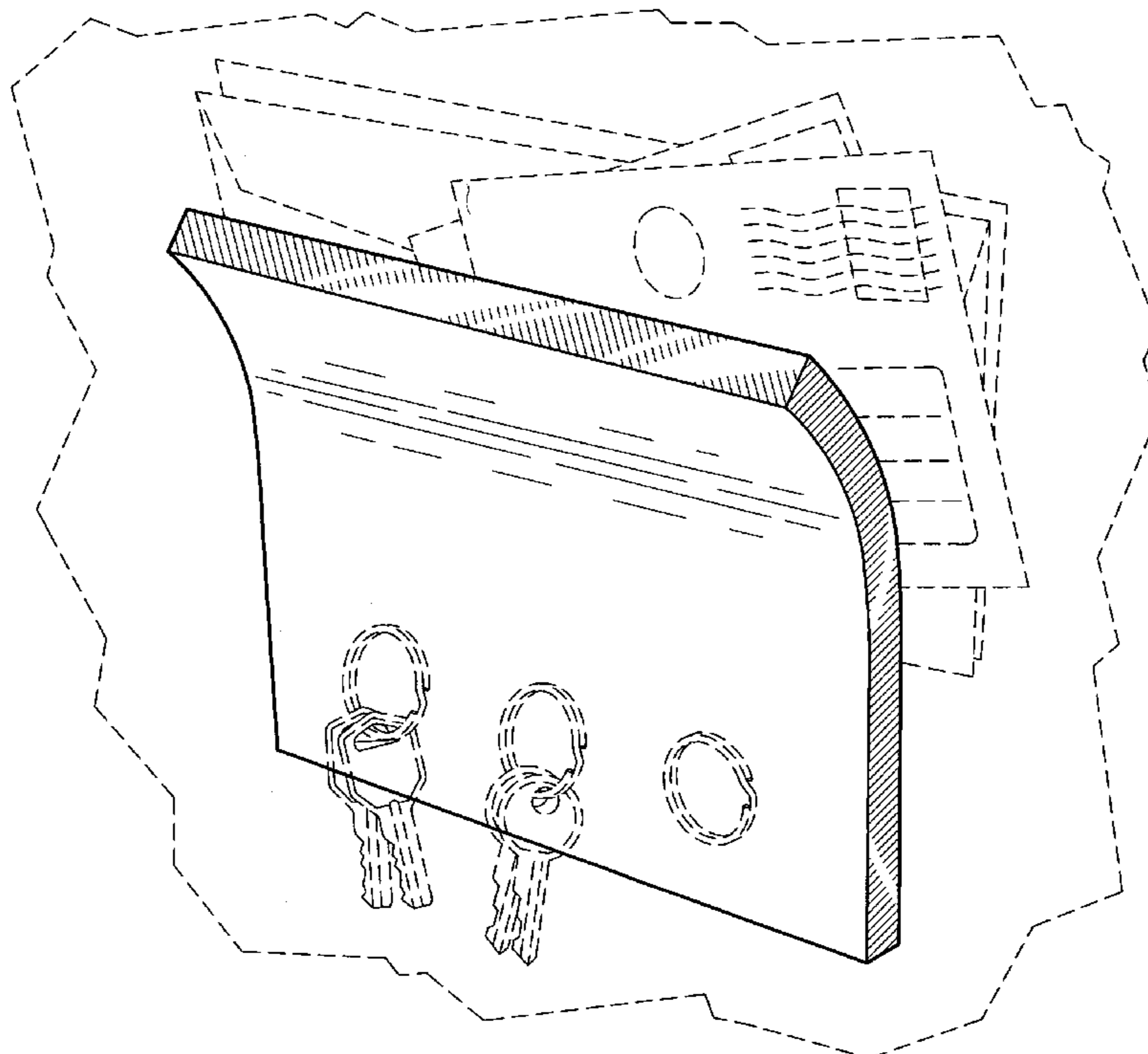
The broken line disclosure of mail items, key rings, keys, and wall fragment in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

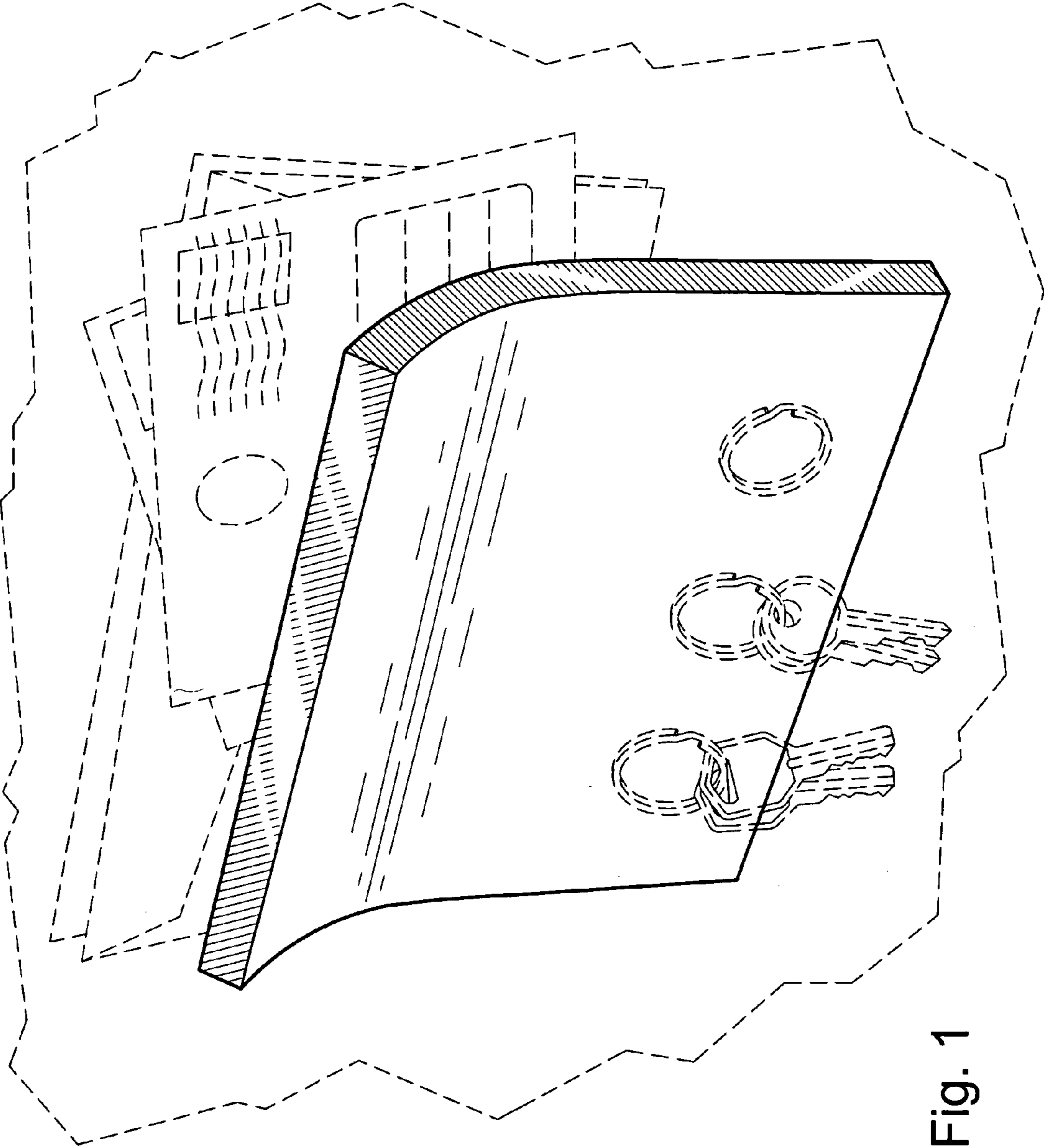

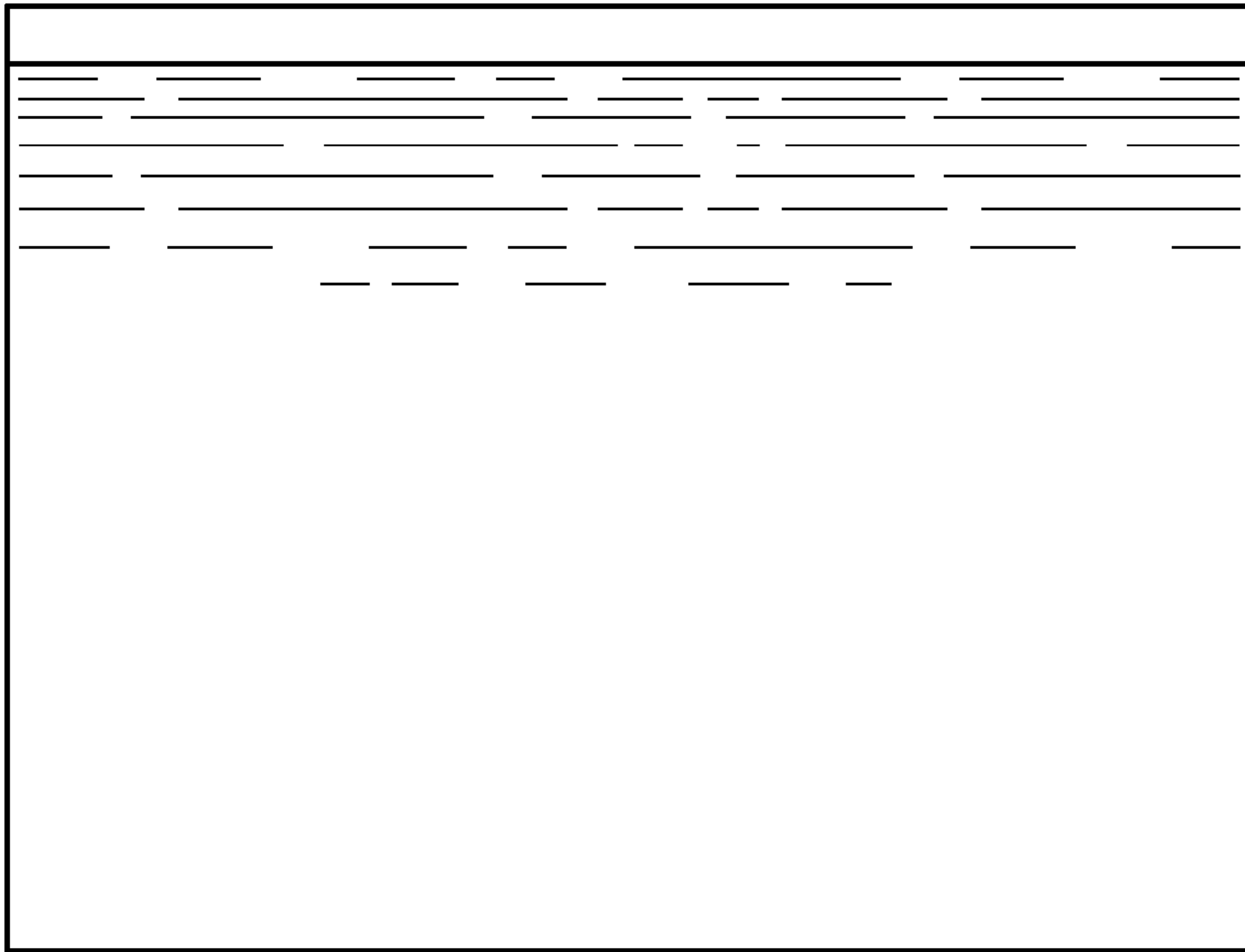

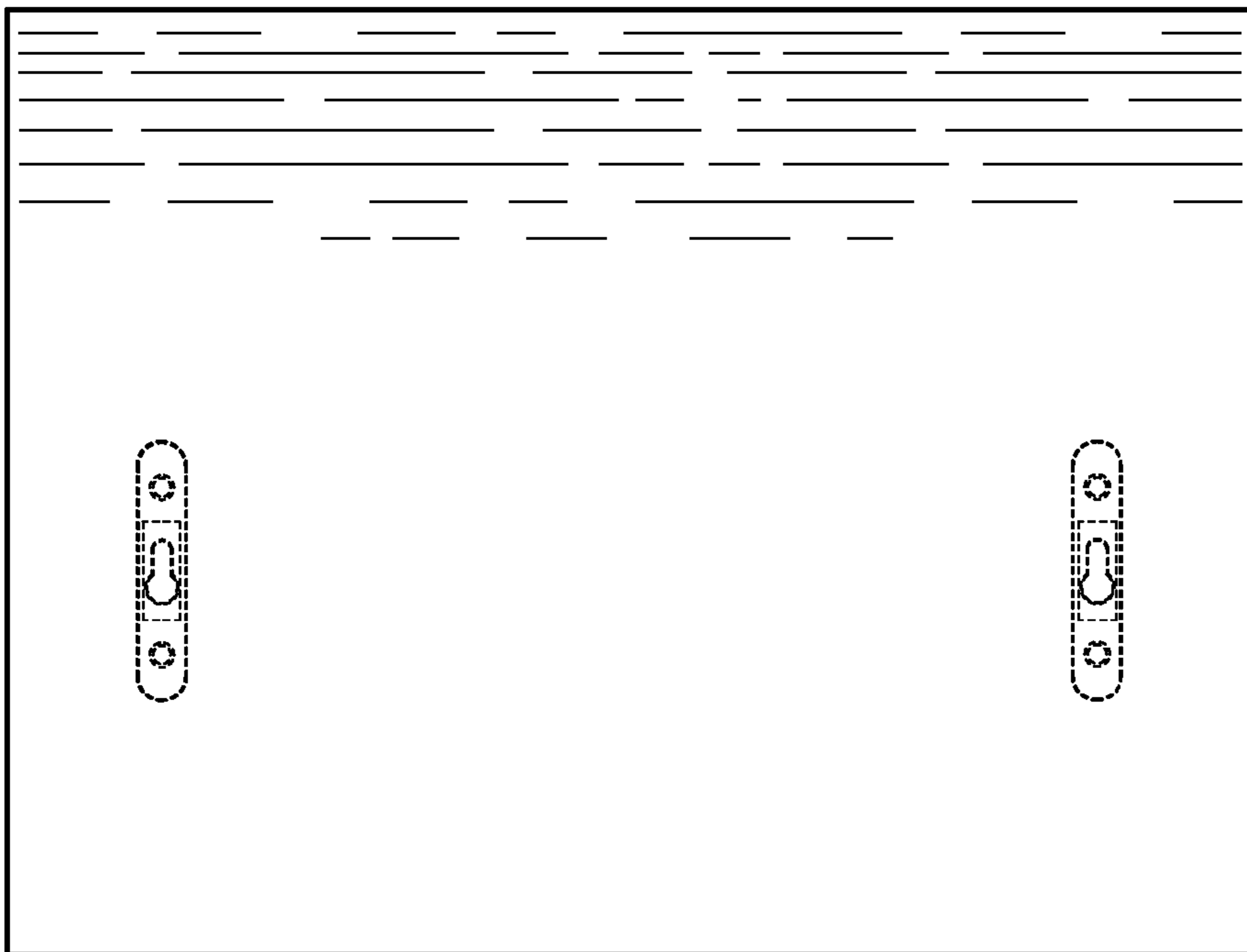

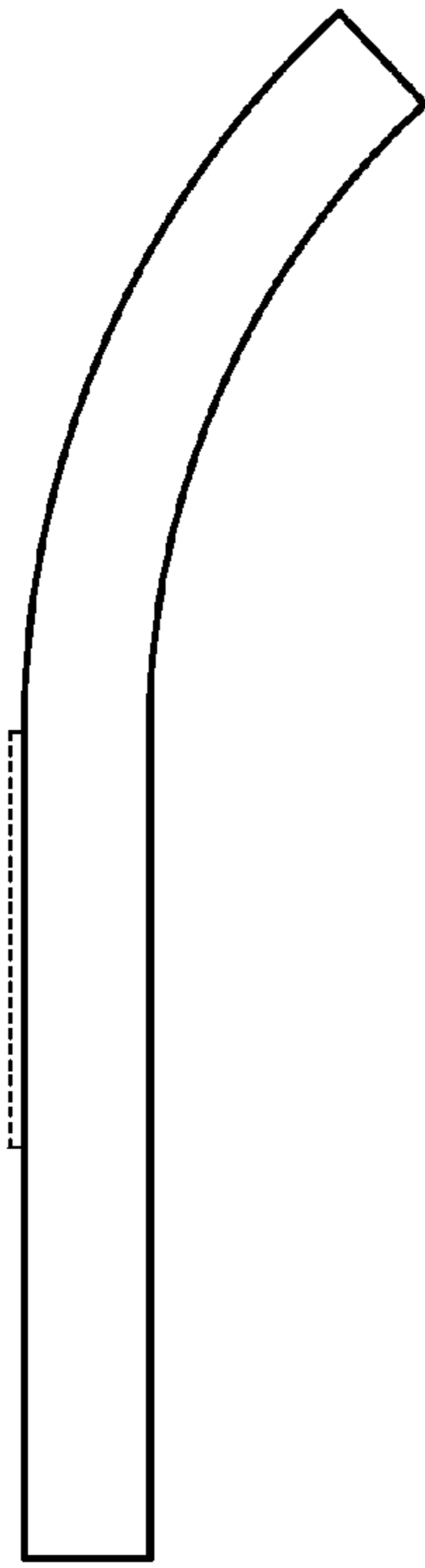

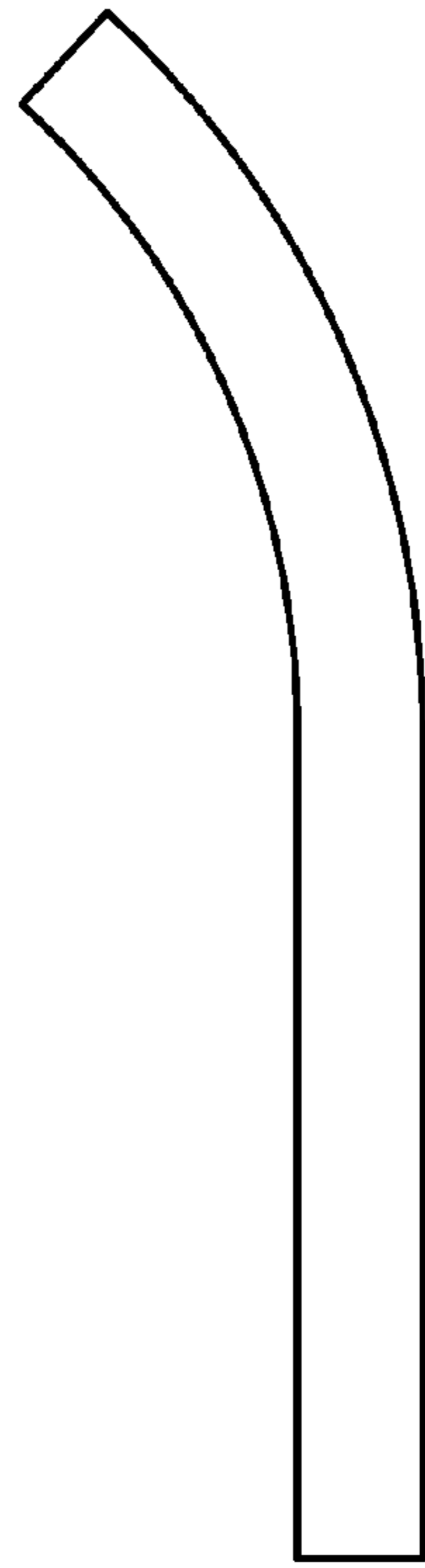

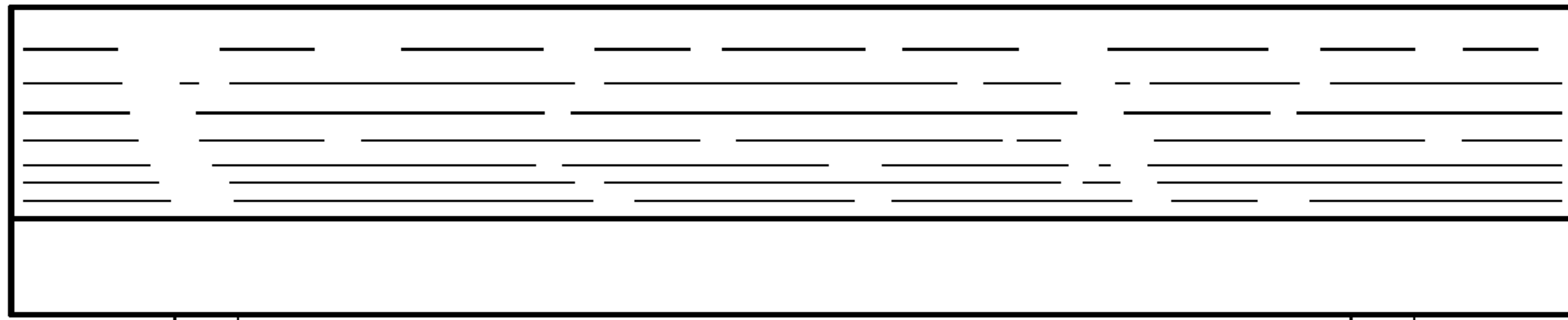

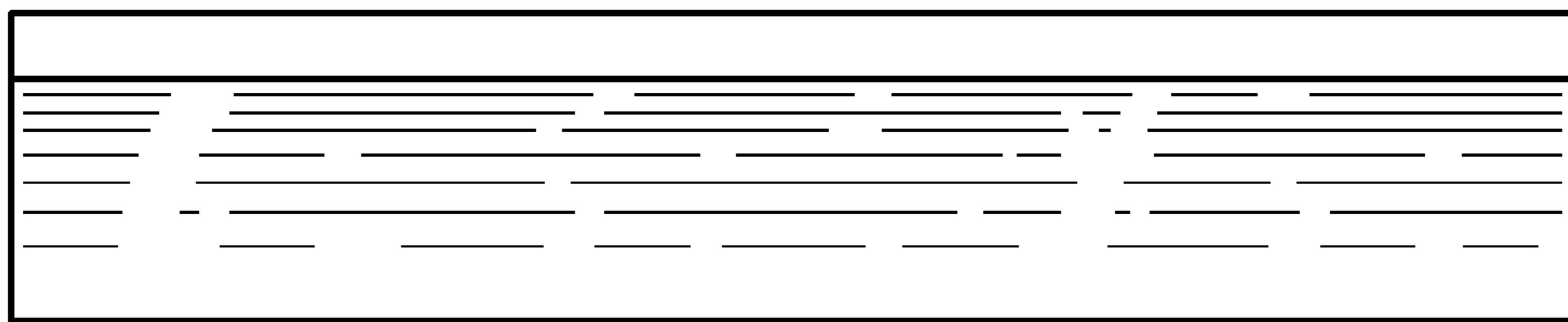
