DESCRIPTION

FIG. 1 is a perspective view of a water filter showing our new design;

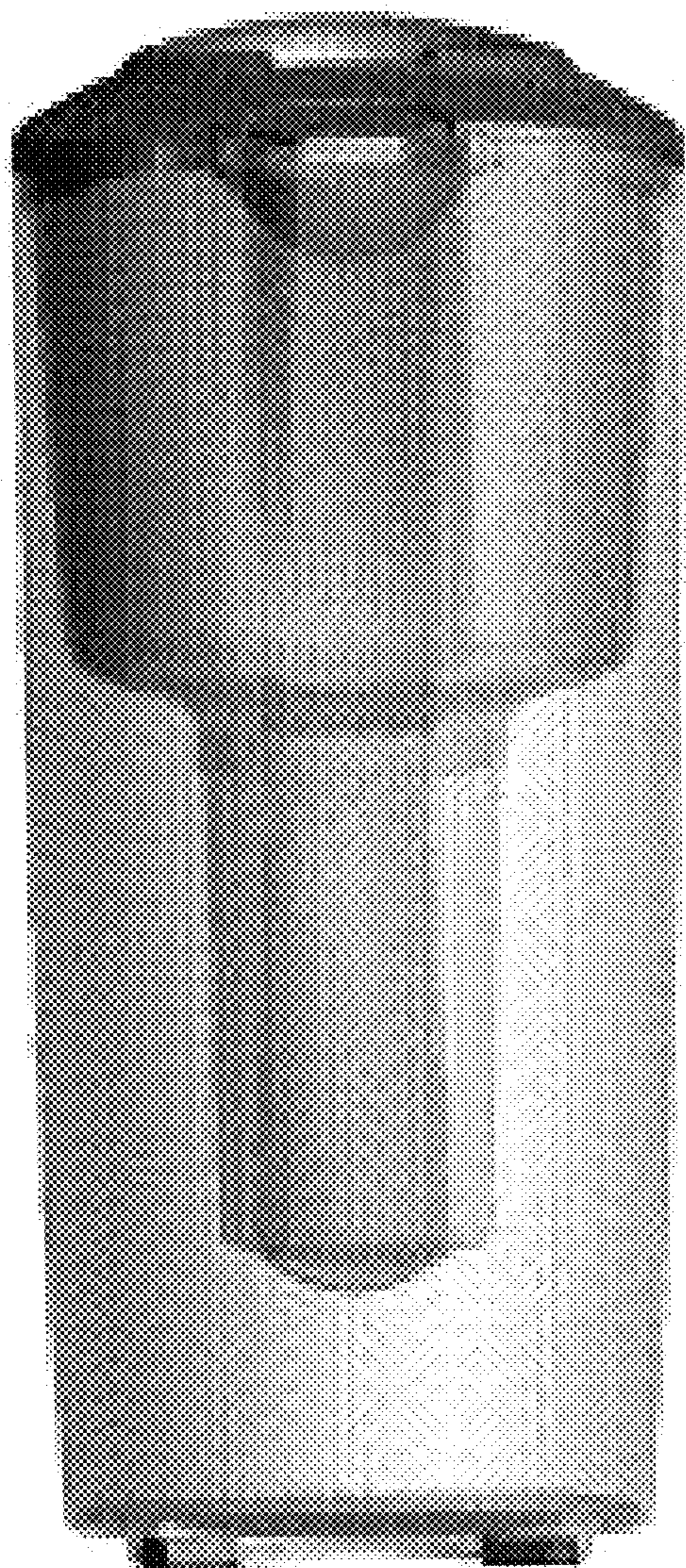

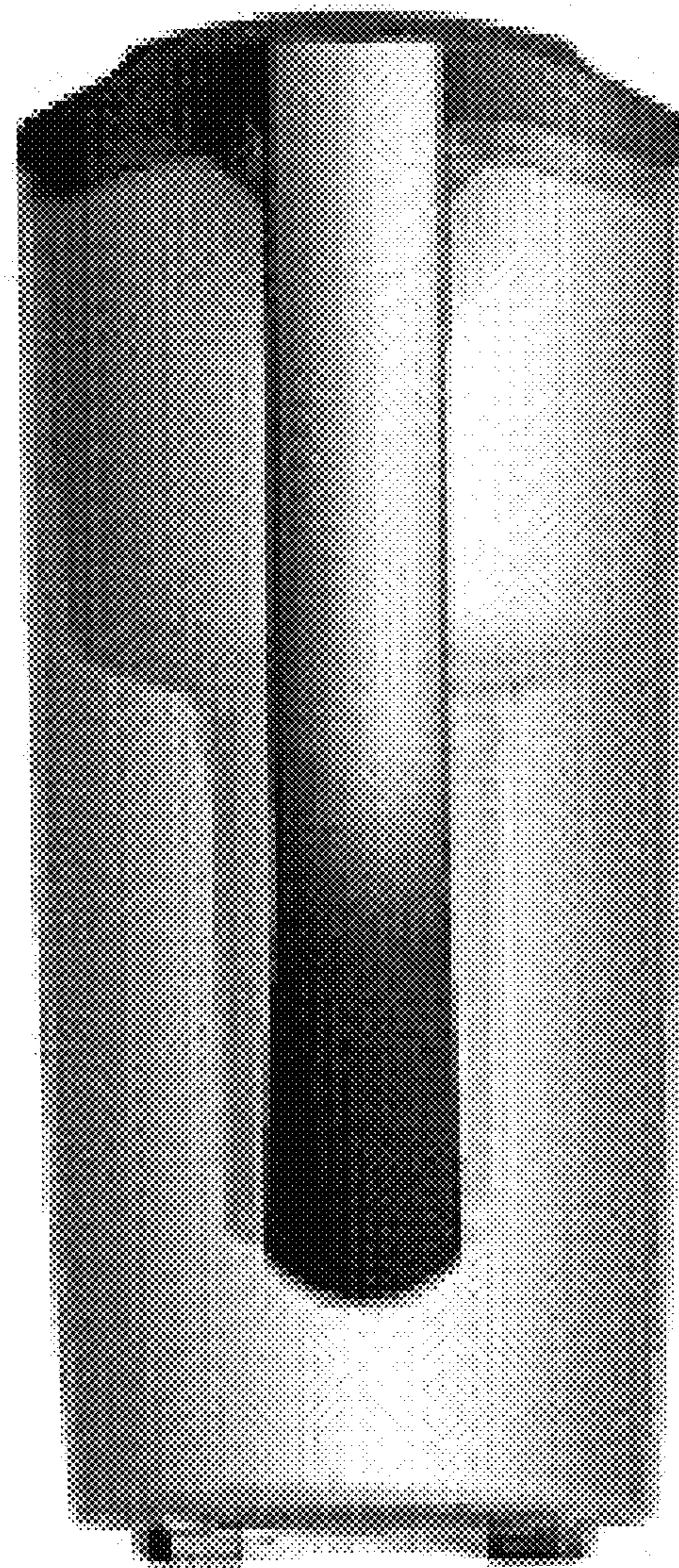

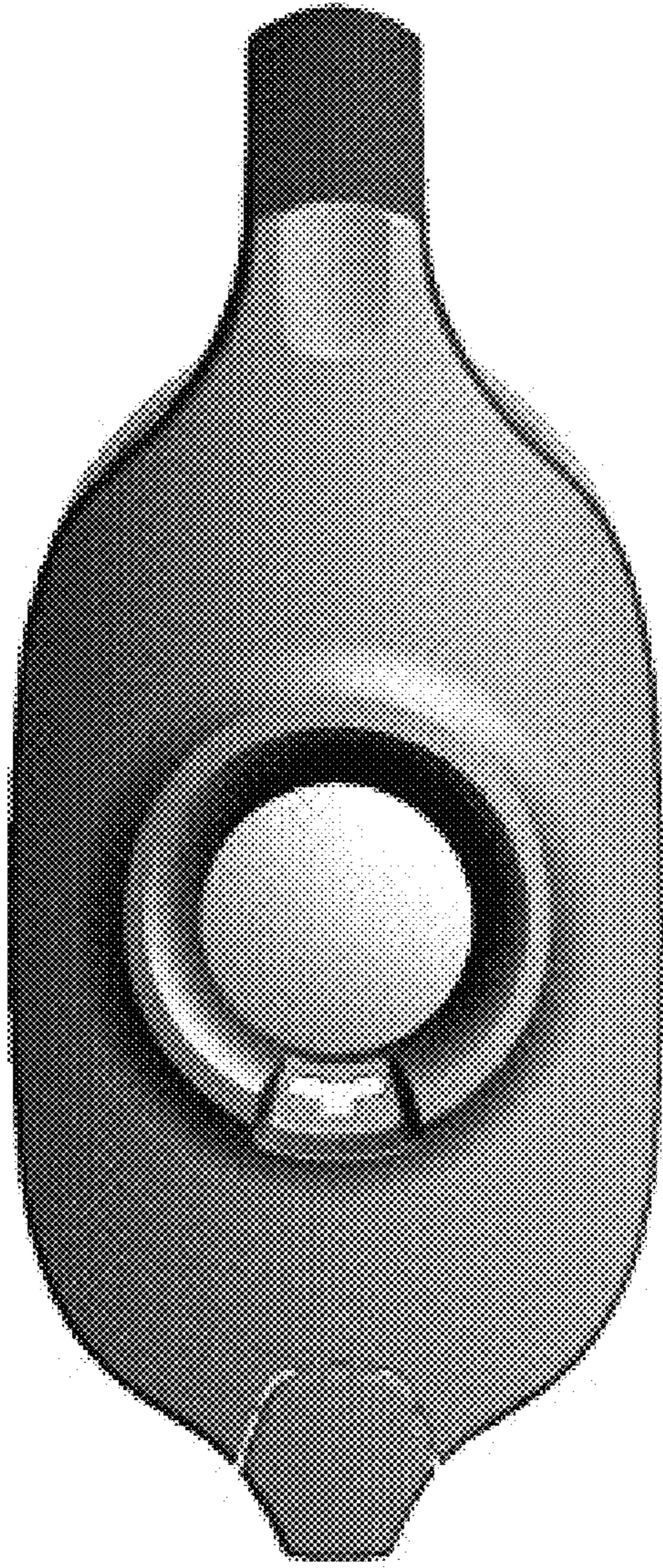

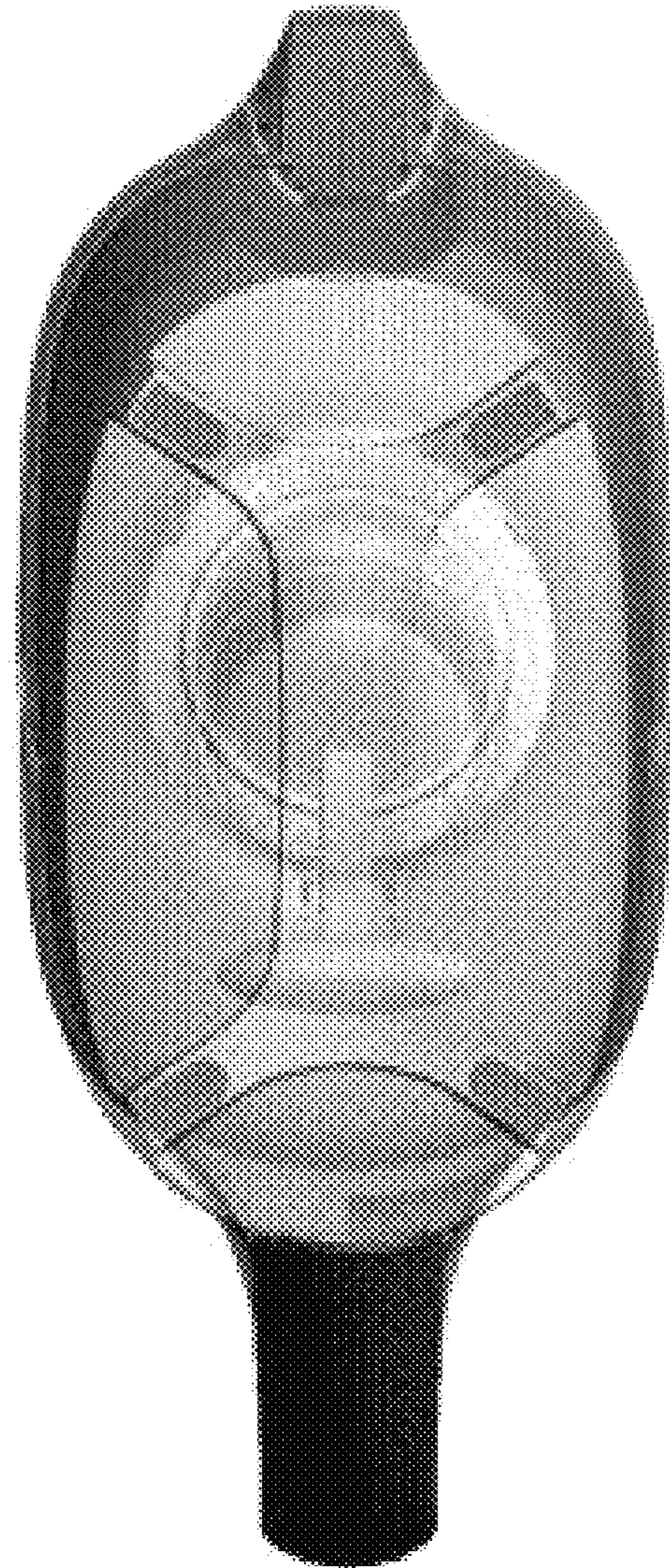
