(57) **CLAIM**

The ornamental design for the electric nut warmer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the entire electric nut warmer showing my new design;

FIG. 2 is a top perspective view of a lower portion, shown without the top portion for ease of illustration;

FIG. 3 is a bottom plan view of the lower portion thereof;

FIG. 4 is a top perspective view of an upper portion, shown without the top cover and bottom portion for ease of illustration;

FIG. 5 is a front perspective view of a cover of the upper portion, shown separately for ease of illustration;

FIG. 6 is a top plan view thereof;

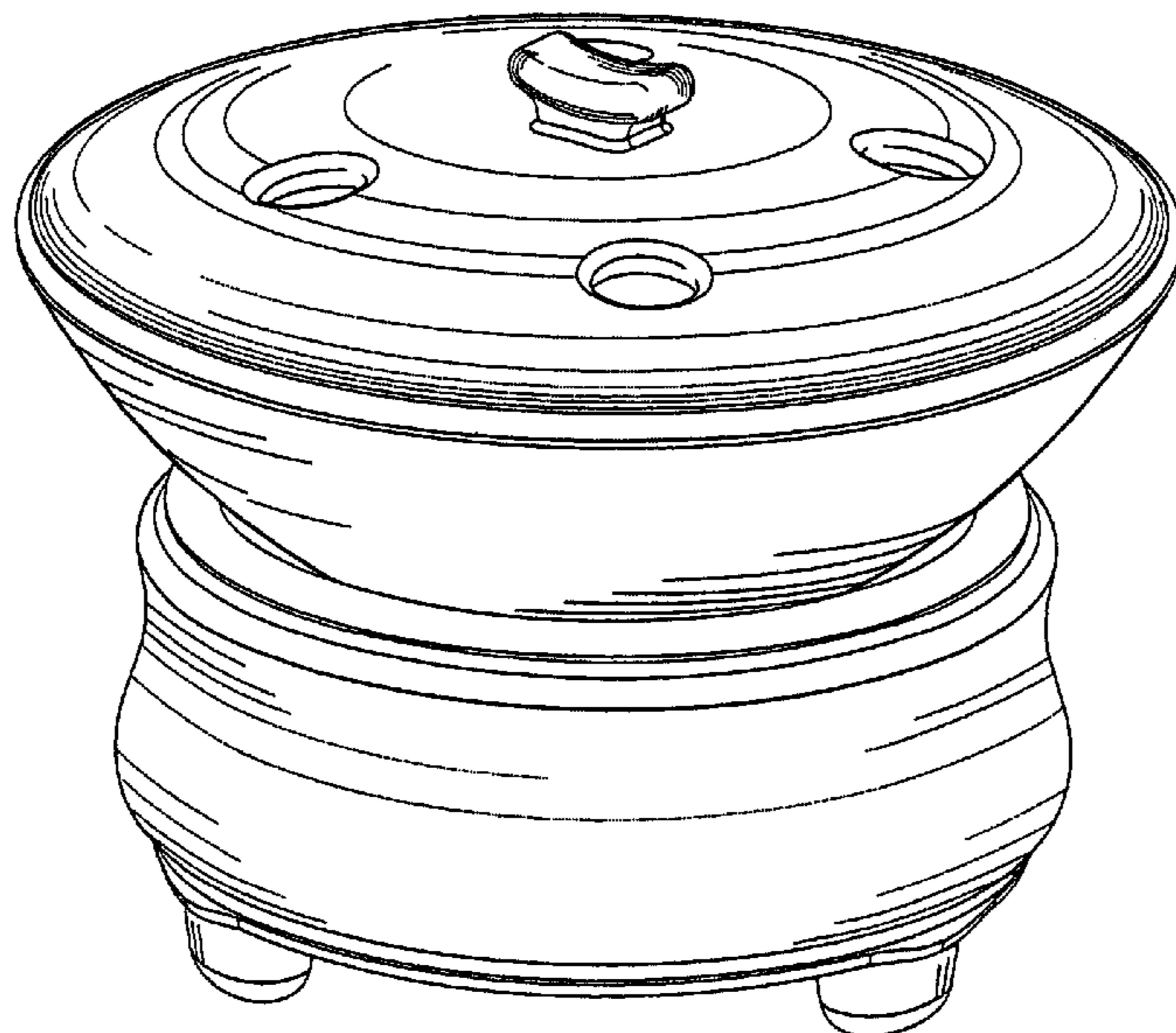
FIG. 7 is a top perspective view of the entire design thereof;

FIG. 8 is a top plan view of the lower portion, shown without the top cover and the upper portion for ease of illustration;

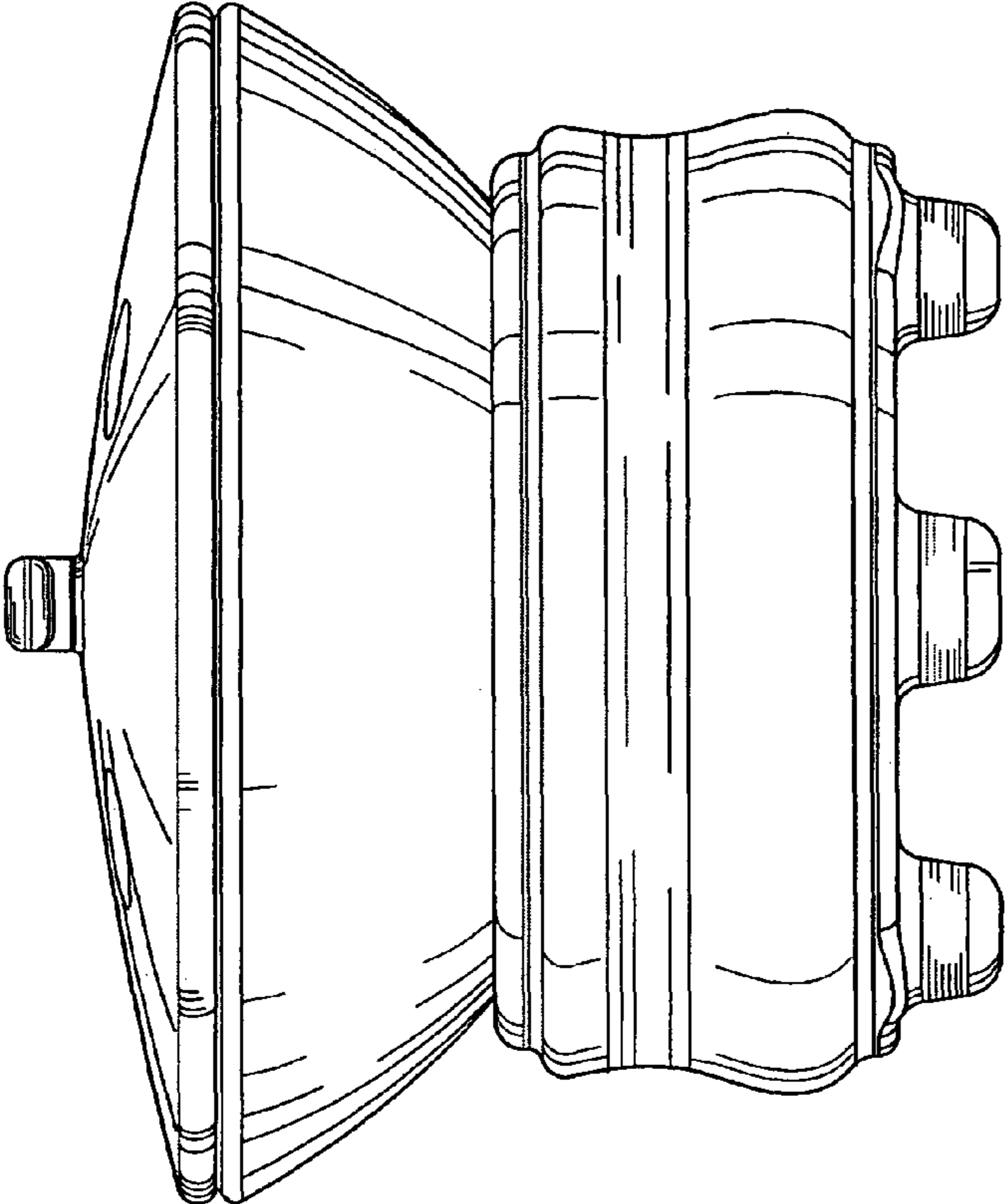

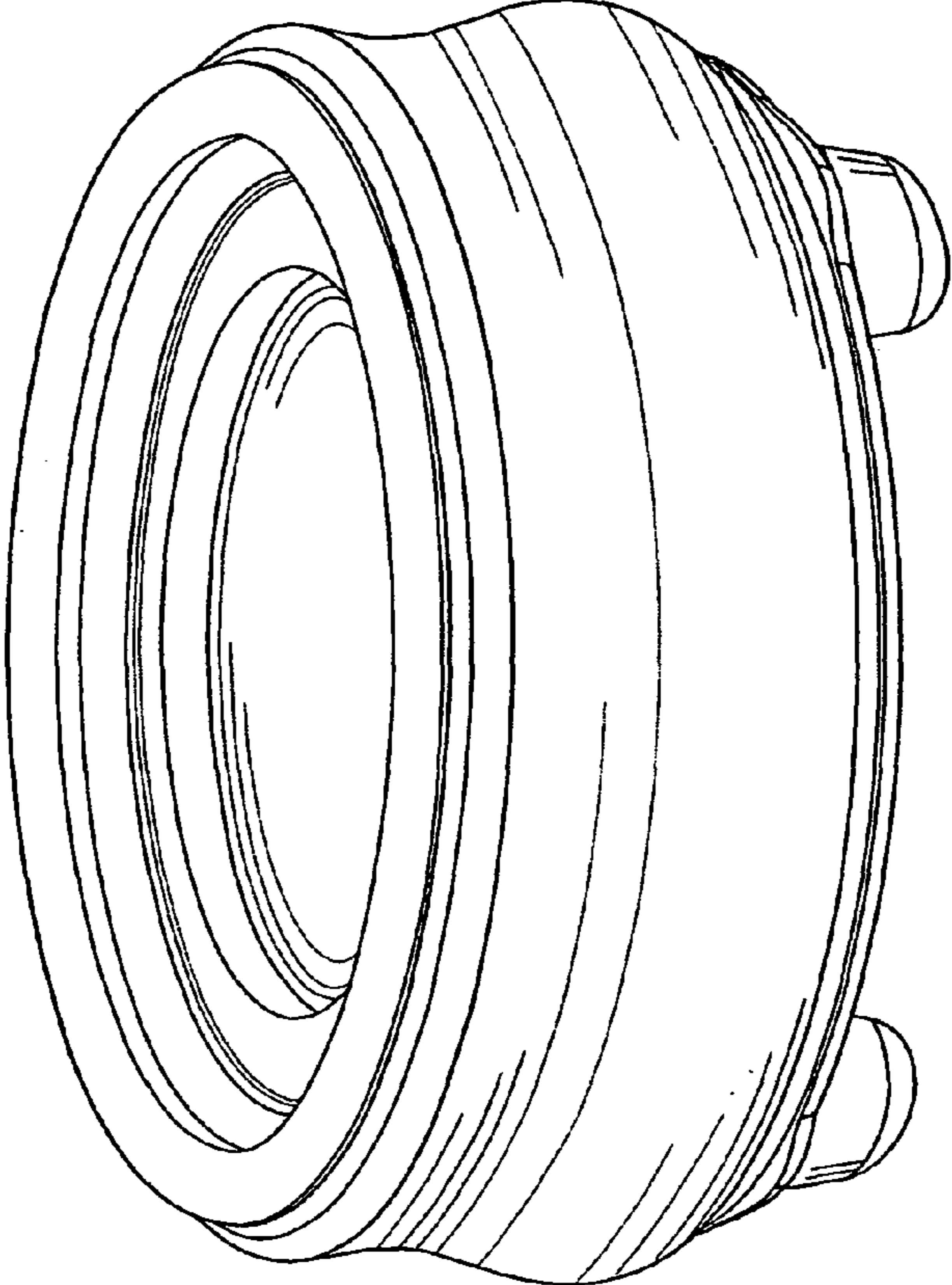

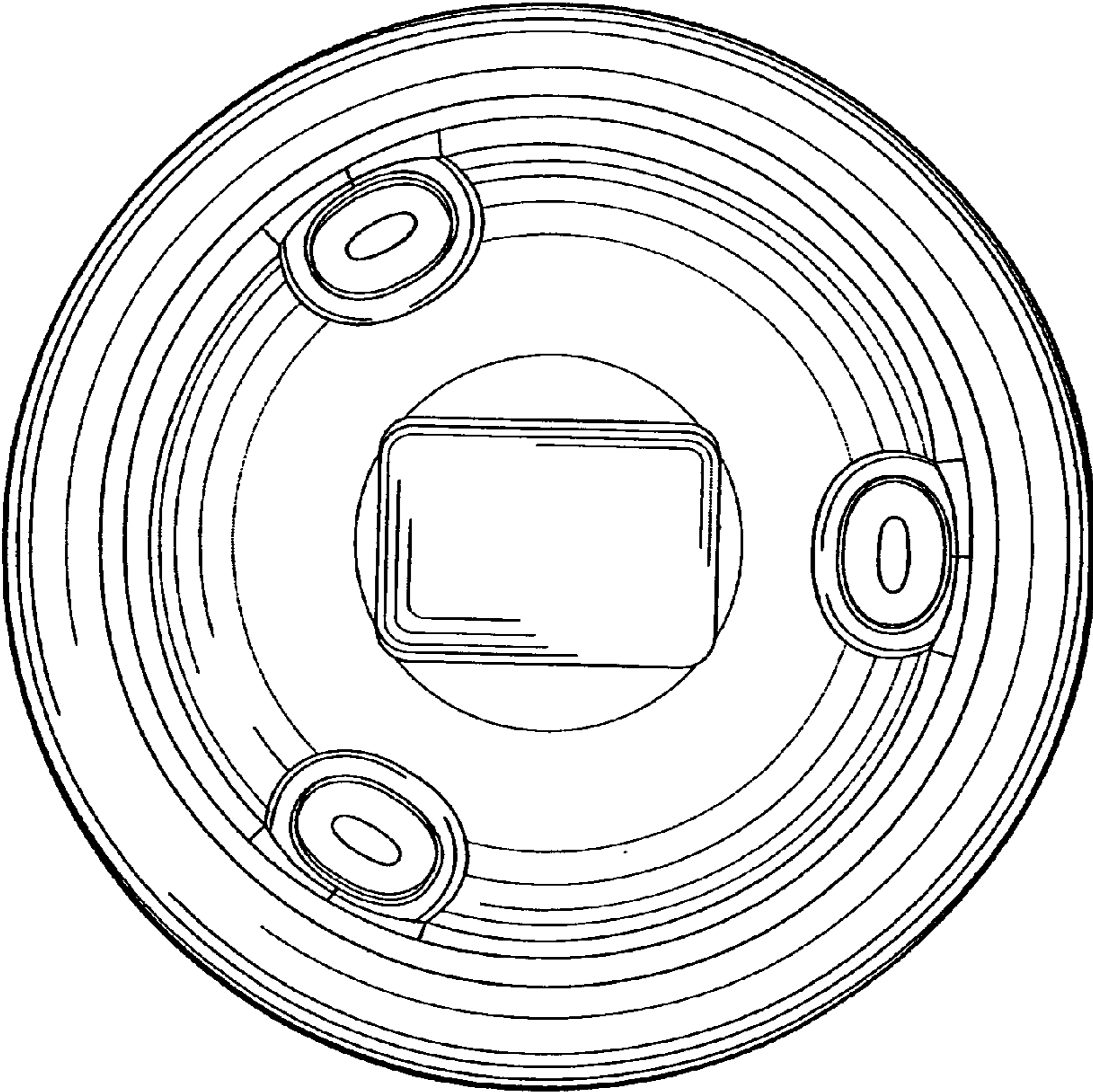

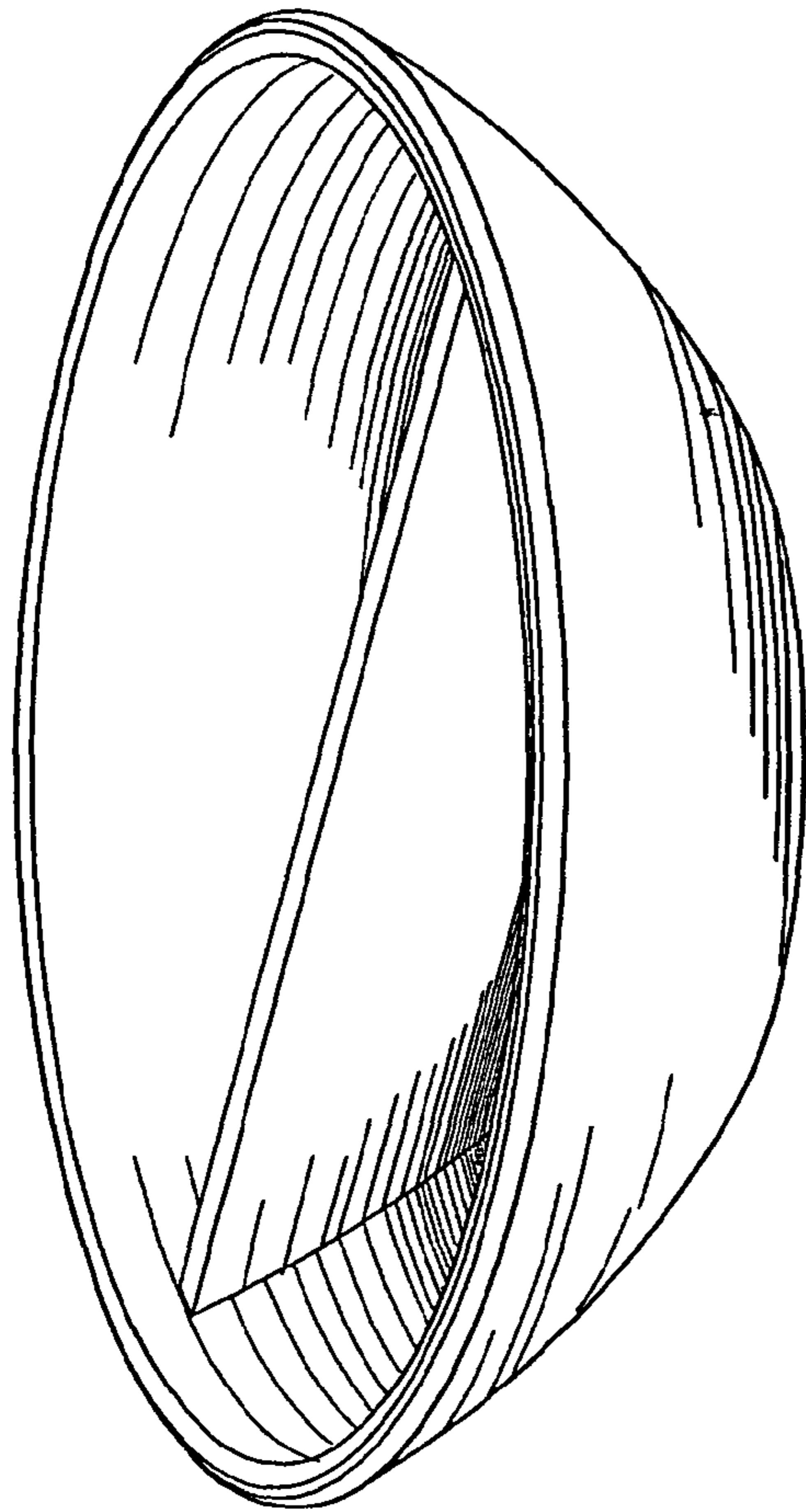

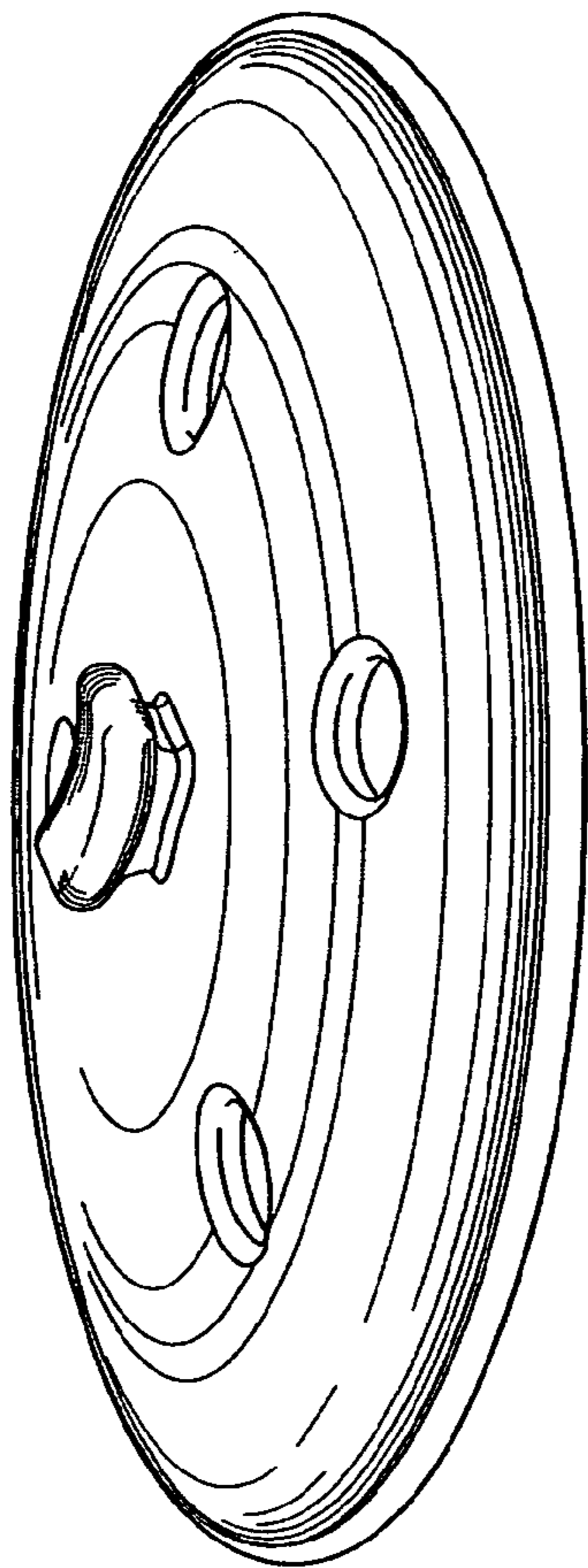

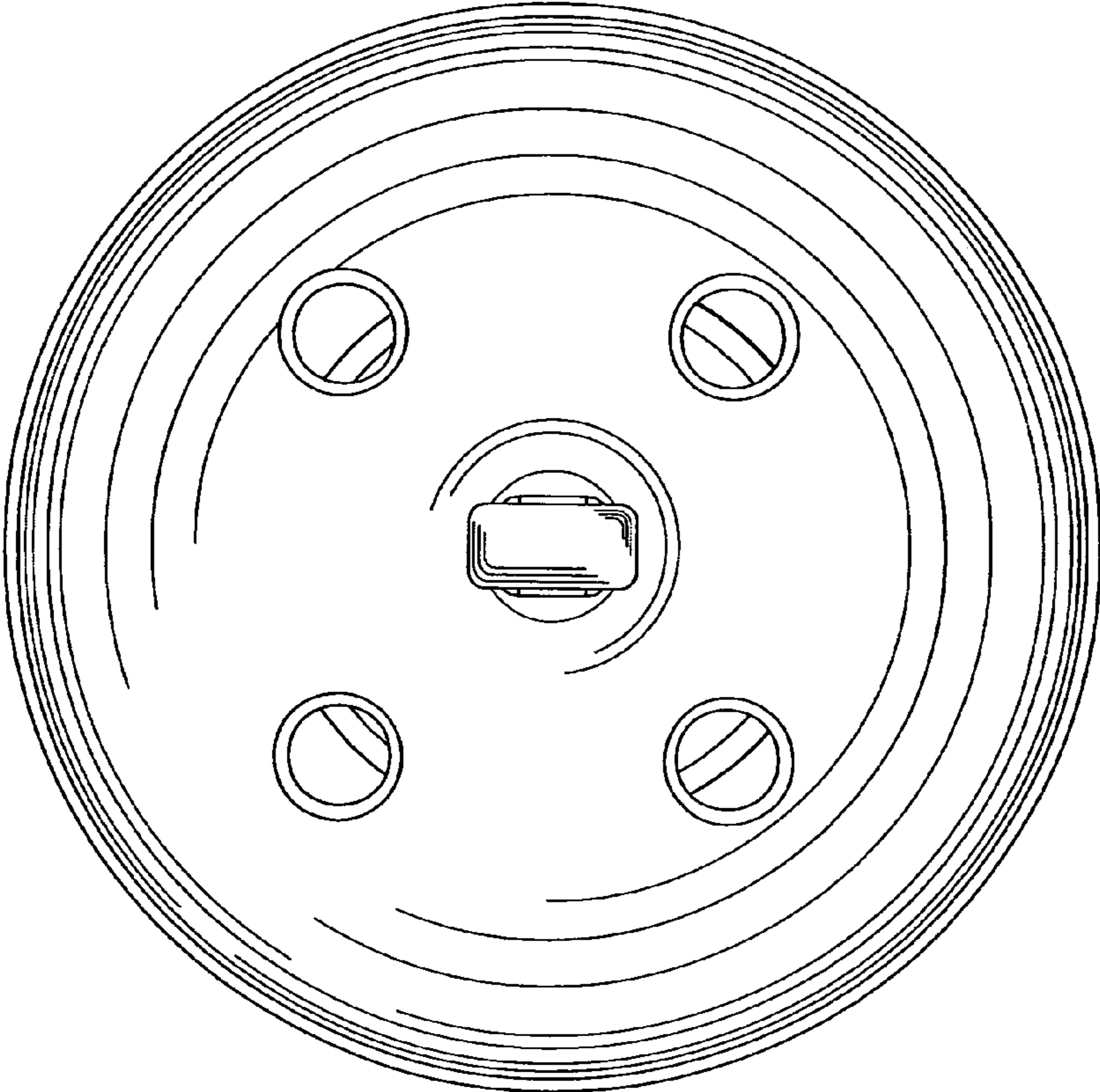

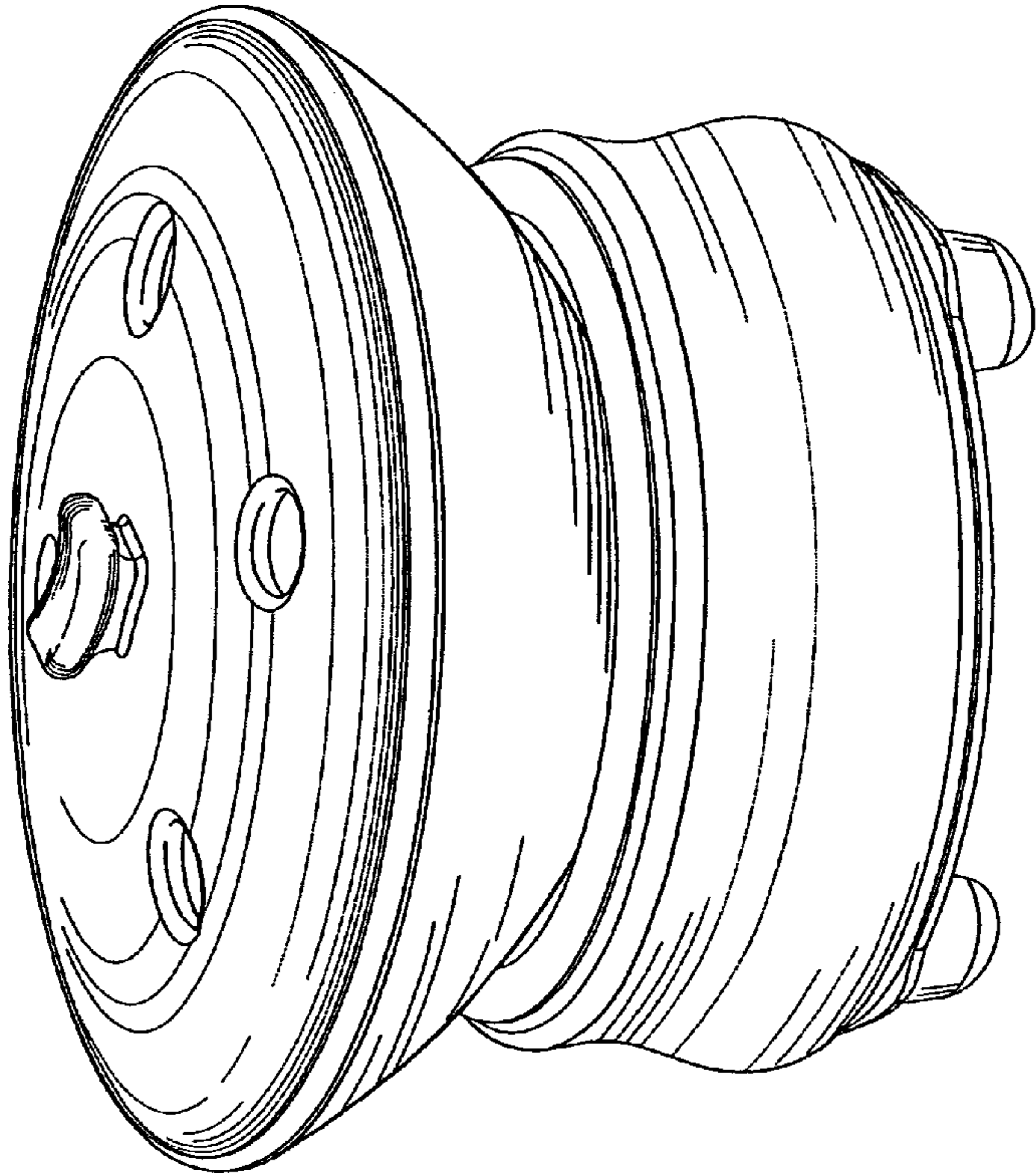

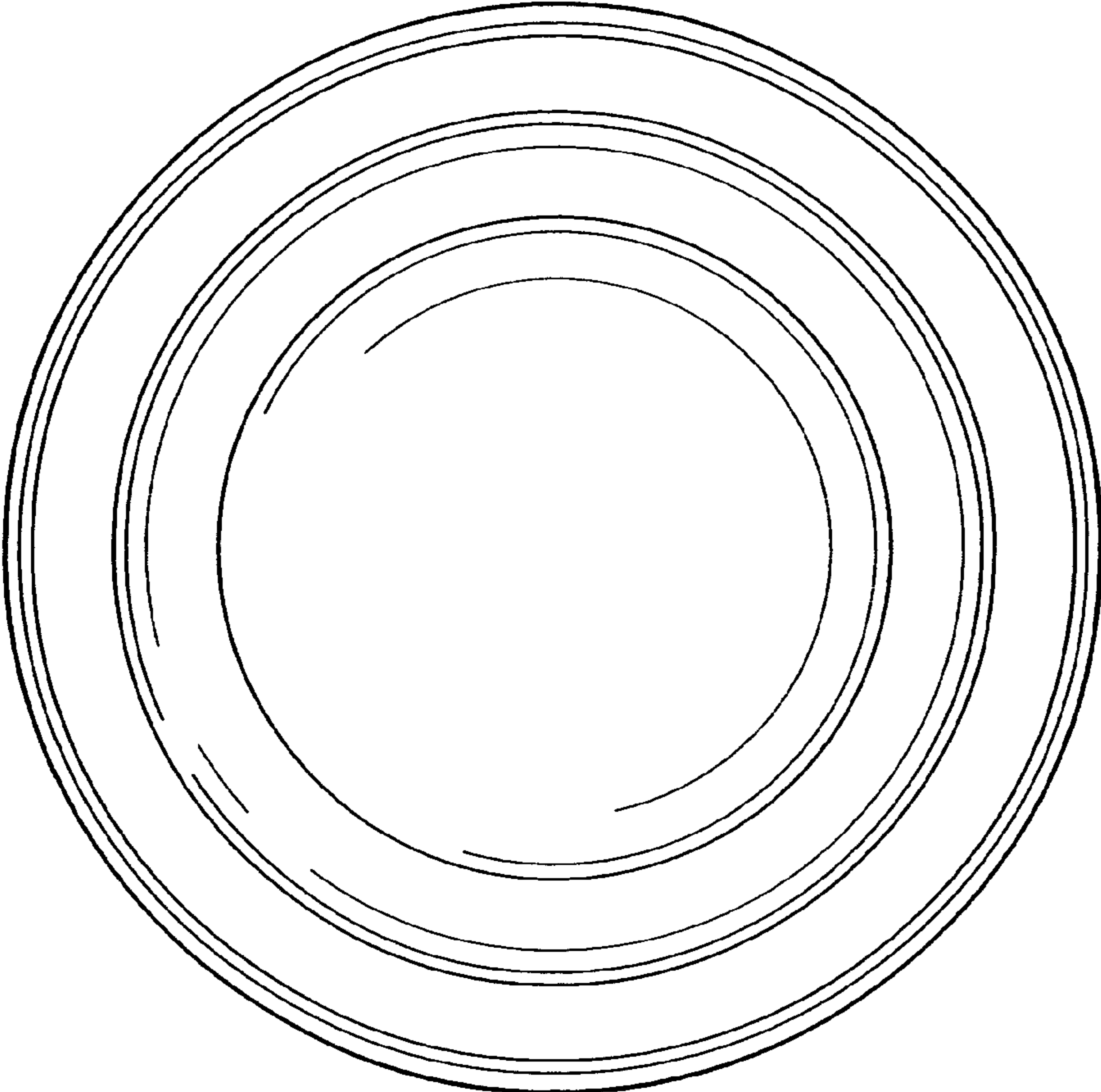

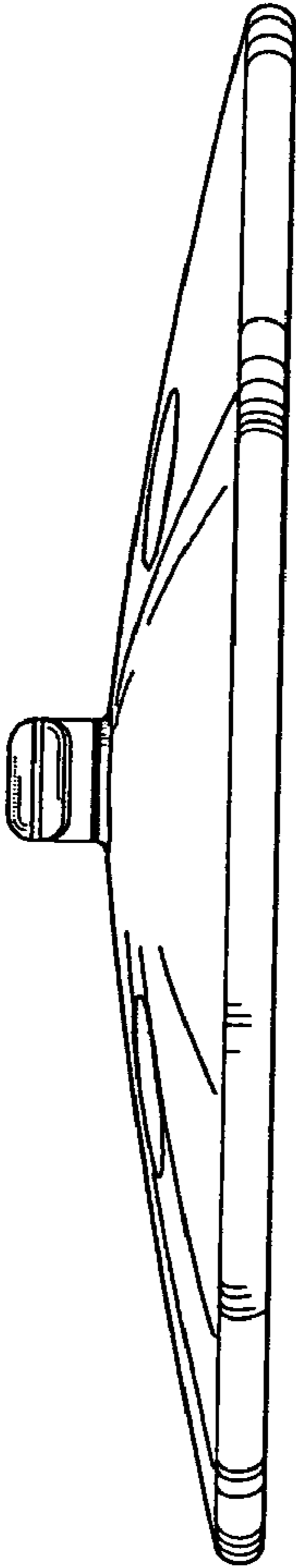

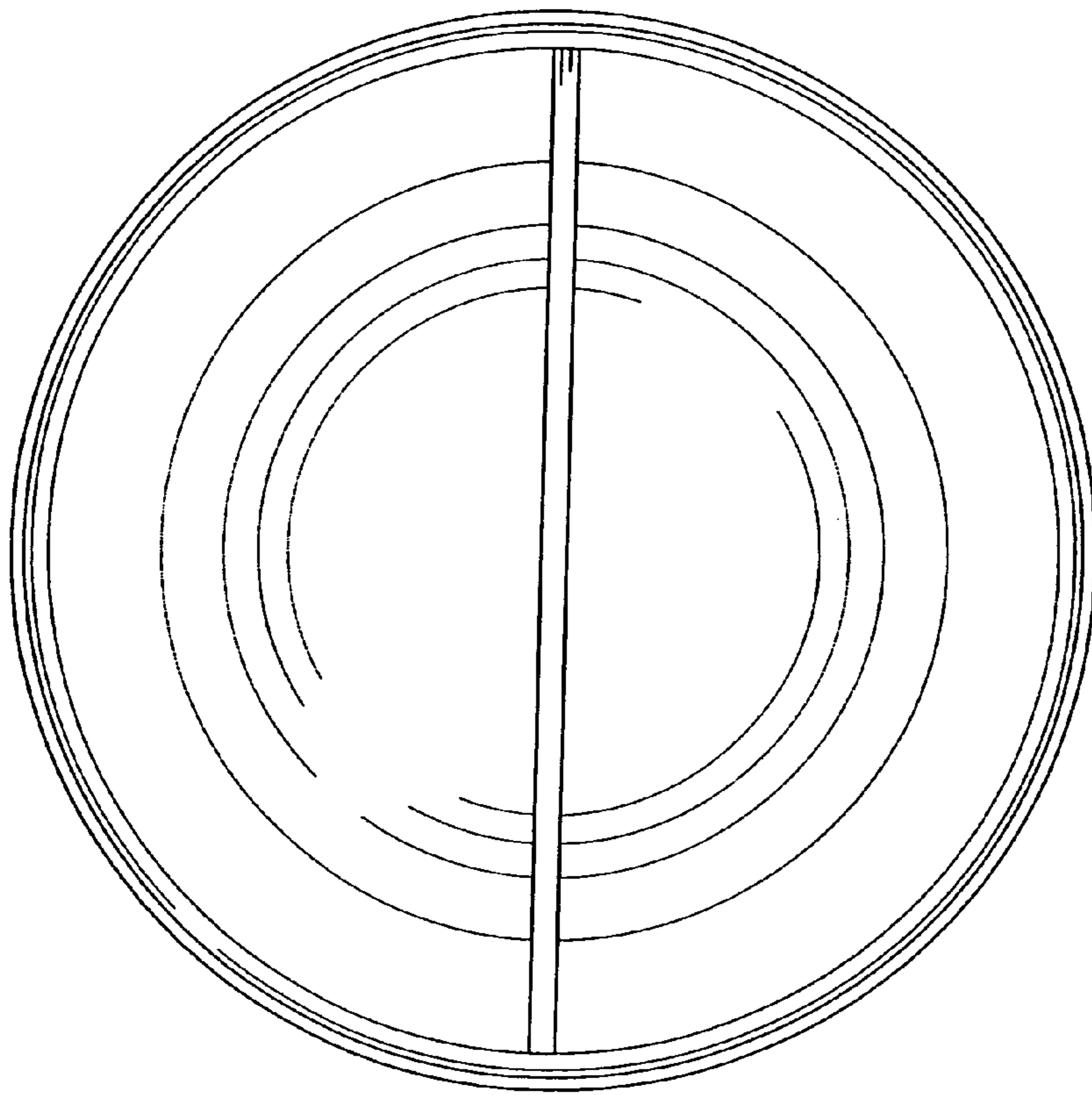
