The ornamental design for a drawer pull, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a drawer pull showing our new design in use condition;

FIG. 2 is an enlarged front perspective view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a front view thereof;

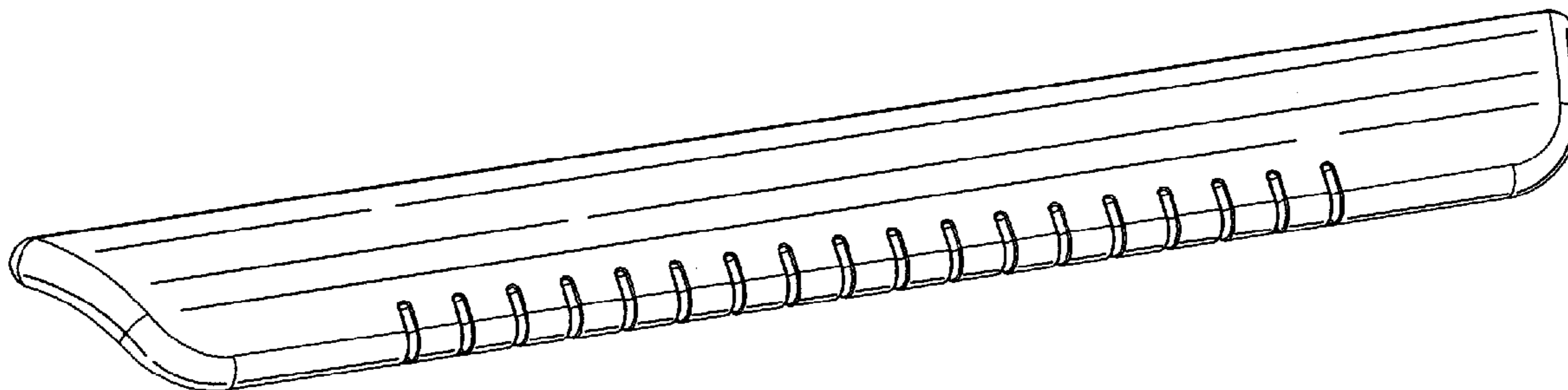
FIG. 5 is a bottom view thereof;

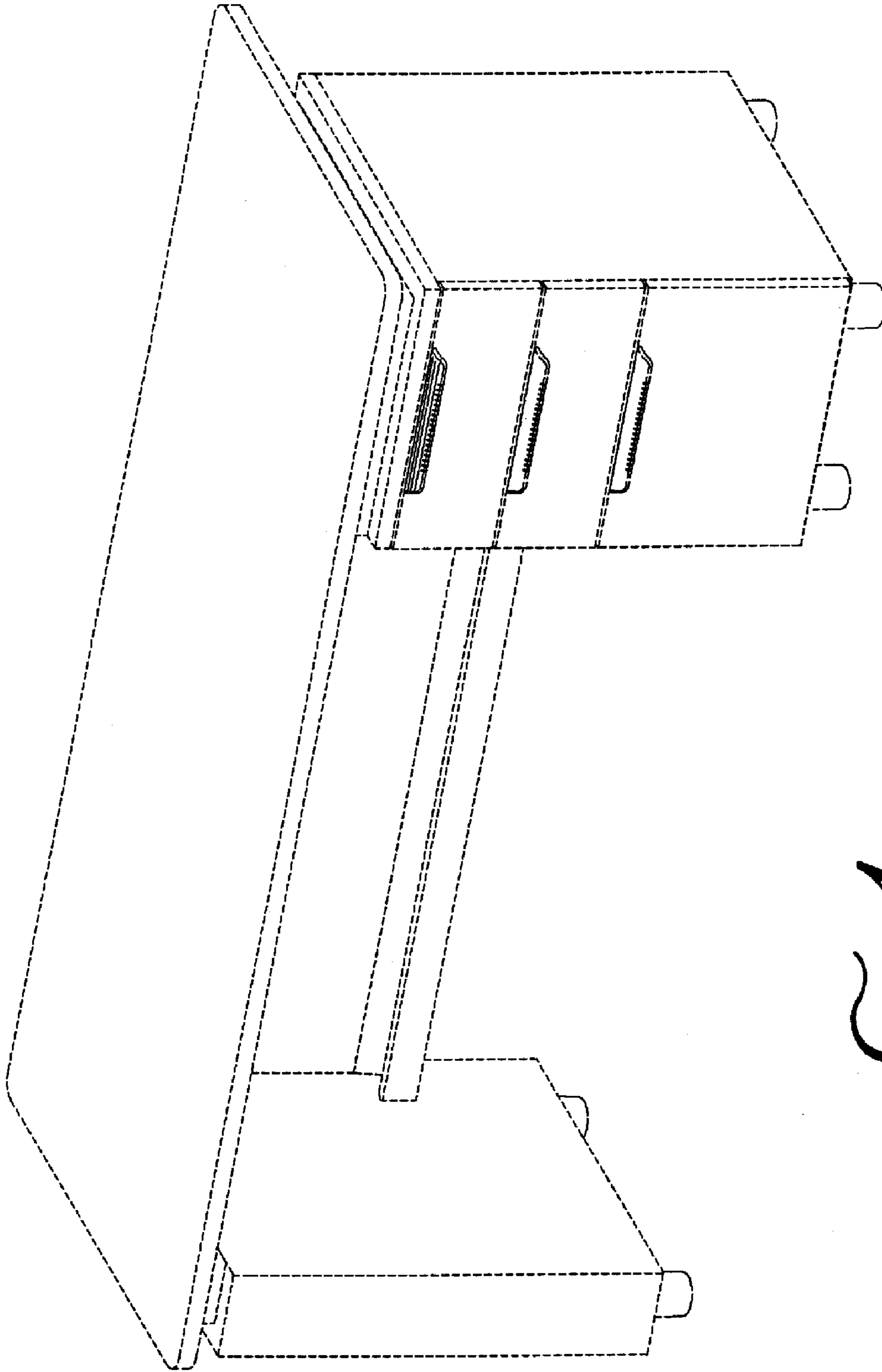

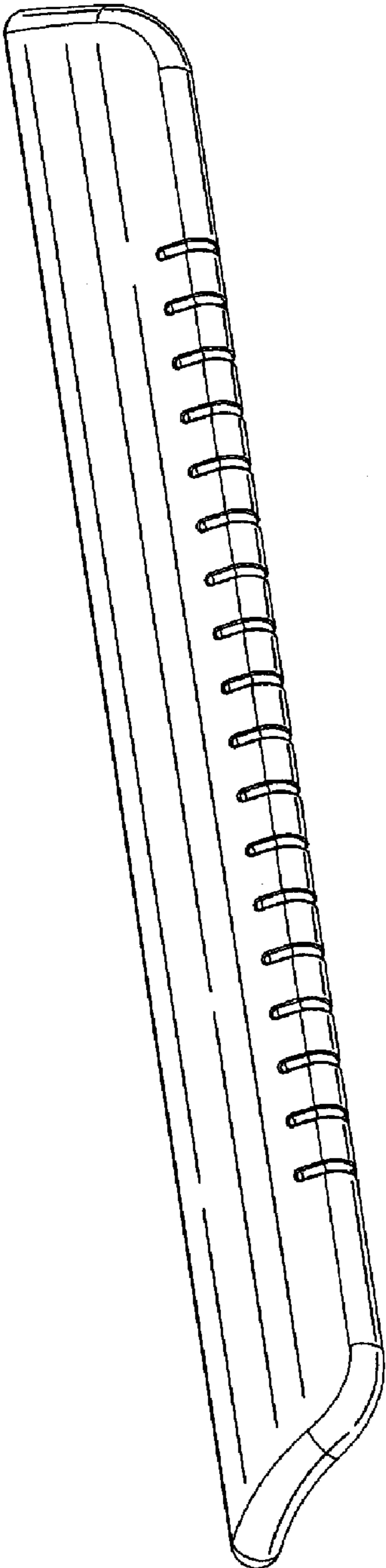

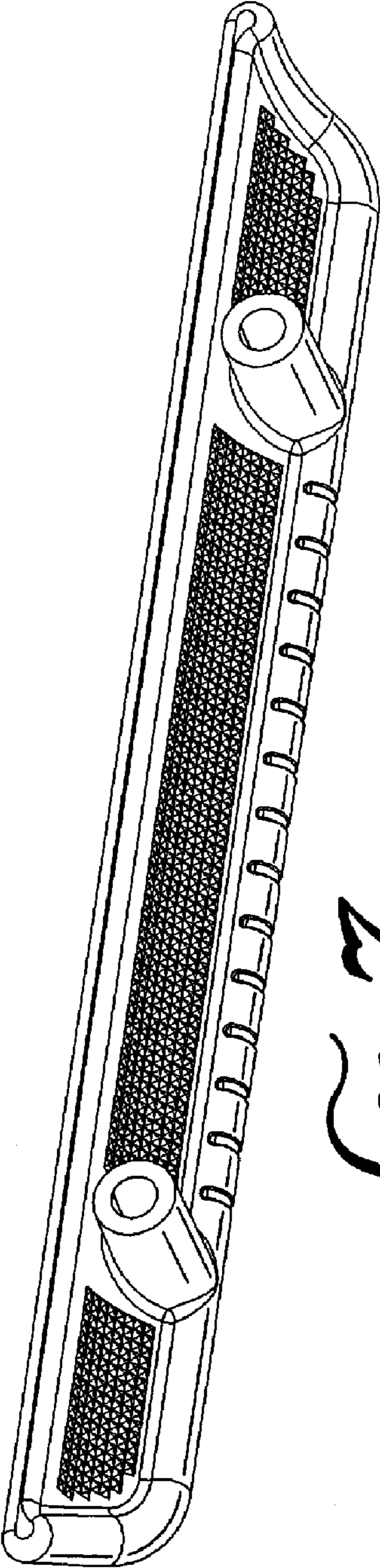

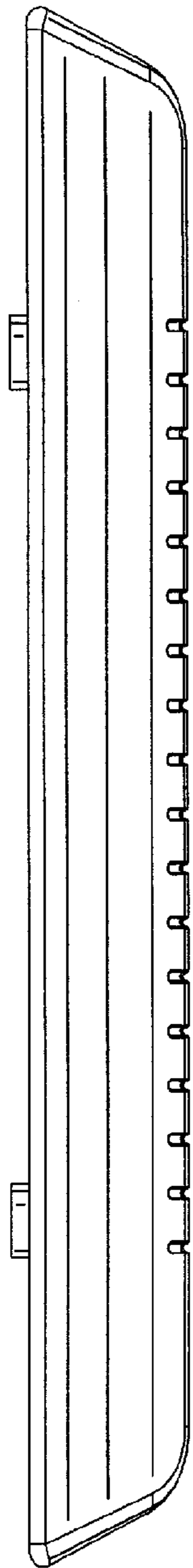

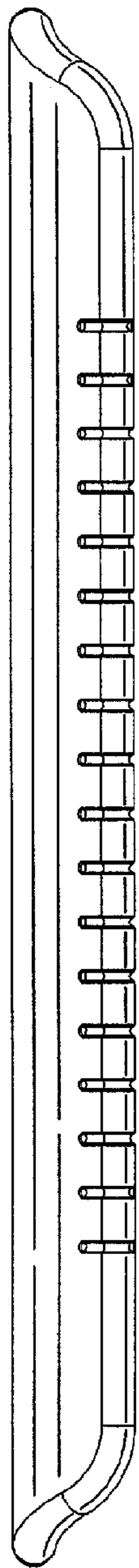

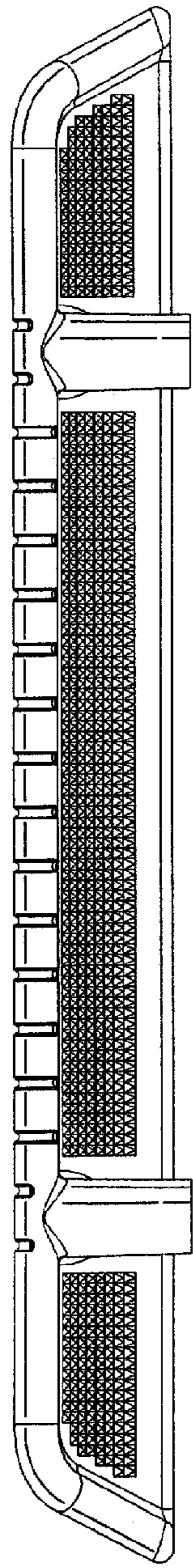

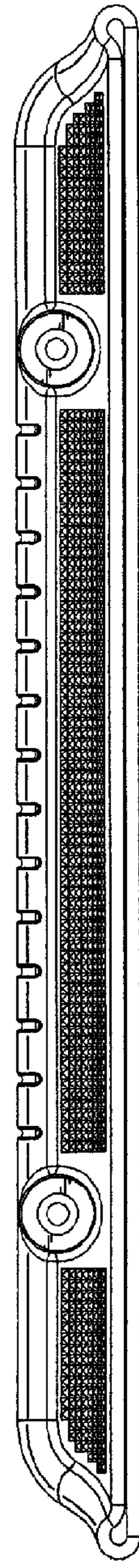
