FIG. 1 is a perspective view of a flower jewelry bail, showing our new design.

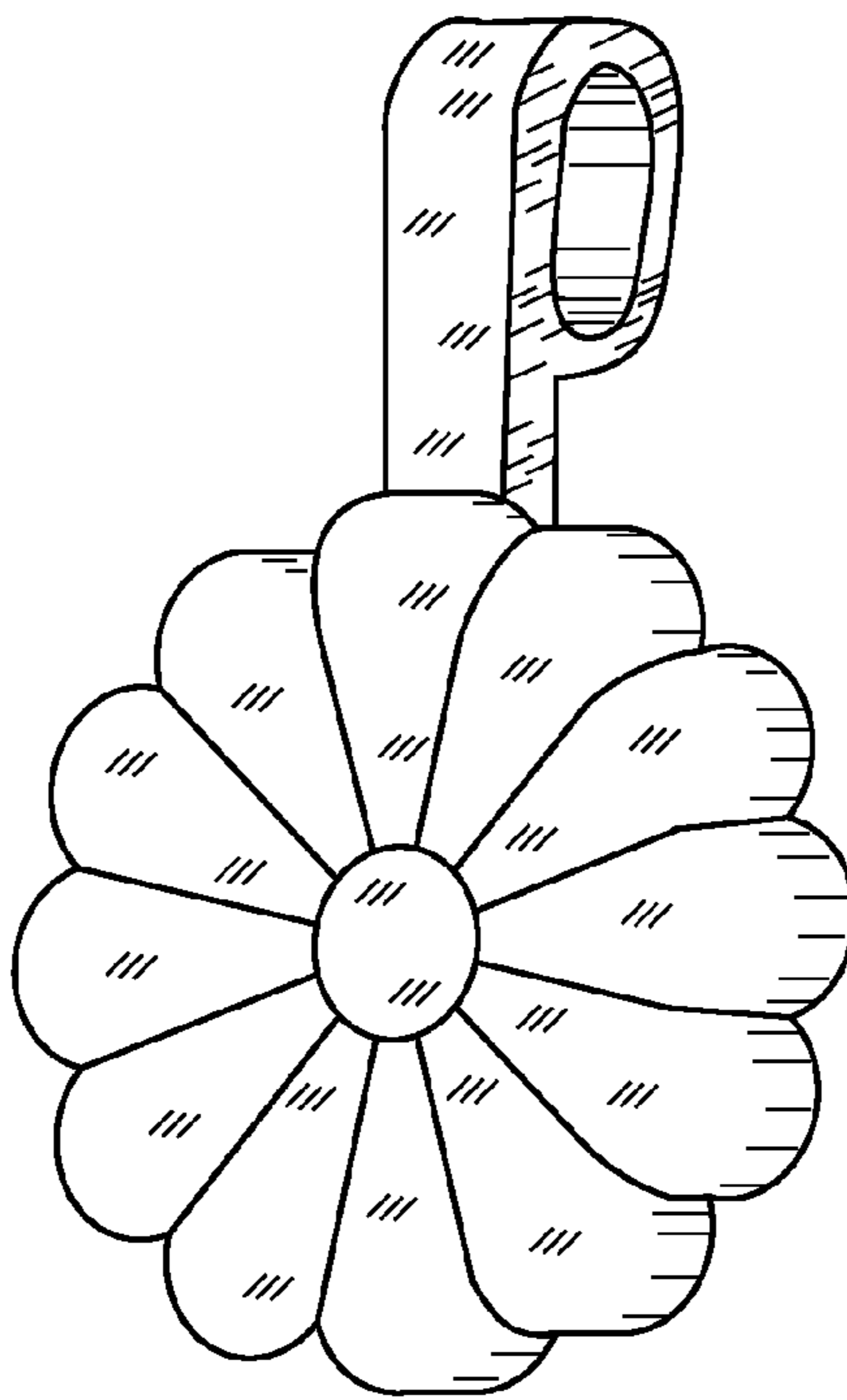
FIG. 2 is a front elevational view;

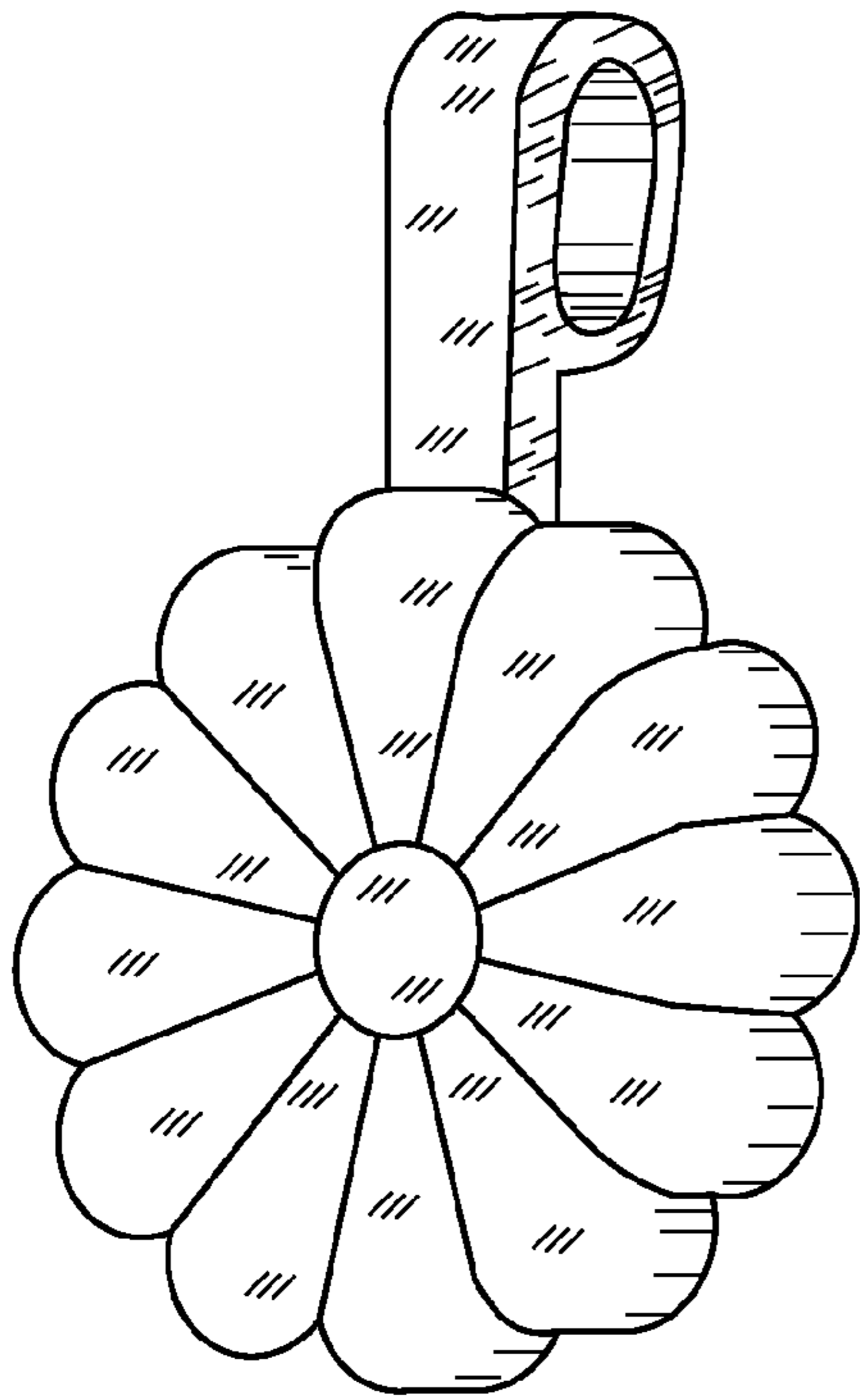

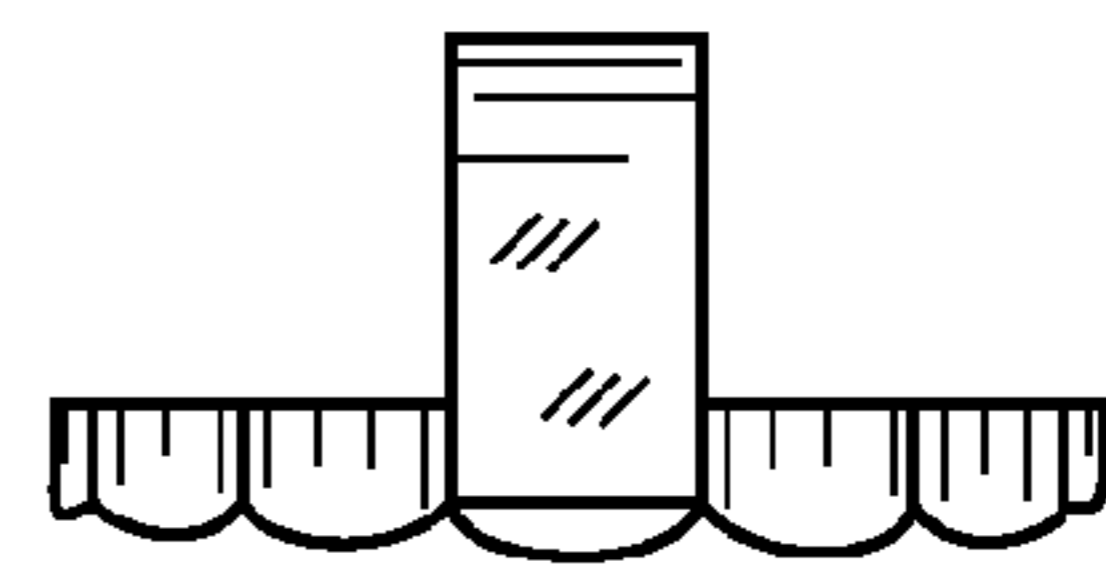

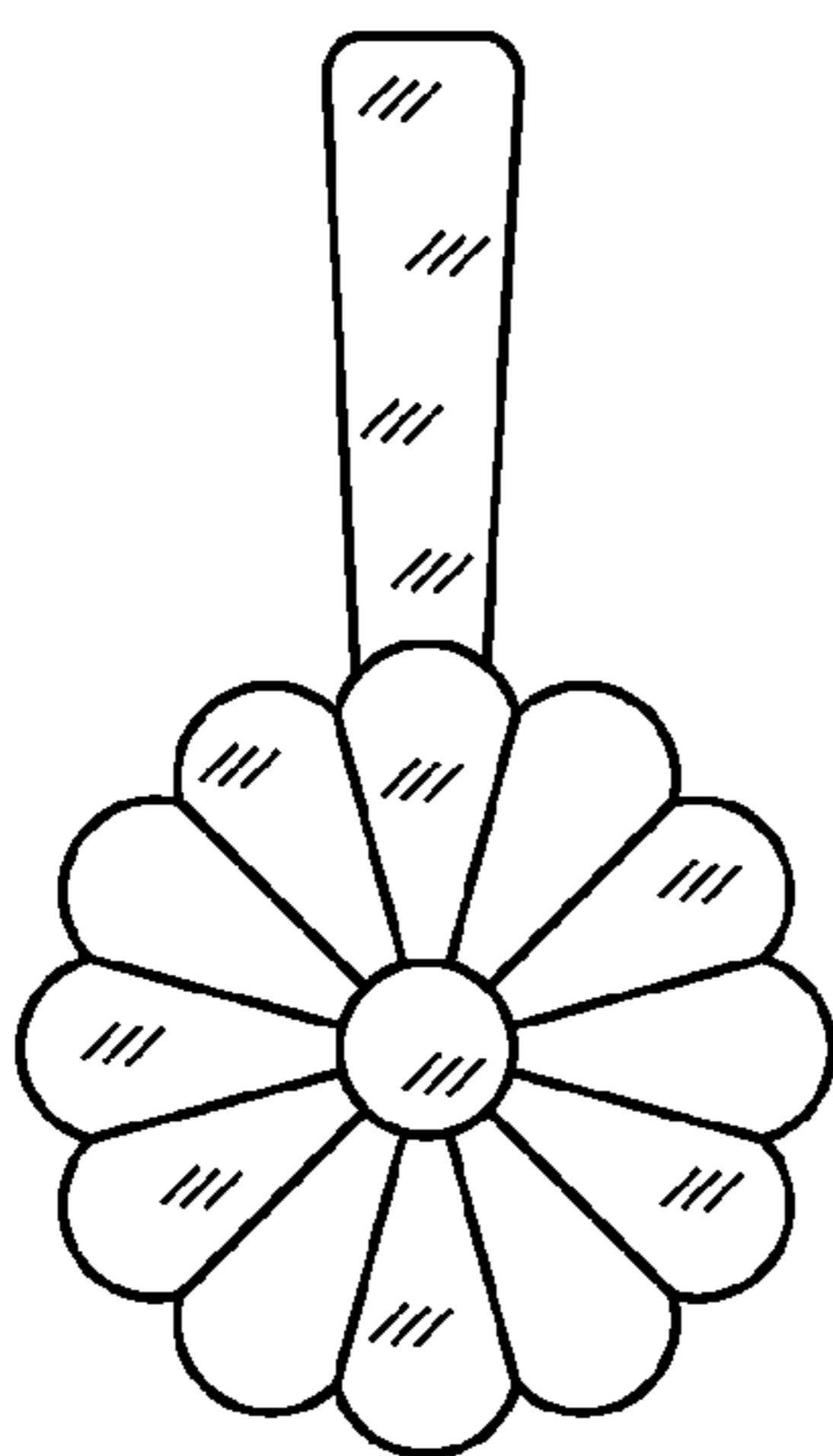

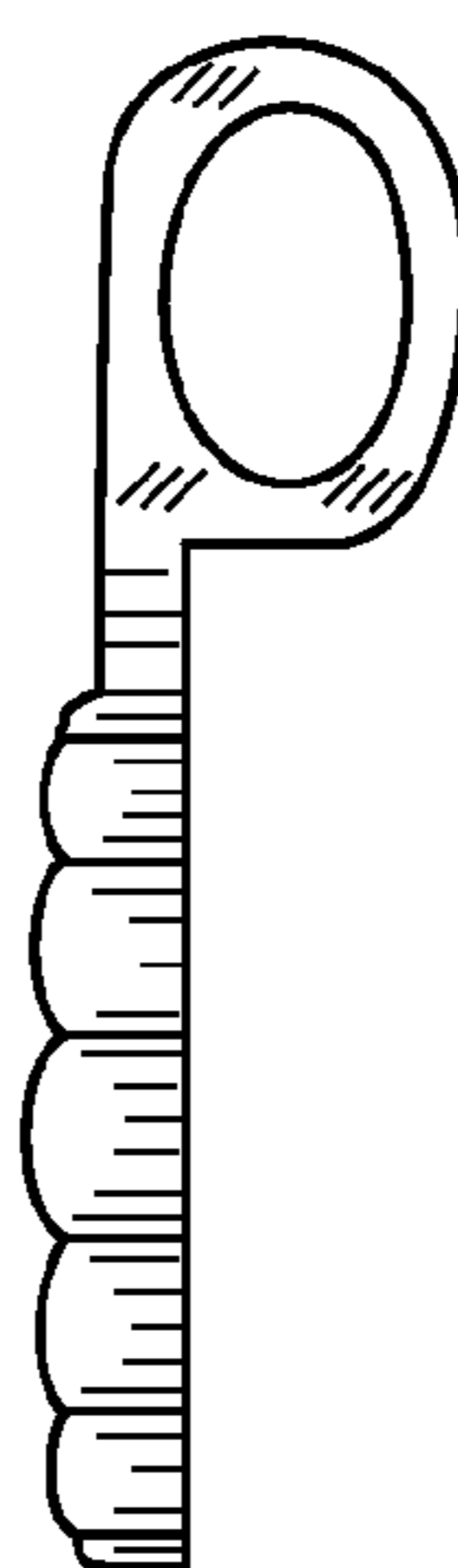

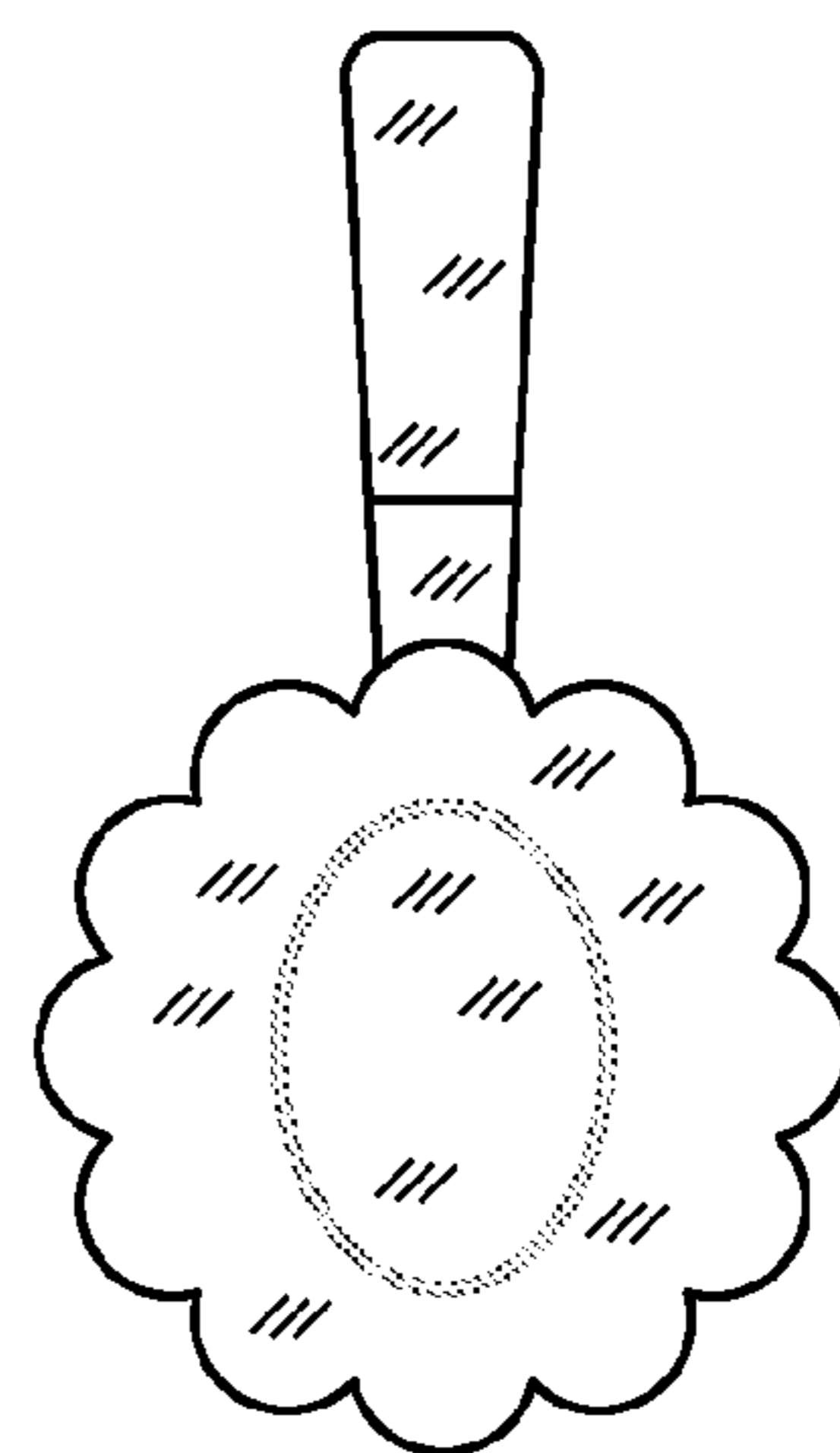
