FIG. 4 is a right side elevational view of FIG. 1;

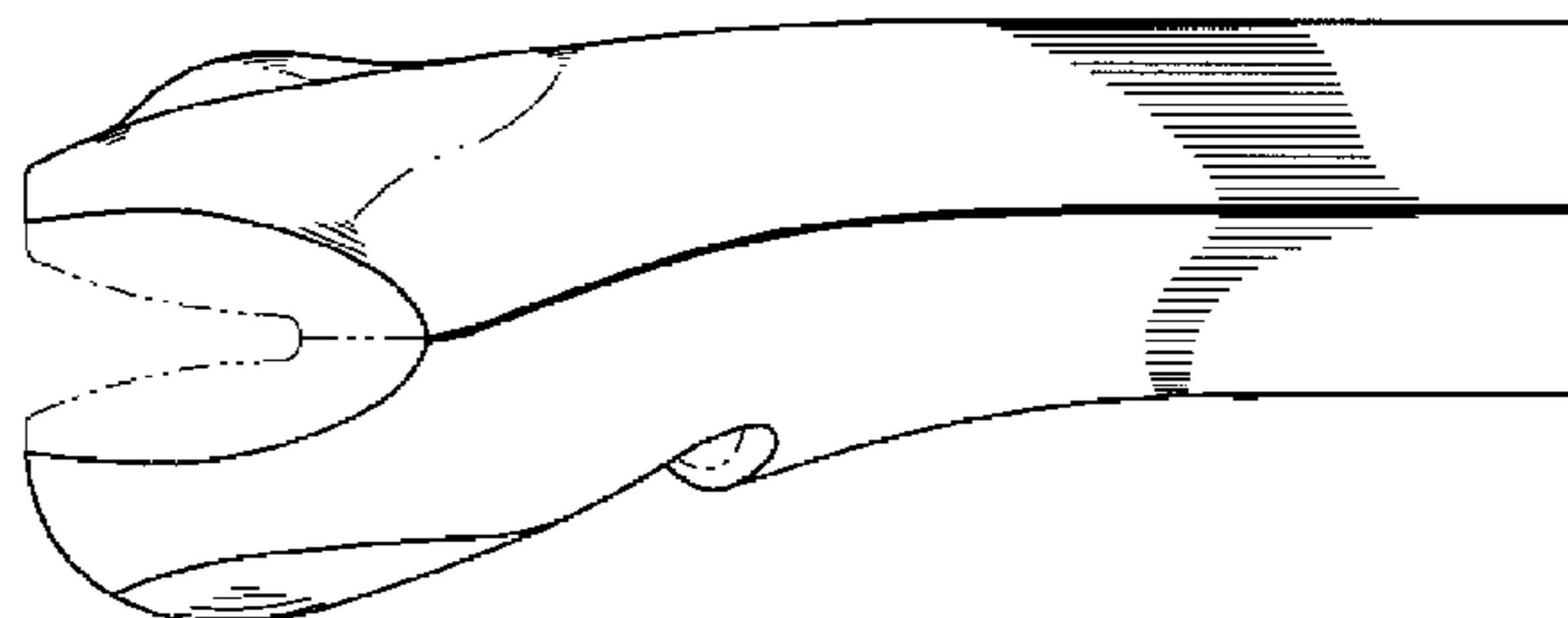
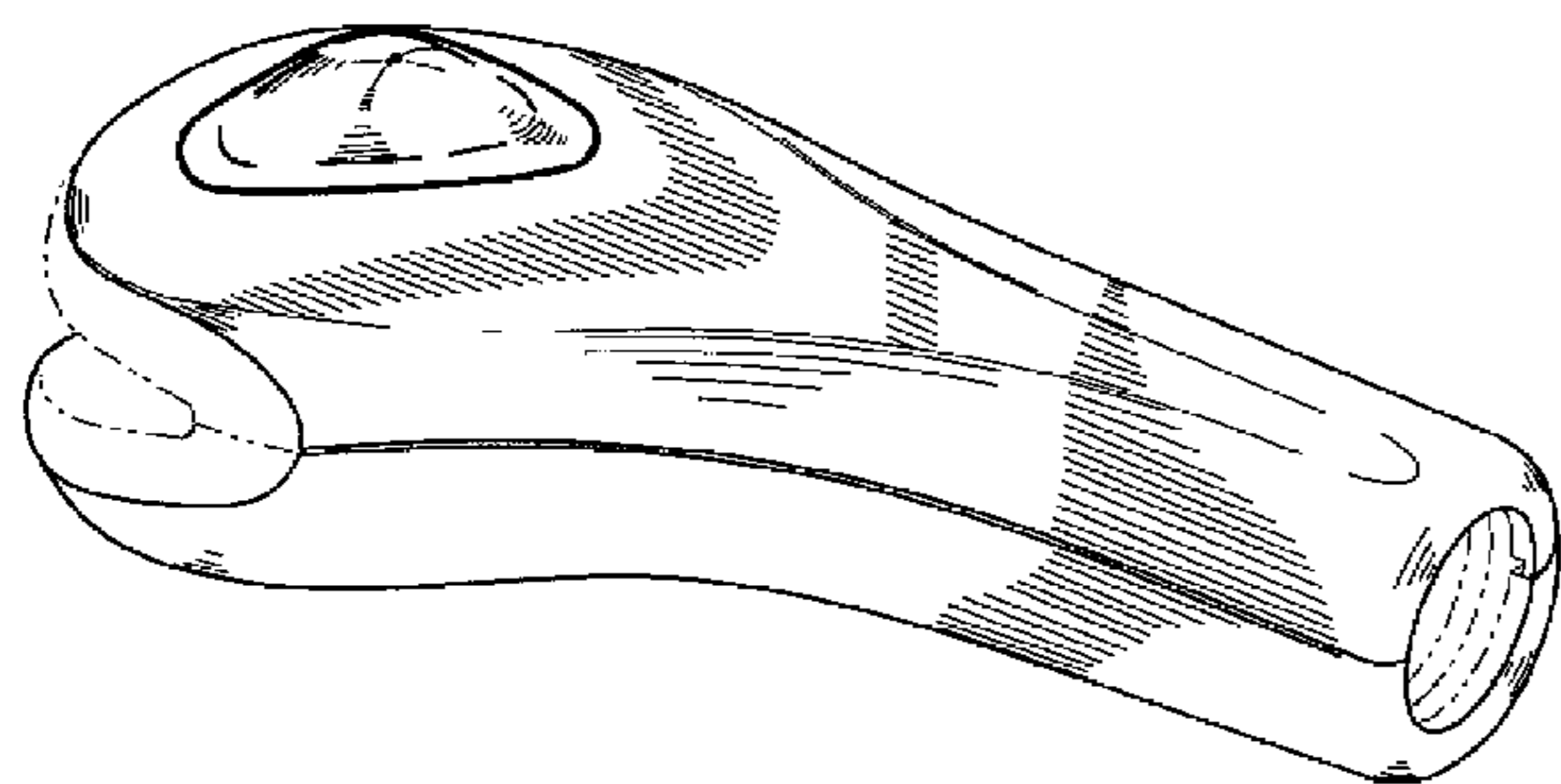
FIG. 5 is a bottom view of FIG. 1;

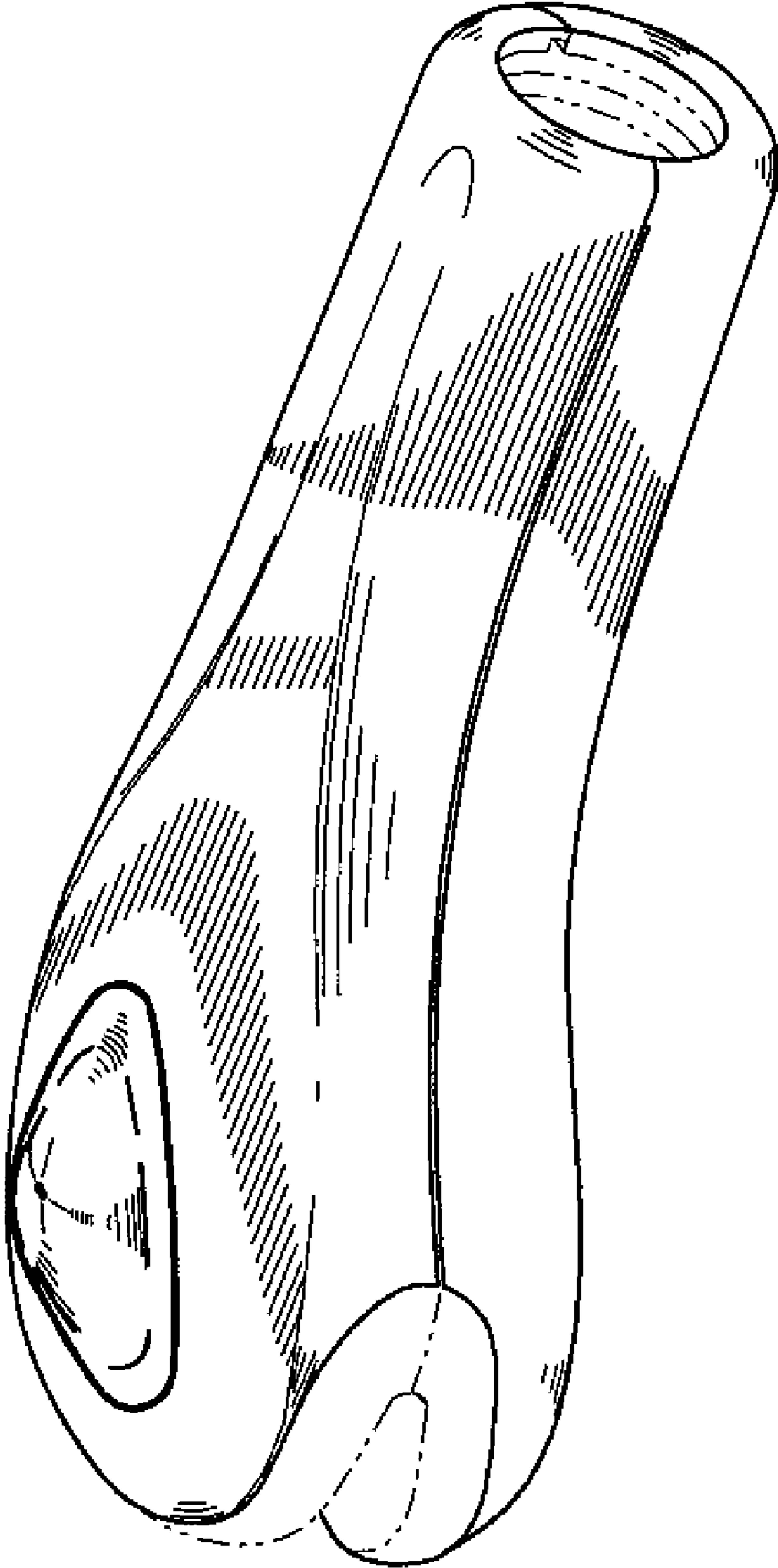

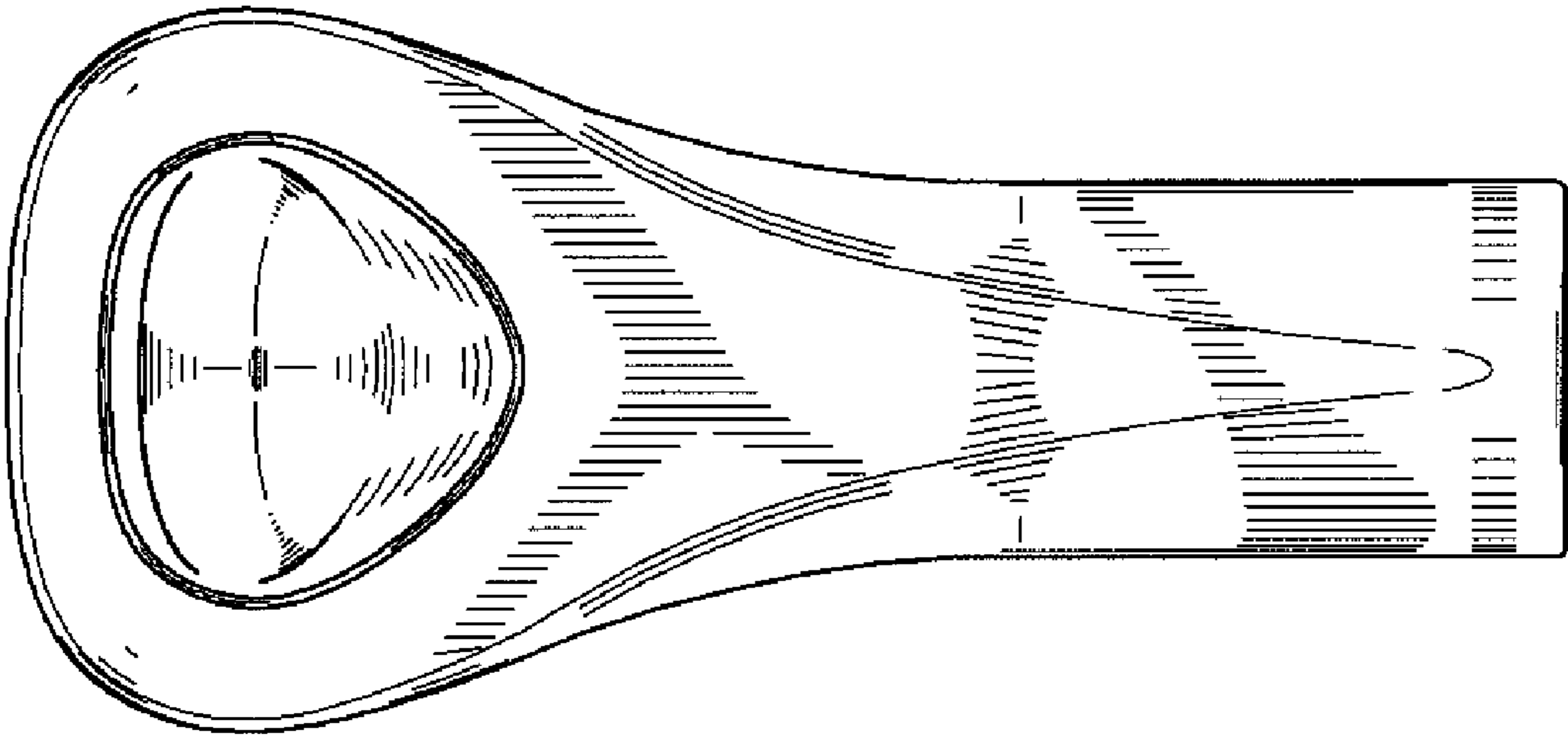

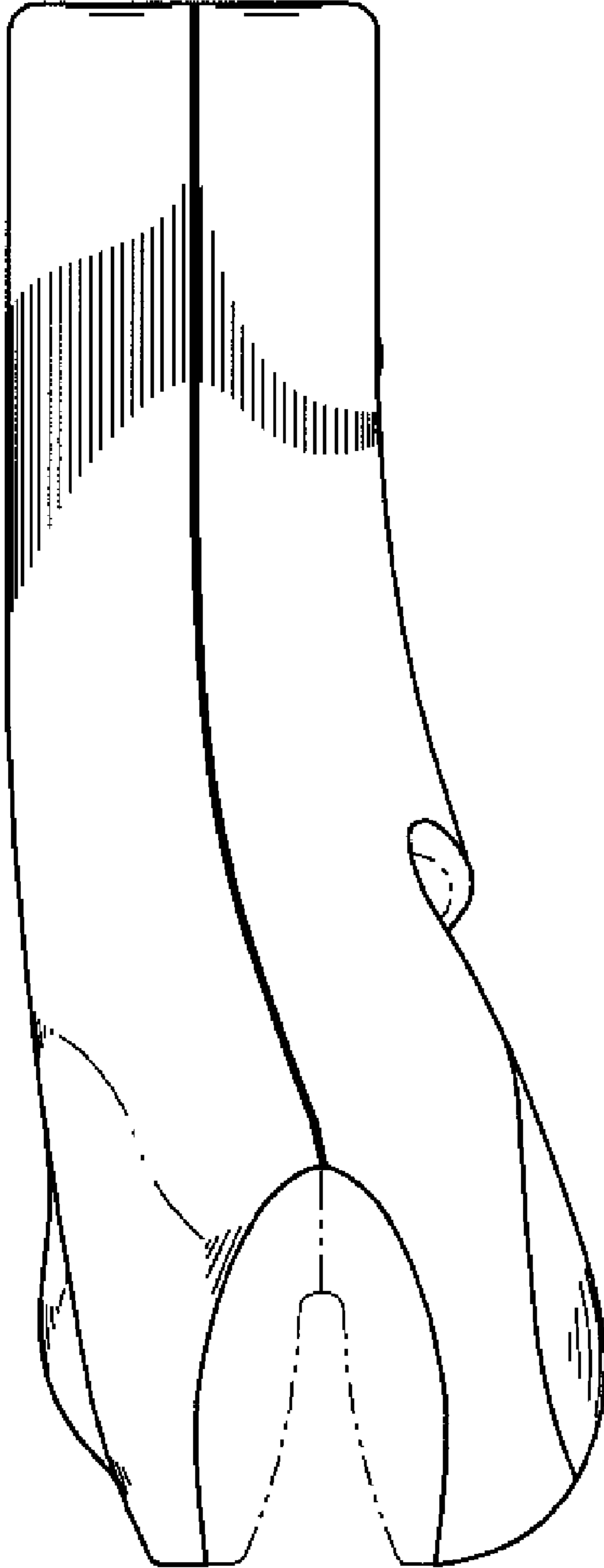

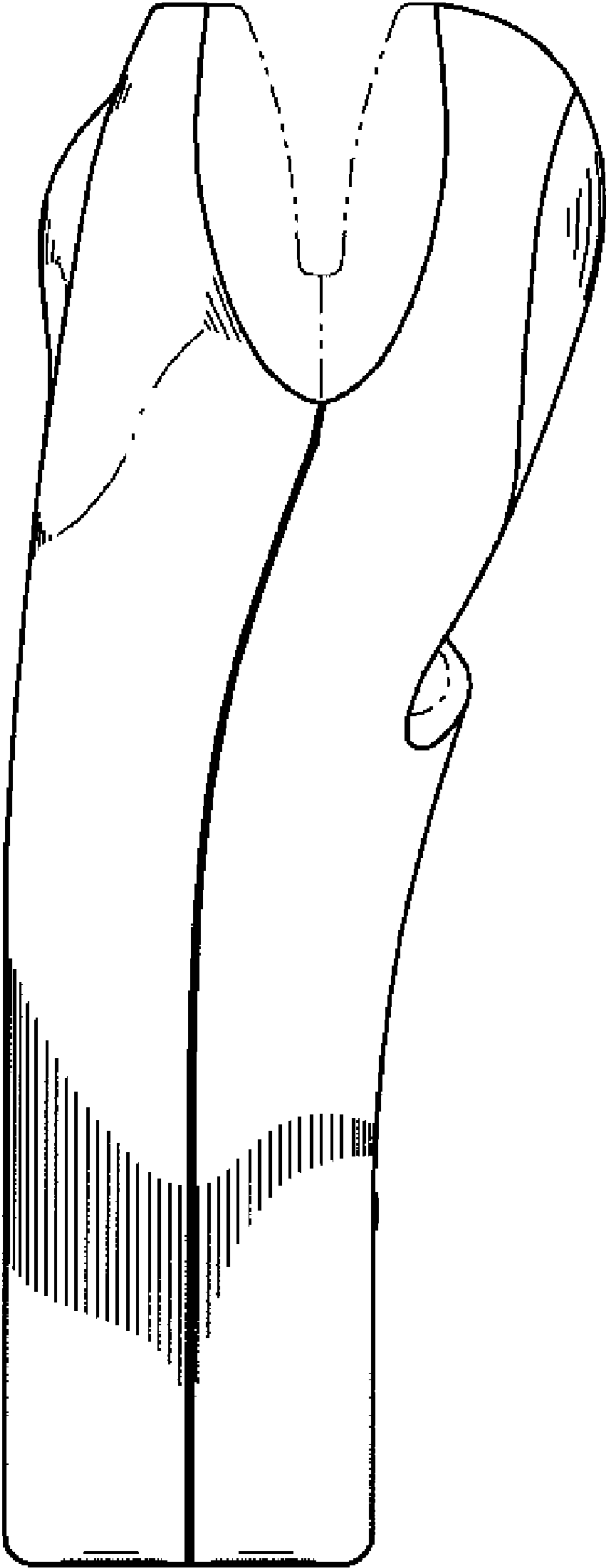

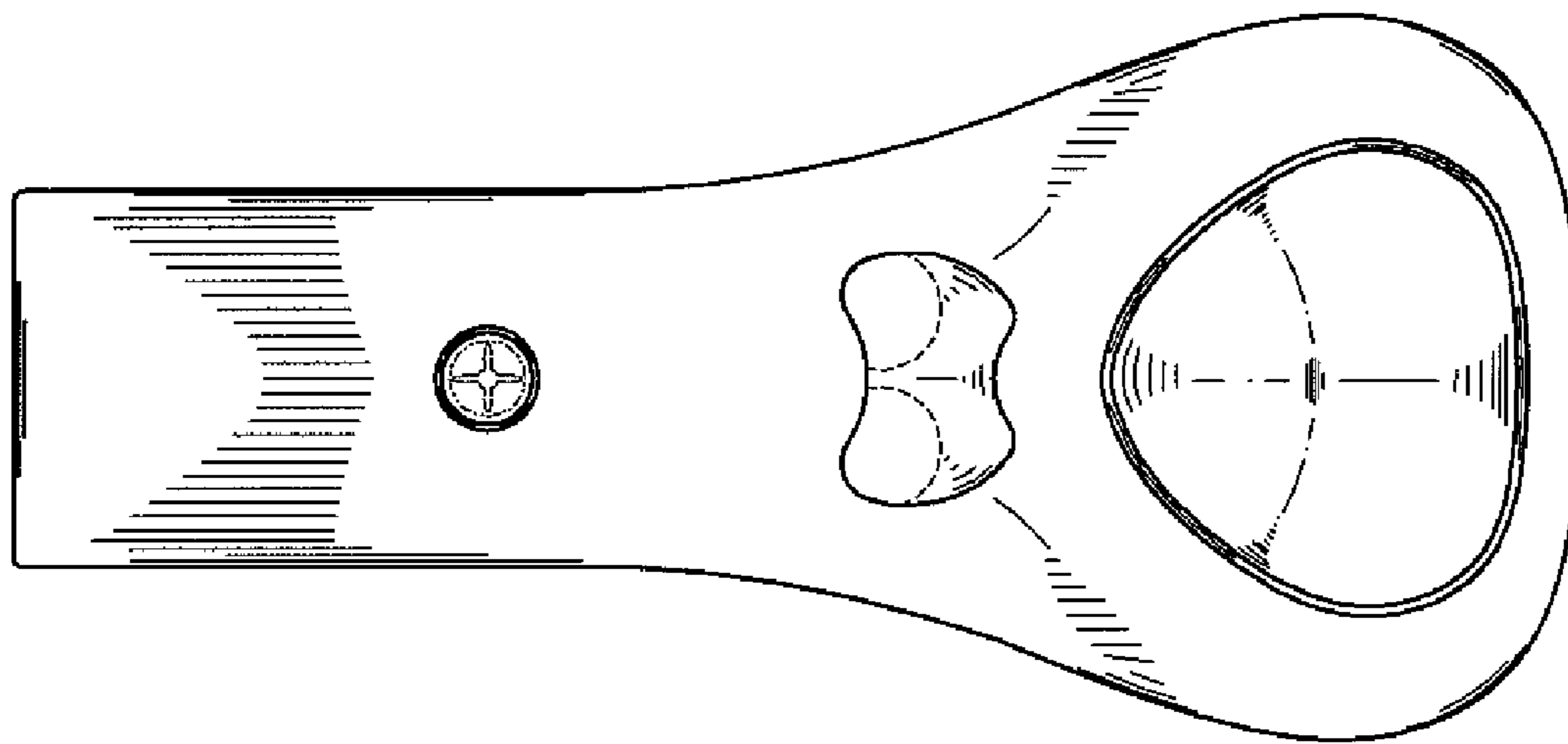

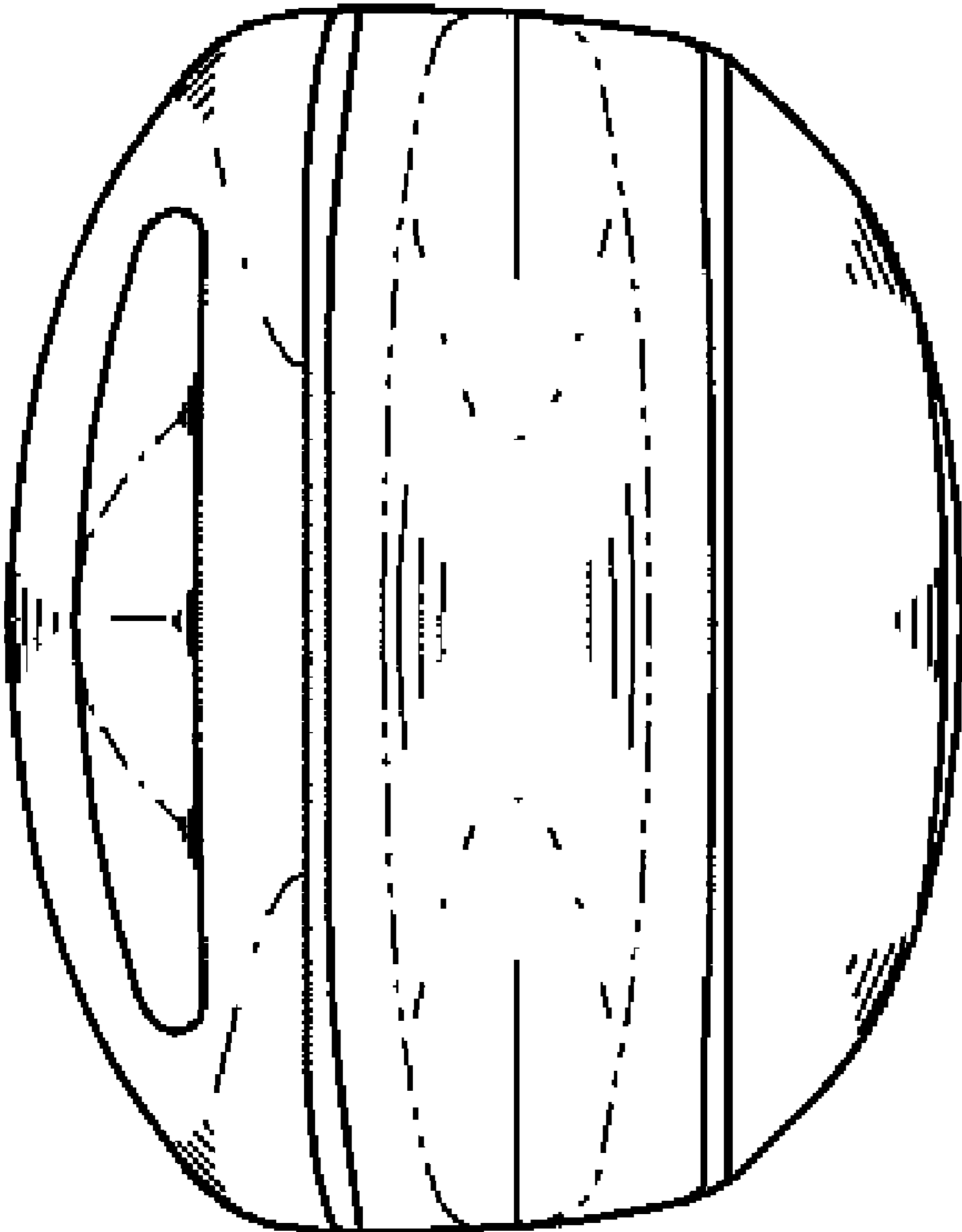

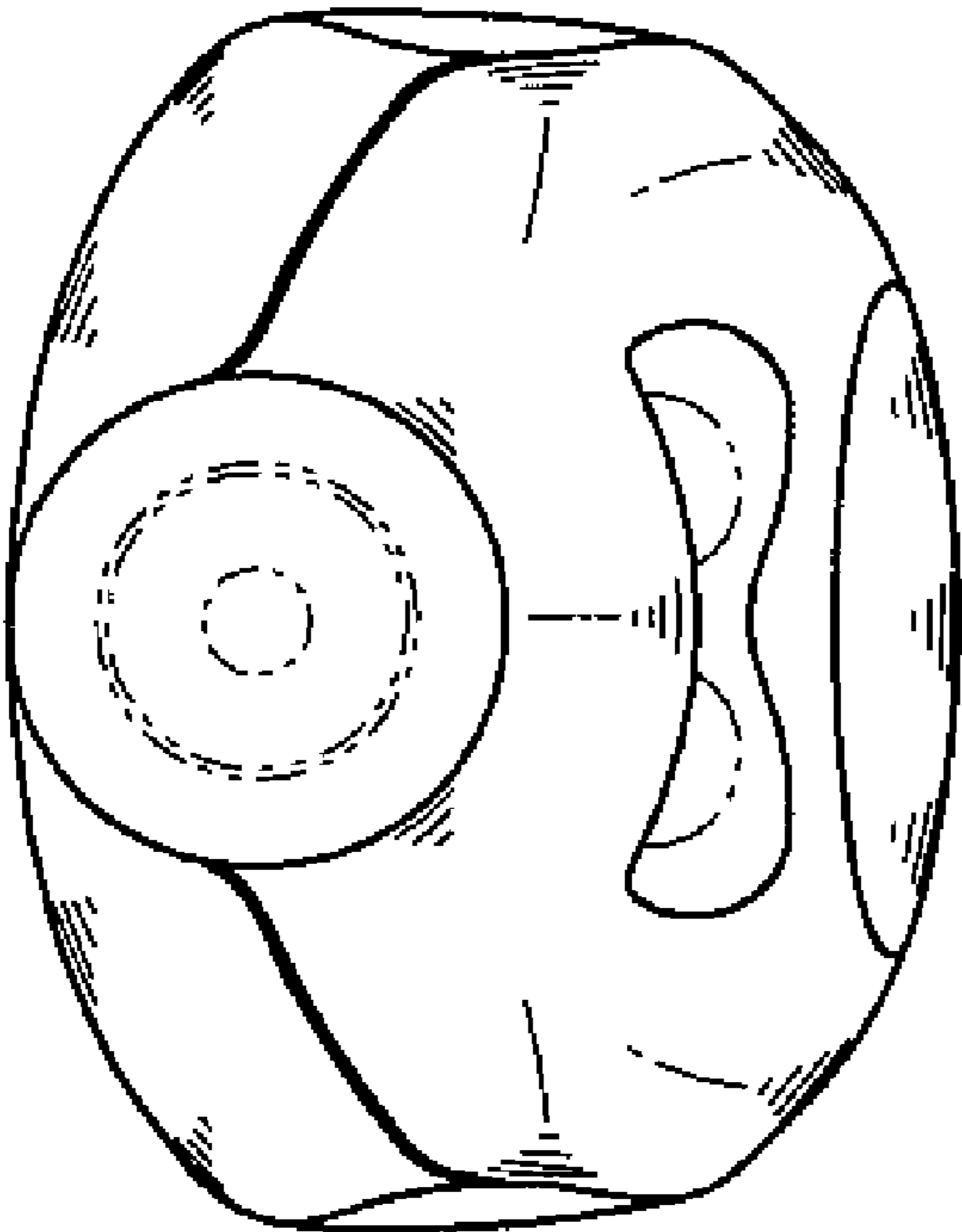
