The ornamental design for a guitar headstock, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a guitar headstock showing our new design;

FIG. 2 is front view of the guitar headstock of FIG. 1;

FIG. 3 is a side view thereof;

FIG. 4 is back view thereof;

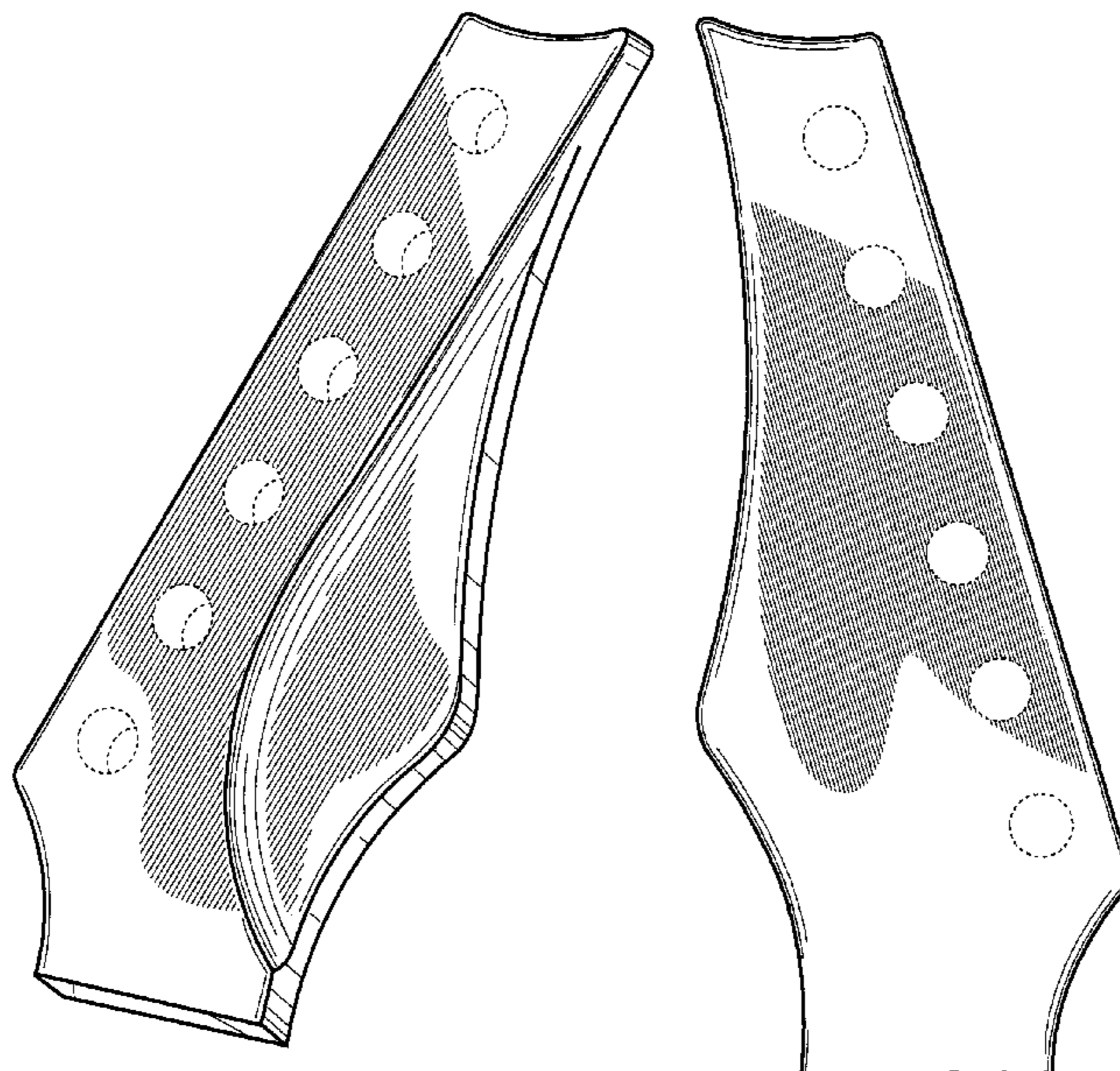
FIG. 5 is an opposing side view of the view shown in FIG. 3;

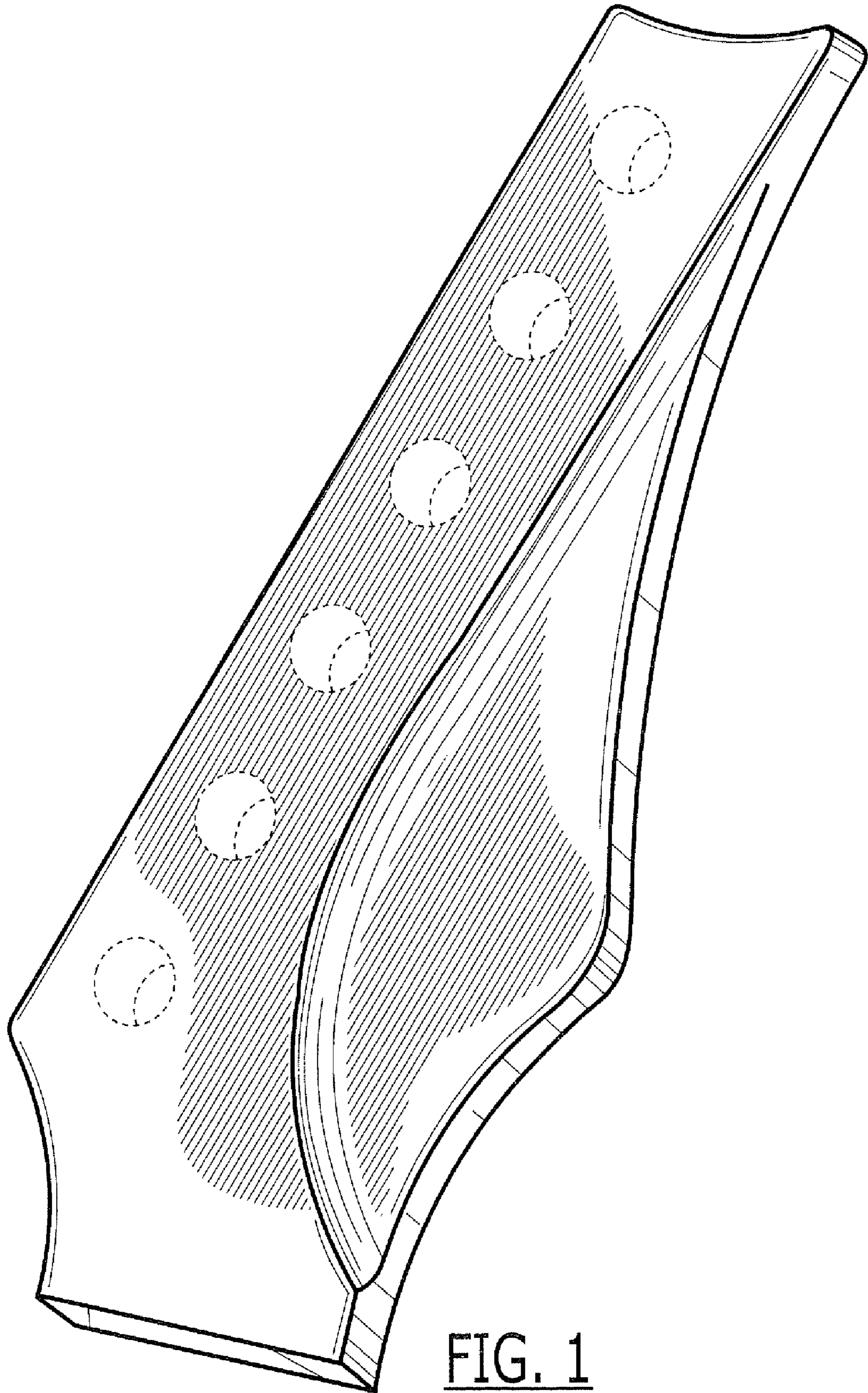

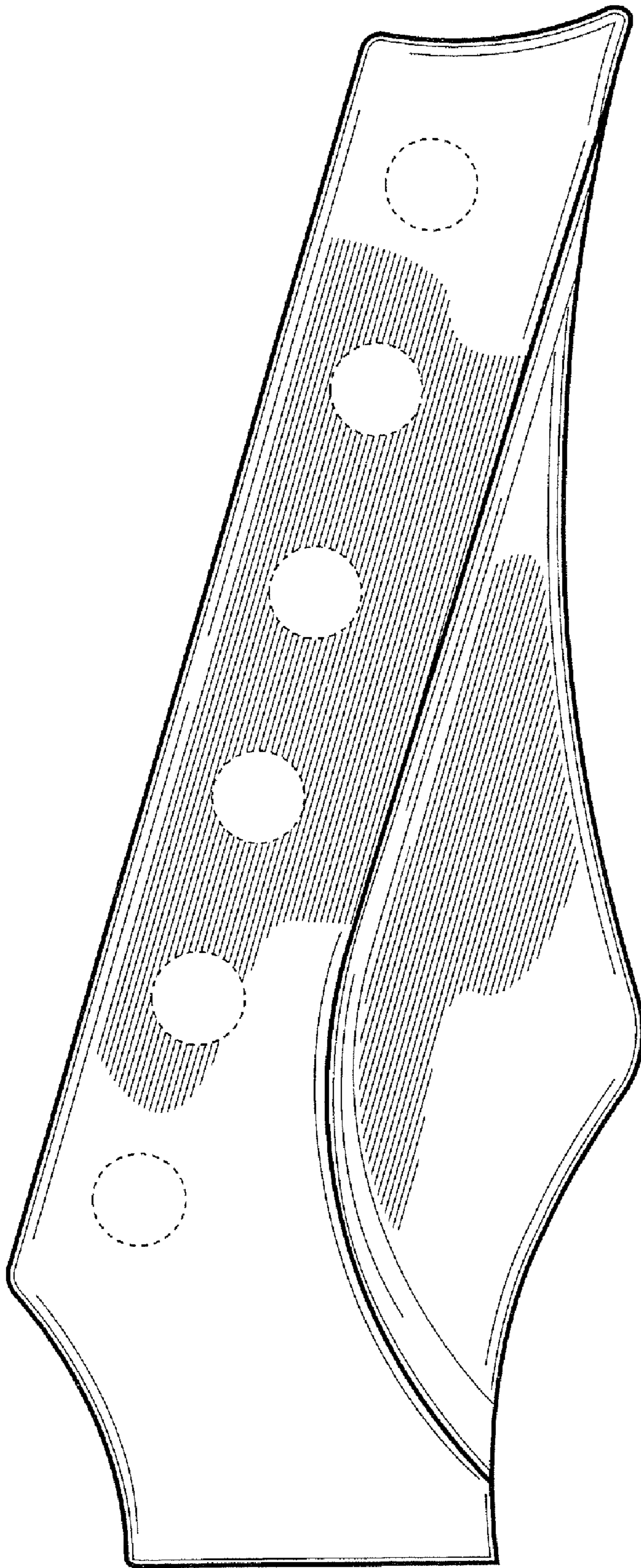

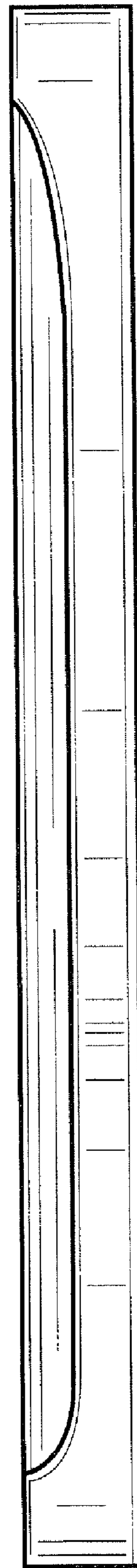

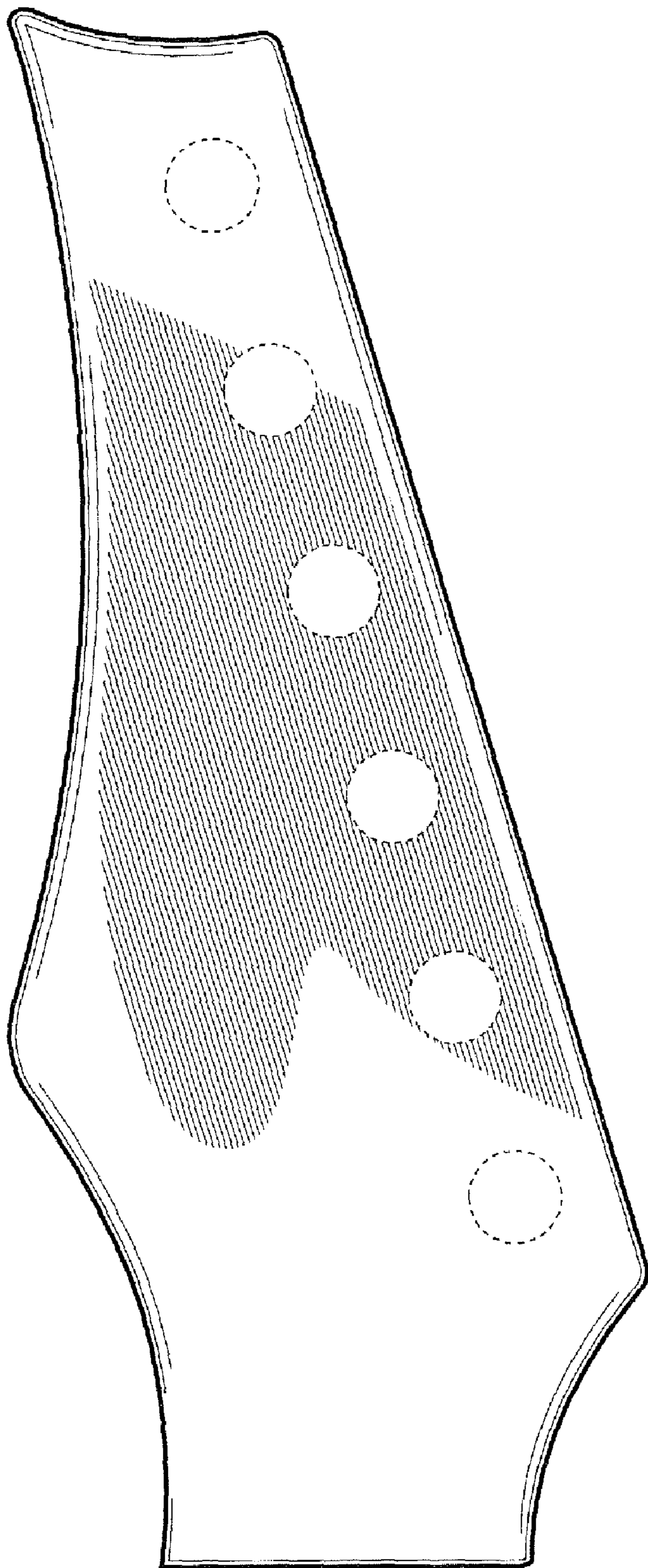

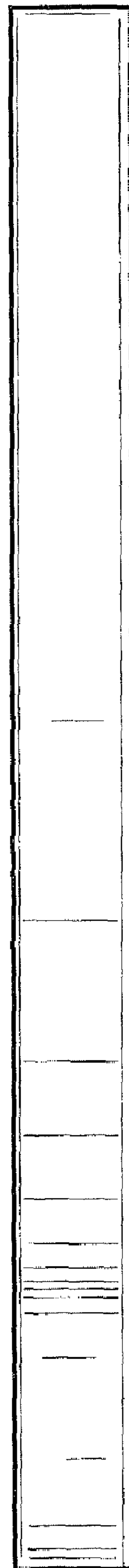

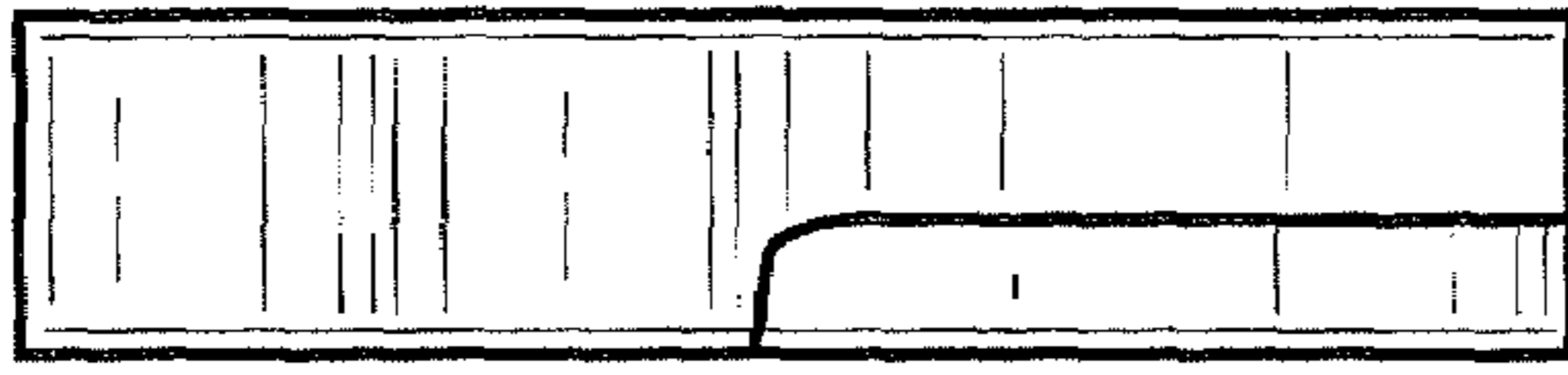

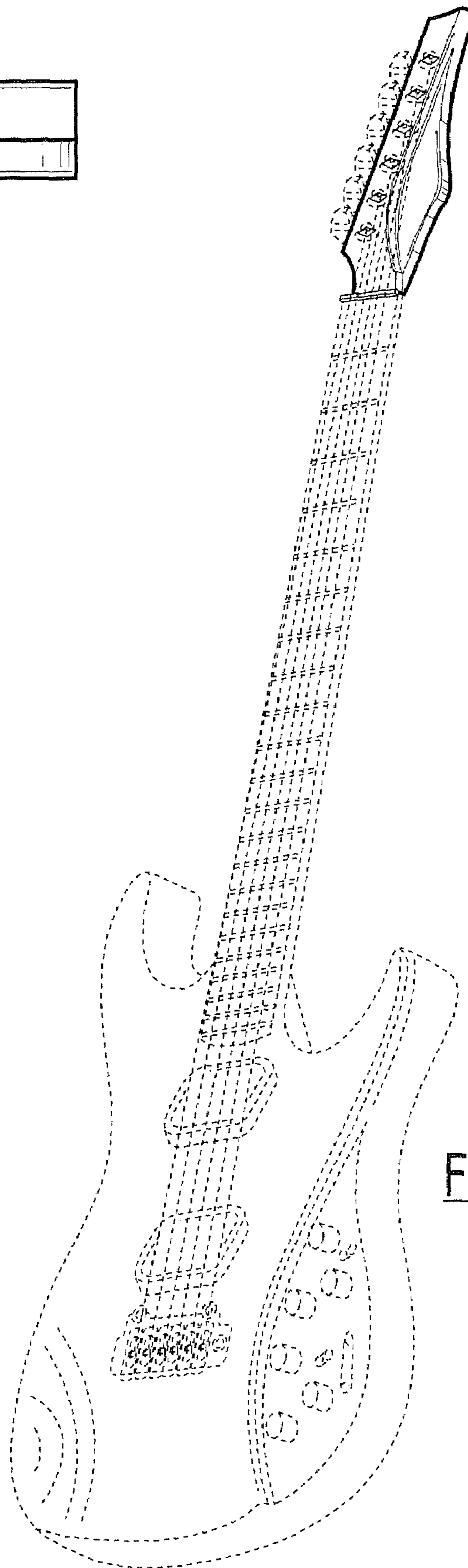
