(57) **CLAIM**

The ornamental design for a shredder, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a shredder showing our new design;

FIG. 2 is a front elevation view of the shredder of FIG. 1;

FIG. 3 is rear elevation view of the shredder of FIG. 1;

FIG. 4 is a left profile view of the shredder of FIG. 1;

FIG. 5 is a right profile view of the shredder of FIG. 1;

FIG. 6 is a top plan view of the shredder of FIG. 1;

FIG. 7 is a bottom plan view of the shredder of FIG. 1;

FIG. 8 is a left side perspective view of a modified embodiment of the design shown in FIGS. 1 through 7;

FIG. 9 is a front elevation view of the shredder of FIG. 8;

FIG. 10 is rear elevation view of the shredder of FIG. 8;

FIG. 11 is a left profile view of the shredder of FIG. 8;

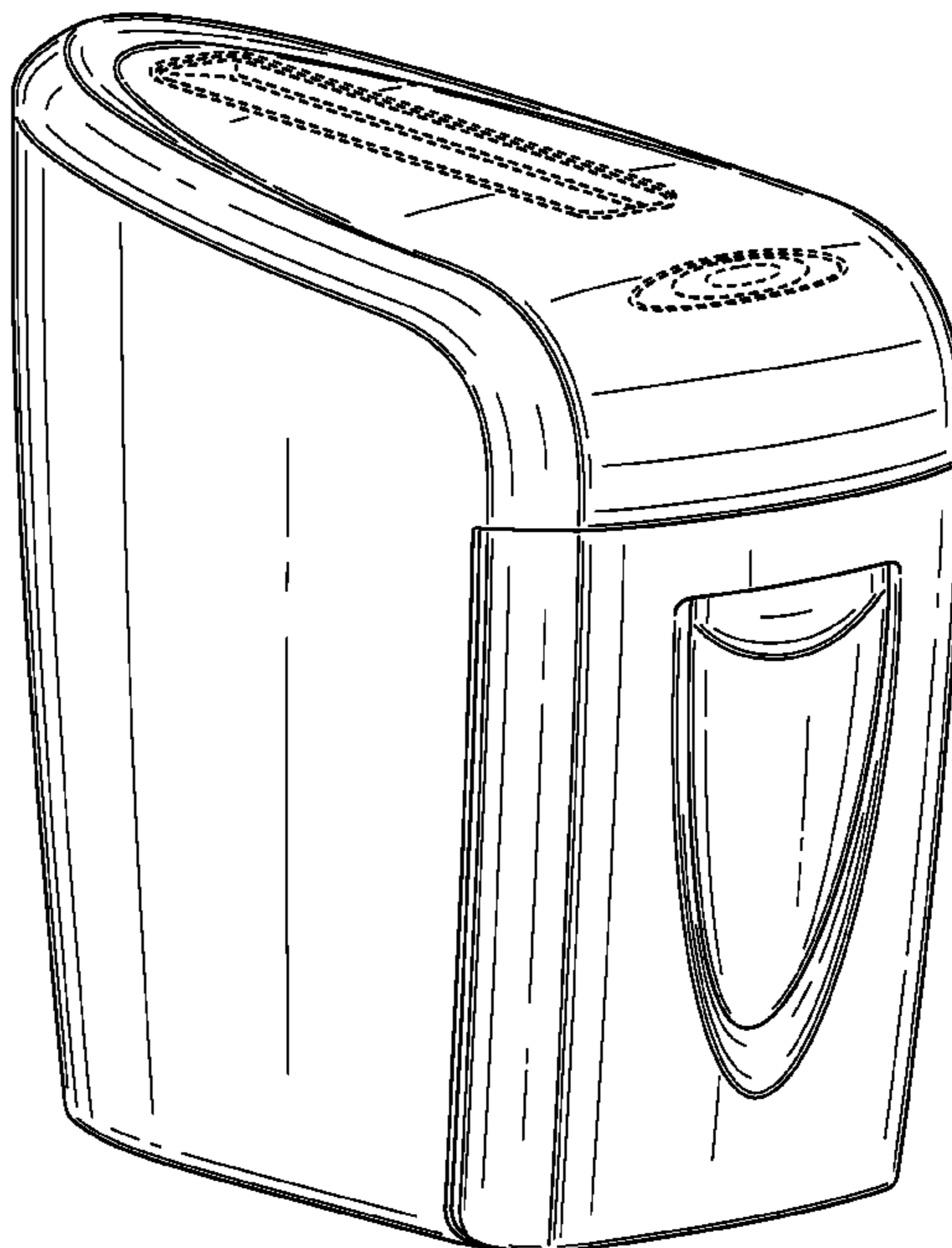
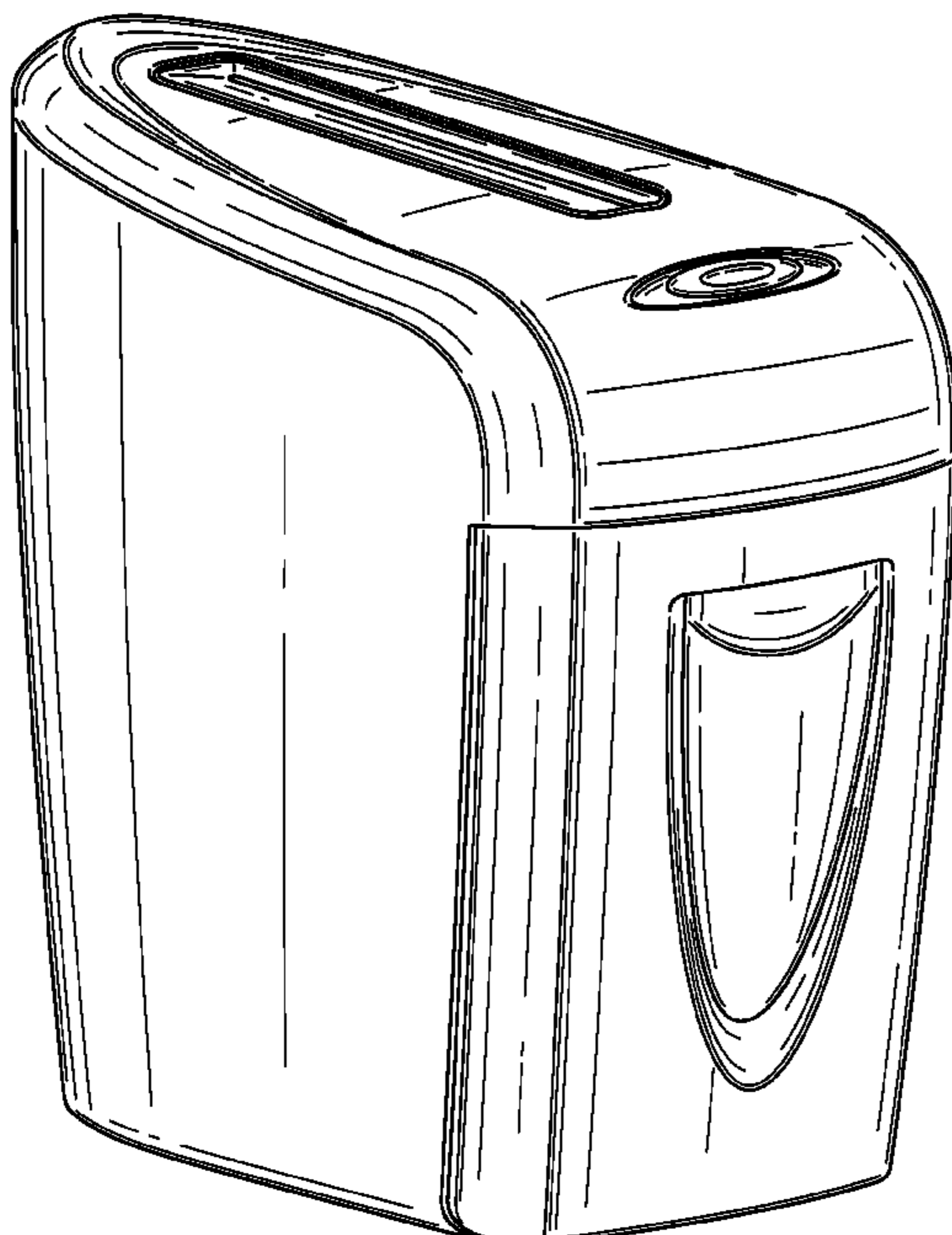
FIG. 12 is a right profile view of the shredder of FIG. 8;

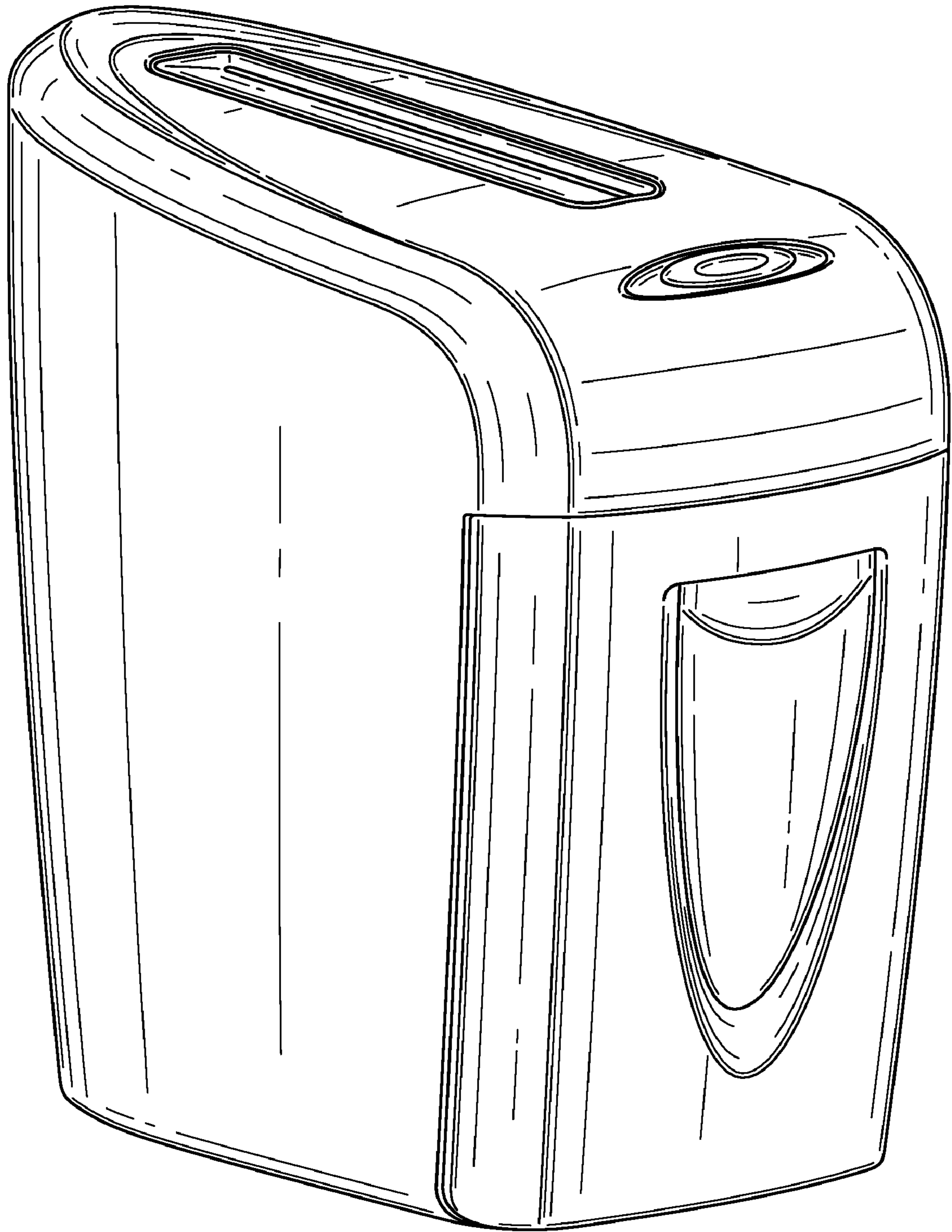

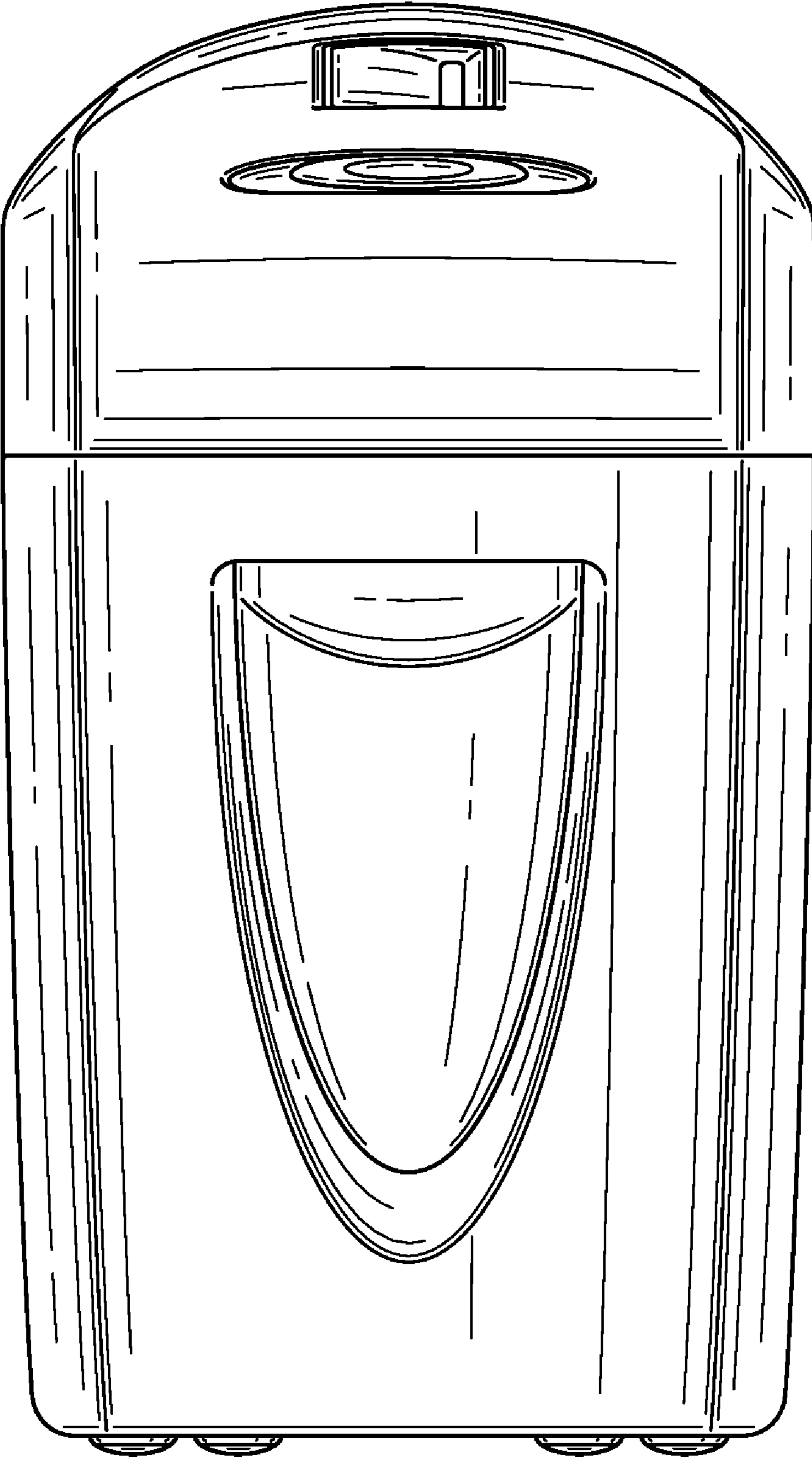

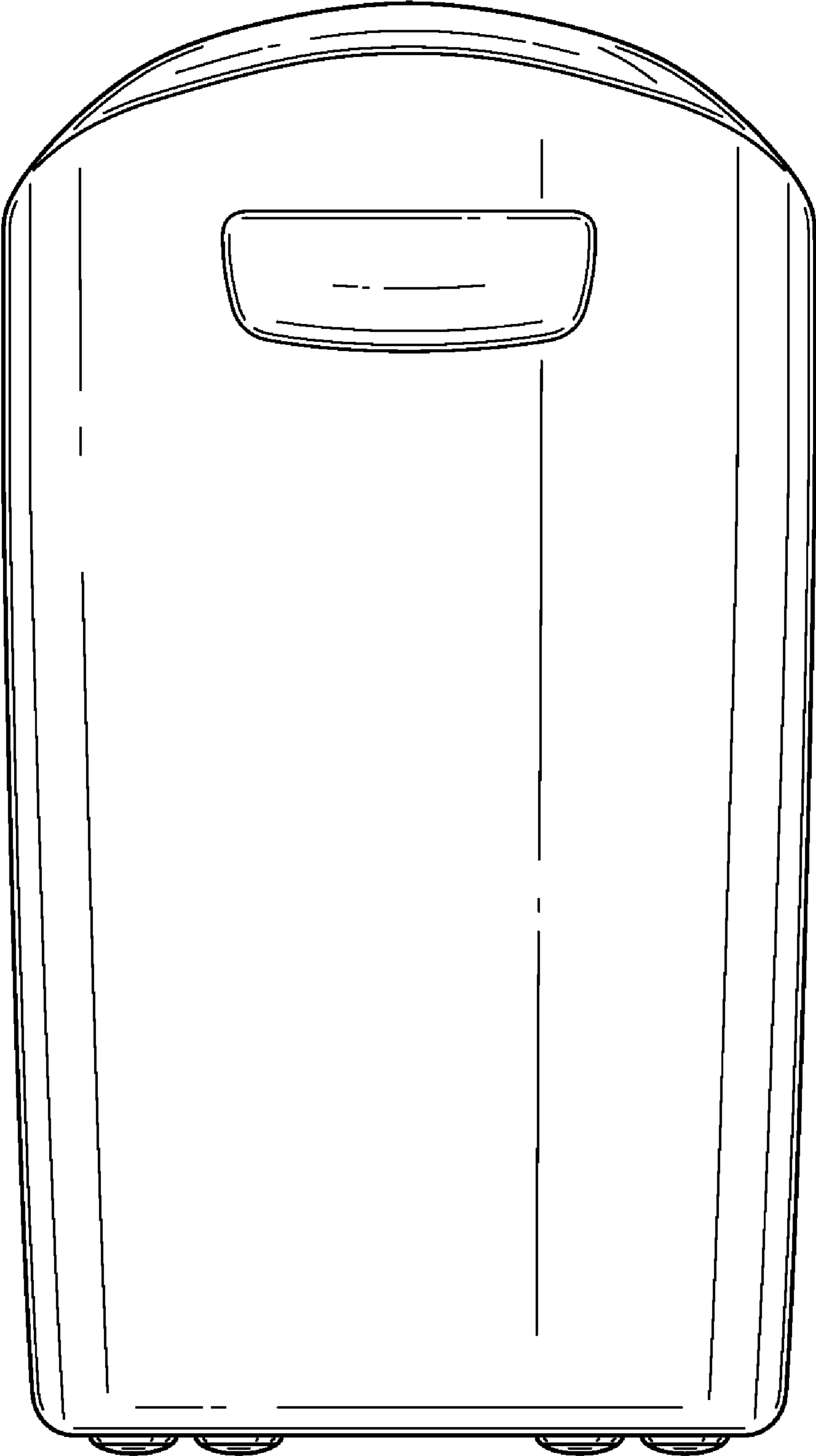

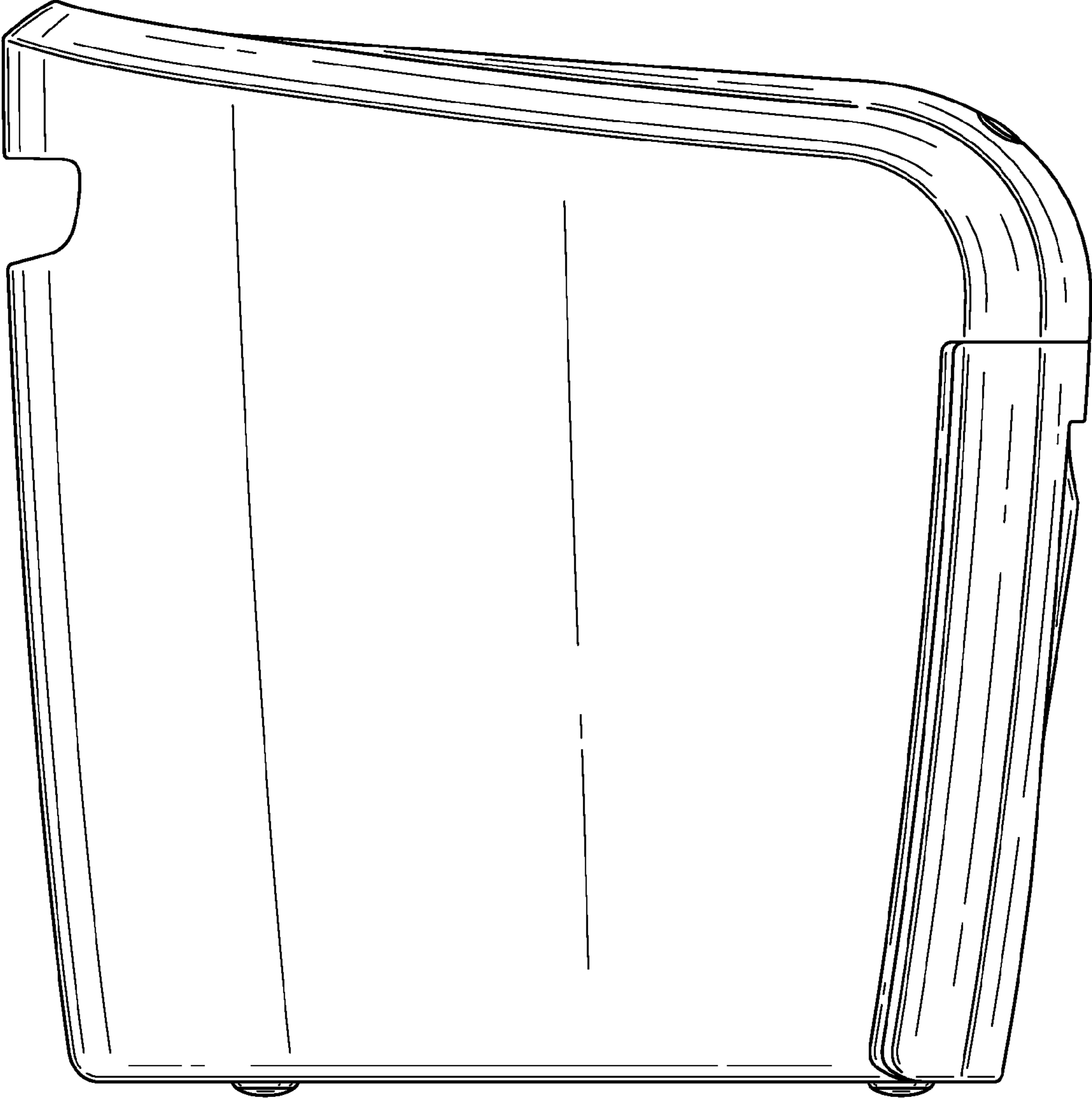

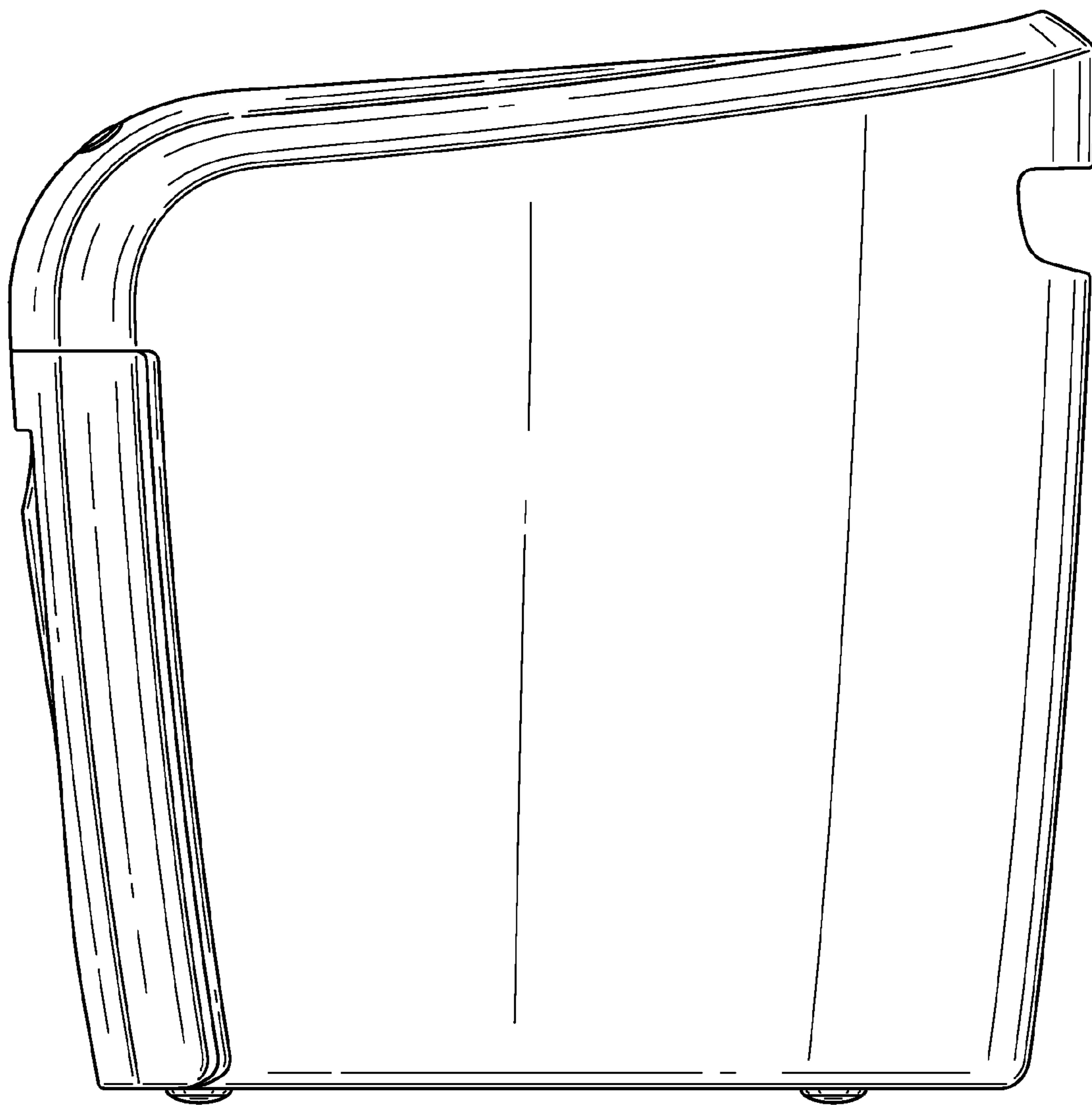

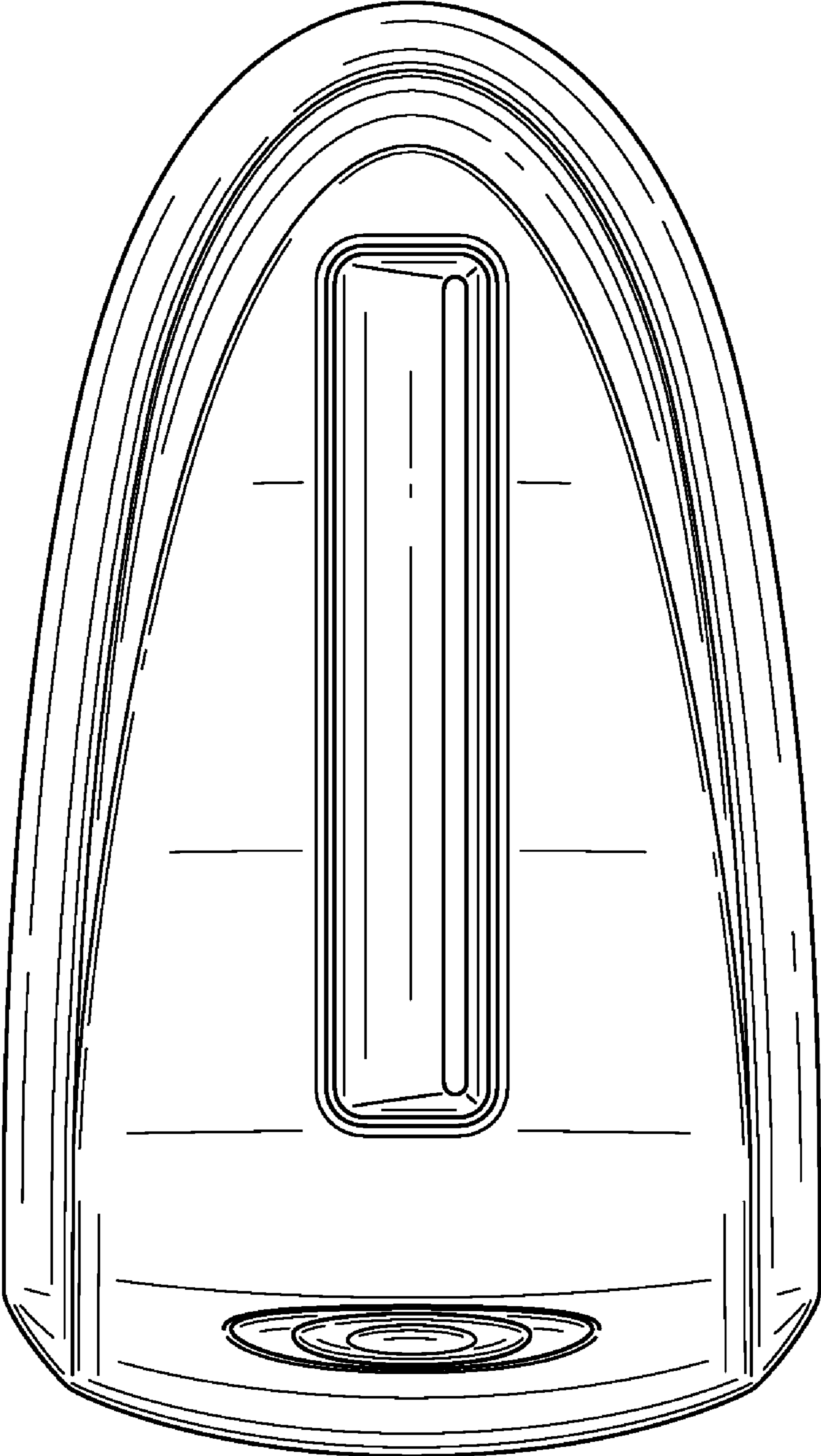

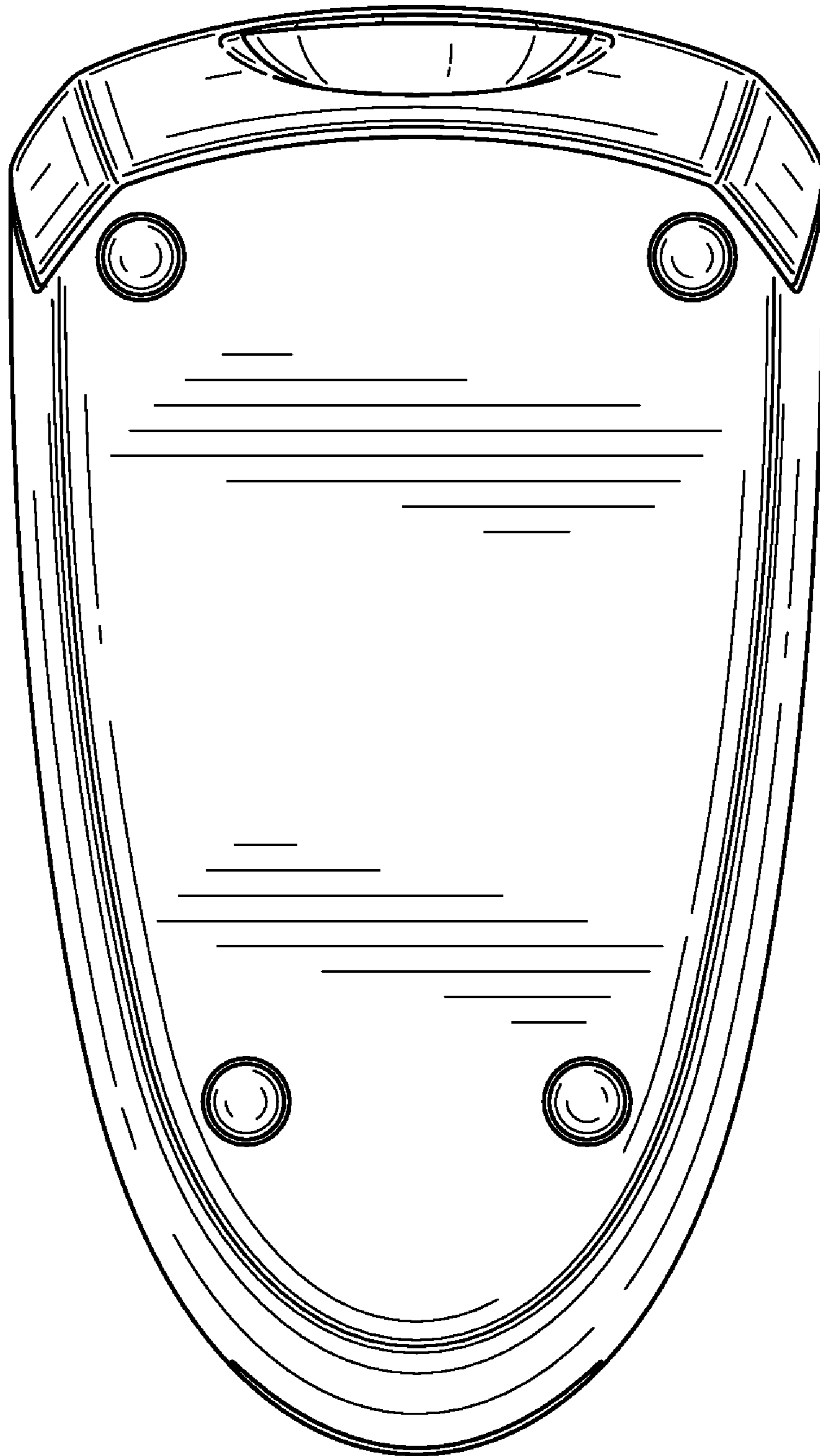

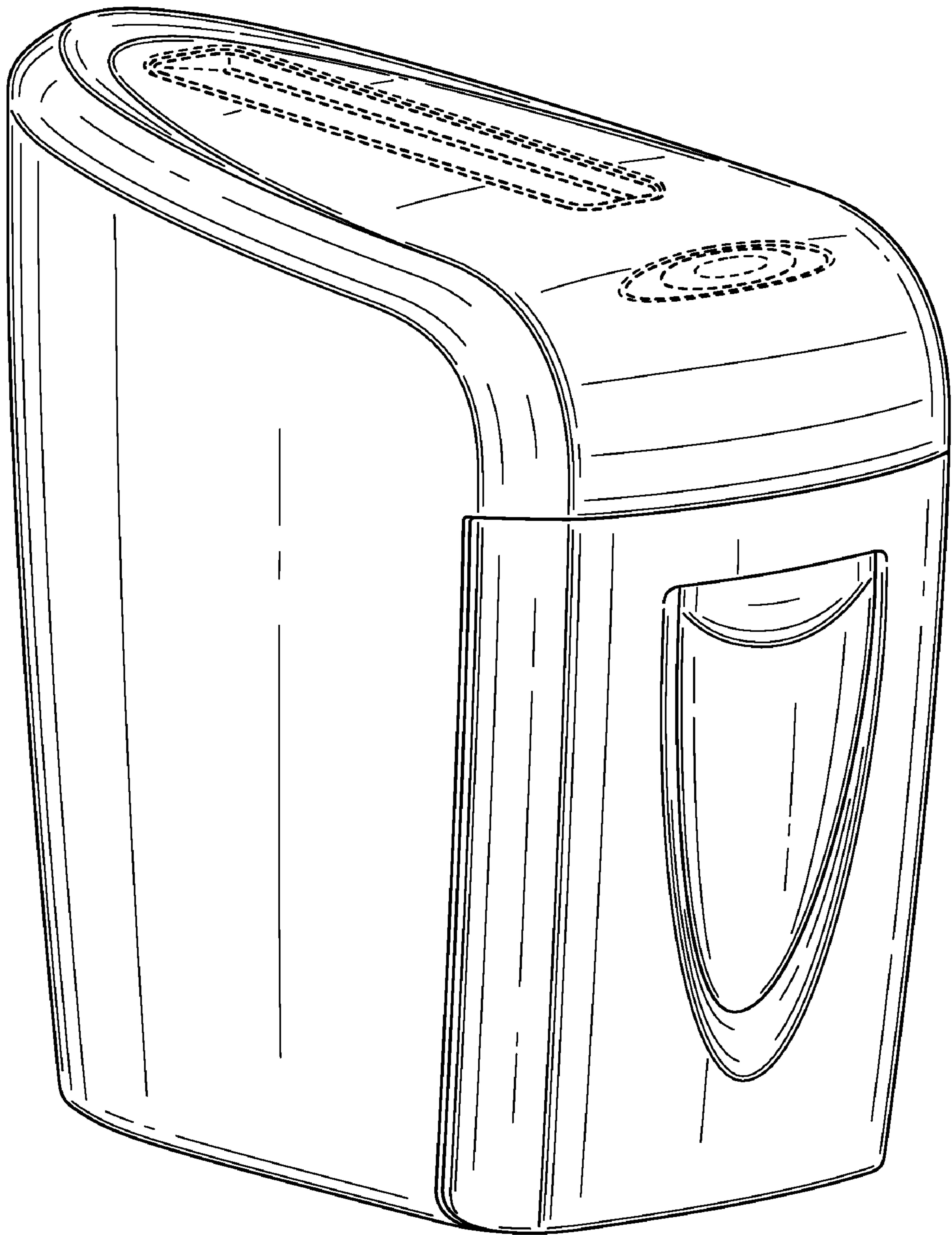

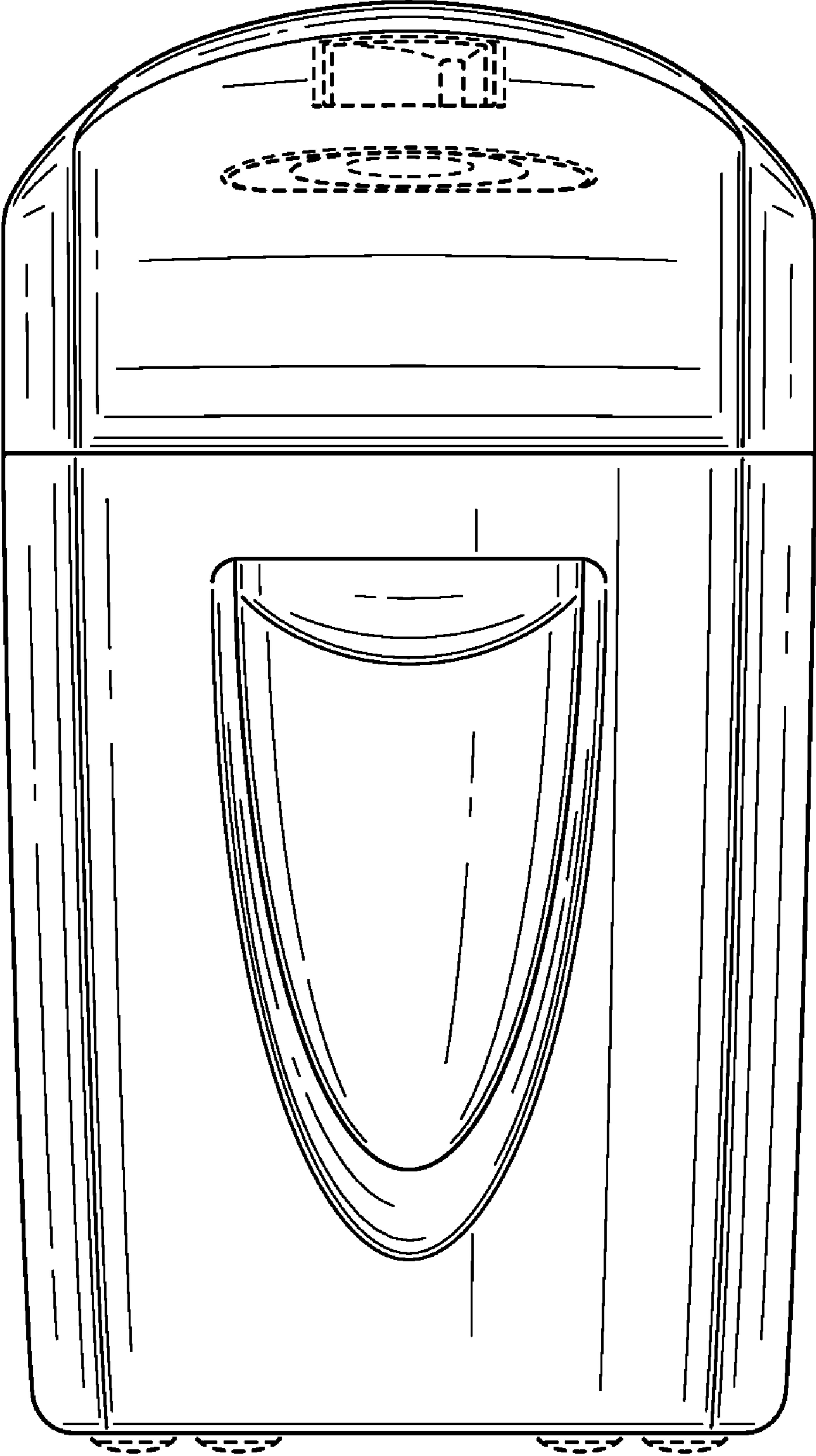

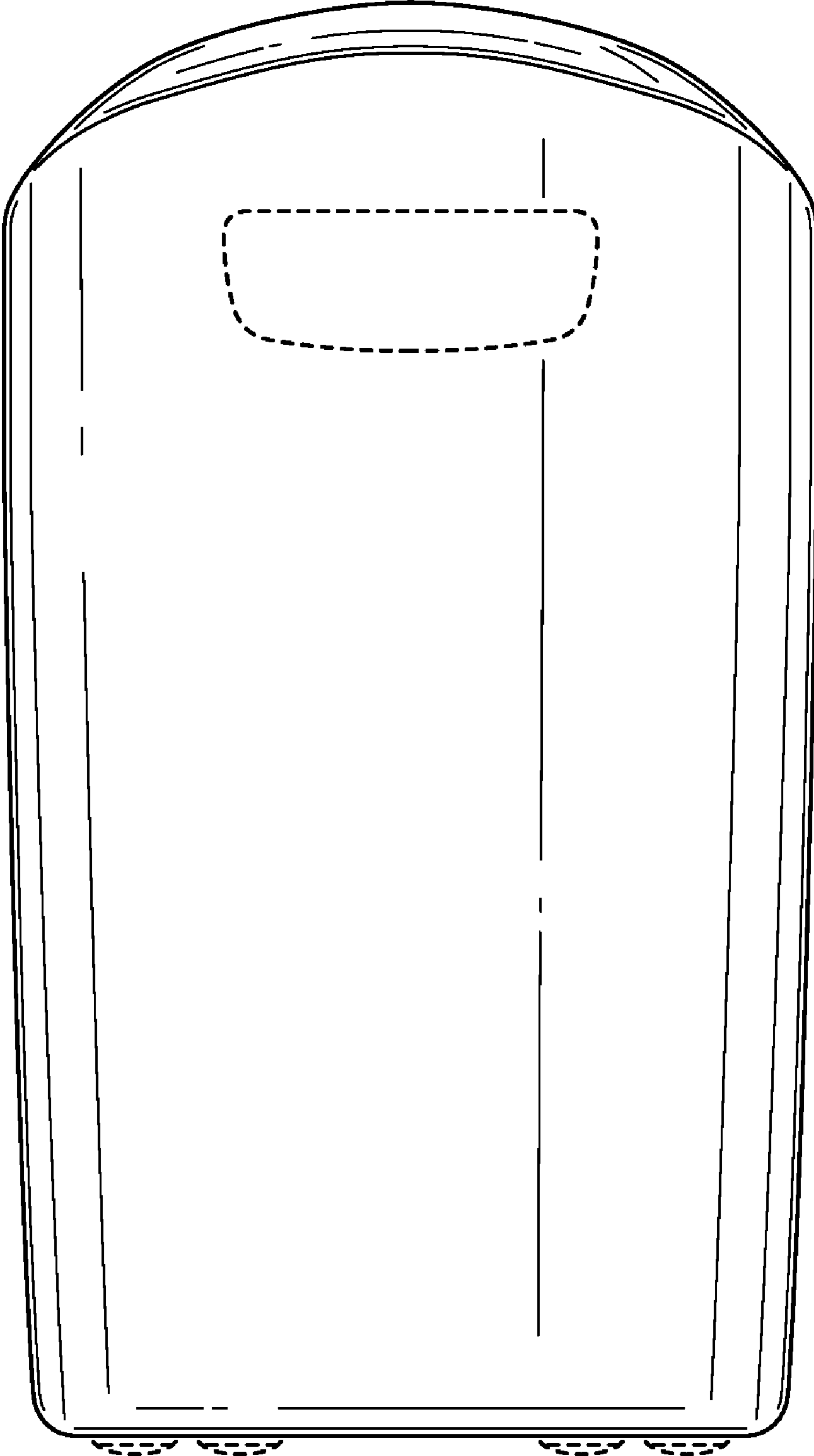

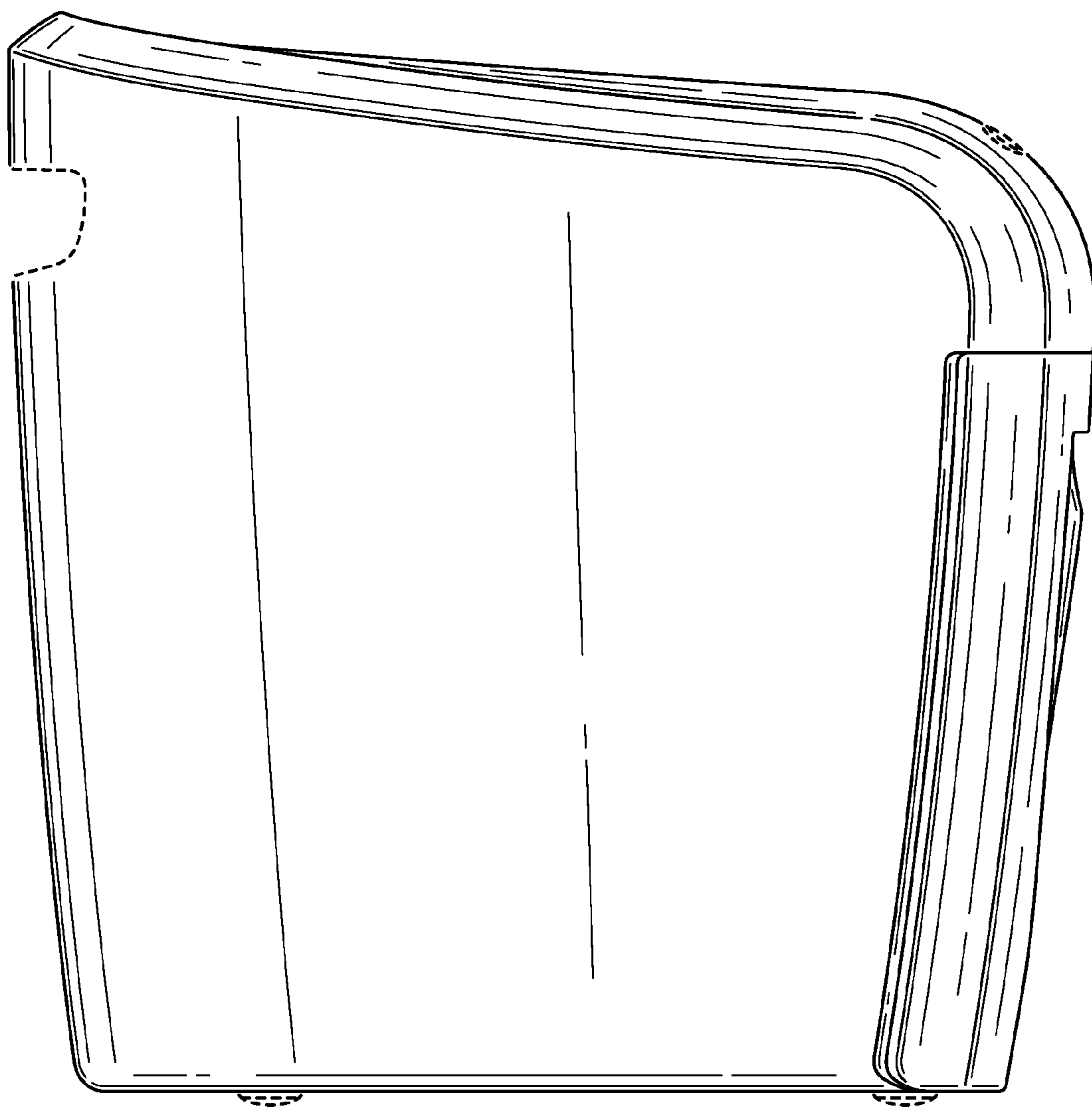

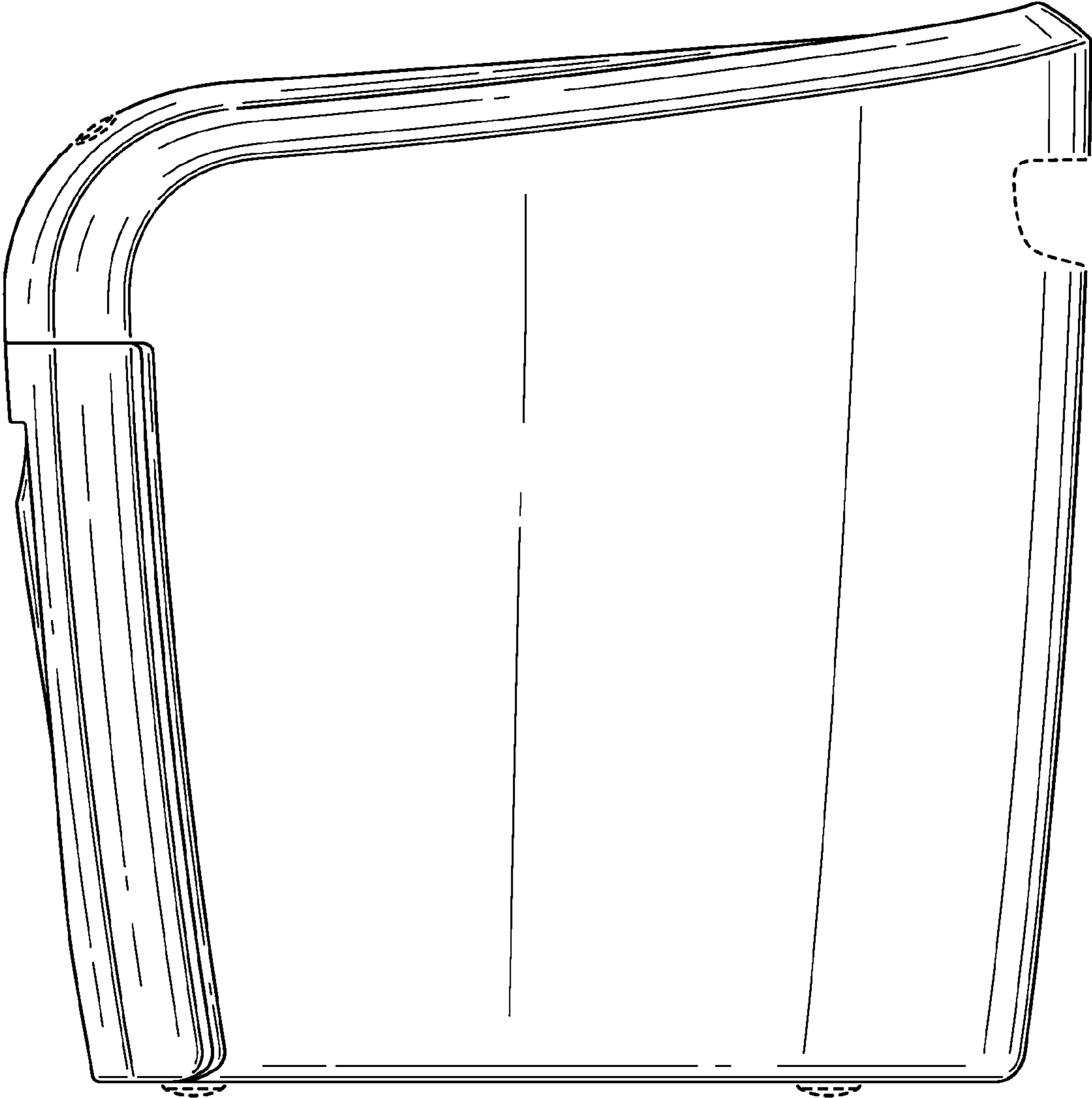

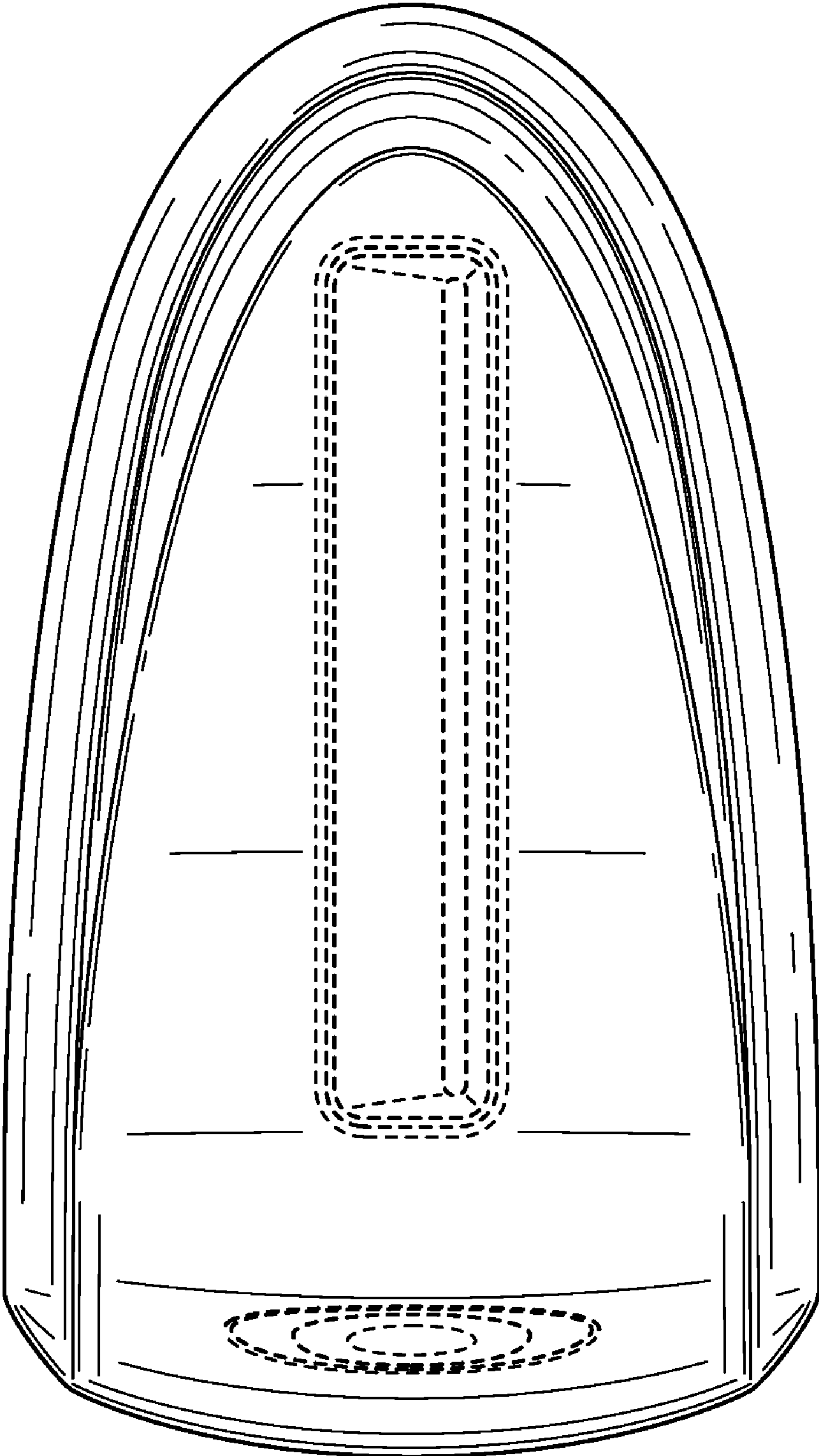

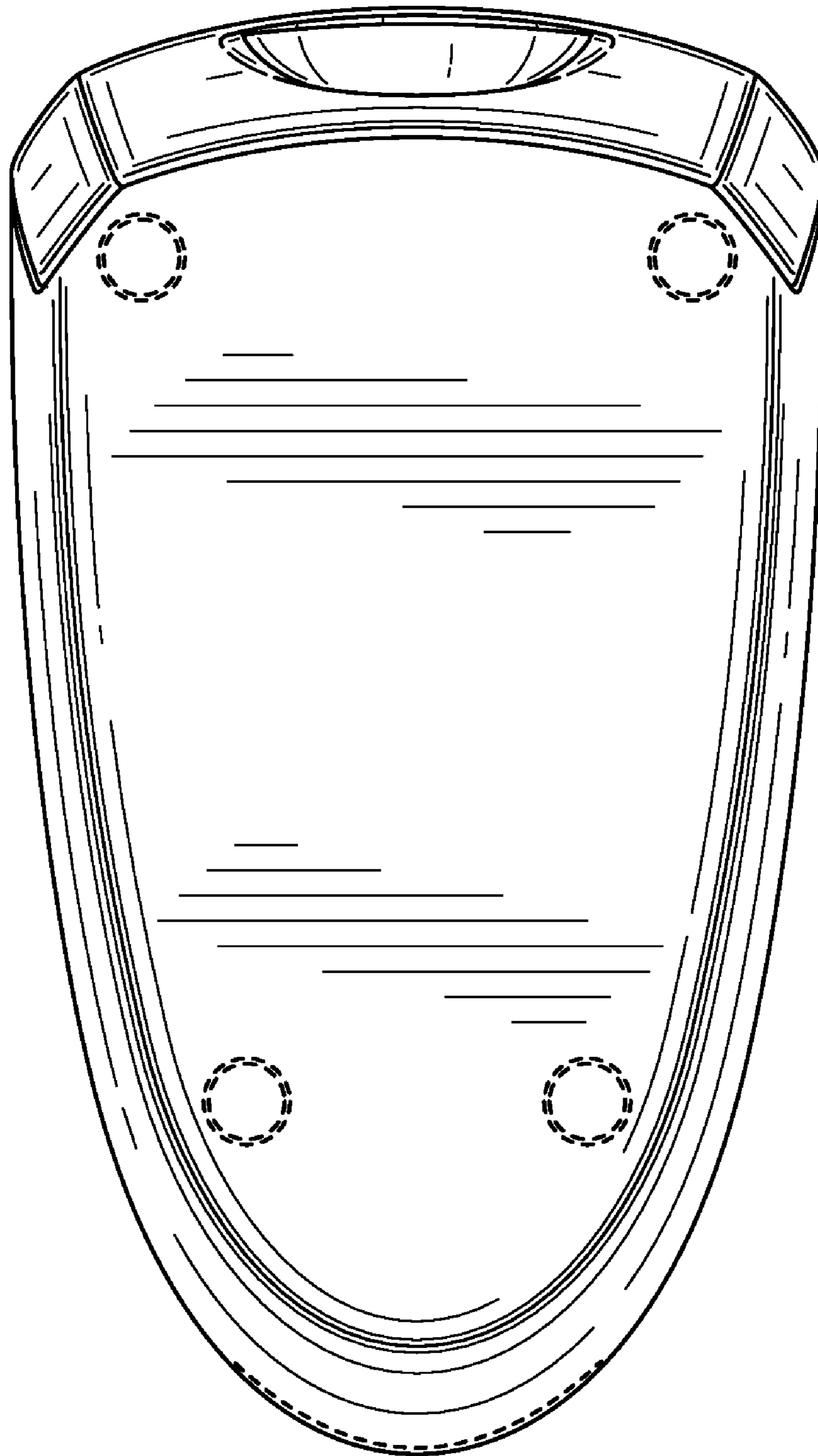
