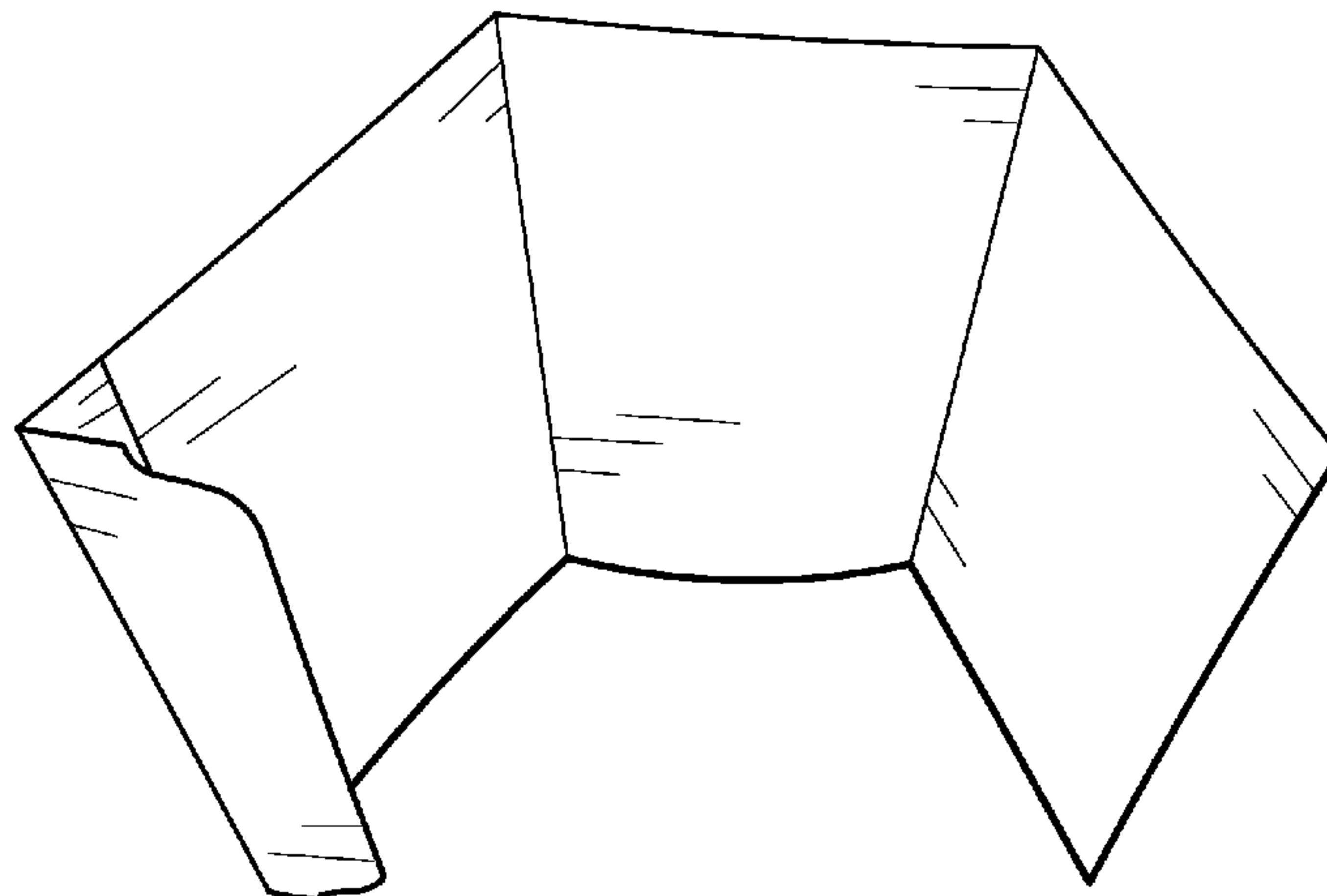


FIG. 18 is a side view of the front of the folding envelope of FIG. 15, the dotted lines represent non-claimed subject matter;

FIG. 31 is a bottom plan view of the folding envelope of FIG. 29;

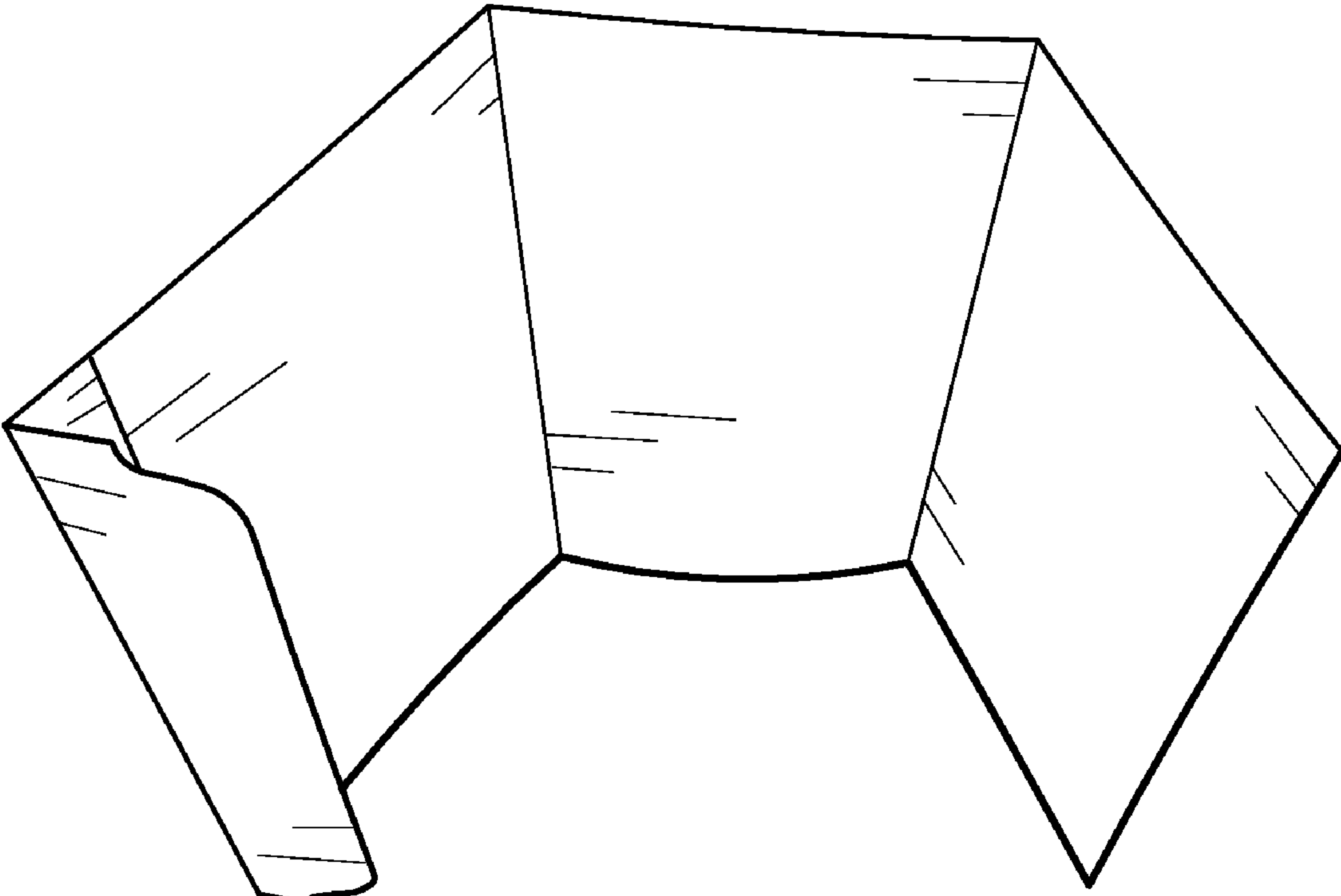
FIG. 32 is a plan view into the pocket of the folding envelope of FIG. 29;

FIG. 33 is a plan view of the bottom of the pocket of the folding envelope of FIG. 29;

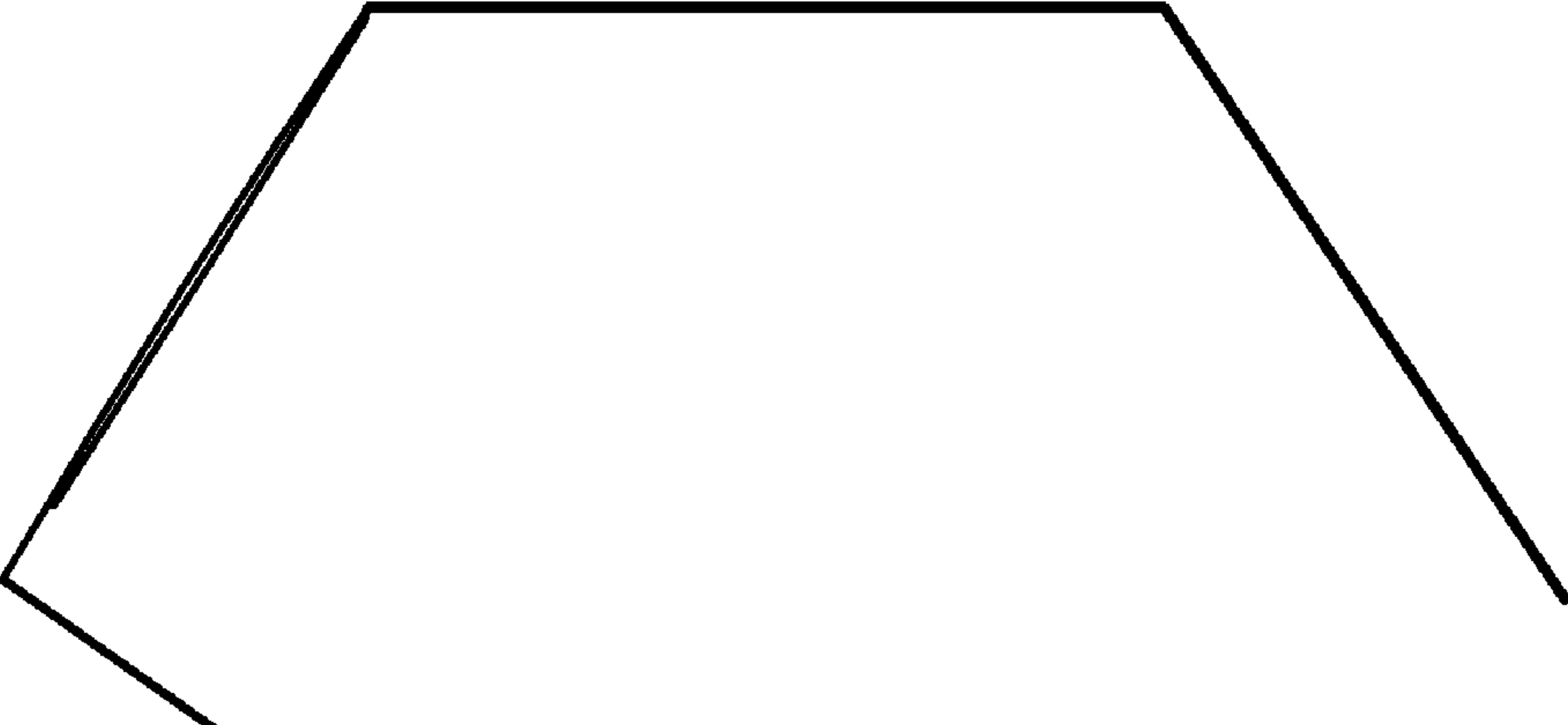
FIG. 34 is a plan view of the back of folding envelope of FIG. 29; and,

FIG. 35 is a plan view of the front of folding envelope of FIG. 29, the dotted lines represent non-claimed subject matter.

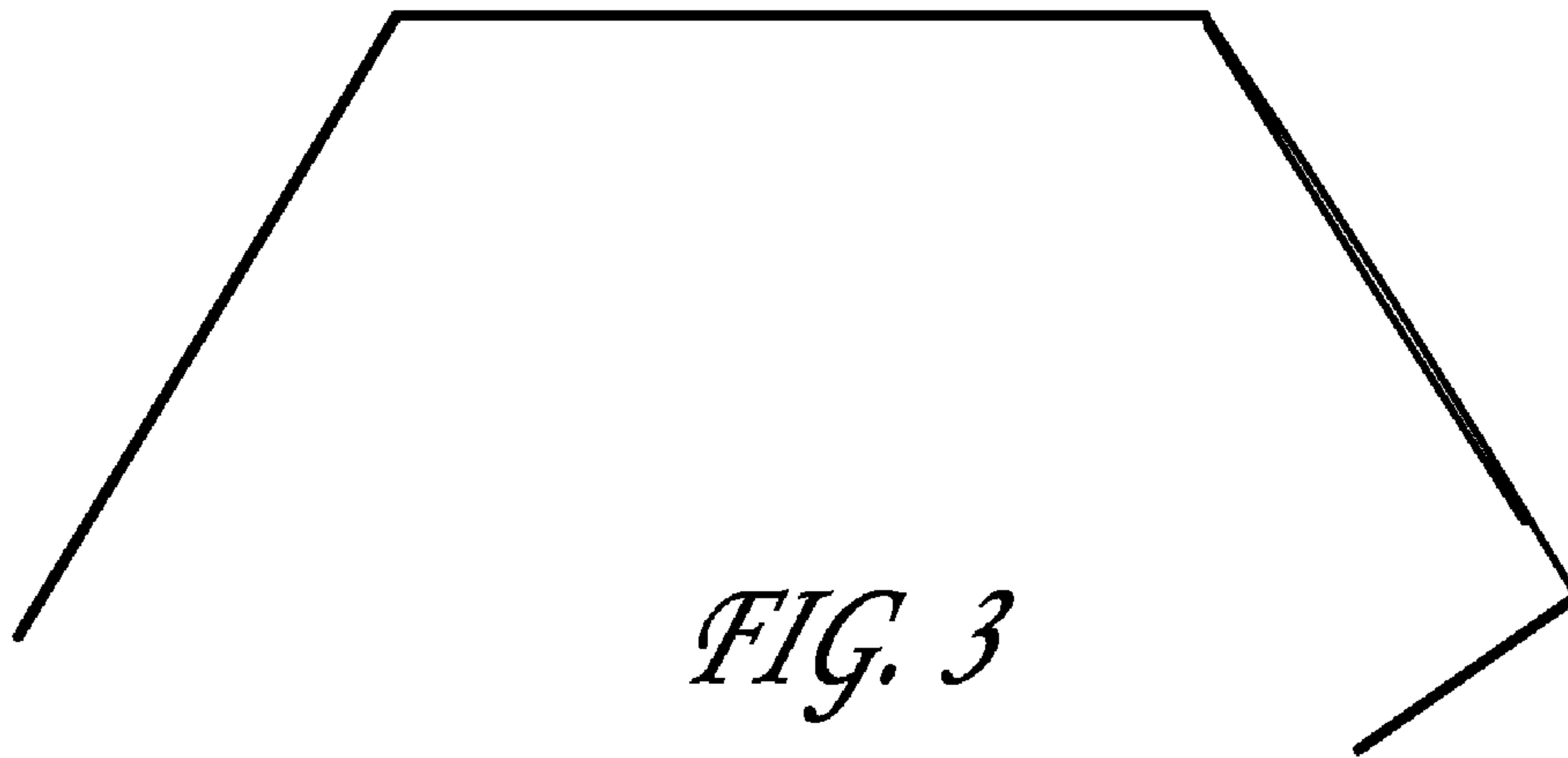

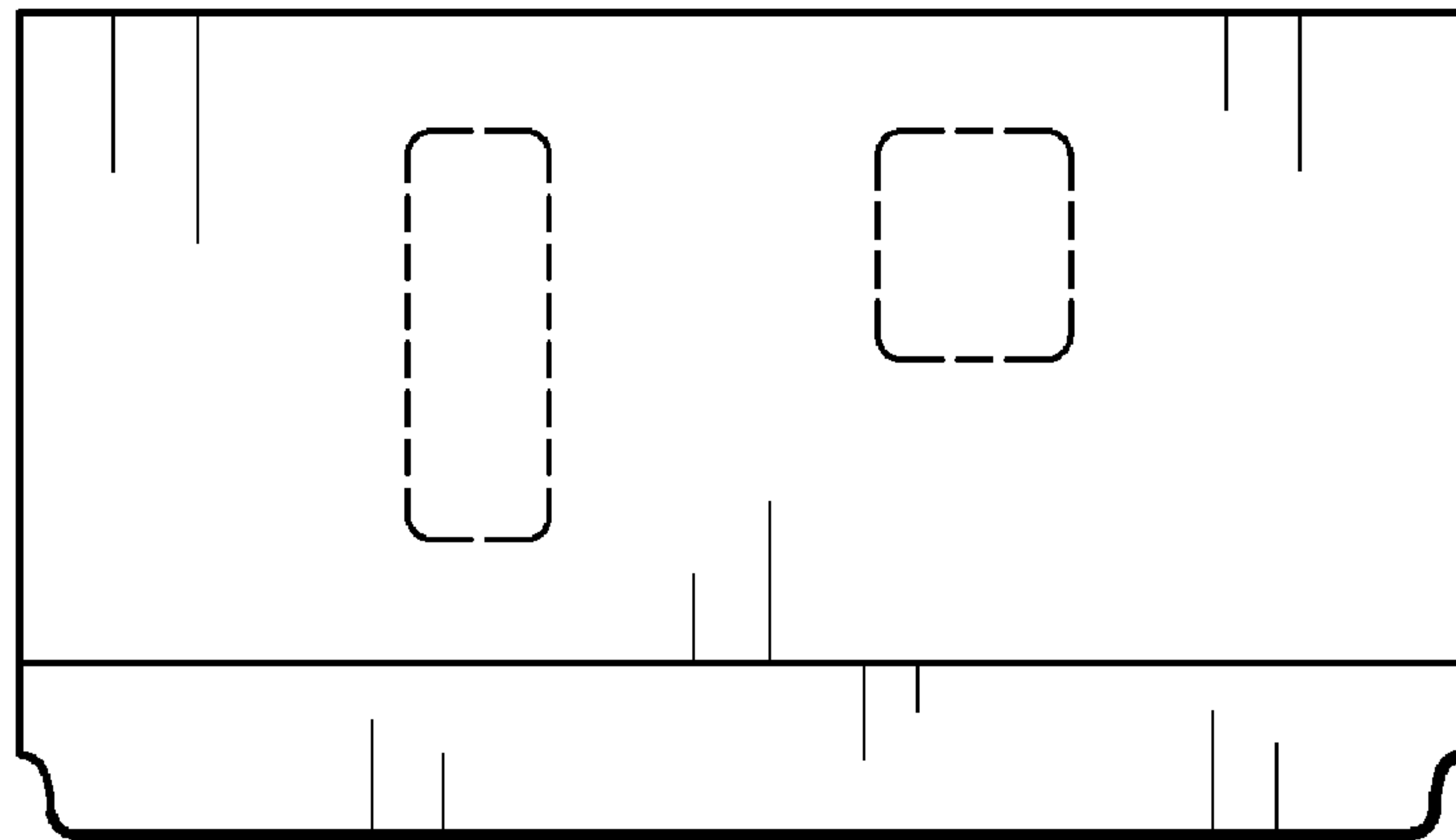

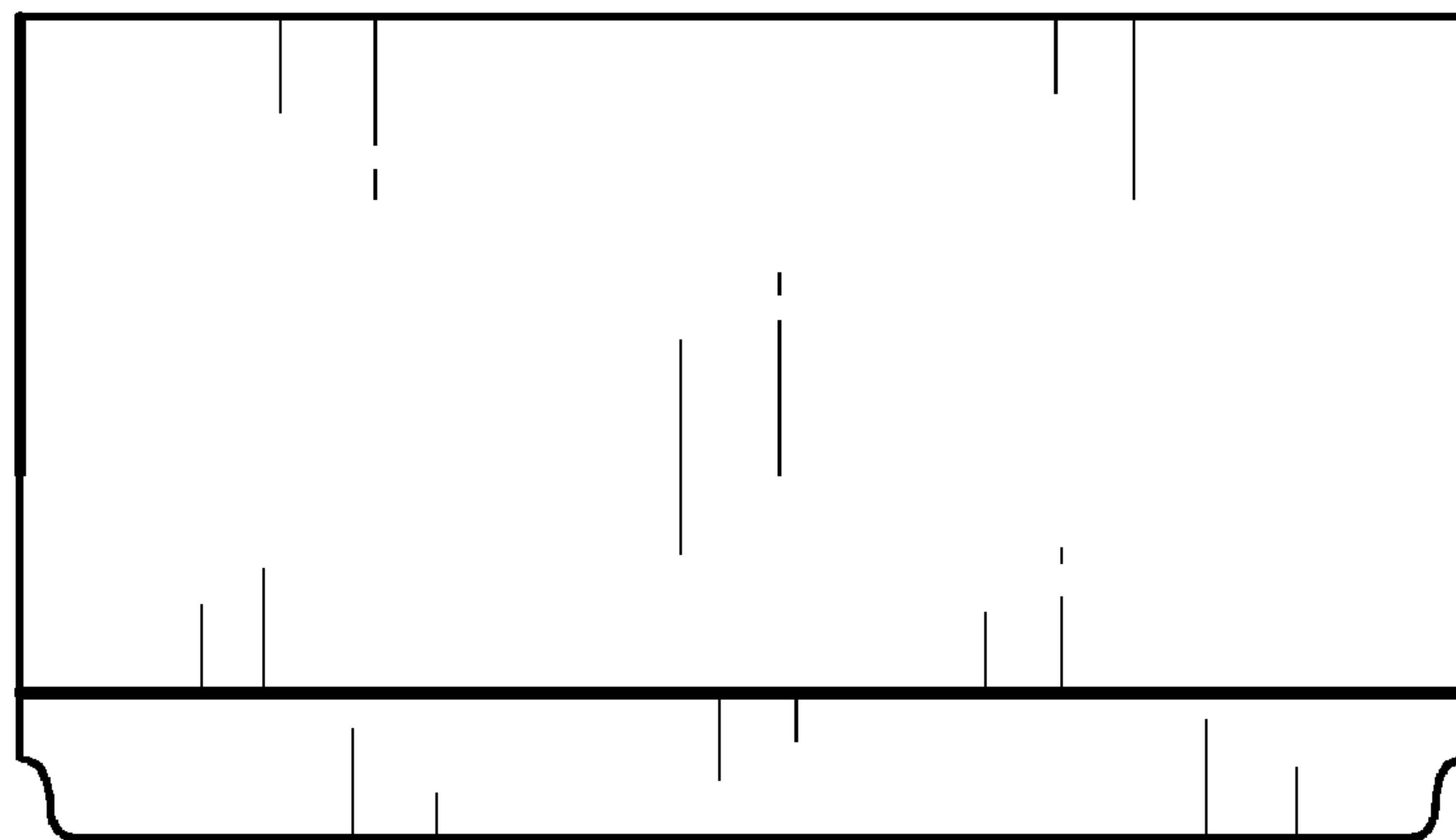

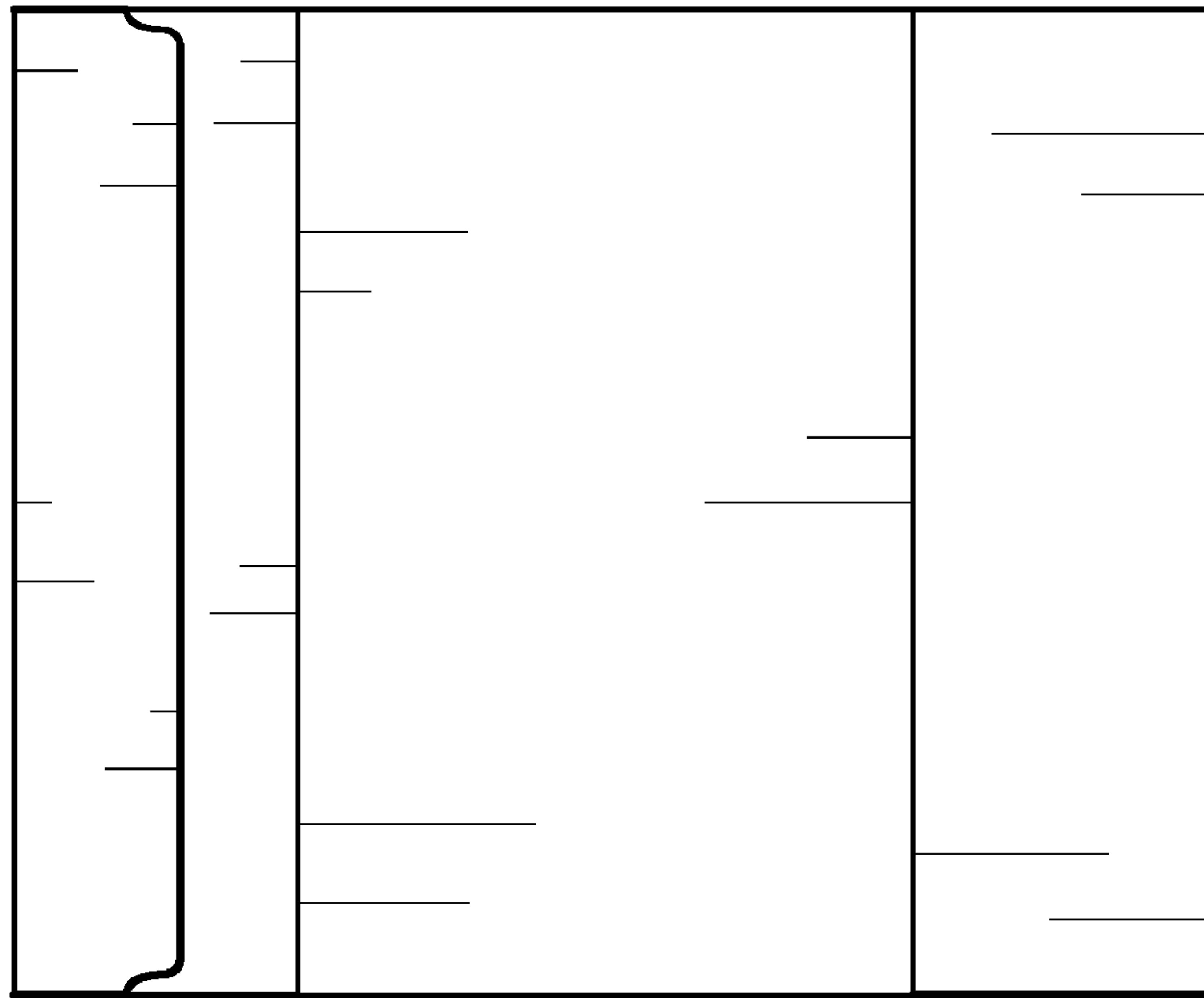

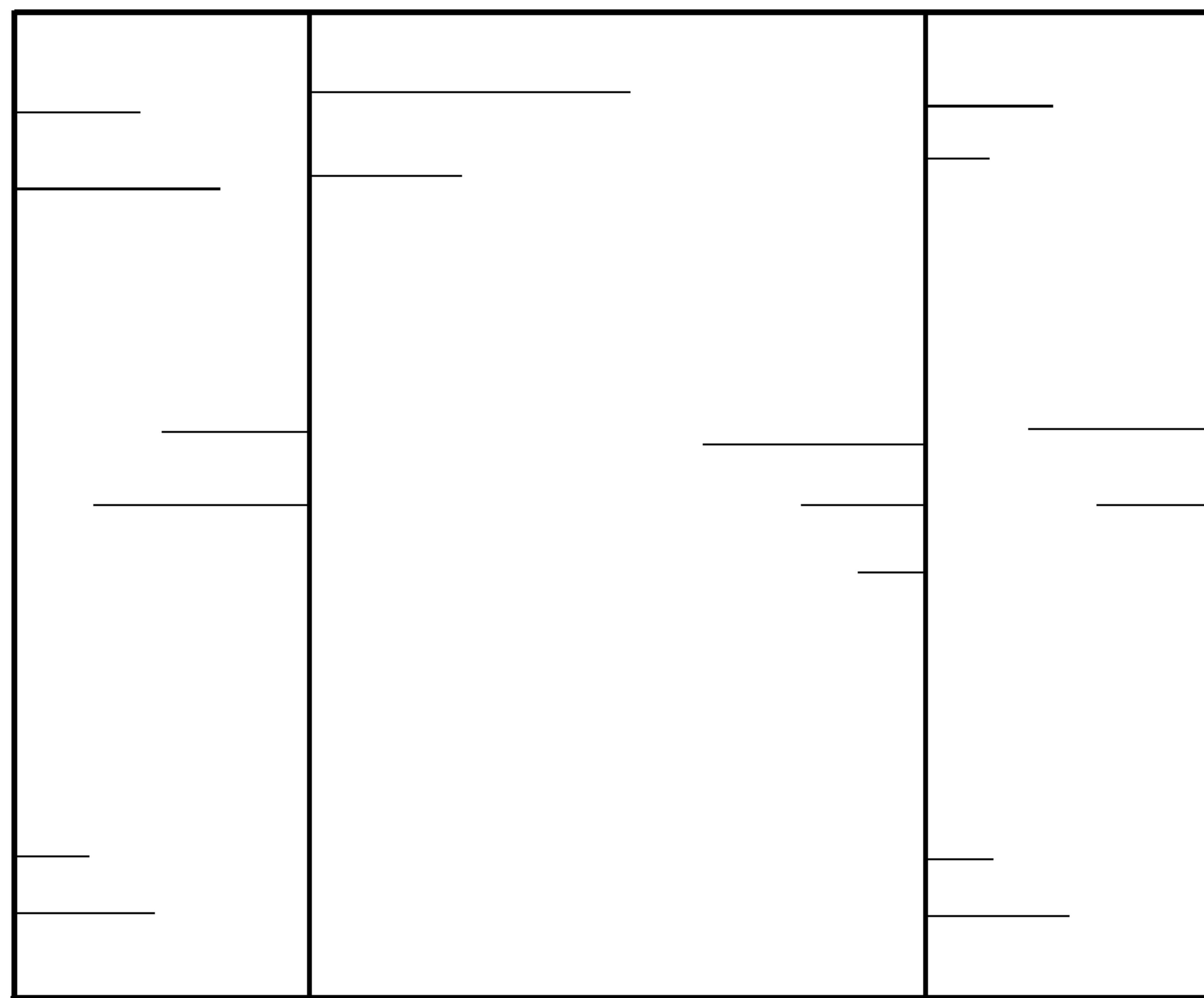

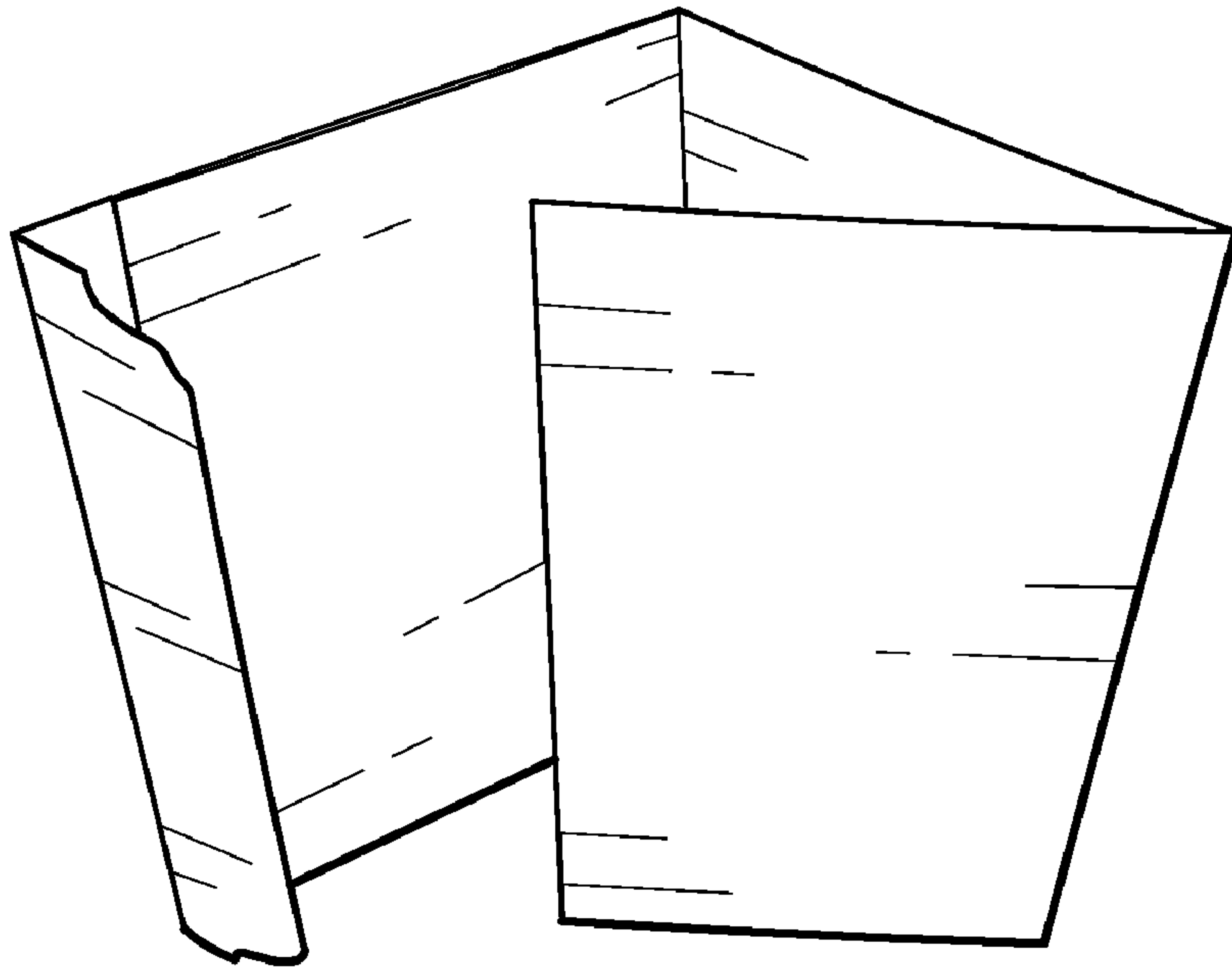

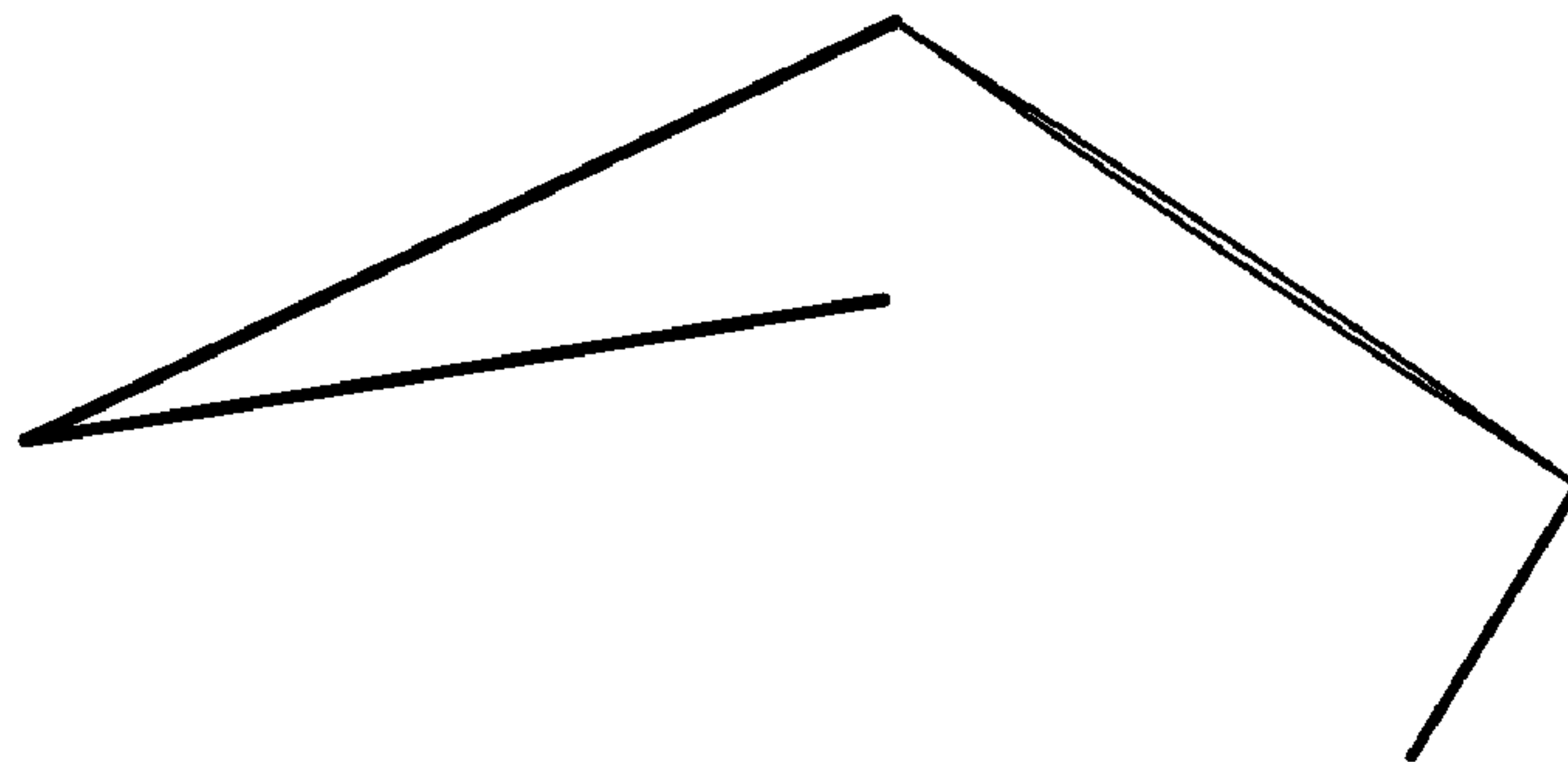

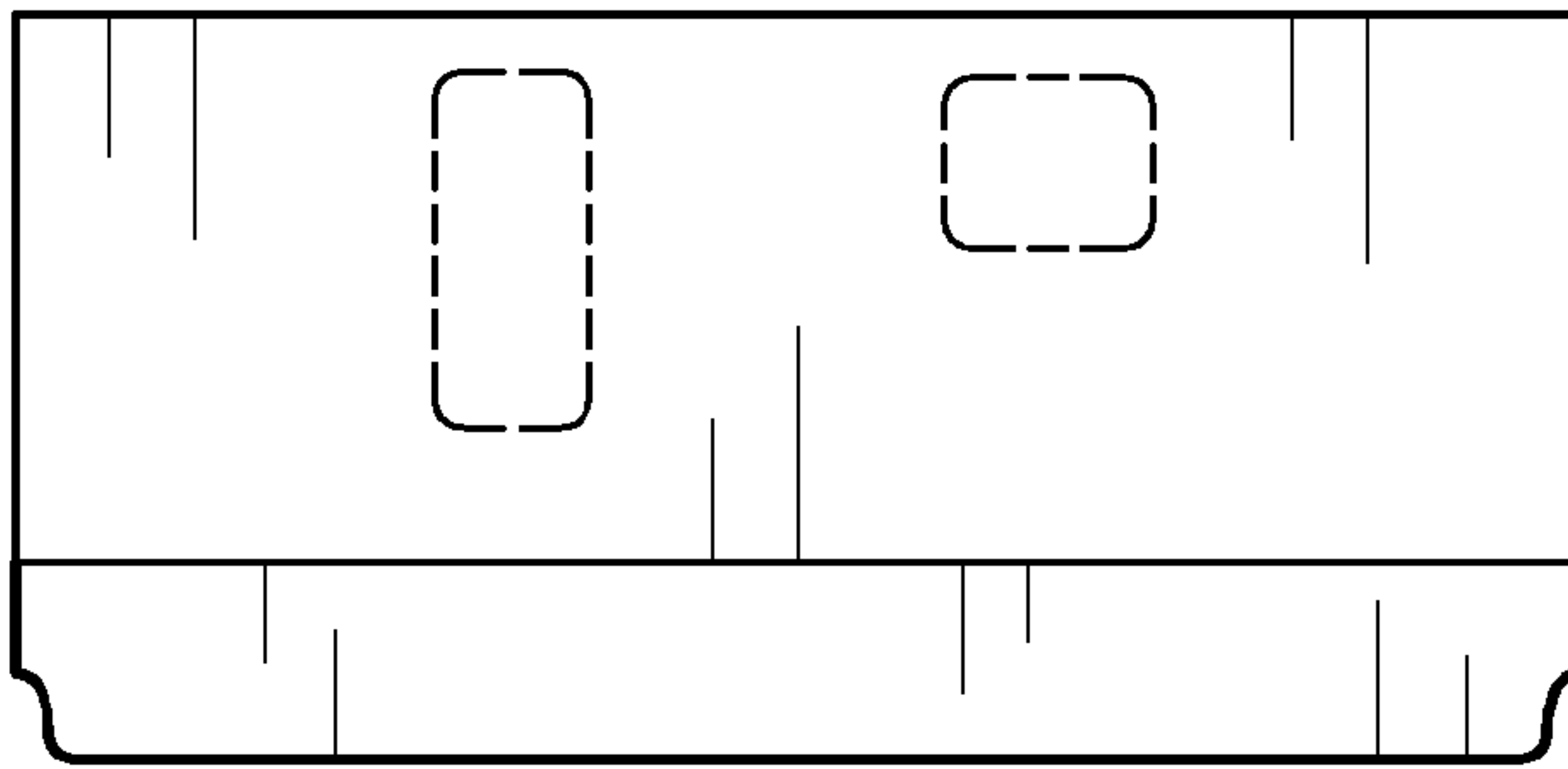

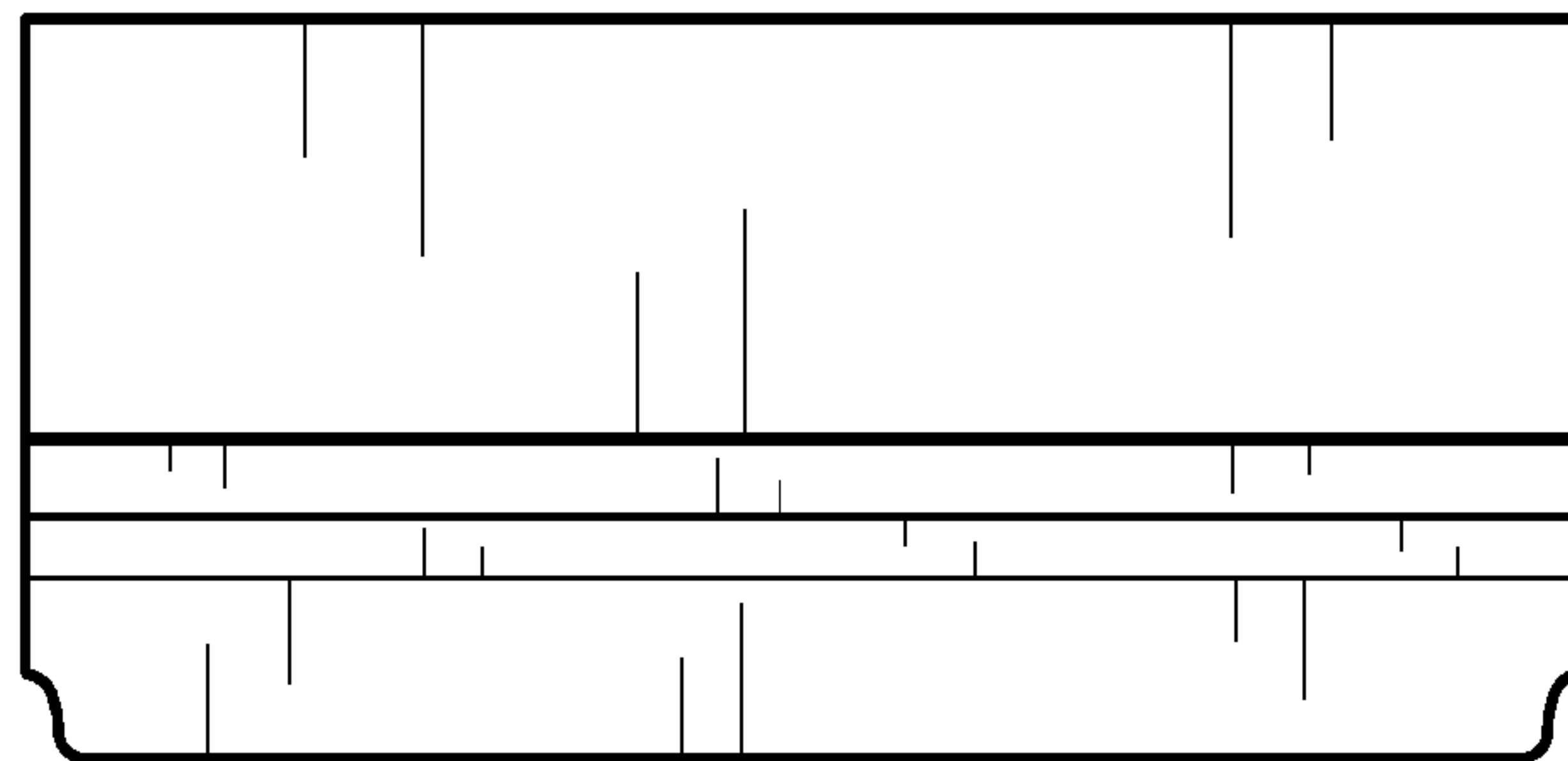

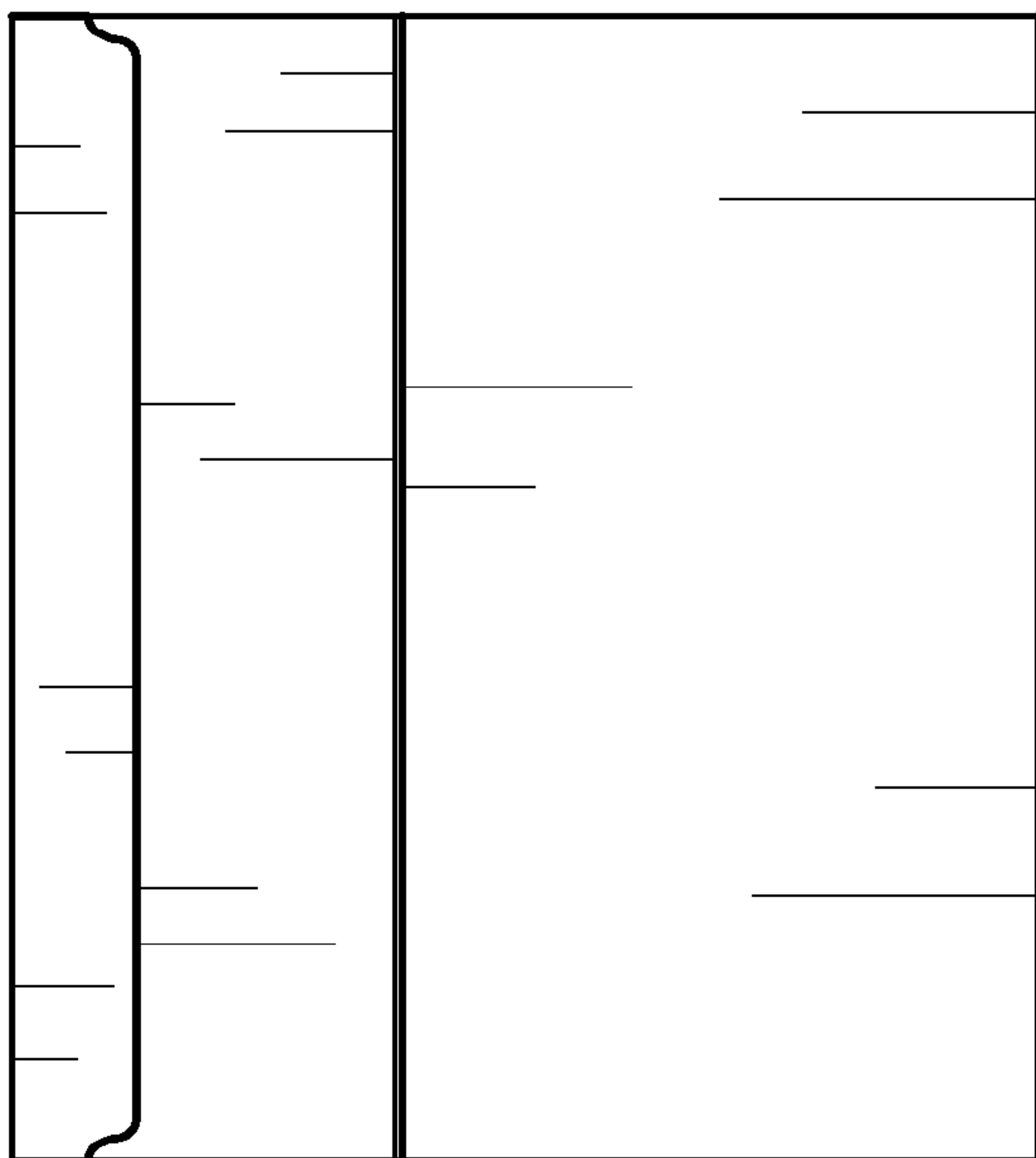

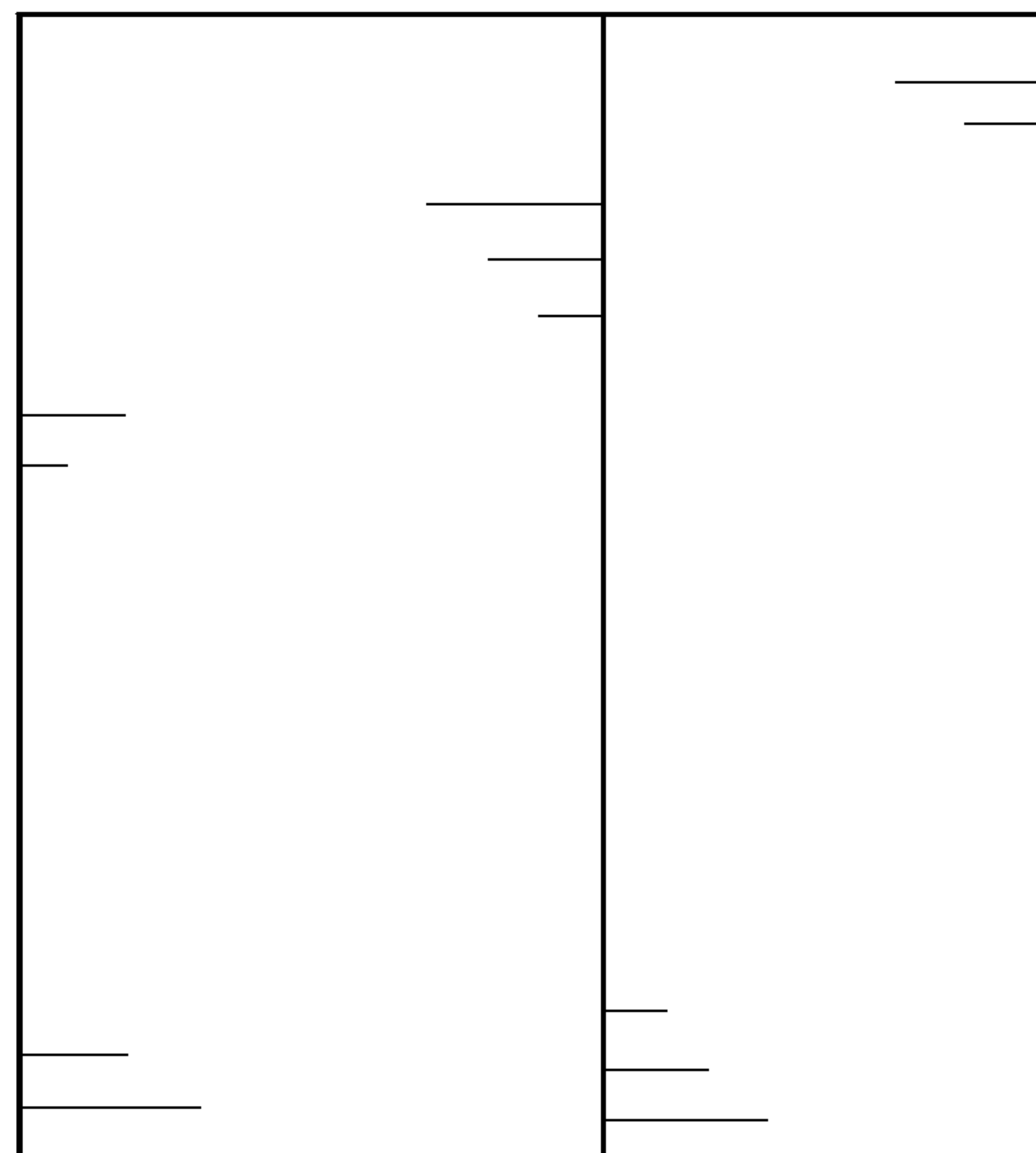

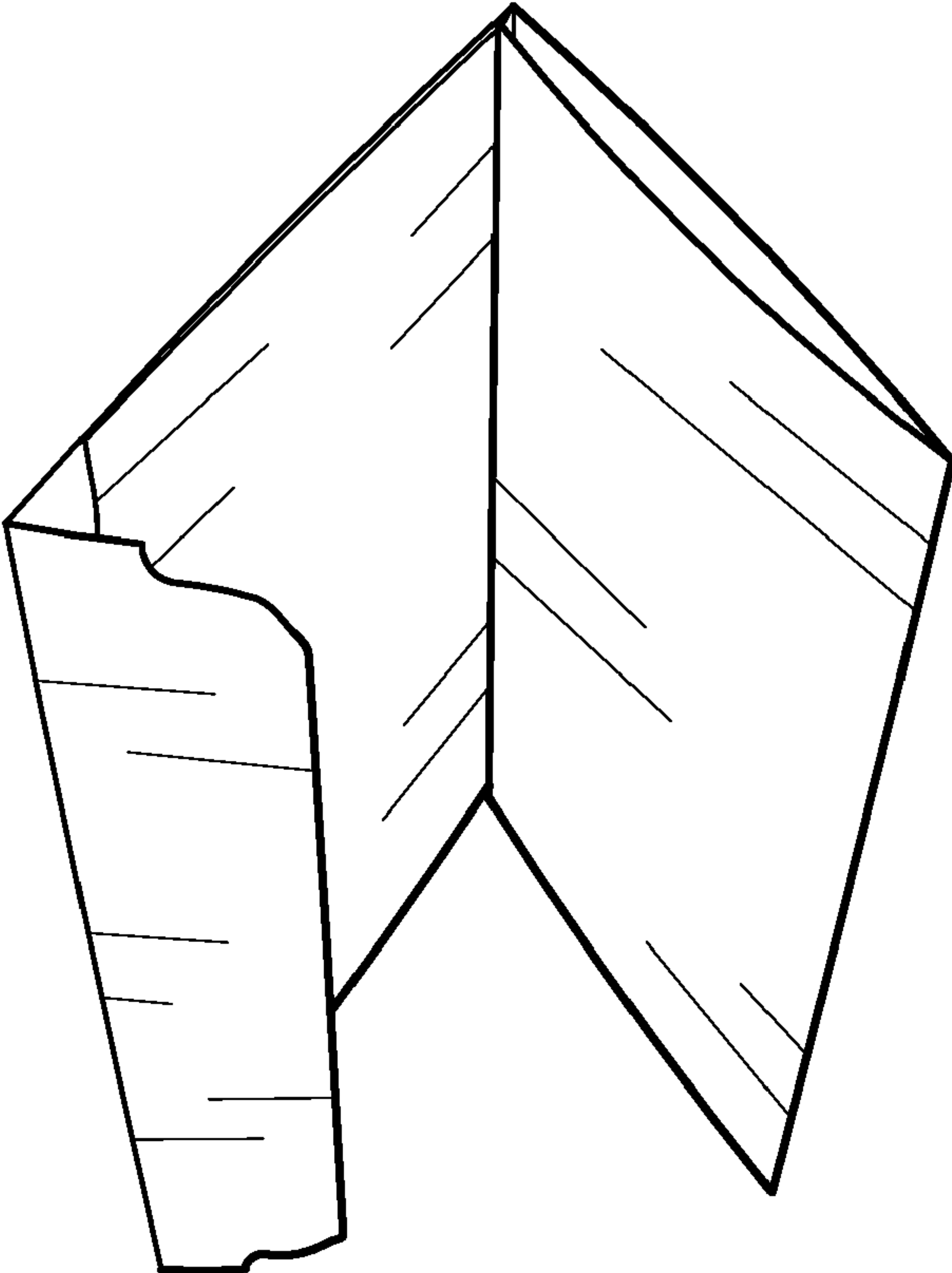

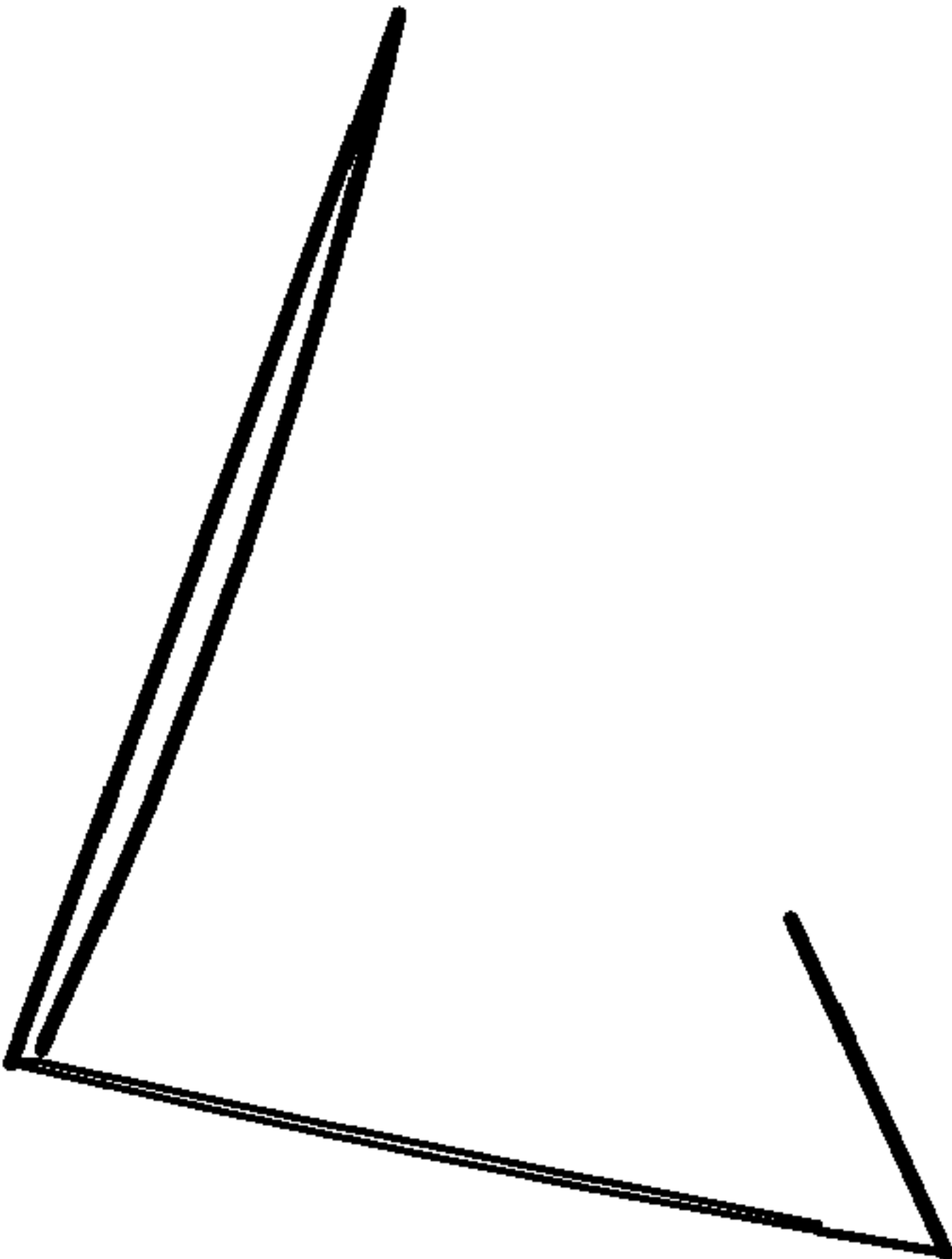

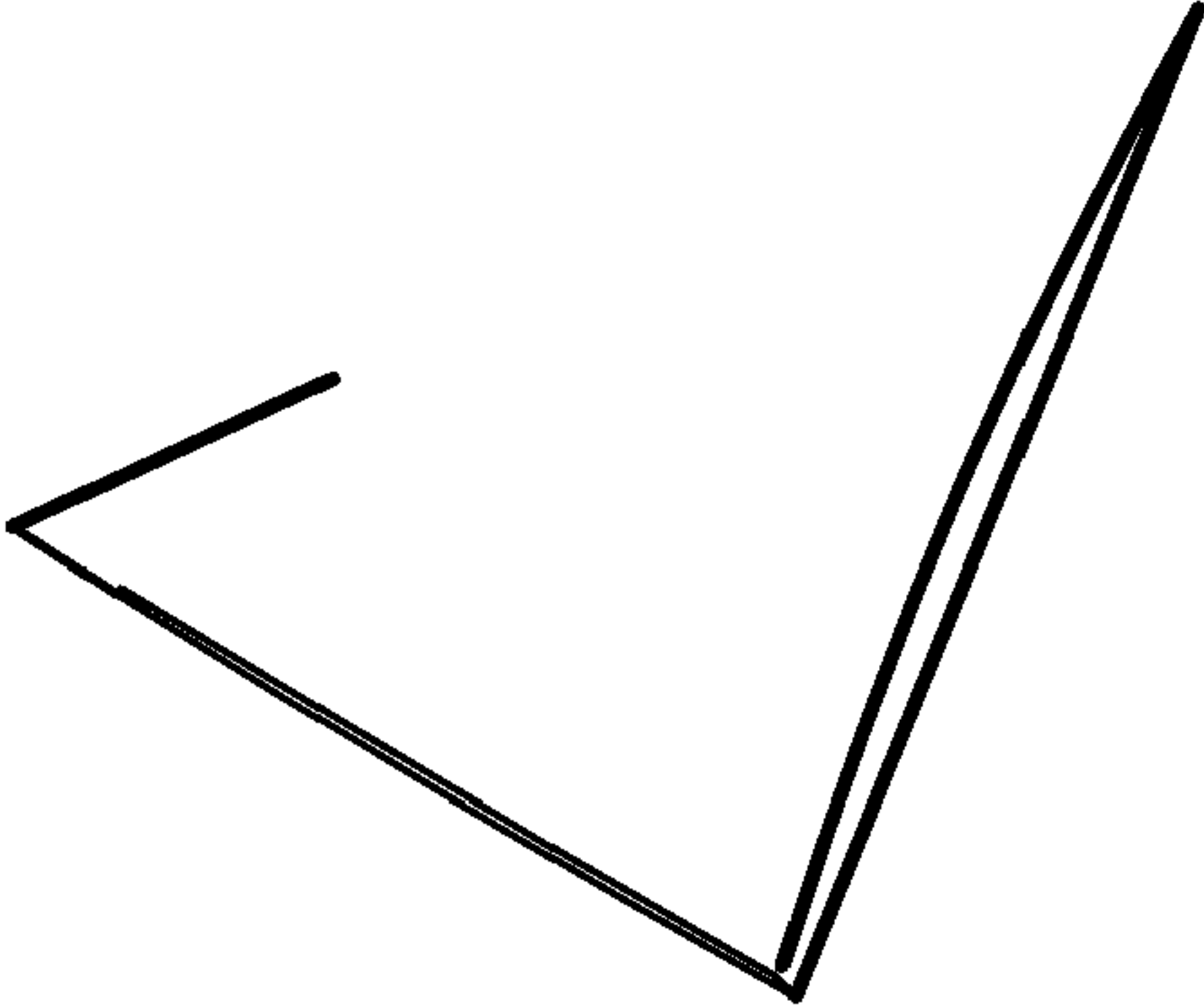

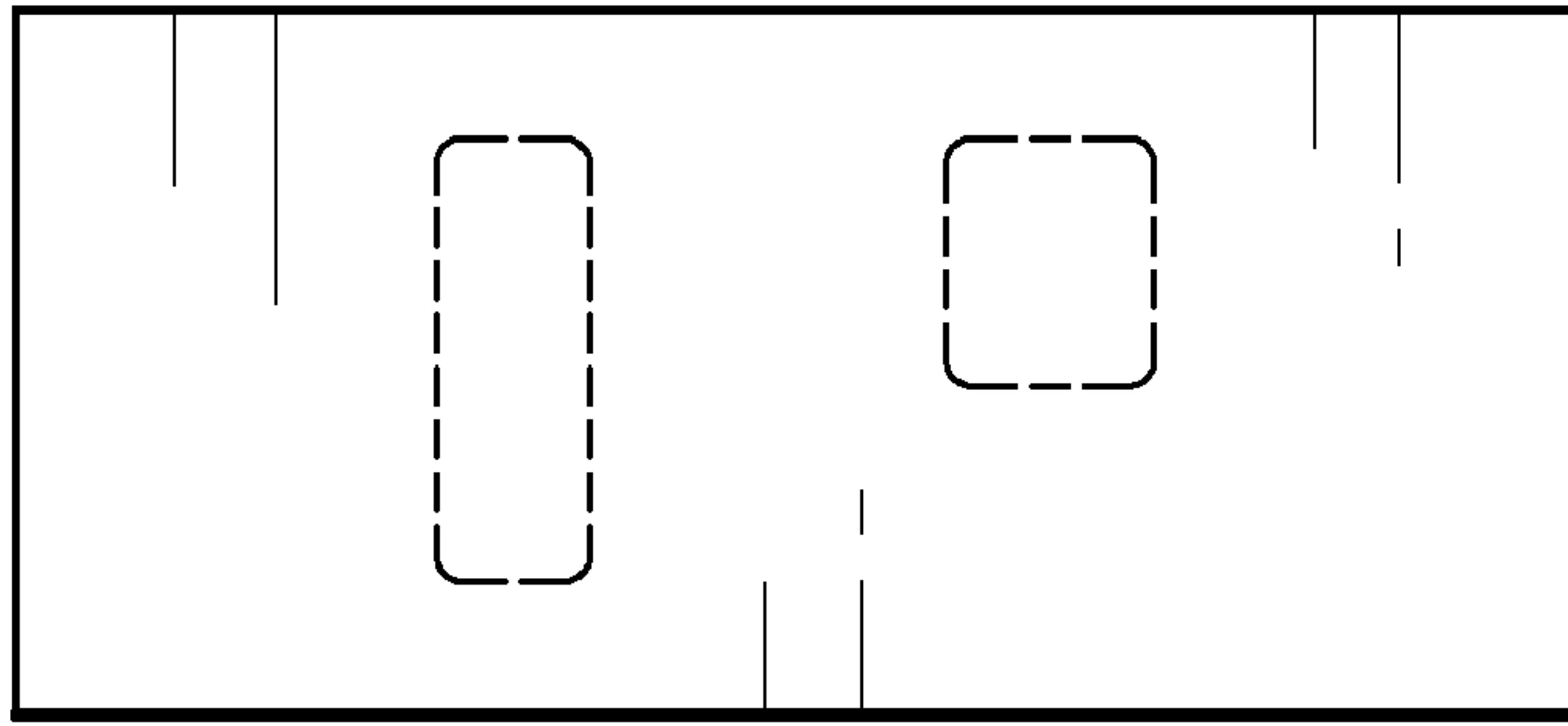

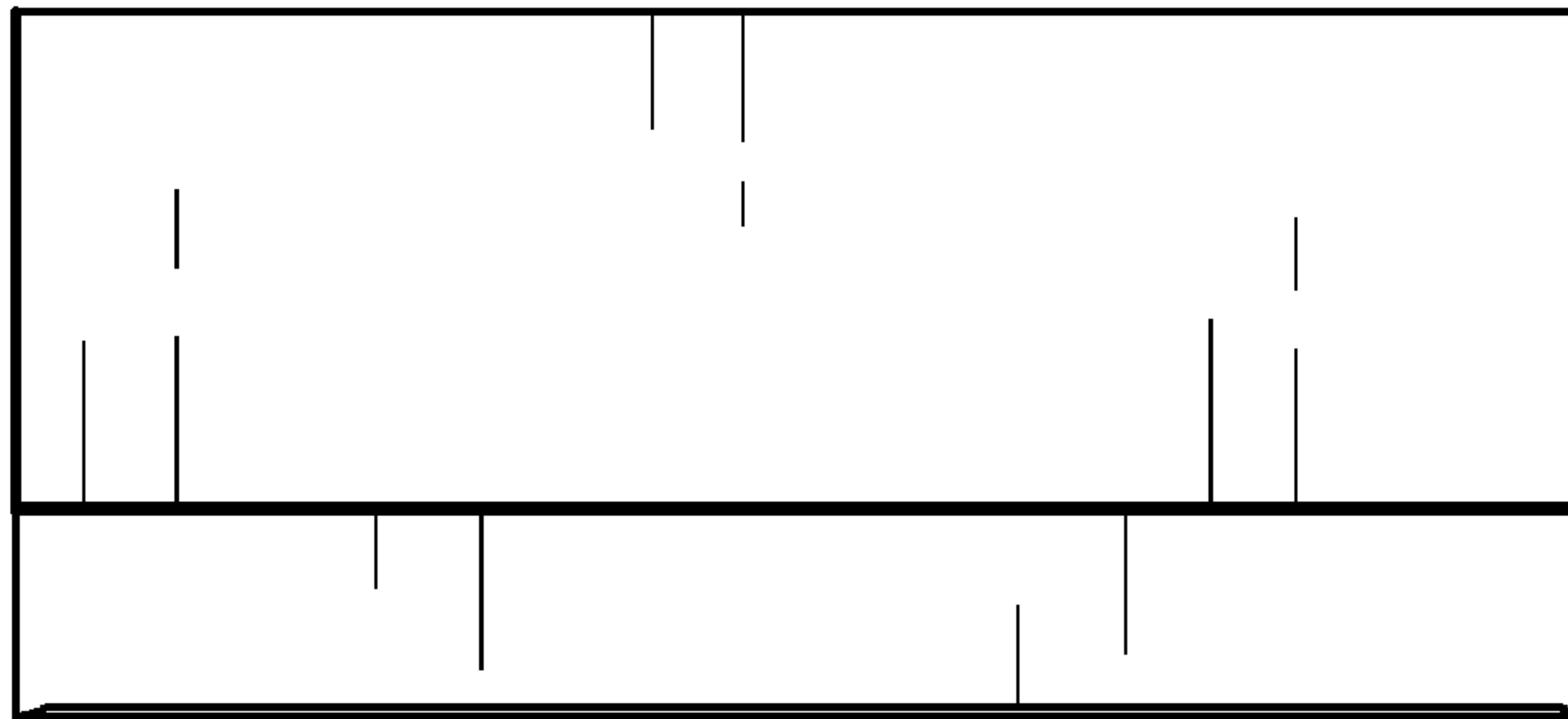

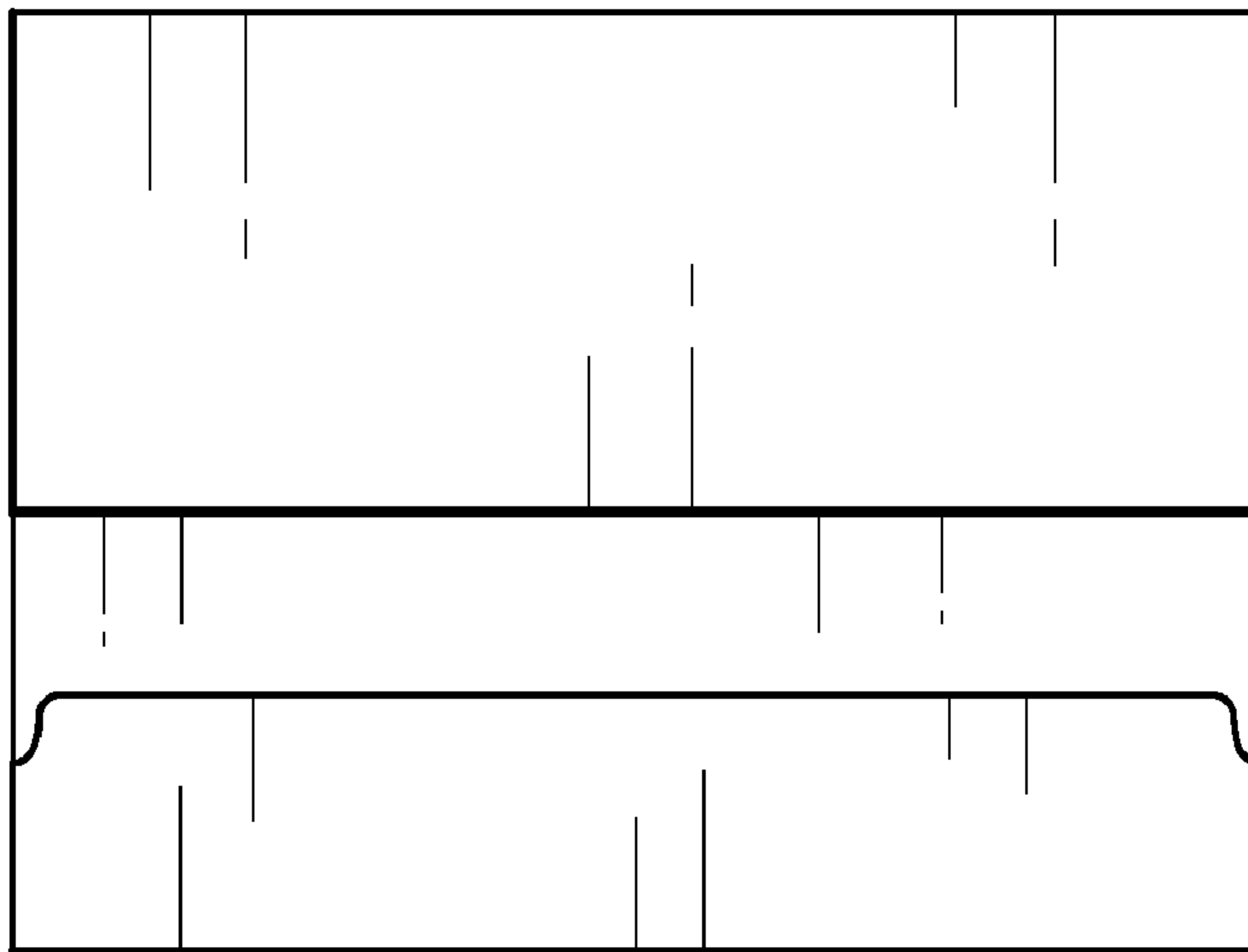




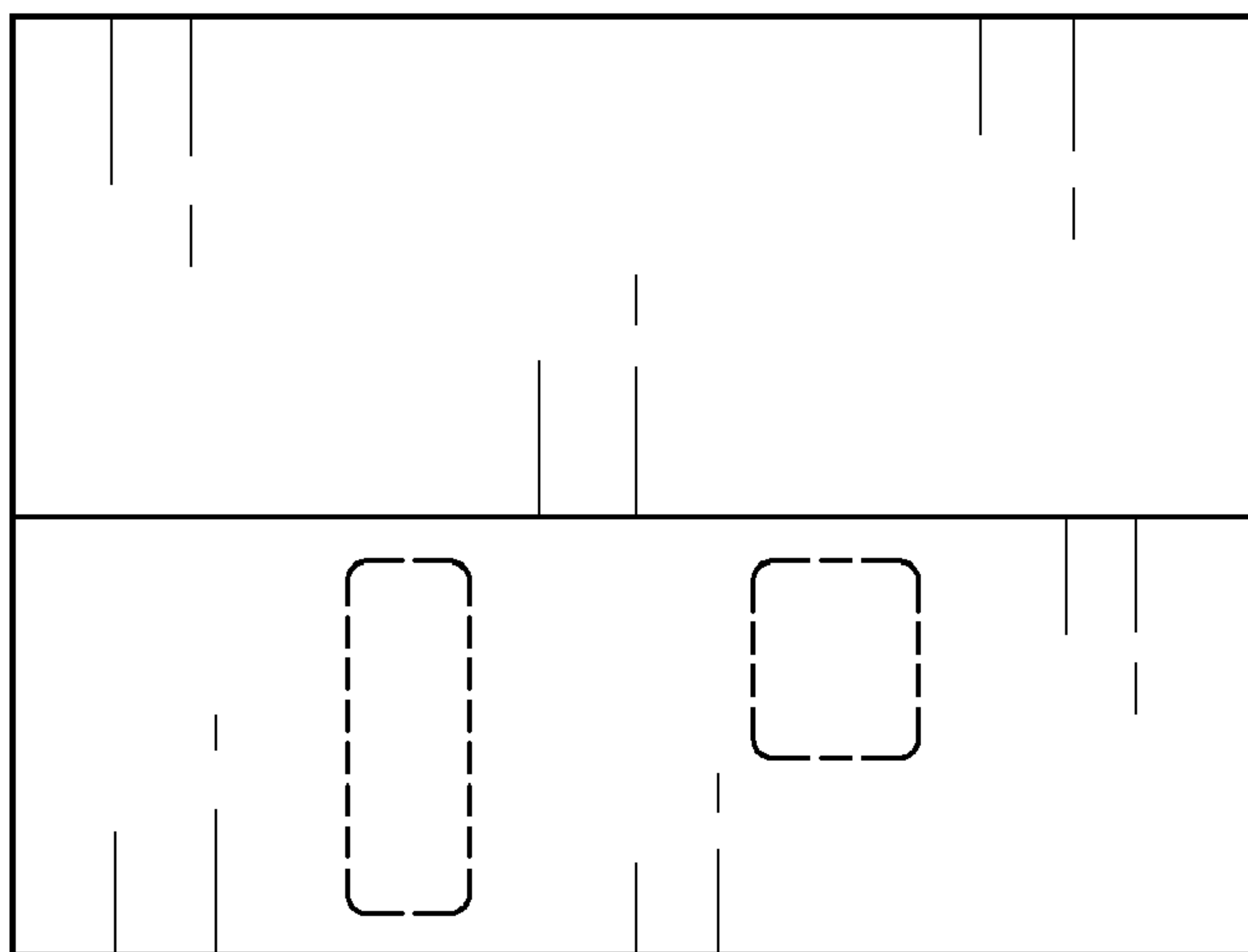

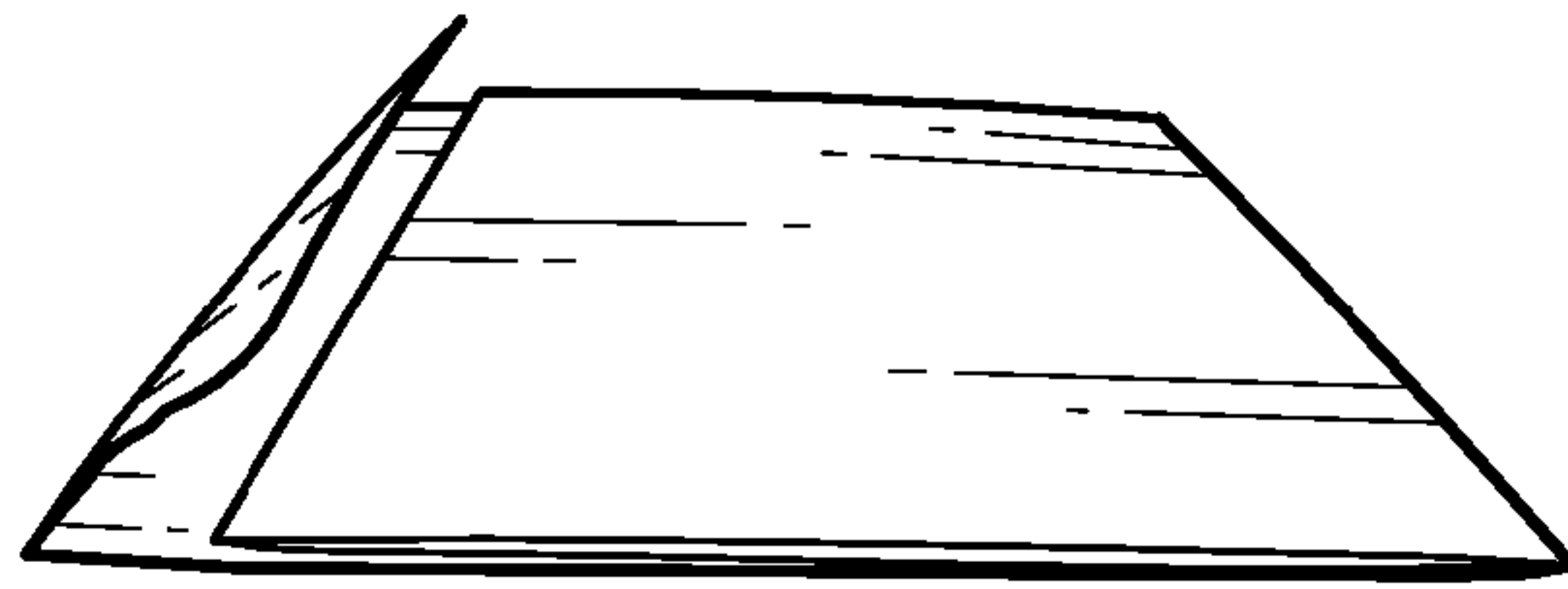

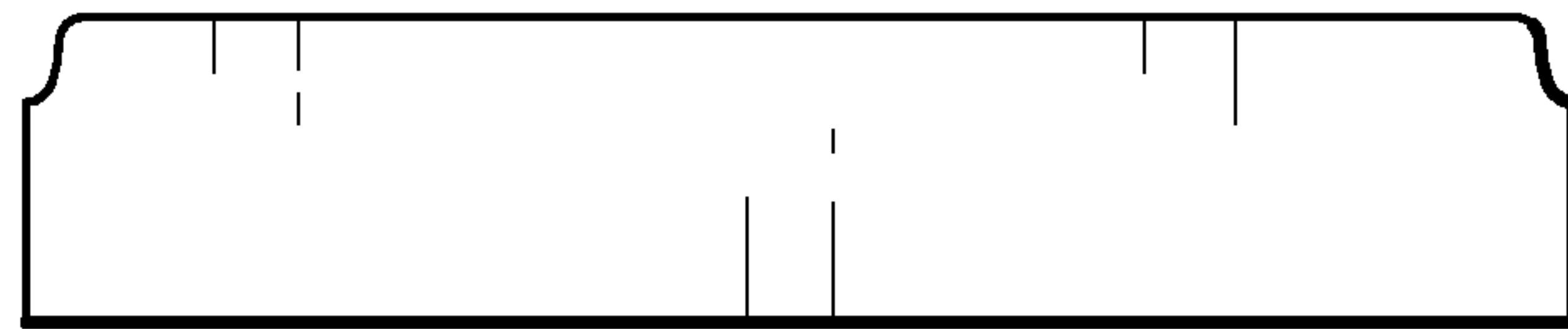

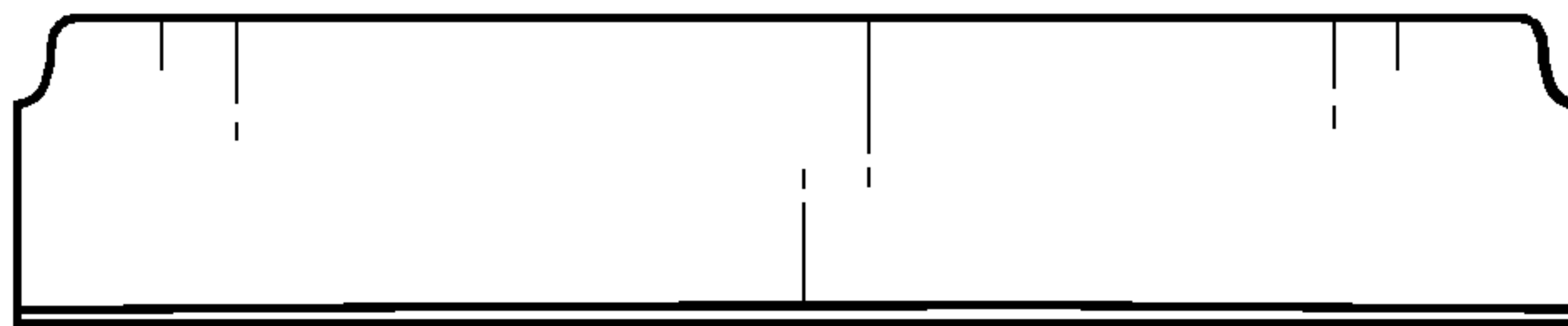

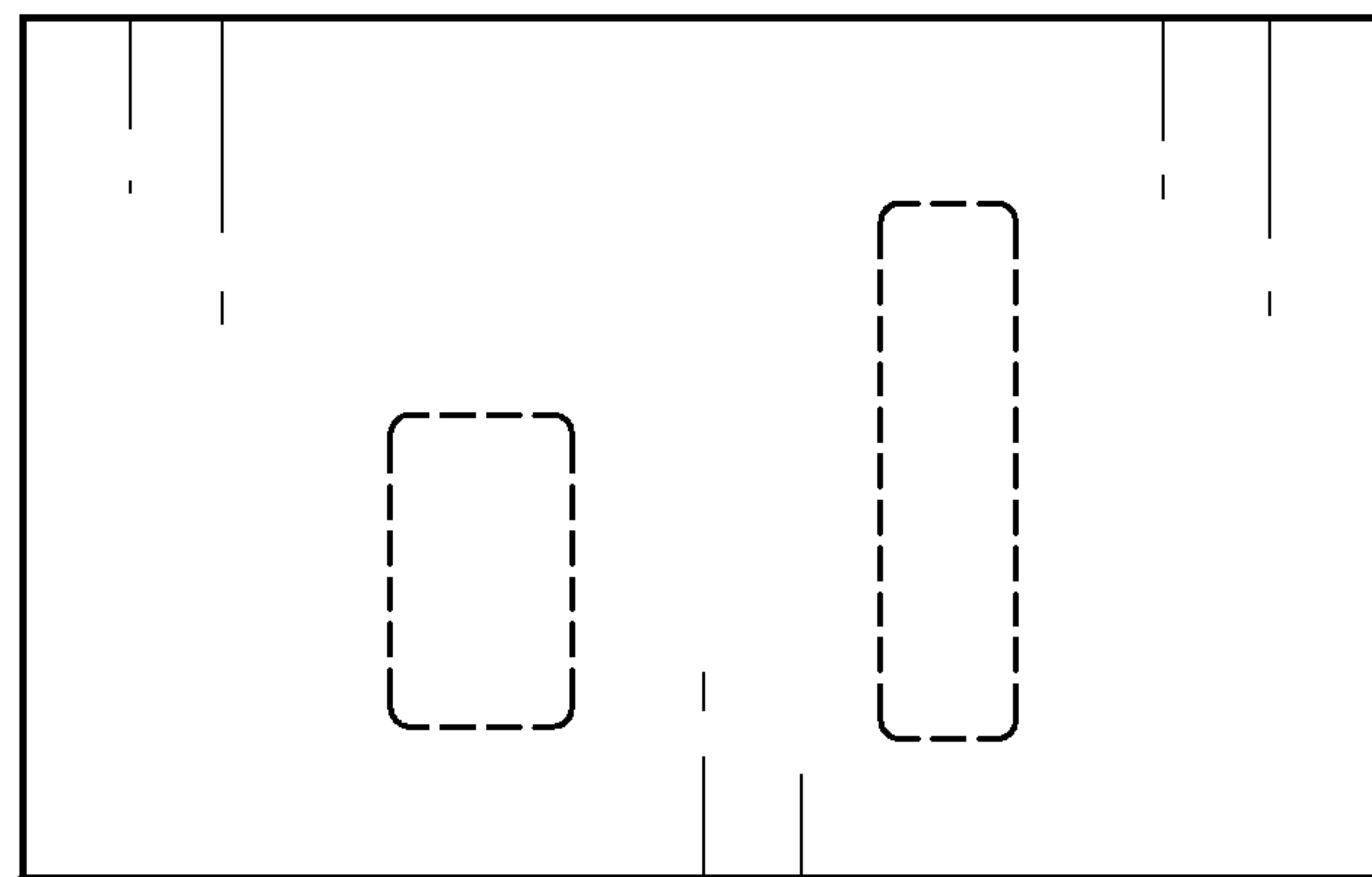

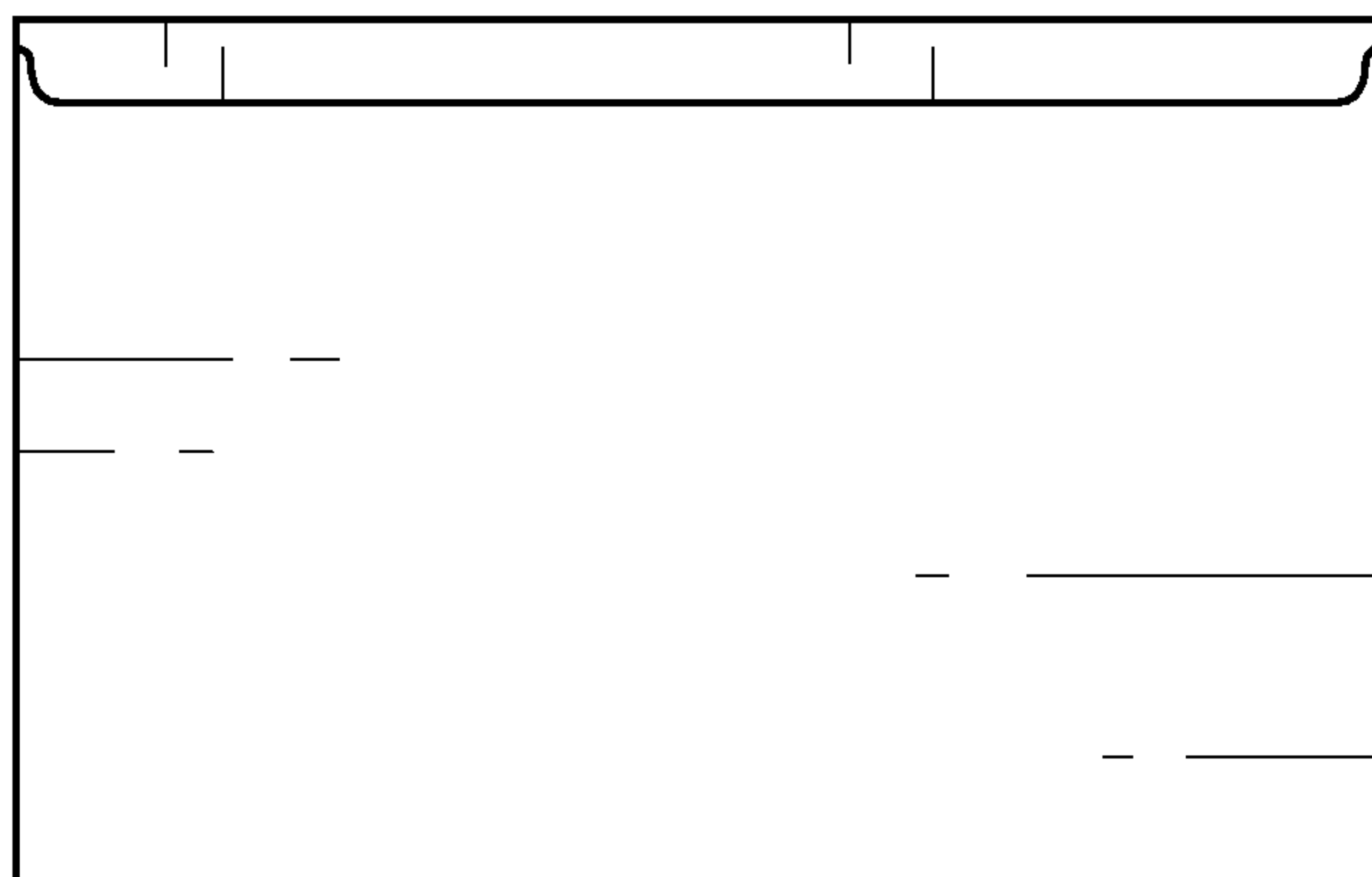

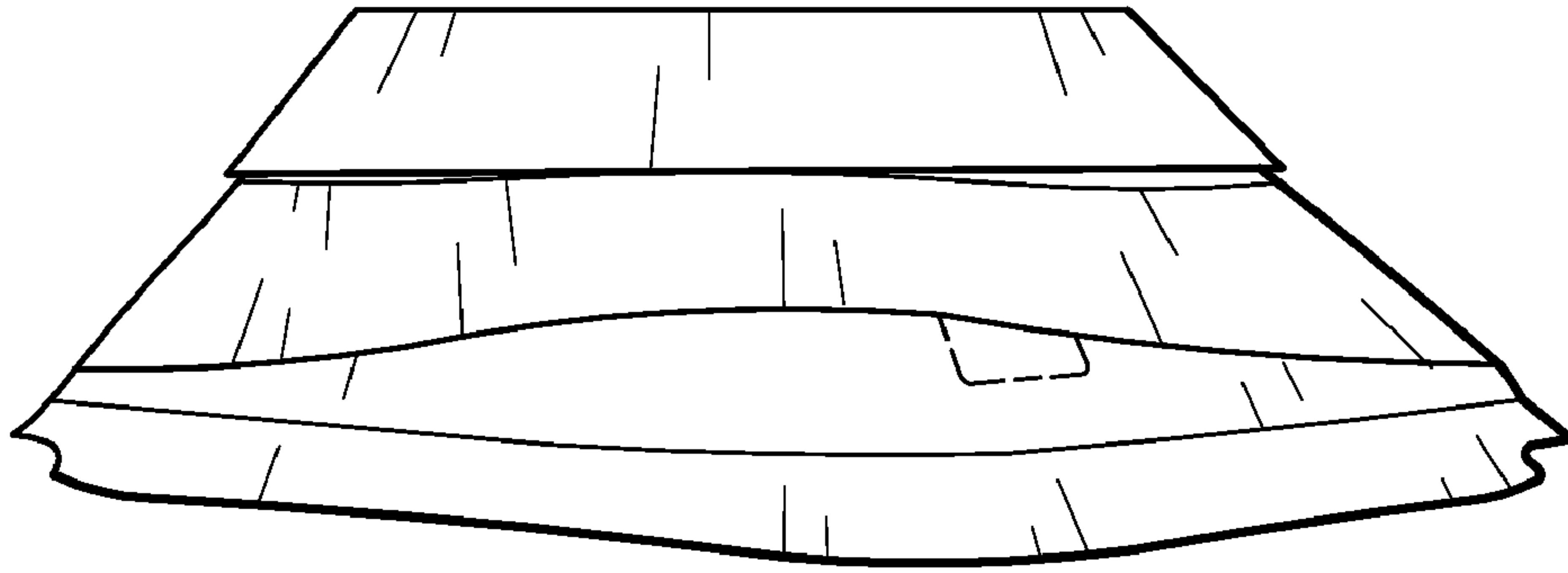

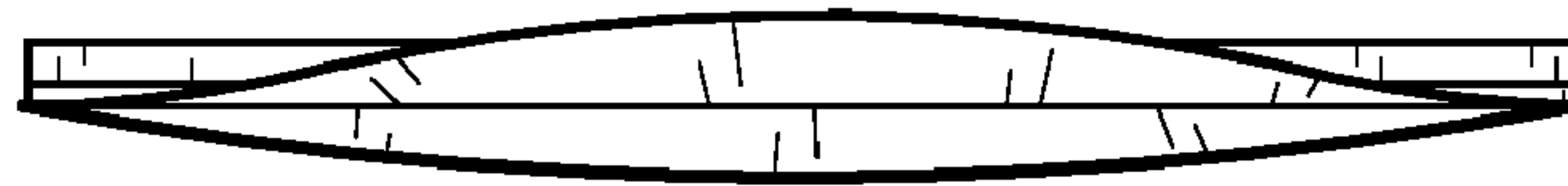

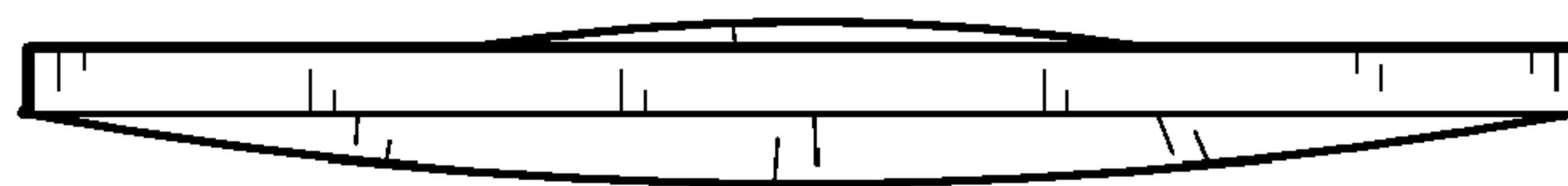

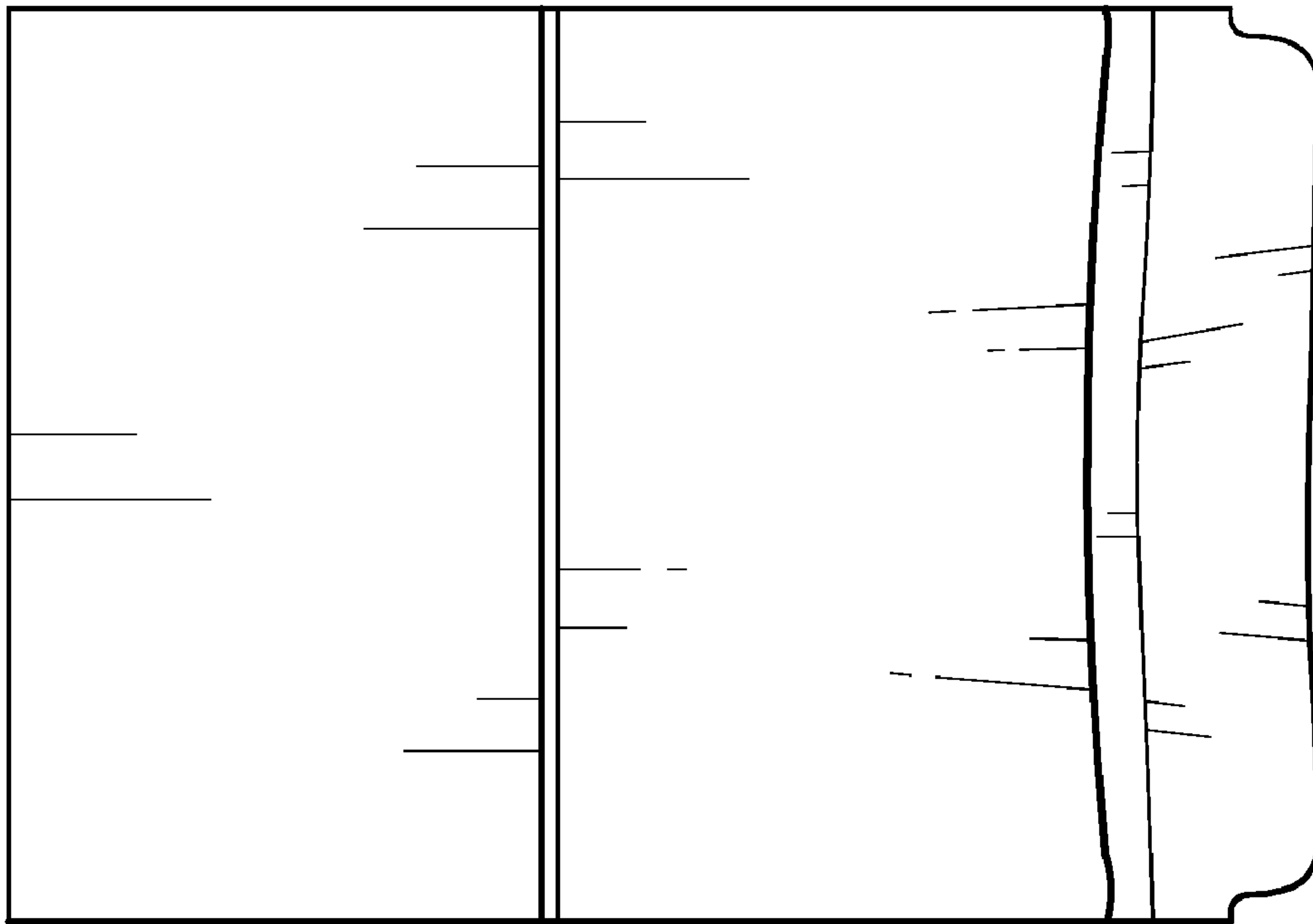

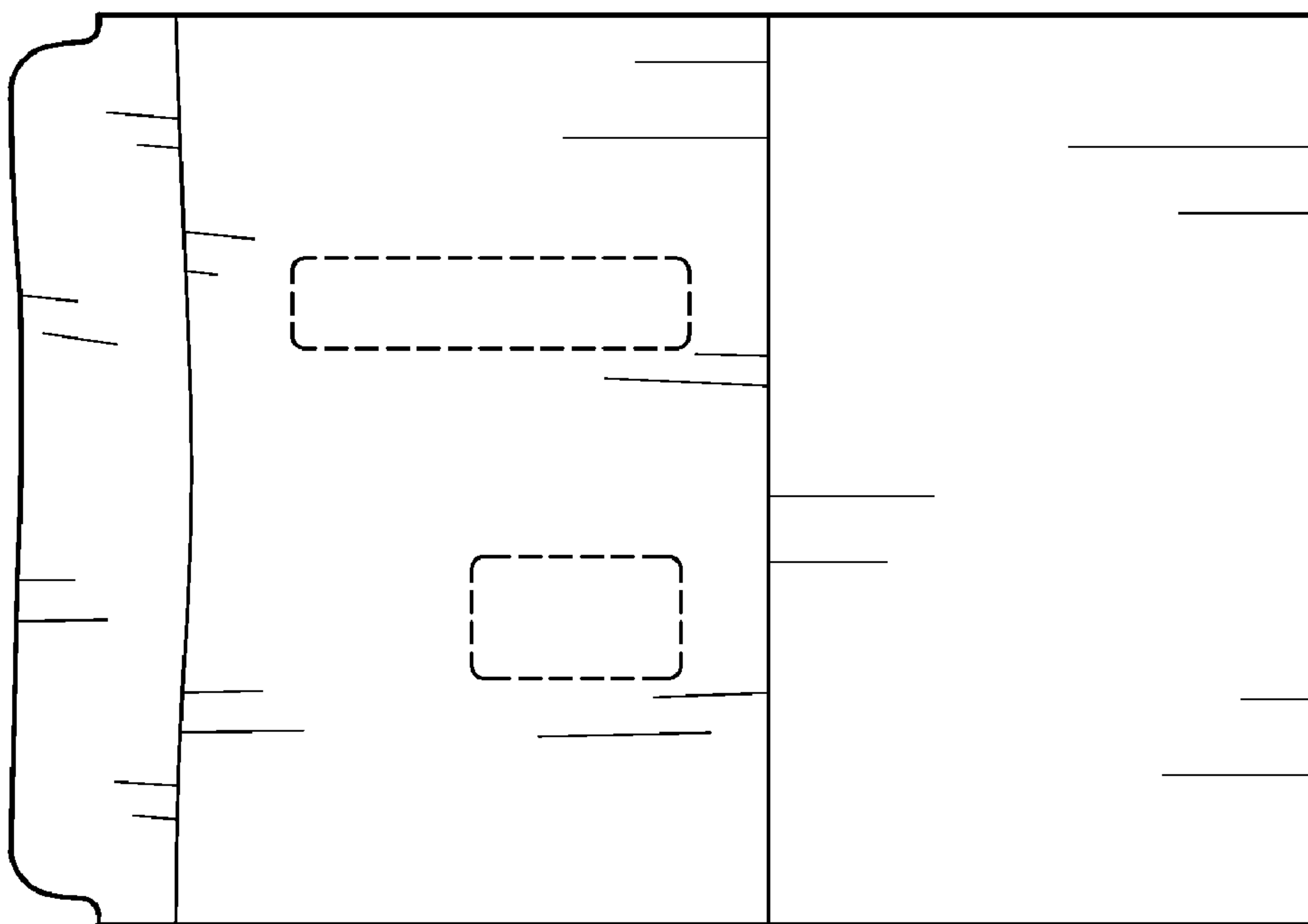
