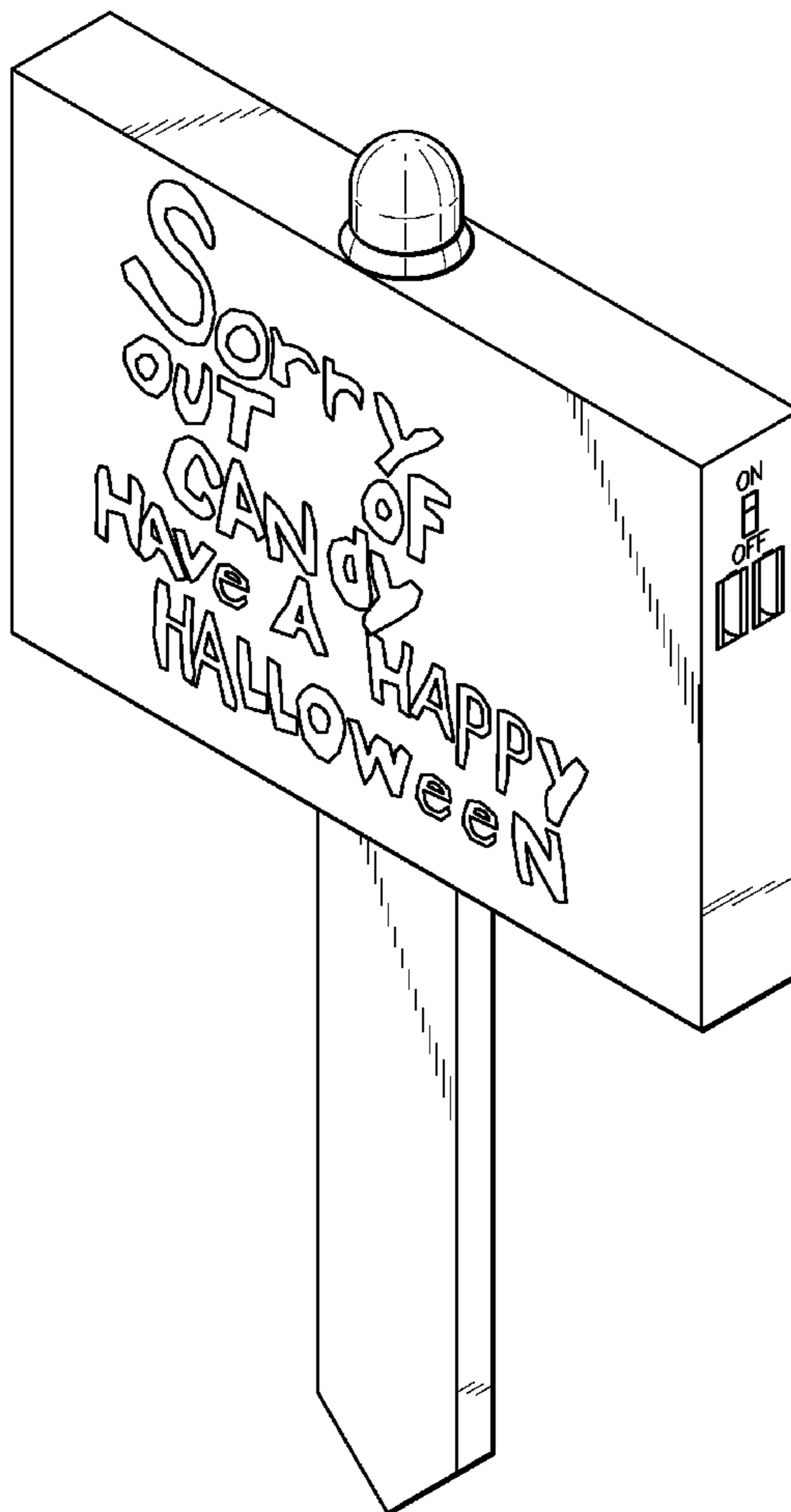
(57) **CLAIM**

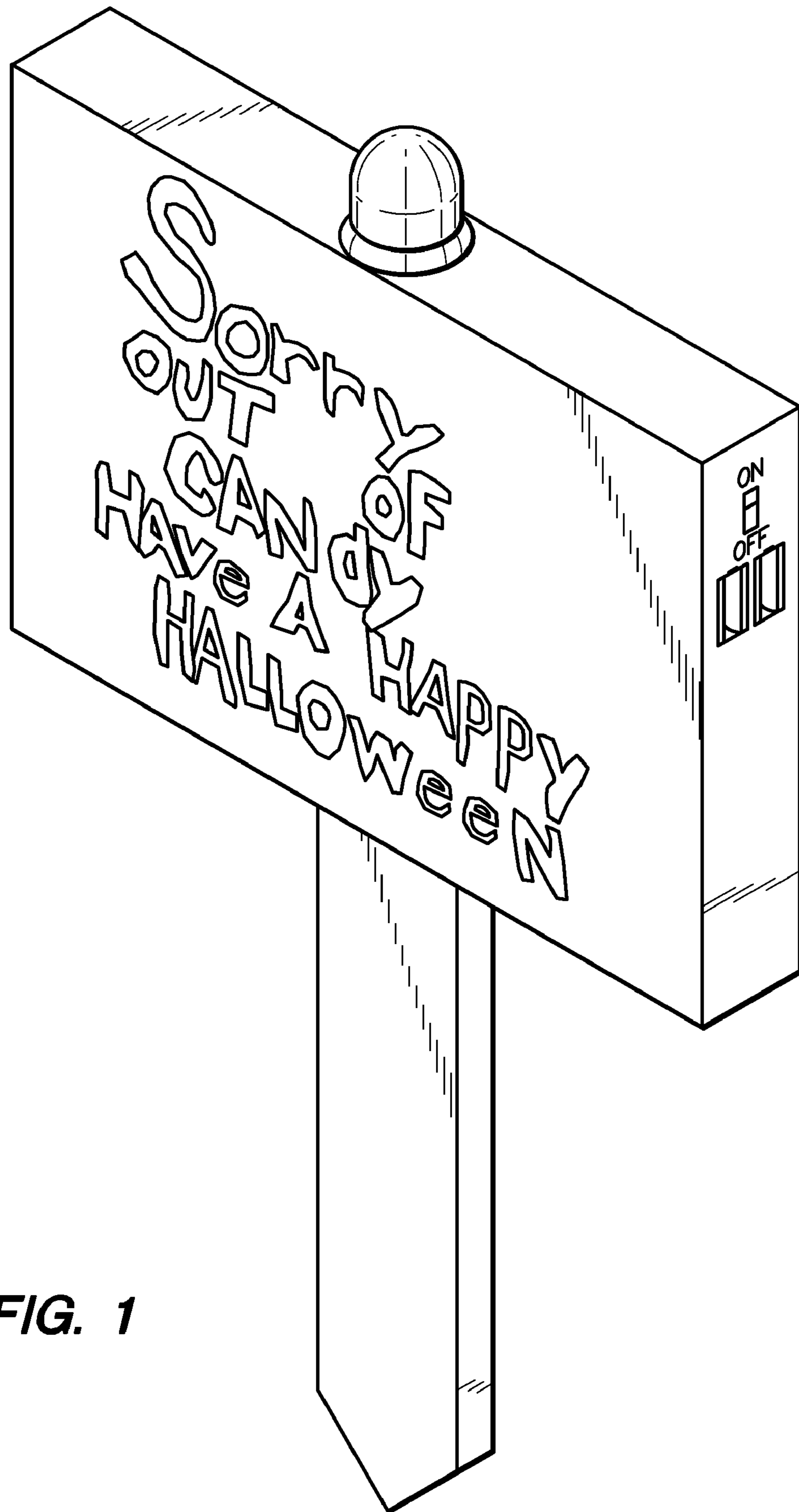
I claim the ornamental design for a Halloween candy sign, as shown and described.

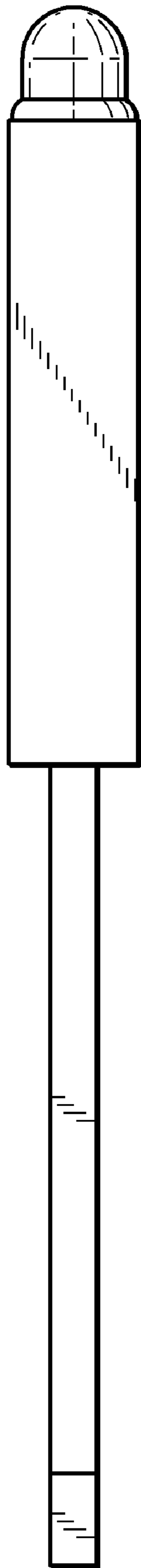

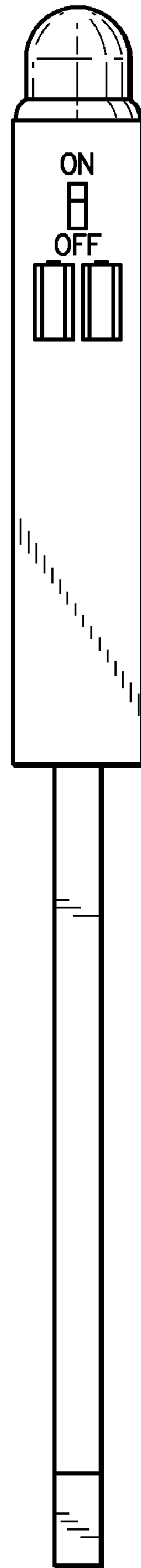

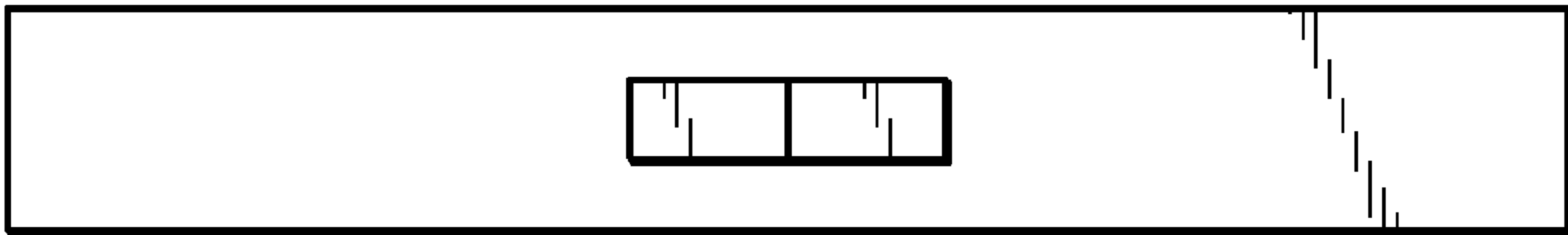
