The ornamental design for “an electronic device for a table game,” as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my new electronic device for a table game design;

FIG. 2 is a front elevation view thereof;

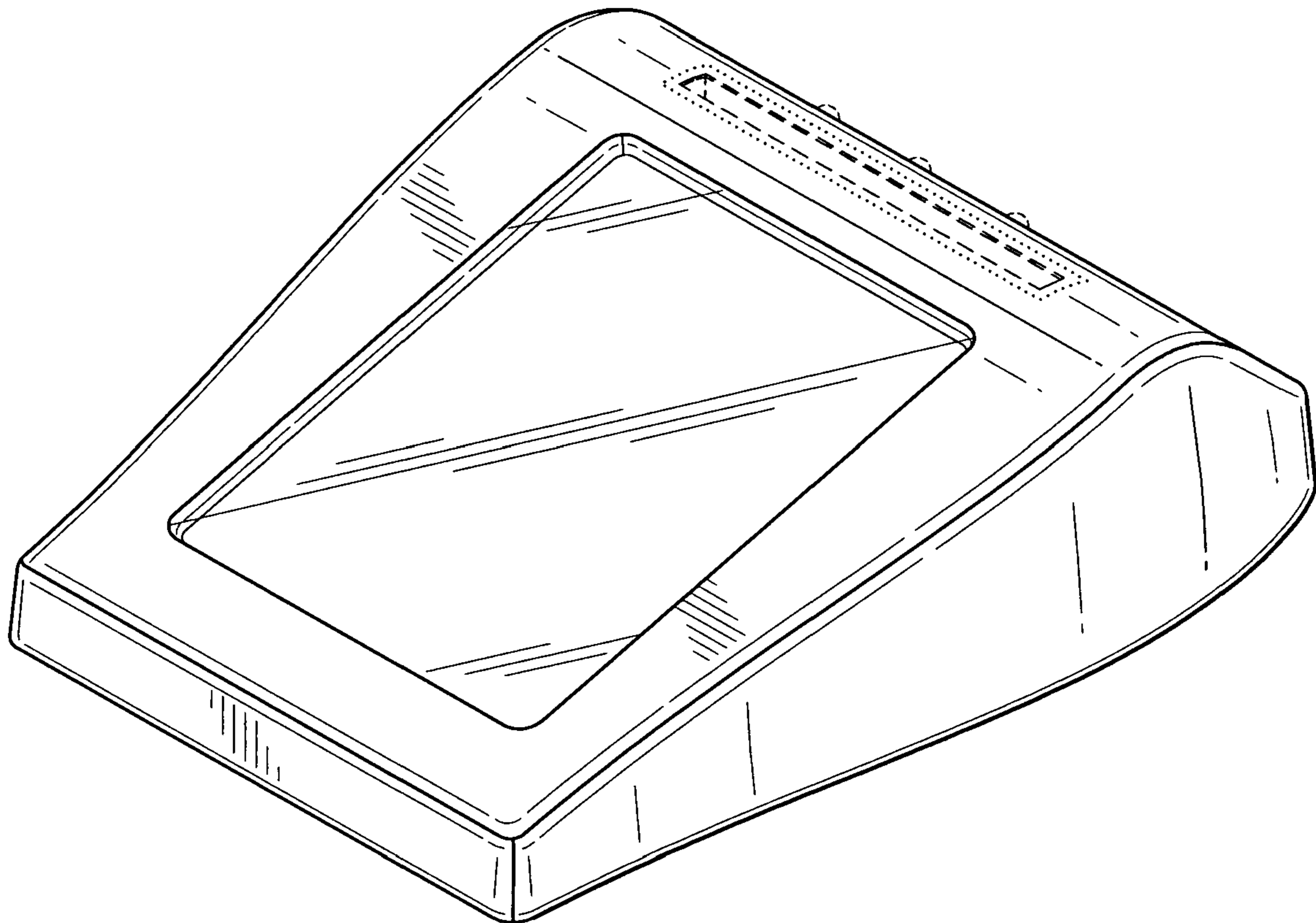
FIG. 3 is a back elevation view thereof;

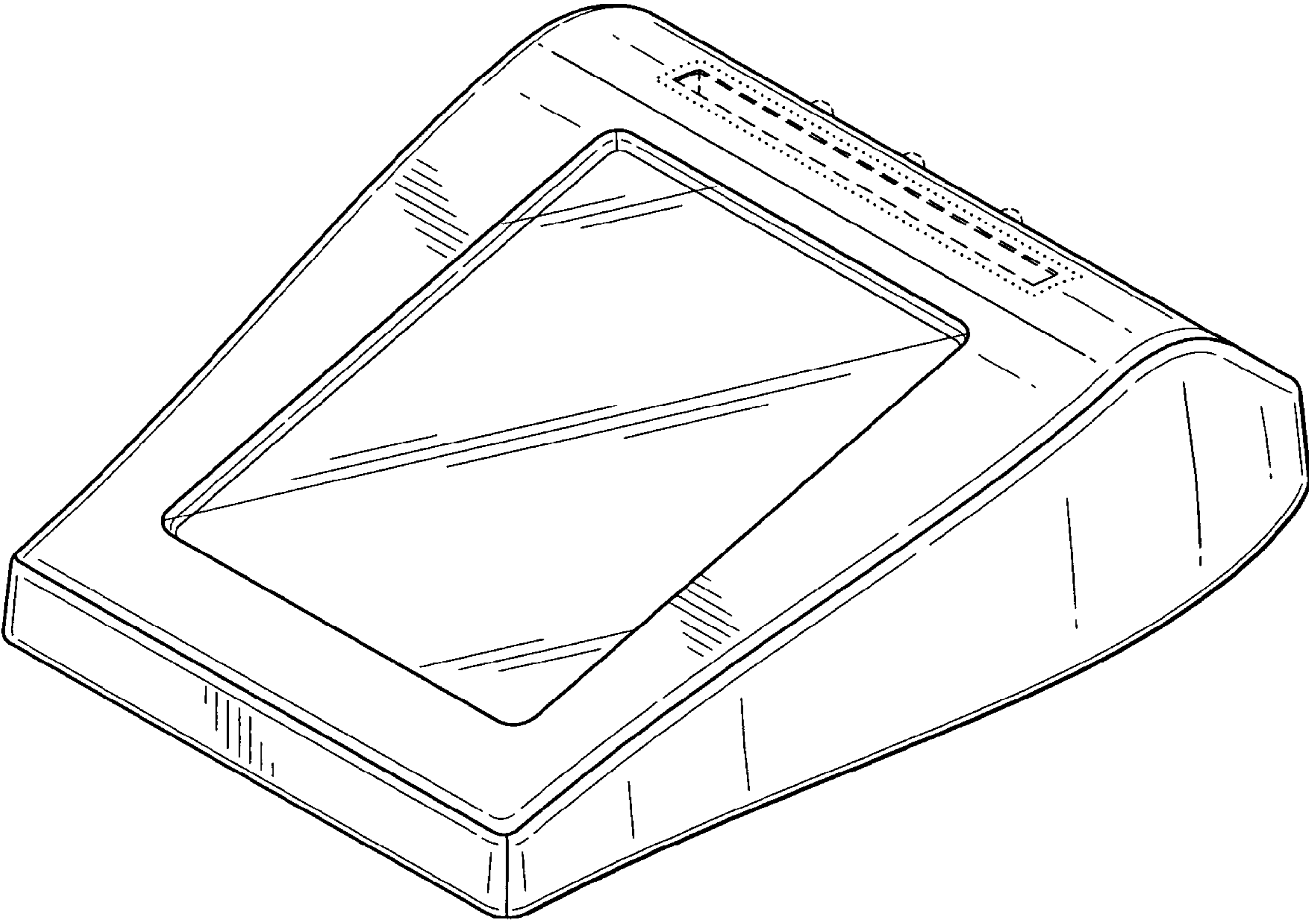

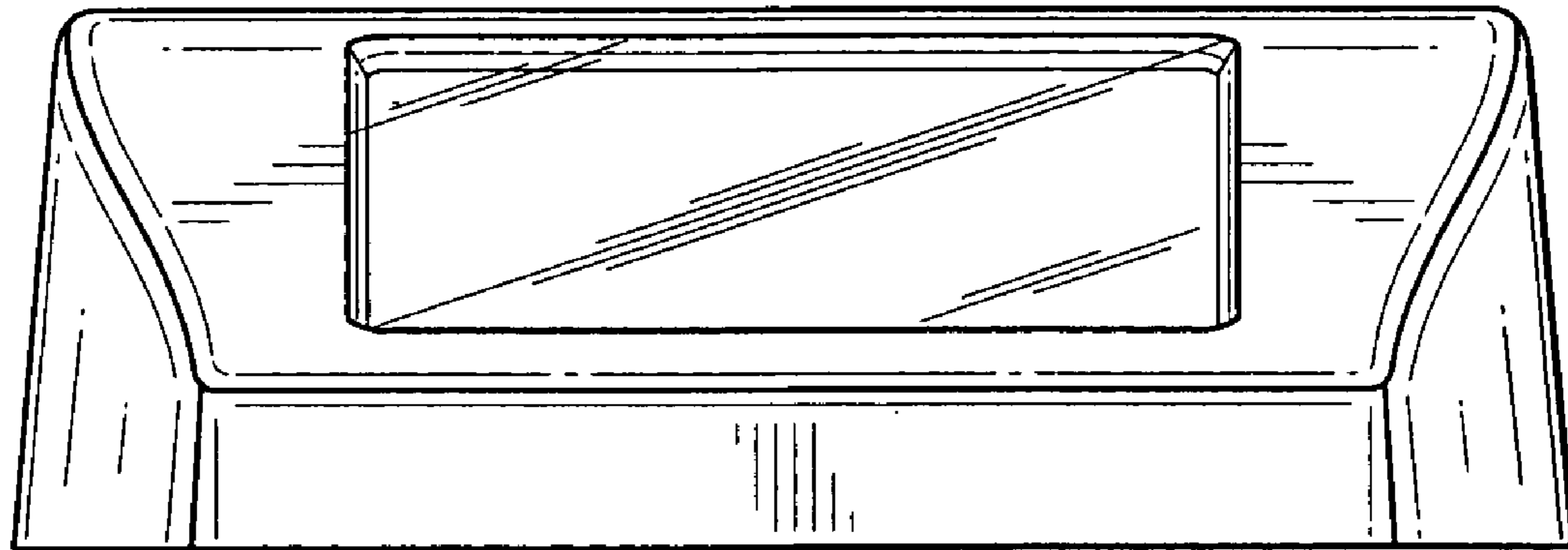

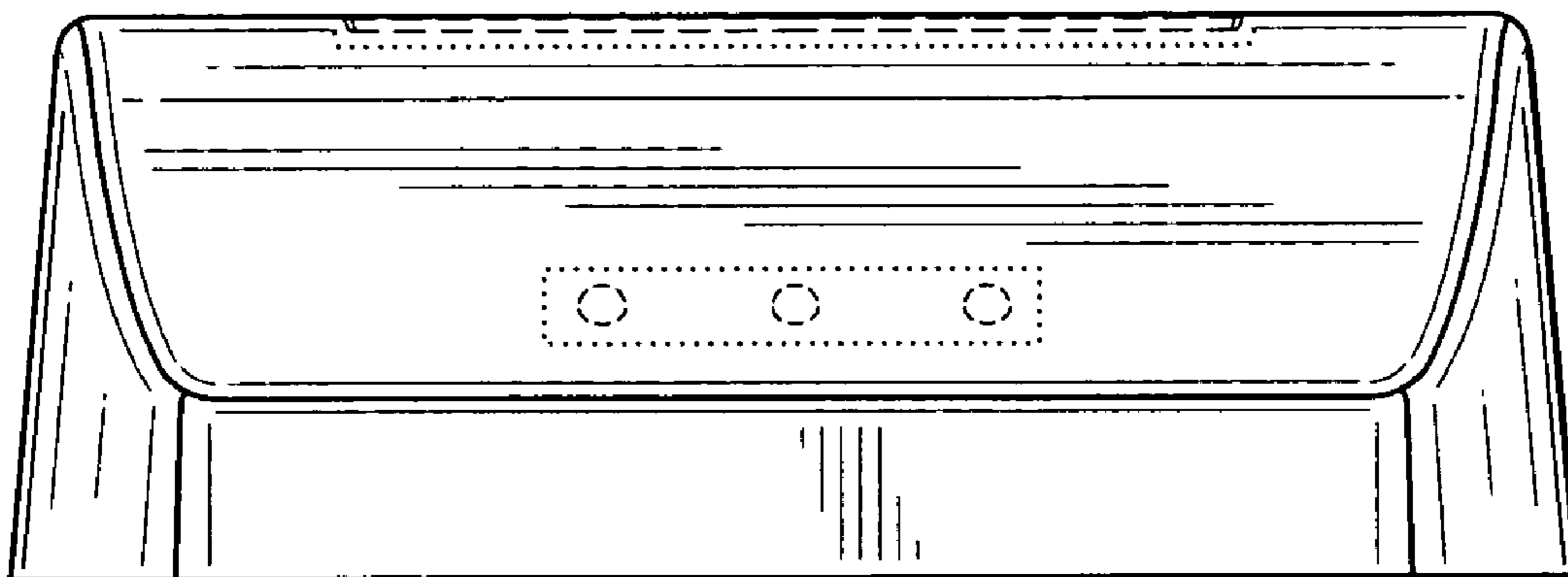

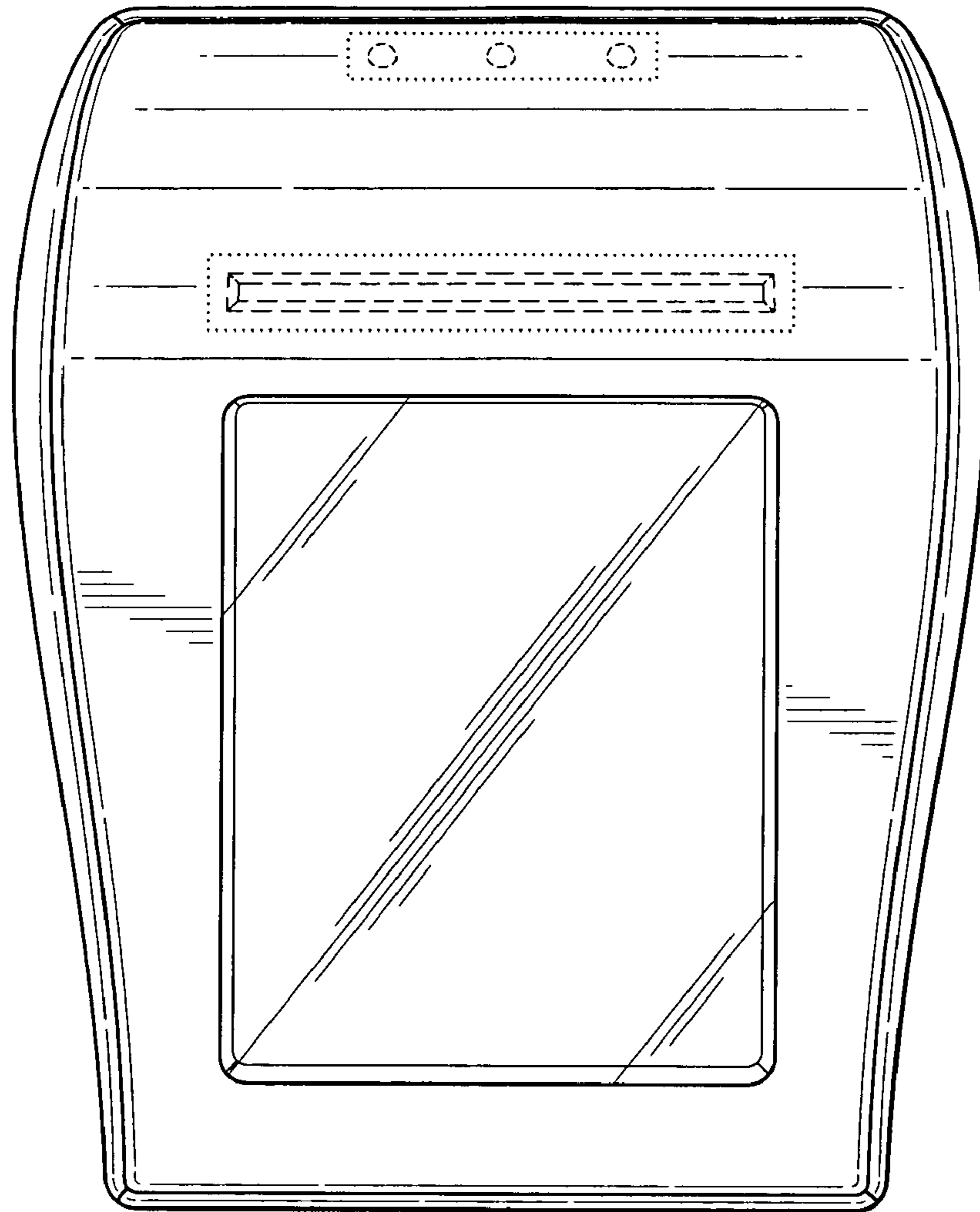

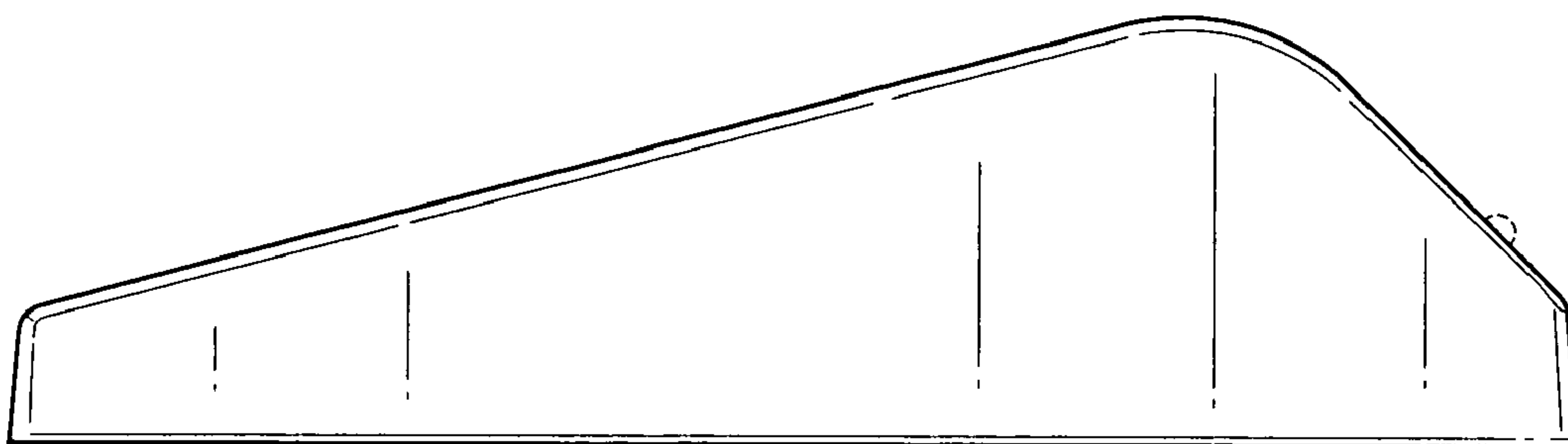
