The ornamental design for a chess set, as shown and described.

DESCRIPTION

FIG. 1 is a reduced front view of the chess set, showing my new design;

FIG. 10 is a rear view thereof;

FIG. 13 is a top view thereof;

FIG. 14 is a front view of the rook piece, shown separately for ease of illustration, the other sides being identical;

FIG. 15 is a top view thereof;

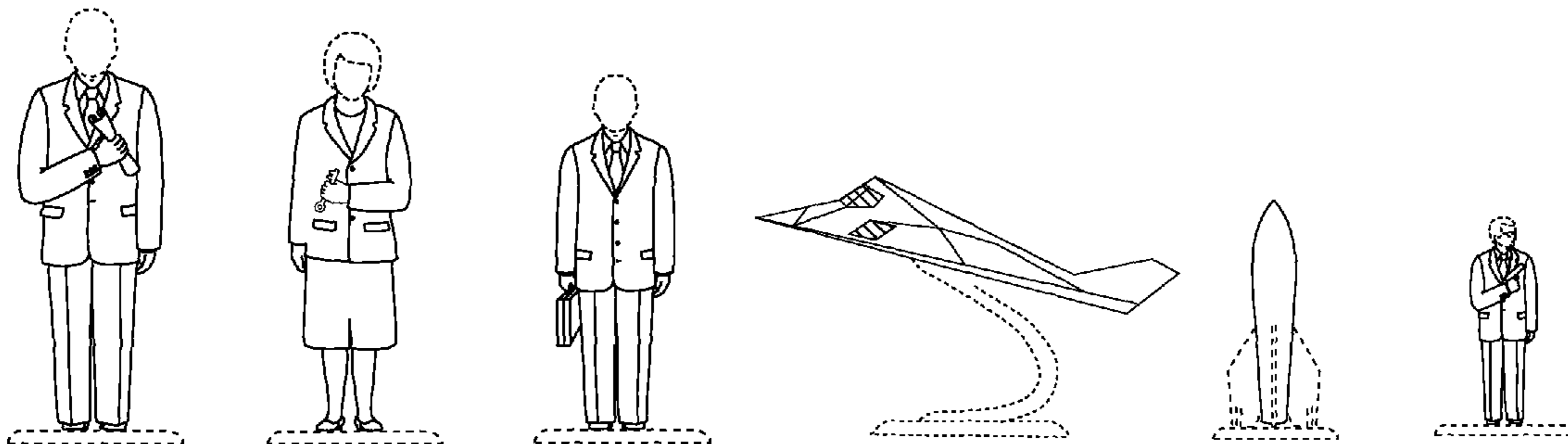
FIG. 16 is a front view of the pawn piece, shown separately for ease of illustration;

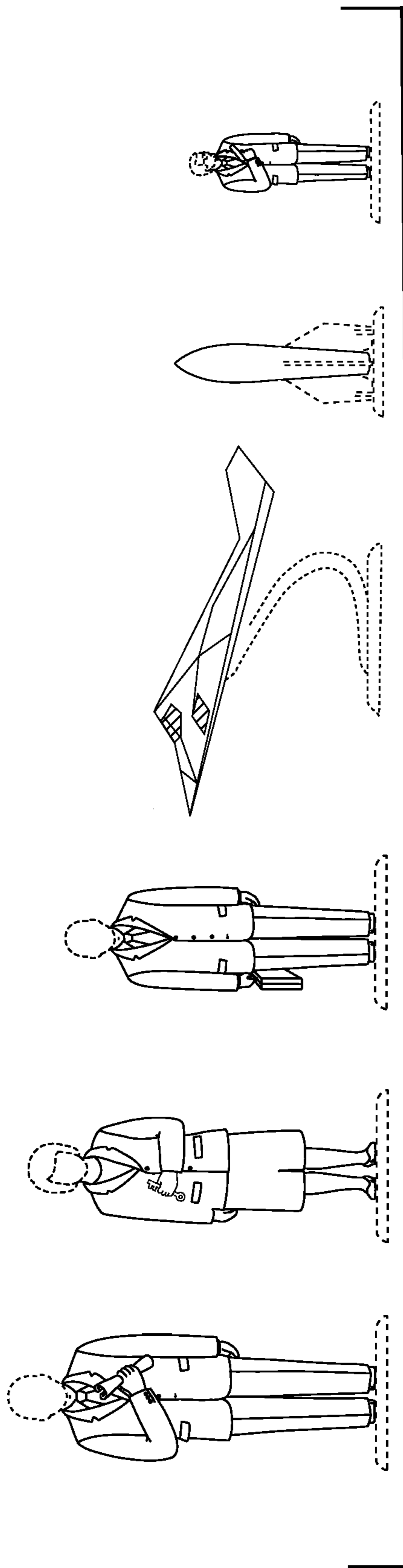

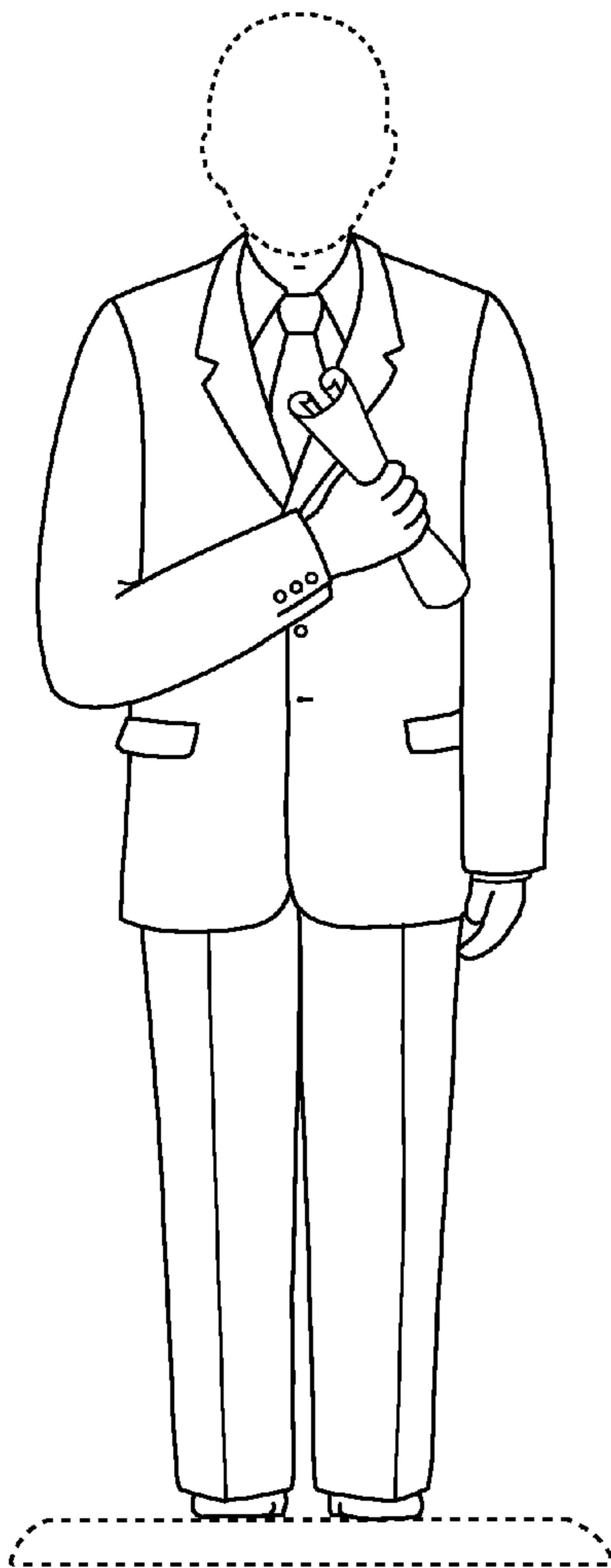

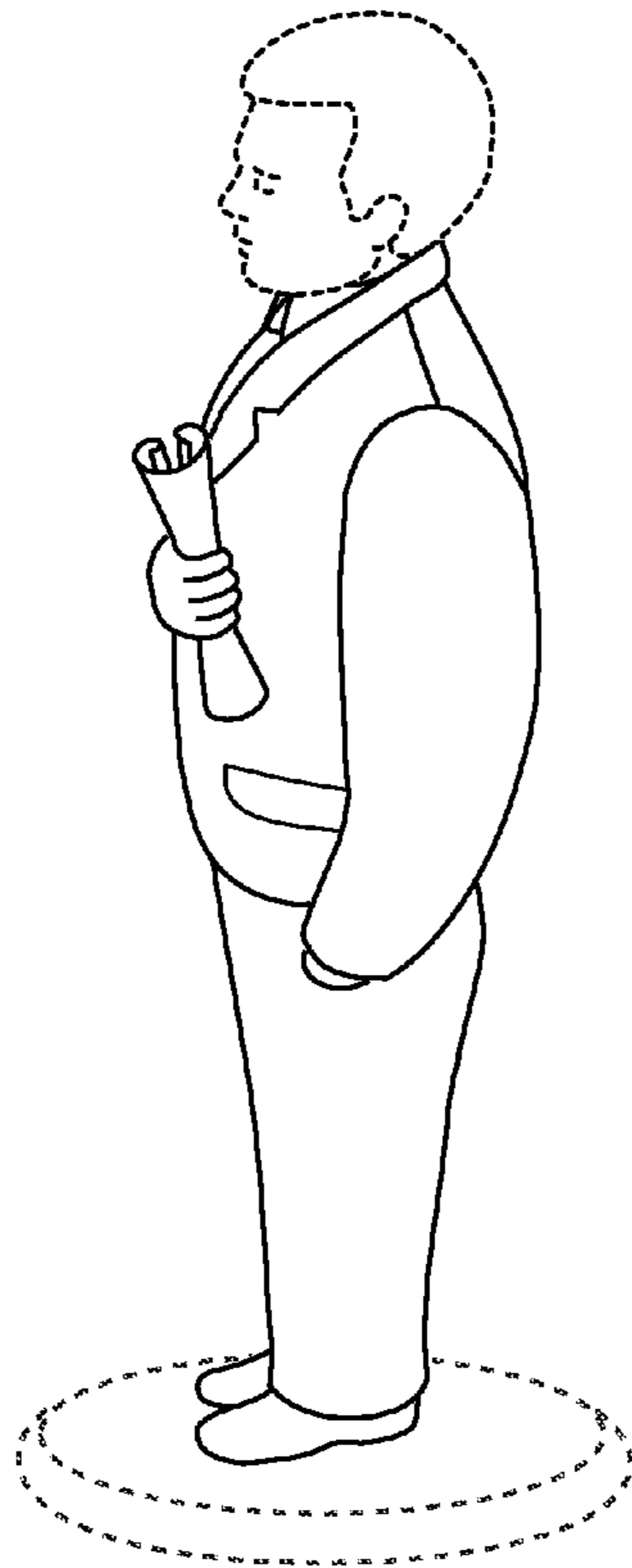

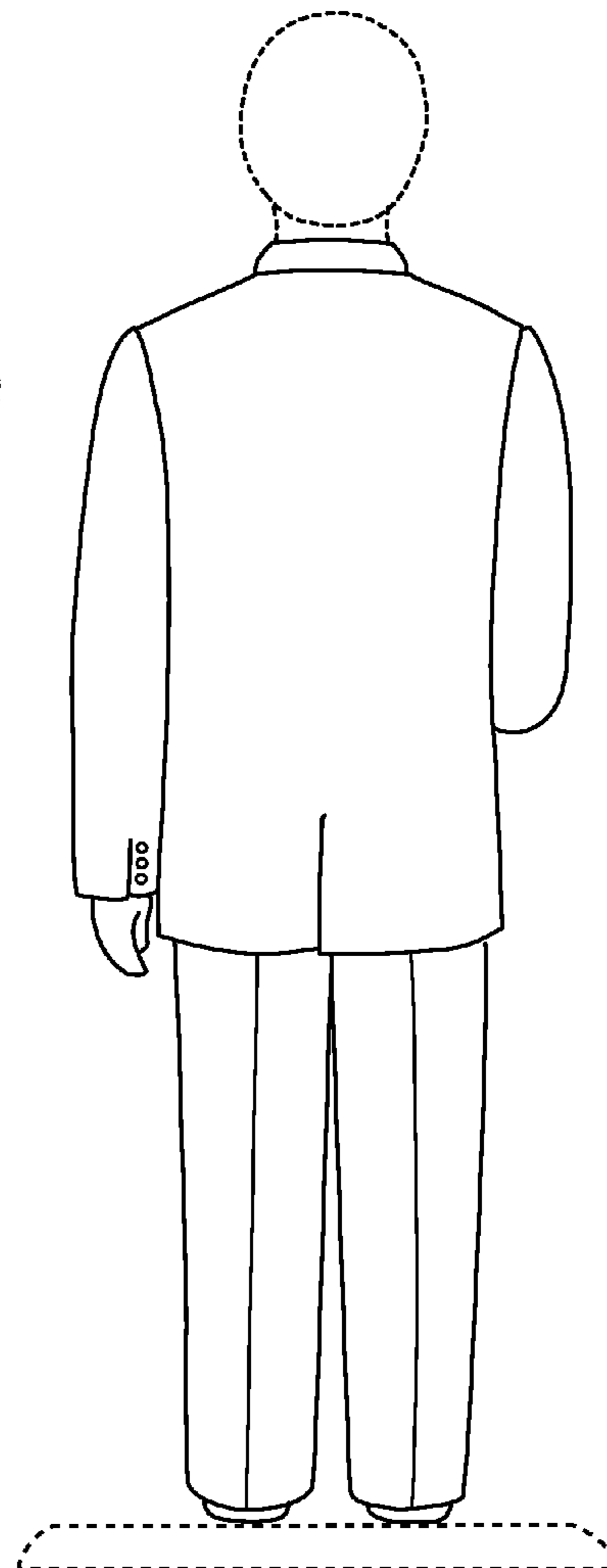

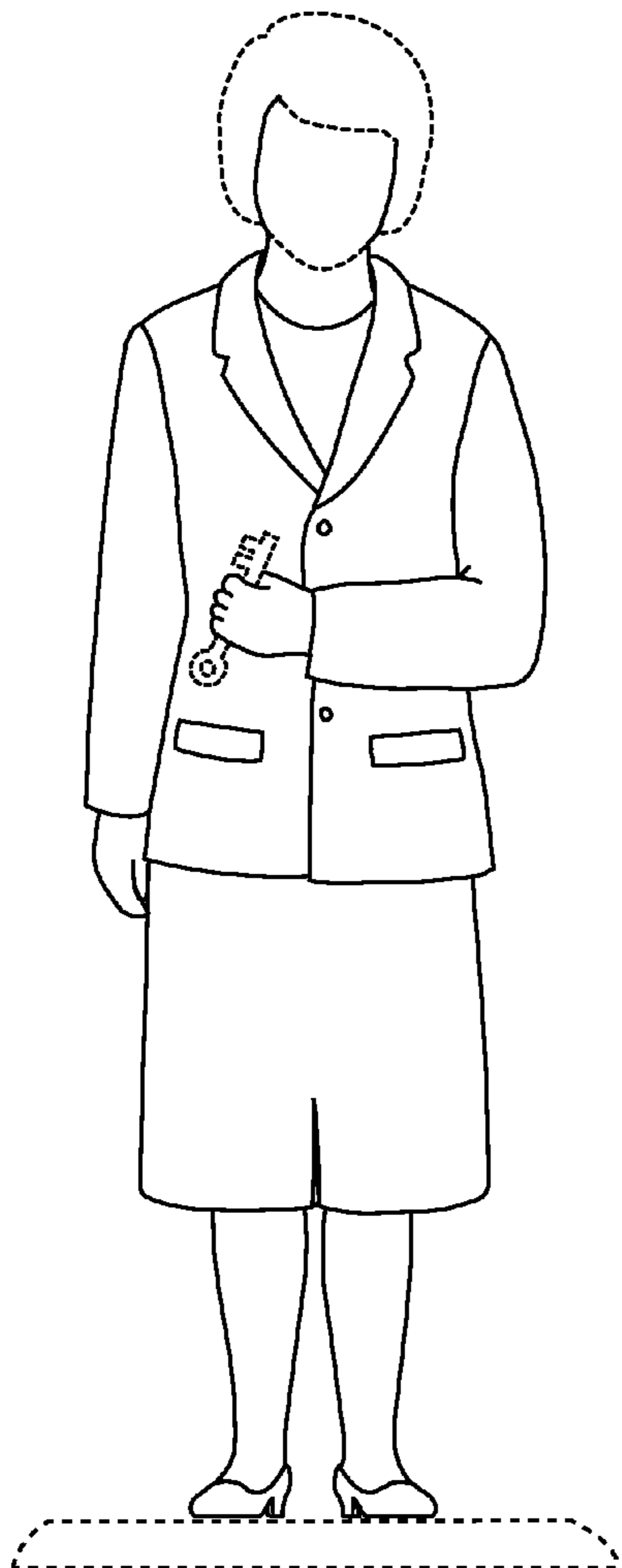

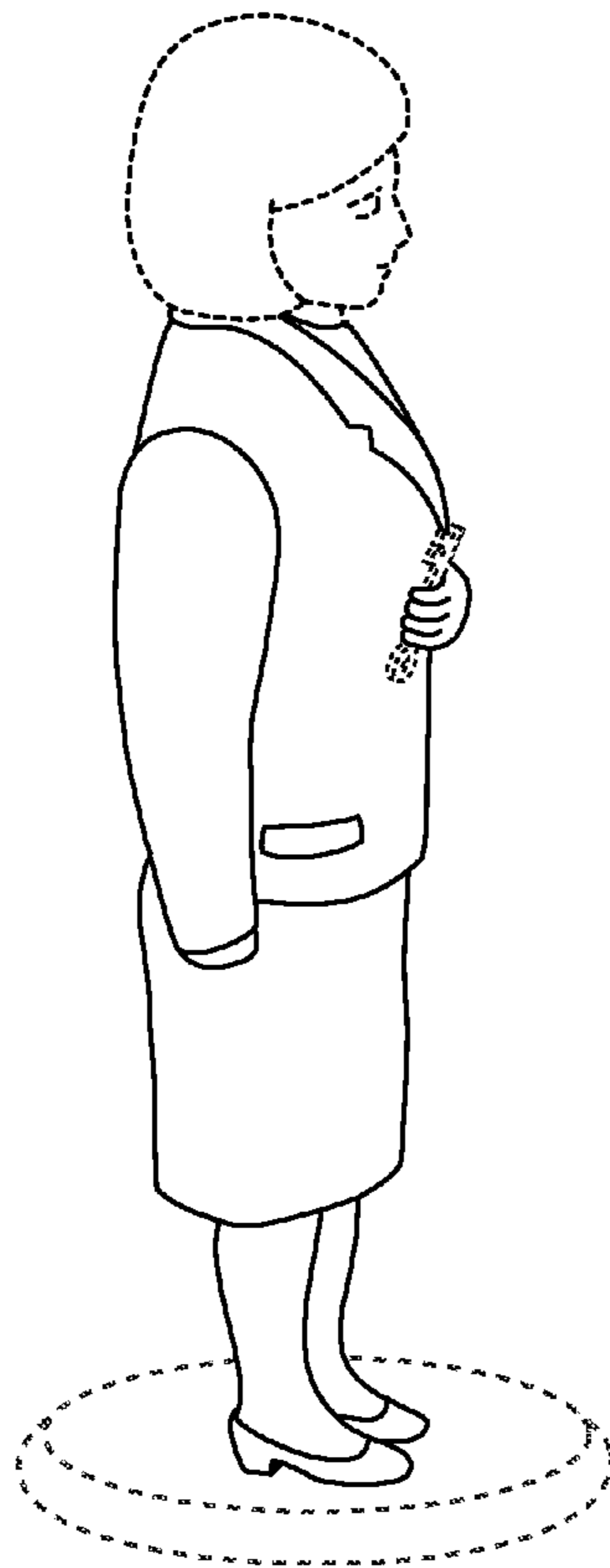

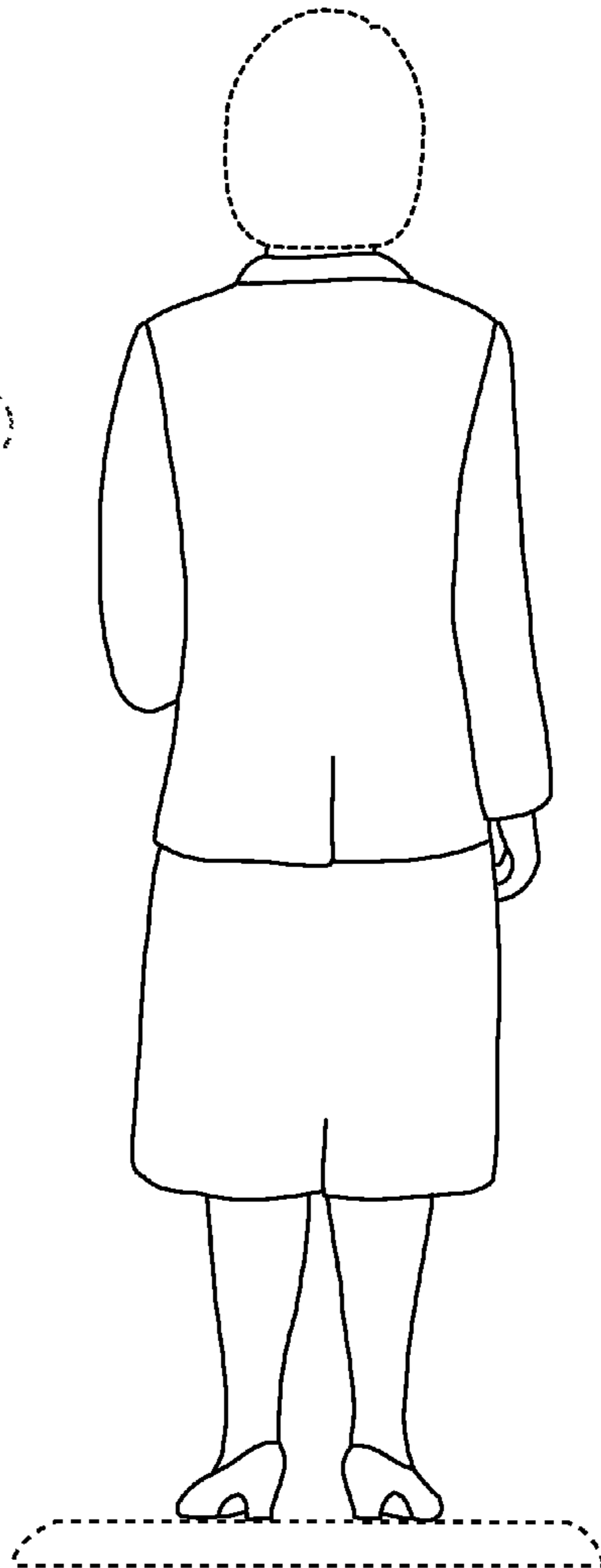

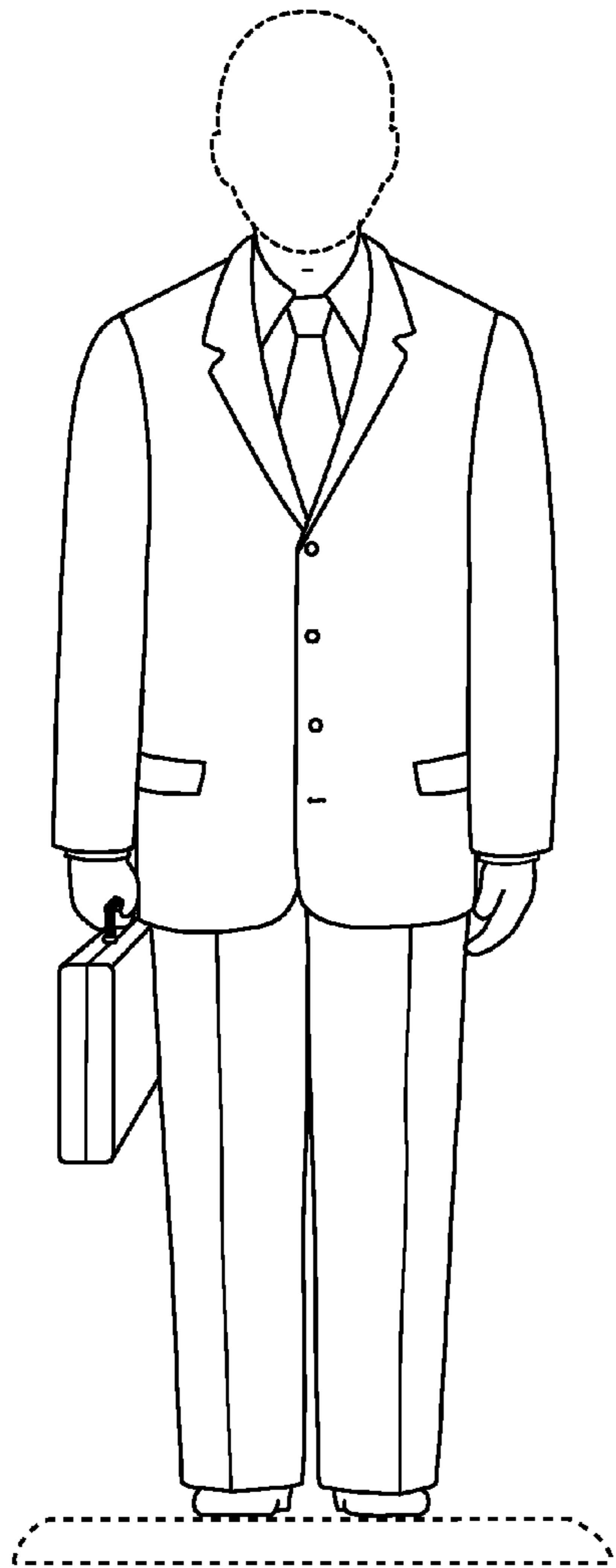

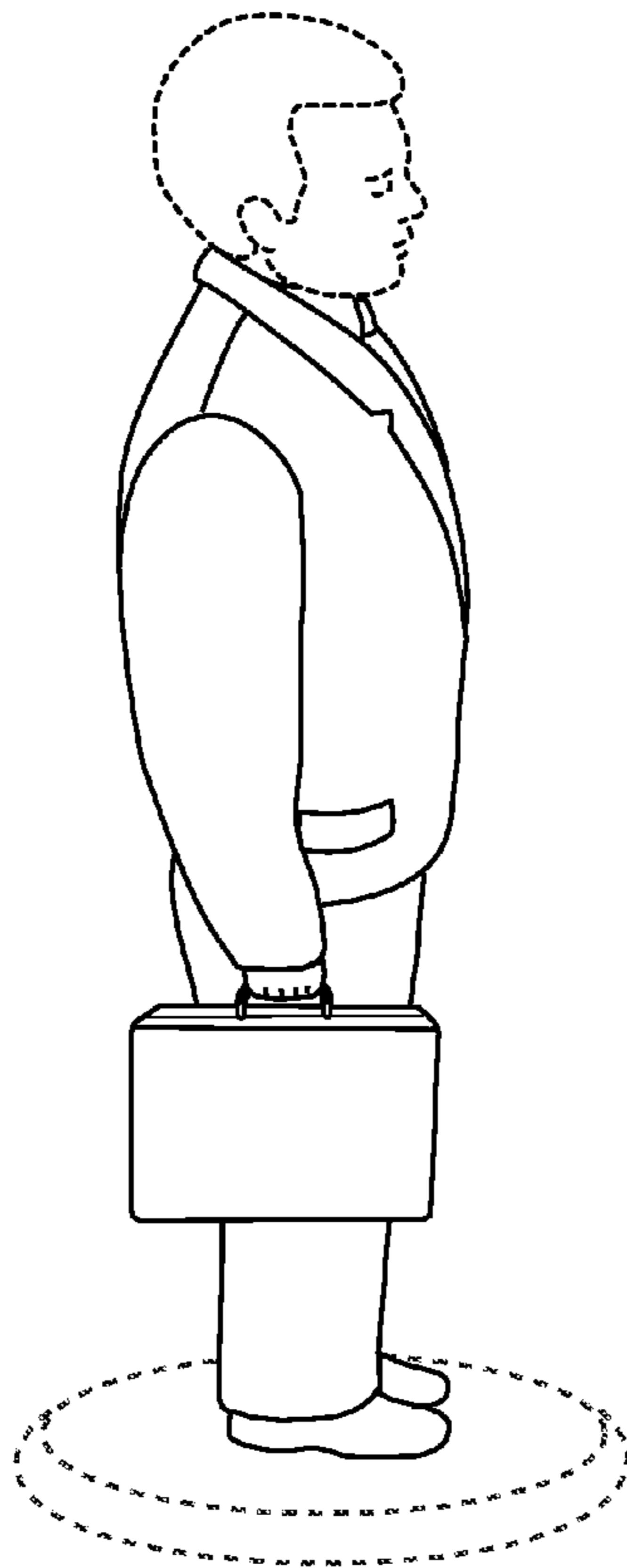

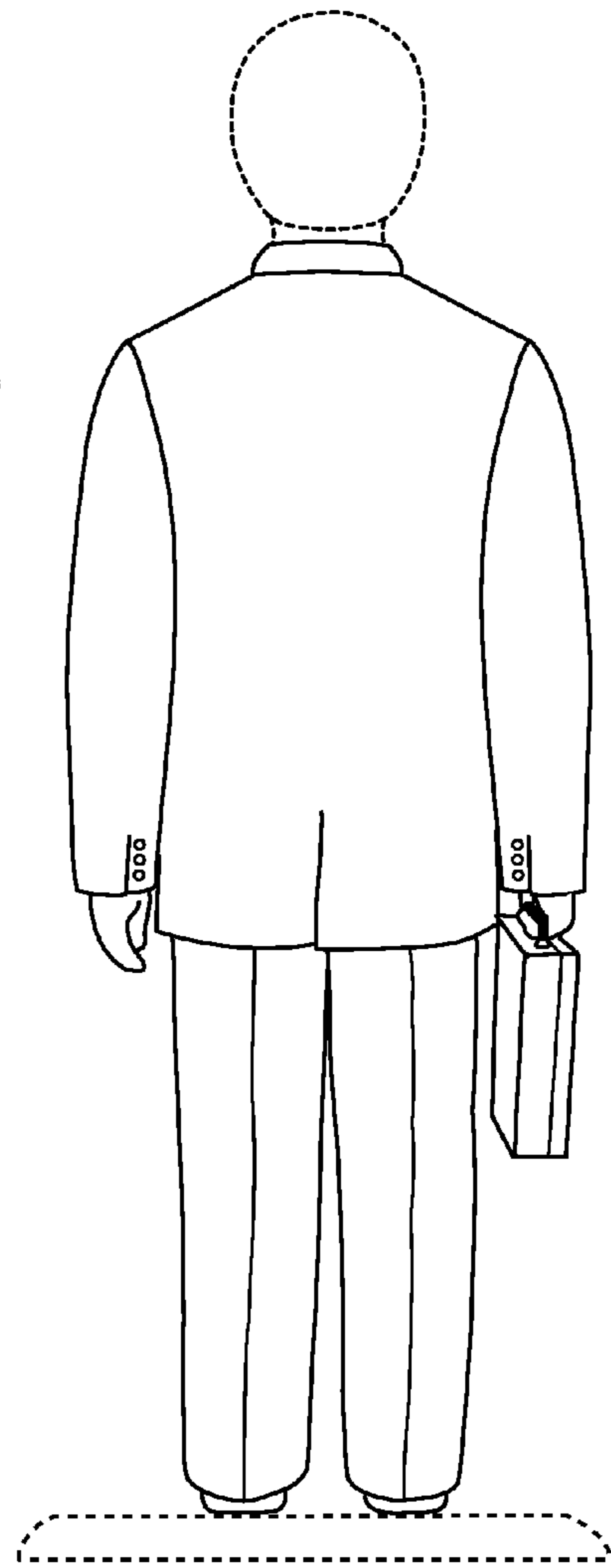

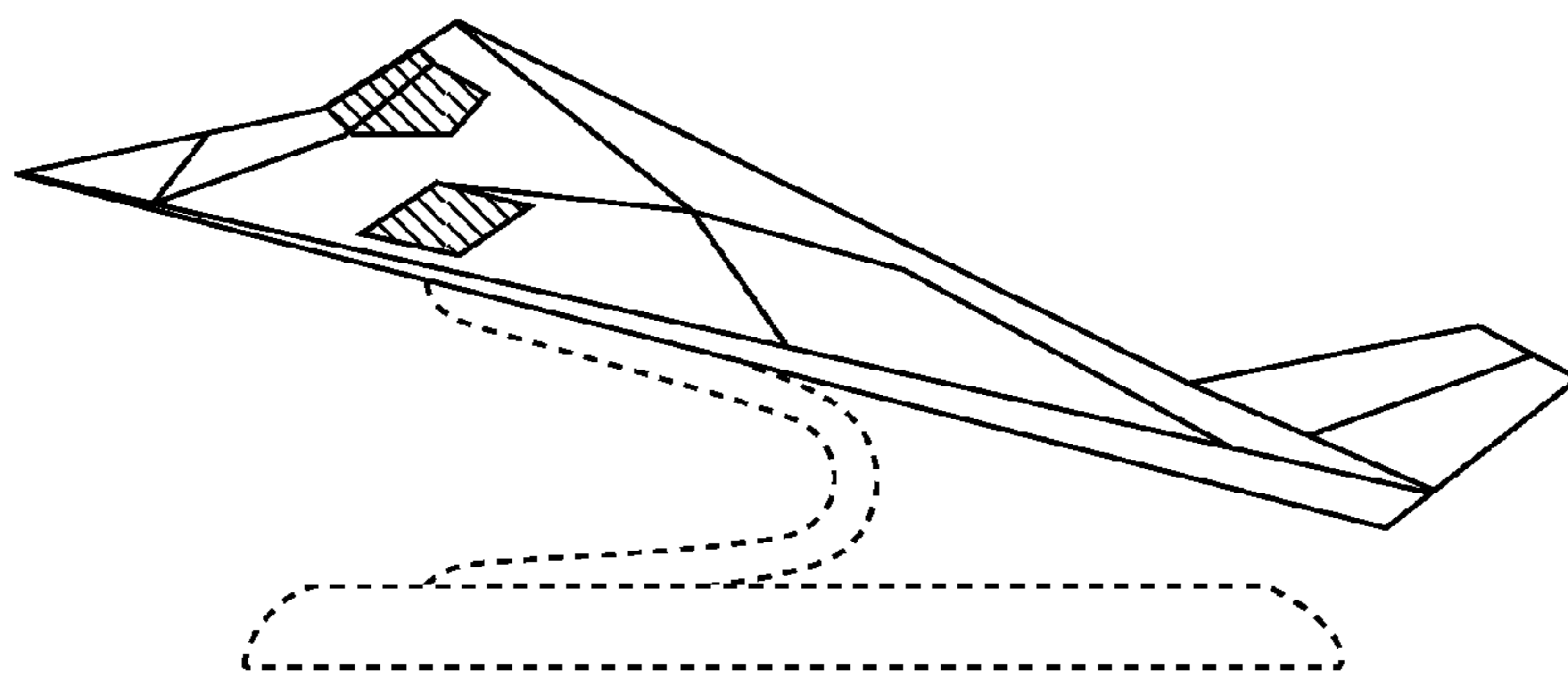

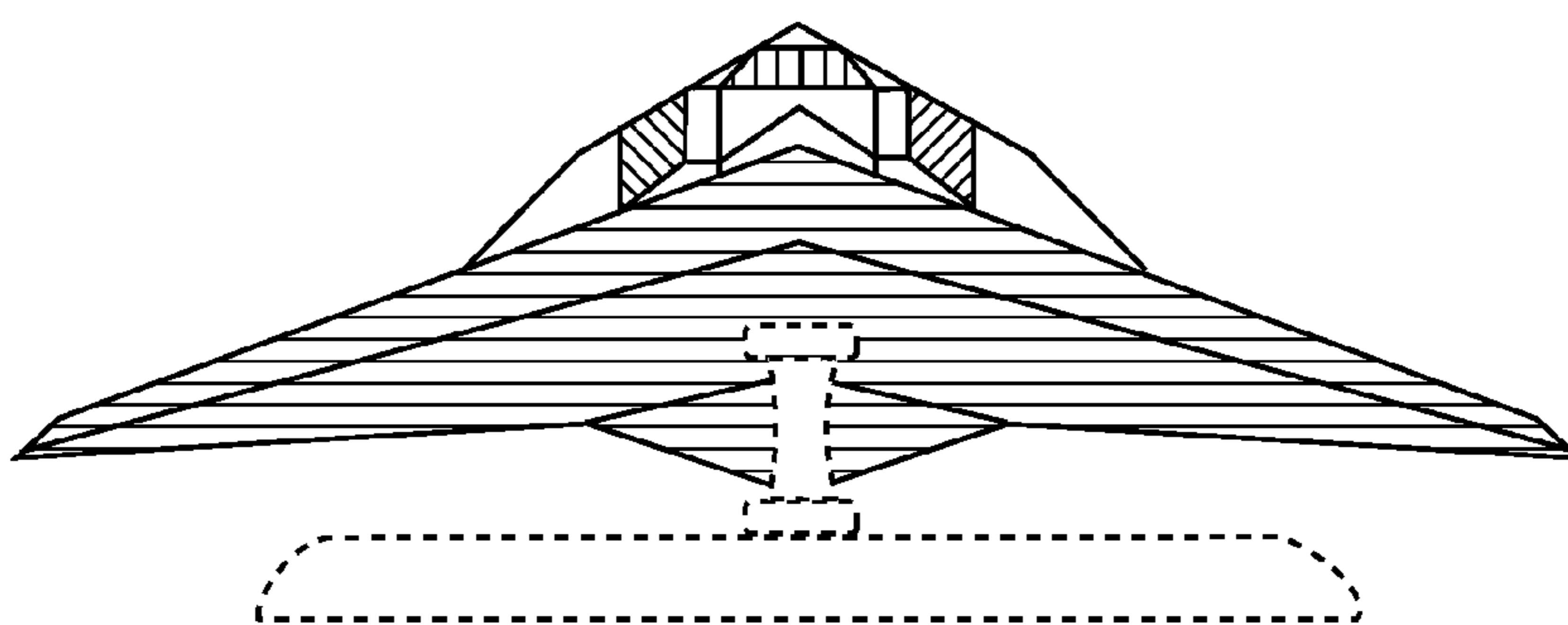

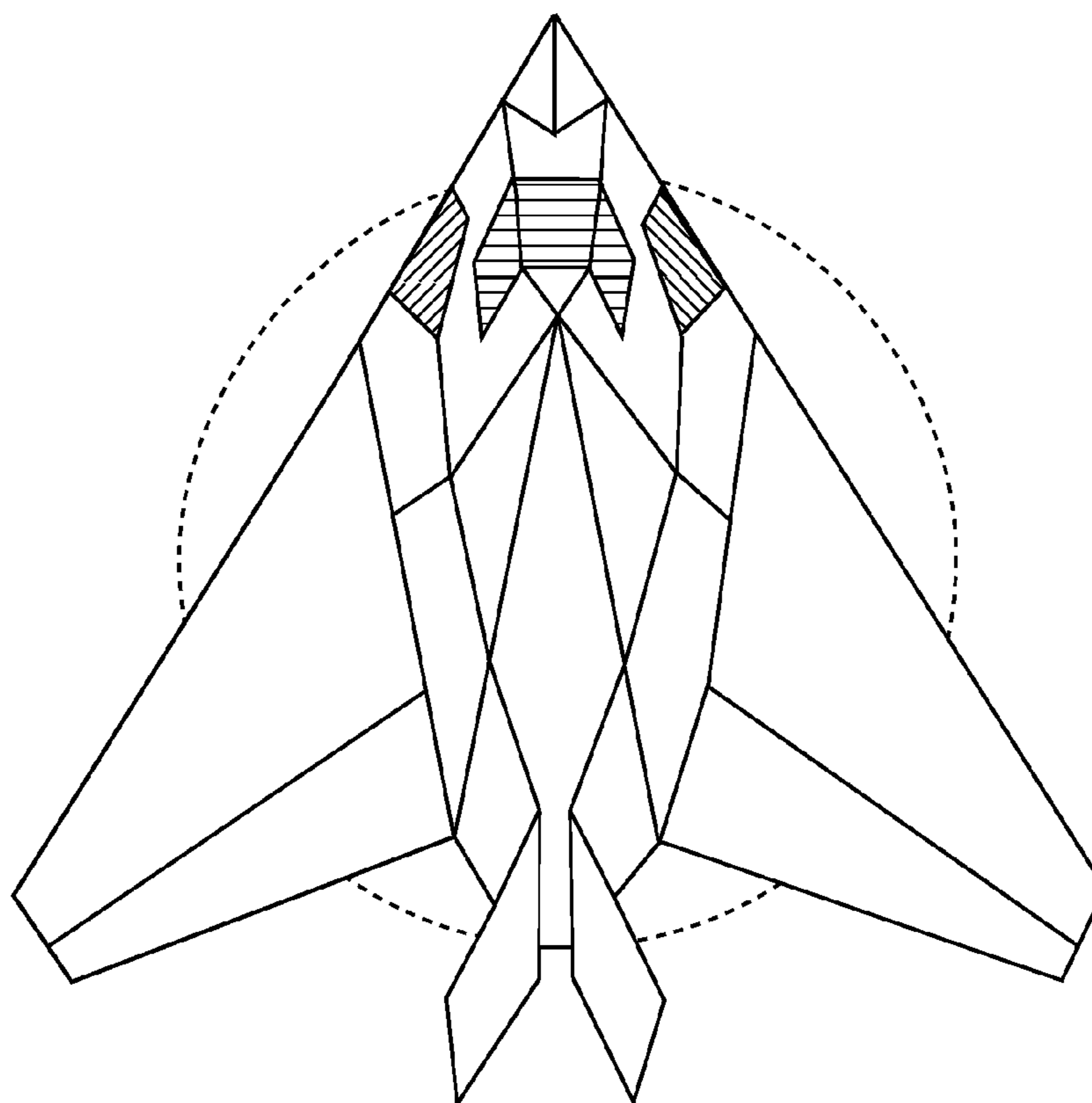

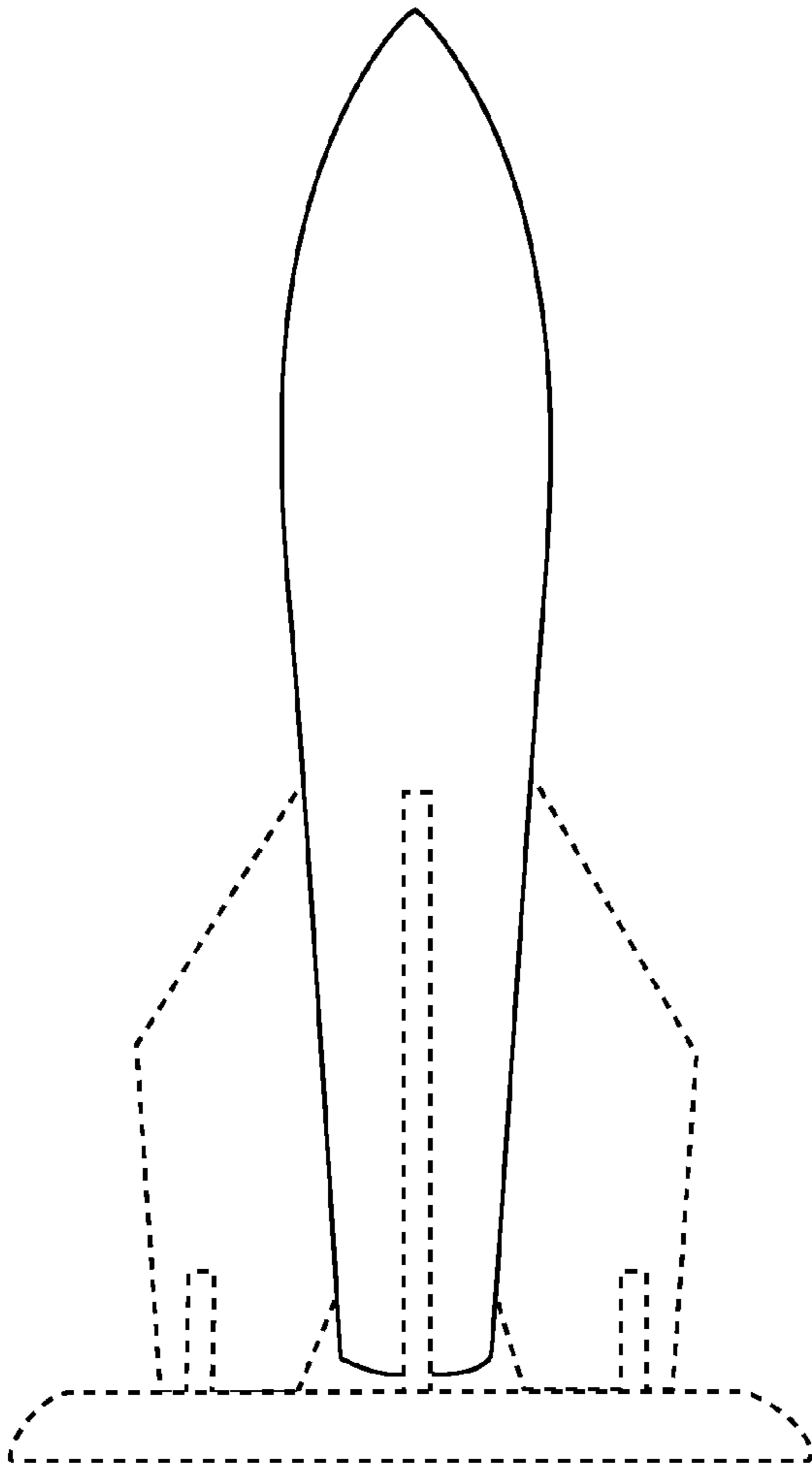

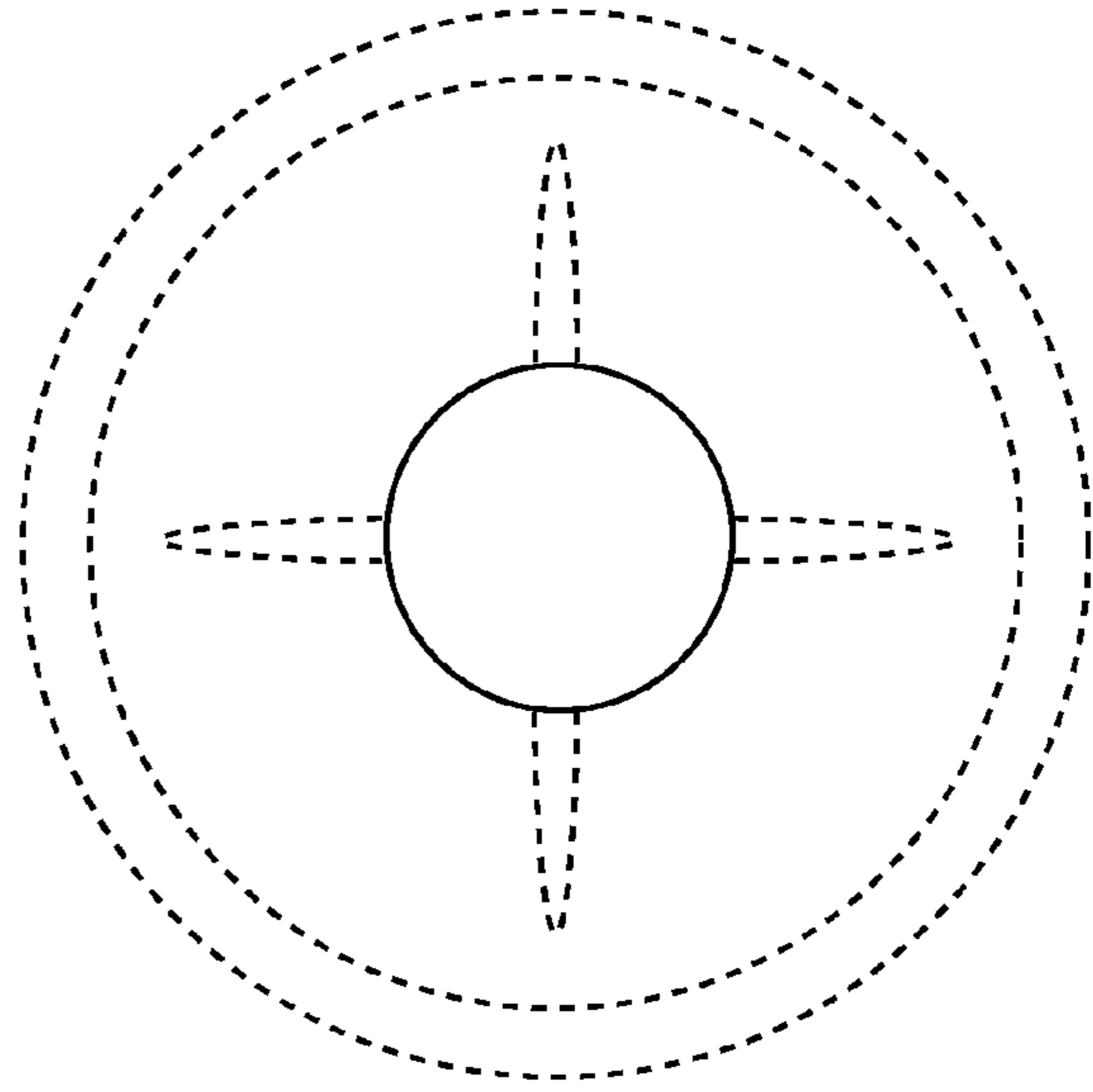

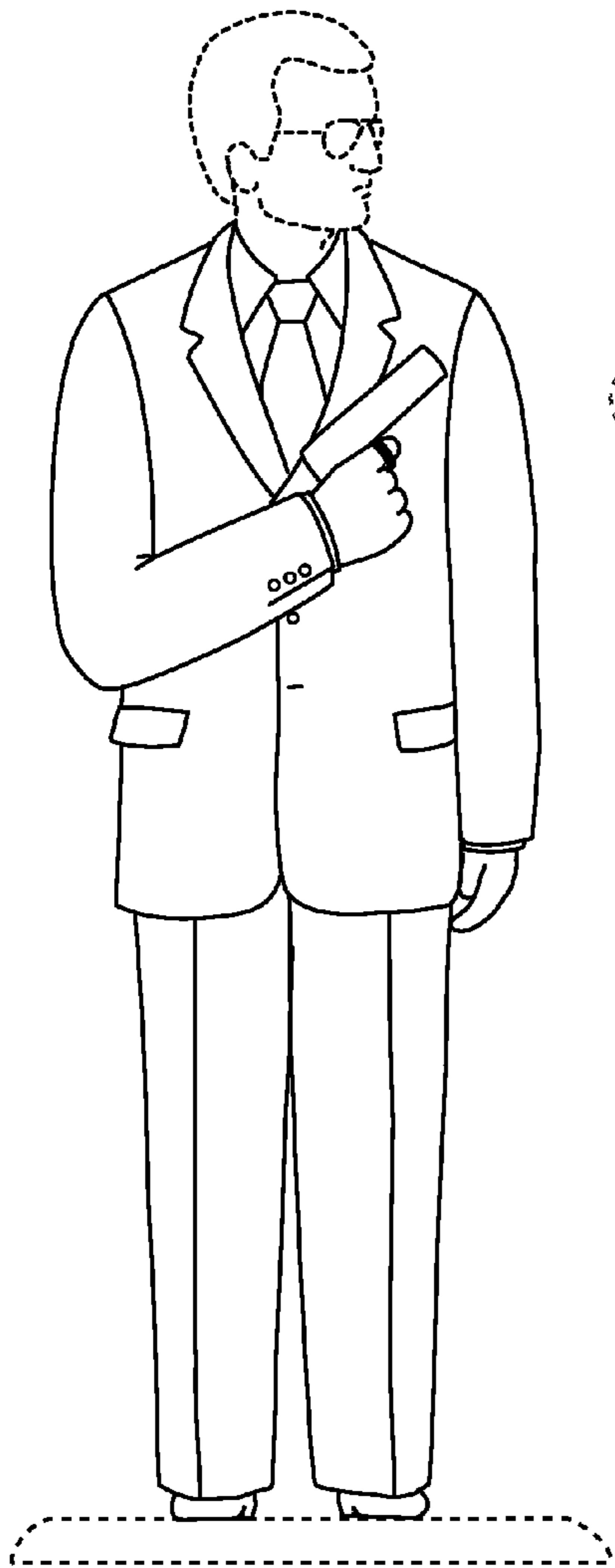

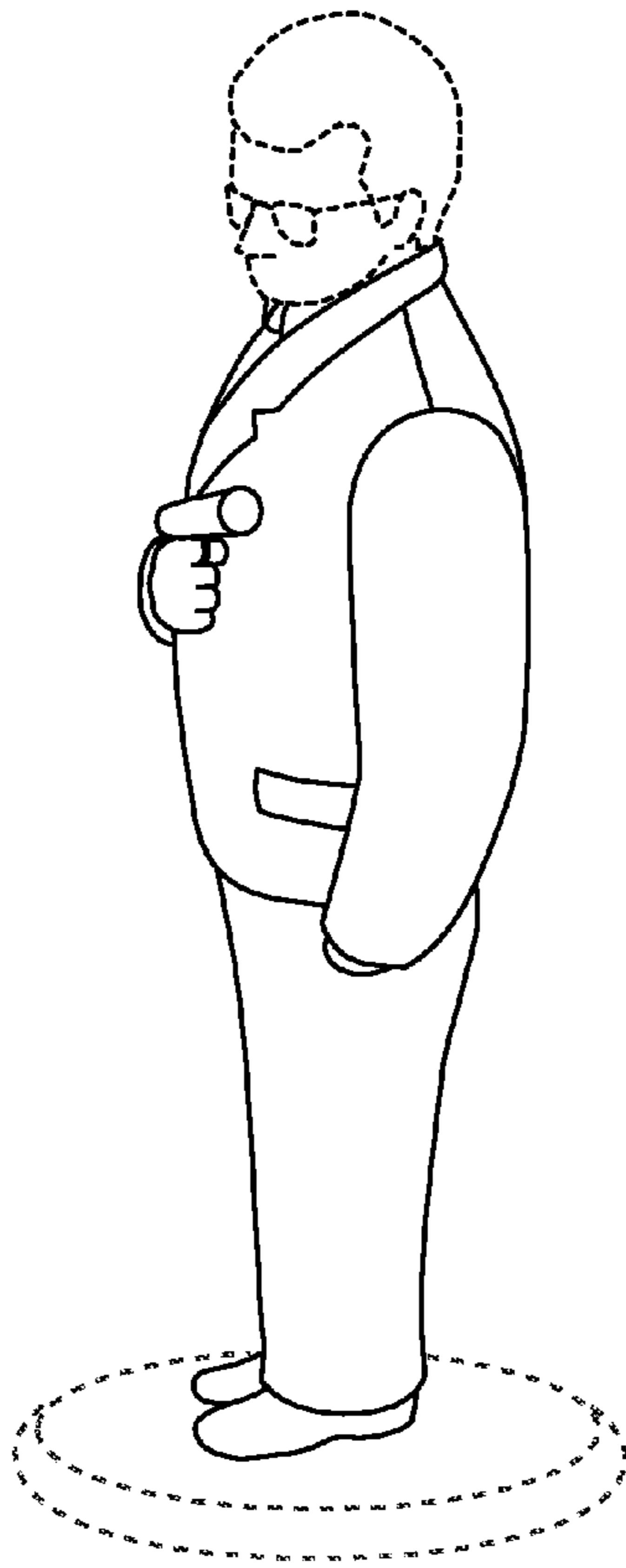

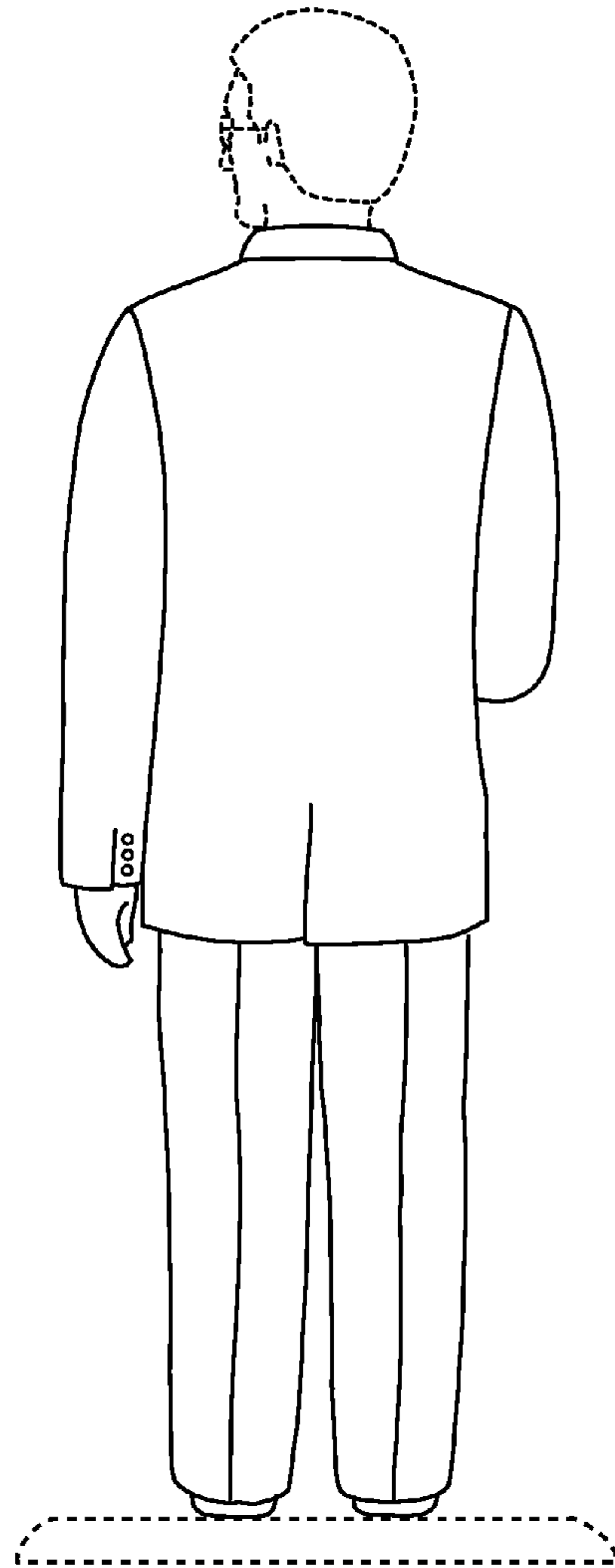
