(57) **CLAIM**

The ornamental design for a rubber resistance exercise tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a rubber resistance exercise tool in accordance with the invention.

FIG. 2 is a rear view thereof.

FIG. 3 is a right side view thereof.

FIG. 4 is a left side view thereof.

FIG. 5 is a top plan view thereof.

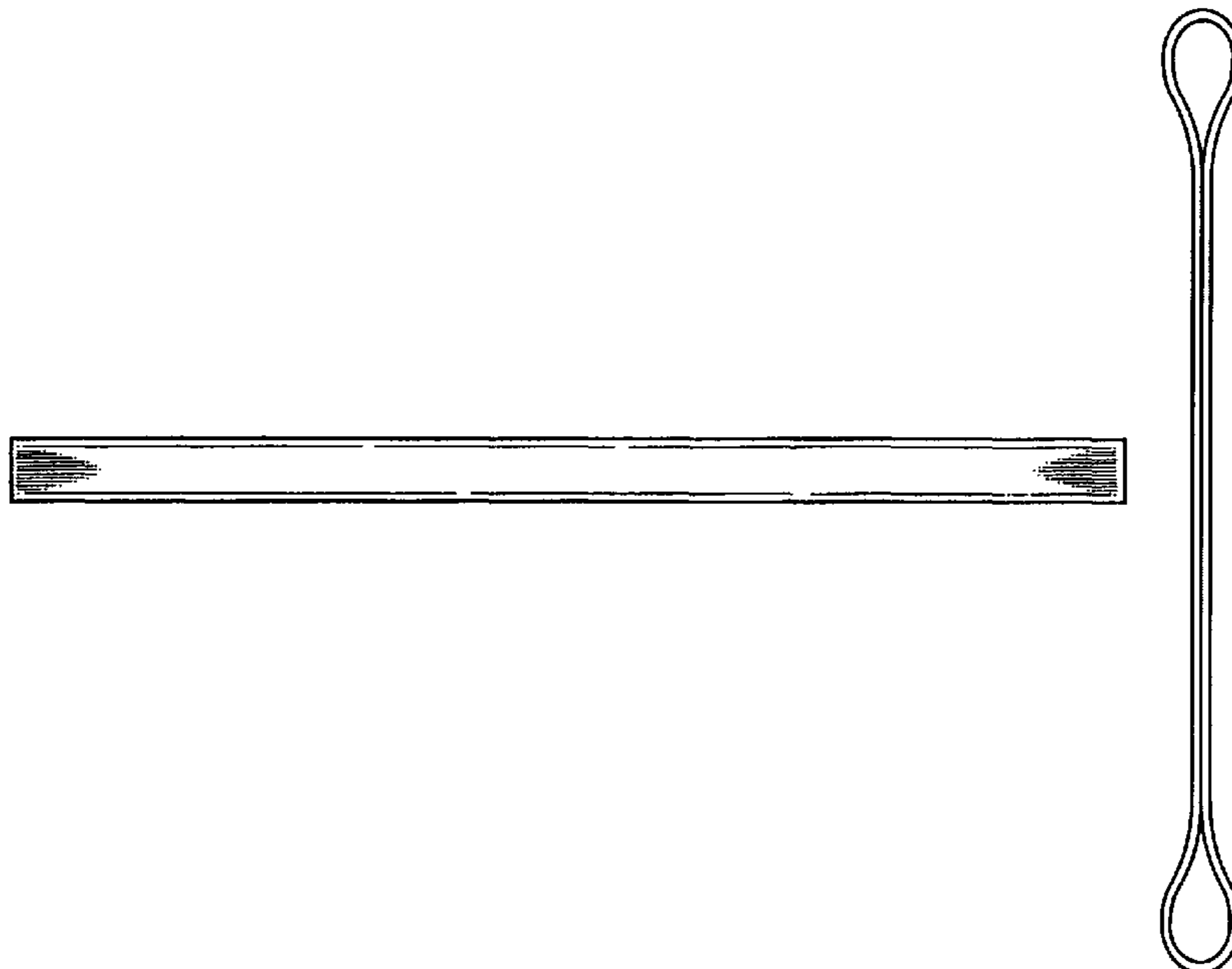
FIG. 6 is a bottom plan view thereof.

FIG. 7 is an enlarged cross sectional view as taken along 7—7 line in FIG. 5.

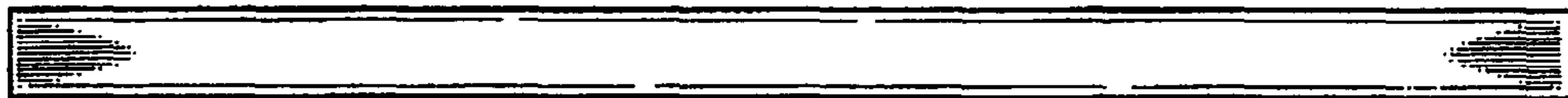

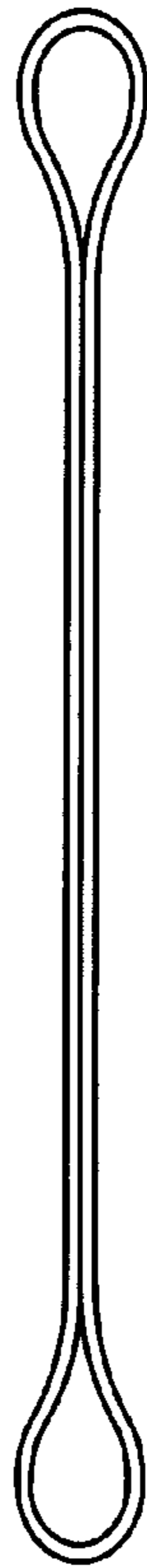

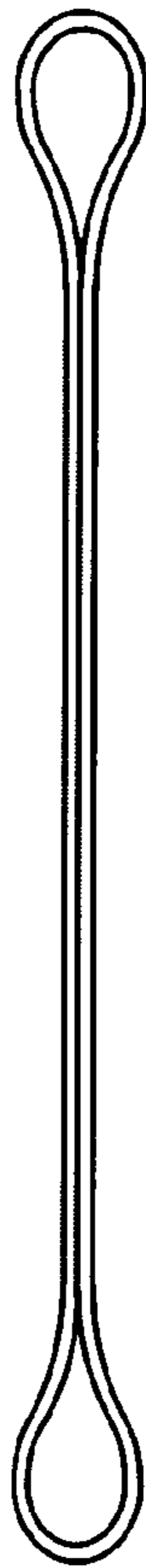

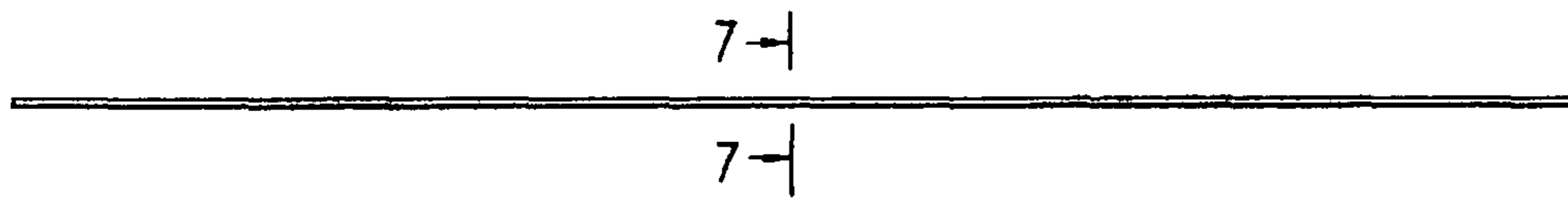

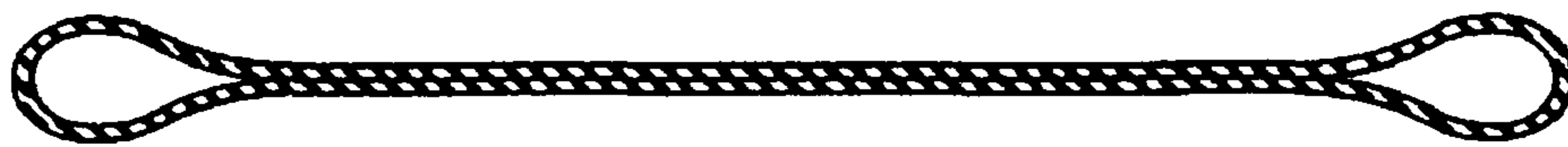

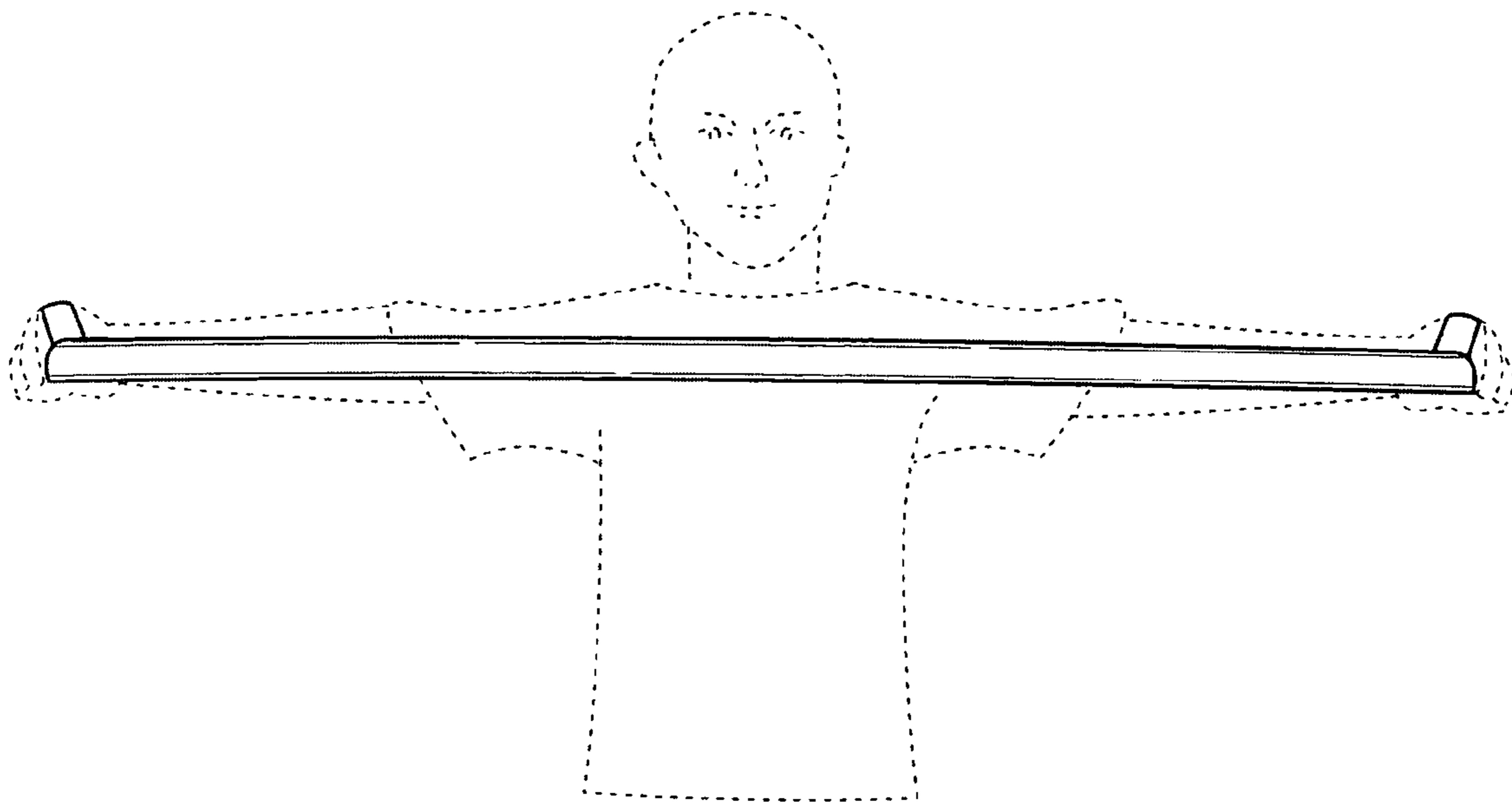
