FIG. 2 is a front view thereof;

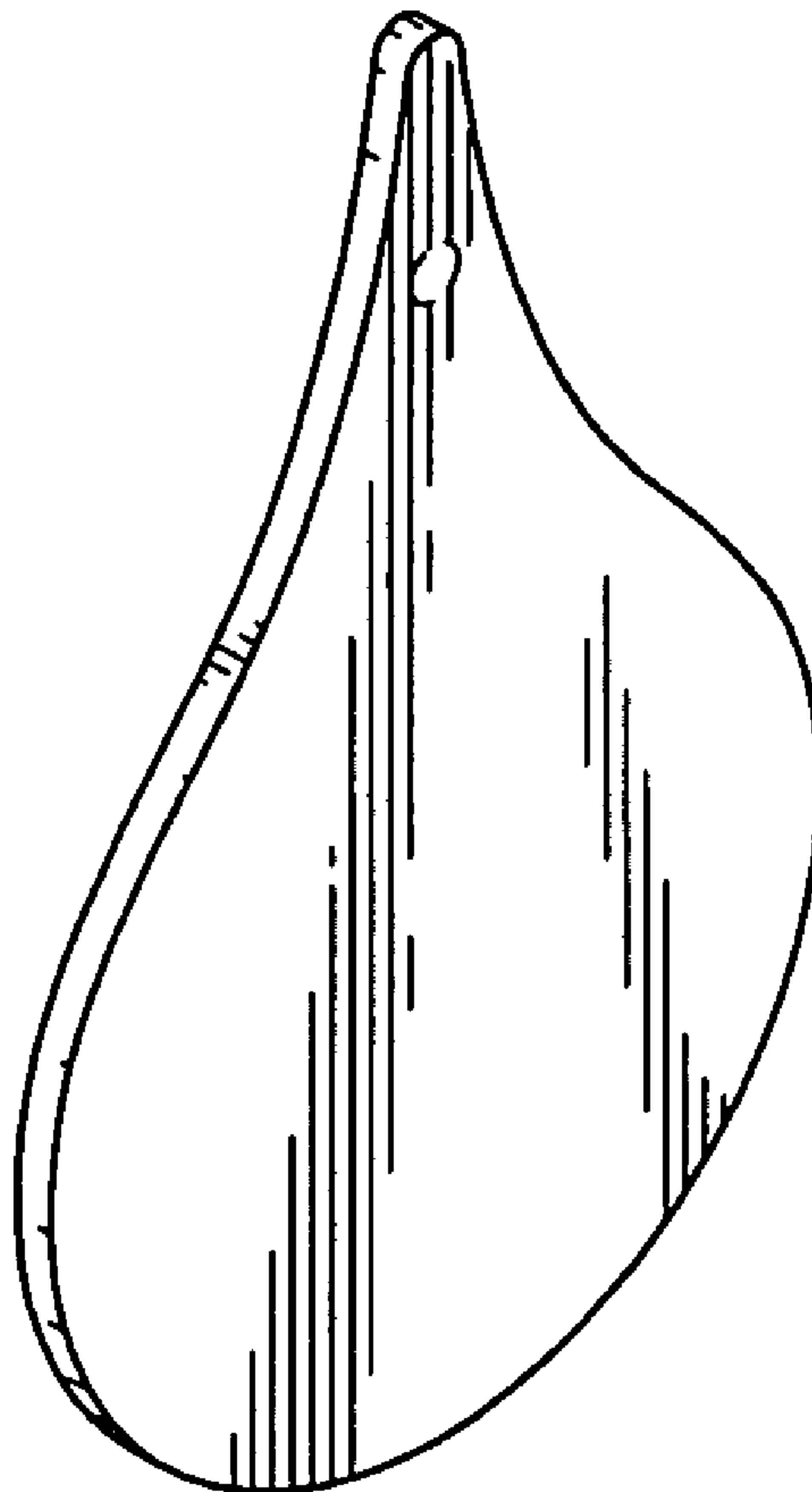
FIG. 3 is a right side view and left side view thereof;

FIG. 4 is a top view thereof; and,

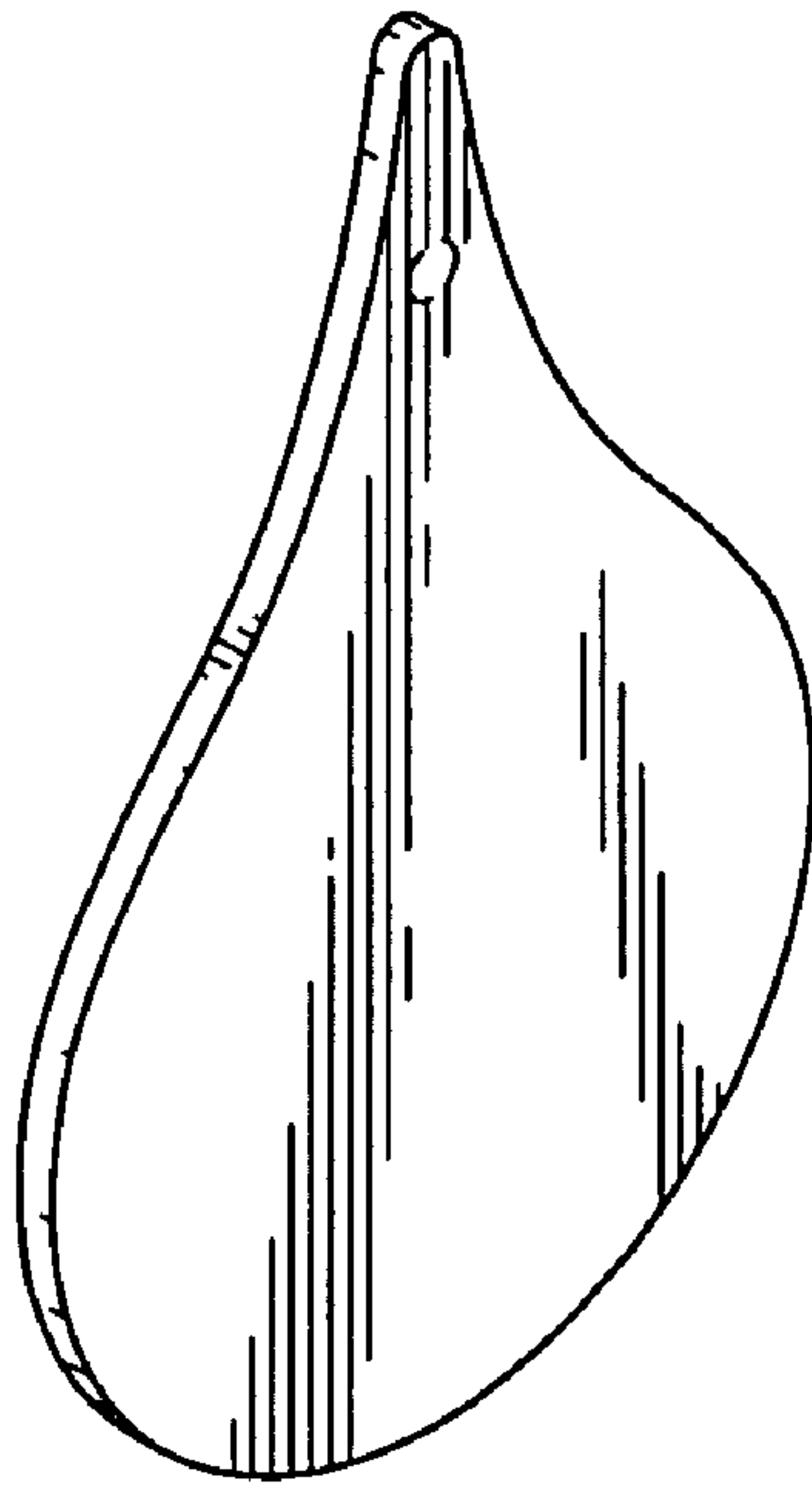
FIG. 5 is a bottom view thereof.

The broken line showing is disclosure included for illustrative purposes and forms no part of the presently claimed design.

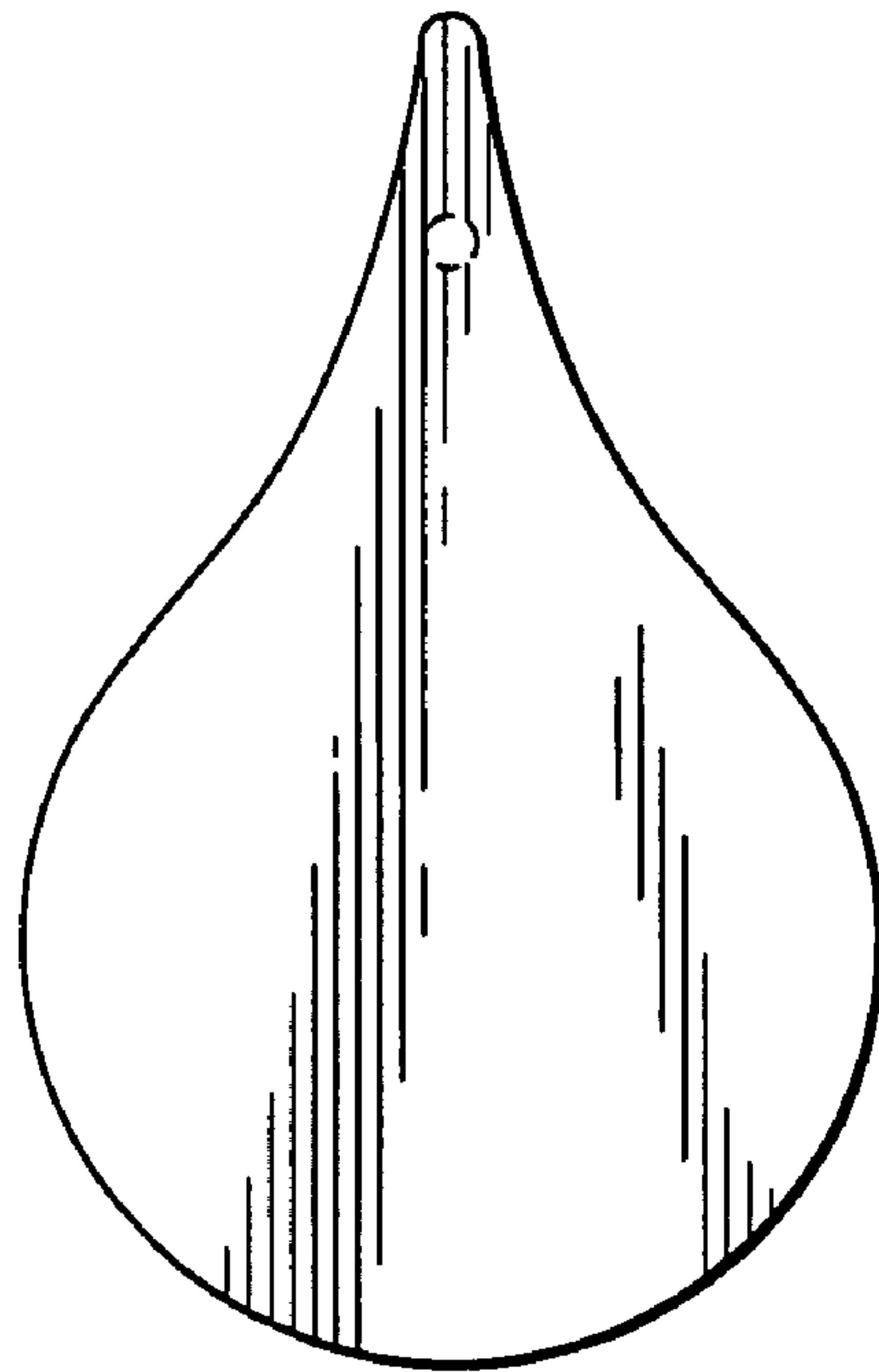
