FIG. 1 is a perspective view of an outdoor office in accordance with the new design;

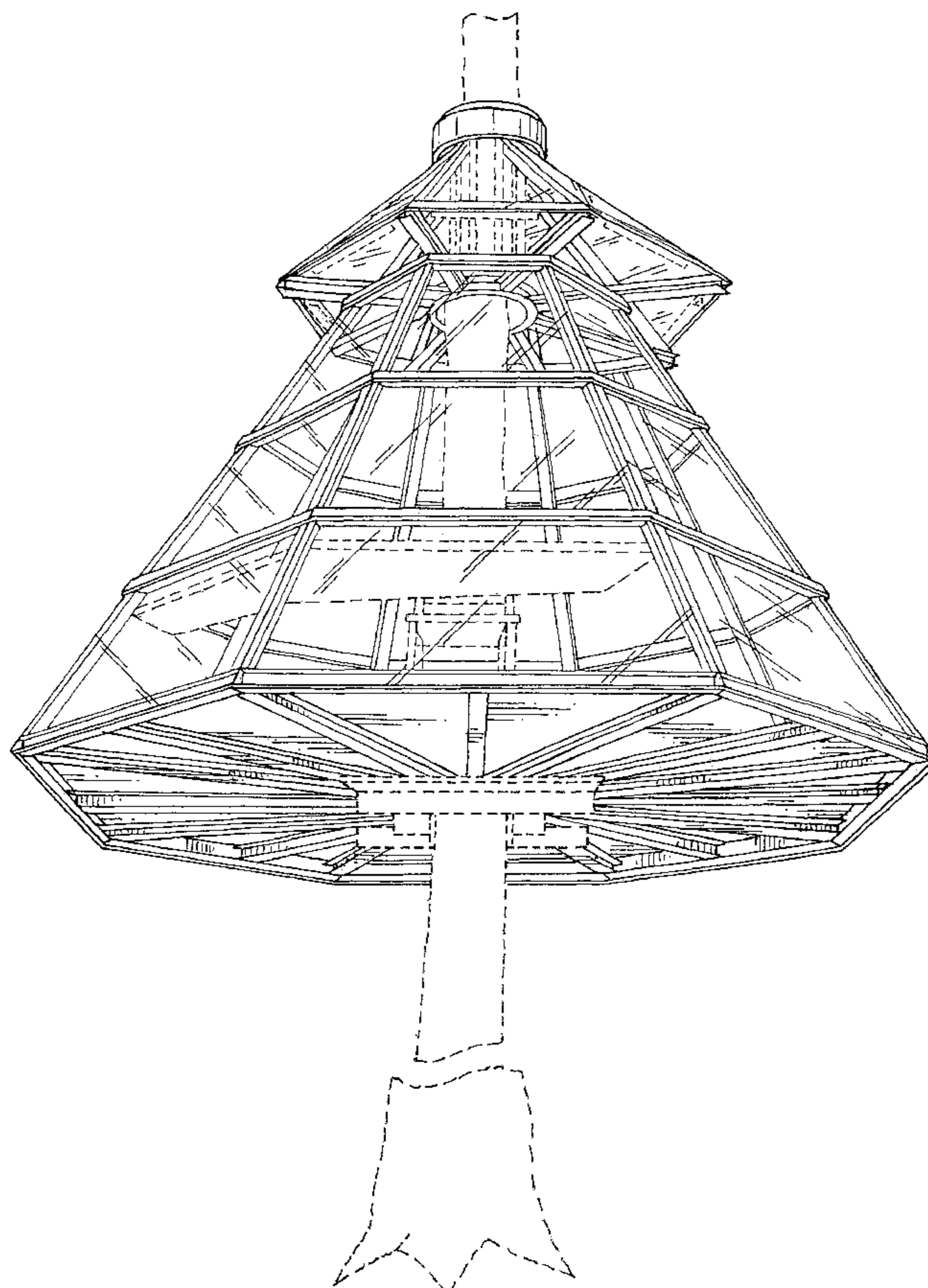
FIG. 2 is a side view thereof;

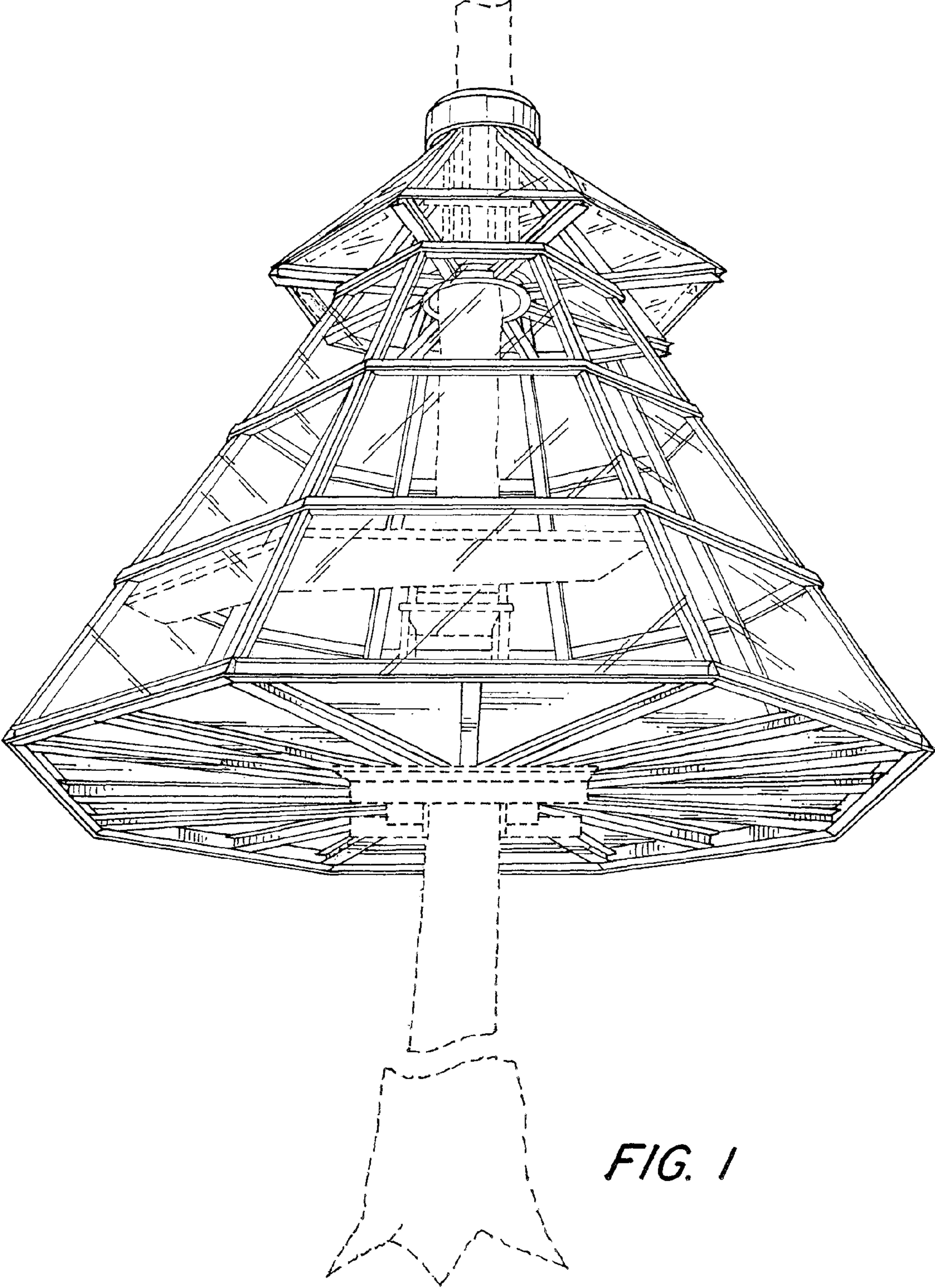
FIG. 3 is a top view thereof; and,

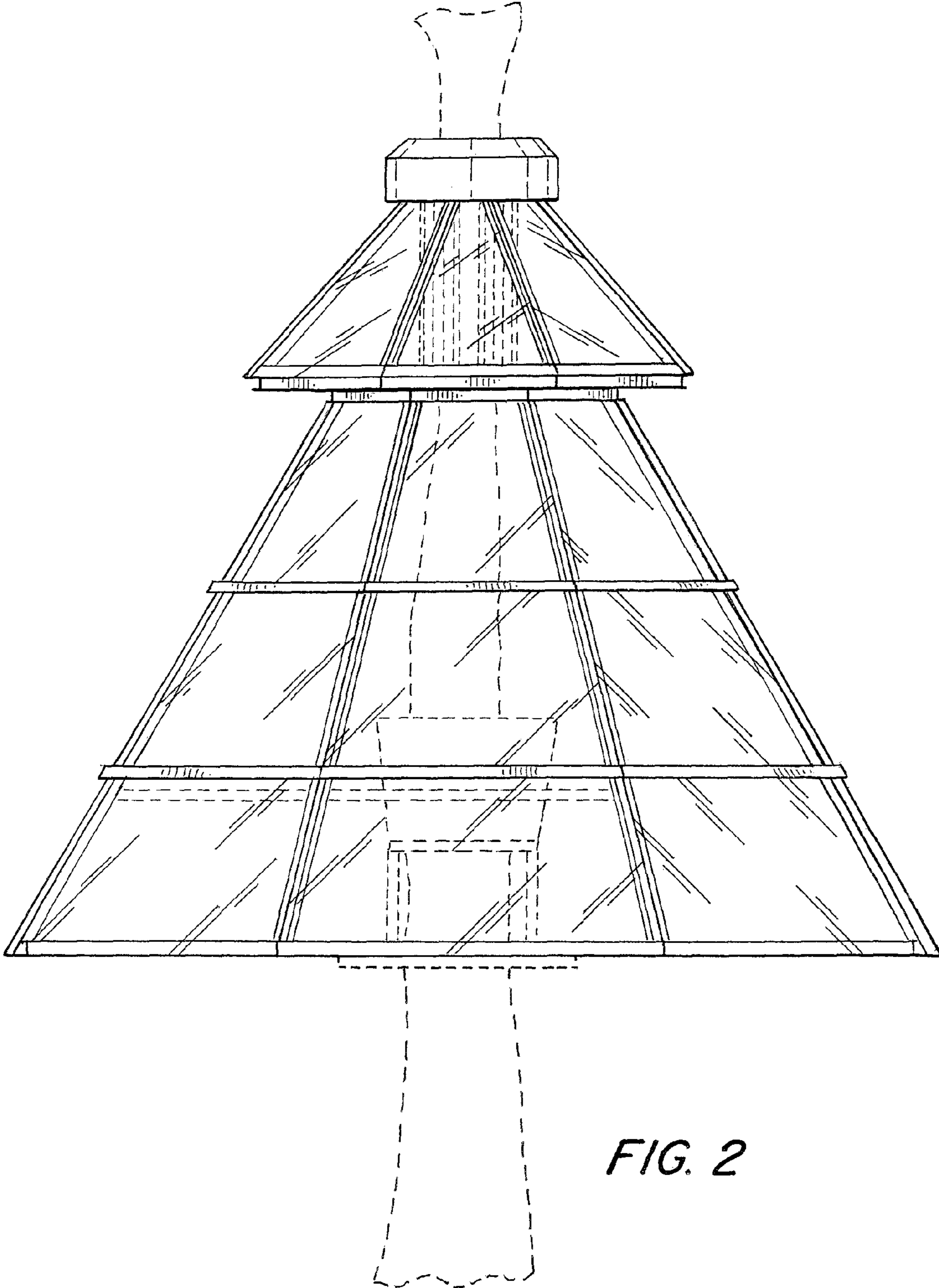
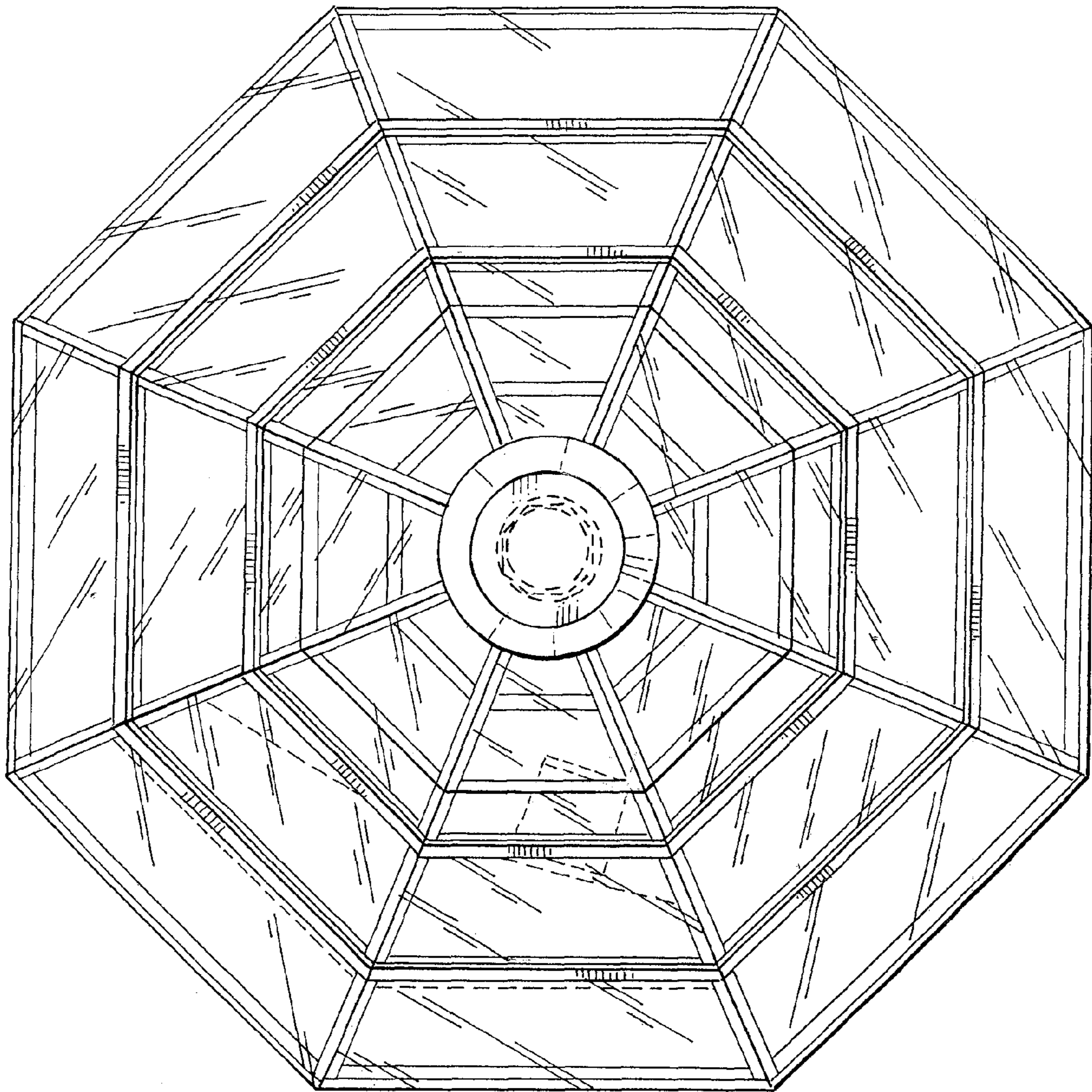
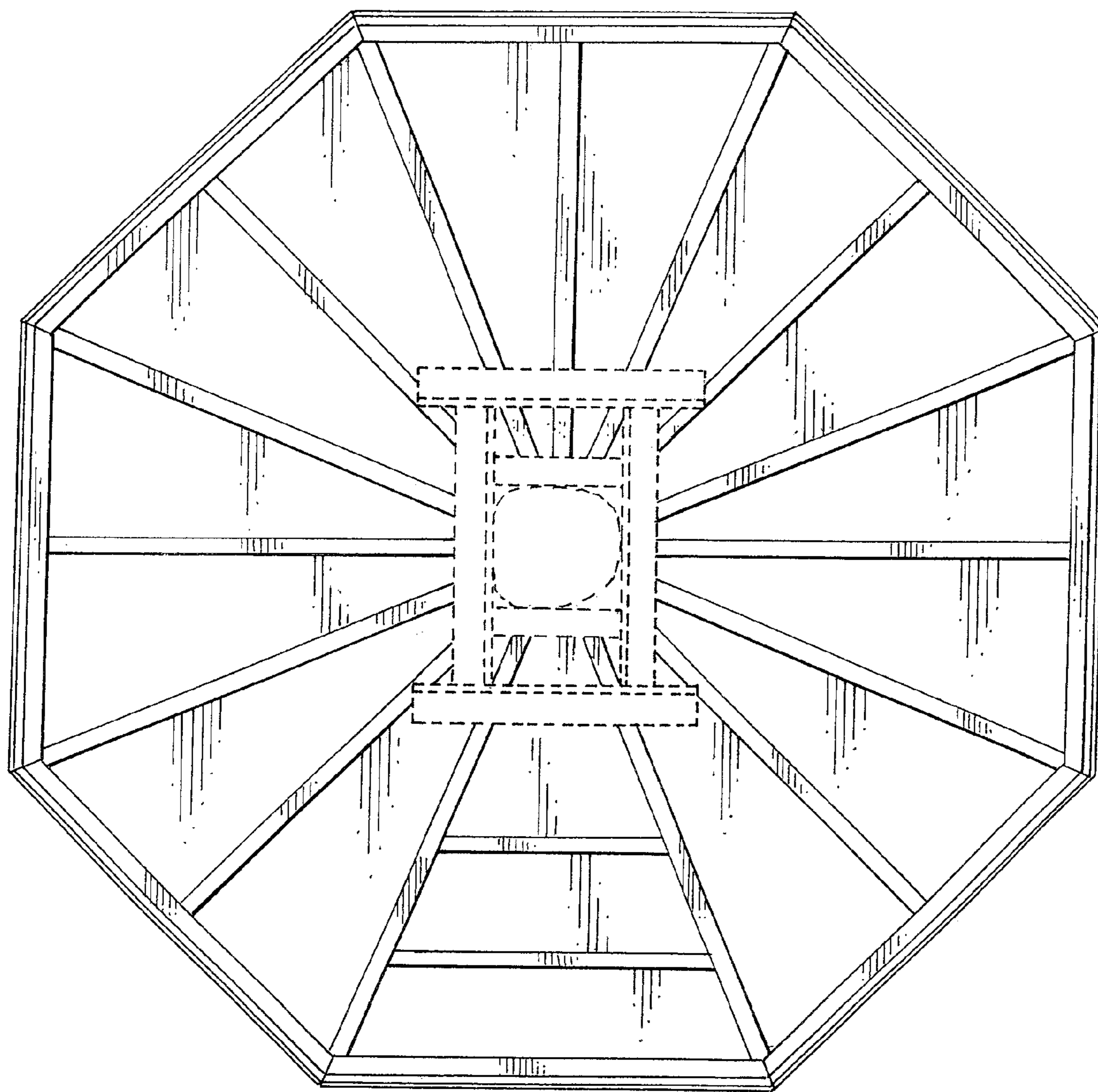
