The ornamental design for a cosmetic product, as shown and described.

DESCRIPTION

FIG. 13 is a right-side view of the design shown in FIG. 9;

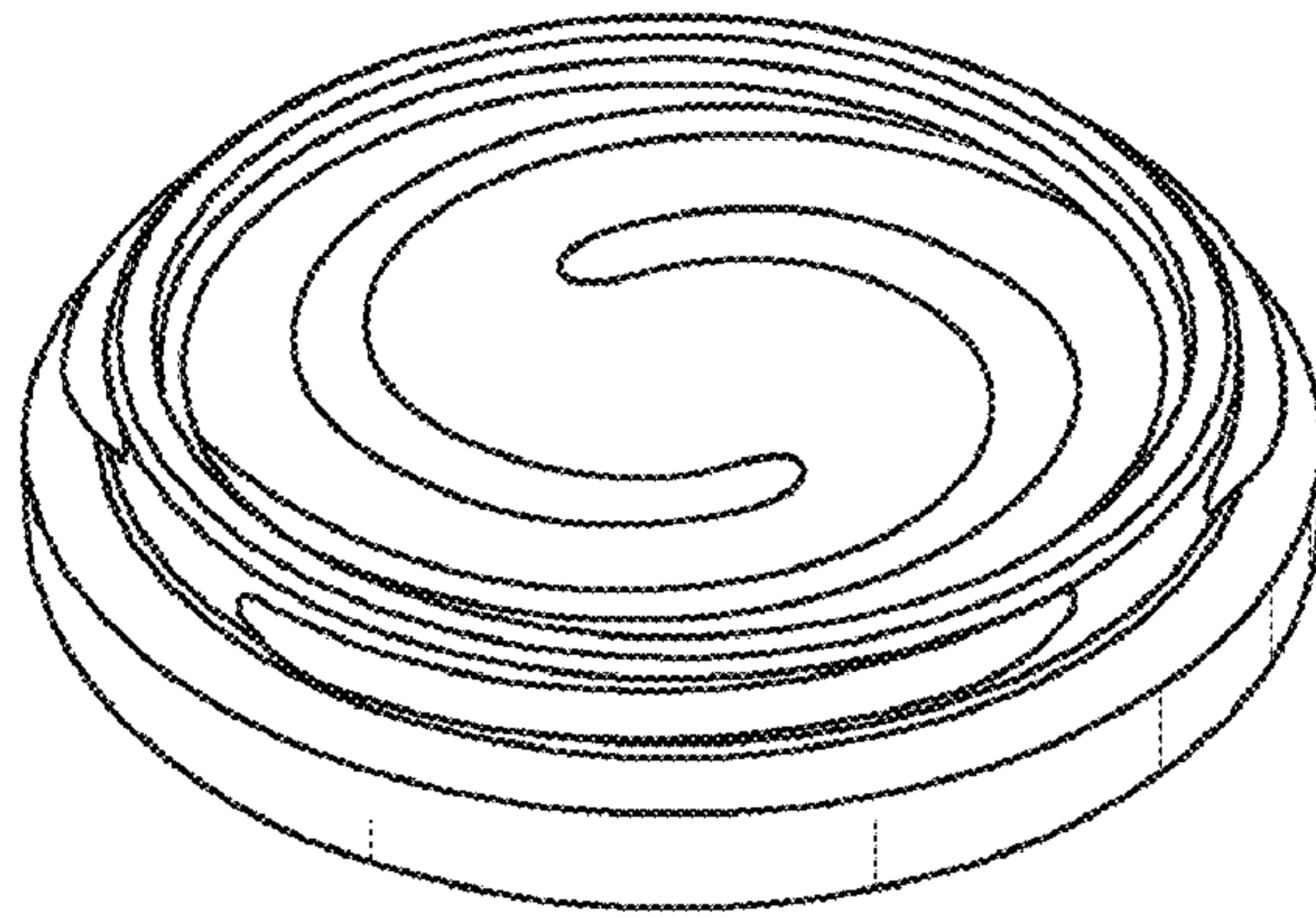
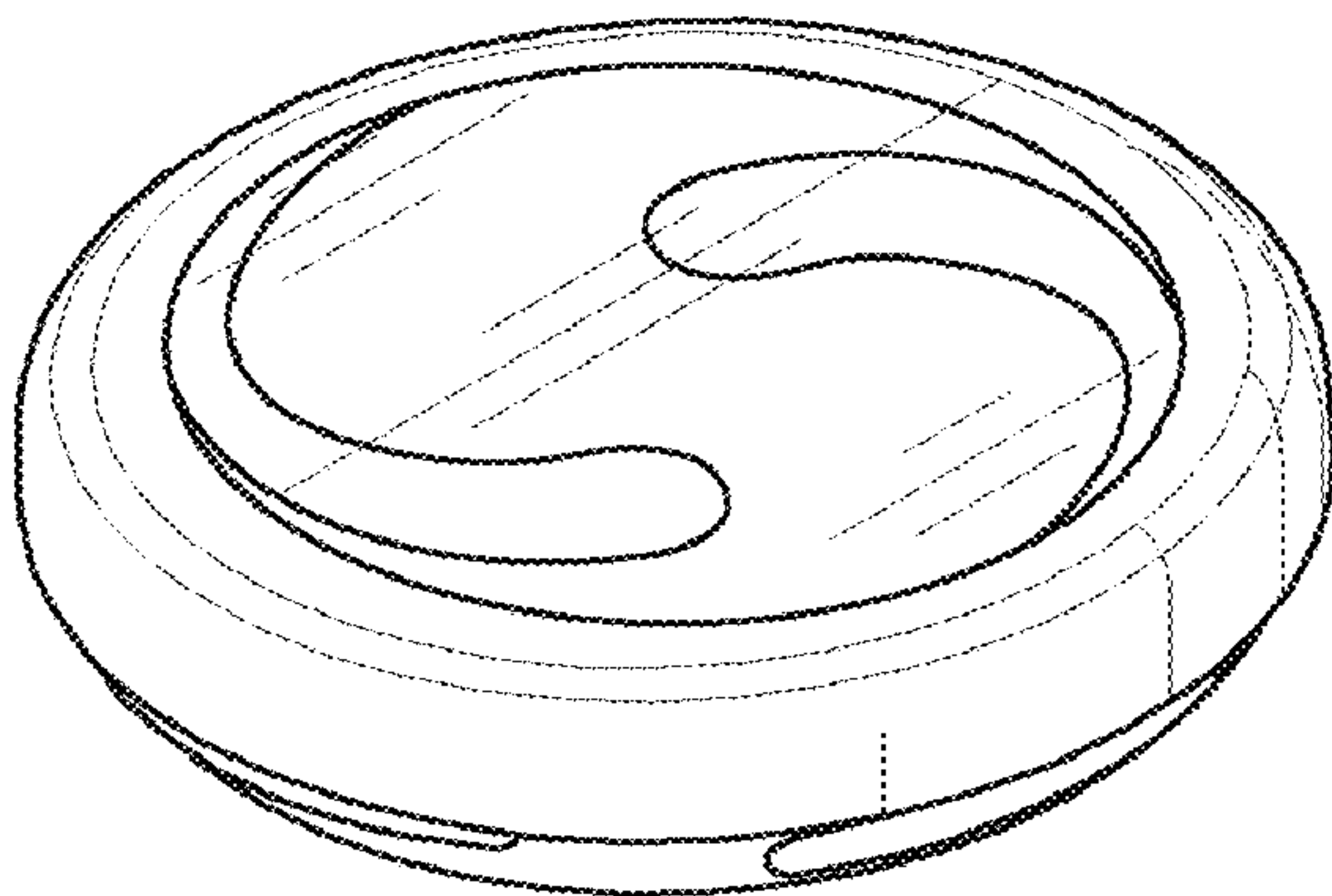
FIG. 14 is a left-side view of the design shown in FIG. 9;

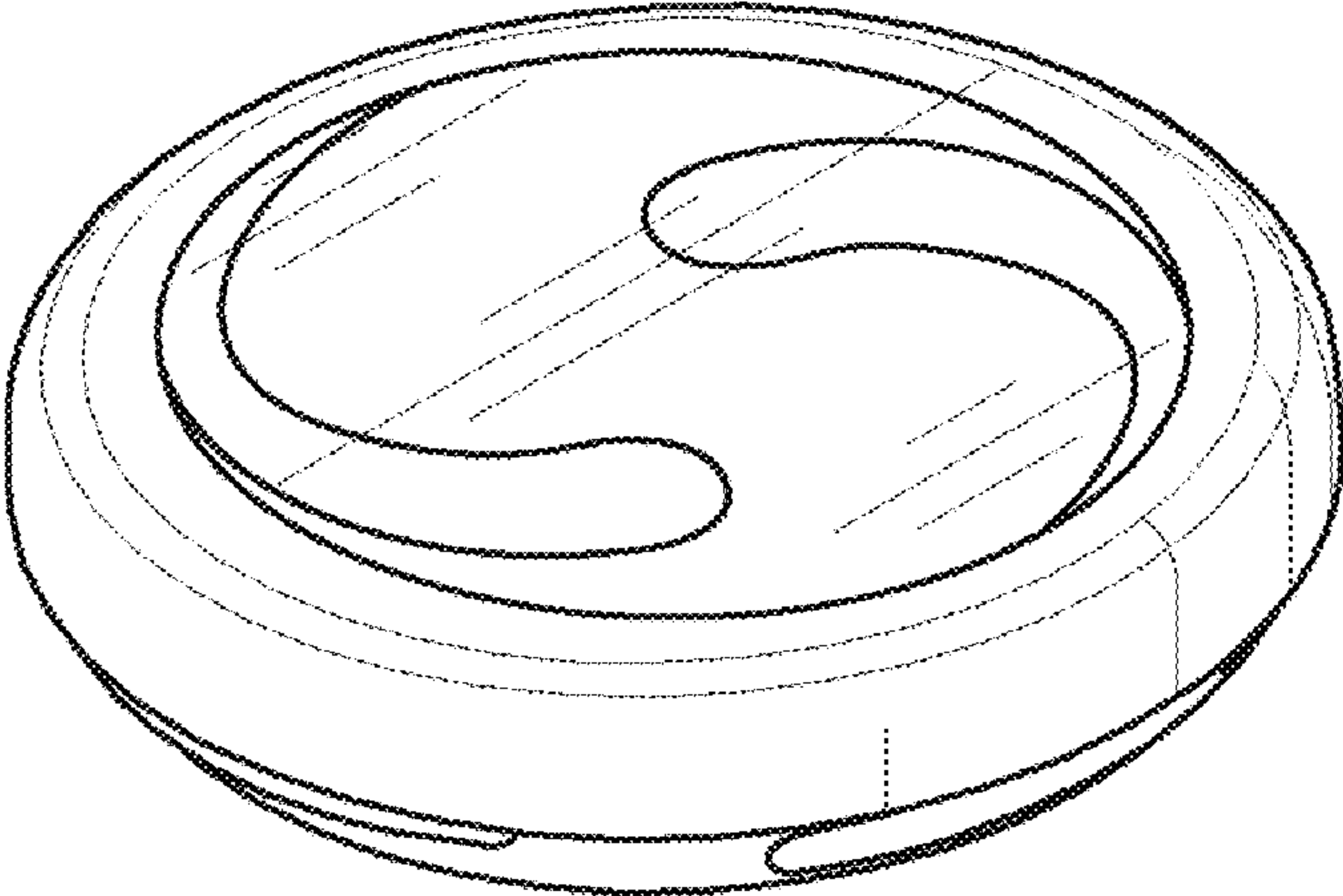

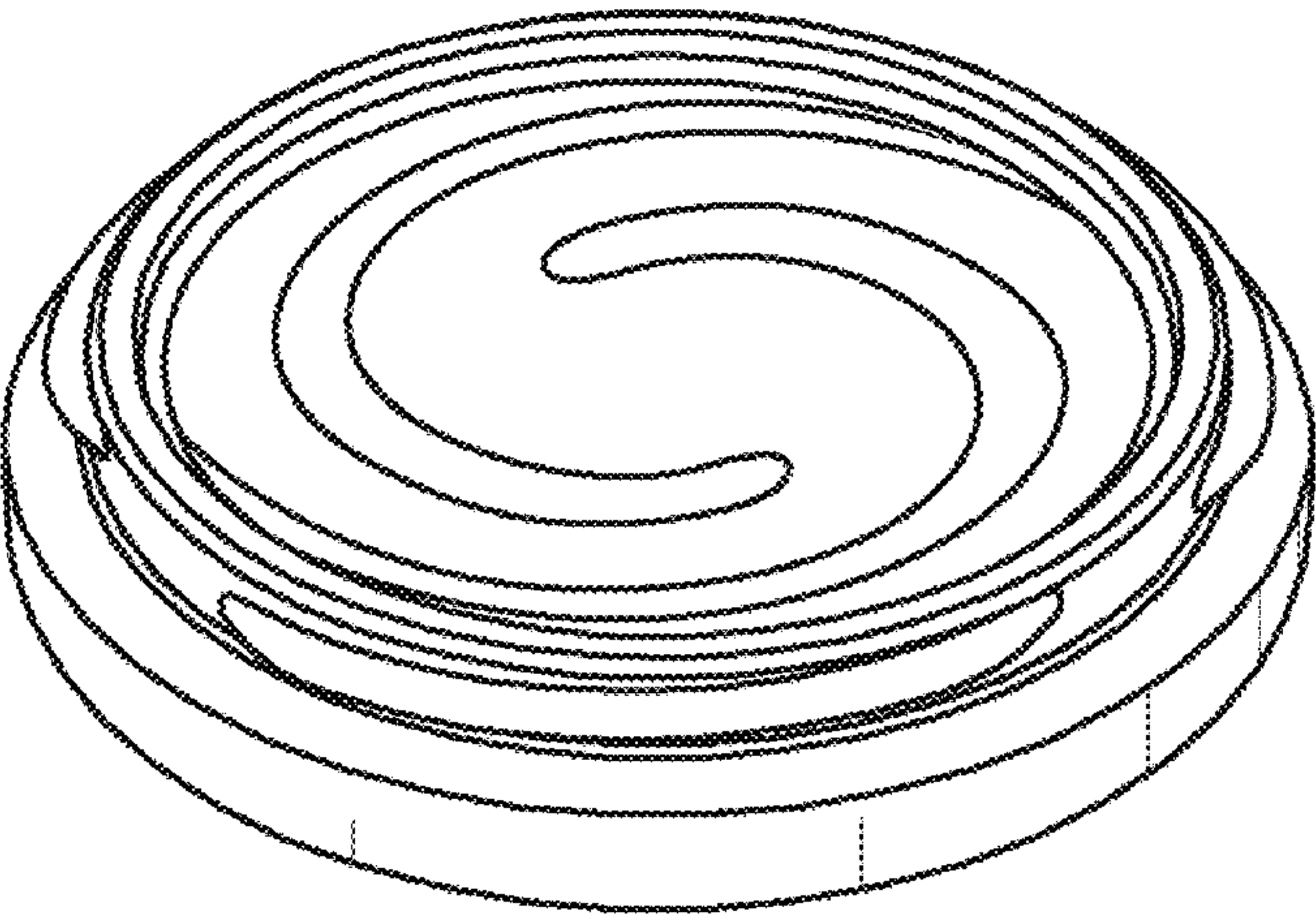

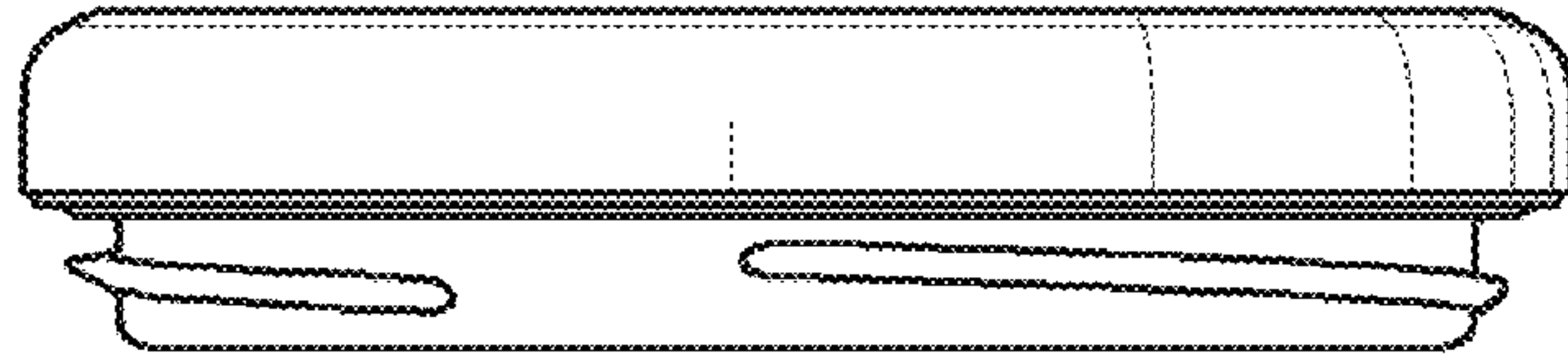

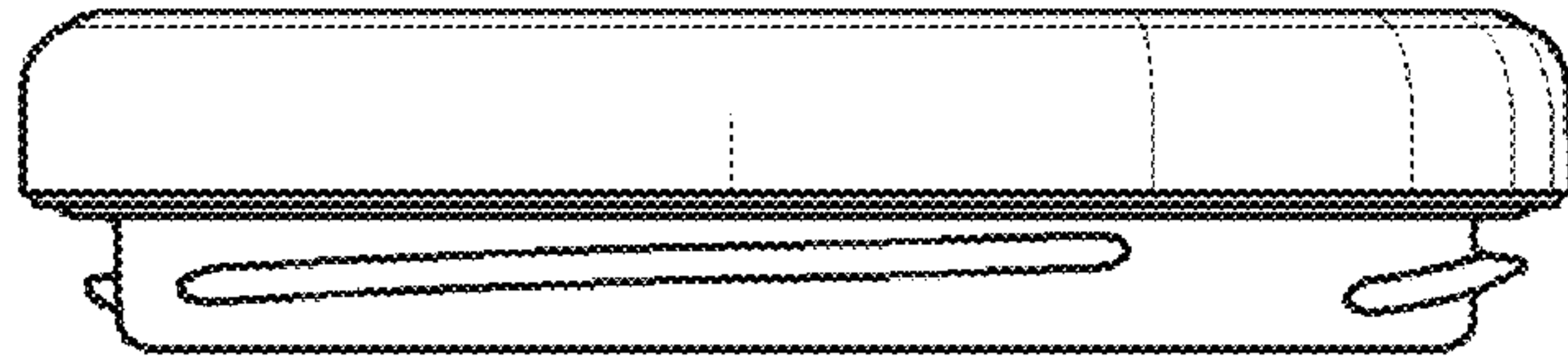

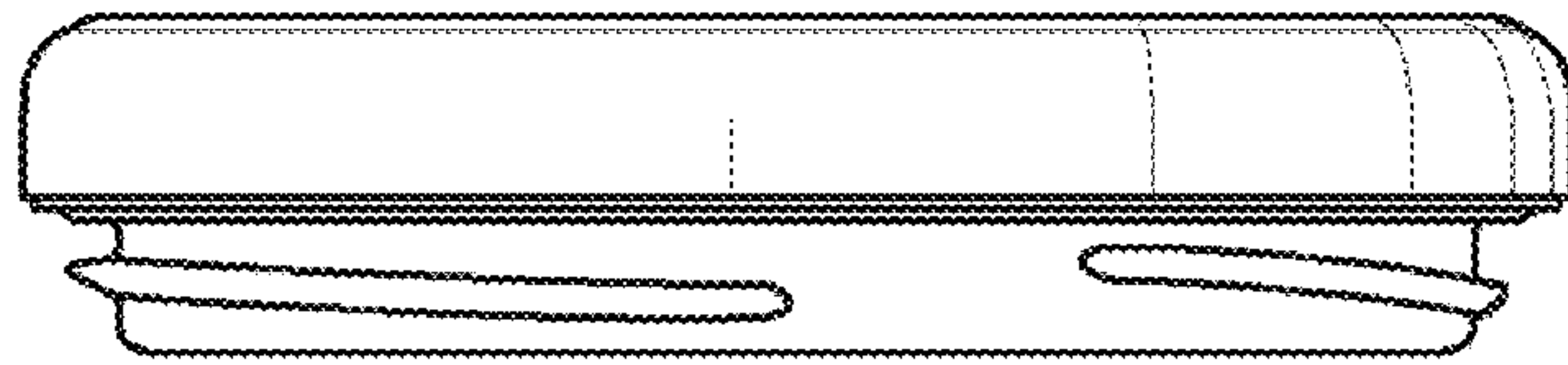

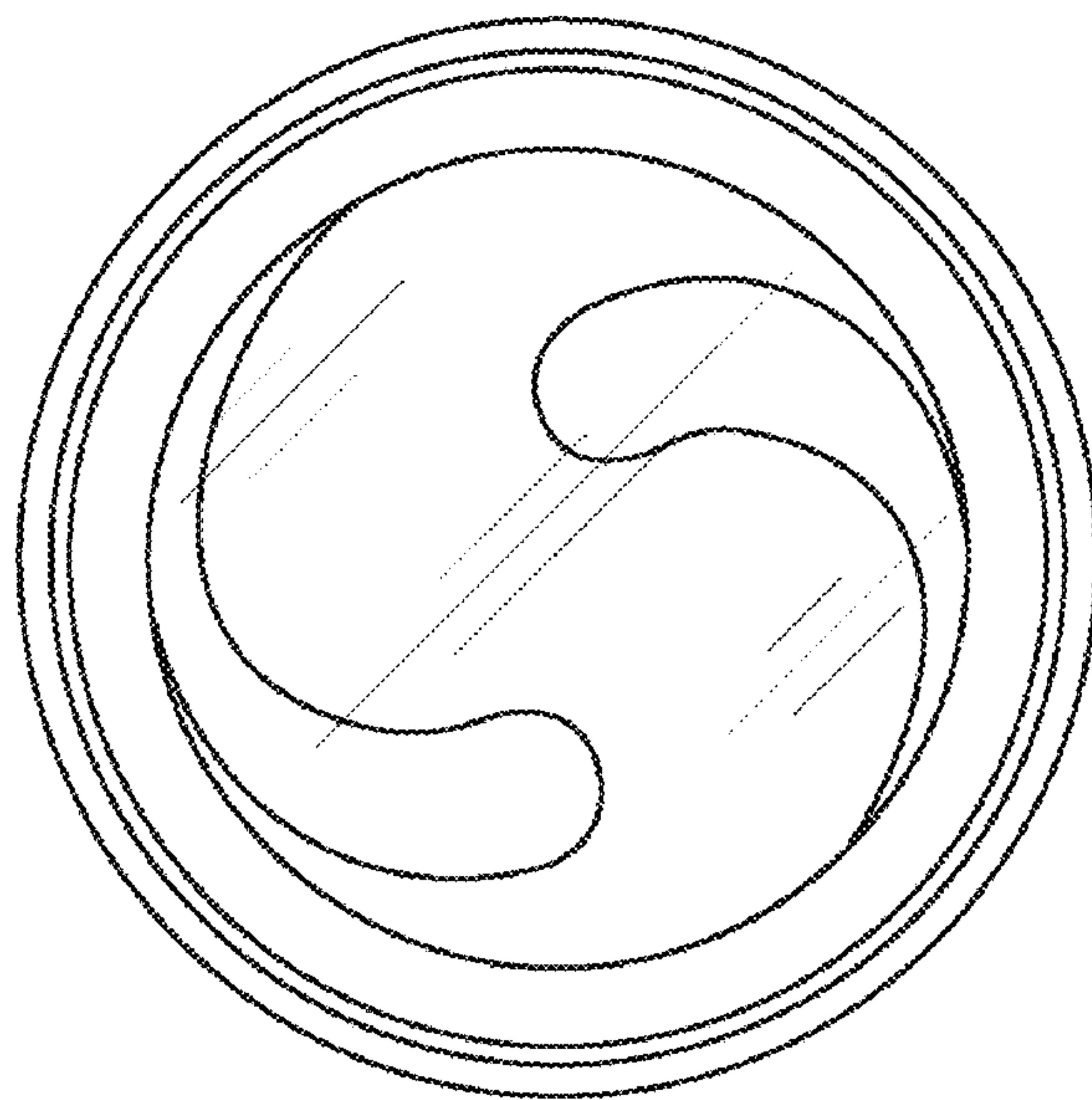

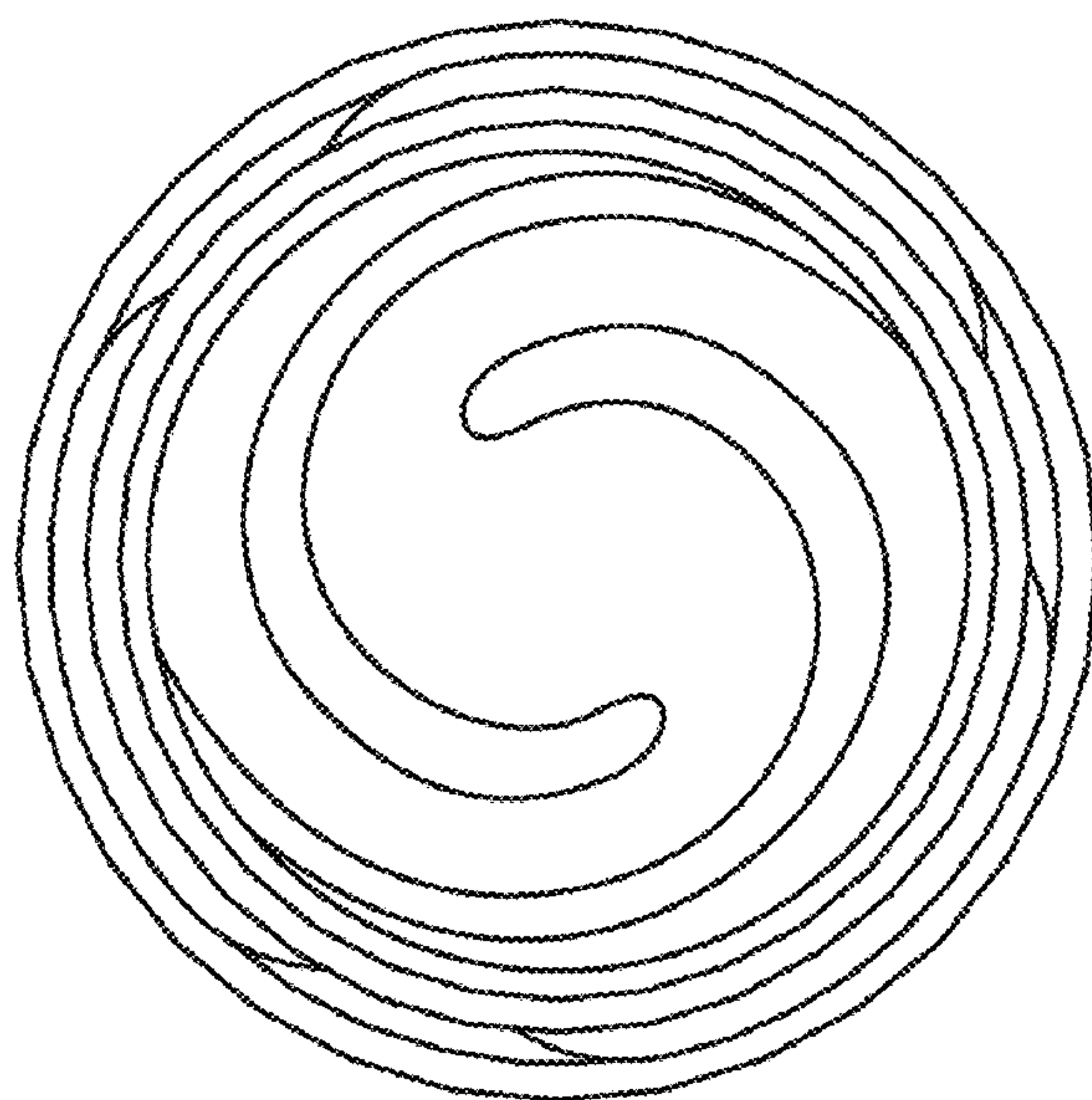

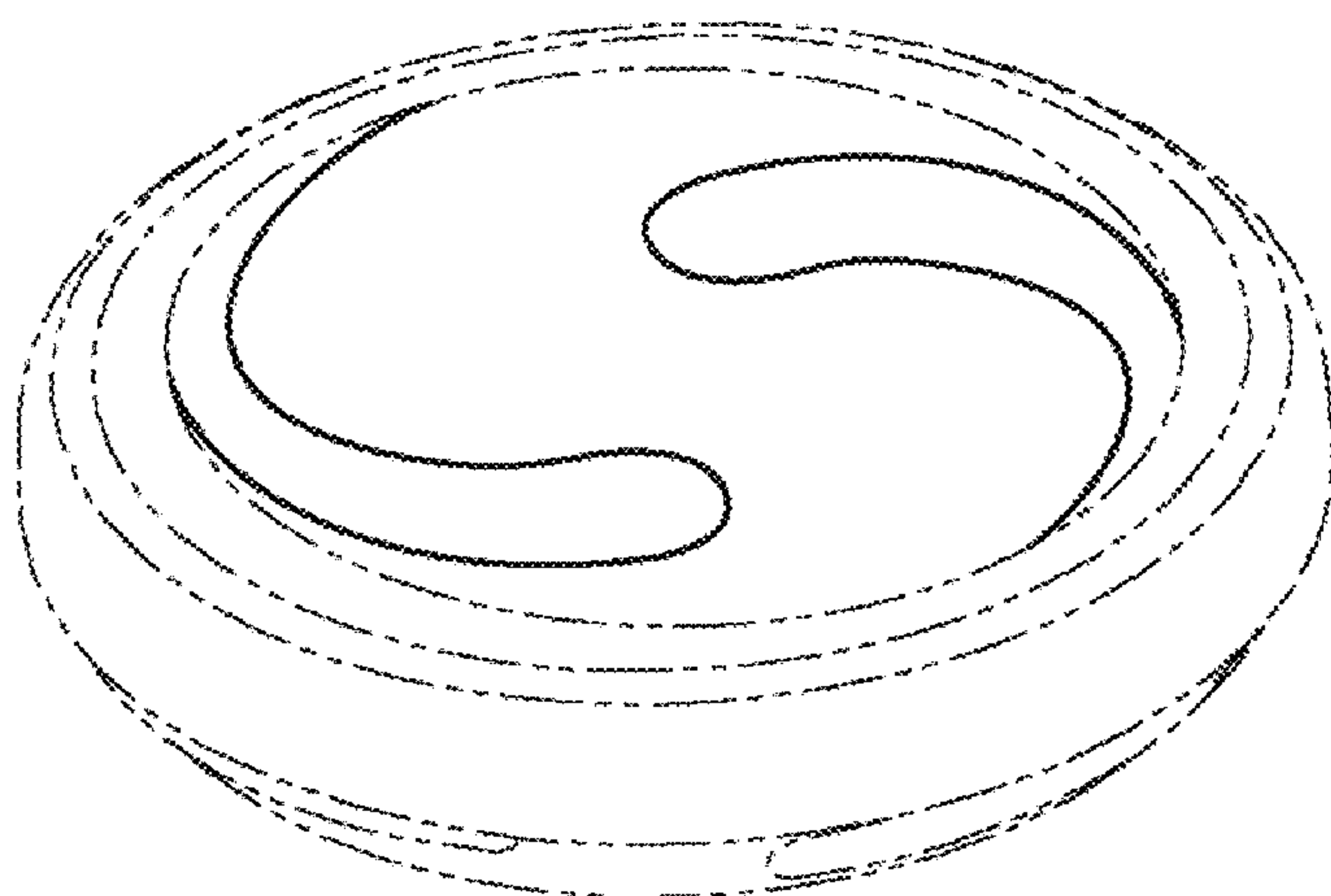

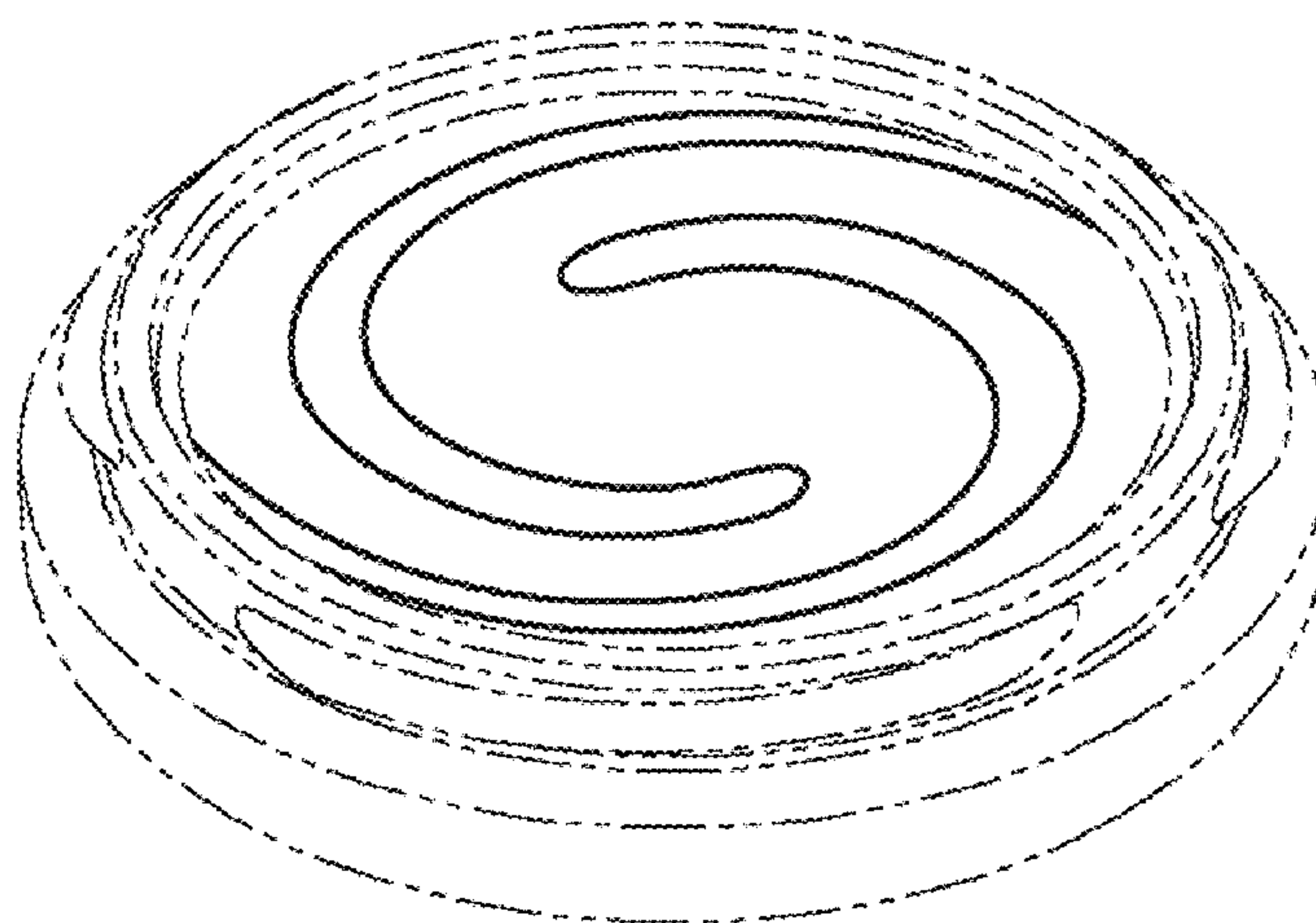

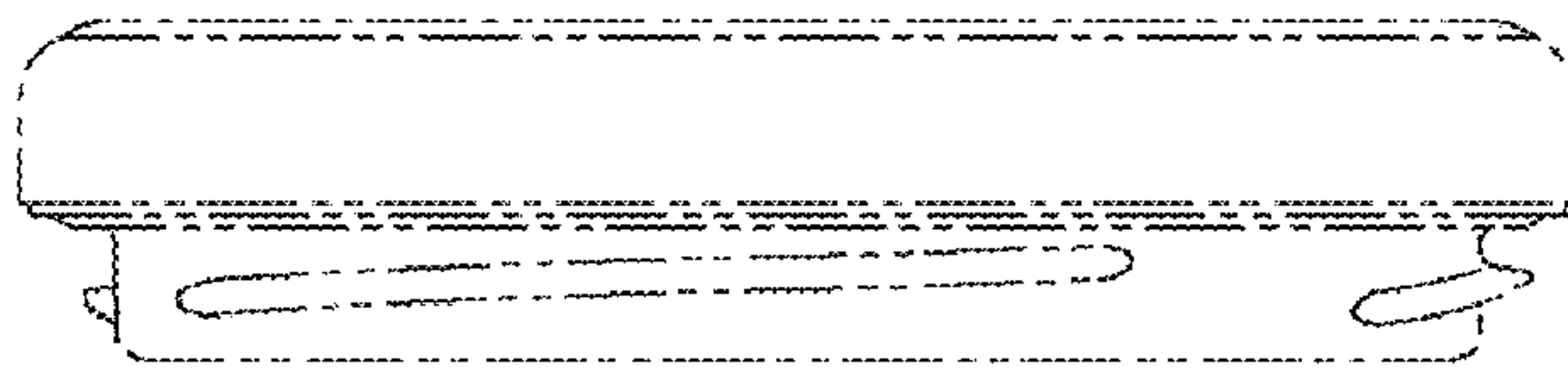

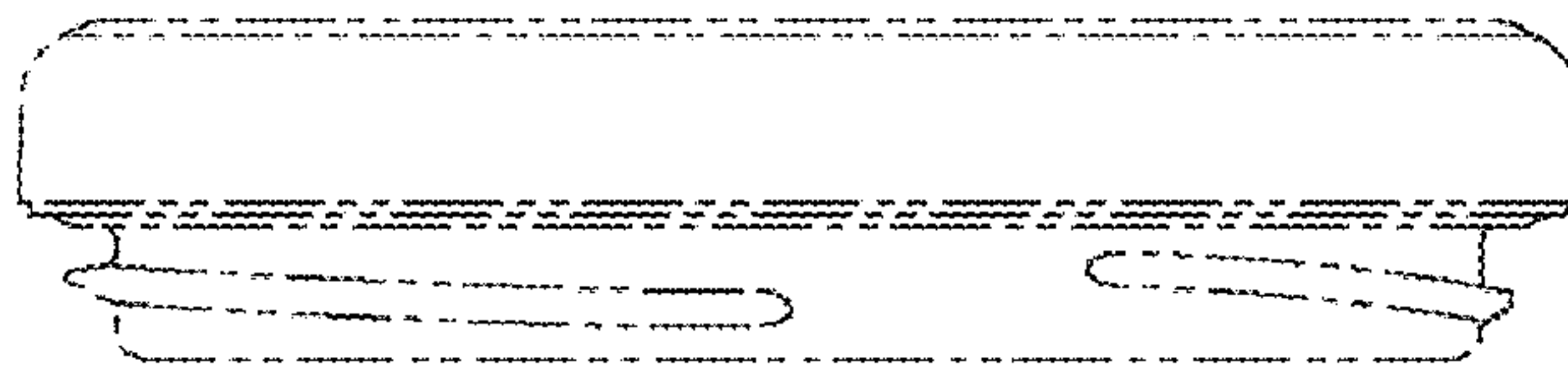

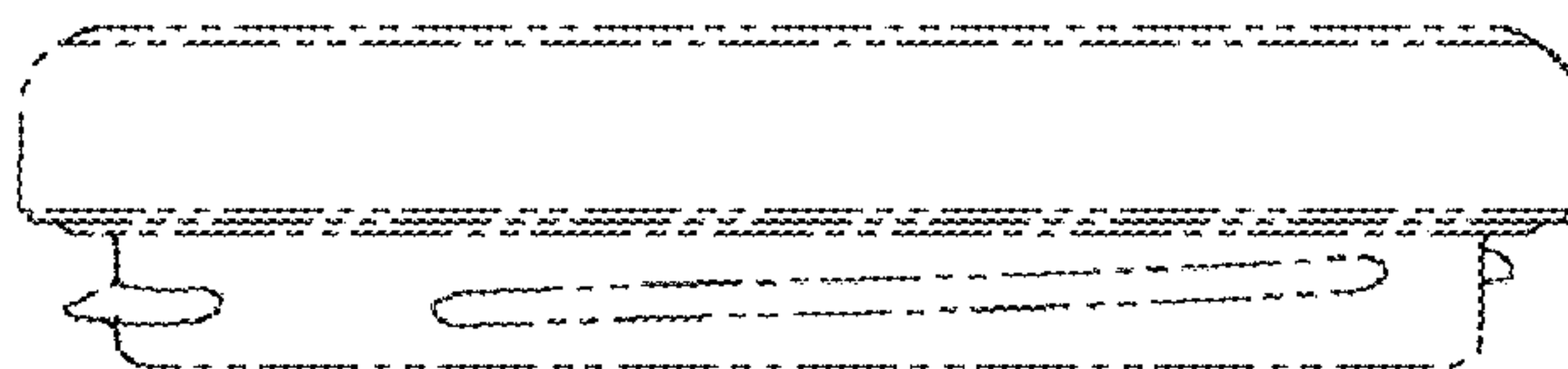

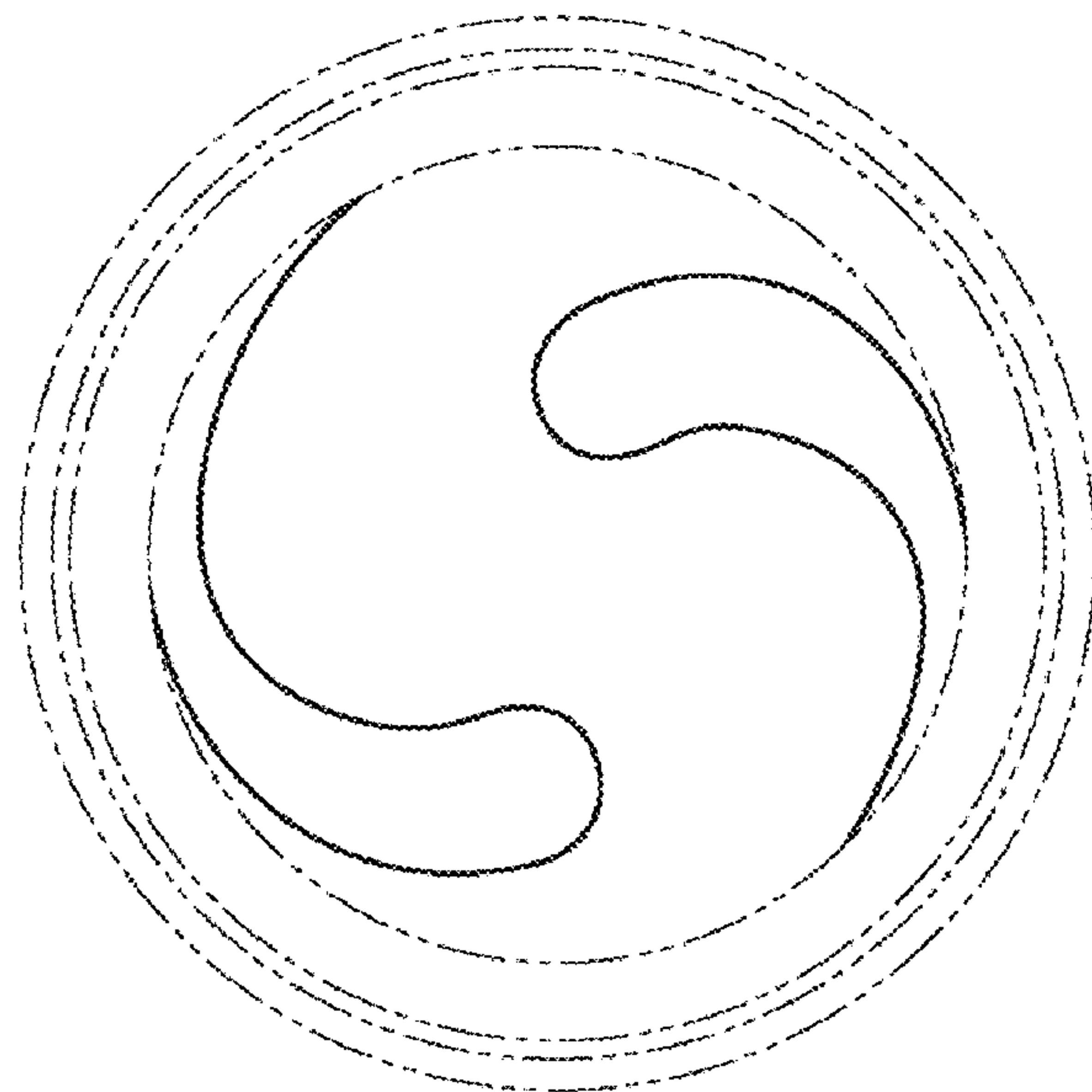

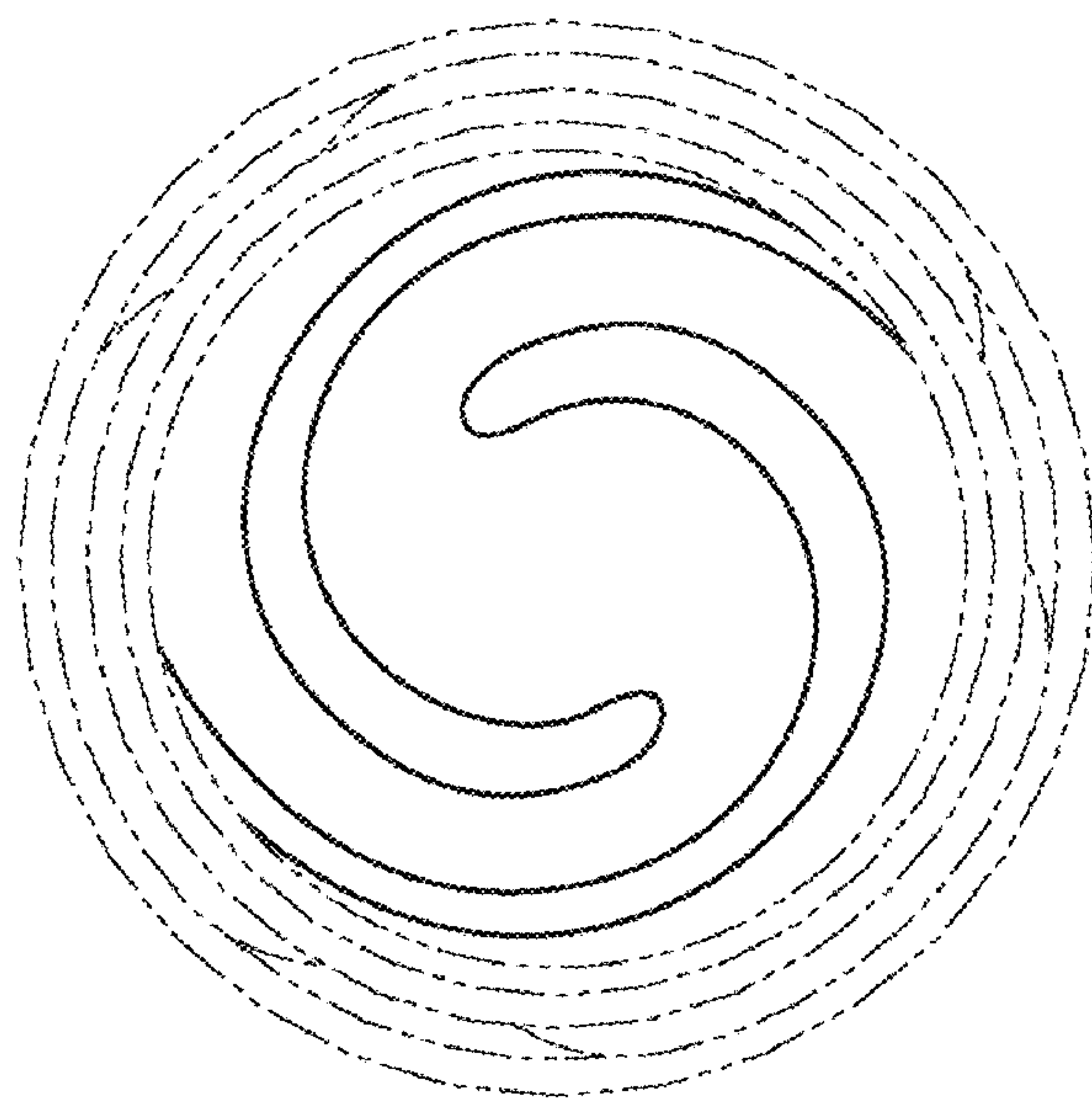
