FIG. 1 is an isometric view of the tool storage rack of my new design;

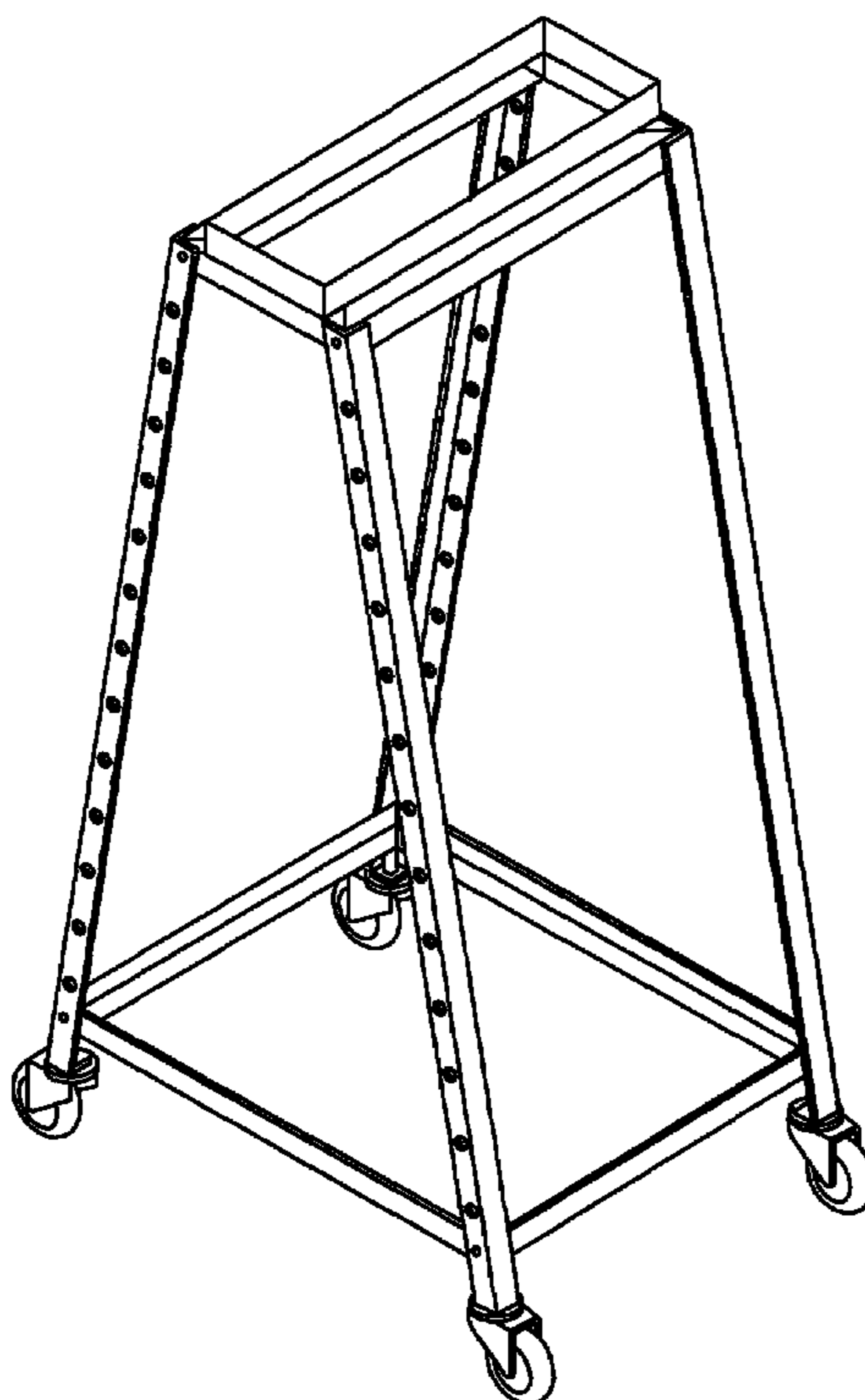
FIG. 2 is a front view thereof, the rear view being a mirror image;

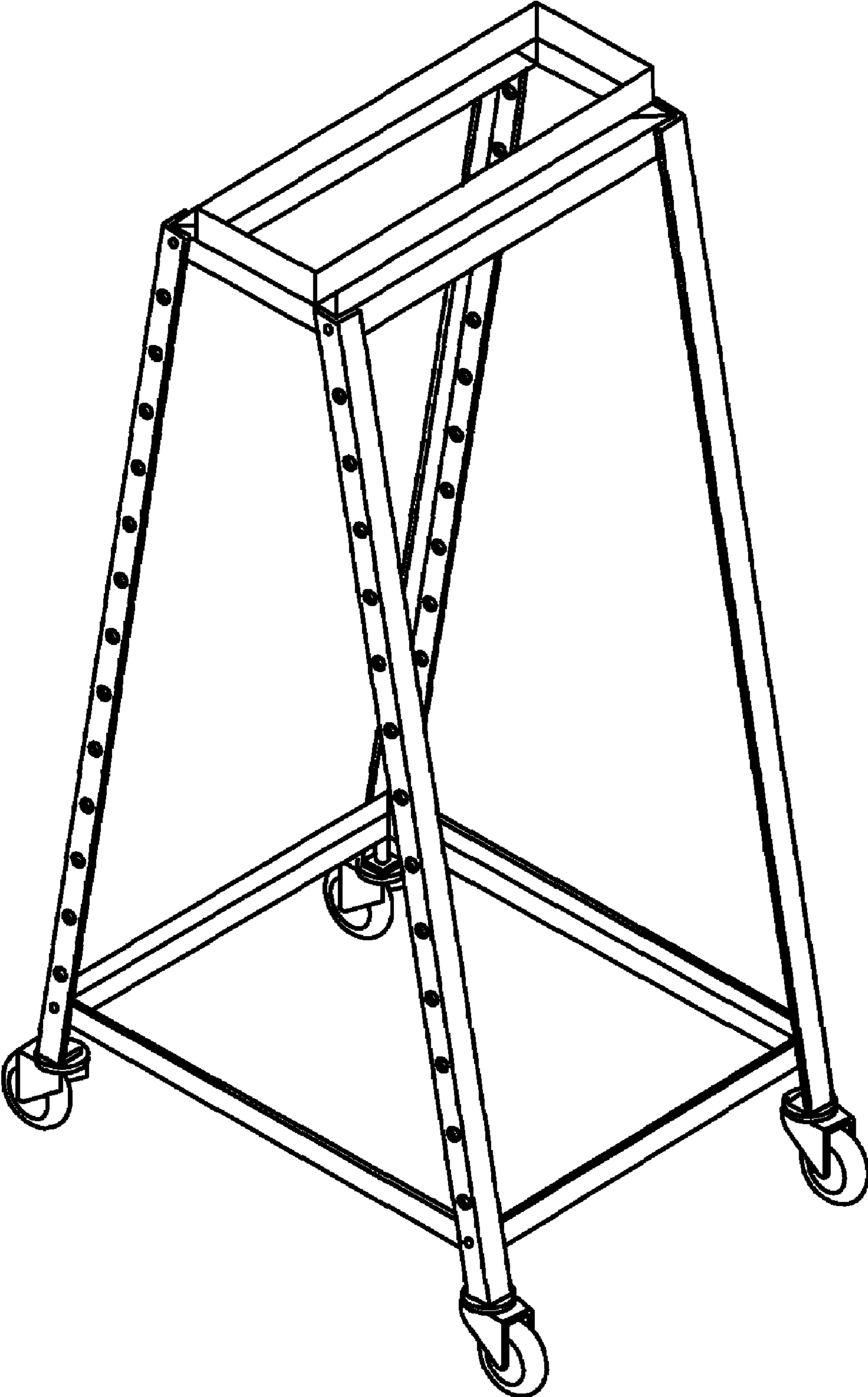

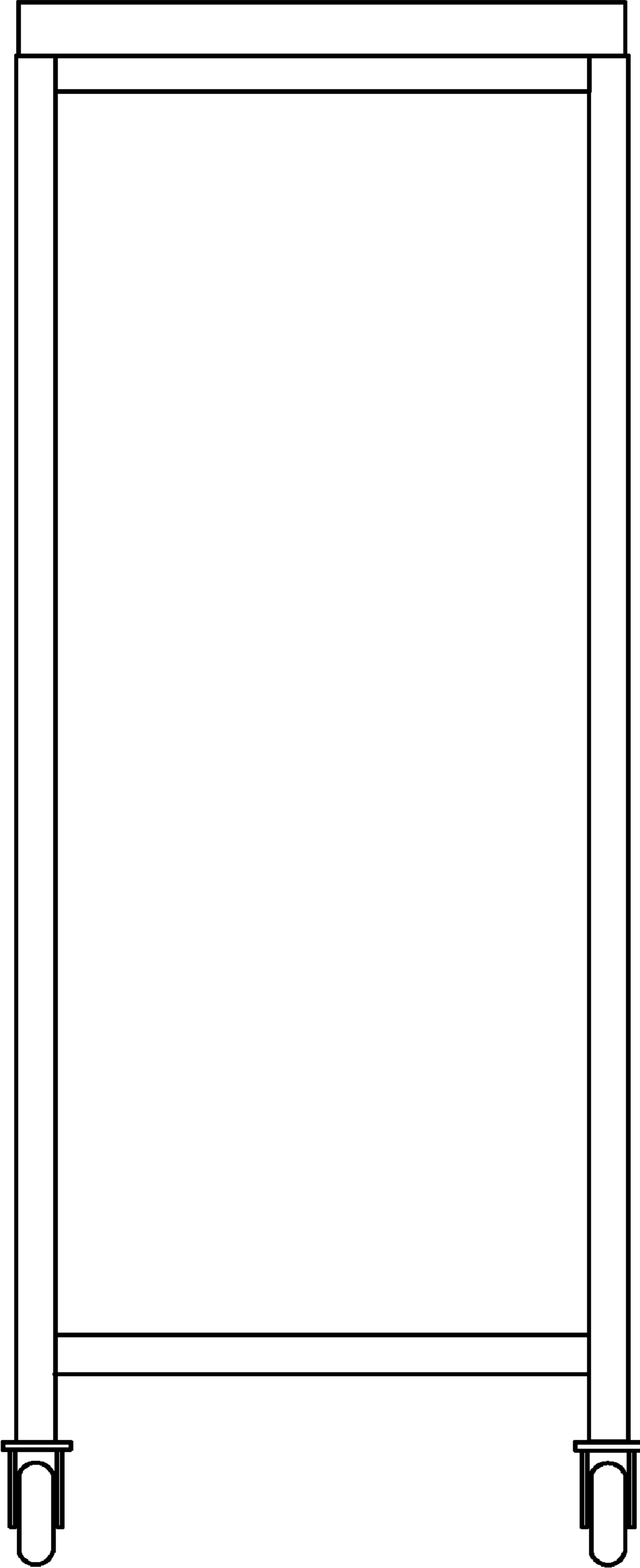

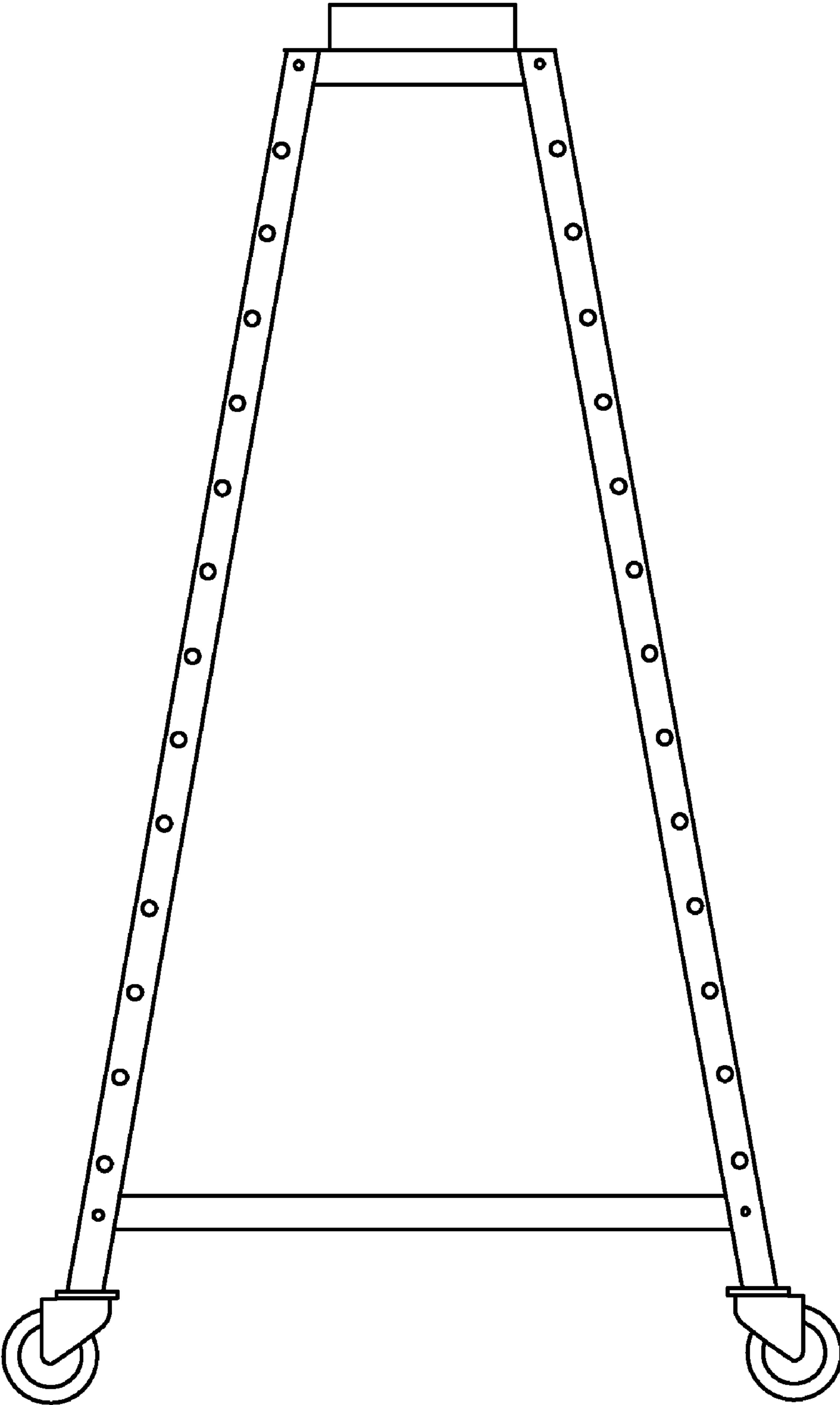

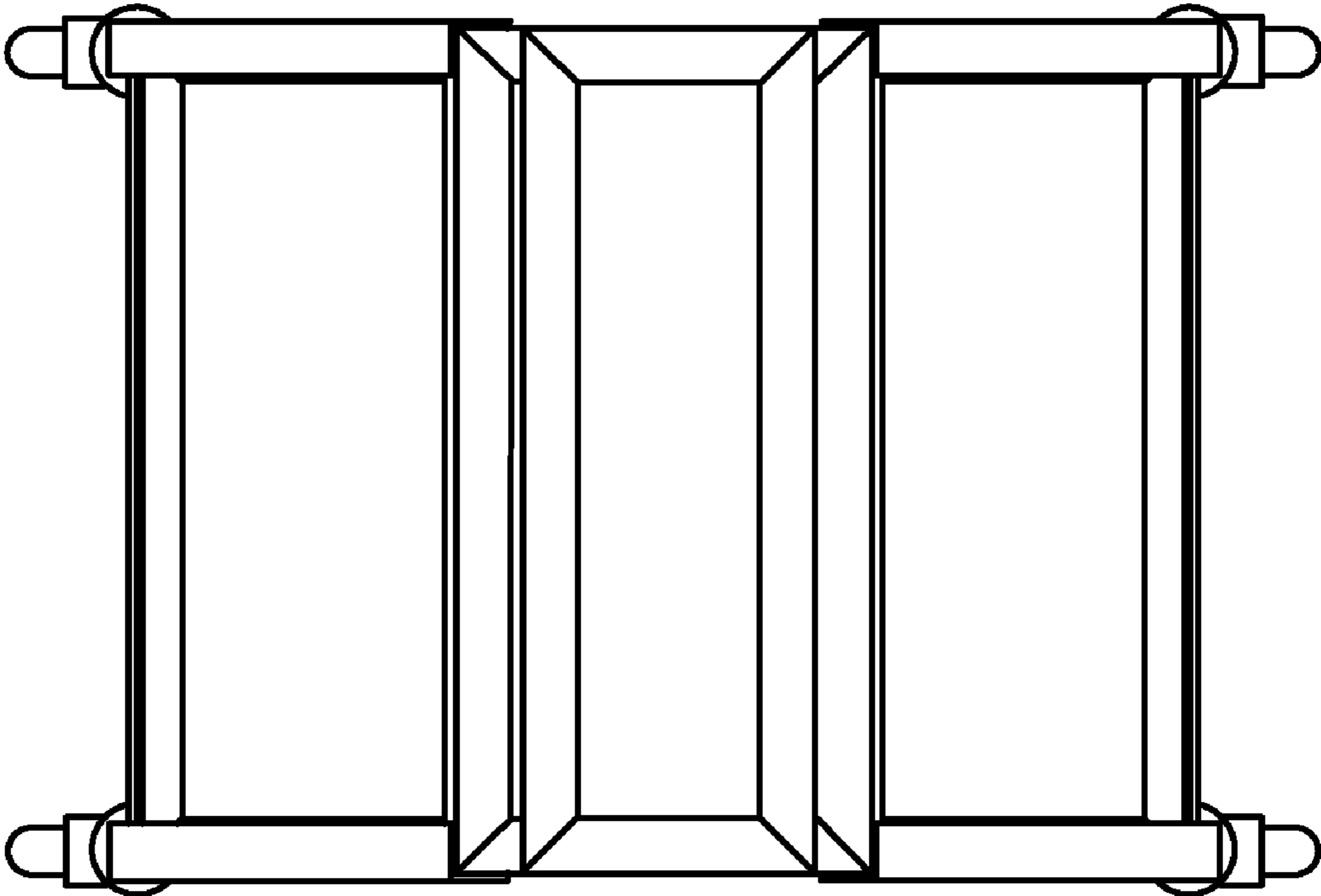

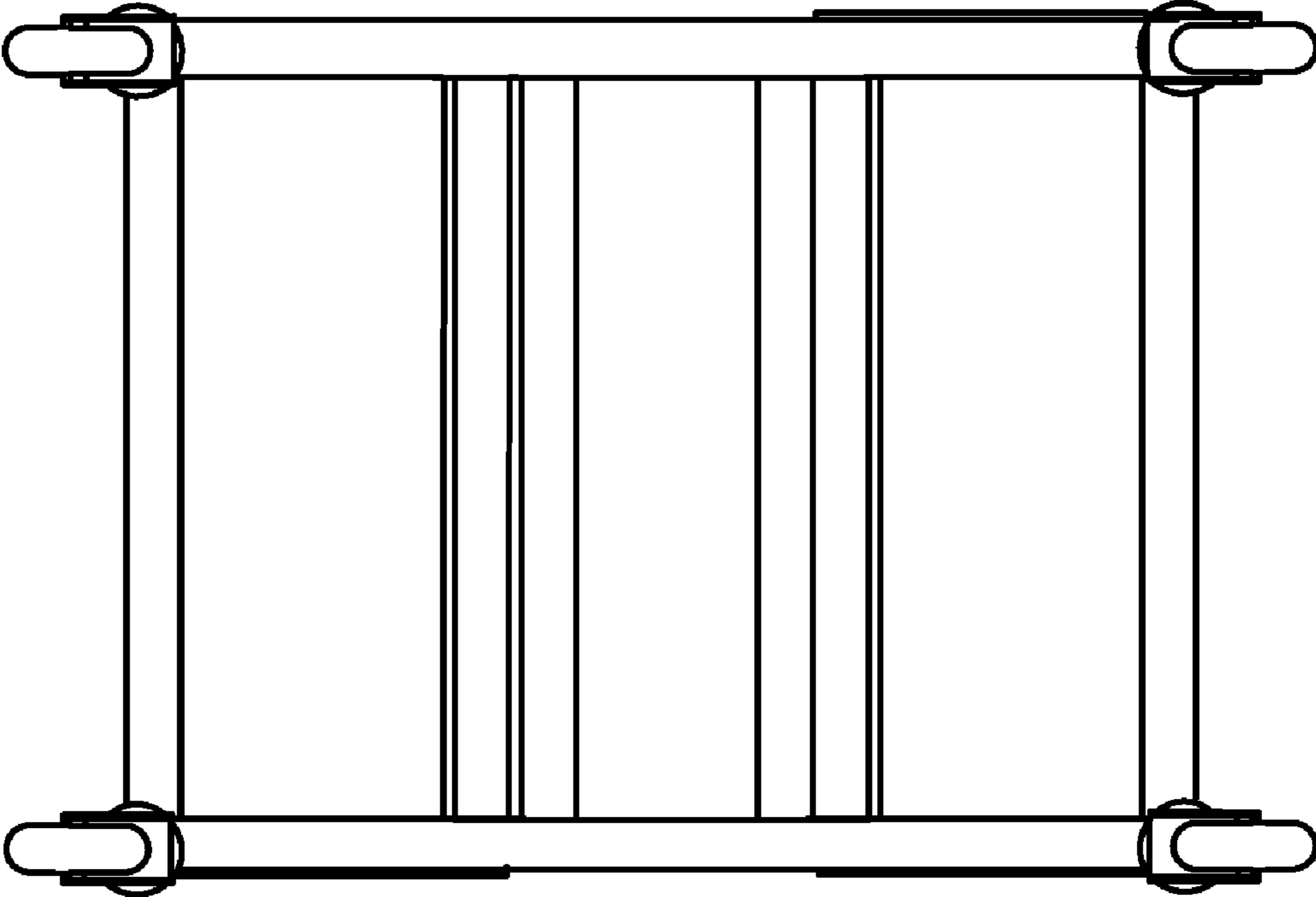
