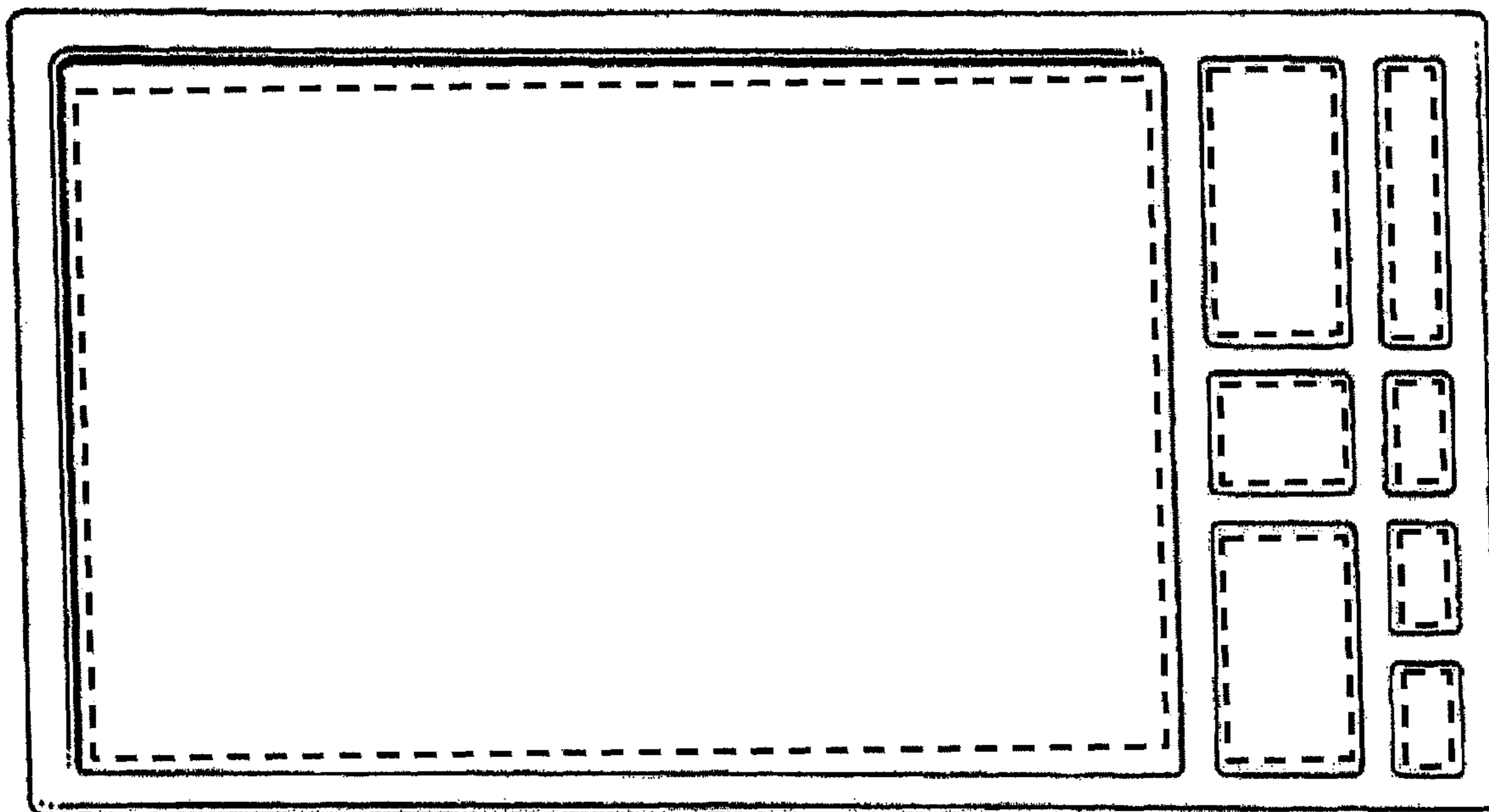
(57) **CLAIM**

The ornamental design for an infant dressing tray, as shown and described.

**DESCRIPTION**

FIG. 1 a right side elevation of the infant dressing tray;  
FIG. 2 is a left side elevation of the infant dressing tray;  
FIG. 3 is an end view of the infant dressing tray;  
FIG. 4 is an opposite end view of the infant dressing tray;  
FIG. 5 is a top plan view of an infant dressing tray in accordance with my invention; and,  
FIG. 6 is a bottom plan view of the infant dressing tray.

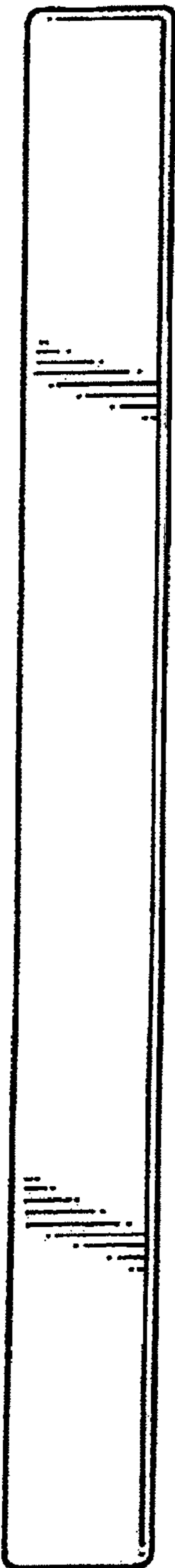

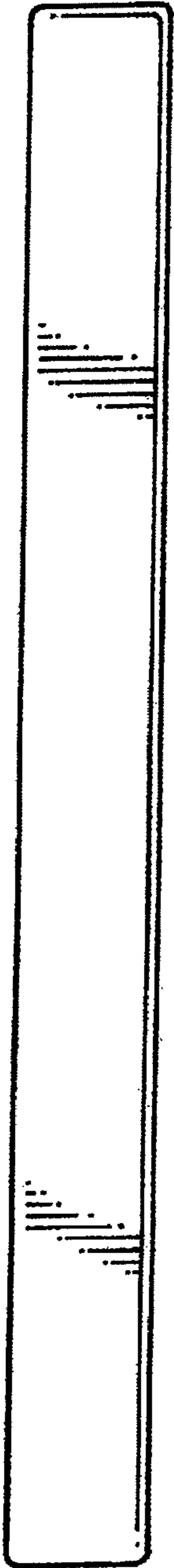

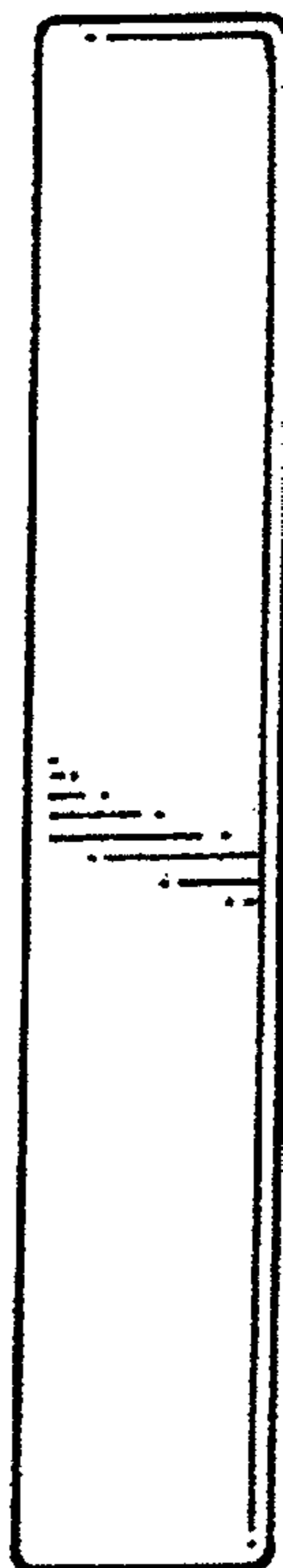

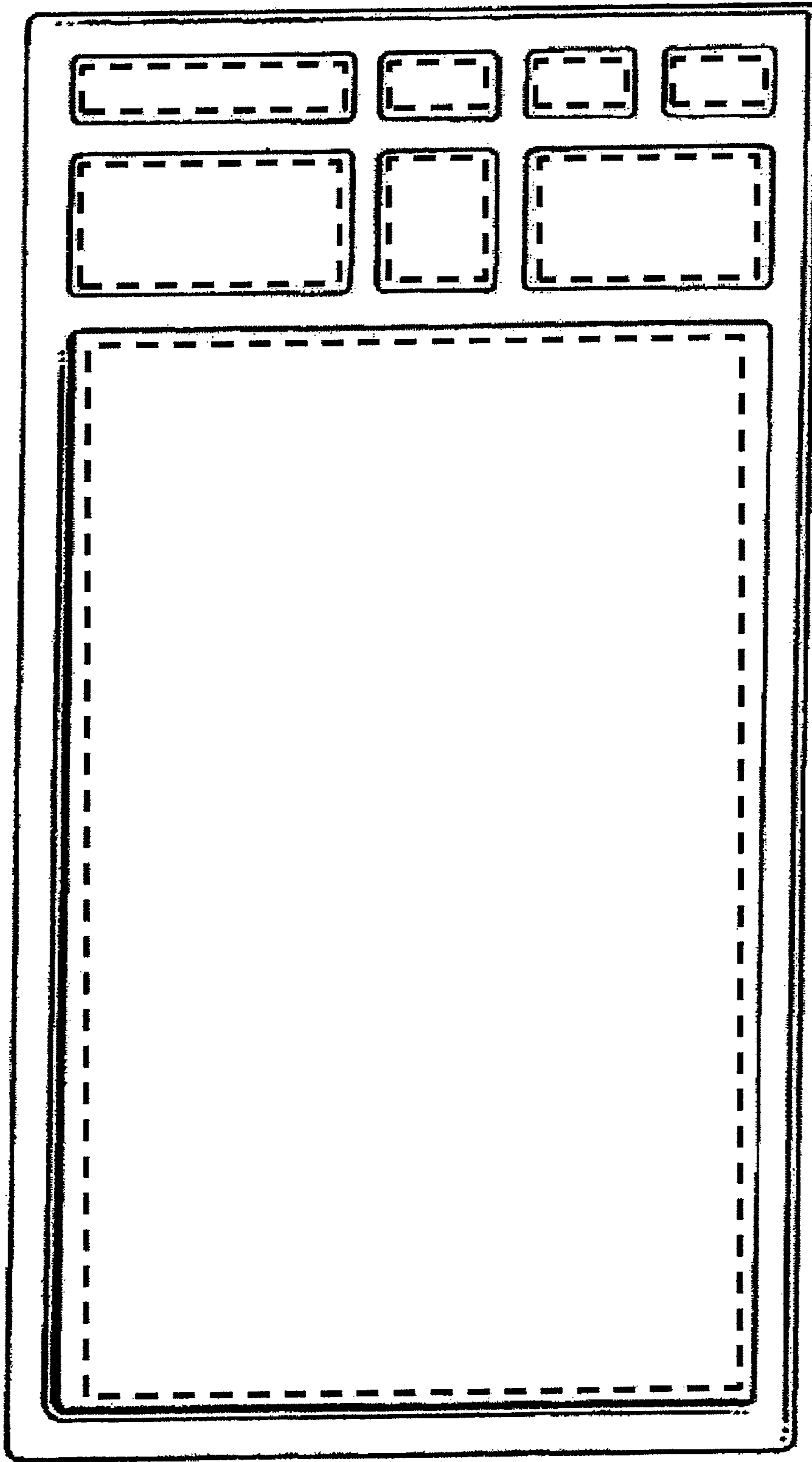

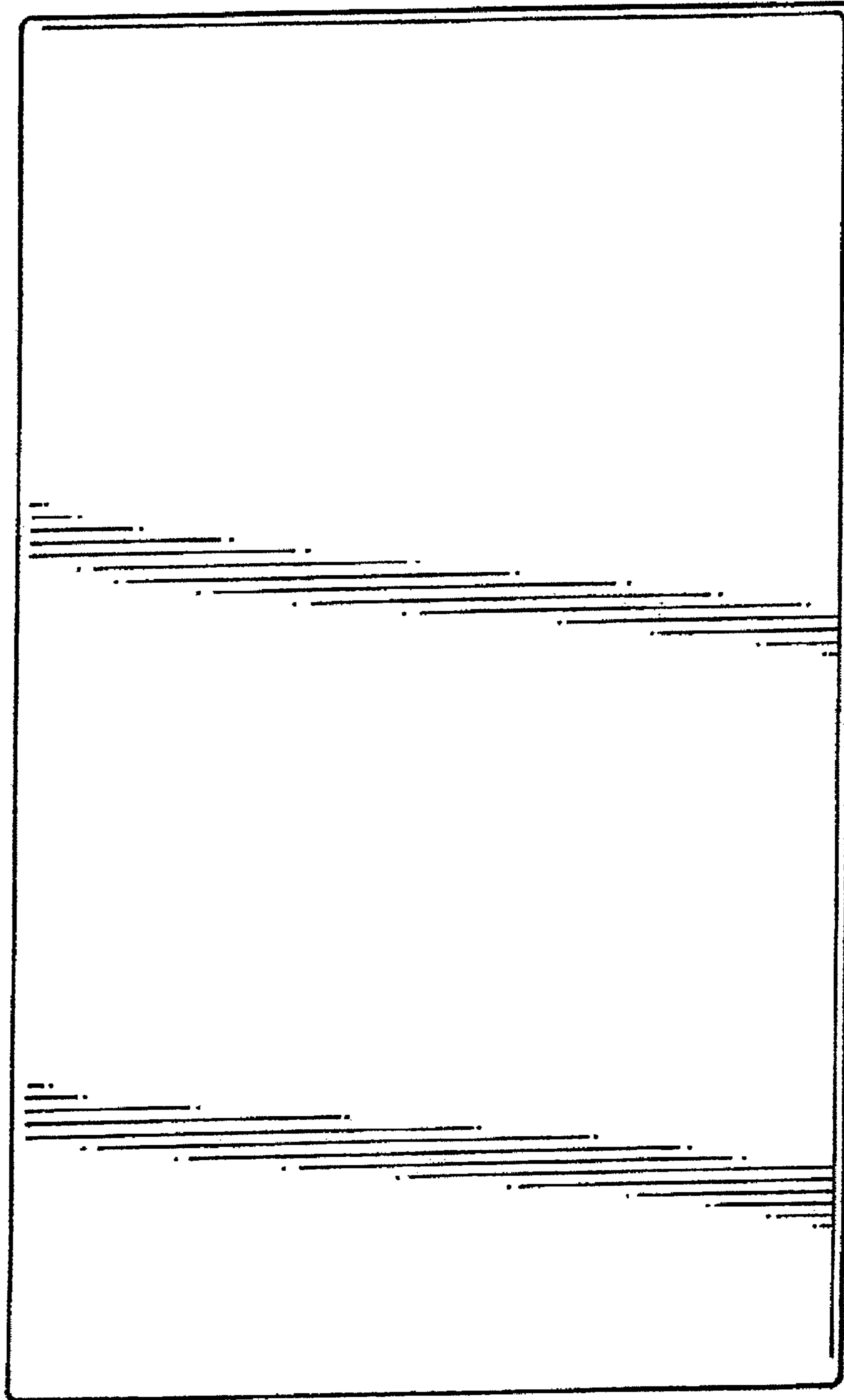
