DESCRIPTION

FIG. 1 - is a perspective view of the shelf divider showing the design;

FIG. 2 - is a front view of the shelf divider of FIG. 1;

FIG. 3 - is a back view of the shelf divider of FIG. 1;

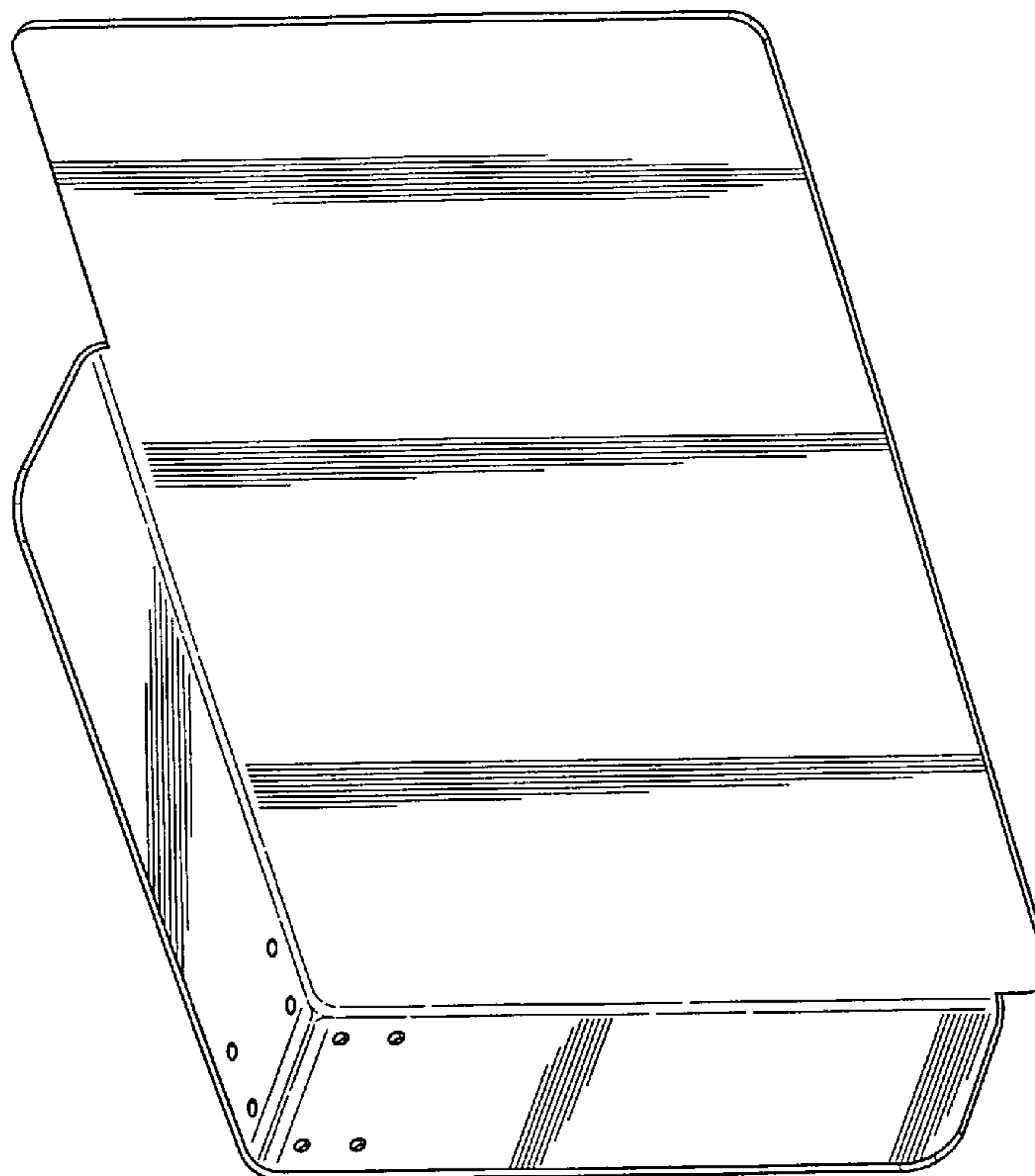
FIG. 4 - is a right side view of the shelf divider of FIG. 1;

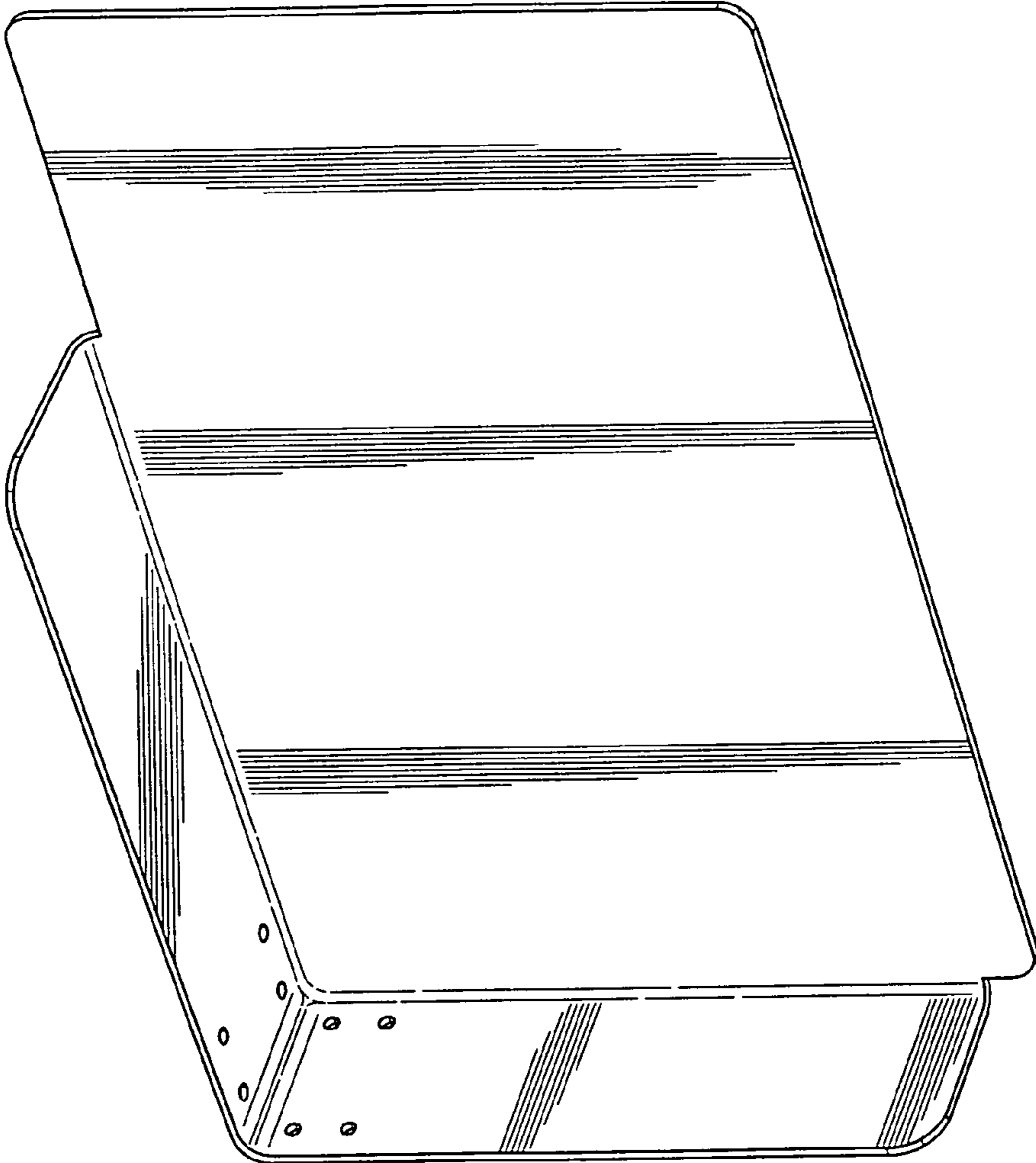

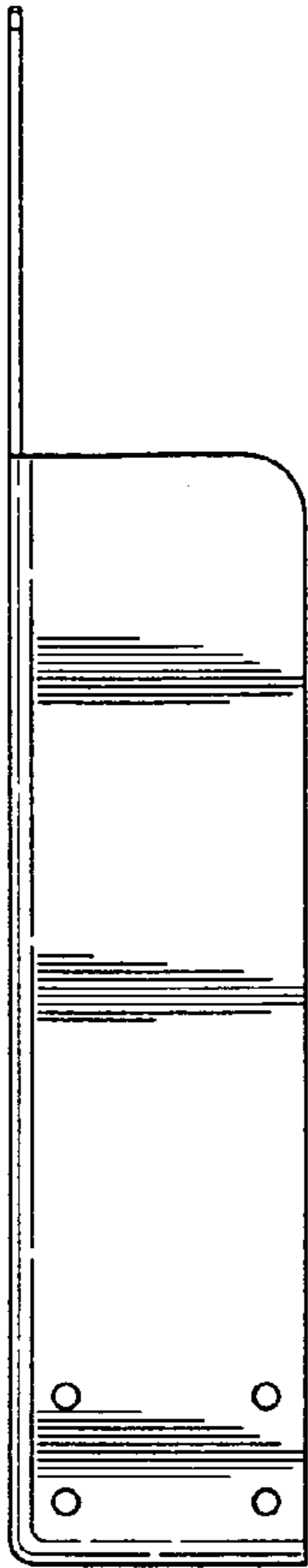

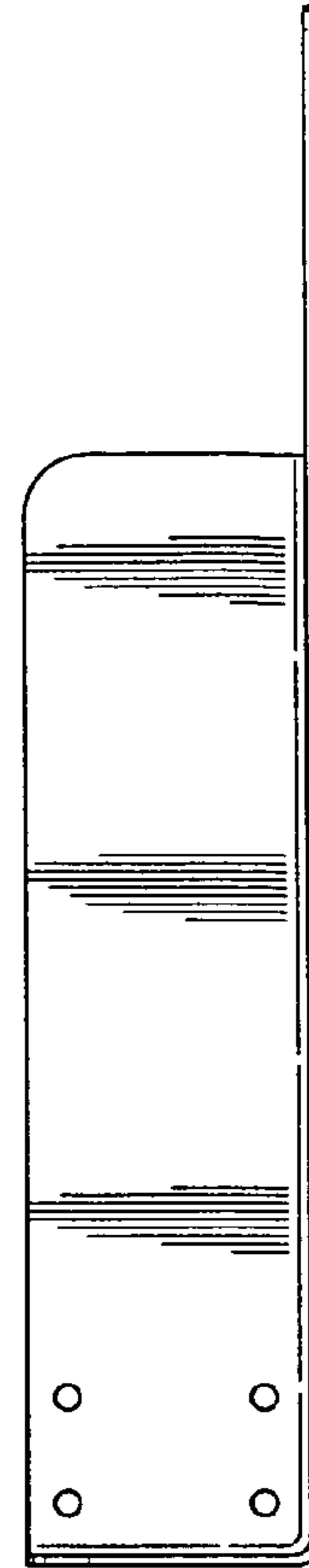

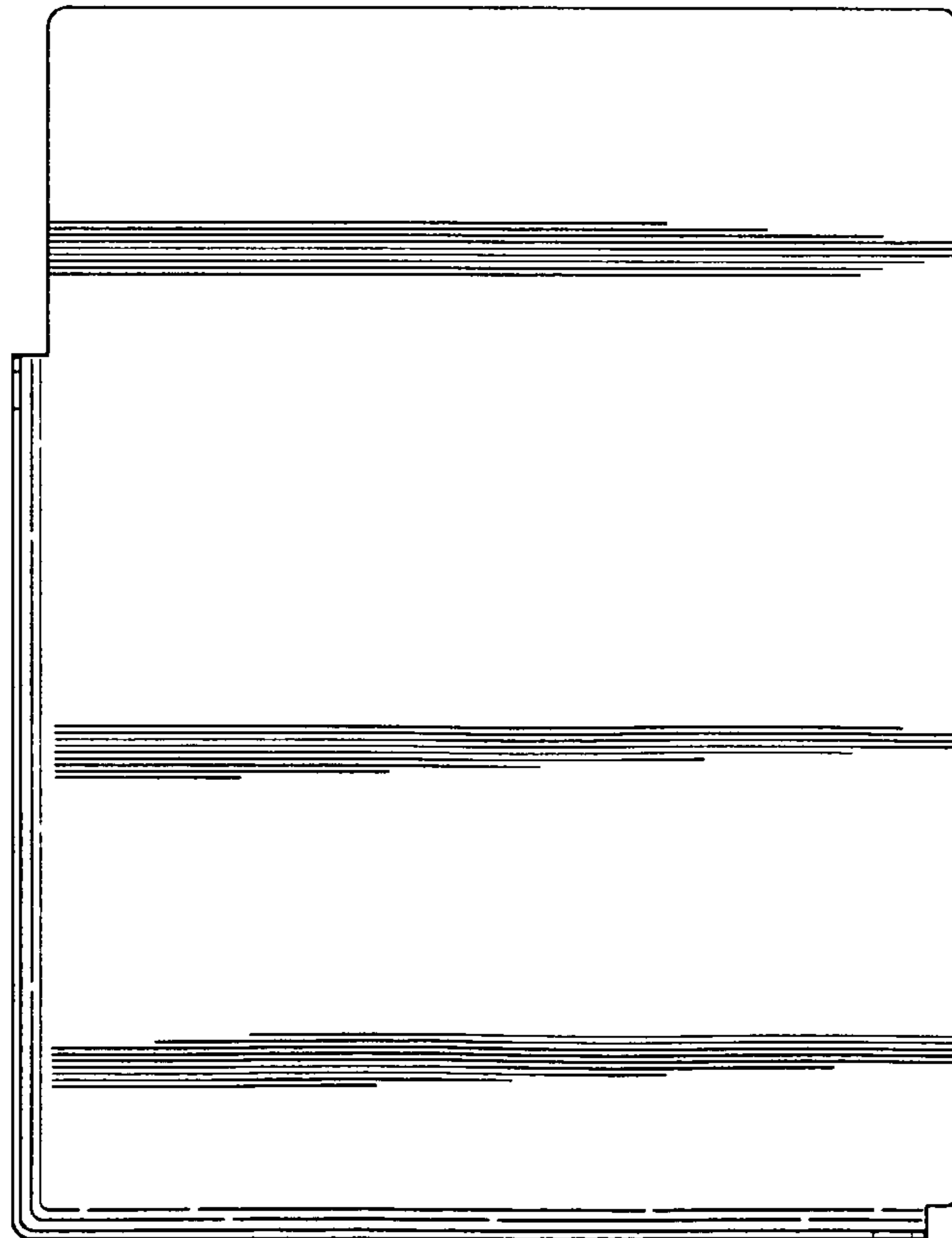

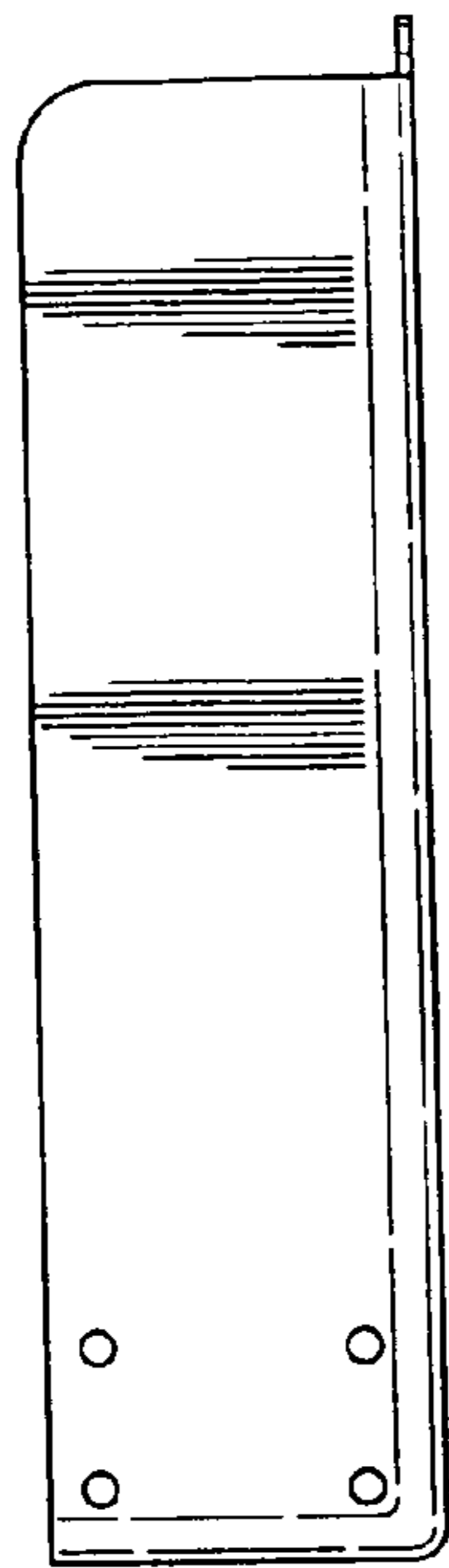

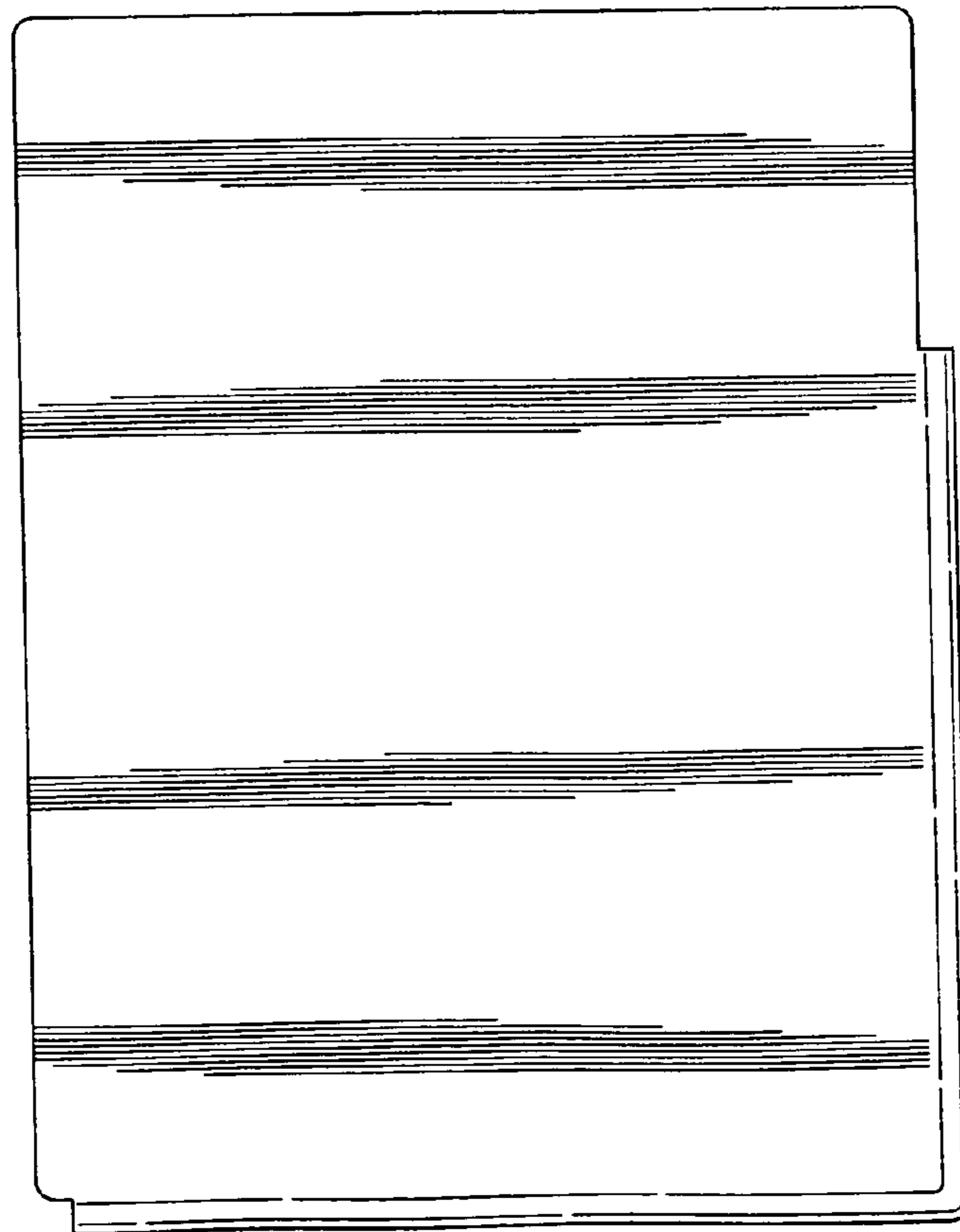
