FIG. 4 is a right side elevational view thereof,

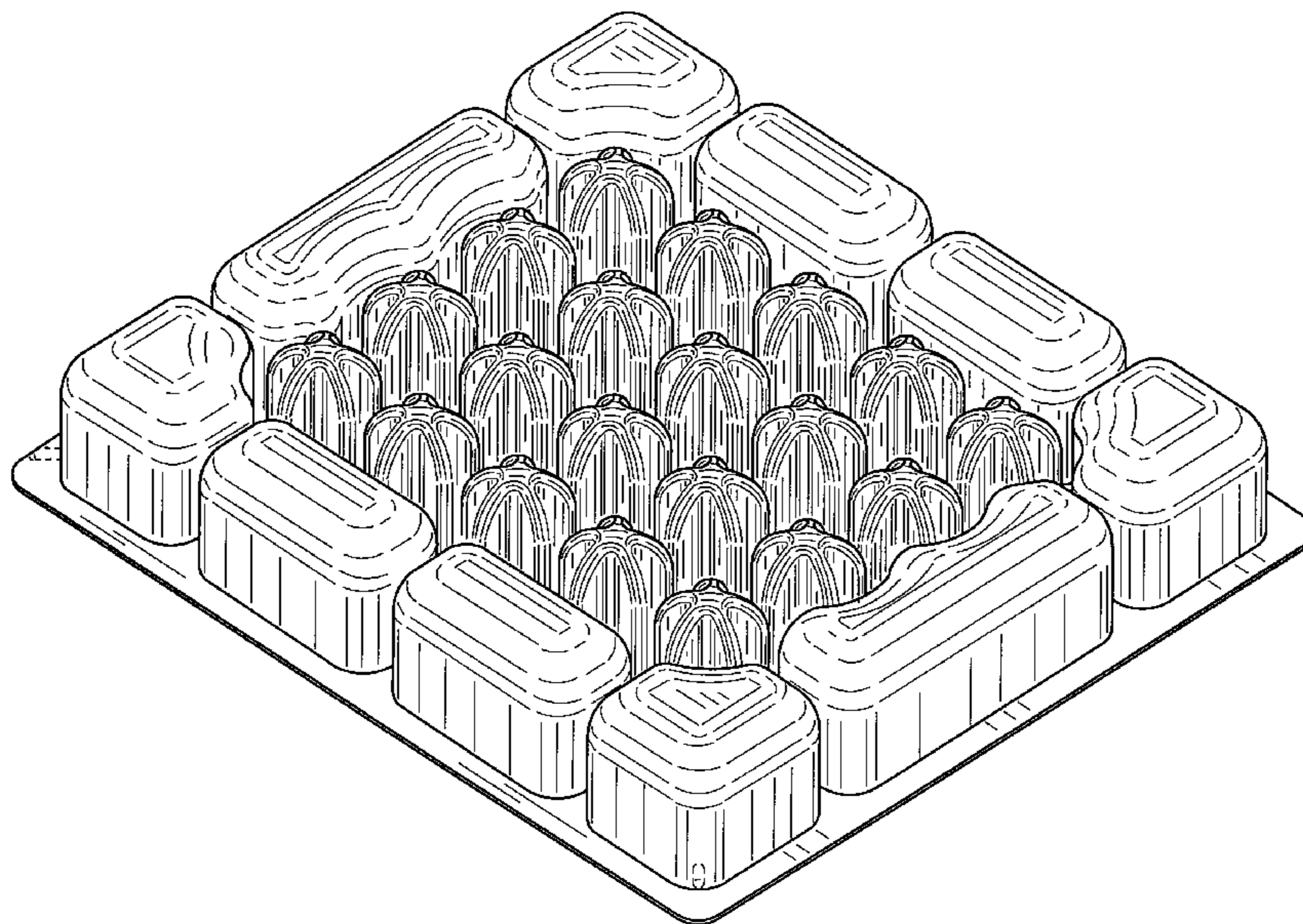
FIG. 5 is the left side elevational view thereof; and

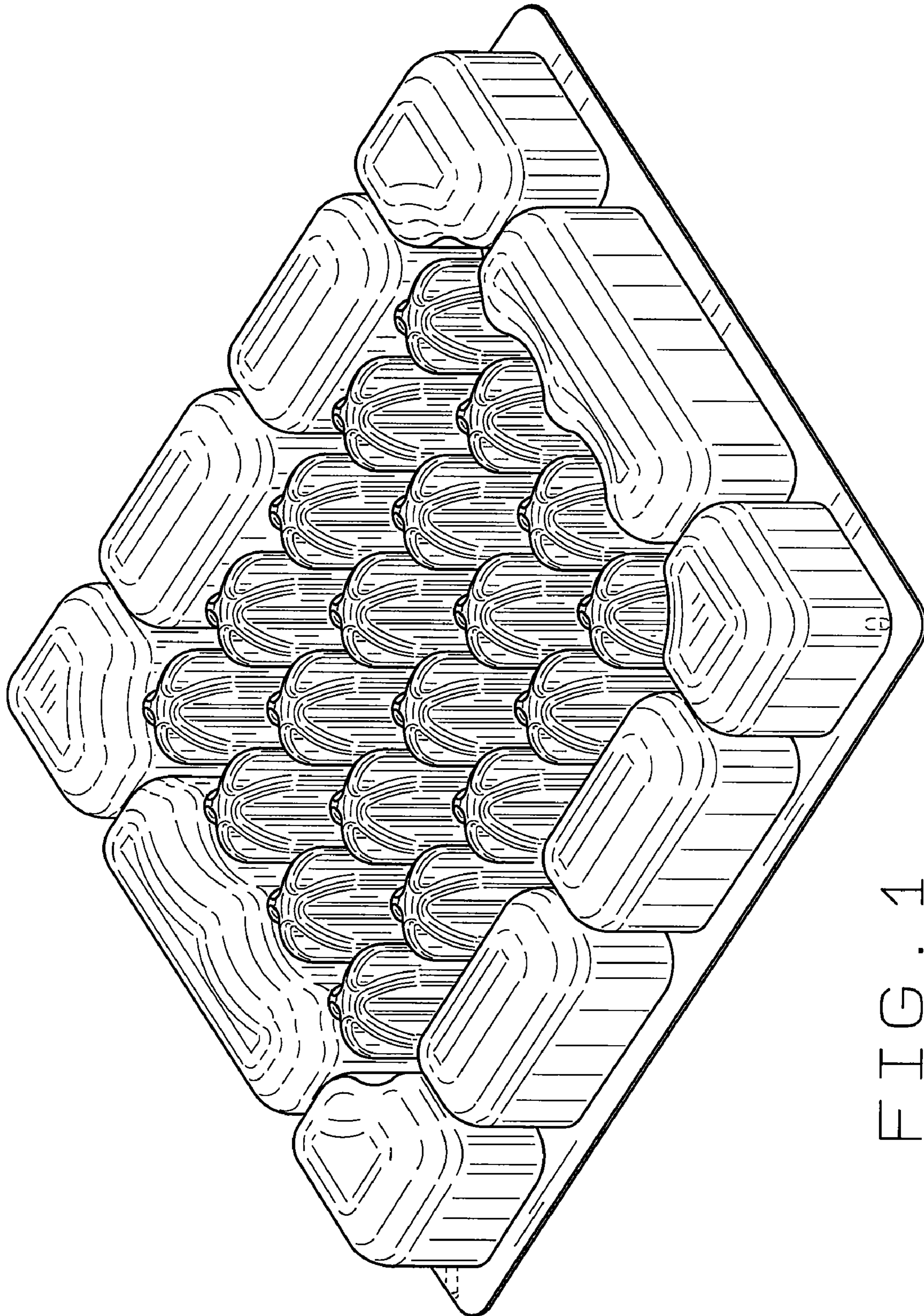

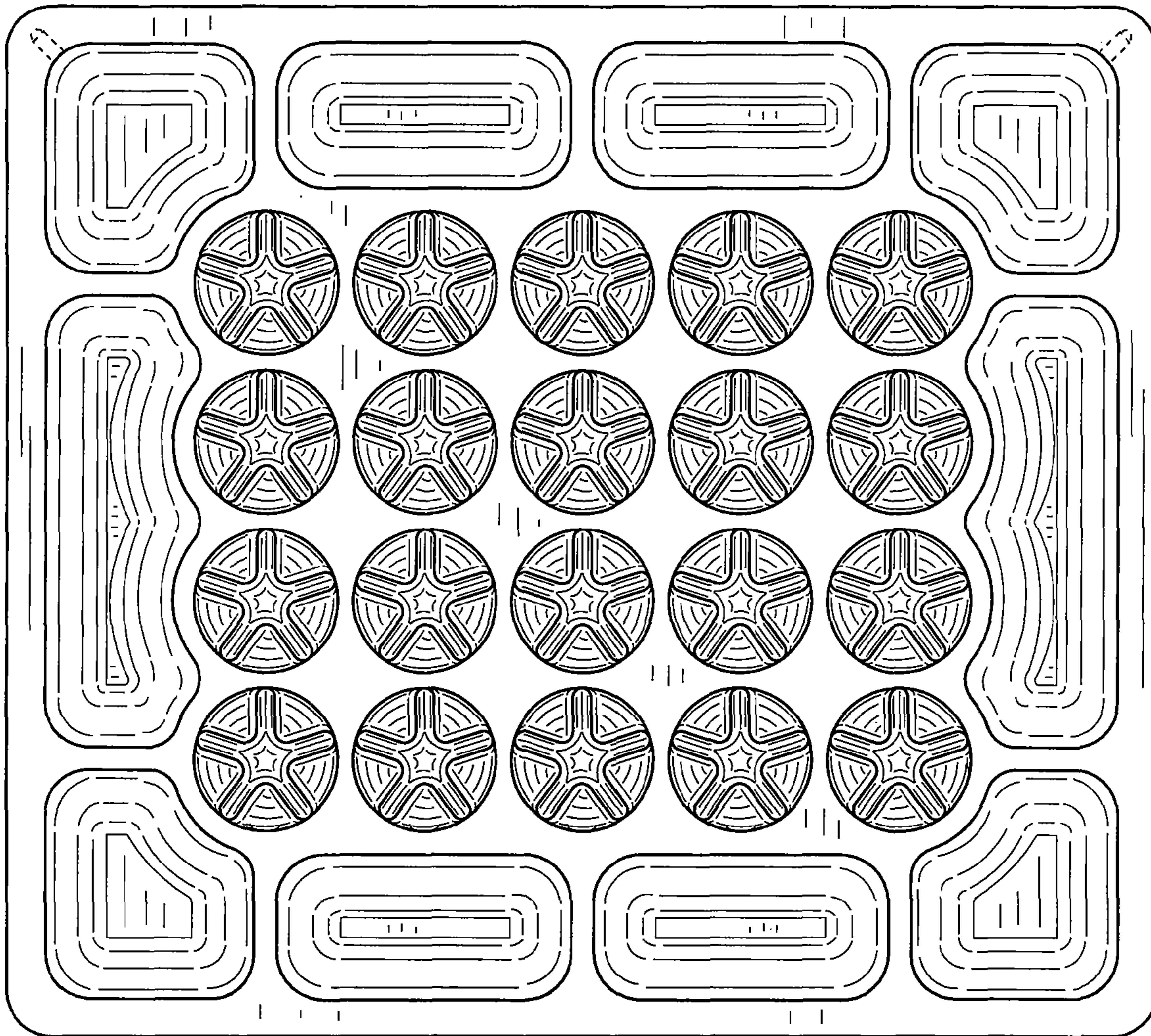

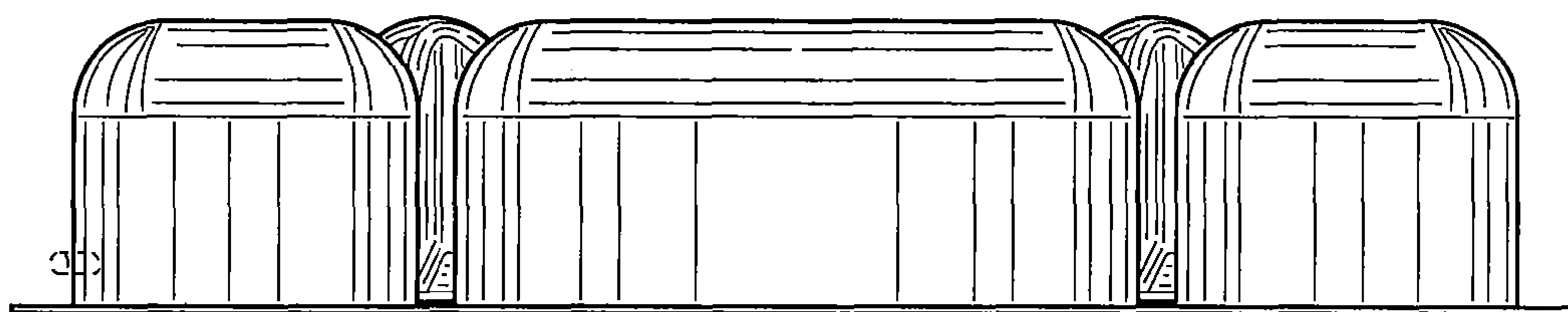

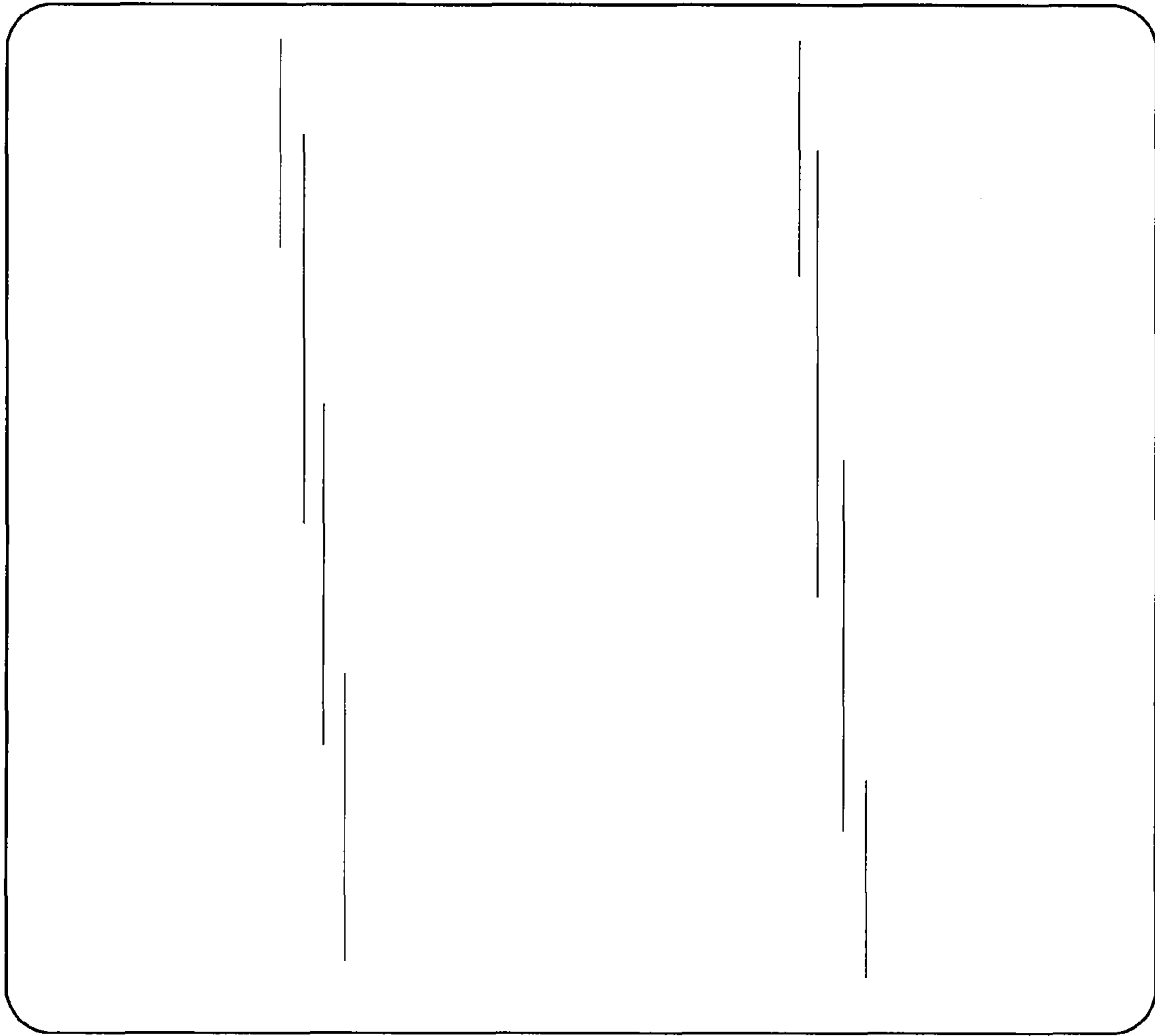

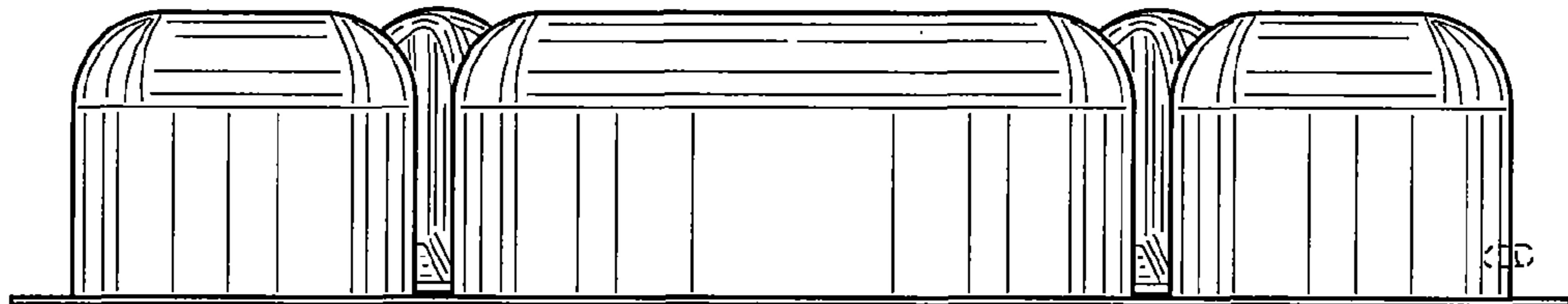

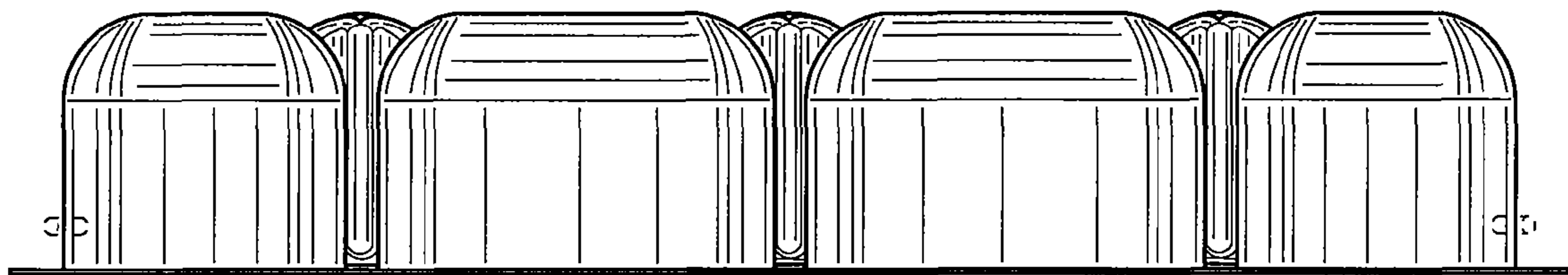

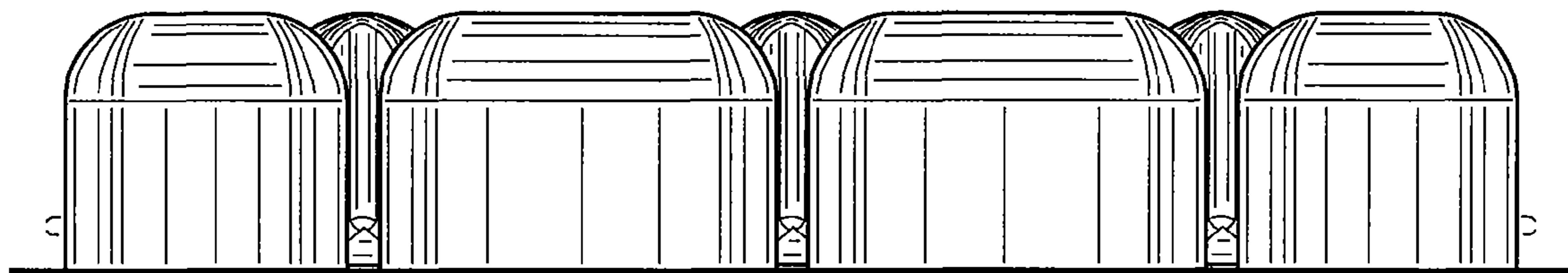
