The ornamental design for a plate, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a forward perspective view of an embodiment of a design for a plate.

FIG. 2 is a rearward perspective view of the embodiment of a design of FIG. 1.

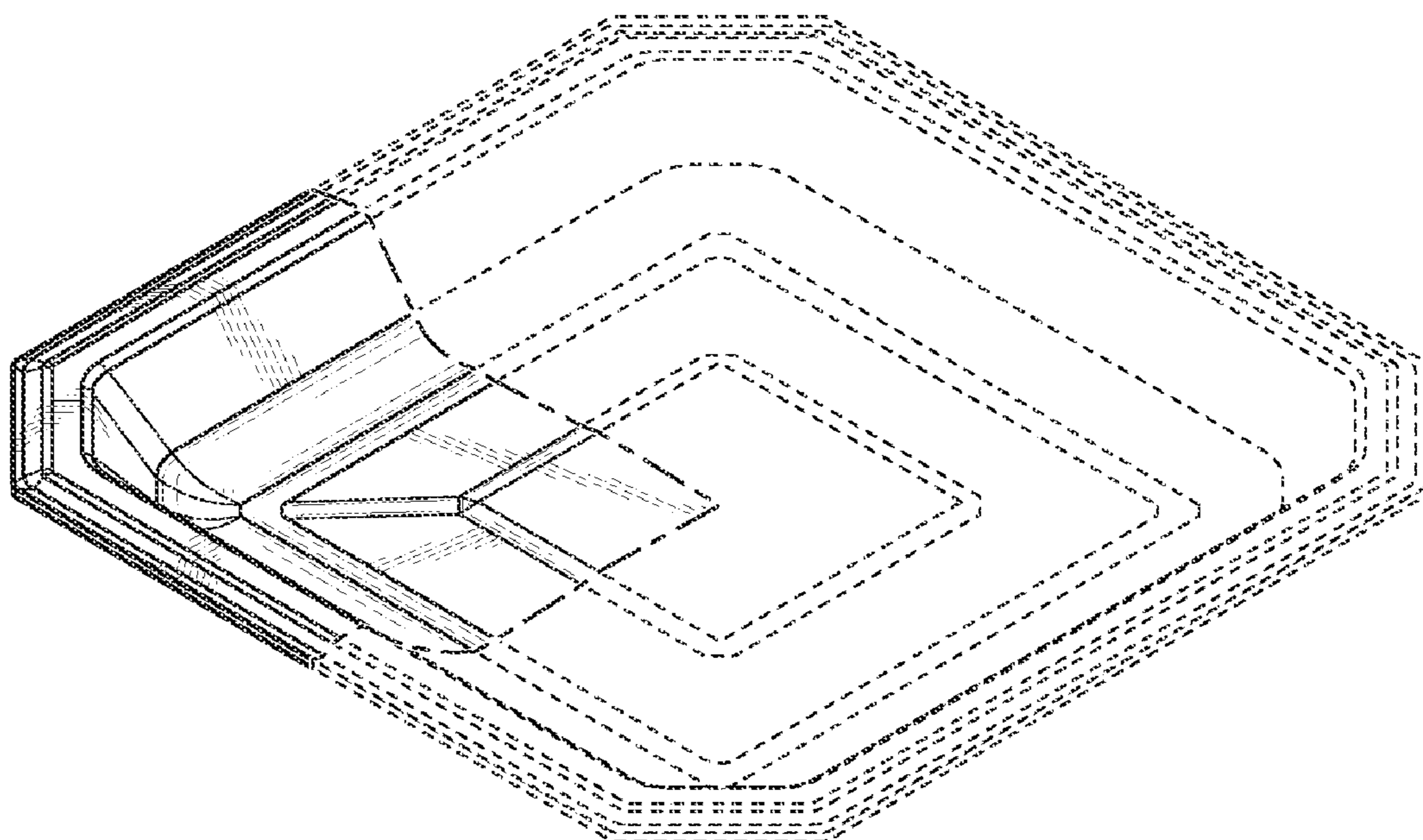
FIG. 3 is a front plan view of the embodiment of a design of FIG. 1.

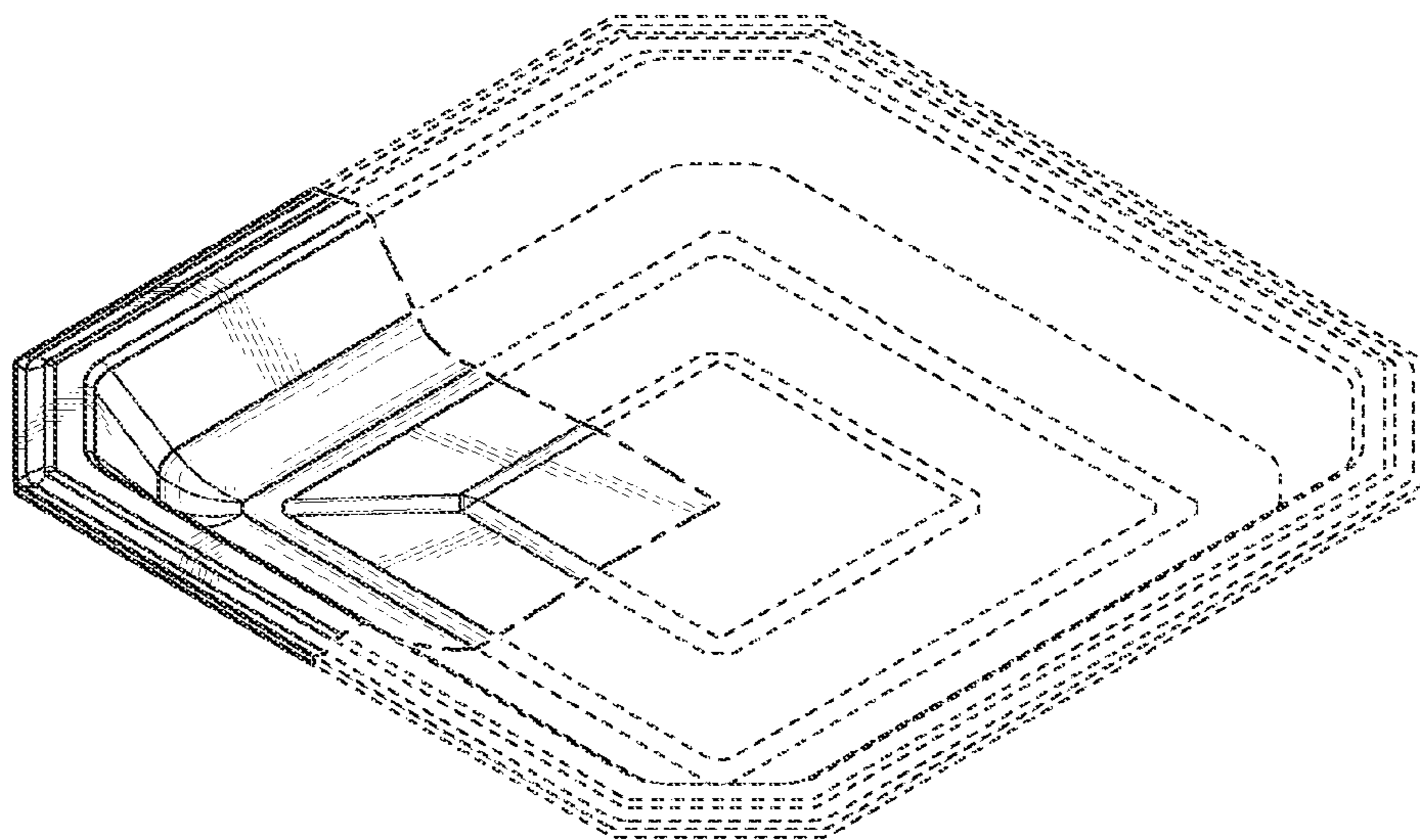

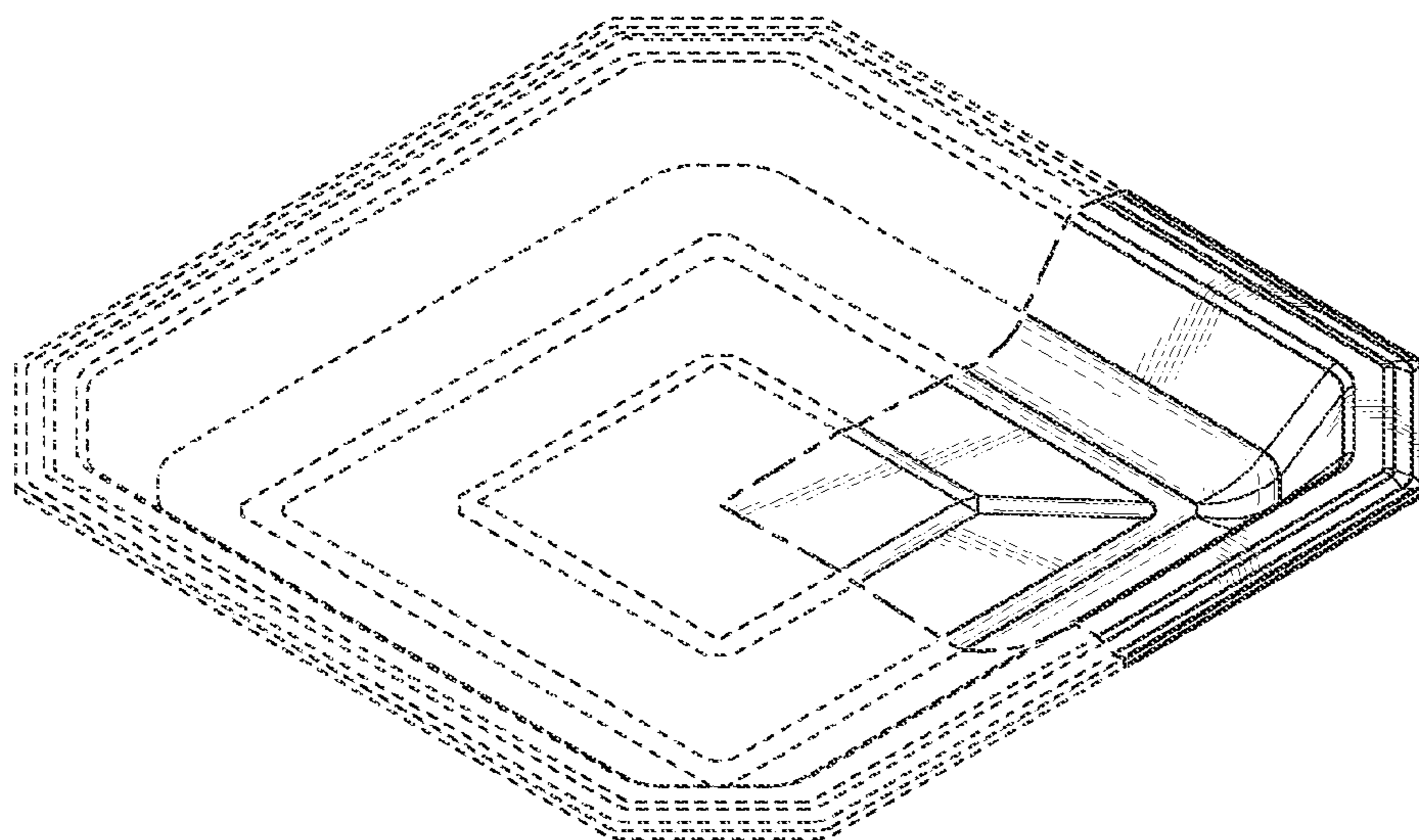
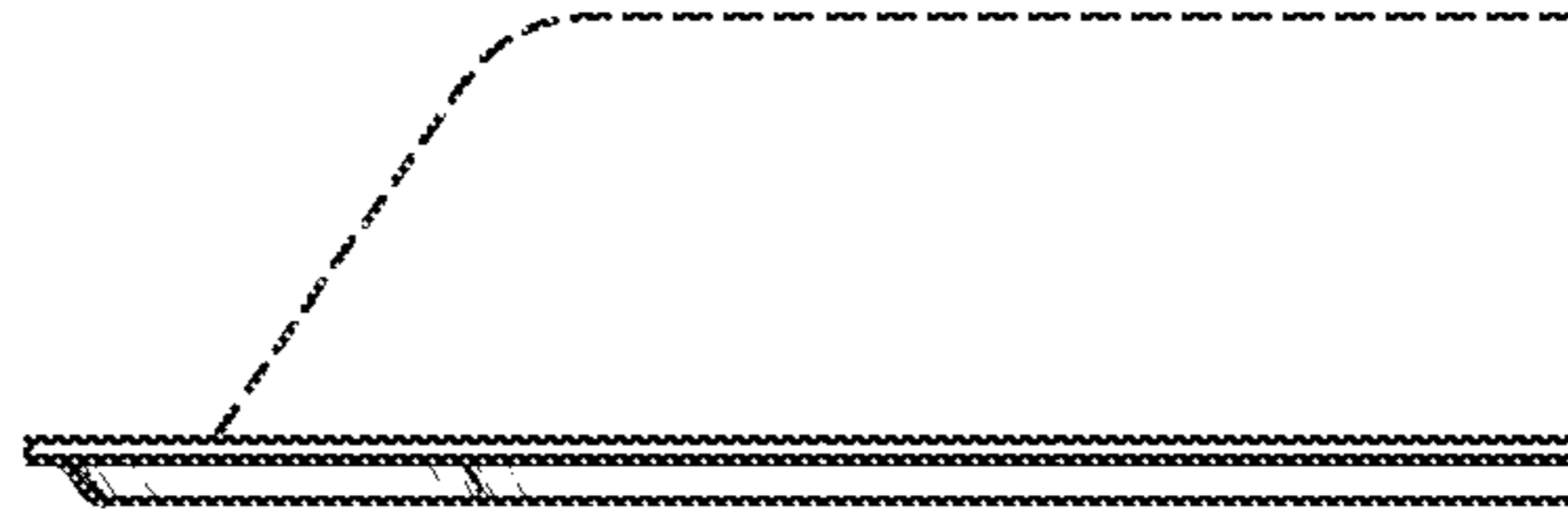
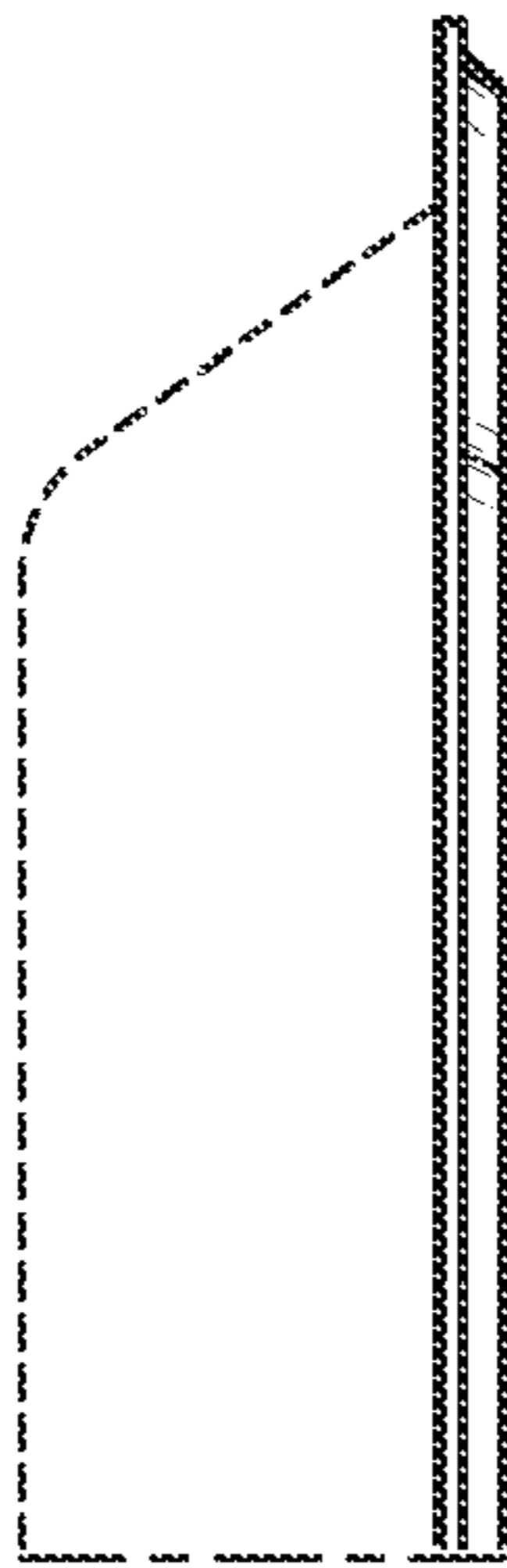


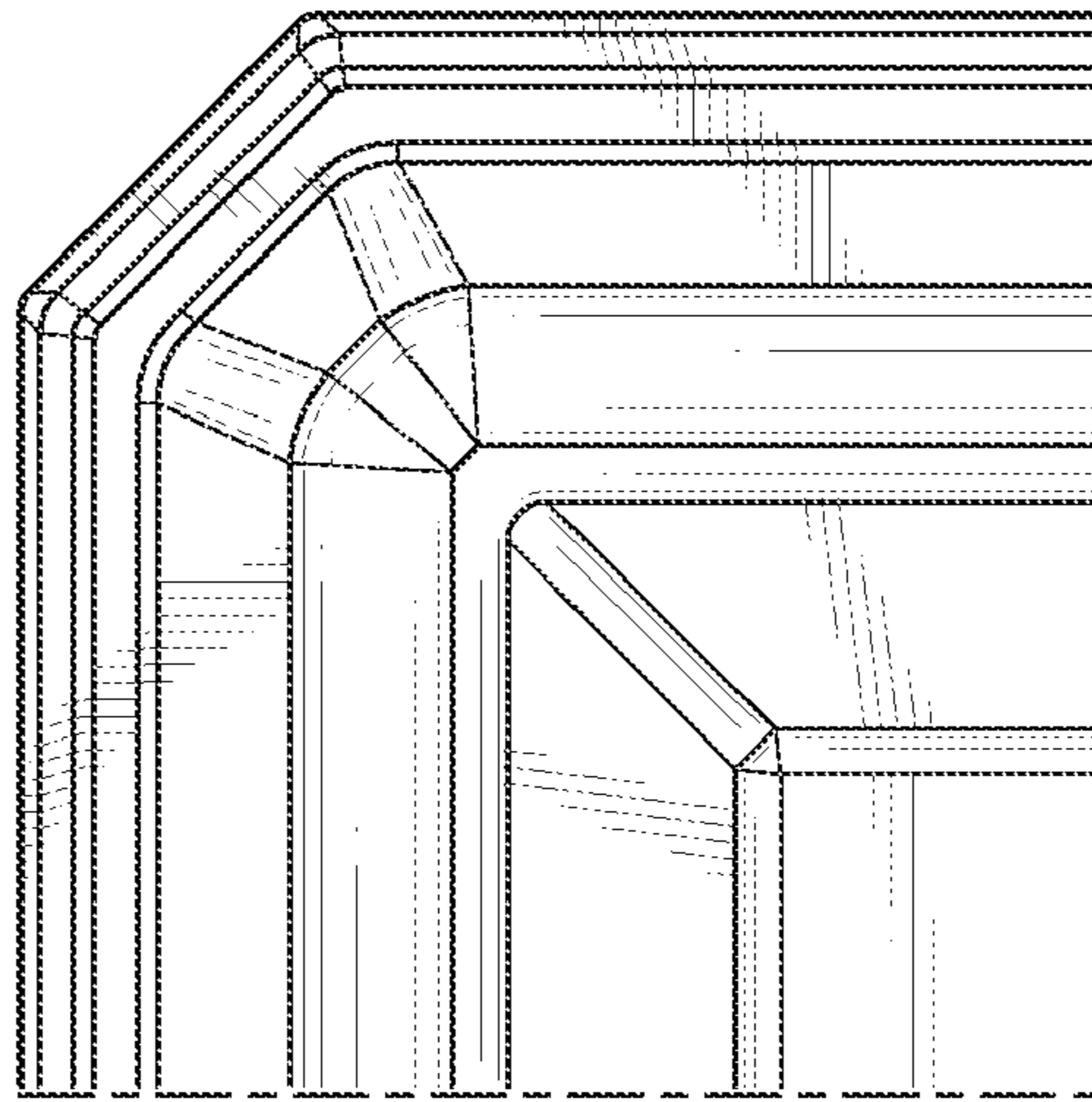
