DESCRIPTION

FIG. 1 is a top, rear and left side perspective view of a container for food showing my new design;

FIG. 2 is a bottom, front, and left side perspective view thereof;

FIG. 3 is a front elevation view thereof;

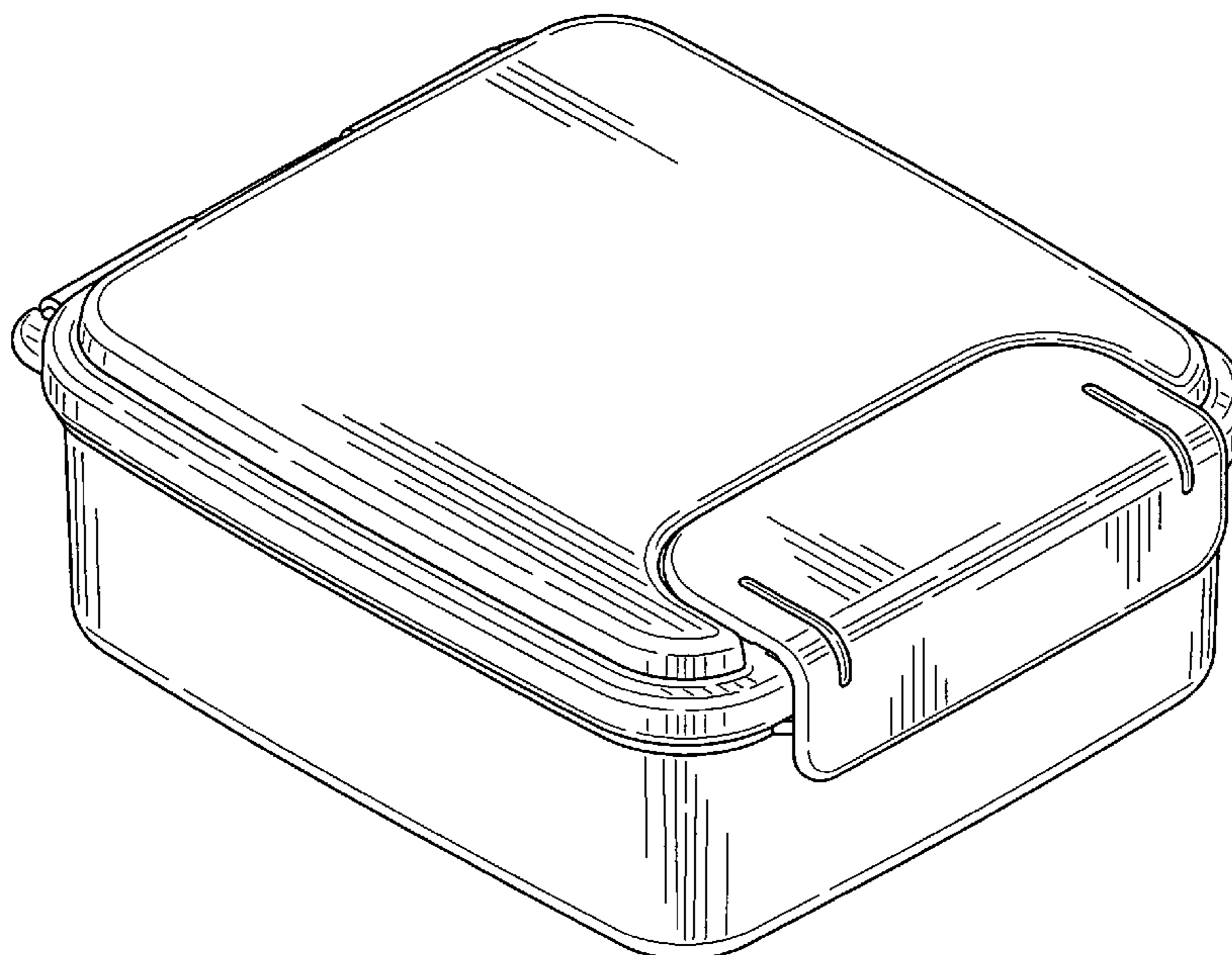
FIG. 4 is a rear elevation view thereof;

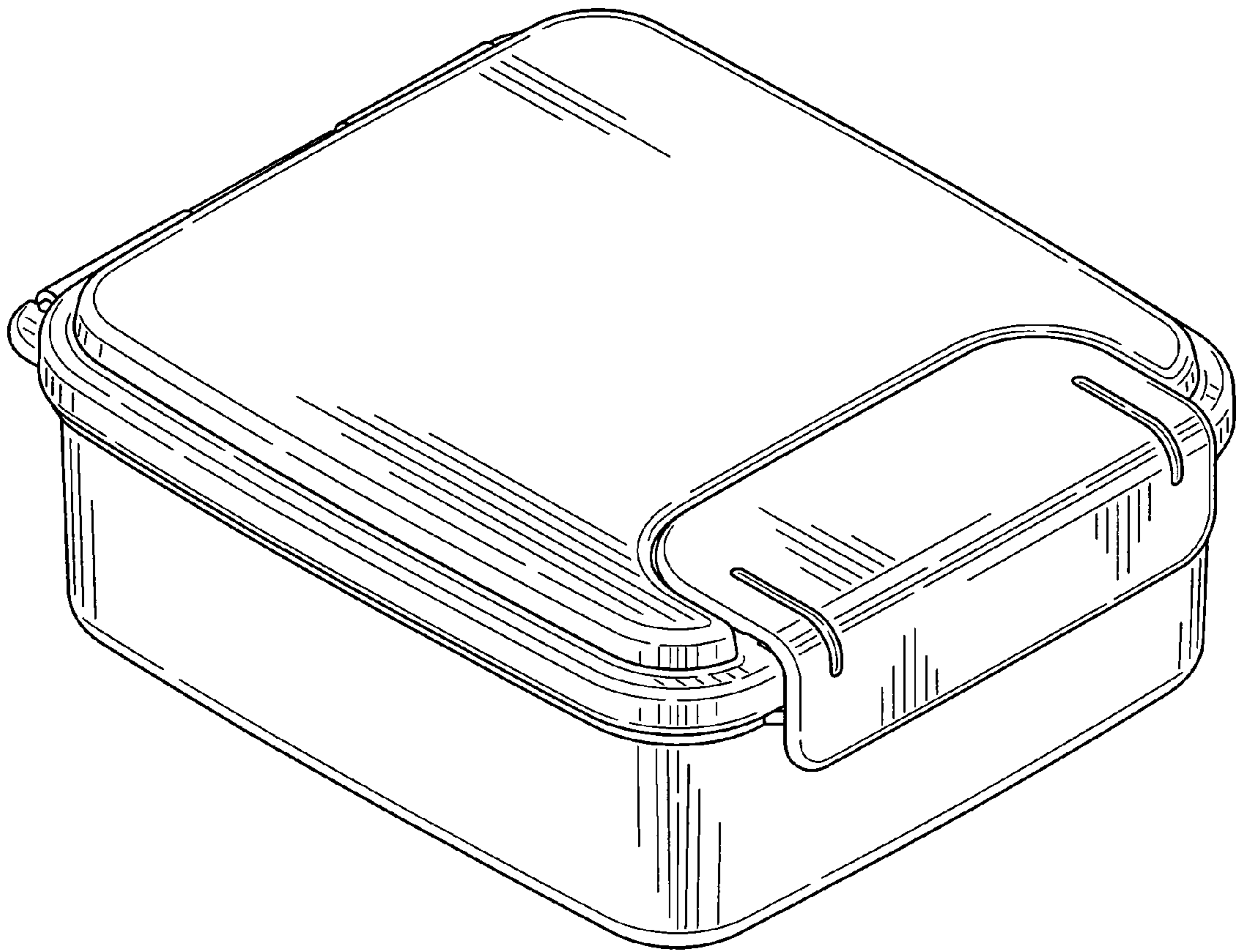

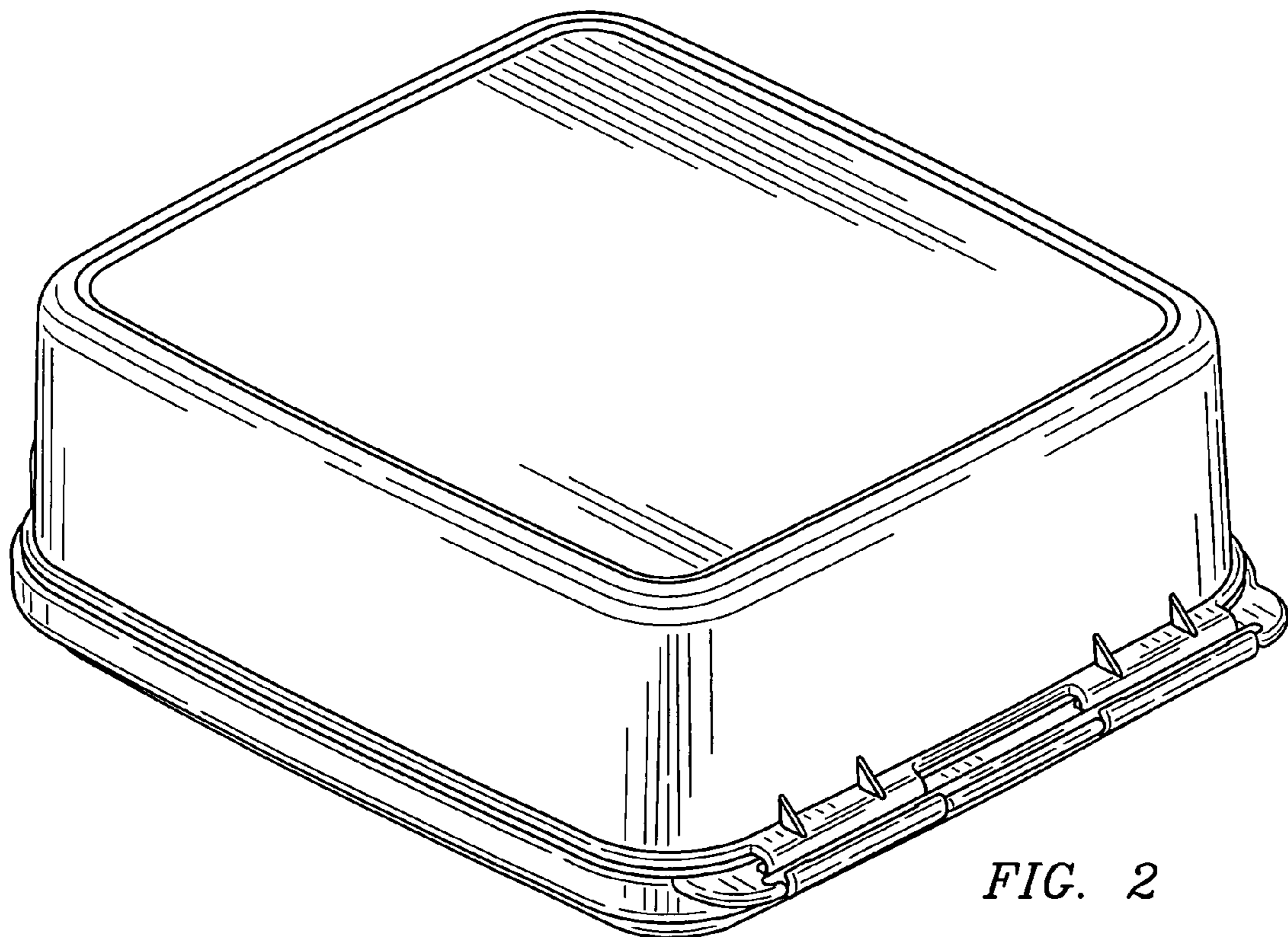

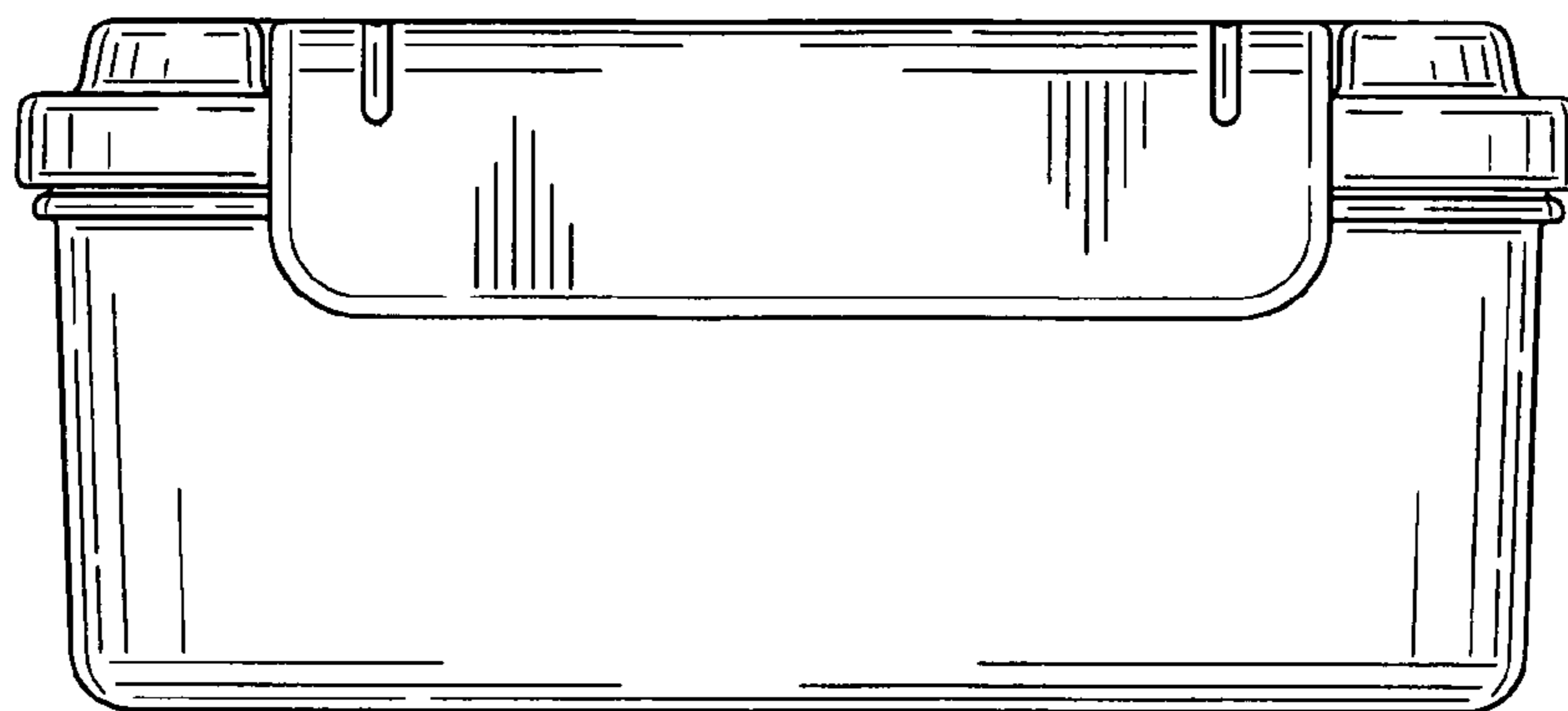

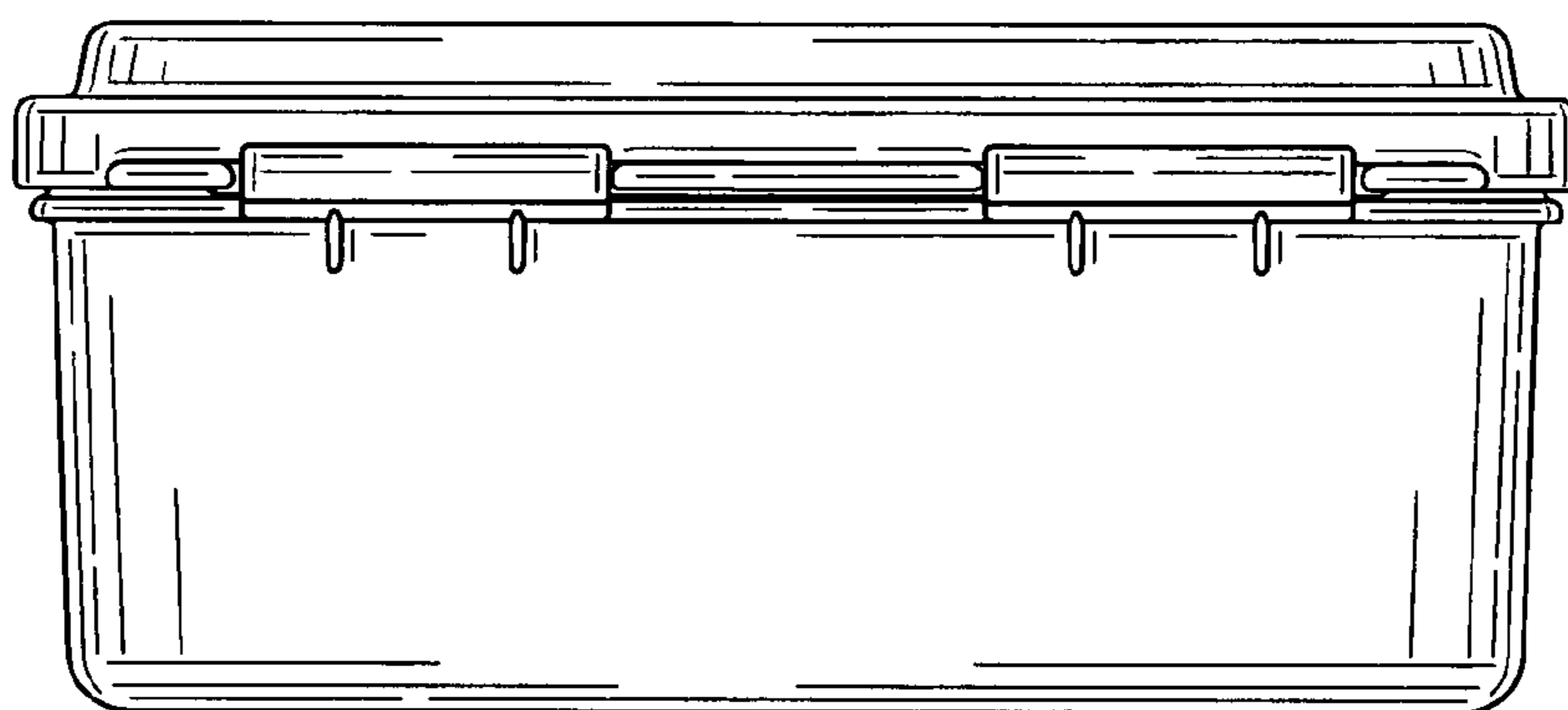

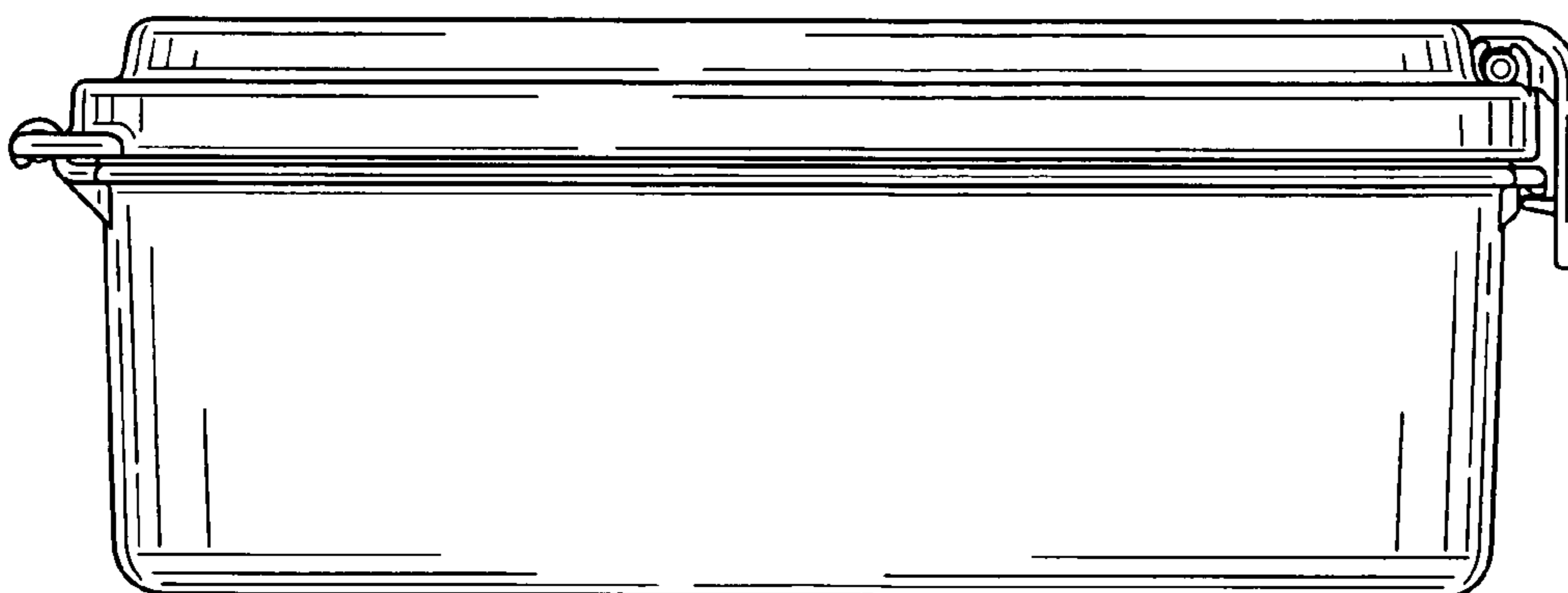

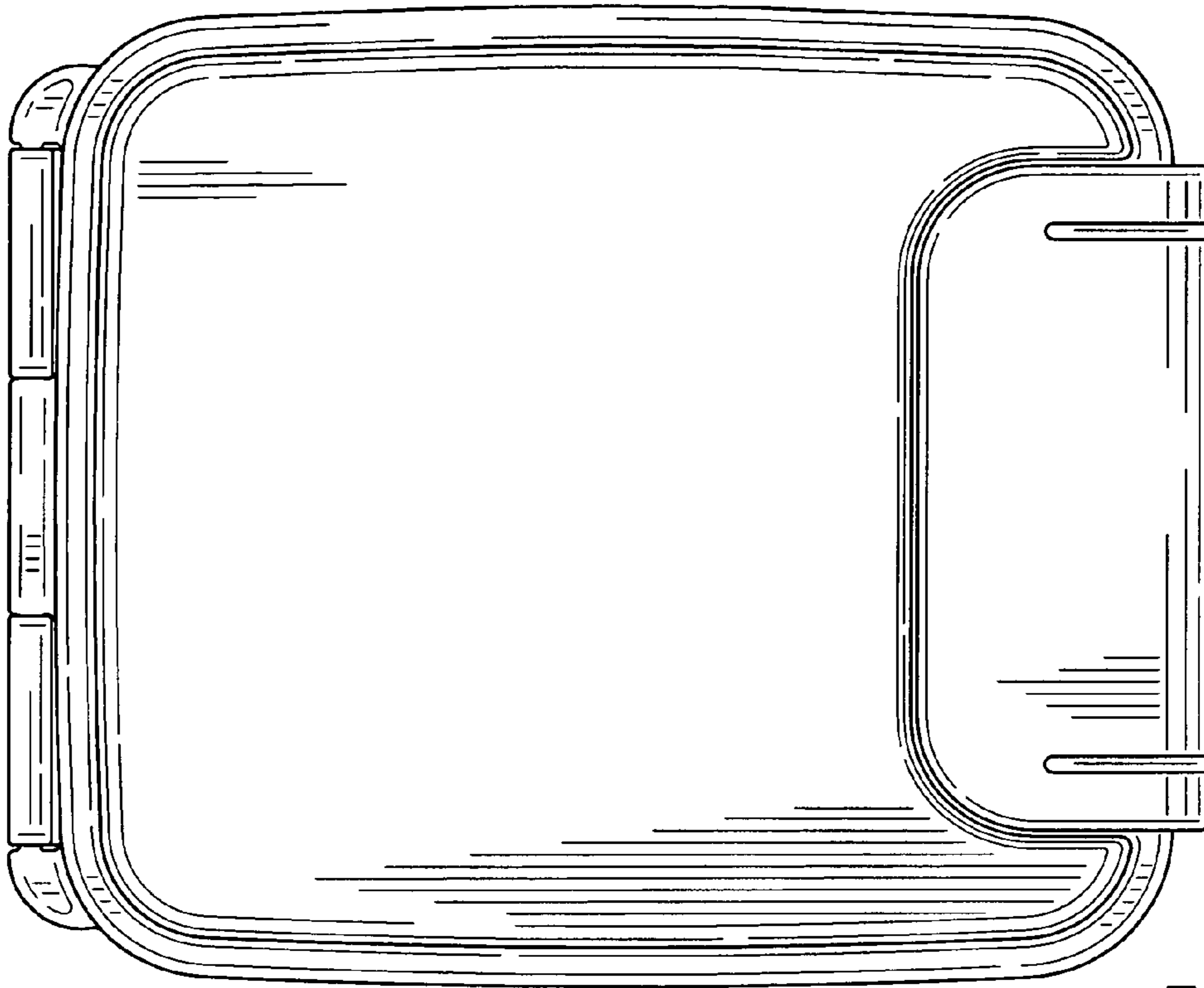

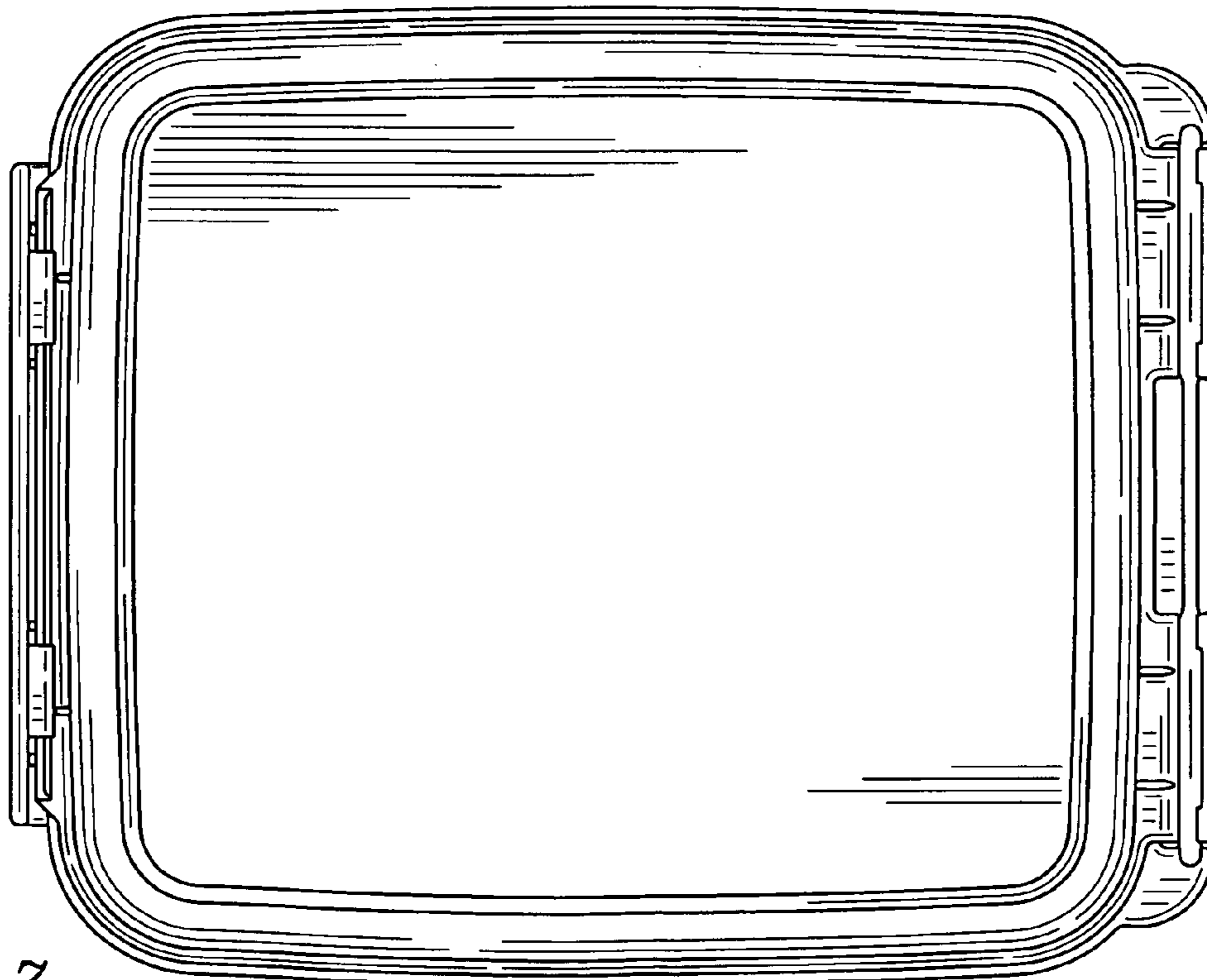
