(57) **CLAIM**

The ornamental design for a serrated utility knife blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a serrated utility knife blade showing our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.
