FIG. 2 is a top view thereof;

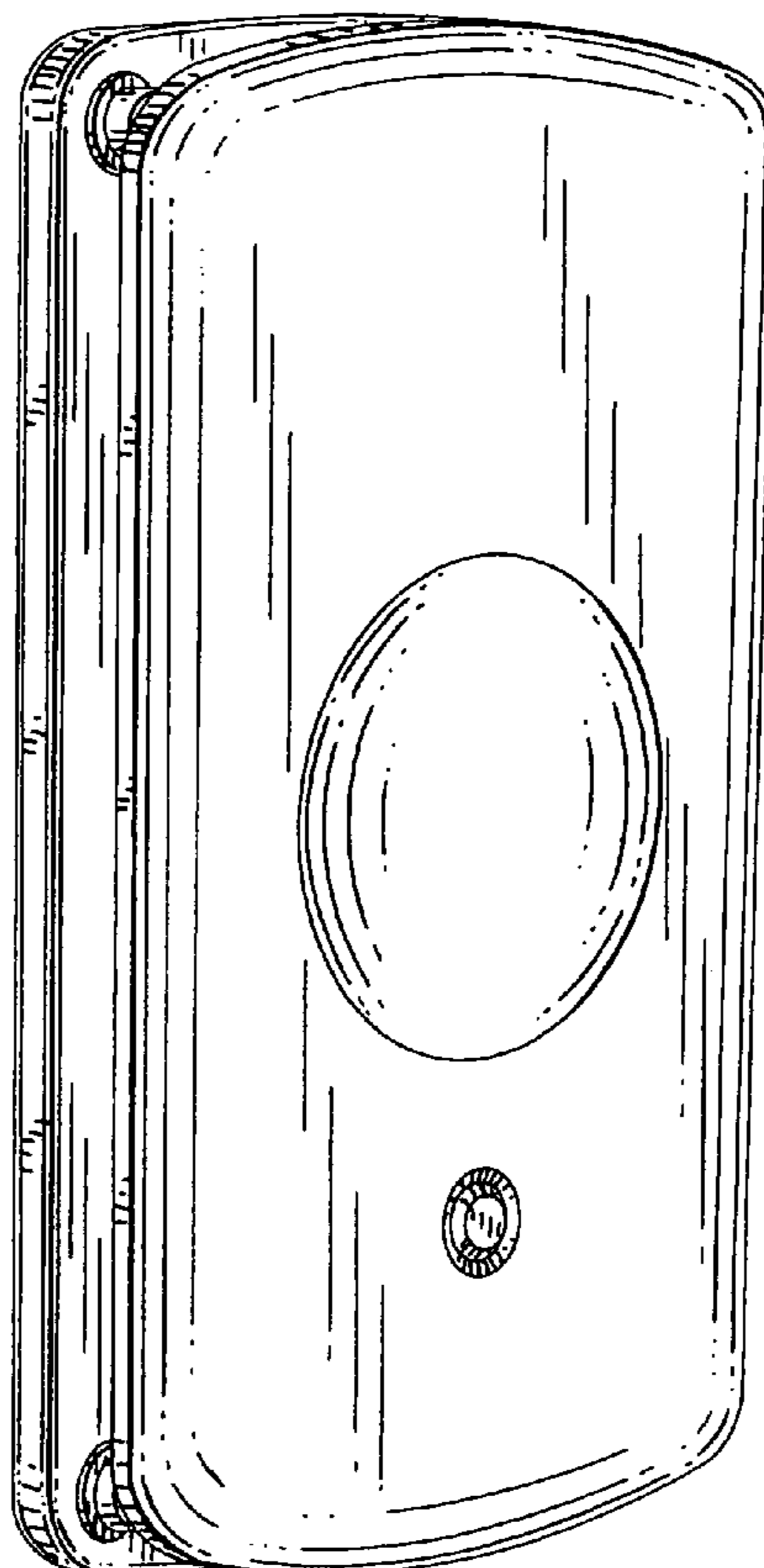
FIG. 3 is a left-side view thereof, the right-side view being a mirror image thereof;

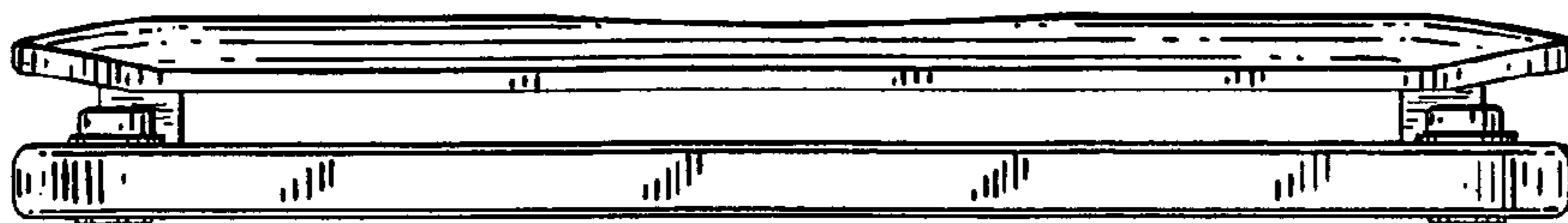

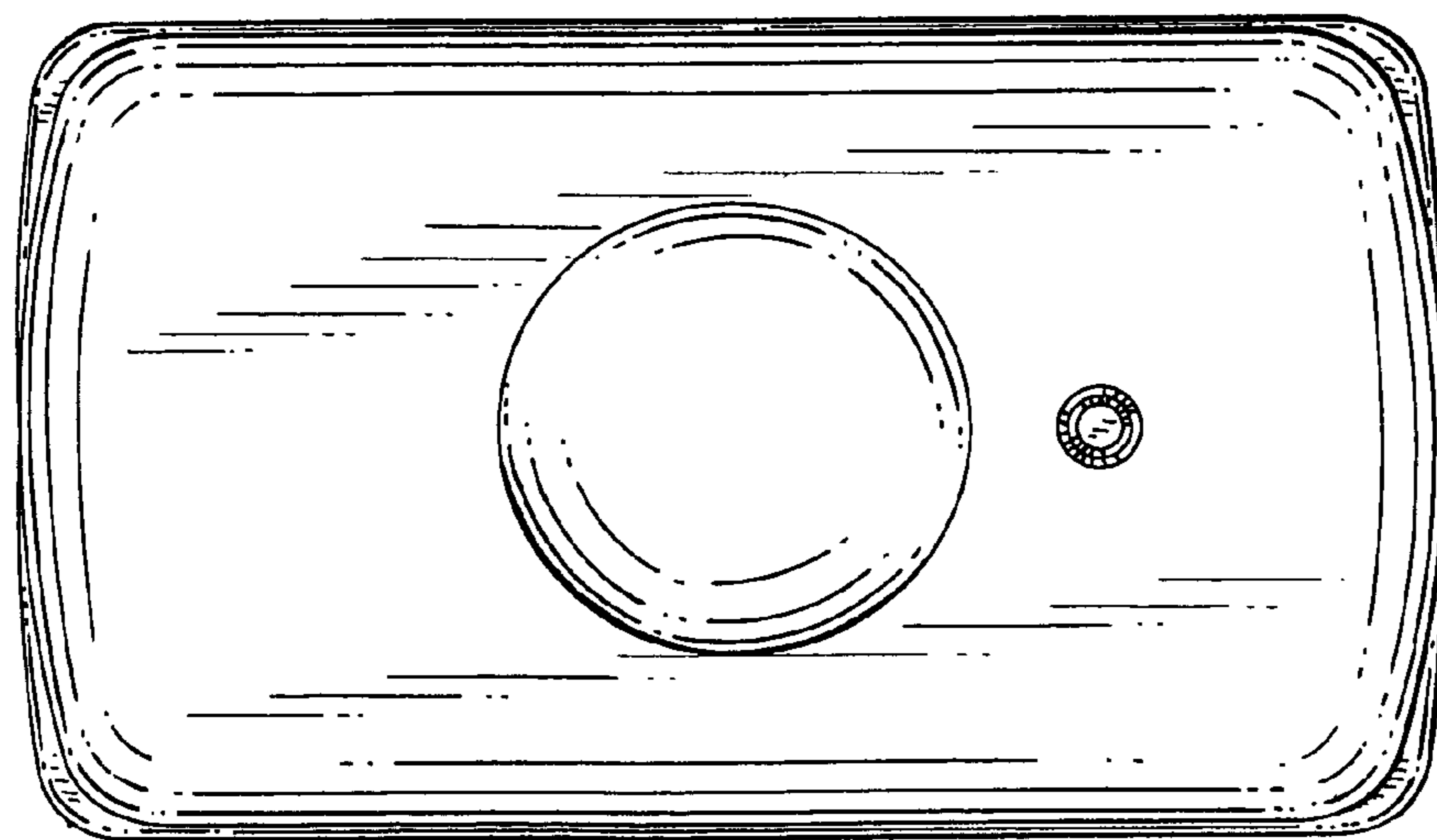

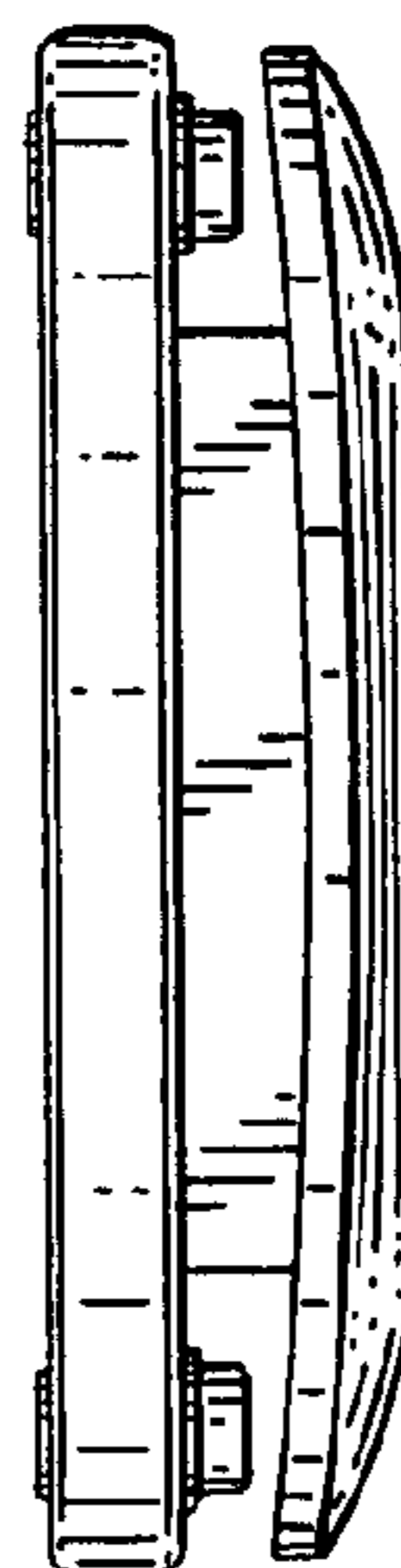

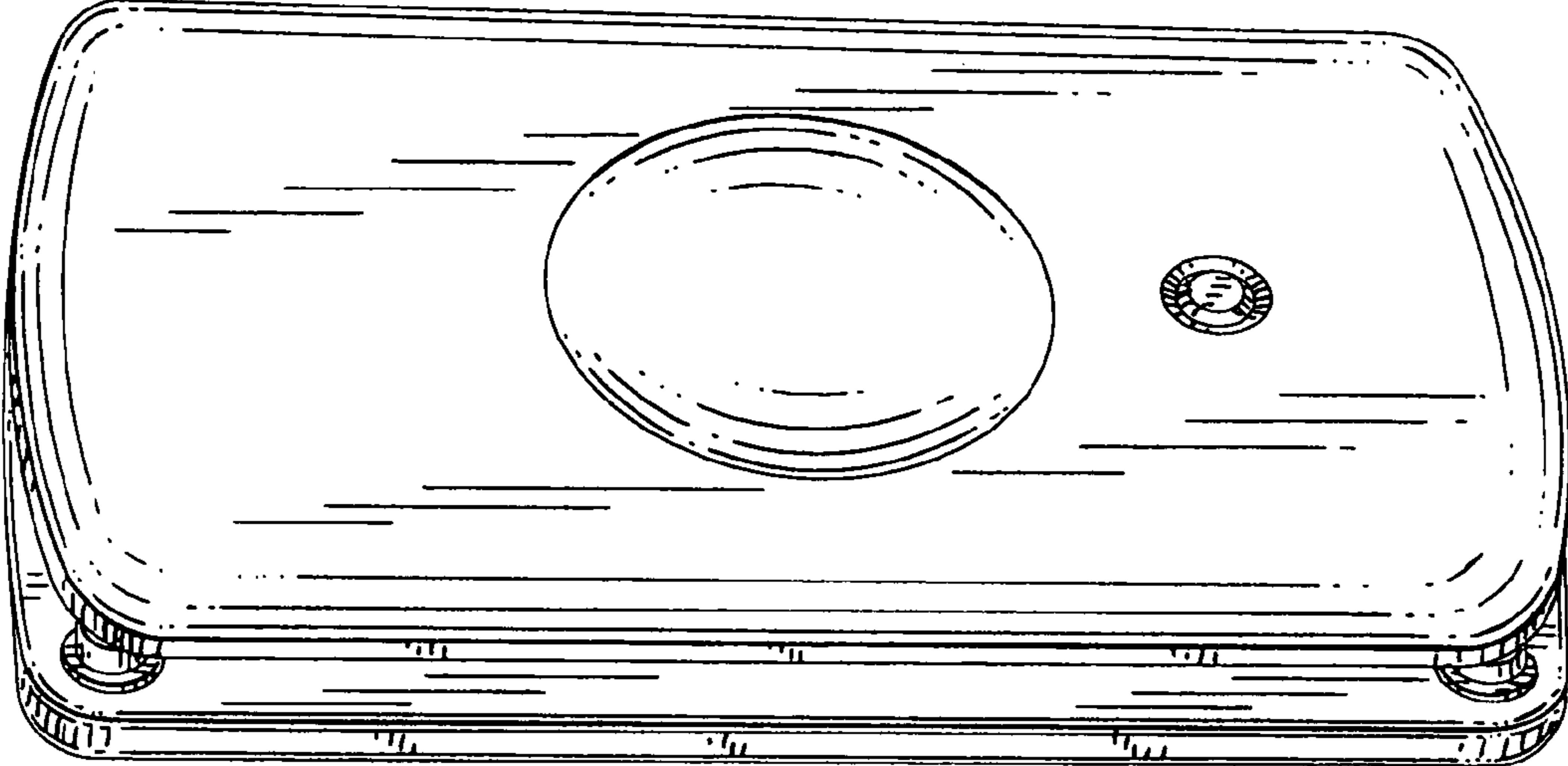

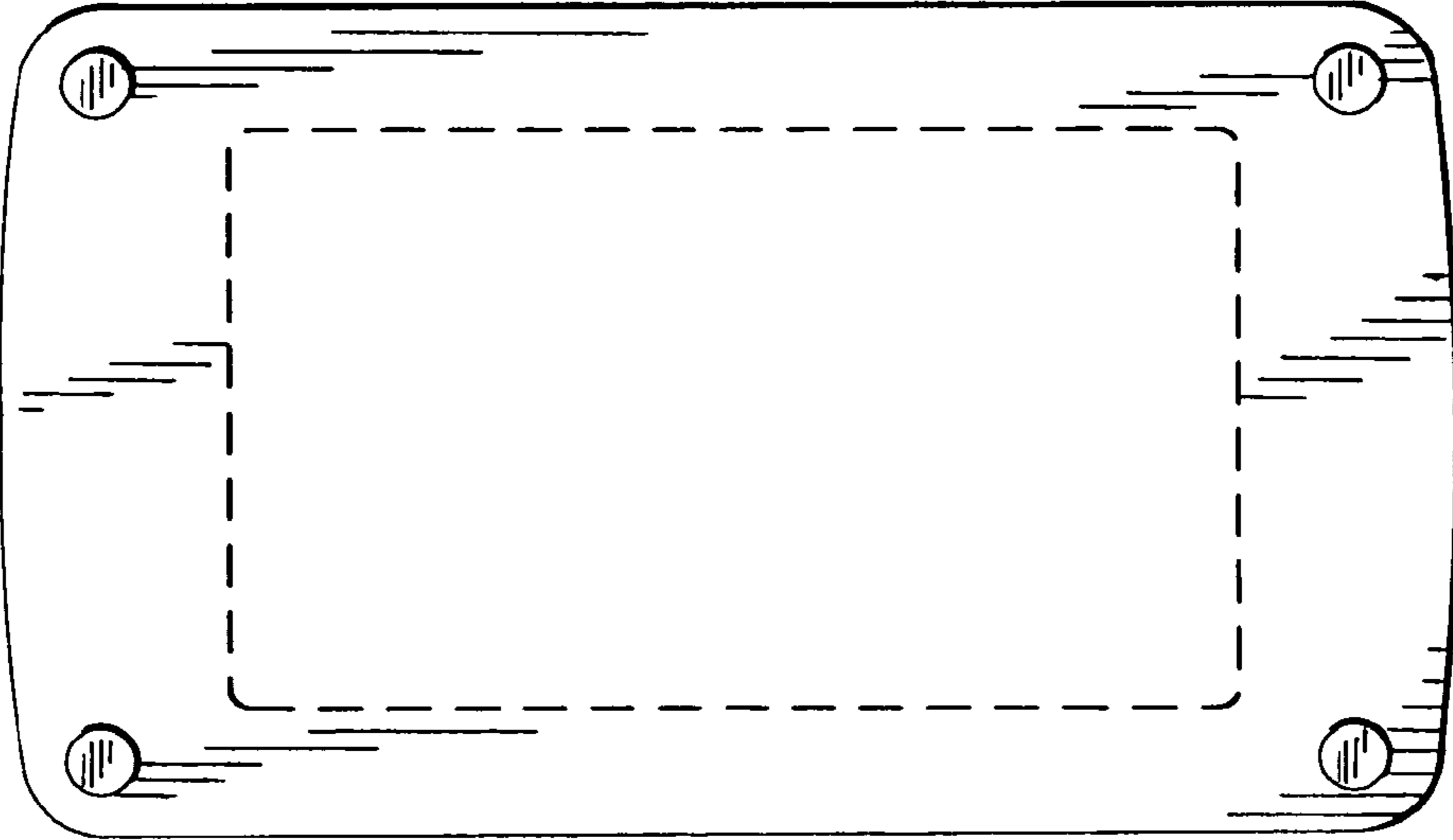
