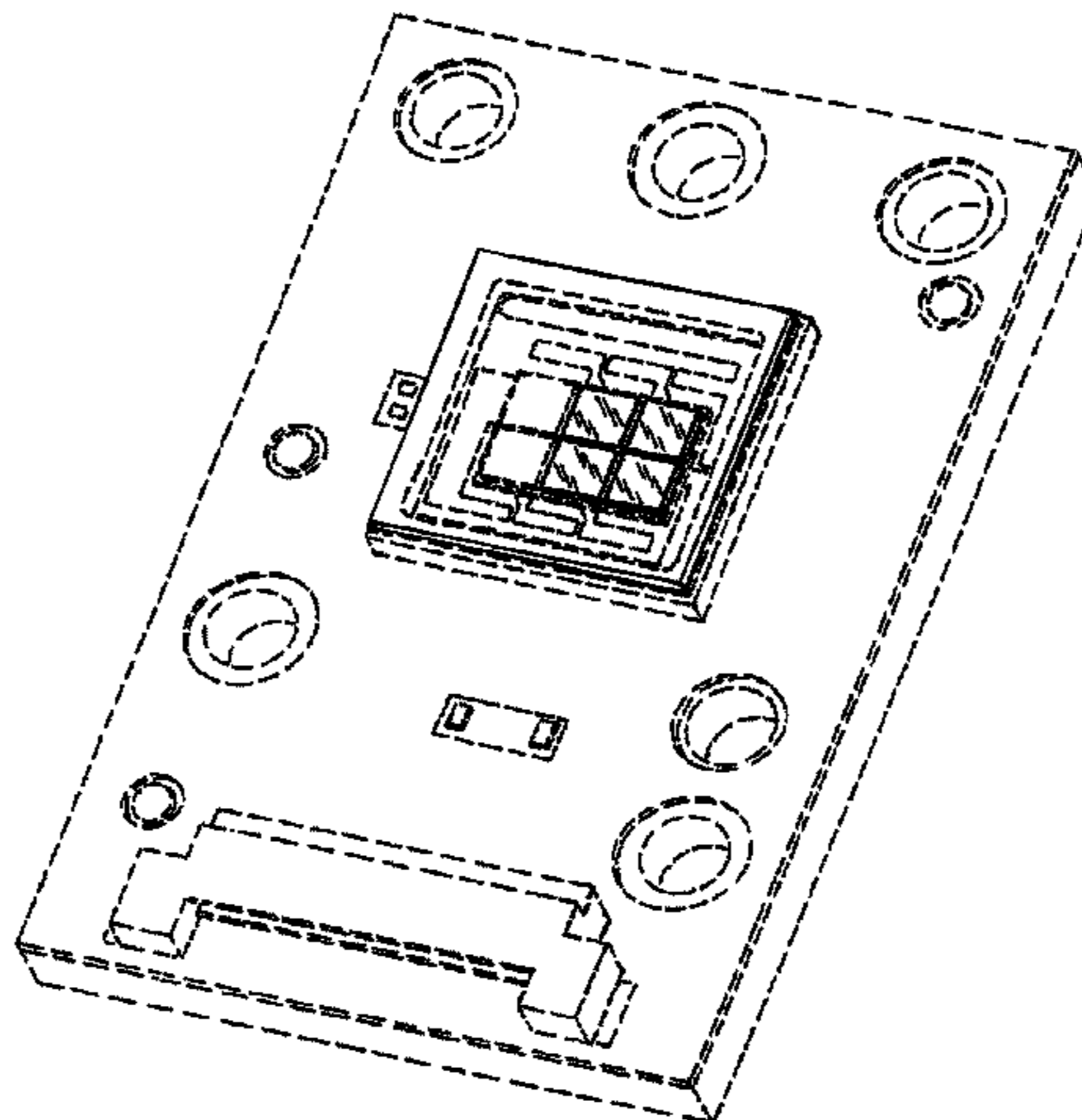
The ornamental design for a LED package, as shown and described.

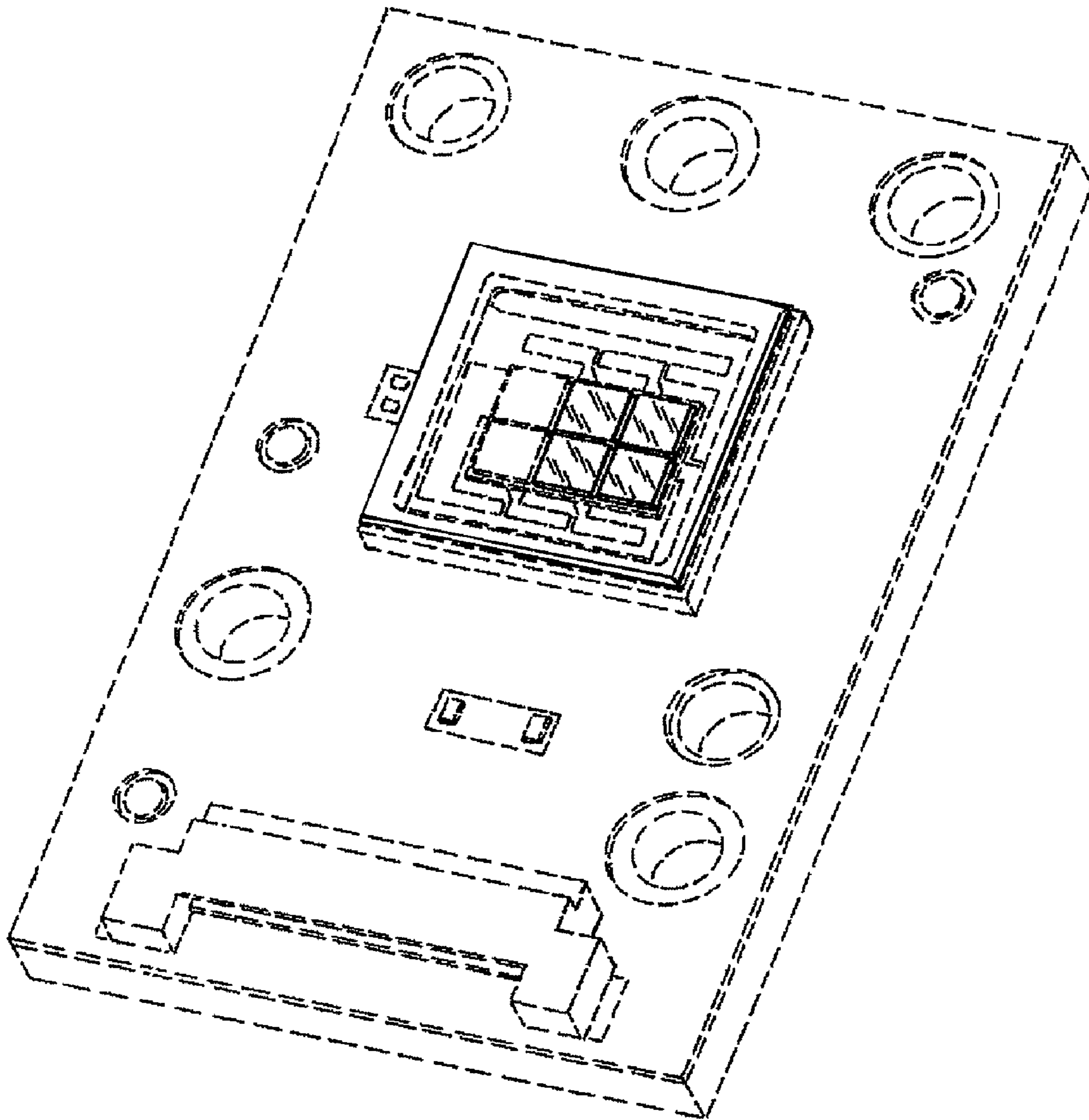

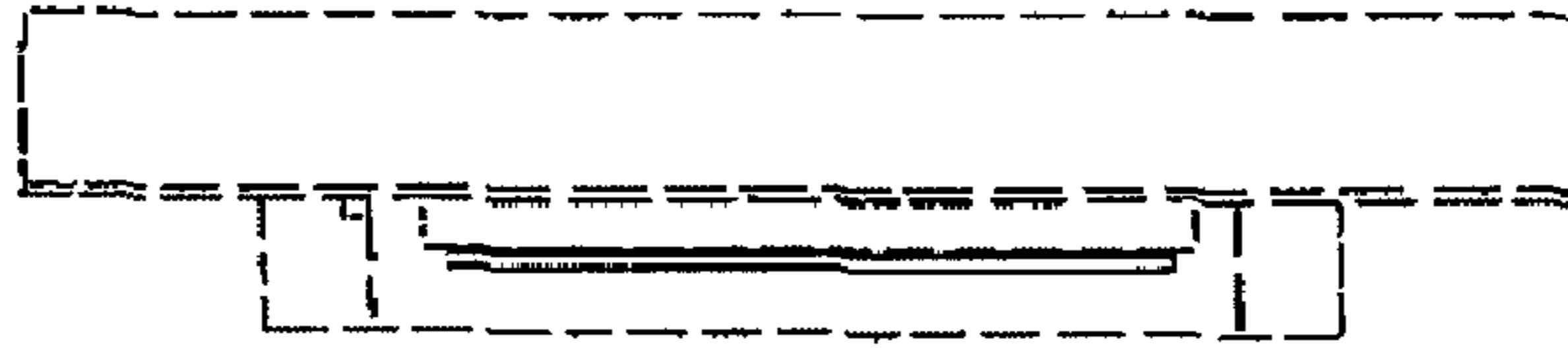

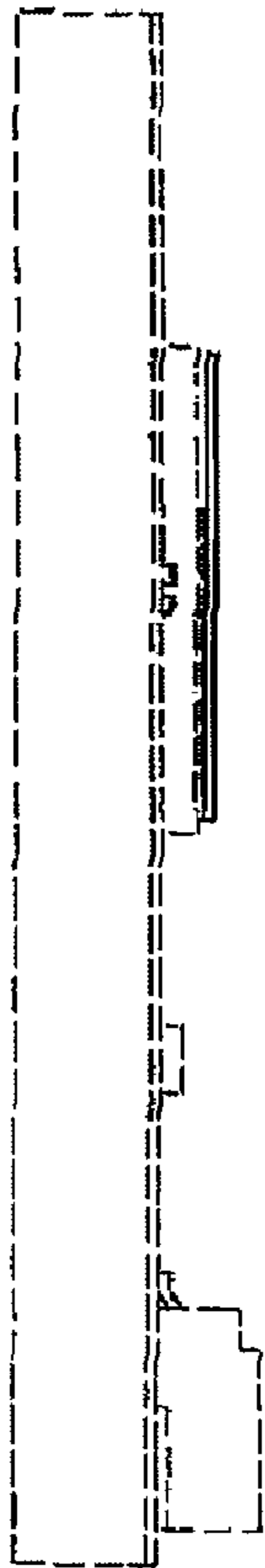

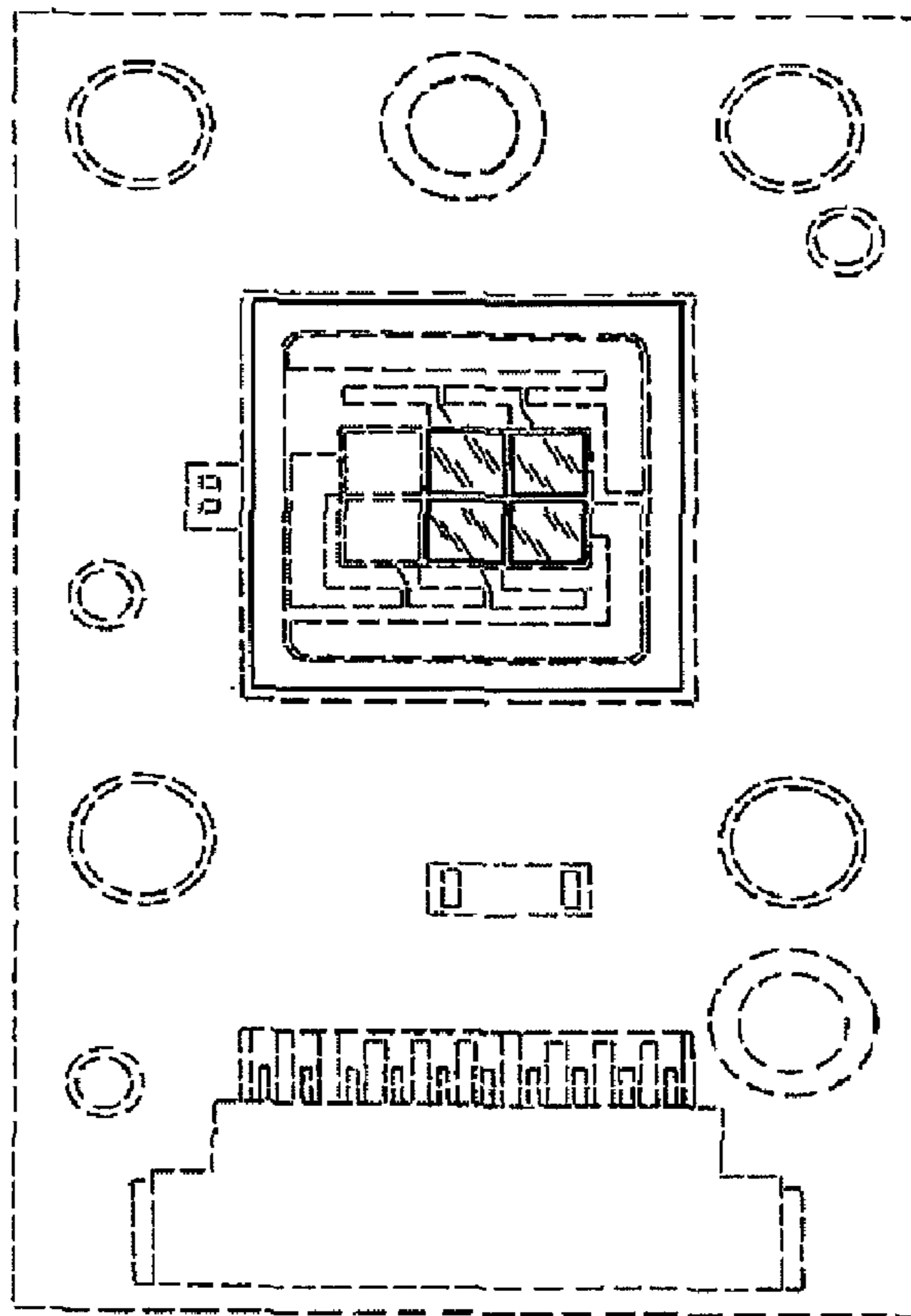

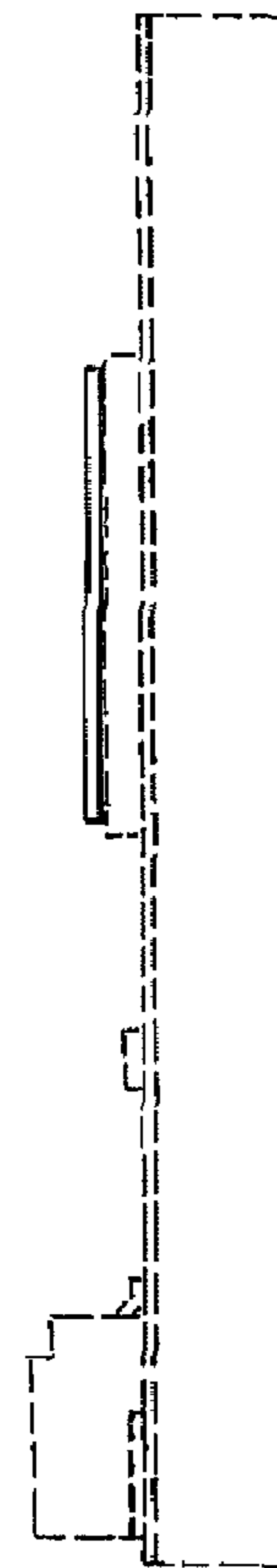

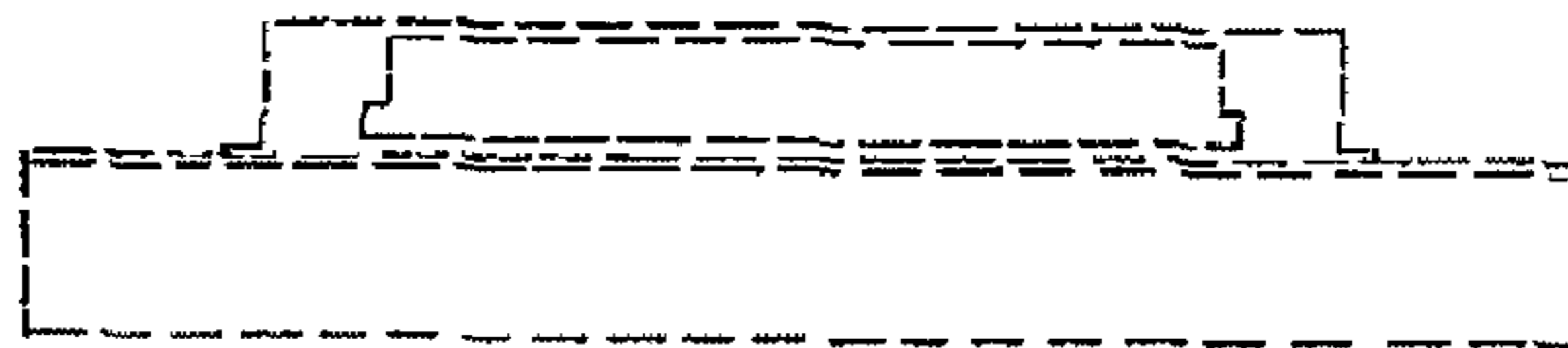
