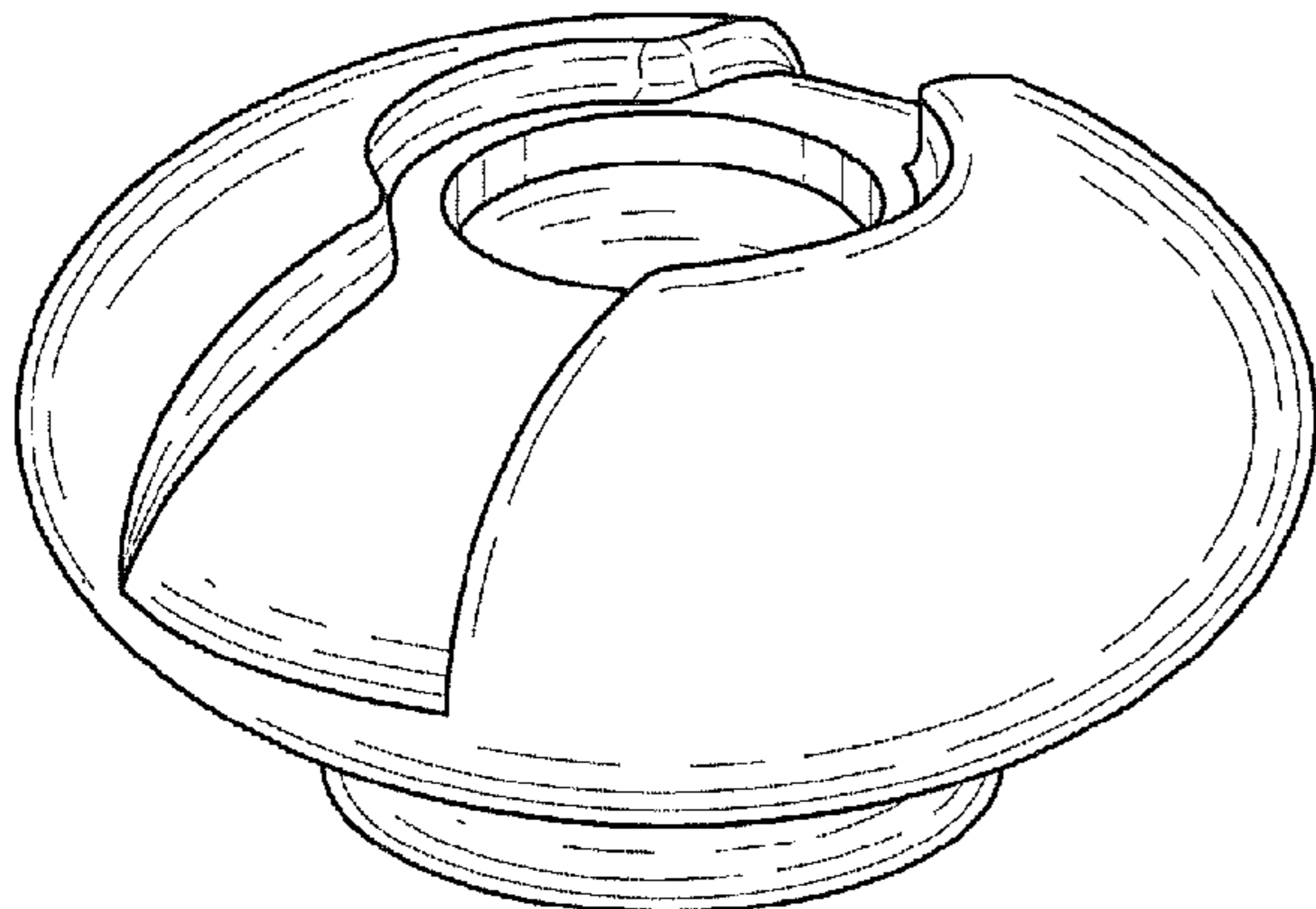

**DESCRIPTION**

FIG. 8 is a back side view thereof; the front side view is a mirror image.

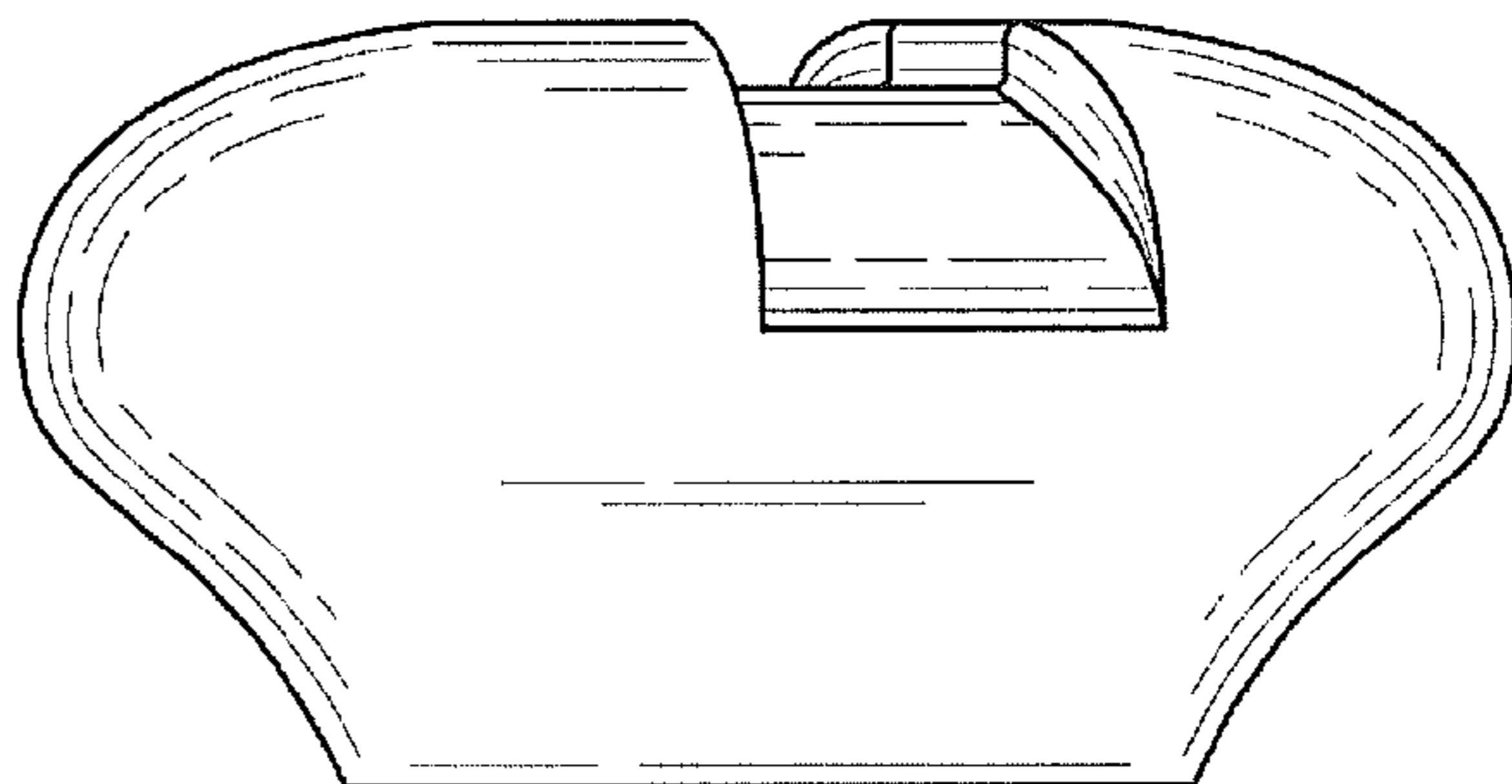
FIG. 9 is a front top right perspective view of an earbud for a communications headset showing my new design;

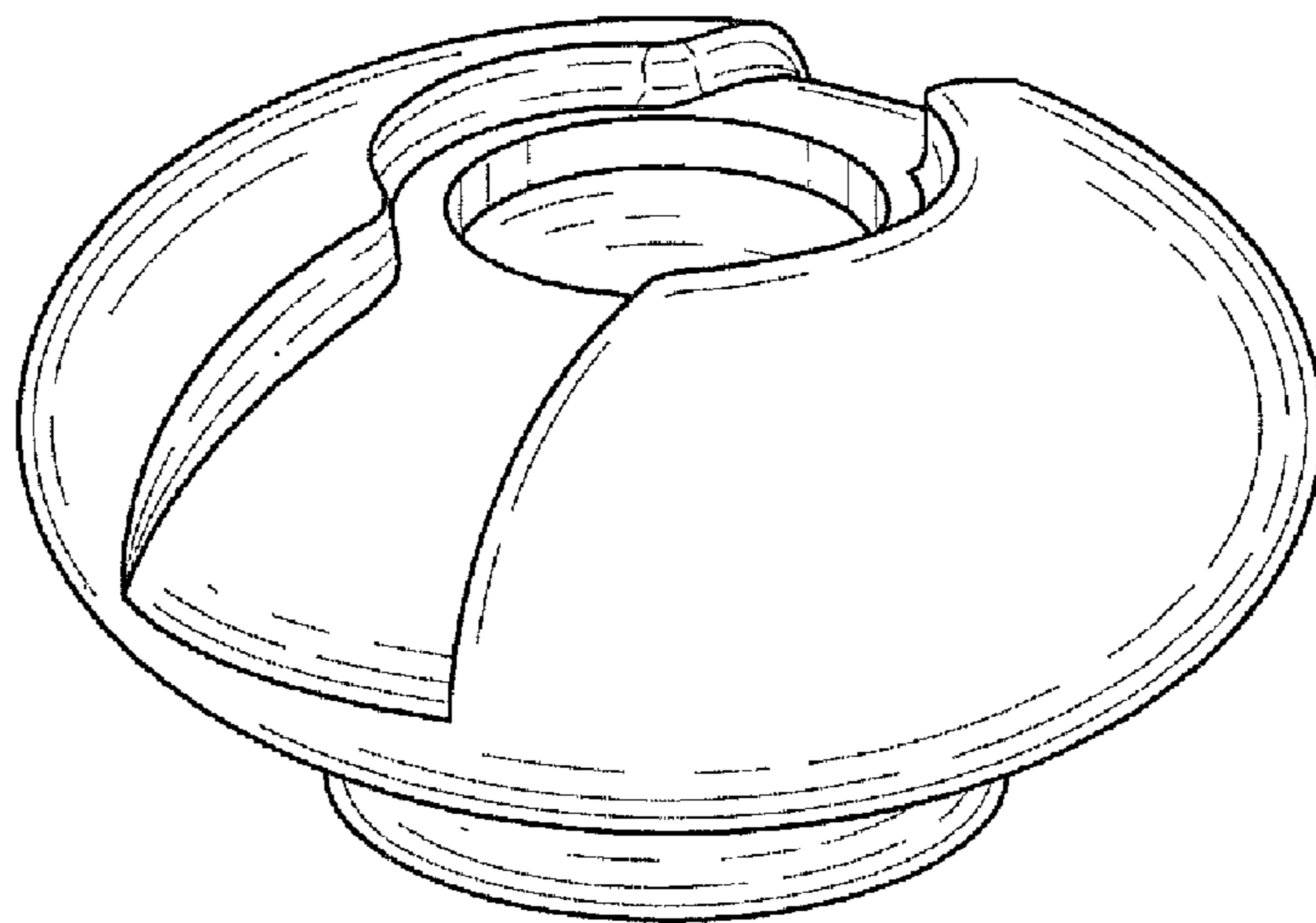

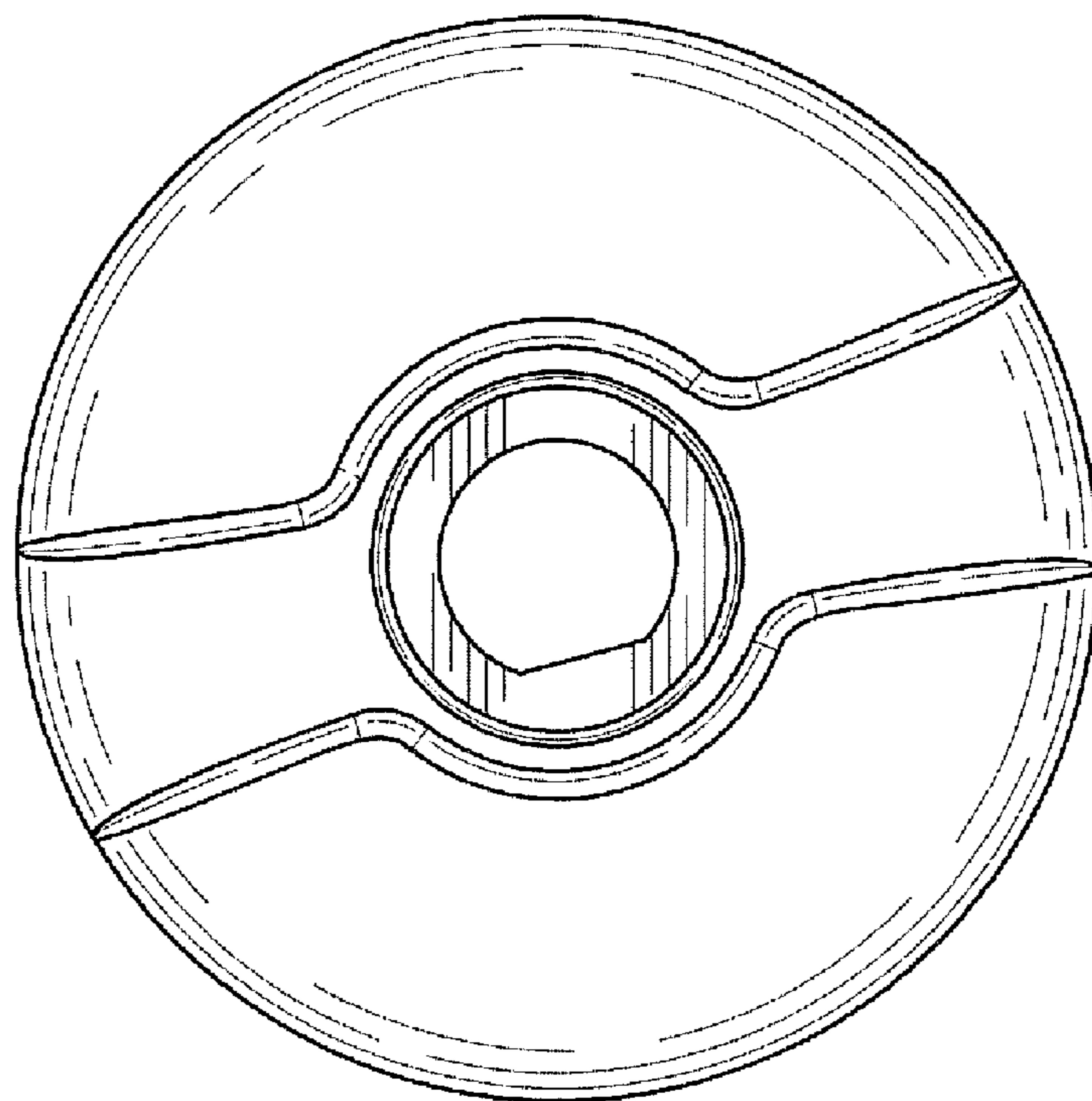

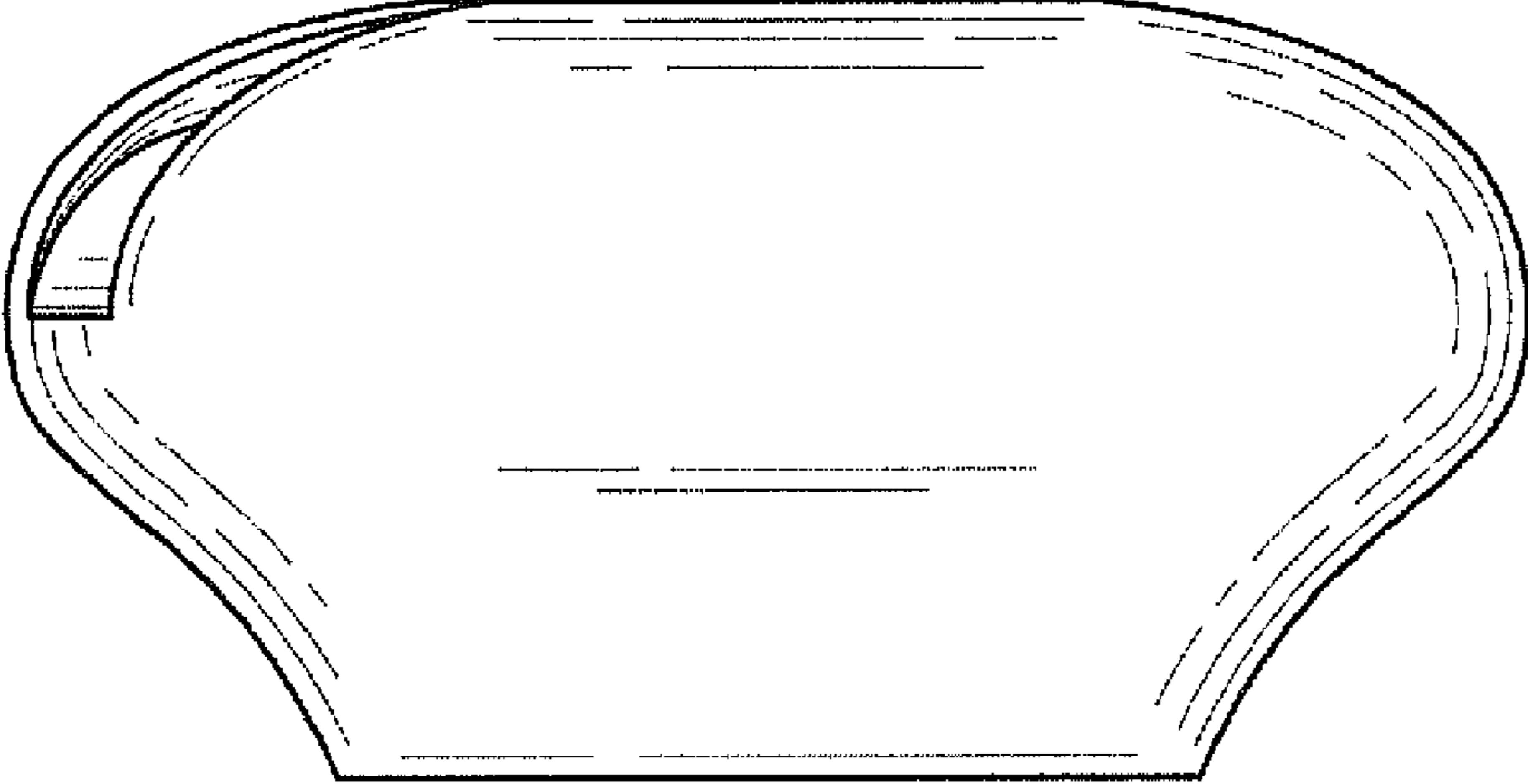

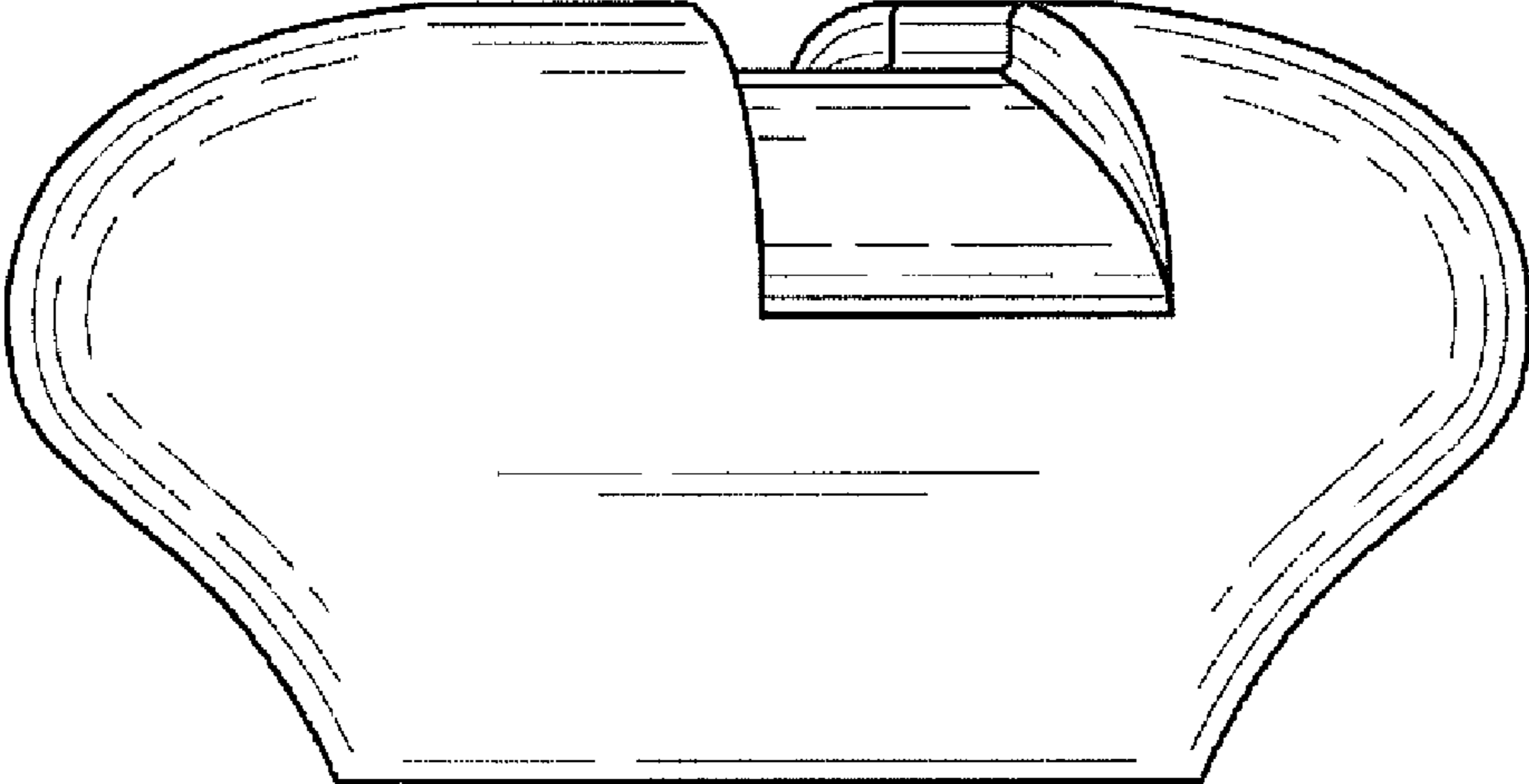

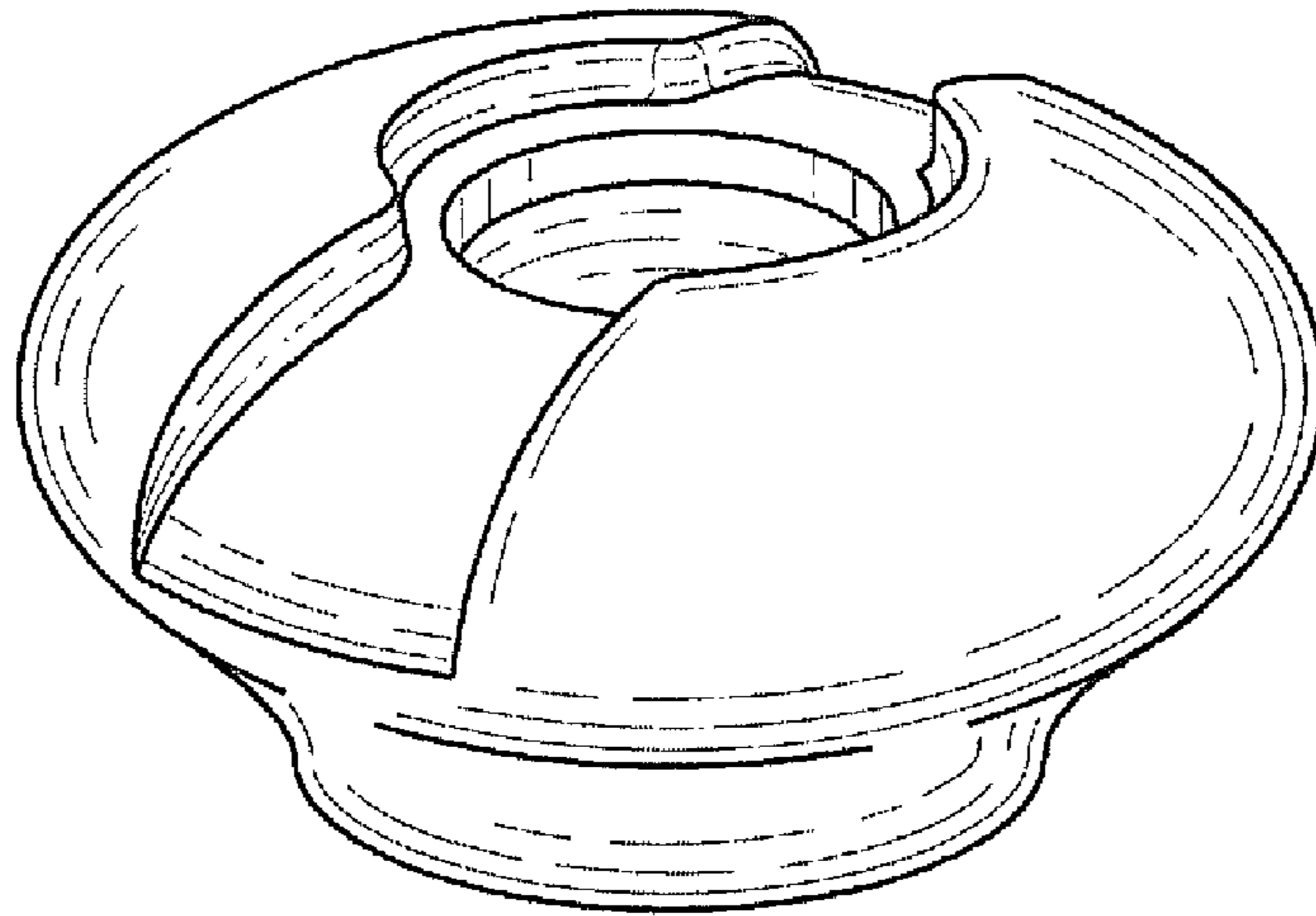

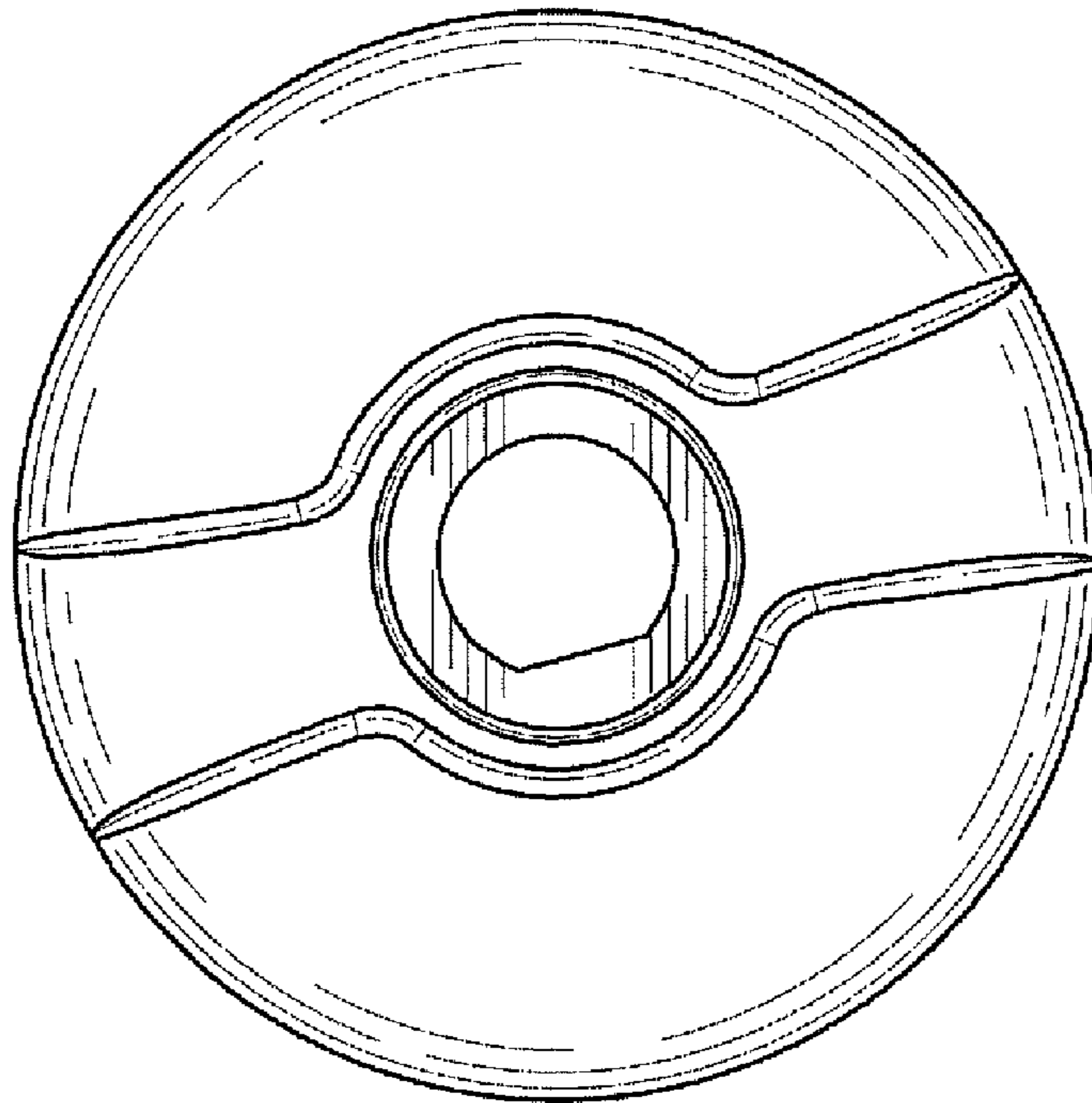

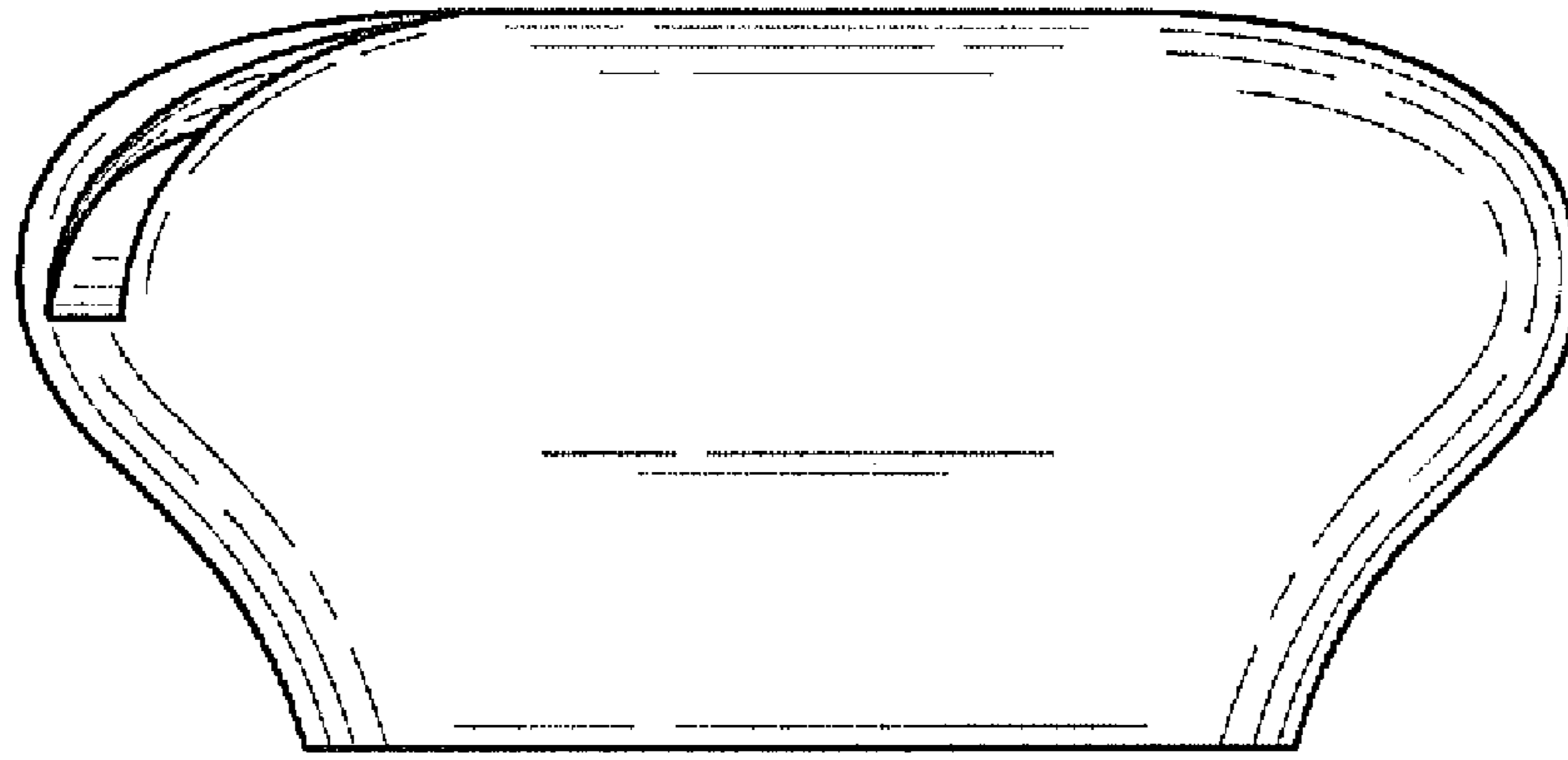

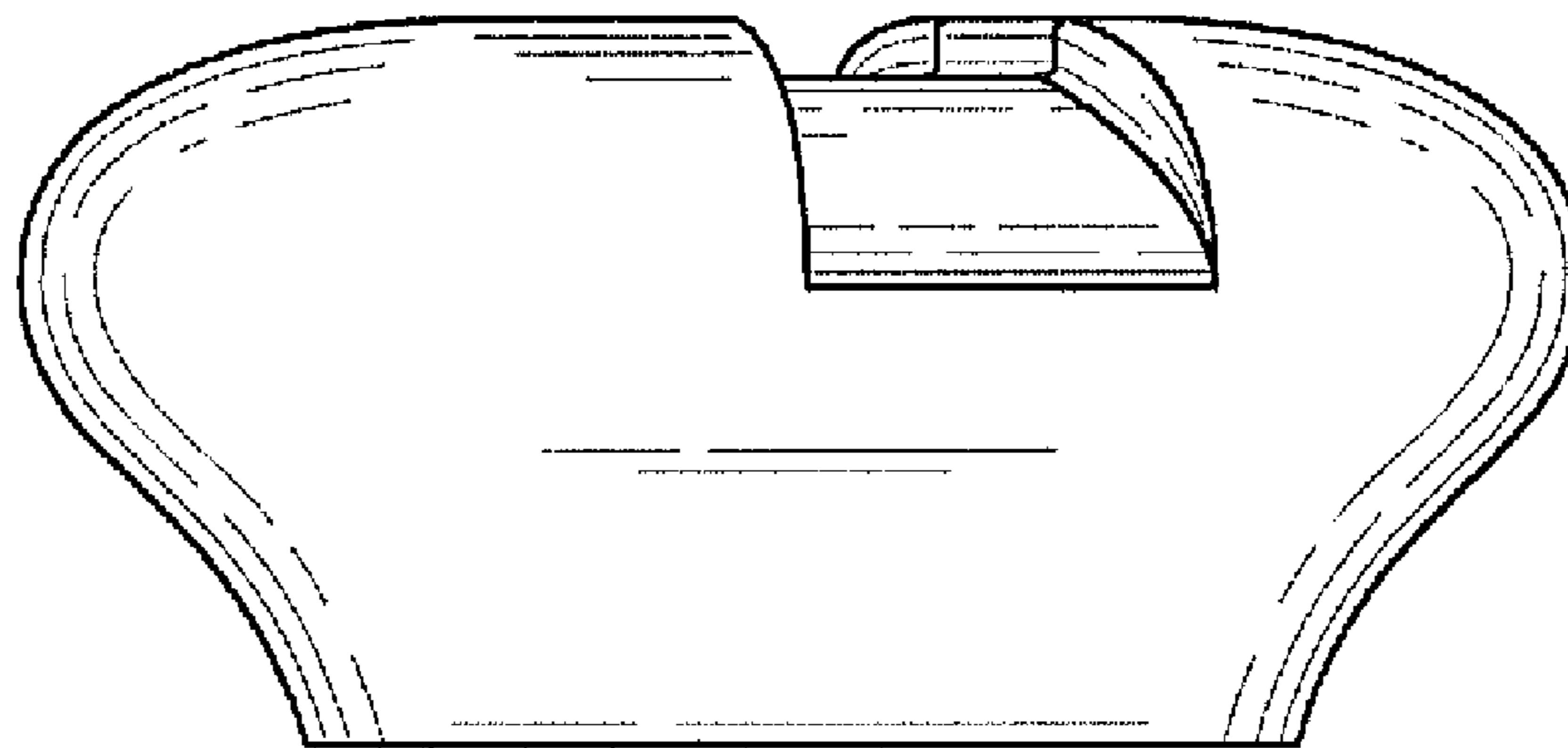

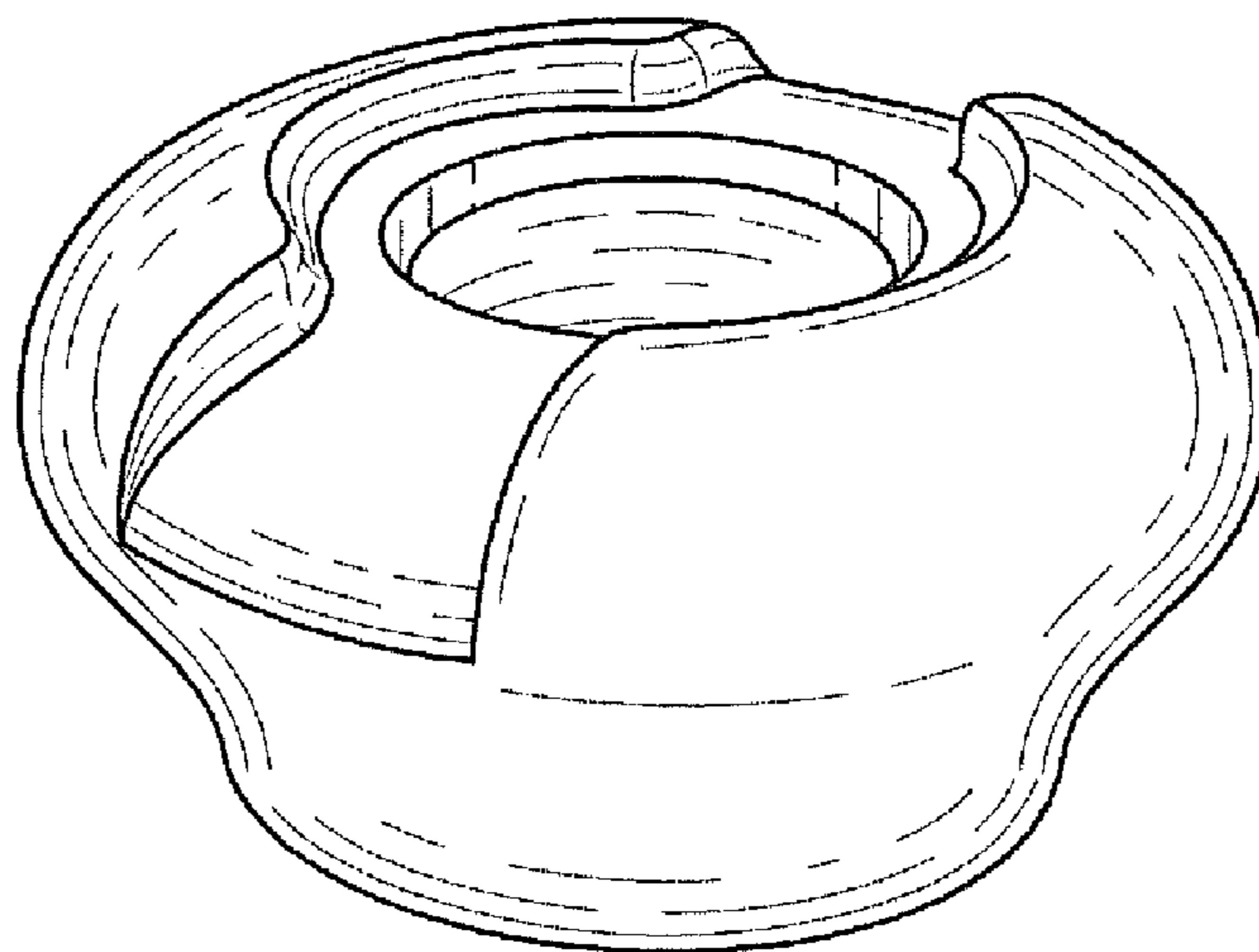

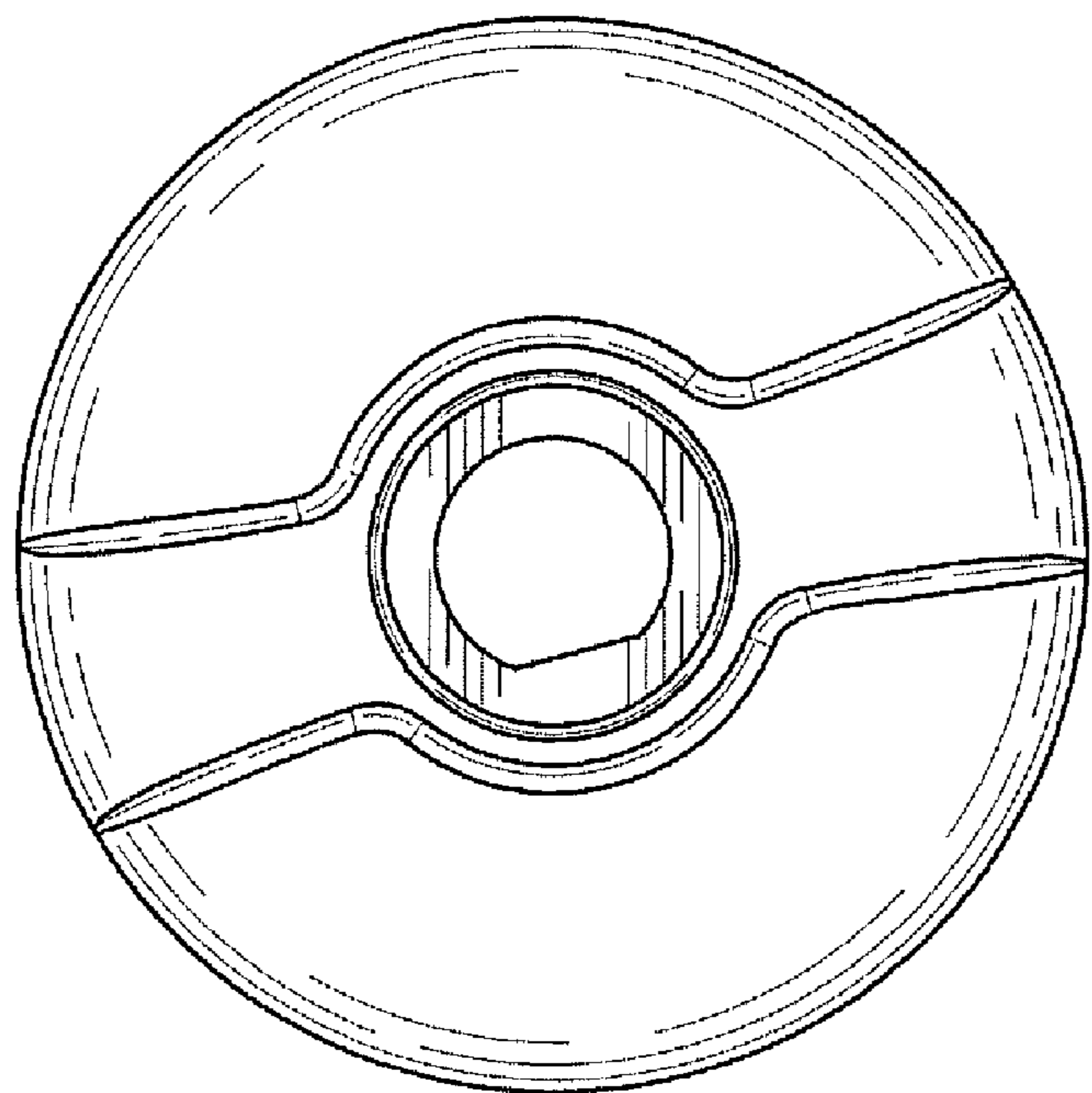

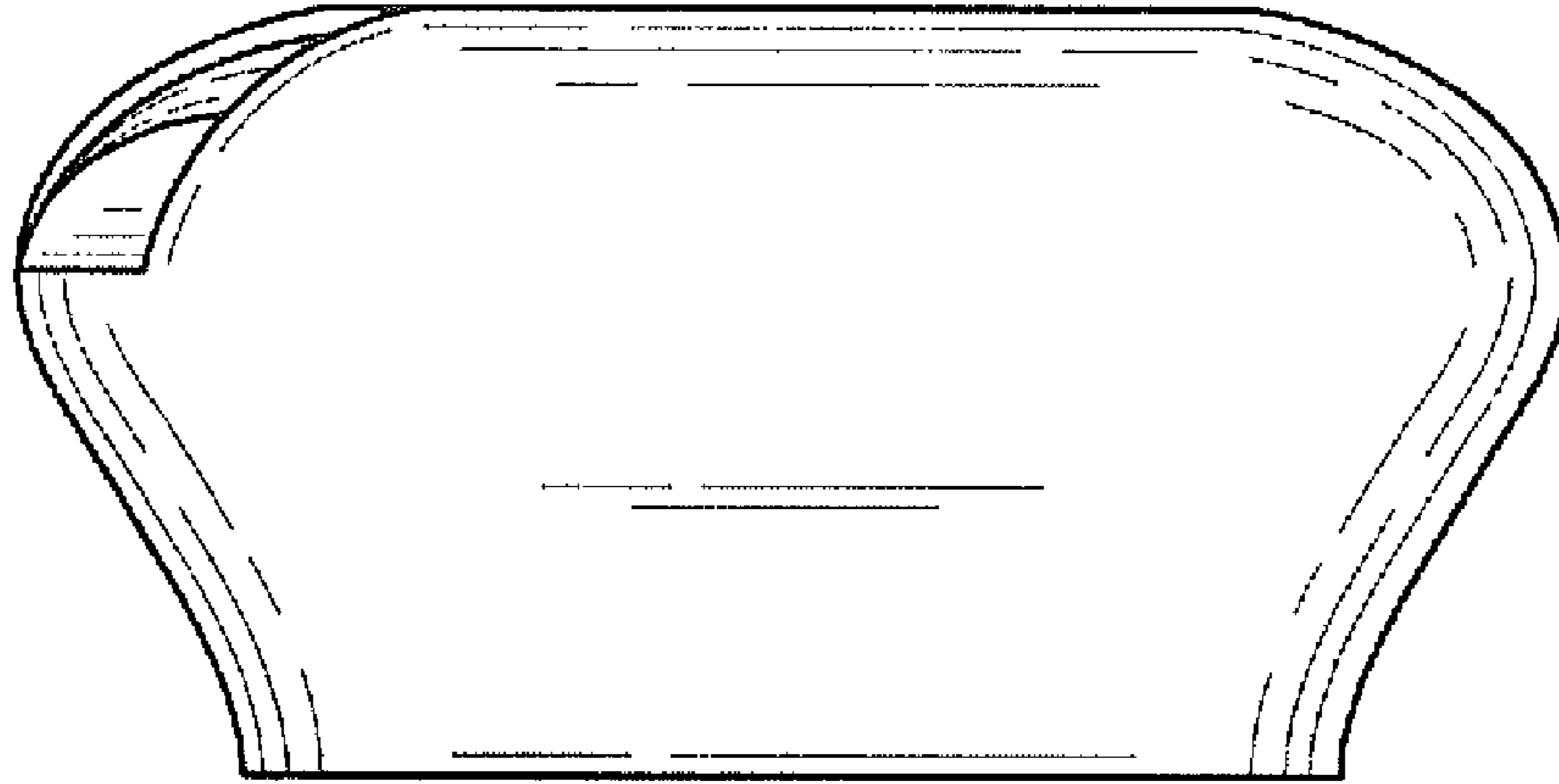

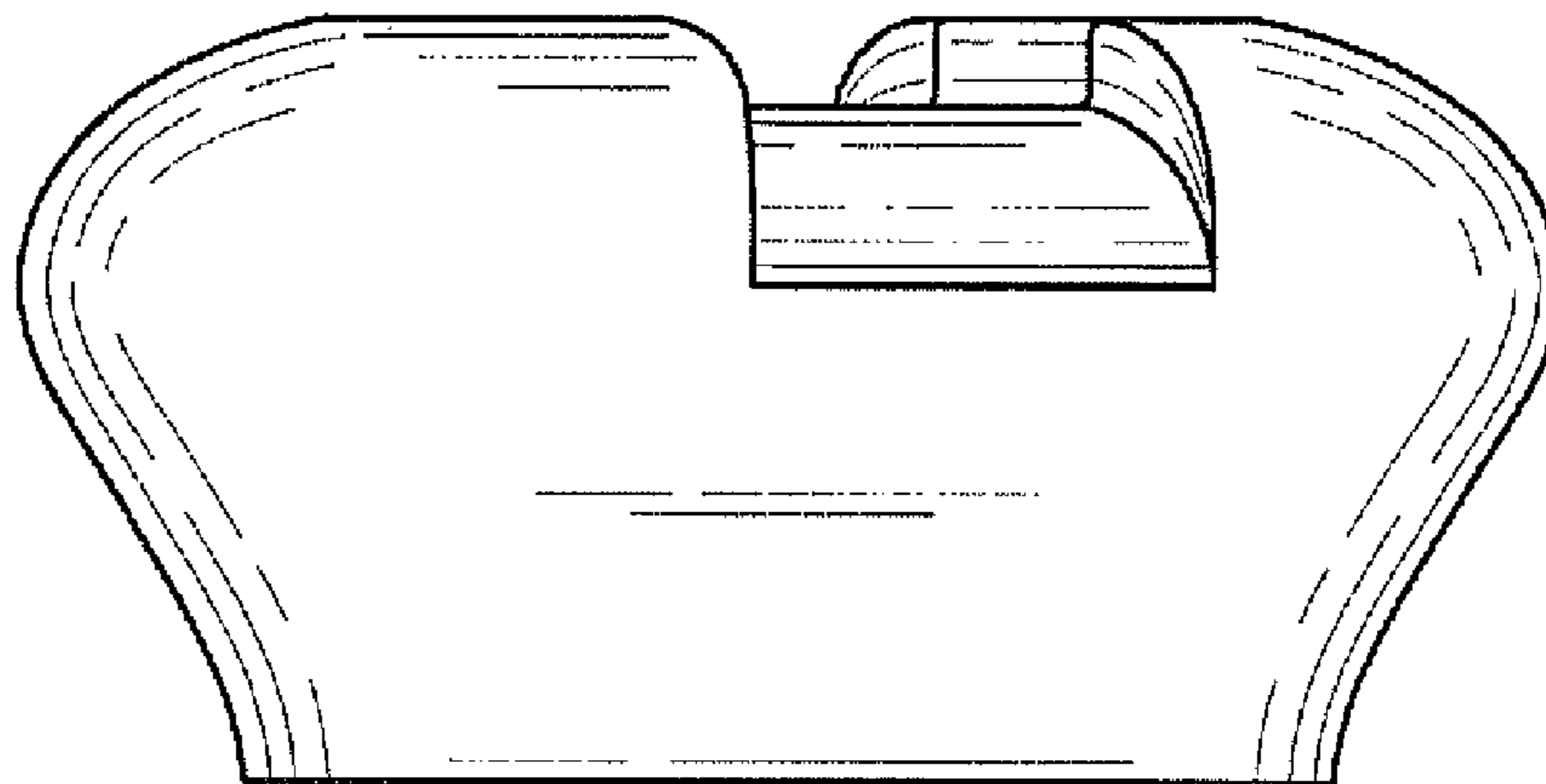
