FIG. 3 is a right side view of the stylus of FIG. 1; the opposite side view being a mirror image thereof;

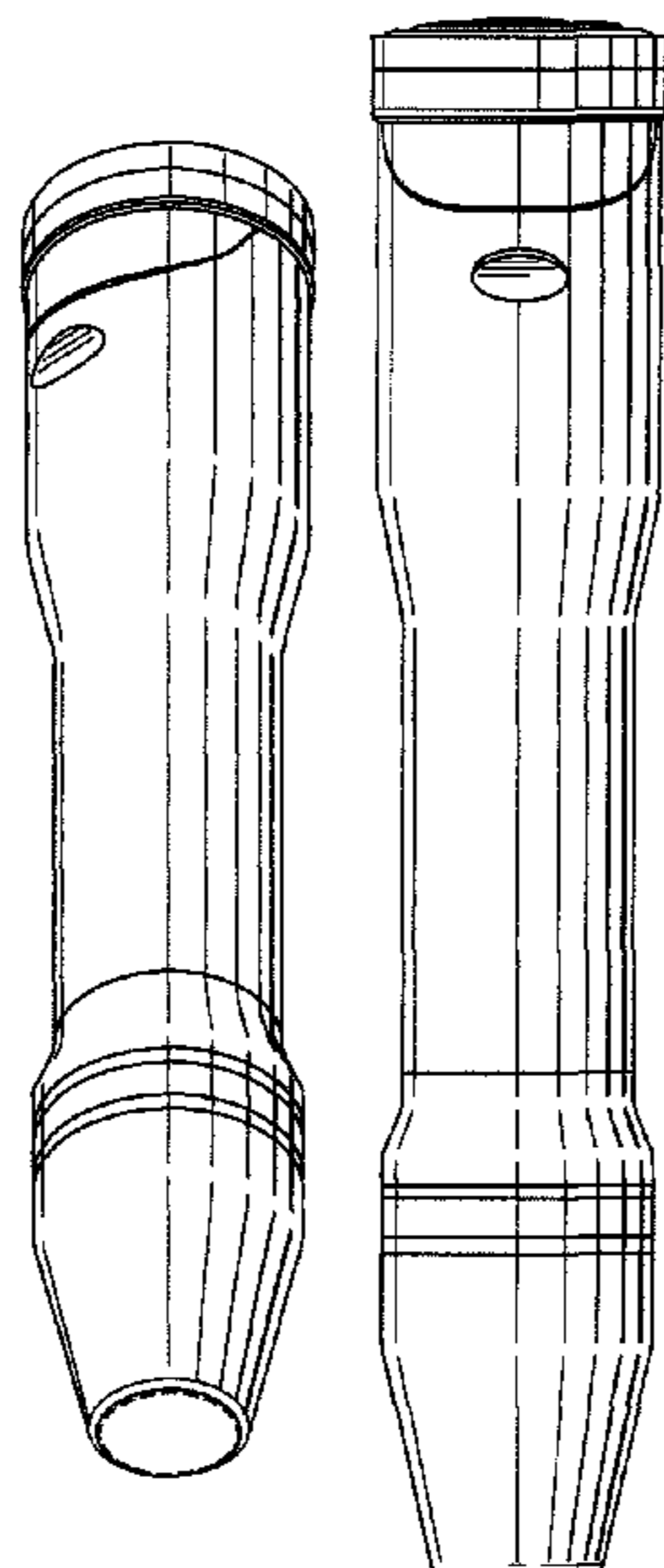
FIG. 4 is a rear view of the stylus of FIG. 1;

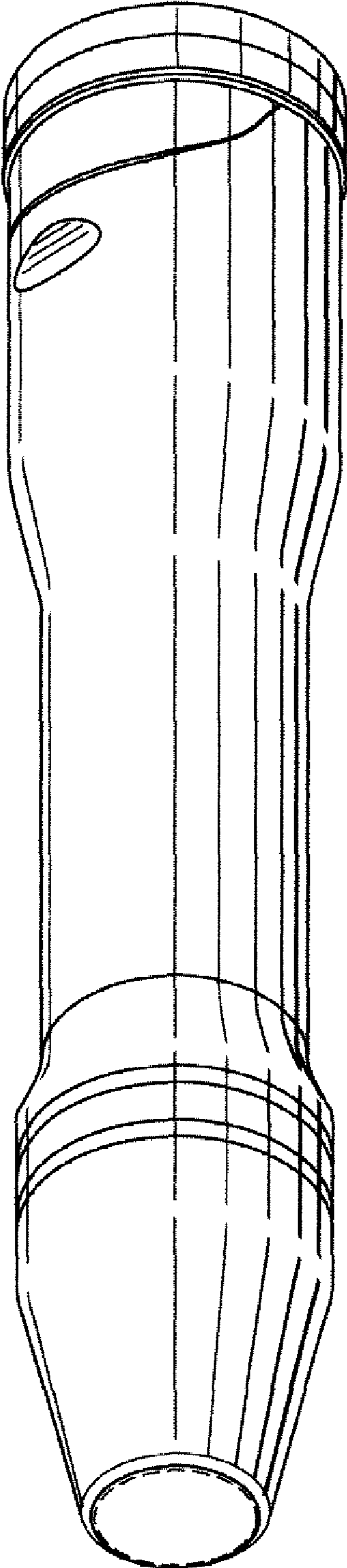

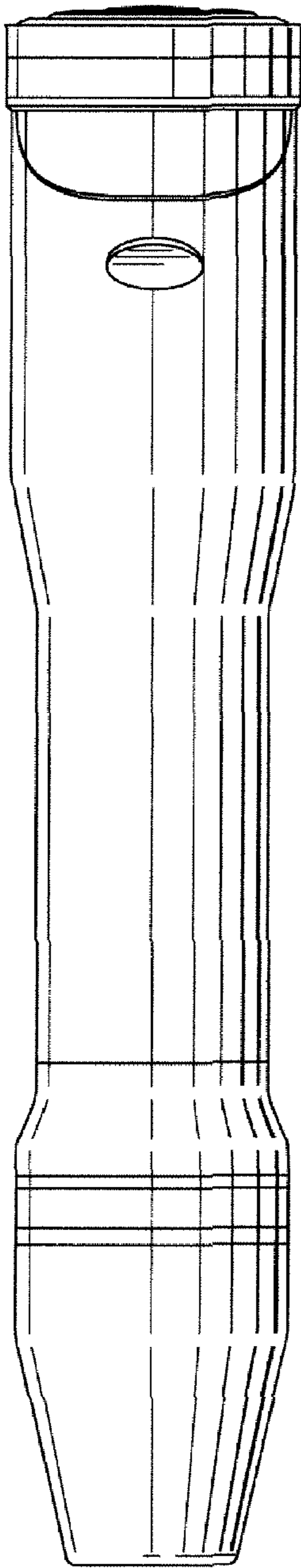

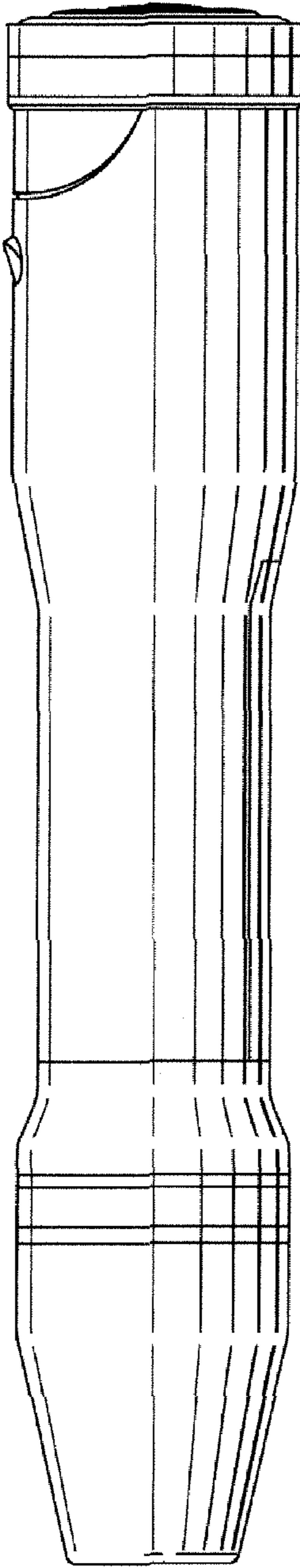

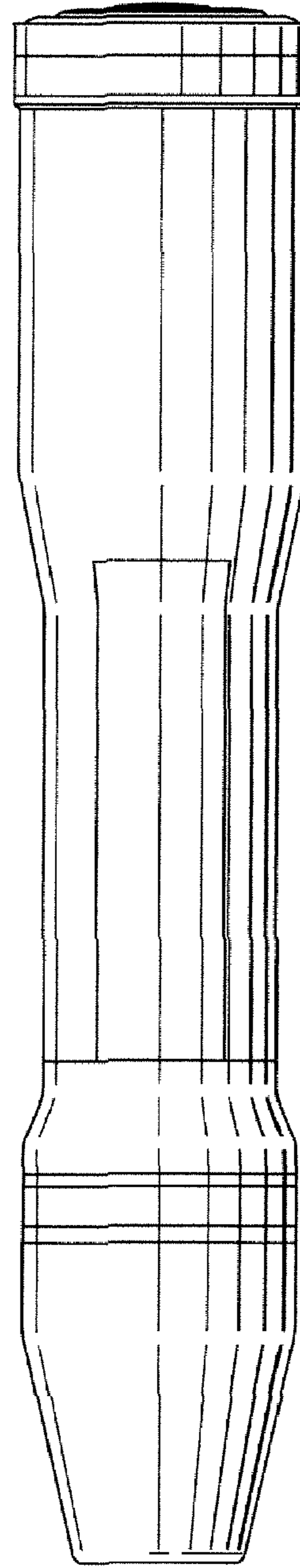

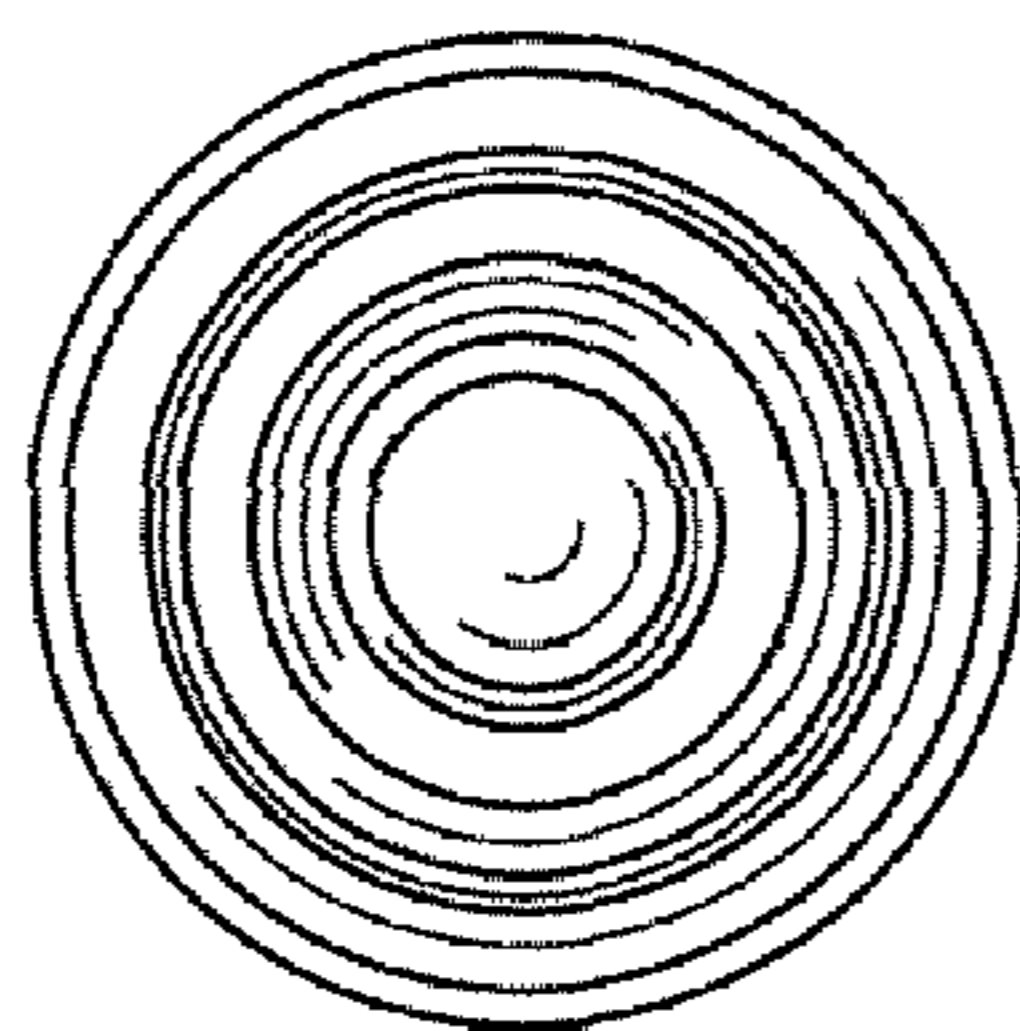
