DESCRIPTION

FIG. 8 is a front view of an eighth embodiment thereof;

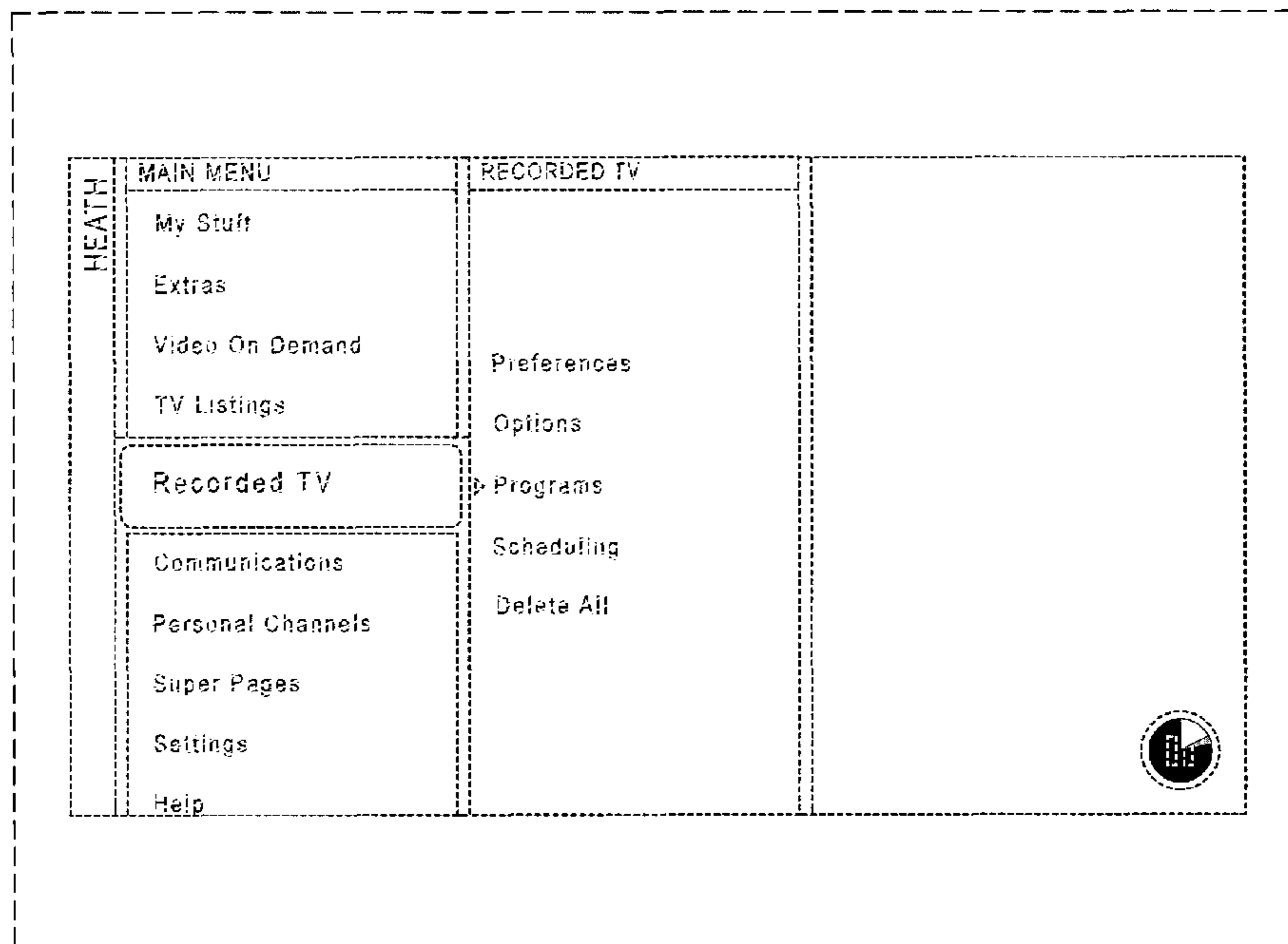
FIG. 9 is a front view of a ninth embodiment thereof; and,

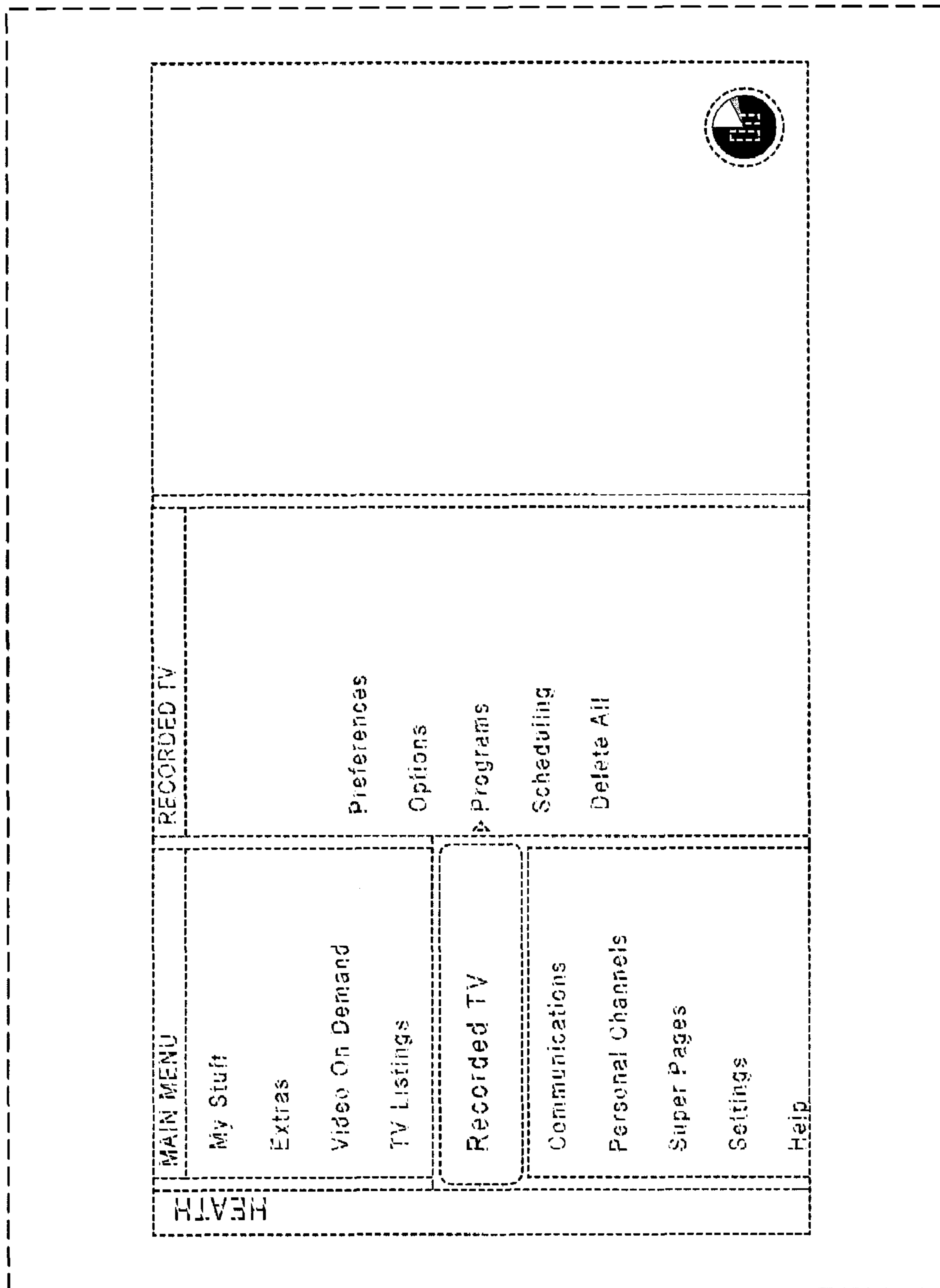

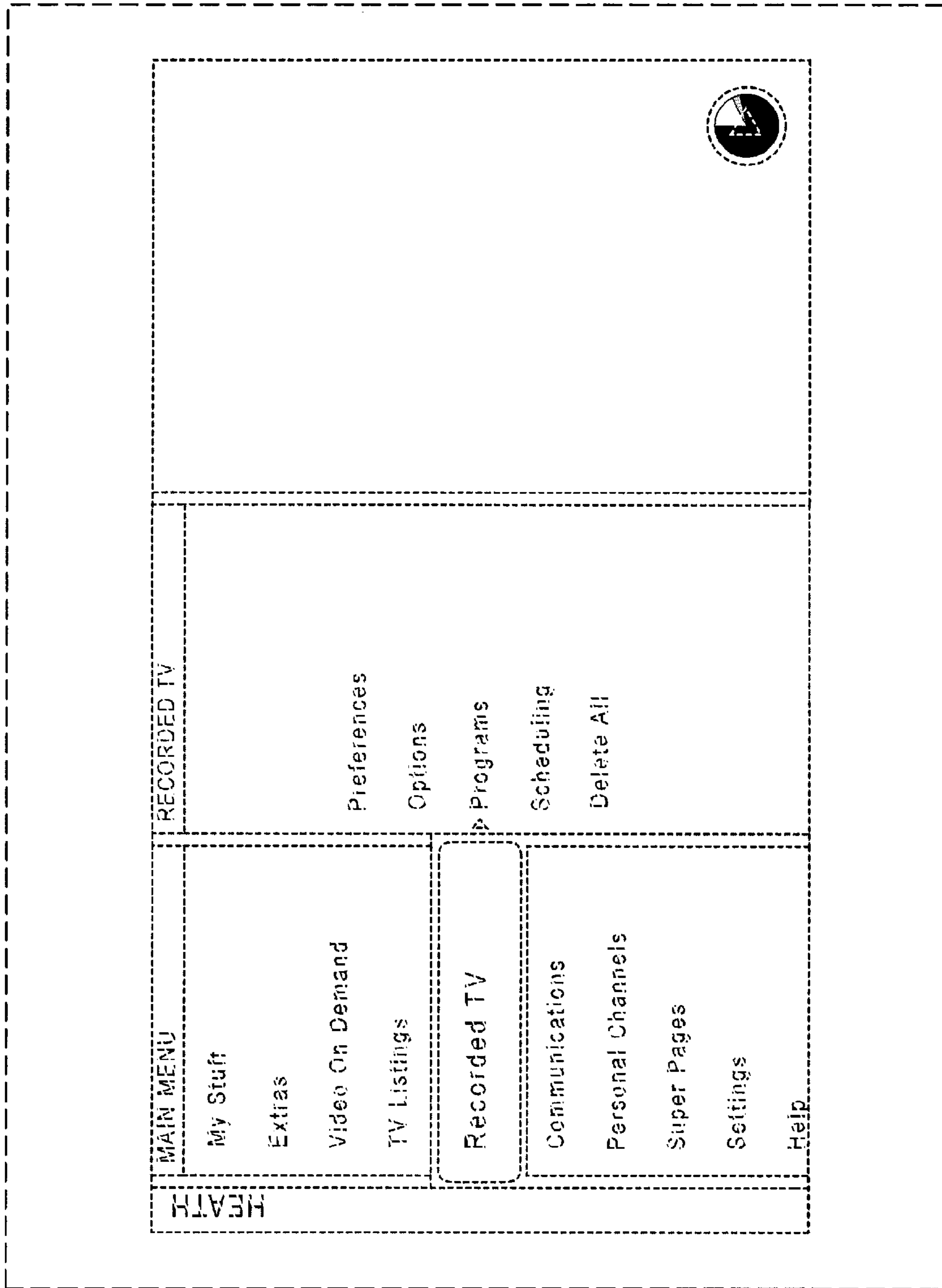

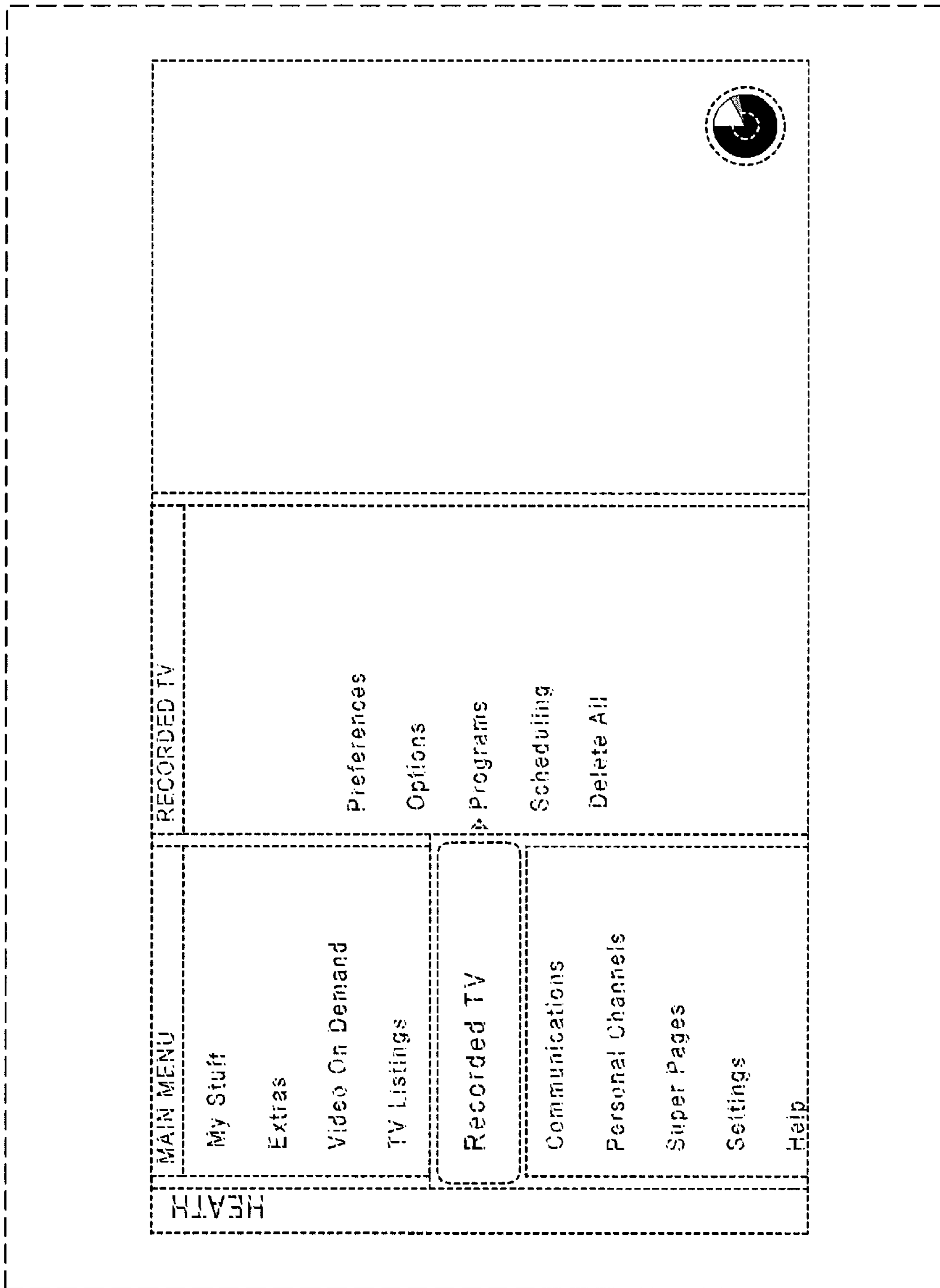

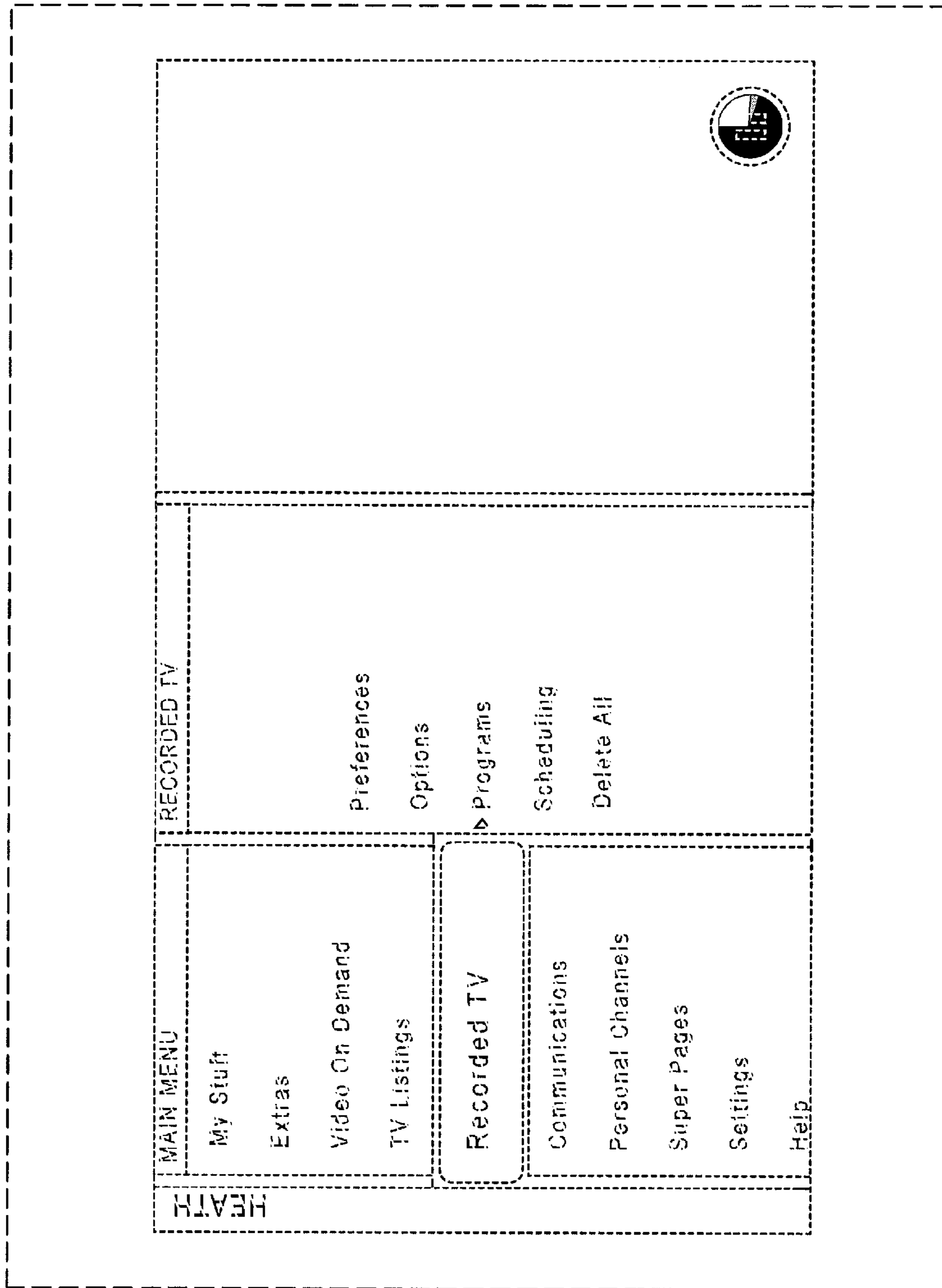

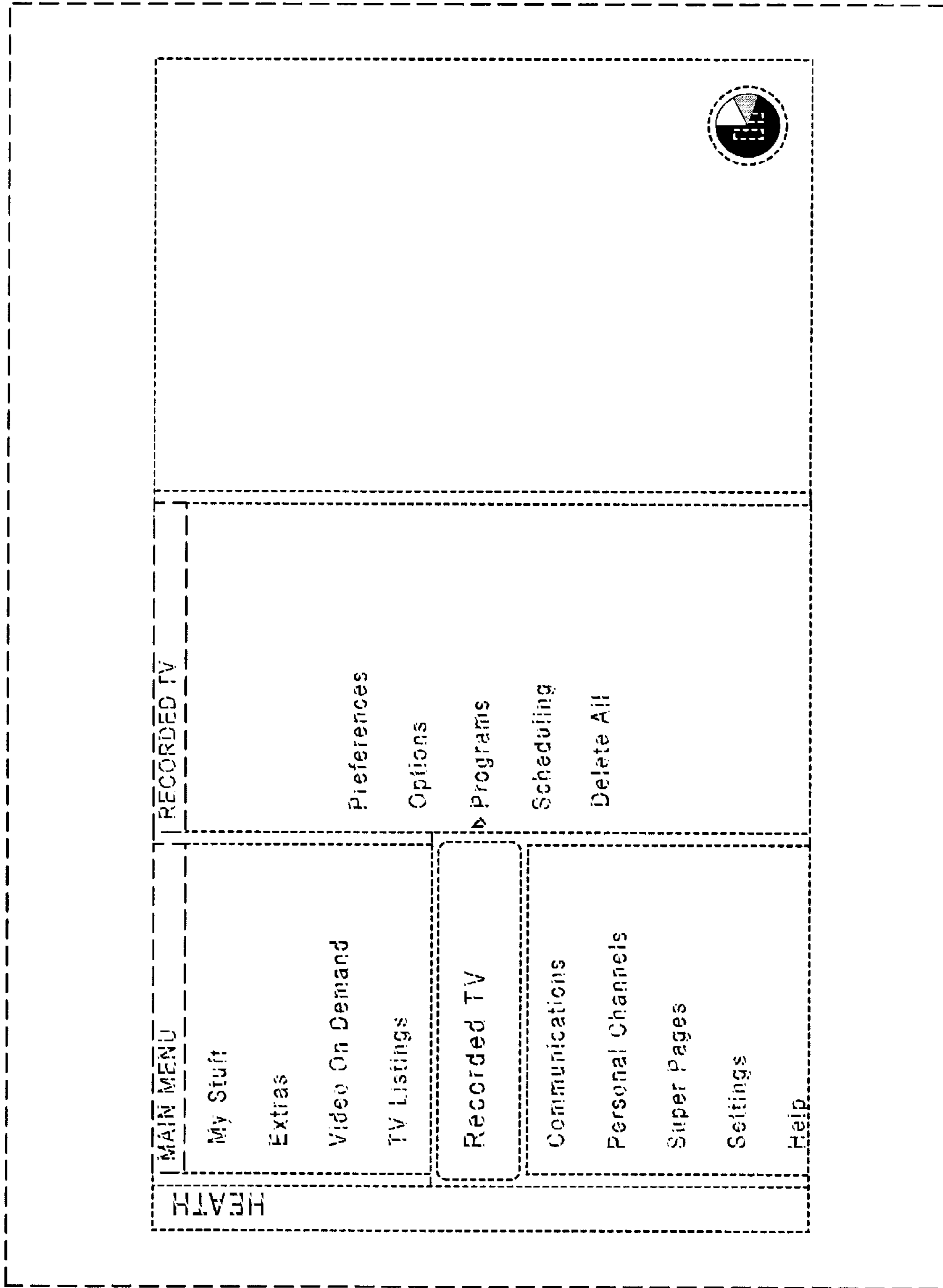

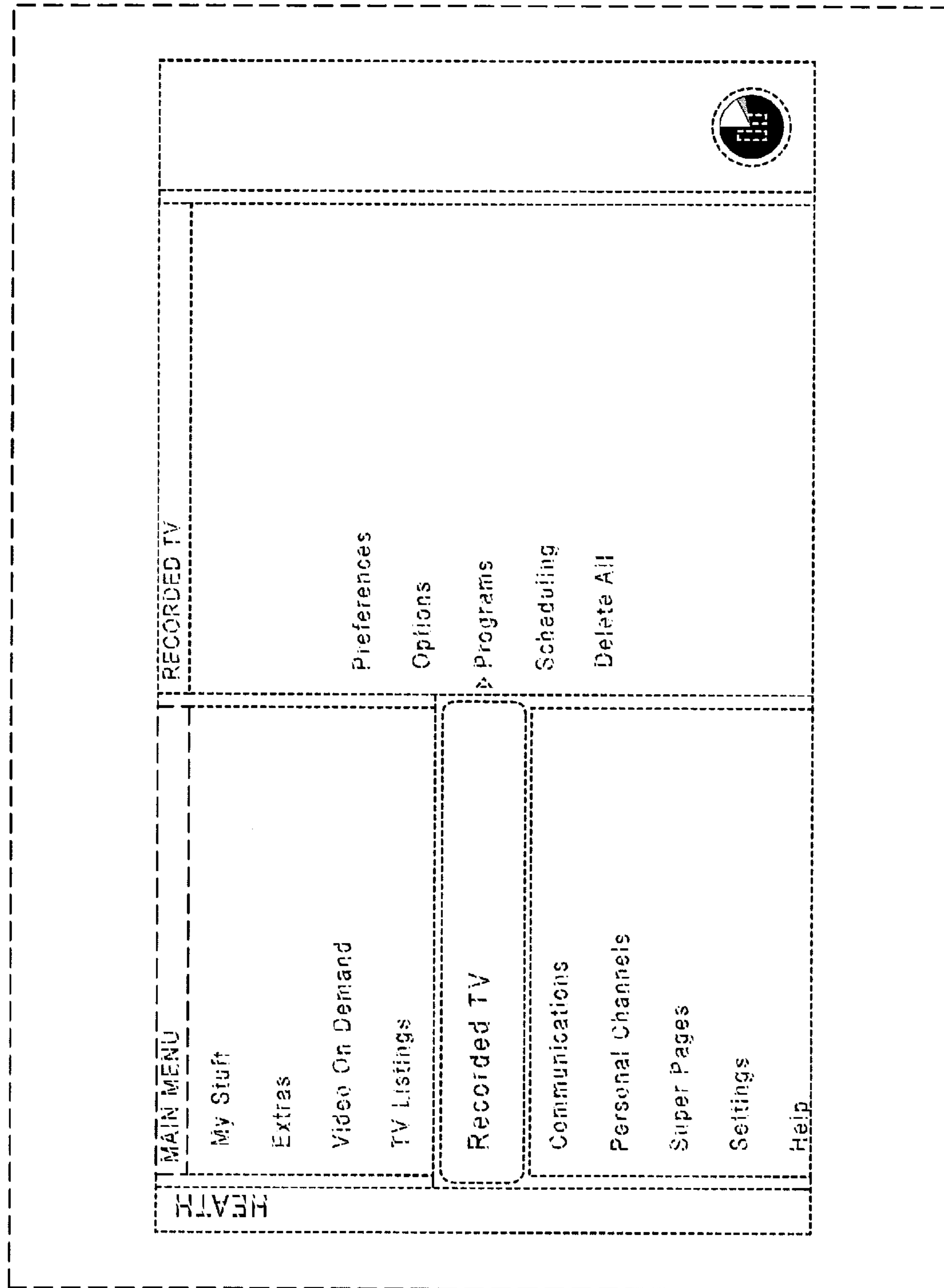

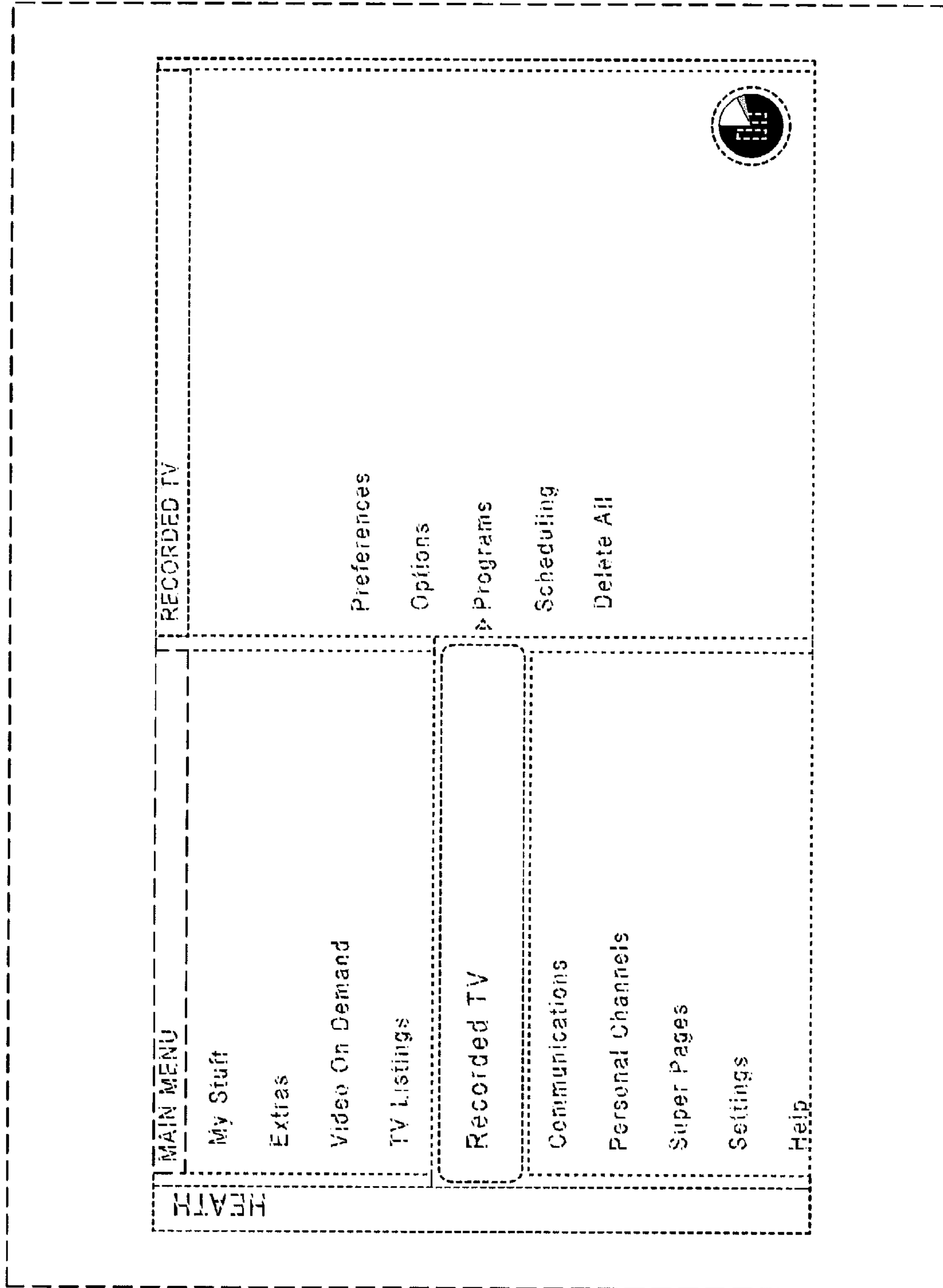

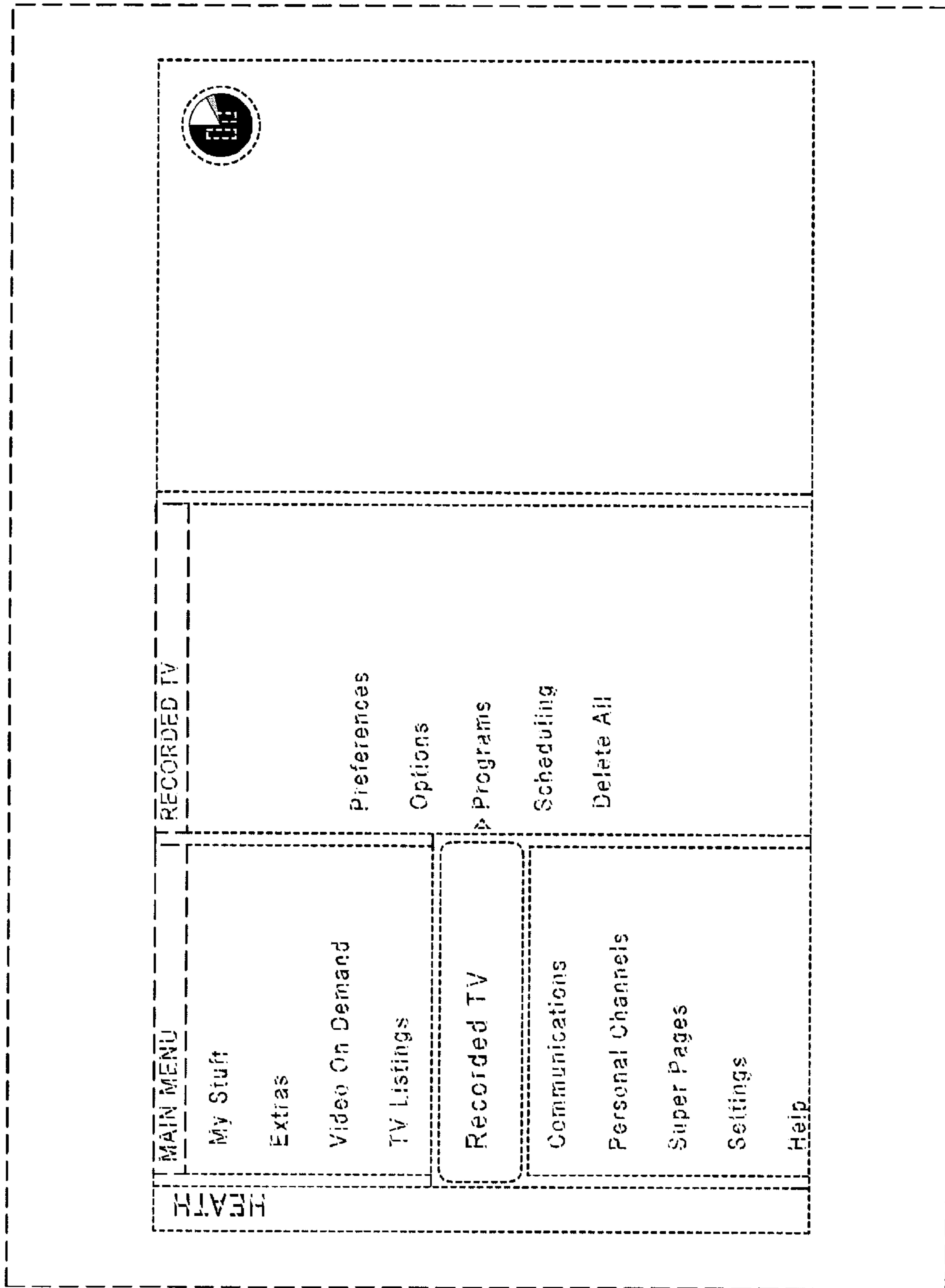

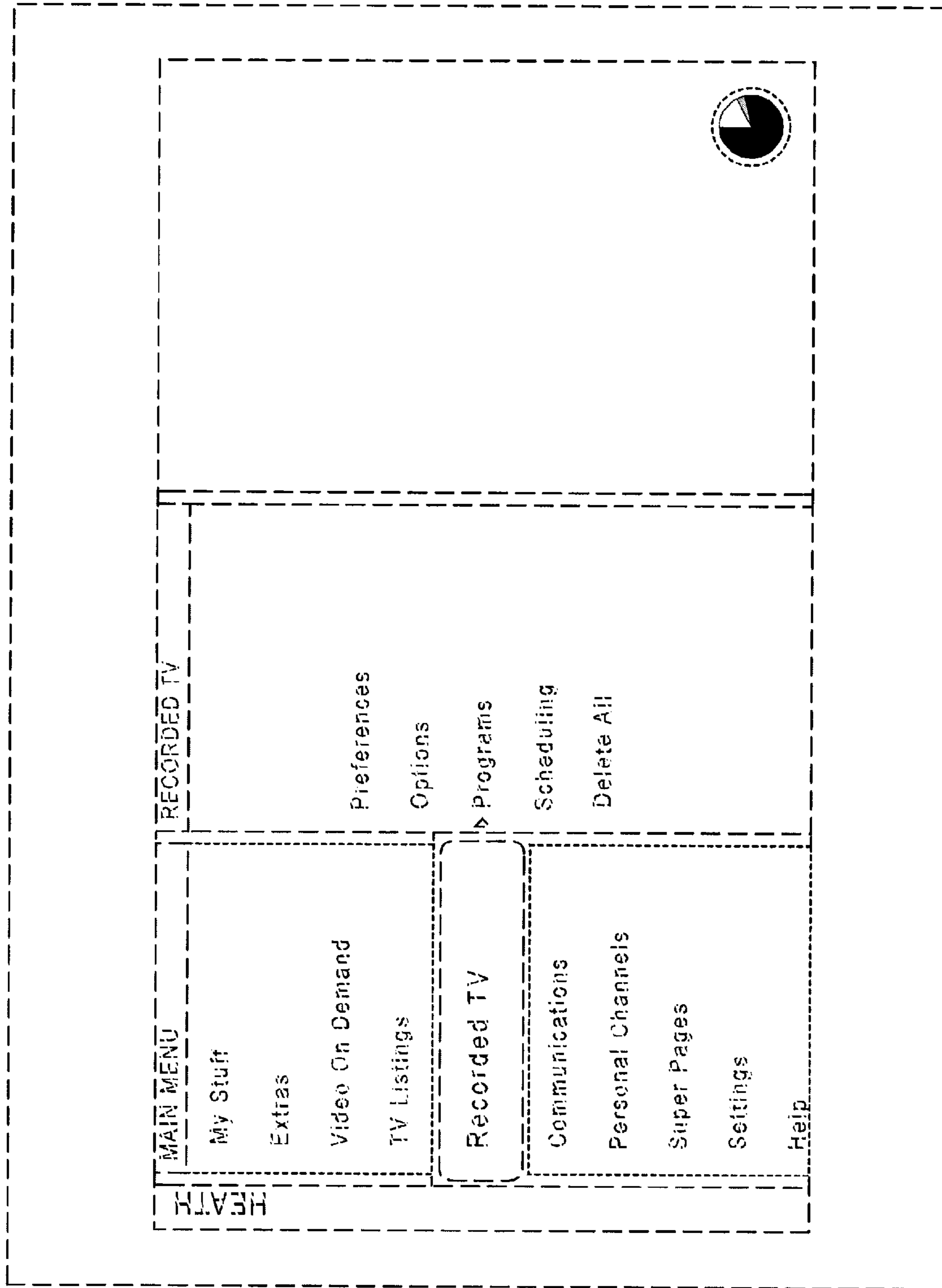

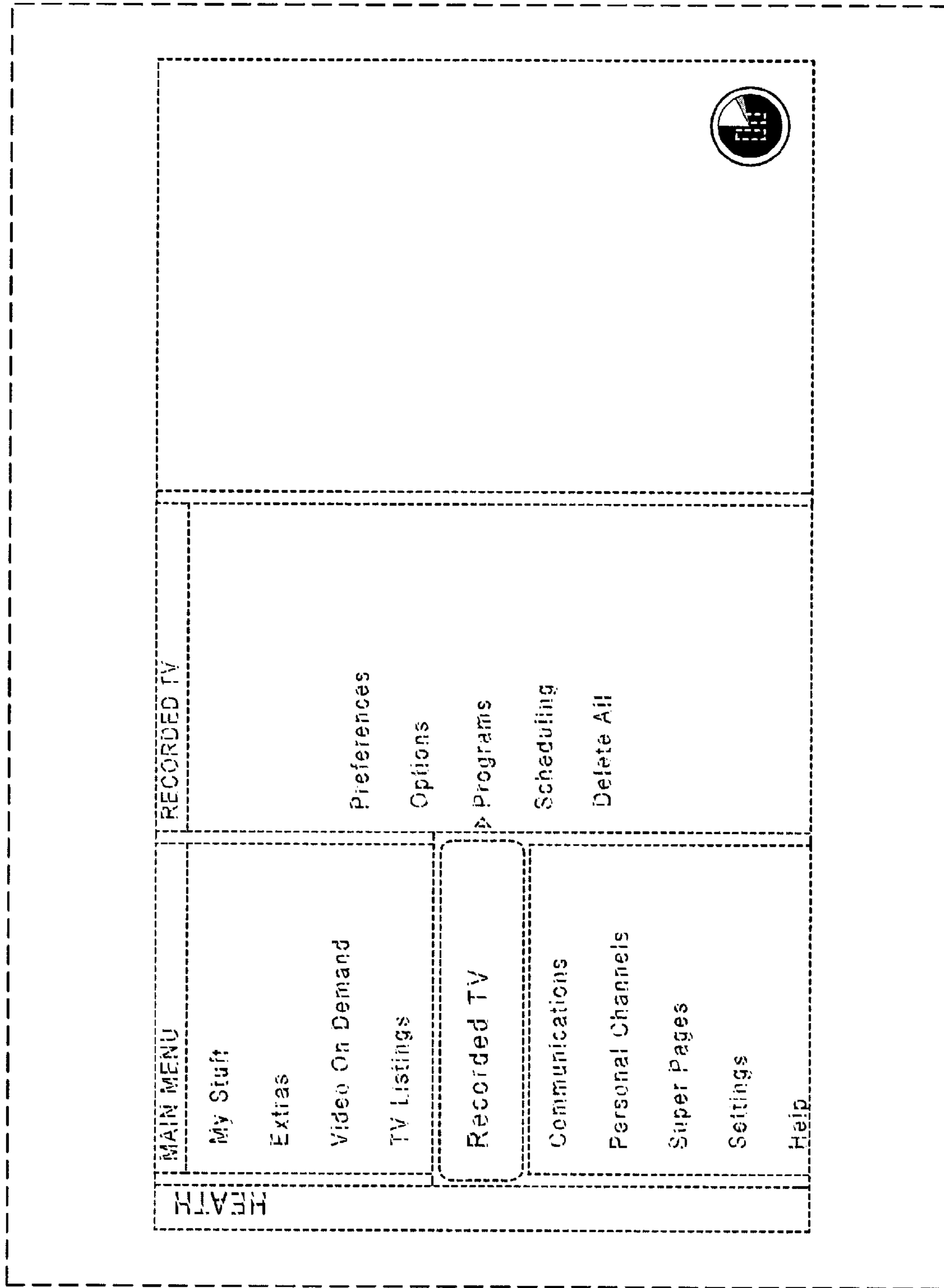
