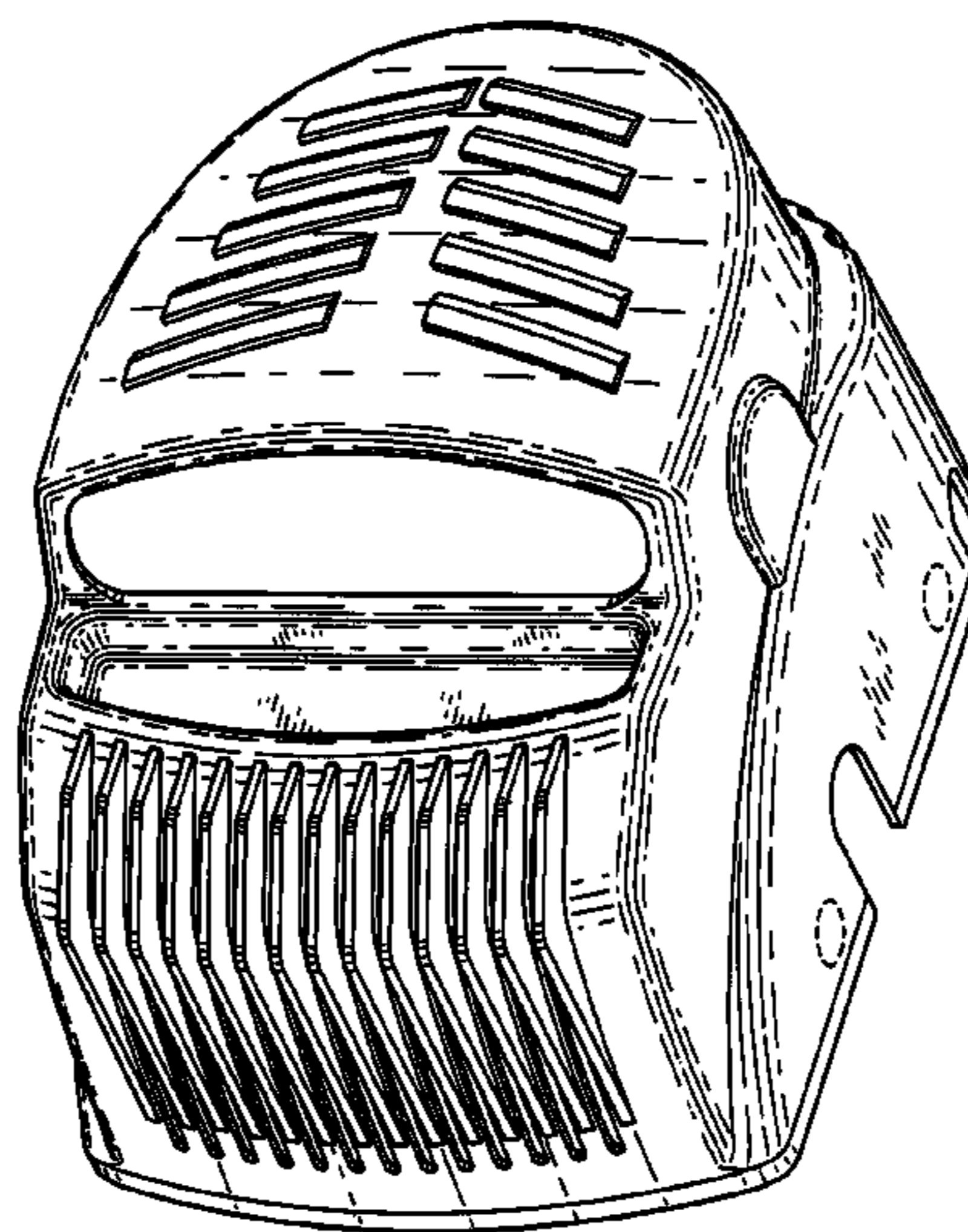
The ornamental design for an air compressor shroud, as shown and described.

DESCRIPTION

FIG. 1 is an elevated front perspective view of the present air compressor shroud;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken line showing of FIGS. 1, 3, 5 and 7 forms the boundary of the design, with the broken lines forming no part of the claimed design or a specified embodiment thereof.

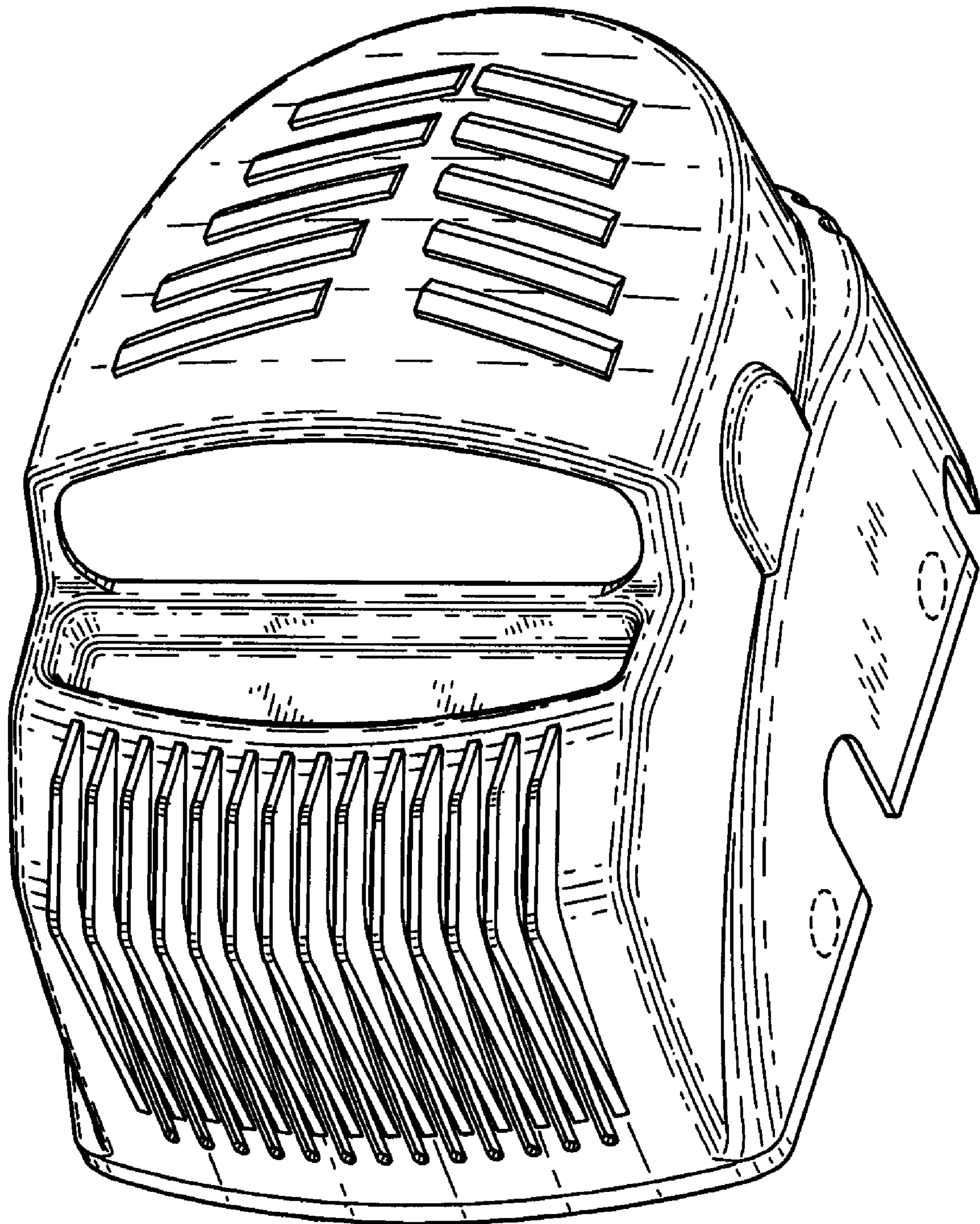

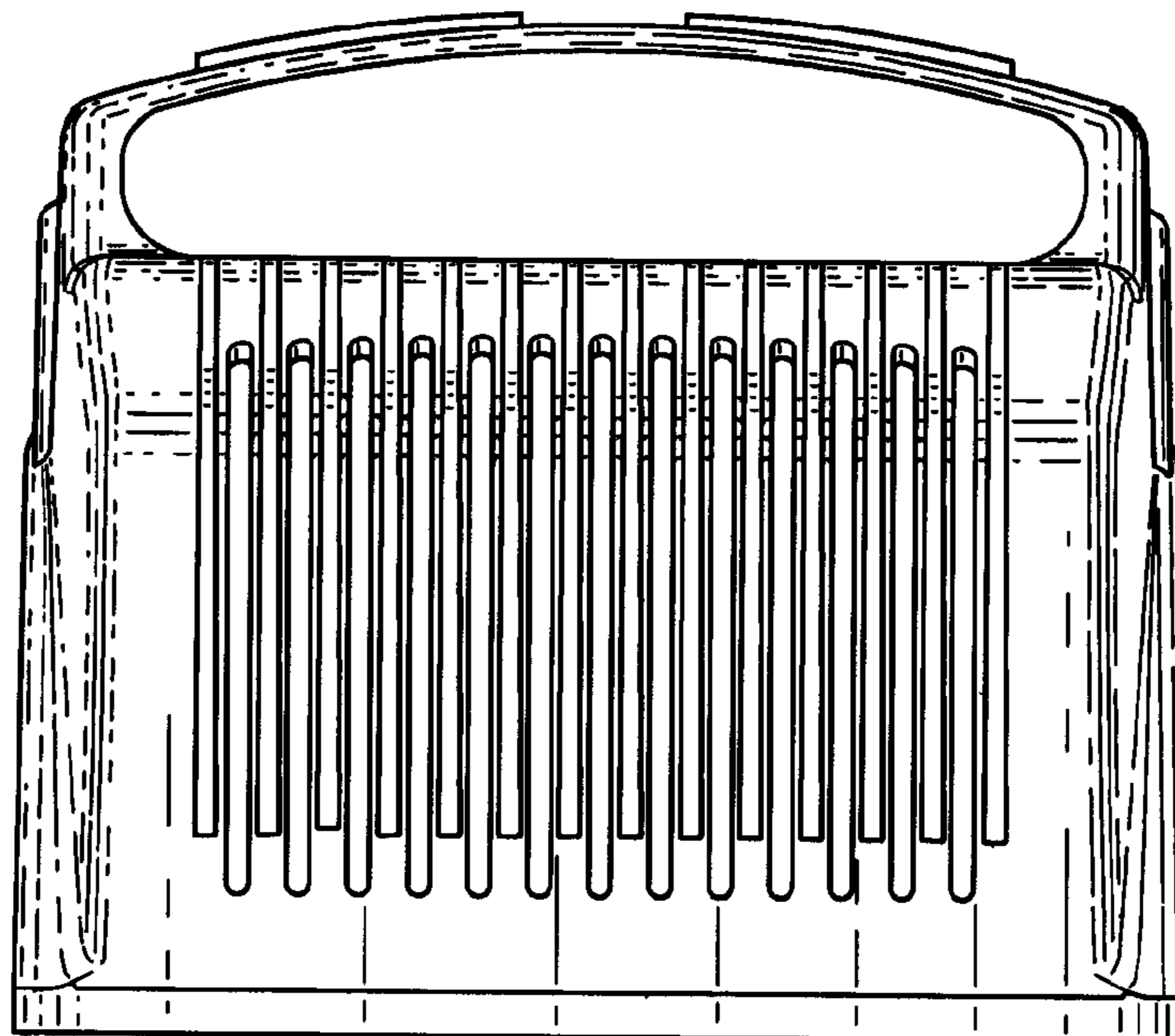

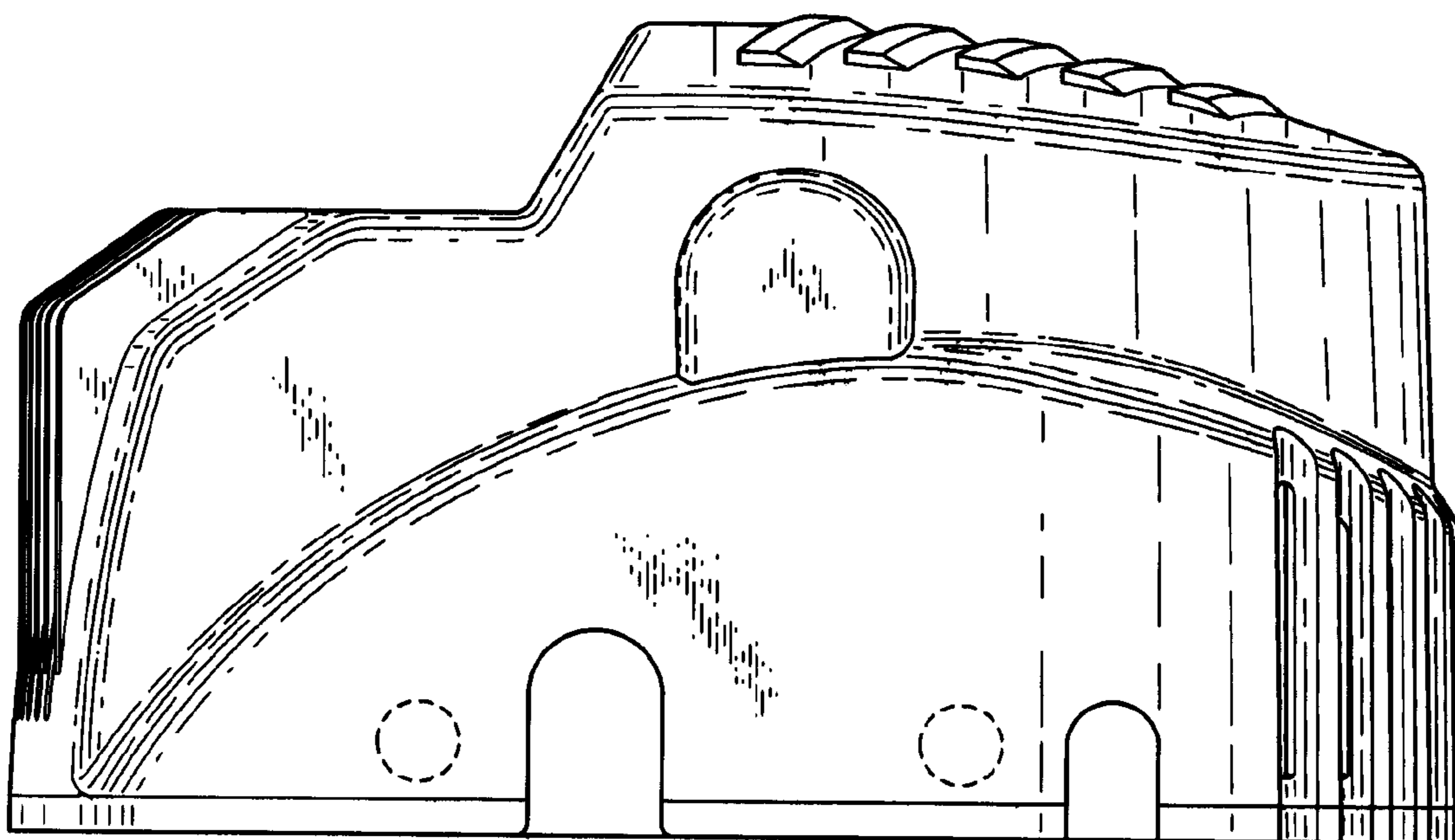

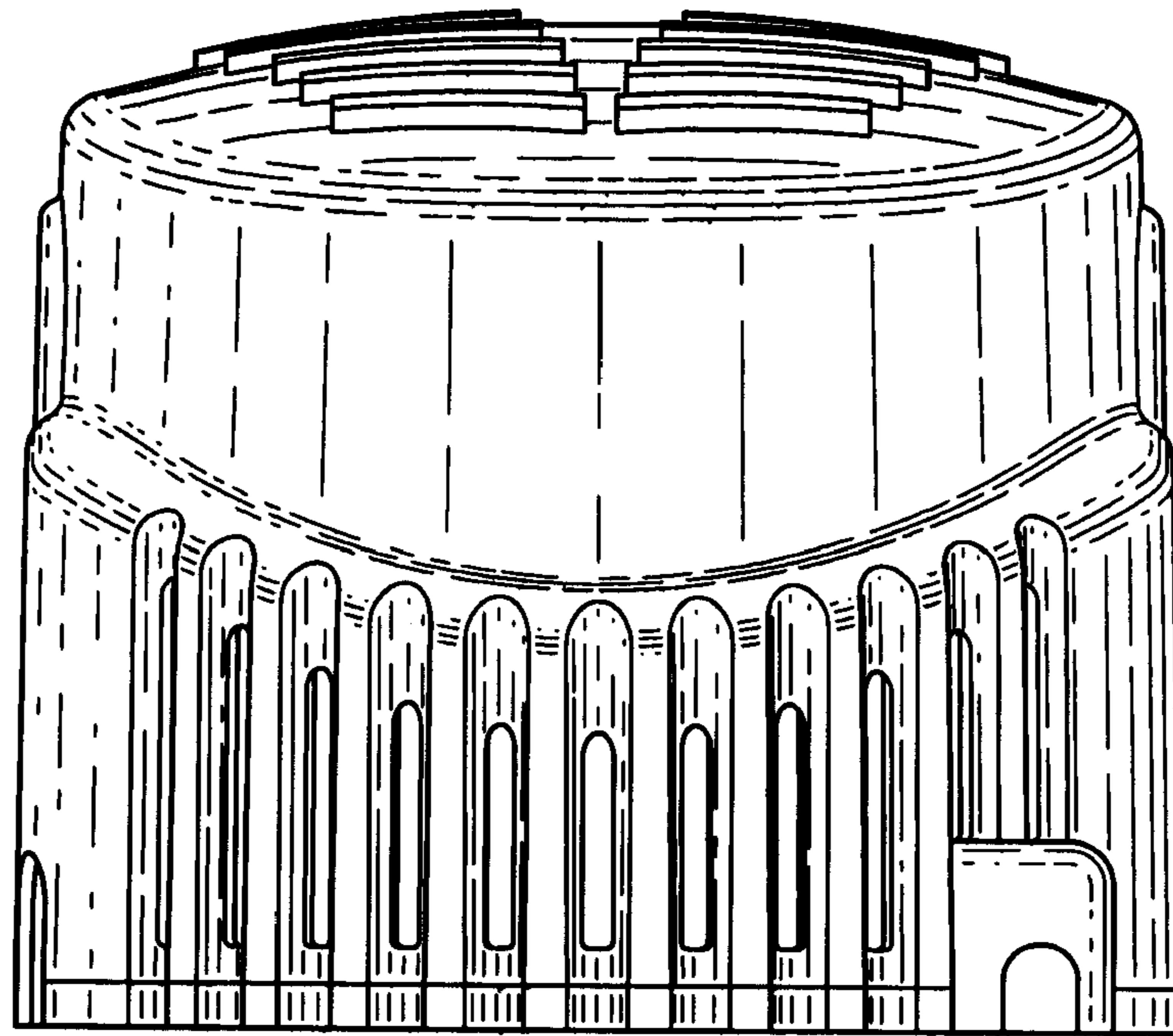

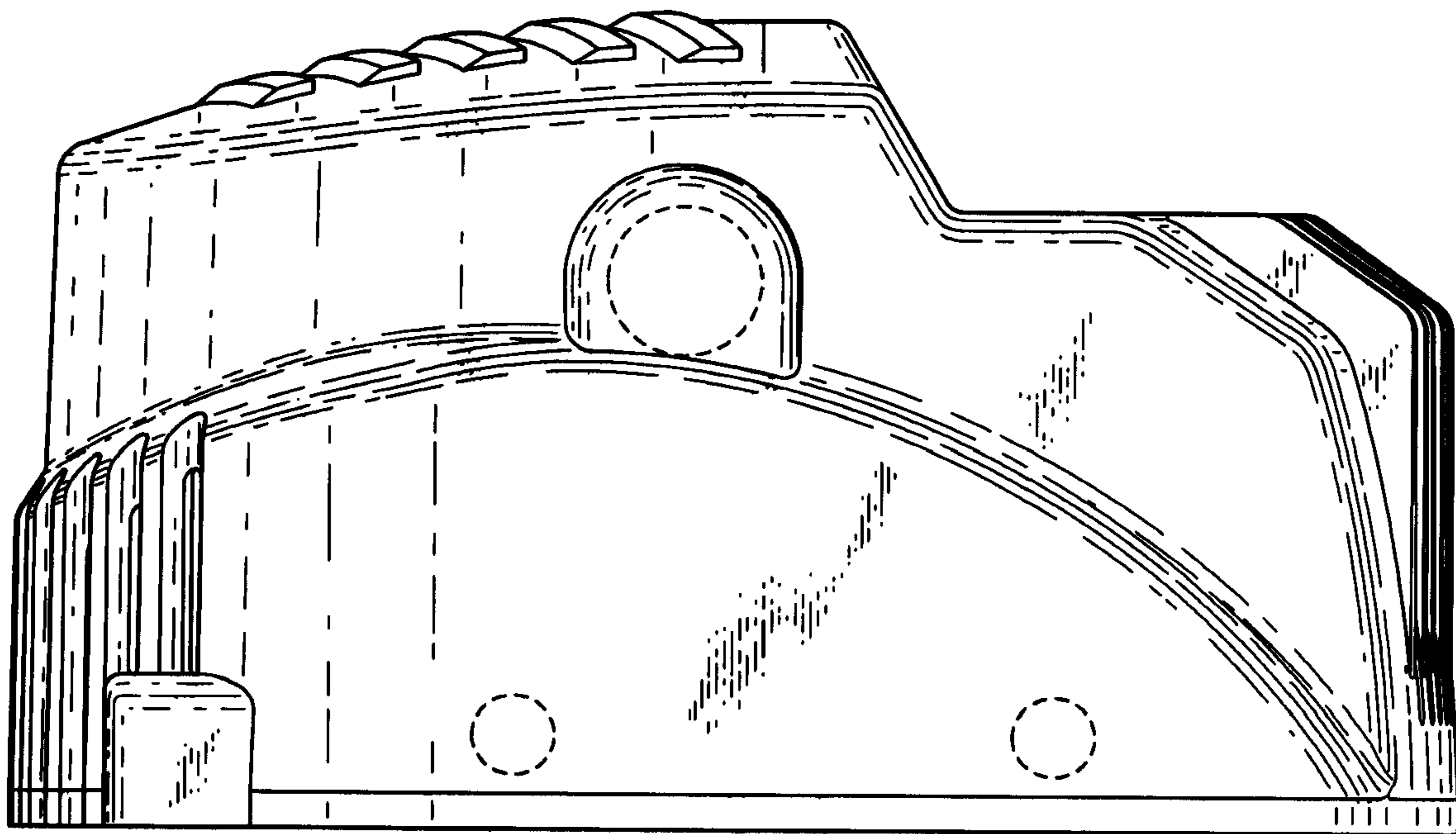

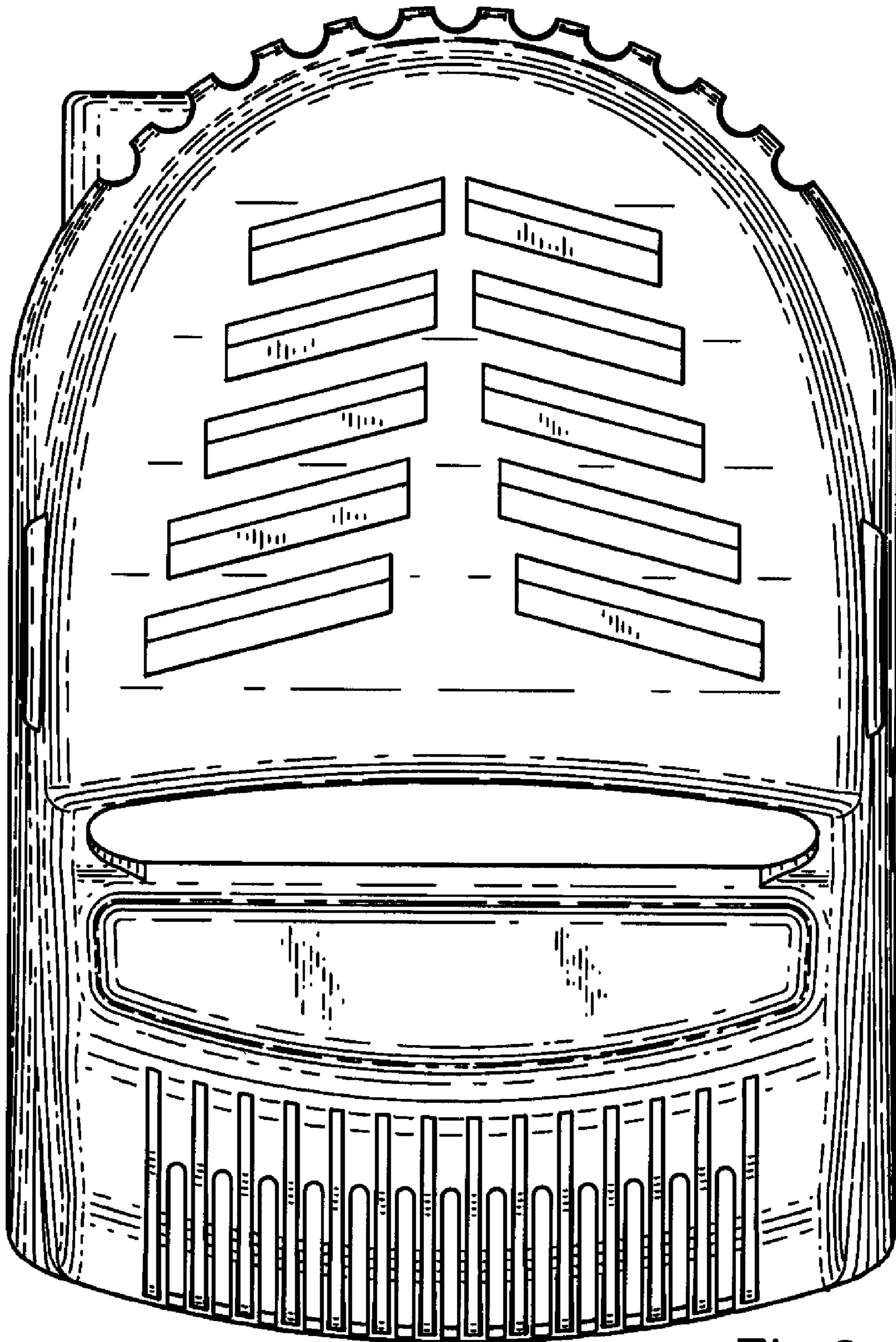

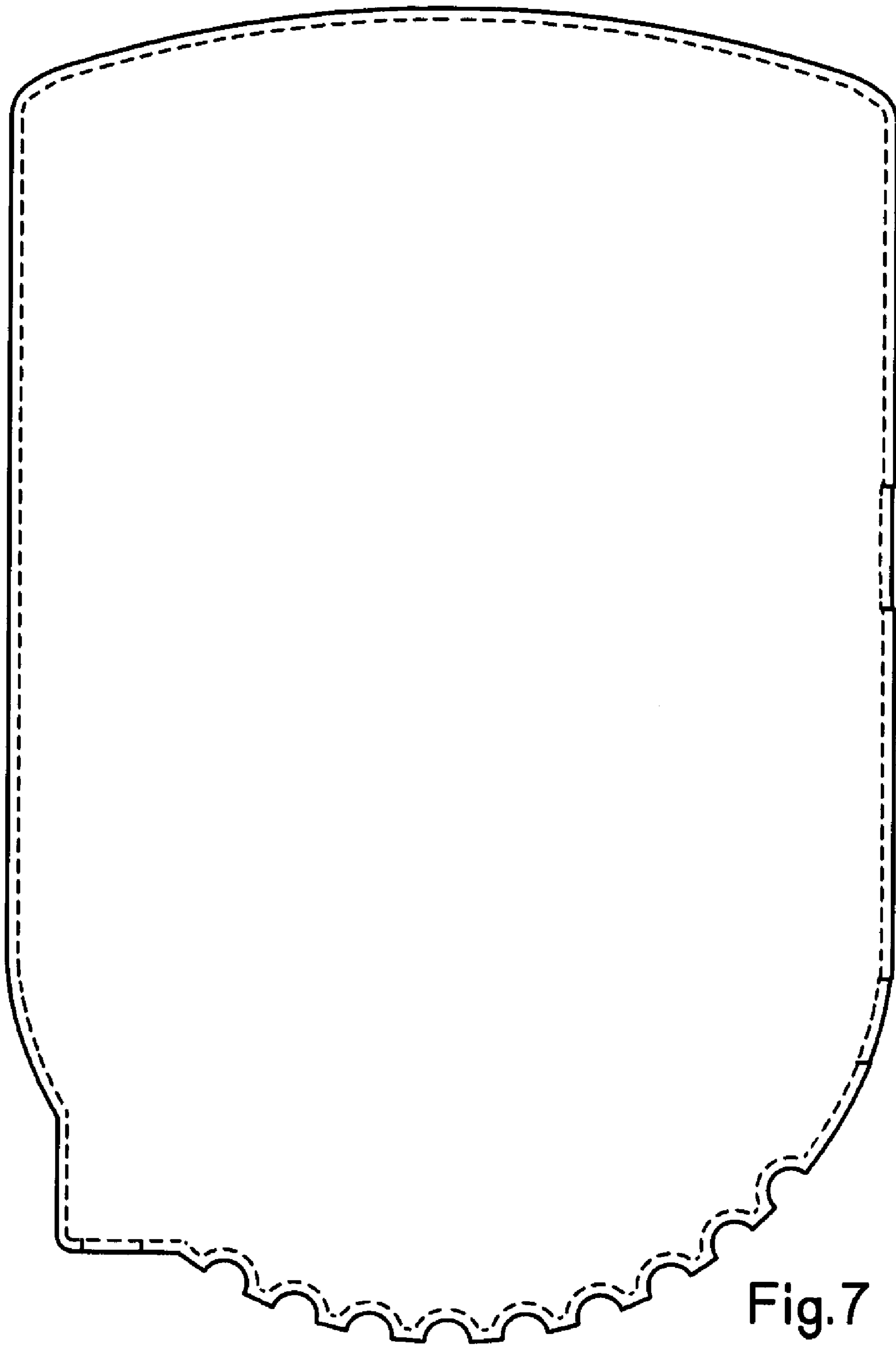
