(57) **CLAIM**

I claim the ornamental design for a label, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a label showing my new design; and,

FIG. 2. Is an enlarged fragmentary top plan view of a label of FIG. 1, showing the label in greater detail.

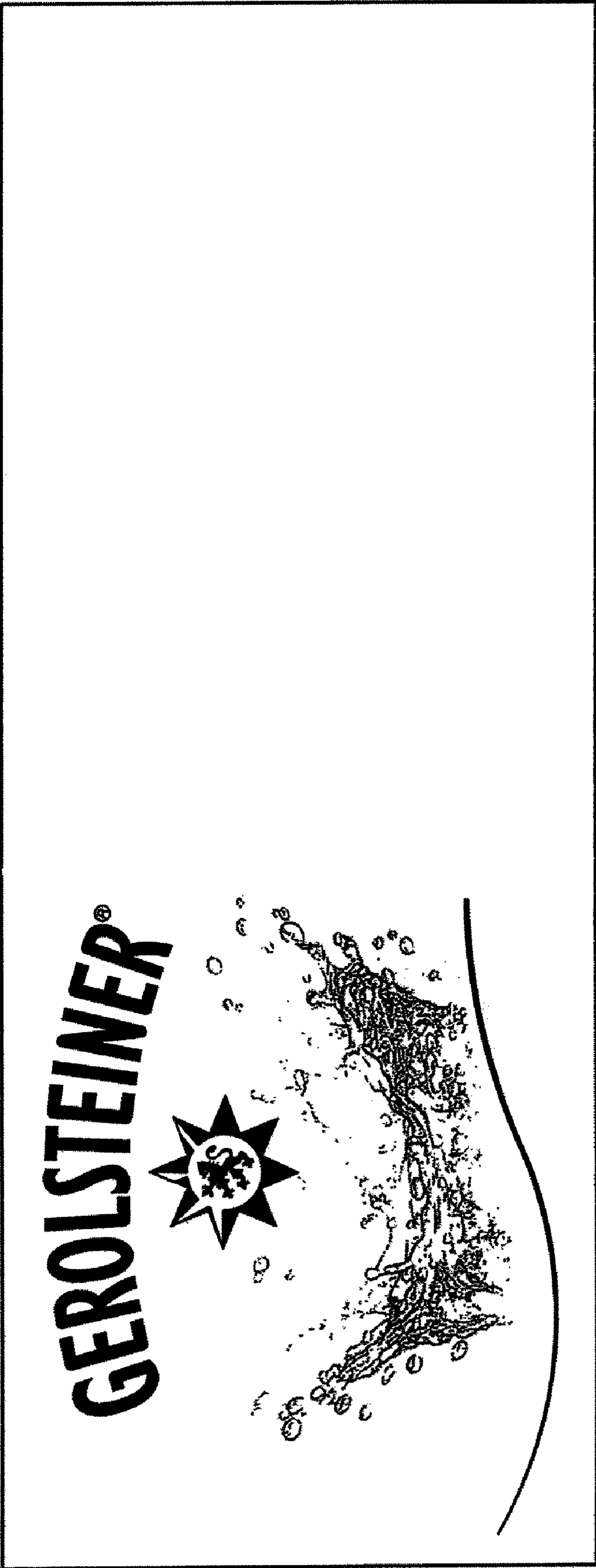

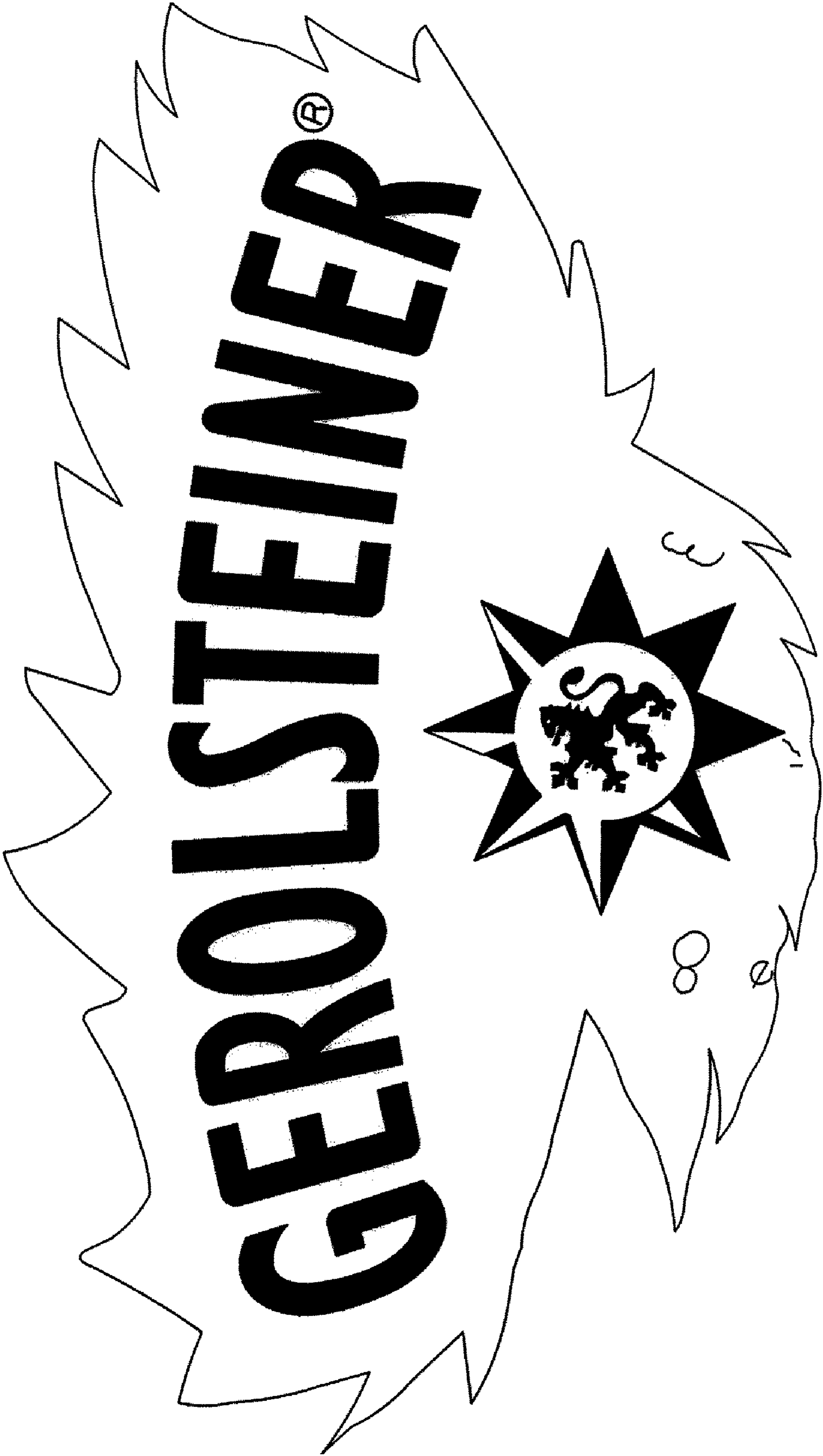
