(57) **CLAIM**

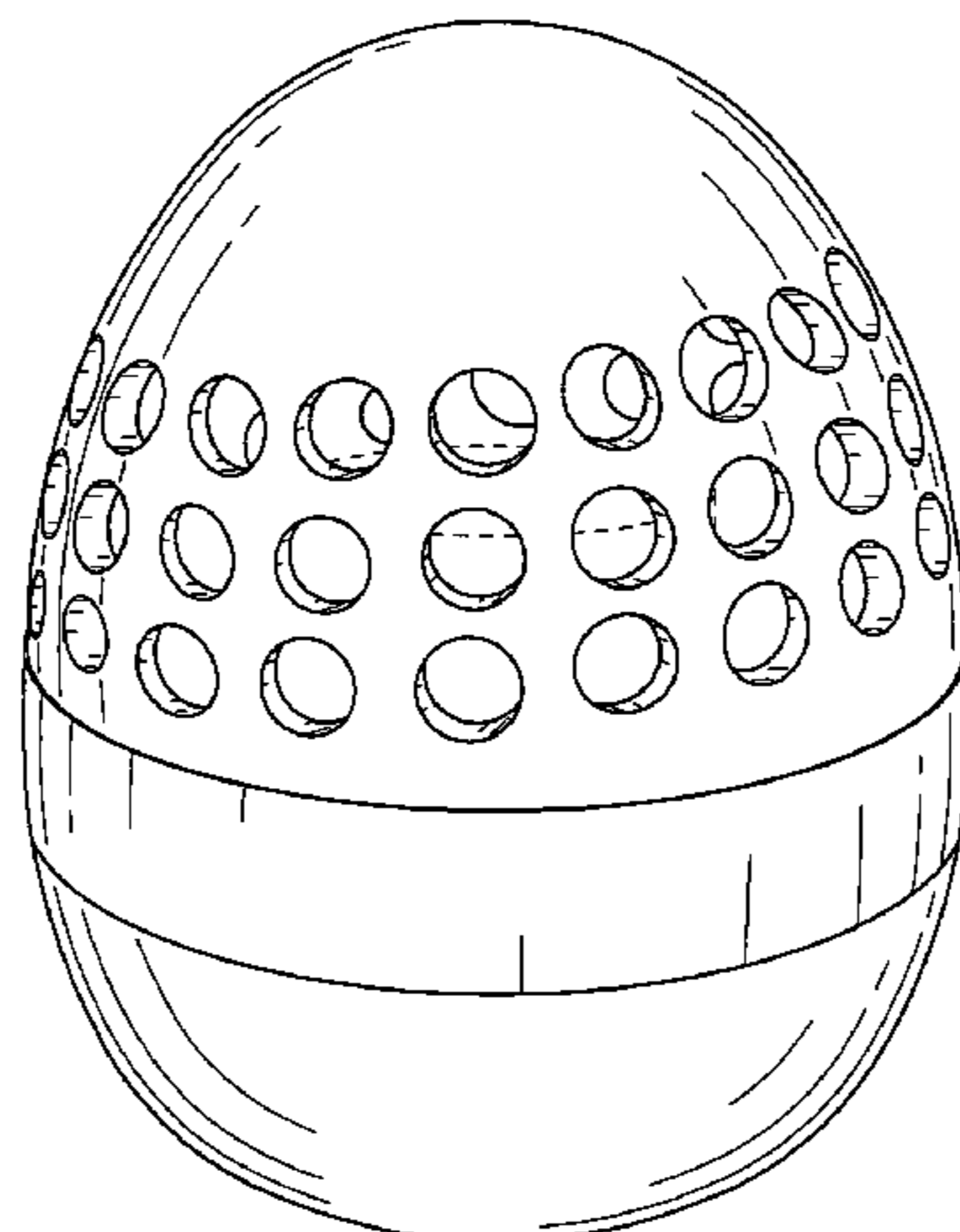
The ornamental design for an air freshener device, as shown and described.

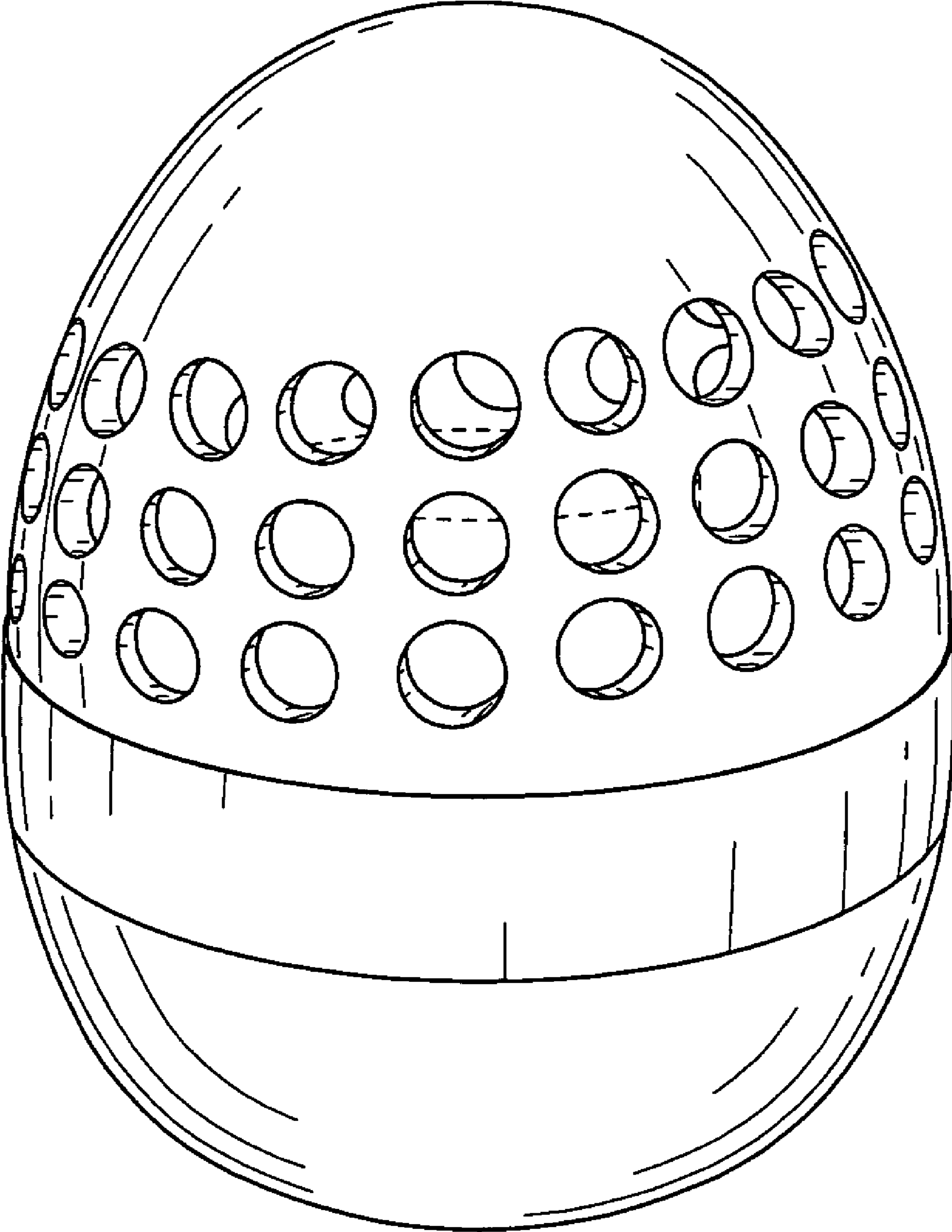

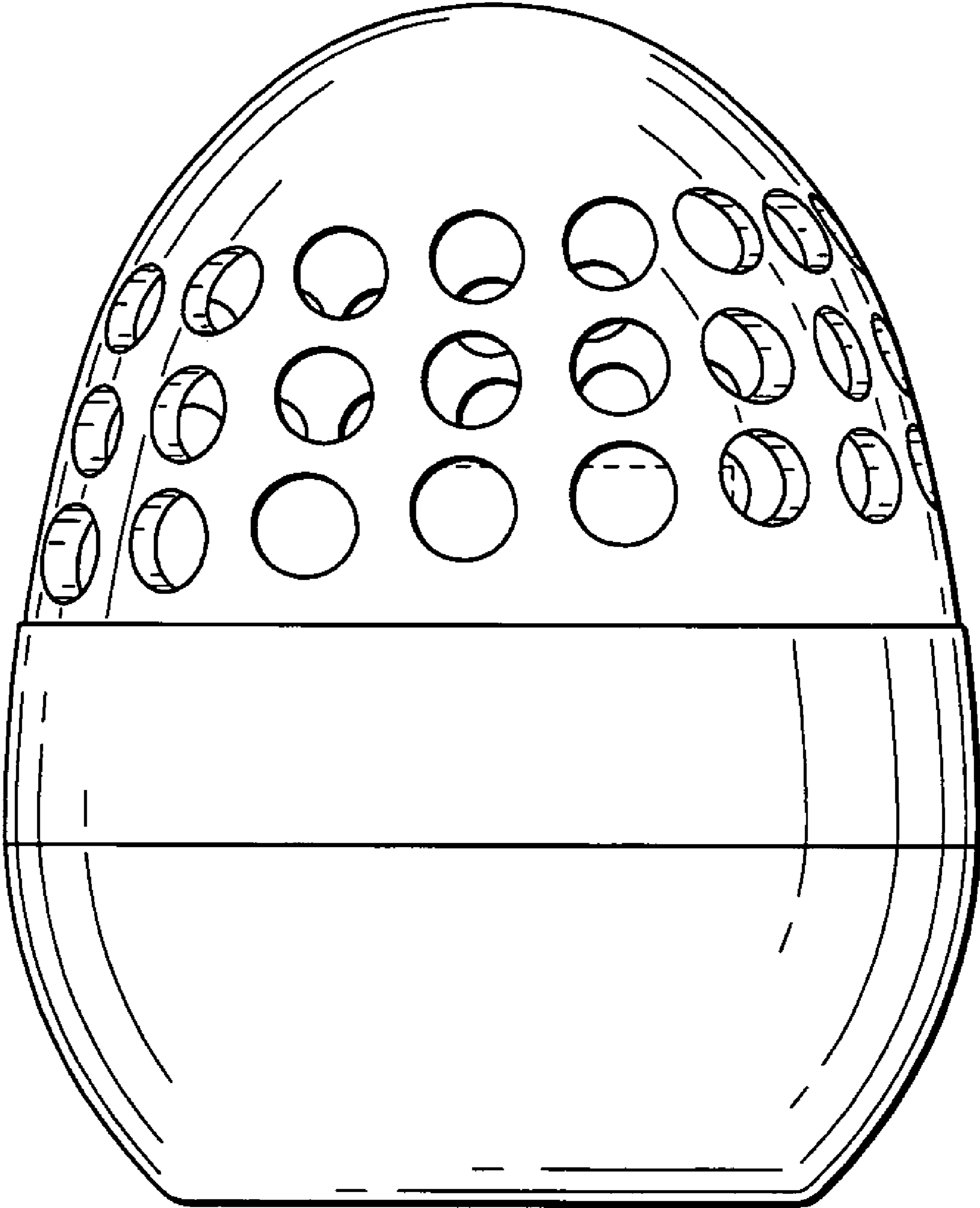

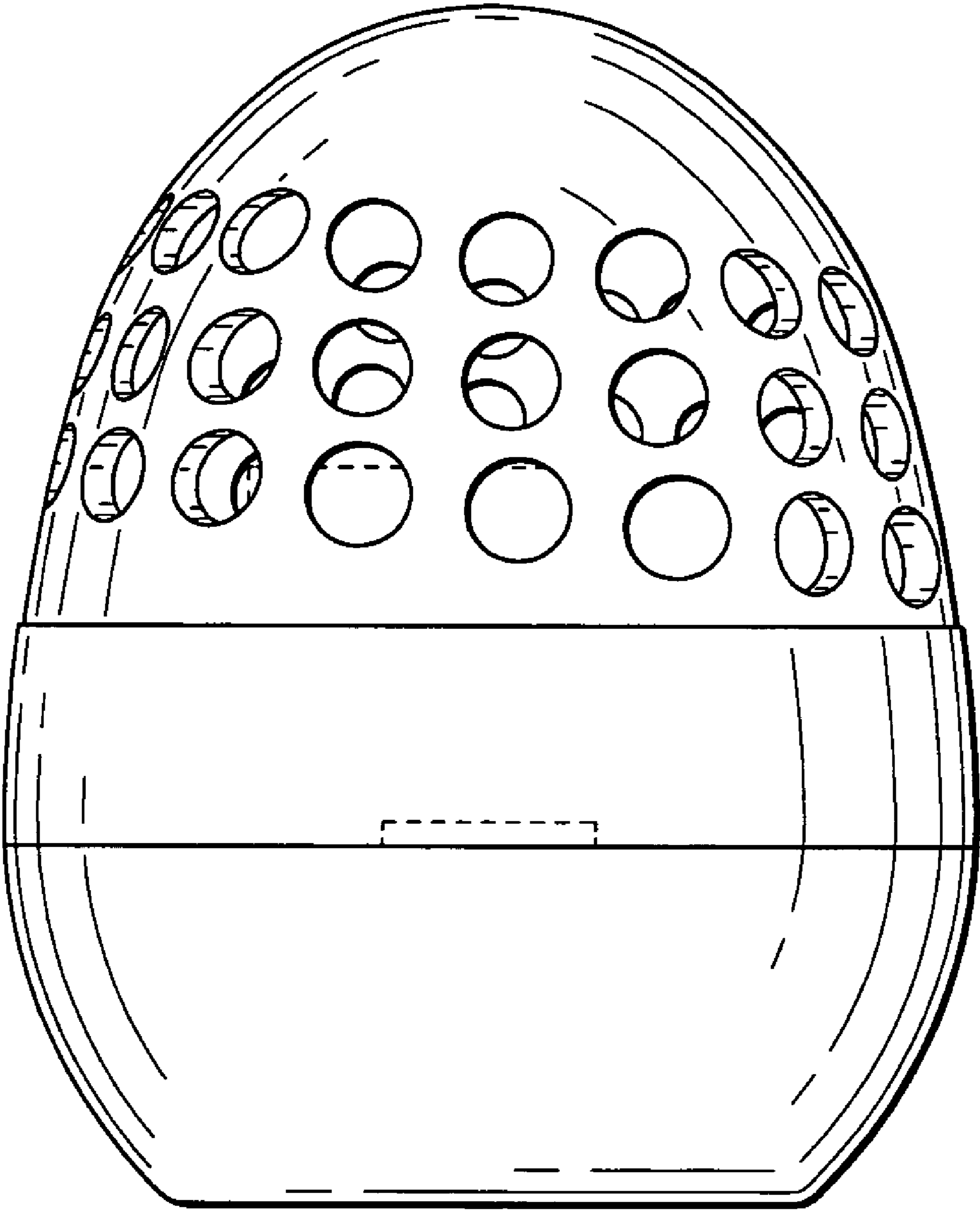

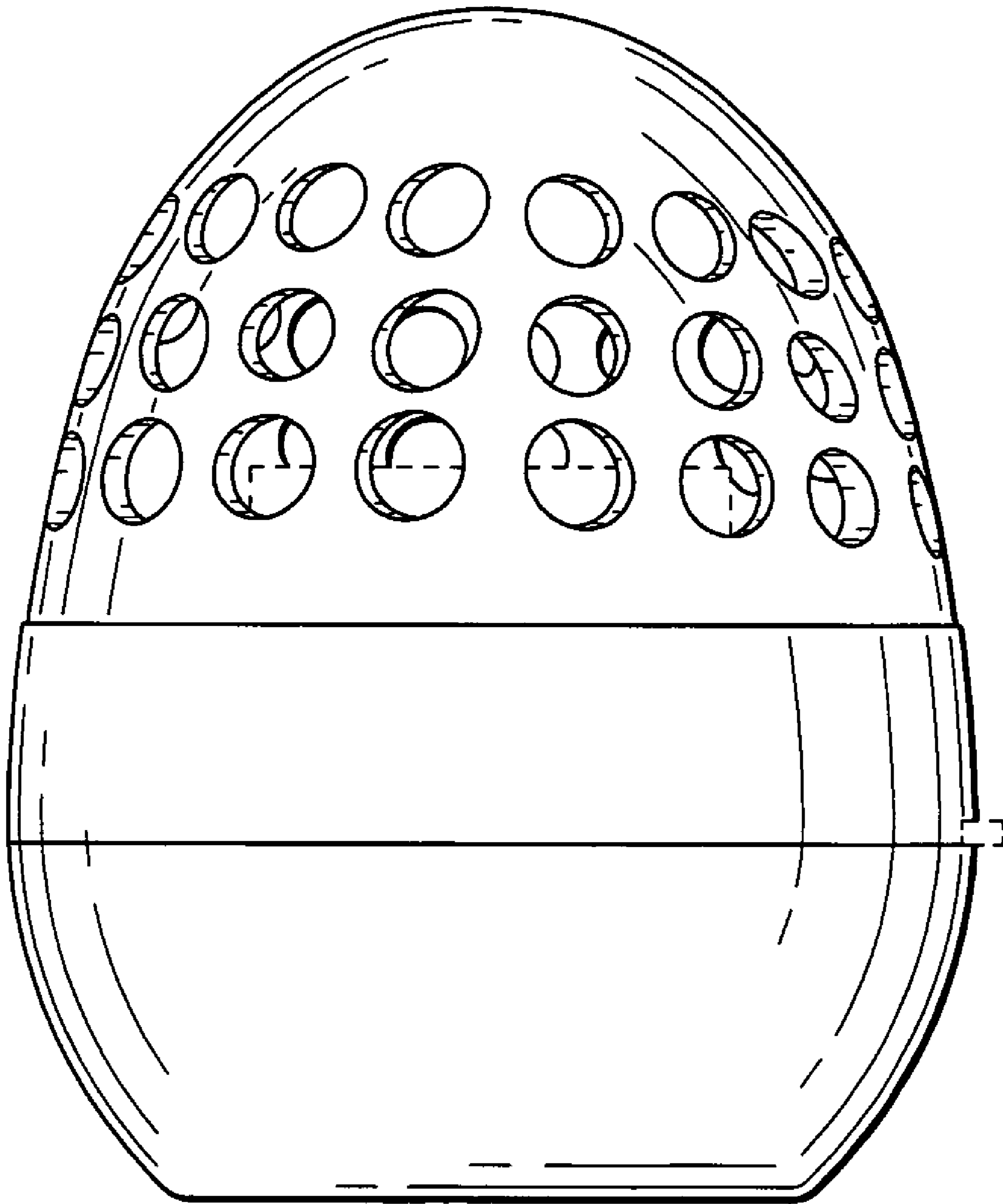

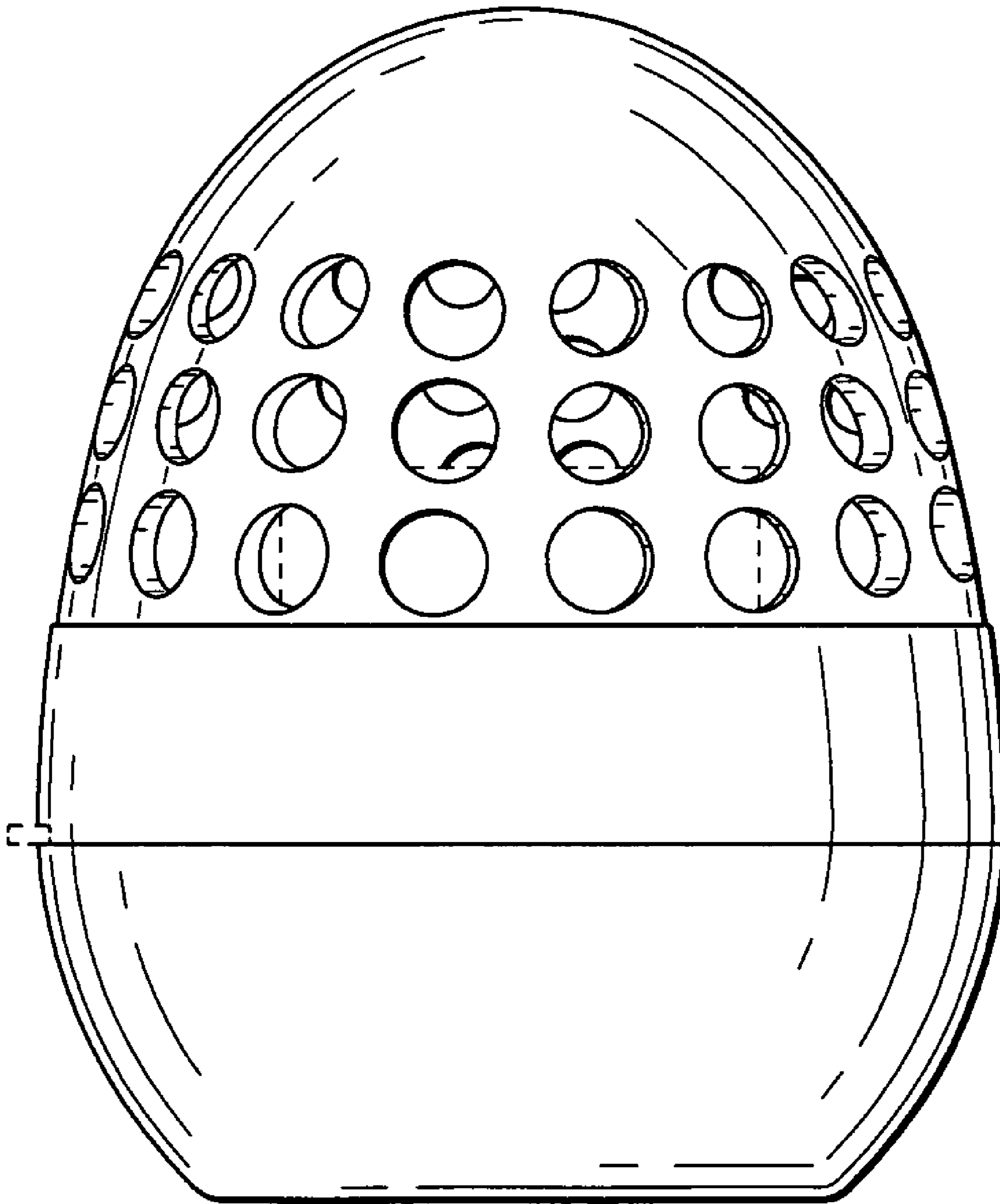

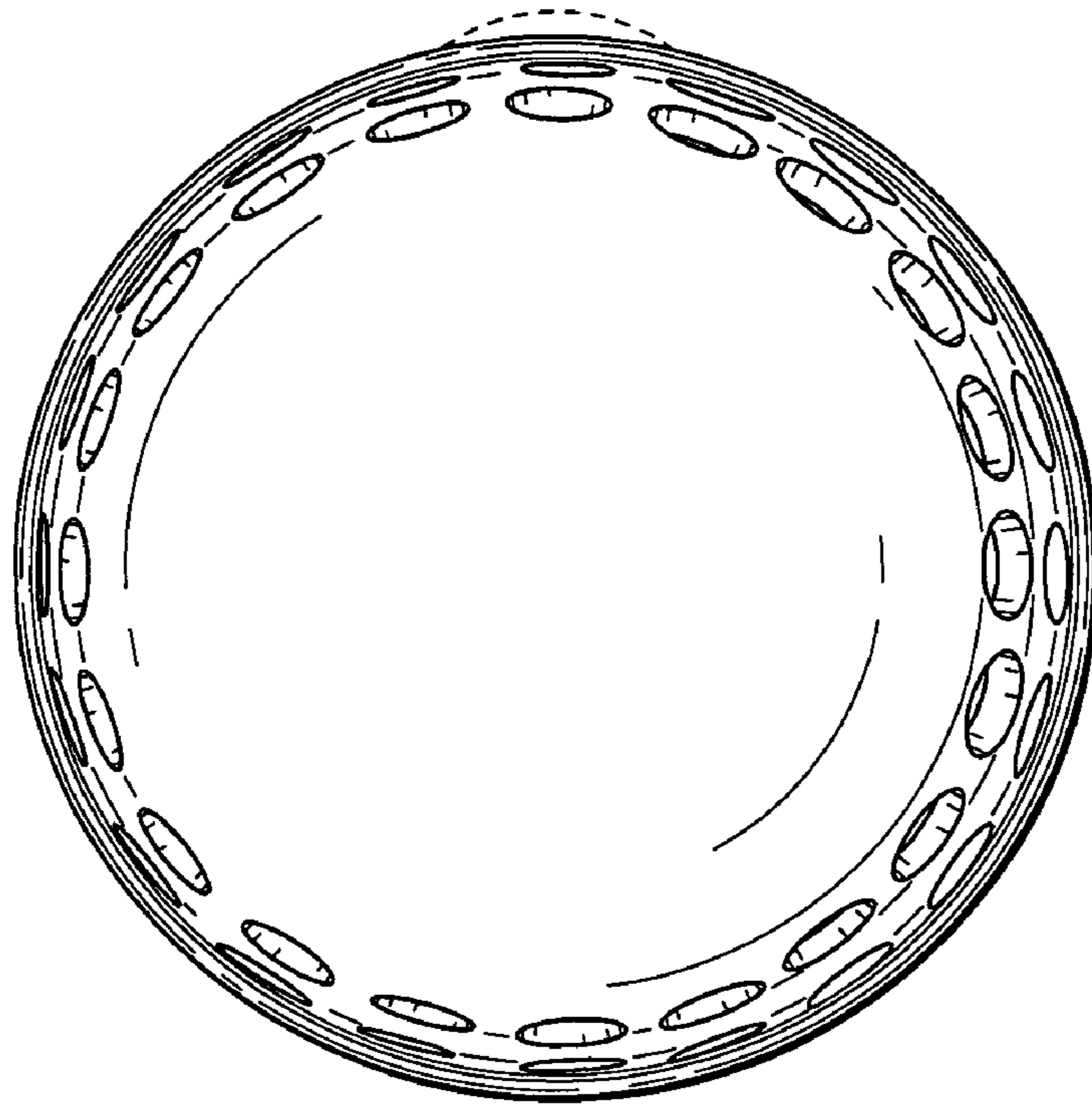
