DESCRIPTION

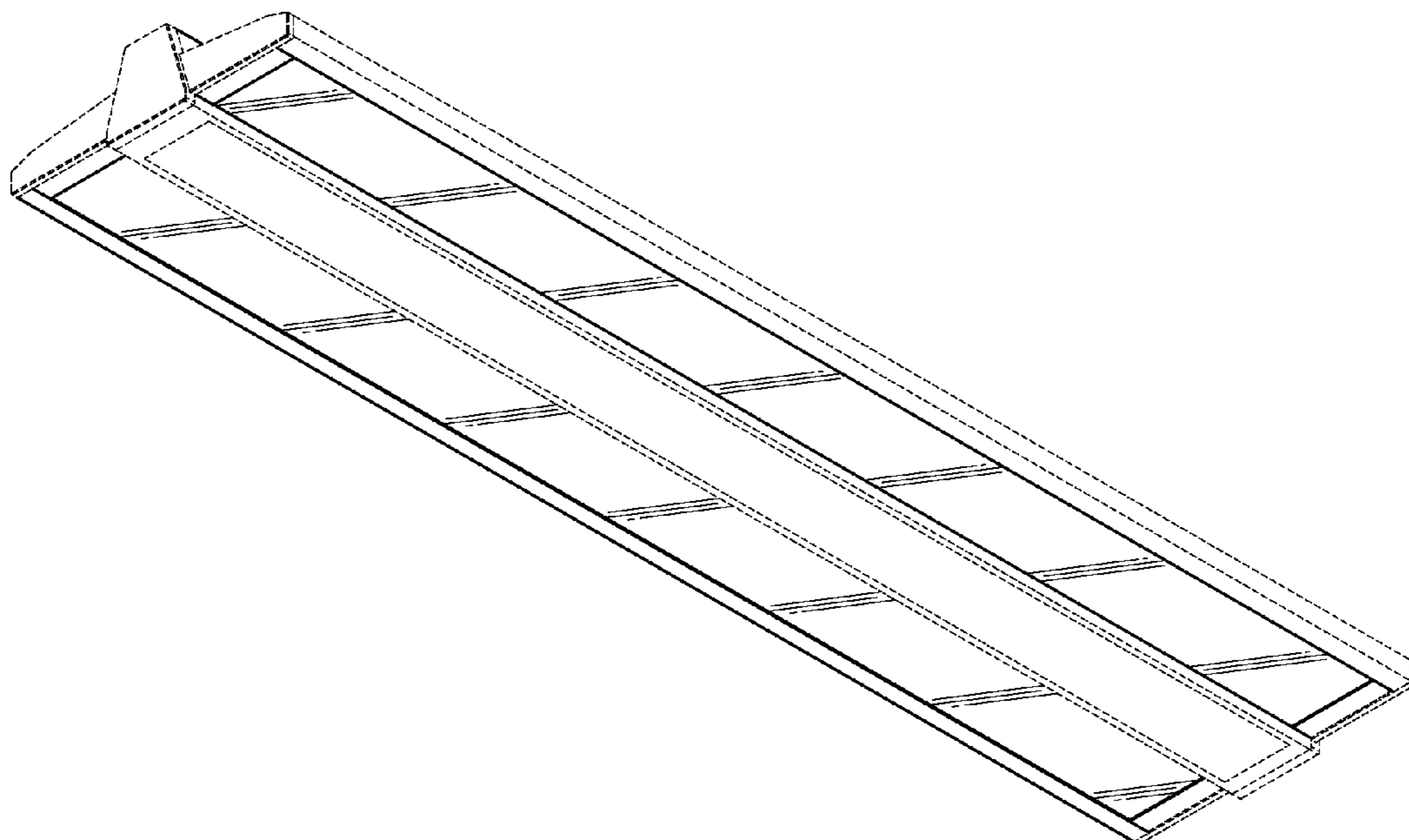
FIG. 1 is a lower perspective view of the luminaire of the present invention; and,

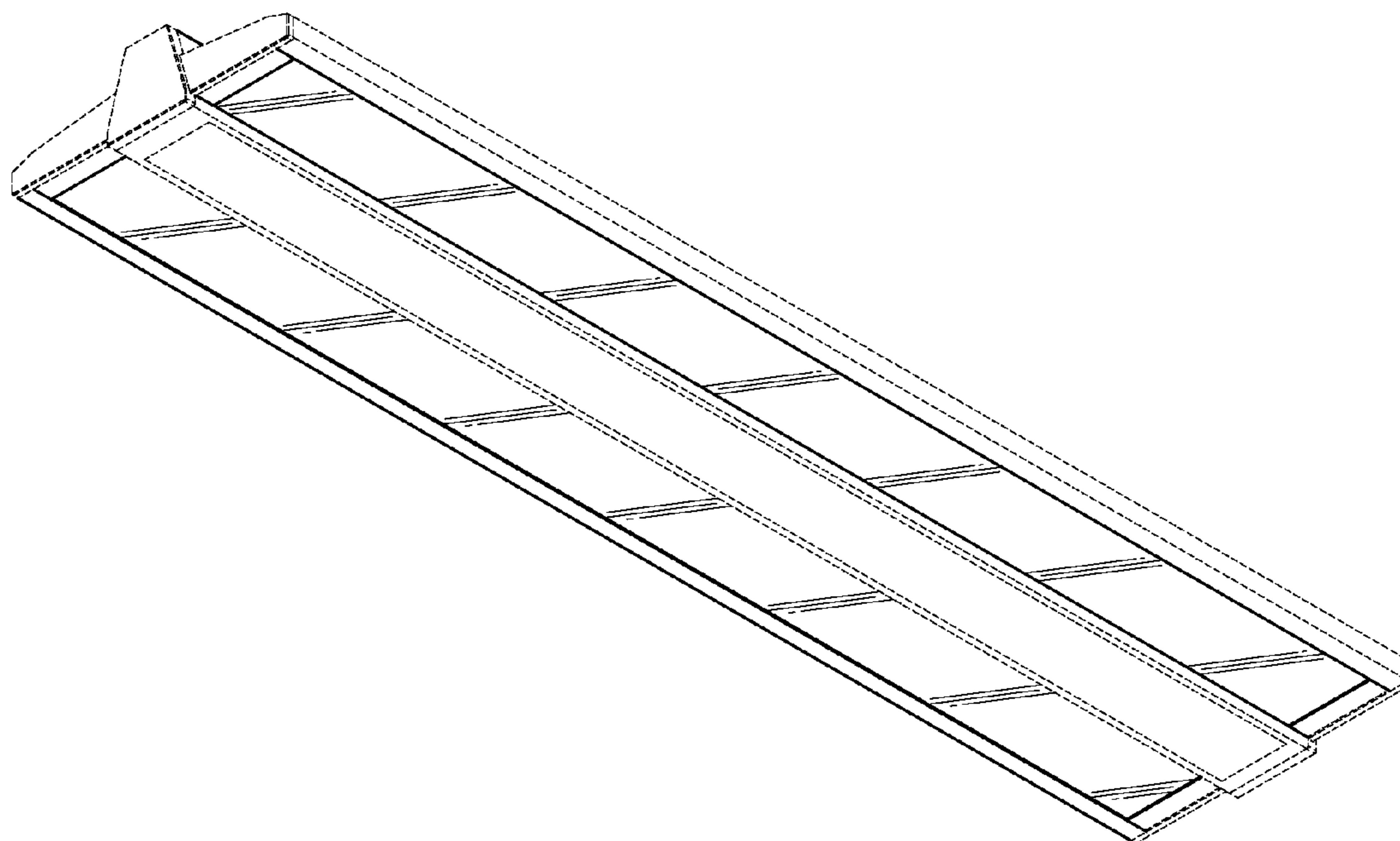

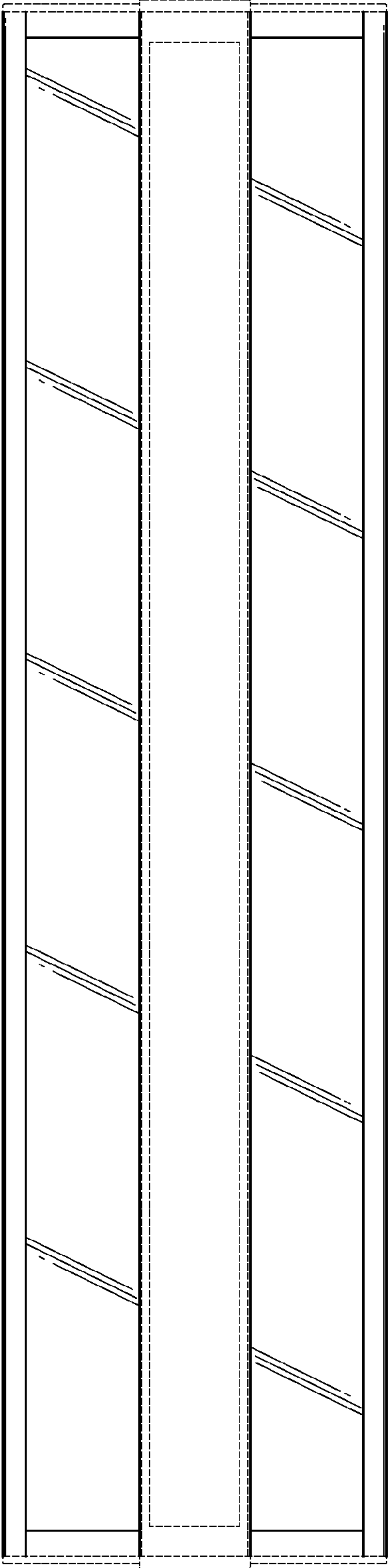
