The ornamental design for an aquarium net handle, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an aquarium net handle,

FIG. 2 is a top view thereof,

FIG. 3 is a bottom view thereof,

FIG. 4 is a right-side view thereof,

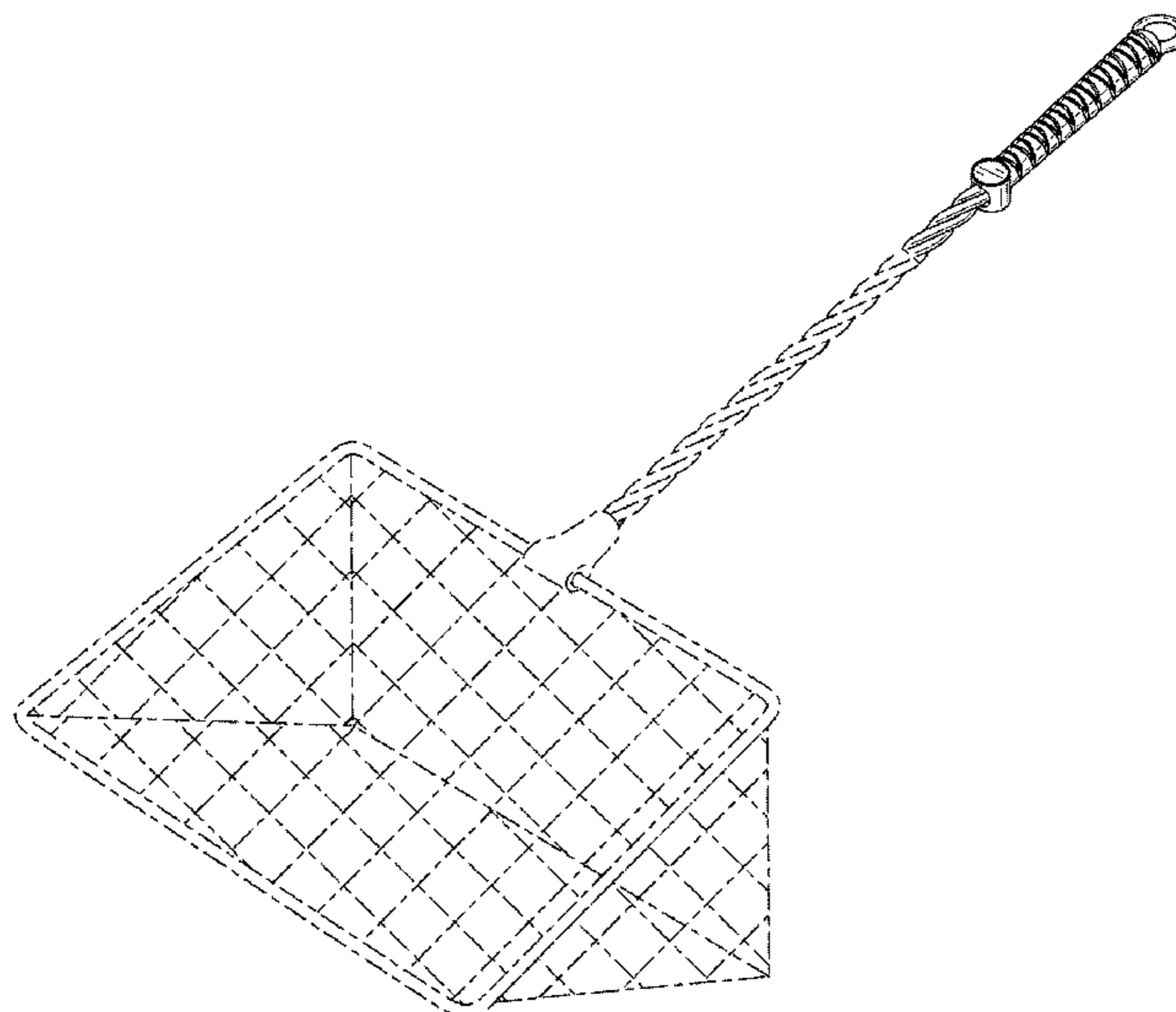
FIG. 5 is a left-side view thereof,

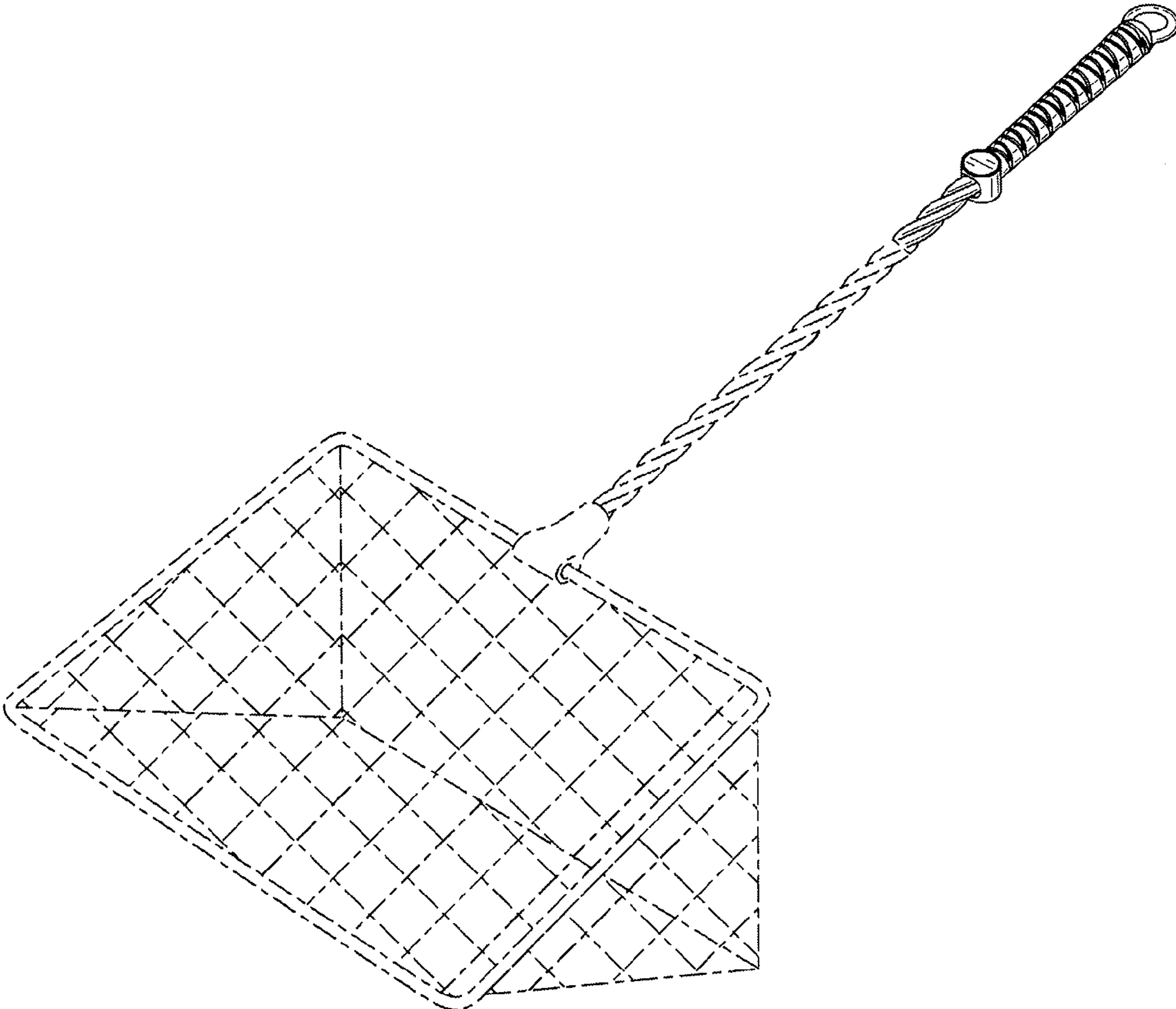

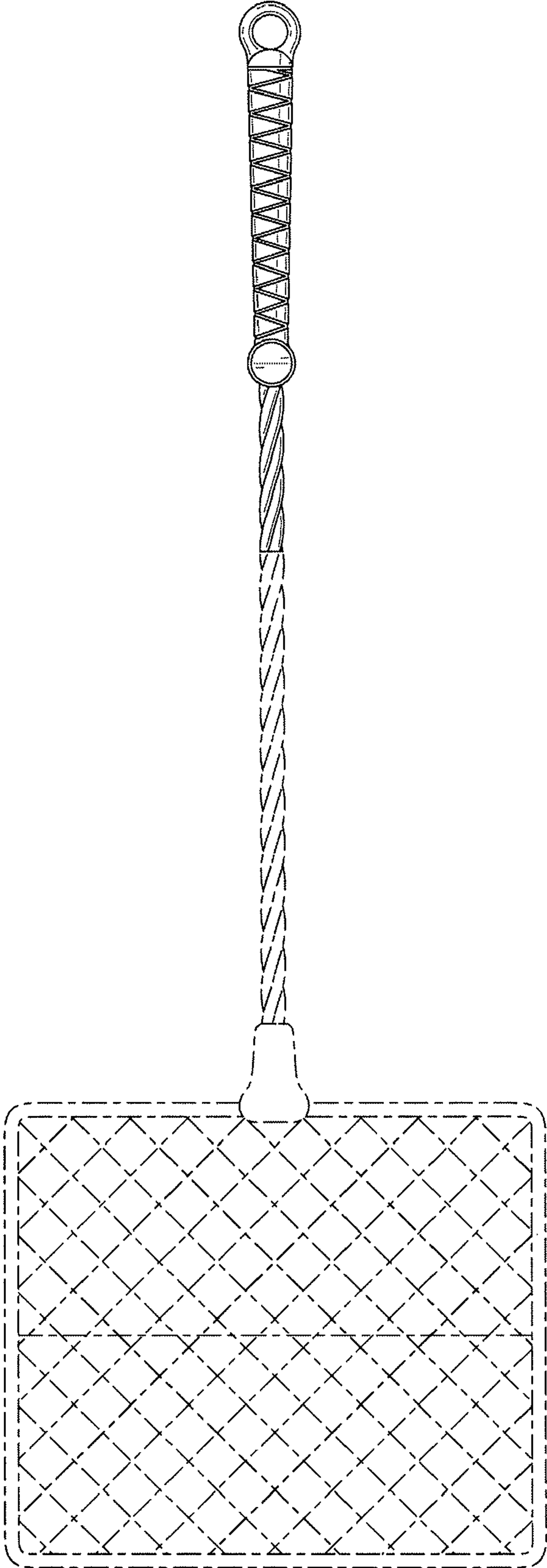

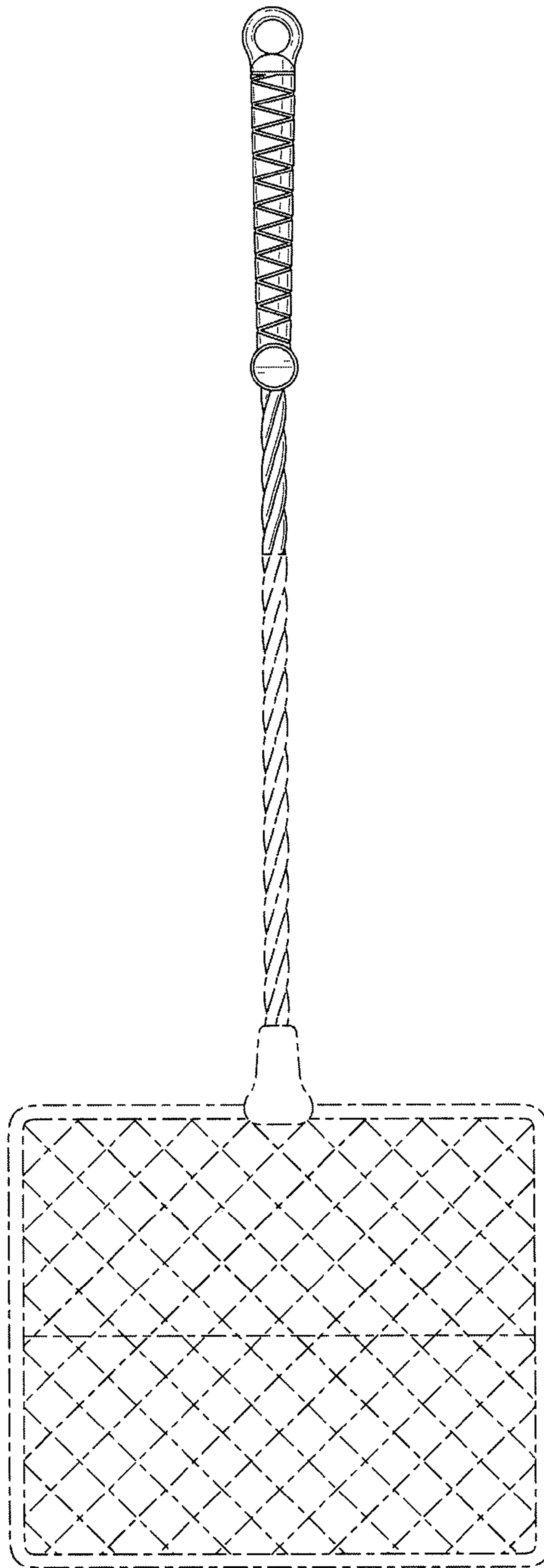

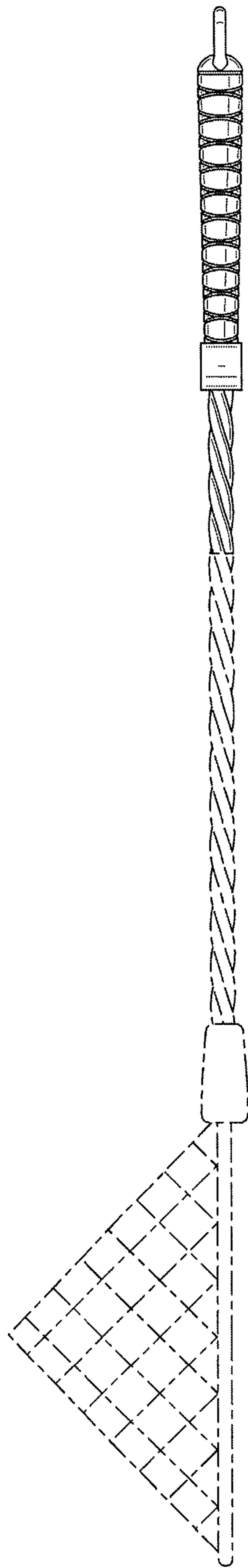

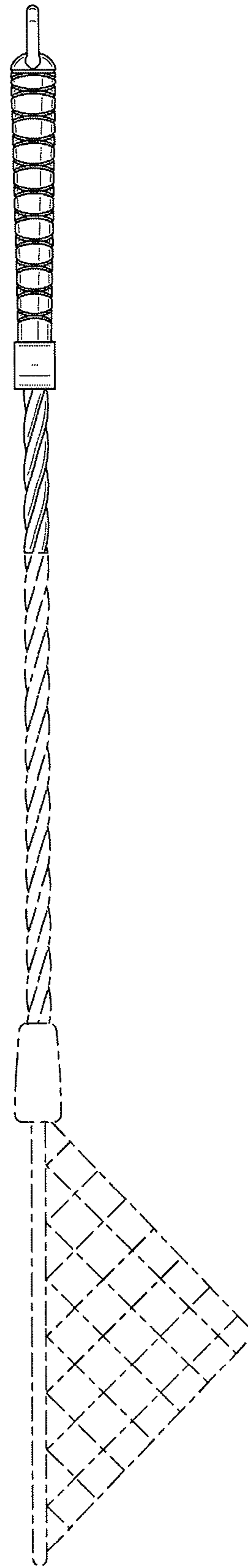

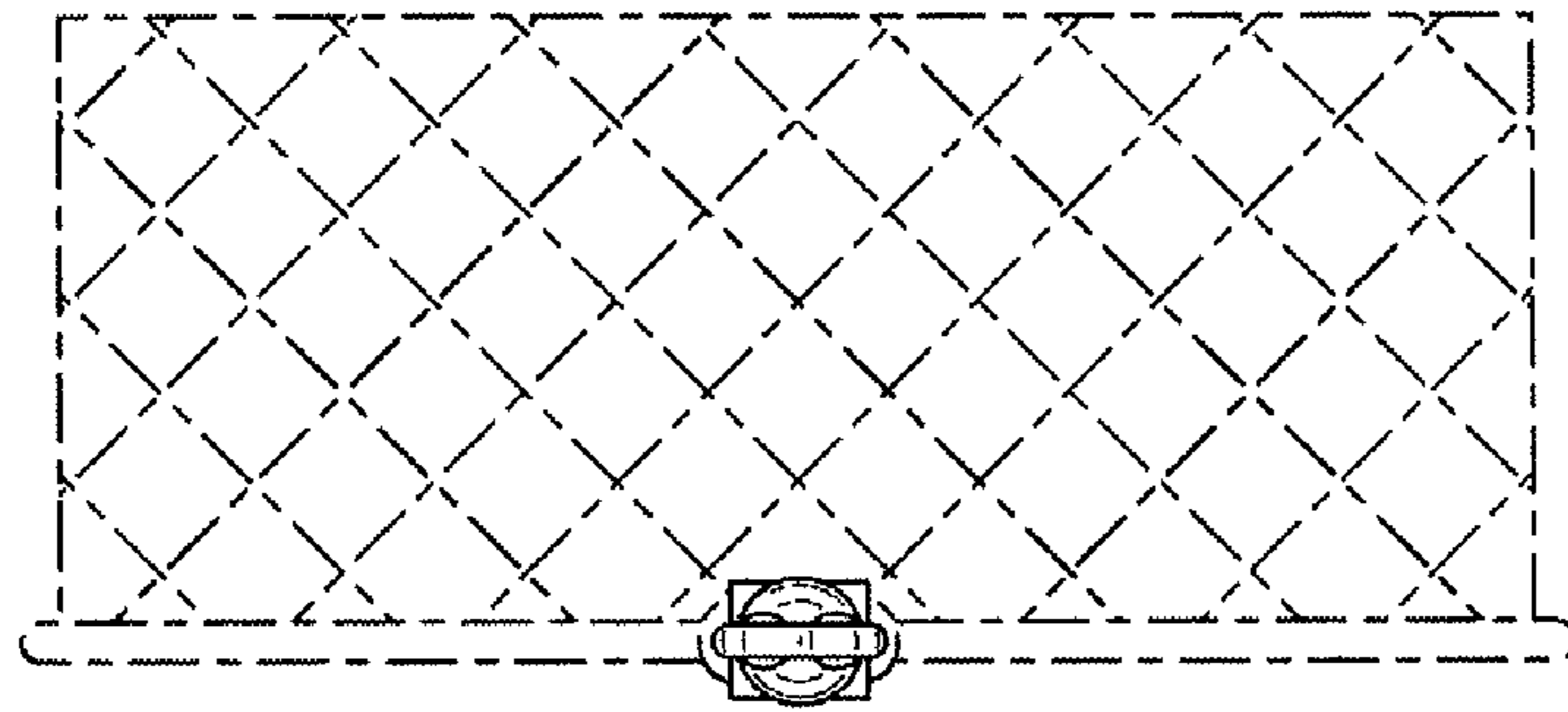

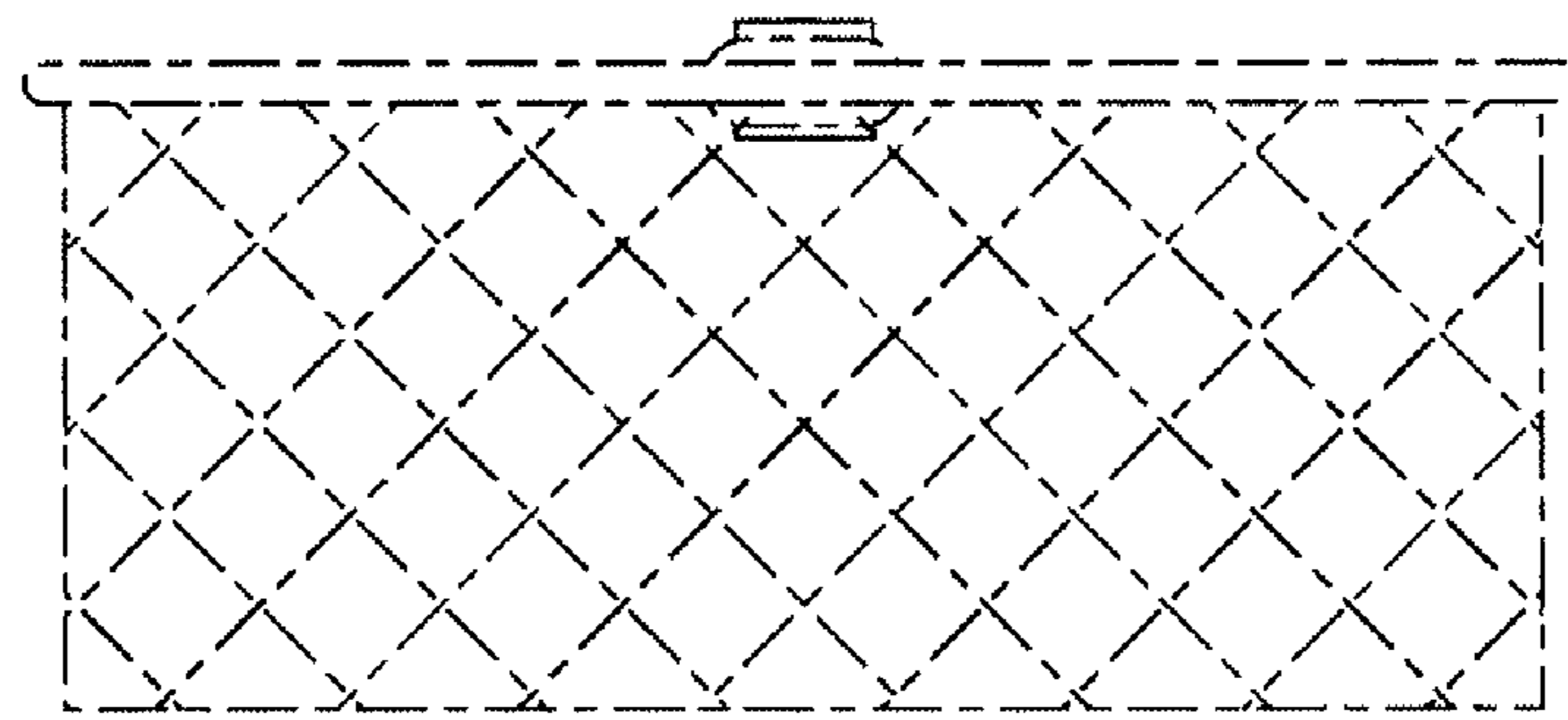
