FIG. 1 is perspective view of the dryer bar;

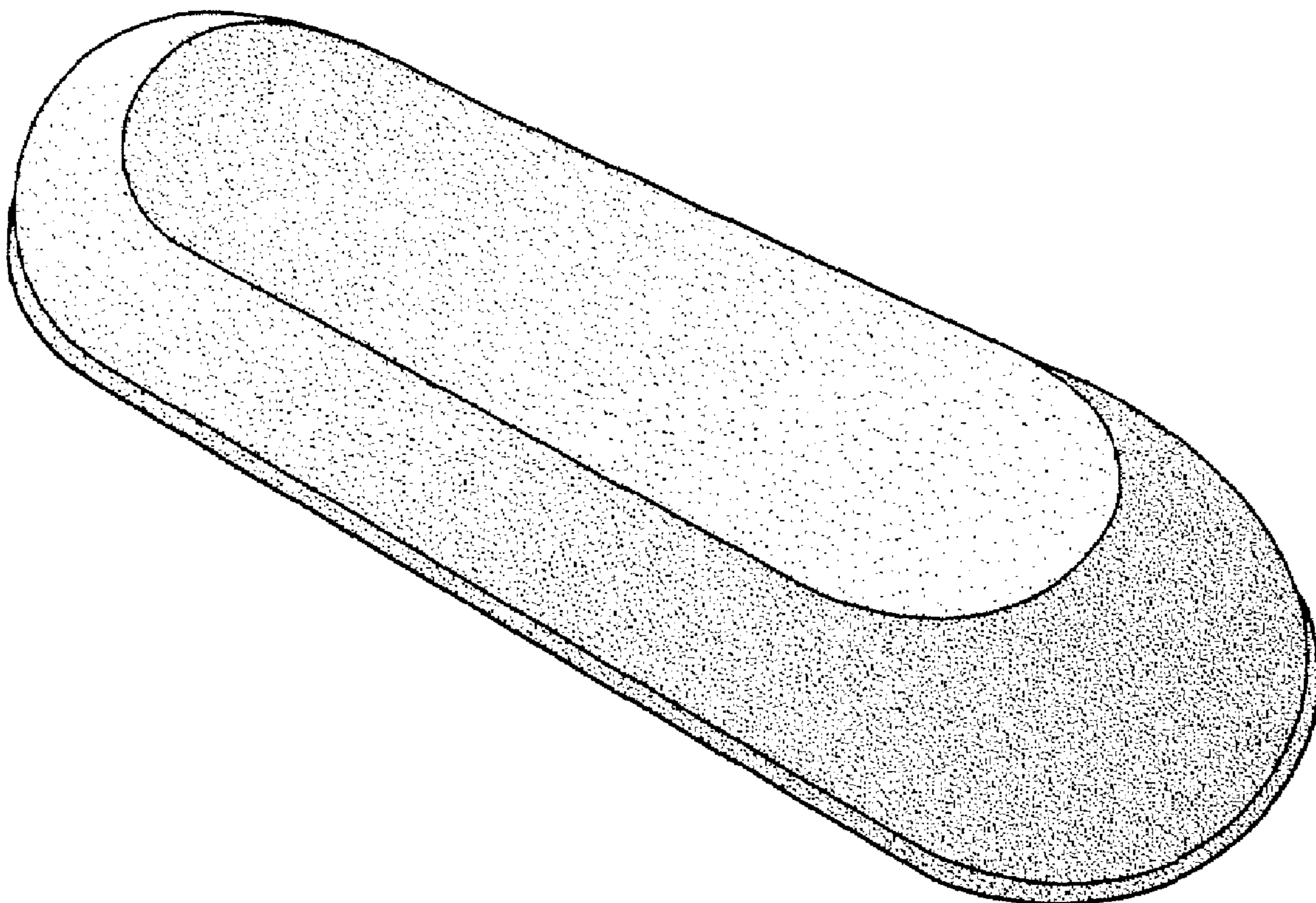
FIG. 2 is top view thereof;

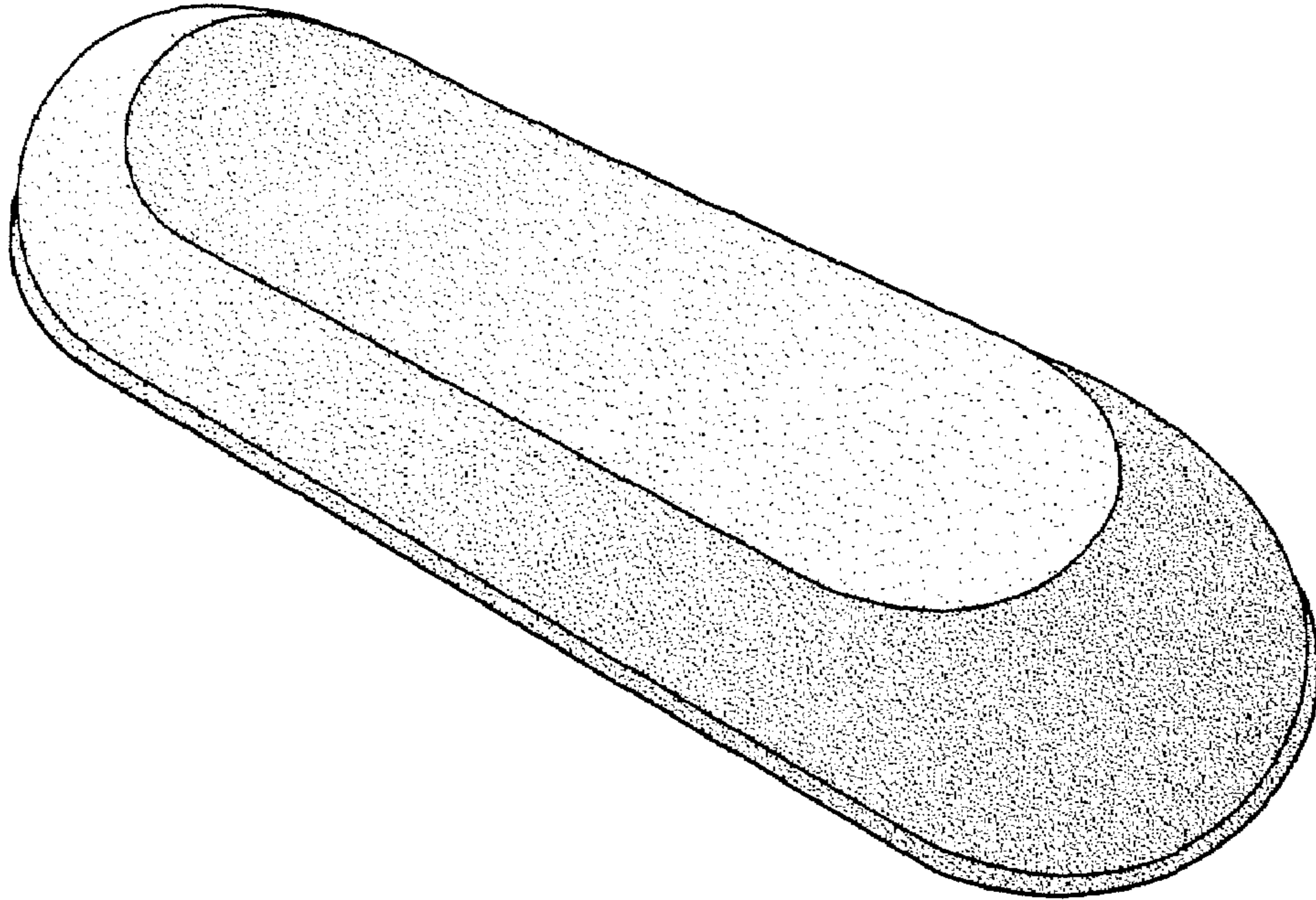

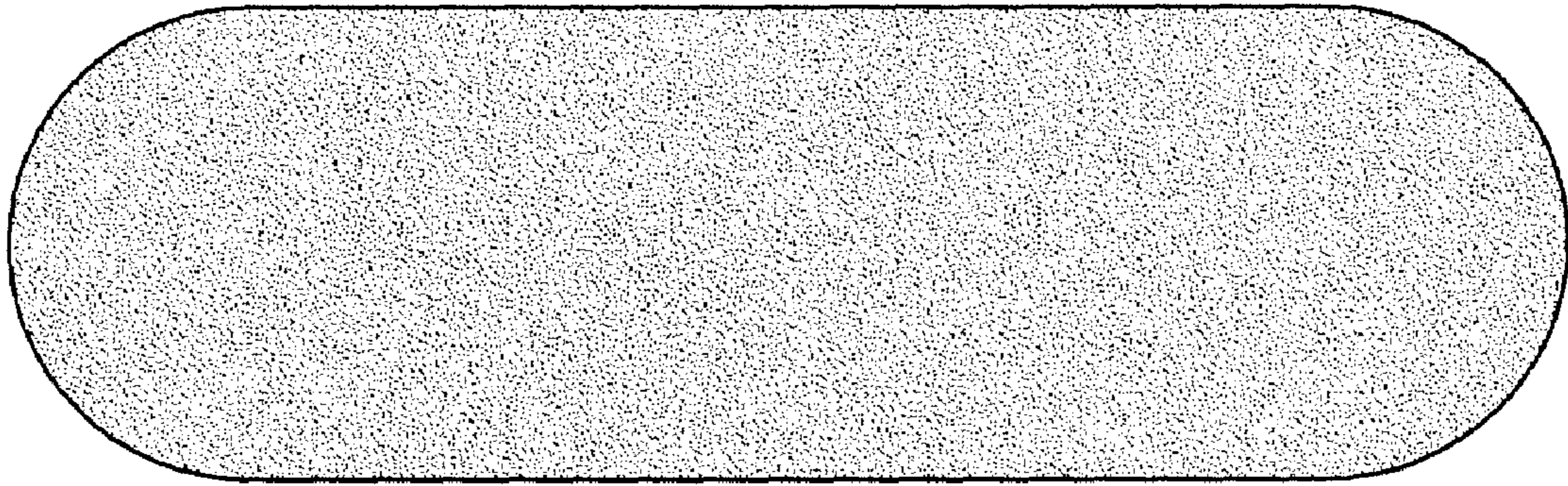

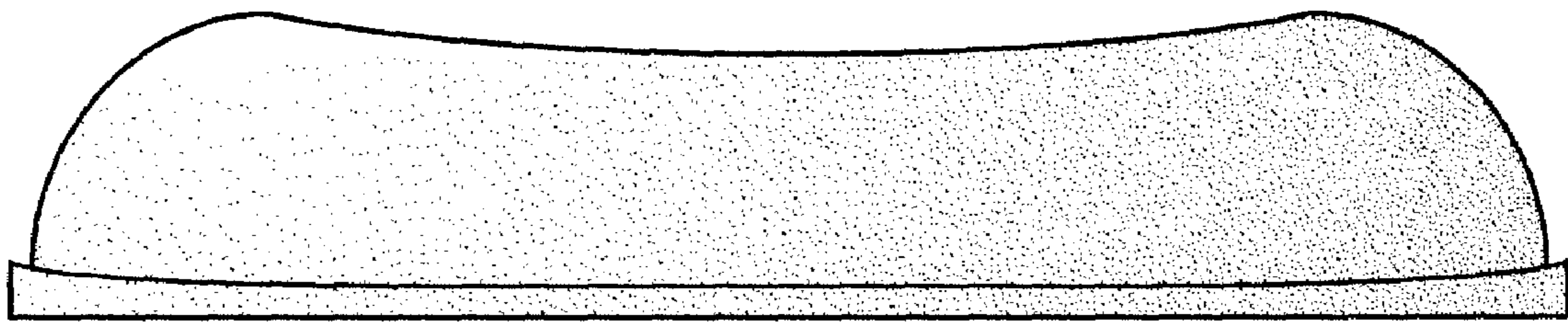

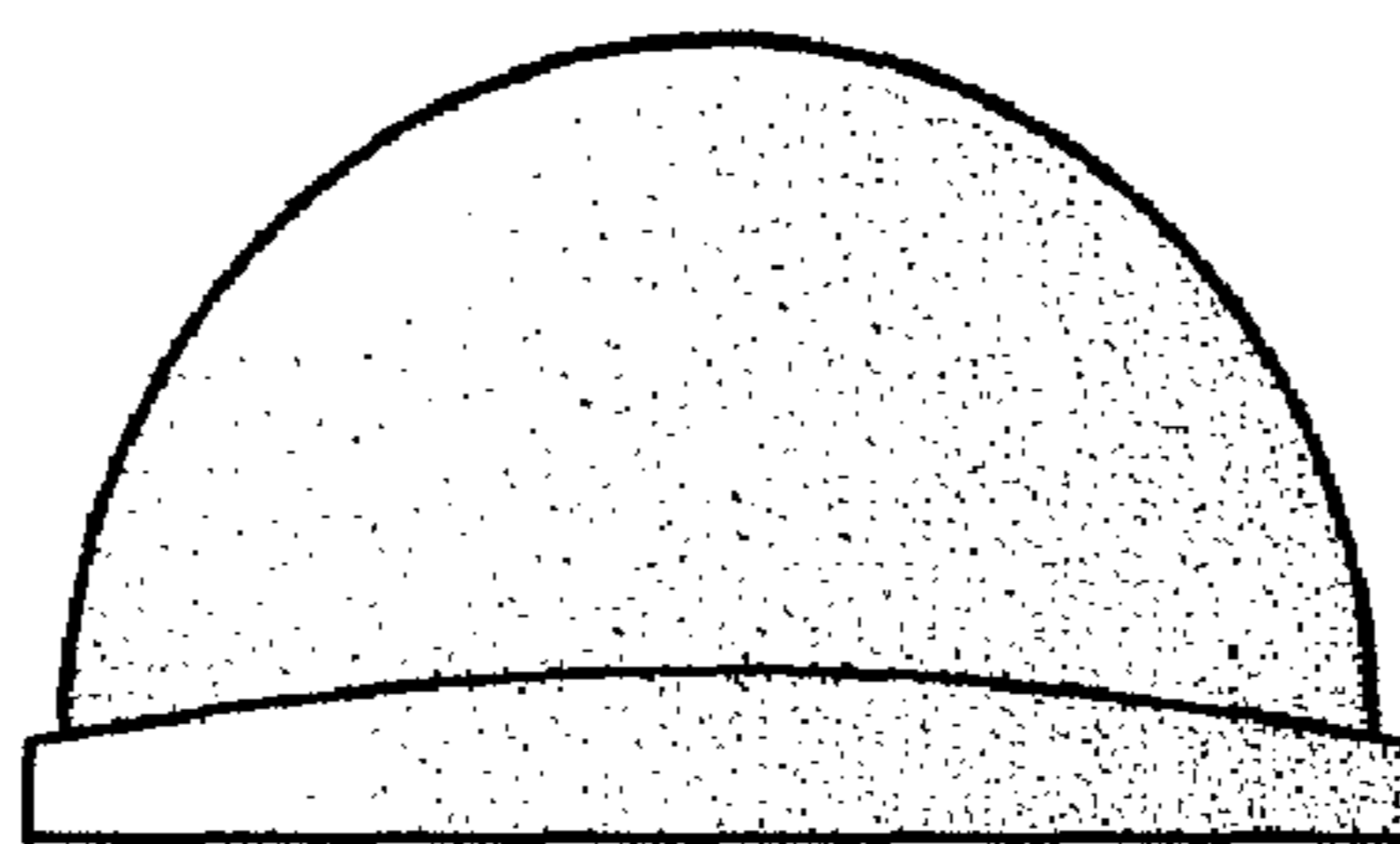
