(57) **CLAIM**

The ornamental design for pair of gloves, as shown and described.

DESCRIPTION

FIG. 1 is an elevational palm-side view of a left-hand glove according to the present invention;

FIG. 2 is an elevational backhand view of the glove of FIG. 1 according to the present invention;

FIG. 3 is an elevational right-side view of the glove of FIG. 1 according to the present invention;

FIG. 4 is an elevational left-side view of the glove of FIG. 1 according to the present invention;

FIG. 5 is an alternate position elevational palm-side view of the glove of FIGS. 1-4 being worn by a user according to the present invention;

FIG. 6 is an elevational palm-side view of a right-hand glove according to the present invention;

FIG. 7 is an elevational backhand view of the glove of FIG. 6 according to the present invention;

FIG. 8 is an elevational left-side view of the glove of FIG. 6 according to the present invention;

FIG. 9 is an elevational right-side view of the glove of FIG. 6 according to the present invention;

FIG. 10 is an alternate position elevational palm-side view of the glove of FIGS. 6-9 being worn by a user according to the present invention;

FIG. 11 is an elevational palm side view of a second embodiment of a left-hand glove of my design shown in FIG. 1;

FIG. 12 is an elevational backhand view of the glove of FIG. 11 according to the present invention;

FIG. 13 is an elevational right-side view of the glove of FIG. 11 according to the present invention;

FIG. 14 is an elevational left-side view of the glove of FIG. 11 according to the present invention;

FIG. 15 is an alternate position elevational palm-side view of the glove of FIGS. 11-14 being worn by a user according to the present invention;

FIG. 16 is an elevational palm side view of a second embodiment of a right-hand glove of my design shown in FIG. 6

FIG. 17 is an elevational backhand view of the glove of FIG. 16 according to the present invention;

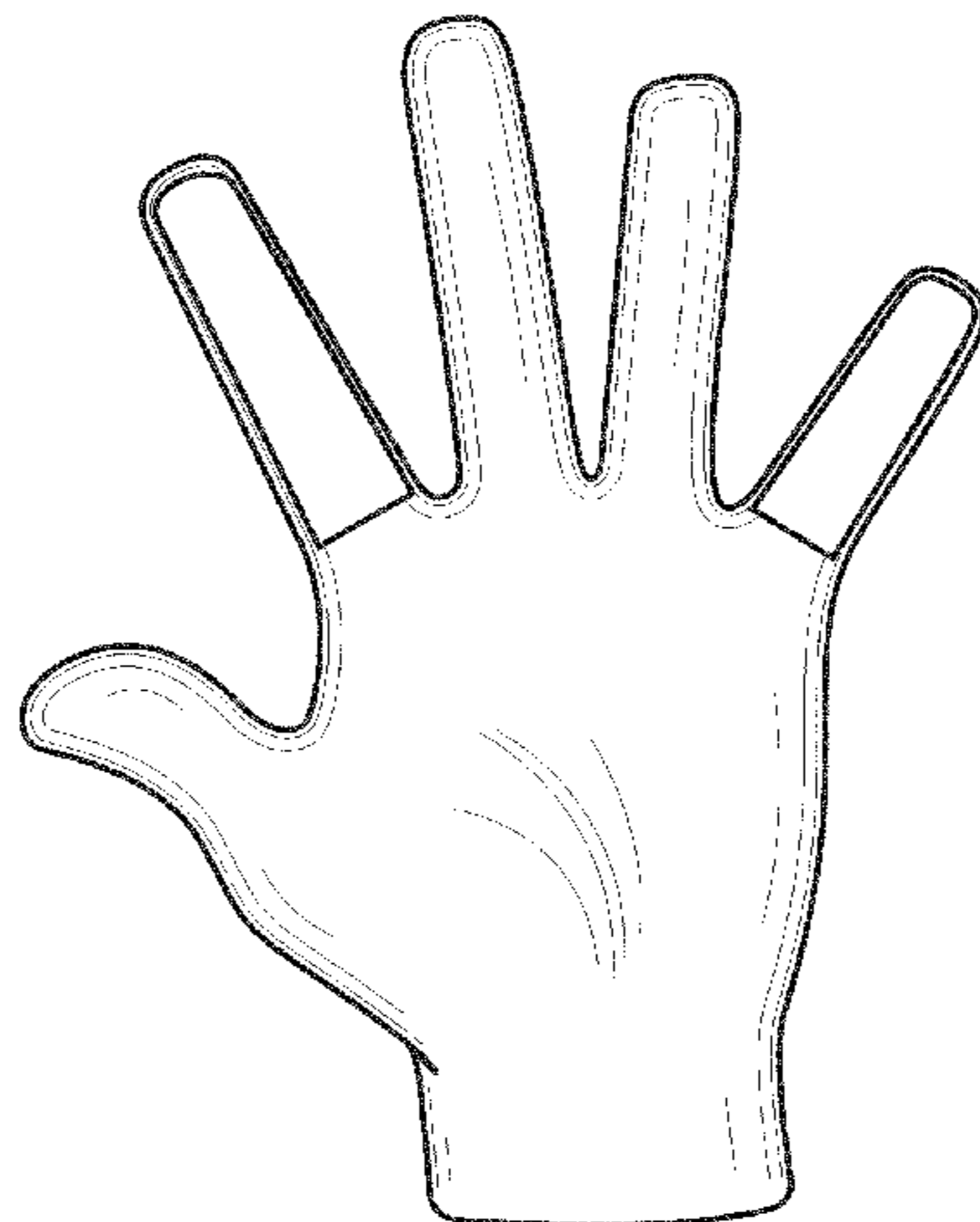
FIG. 18 is an elevational left-side view of the glove of FIG. 16 according to the present invention;

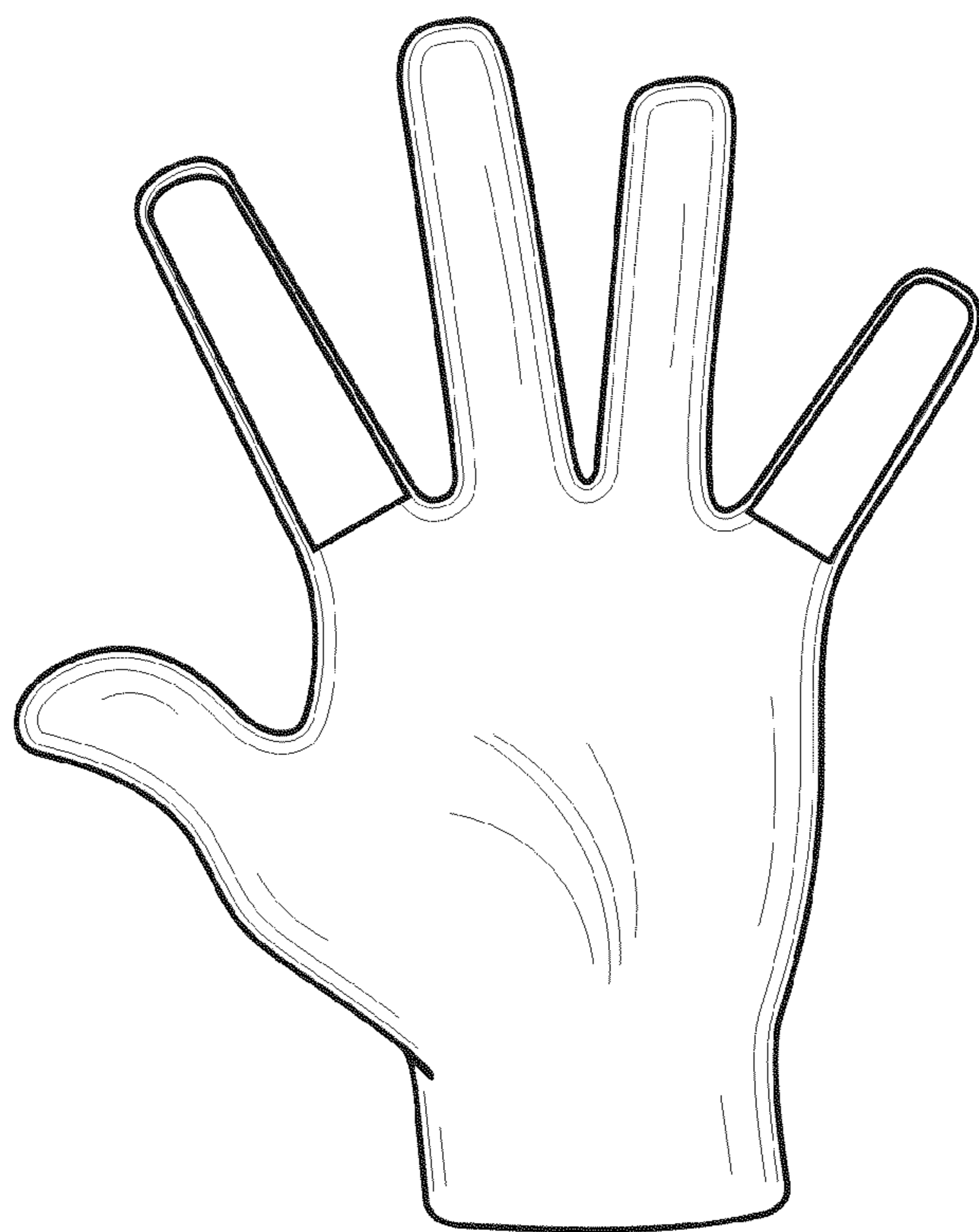

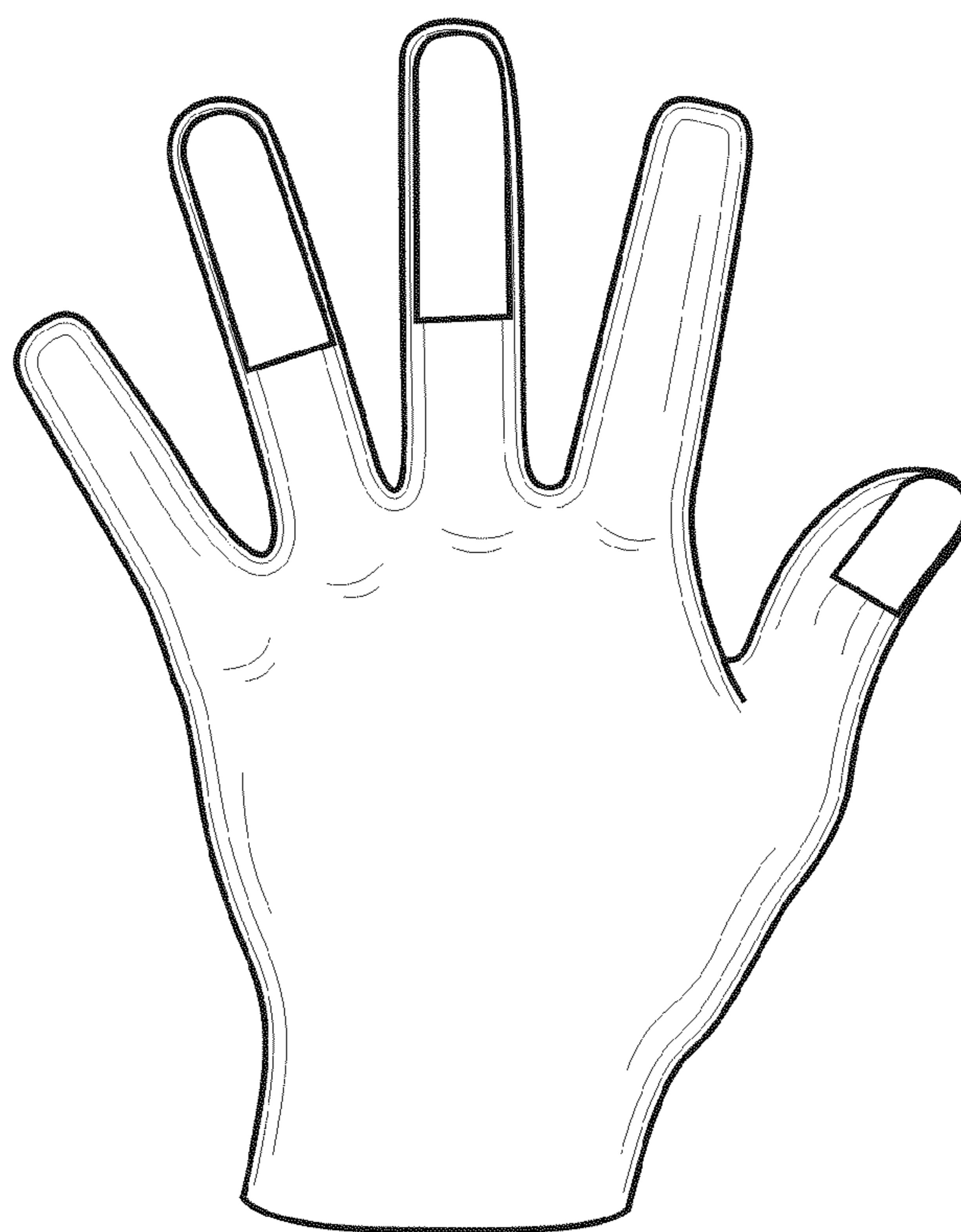

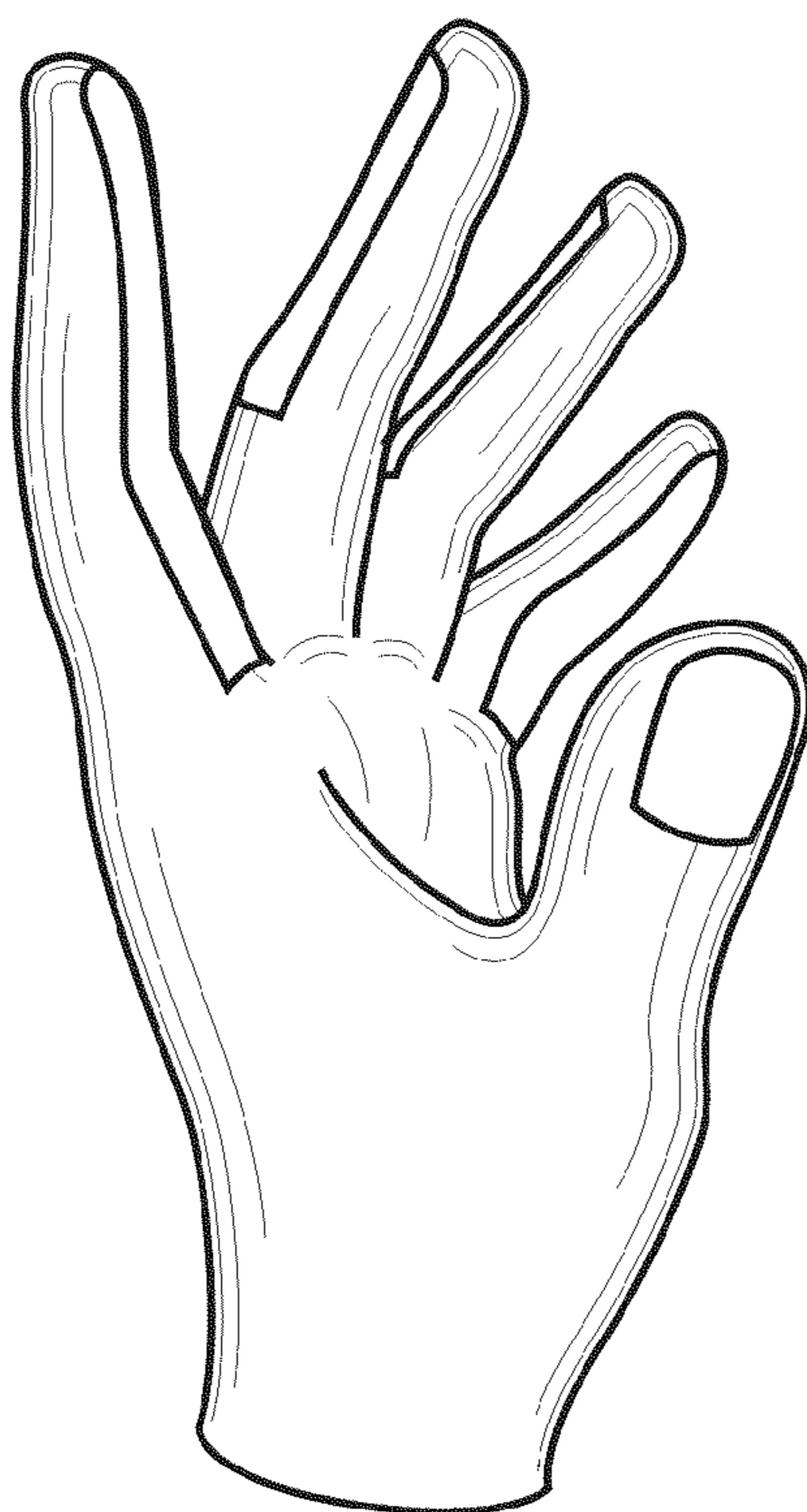

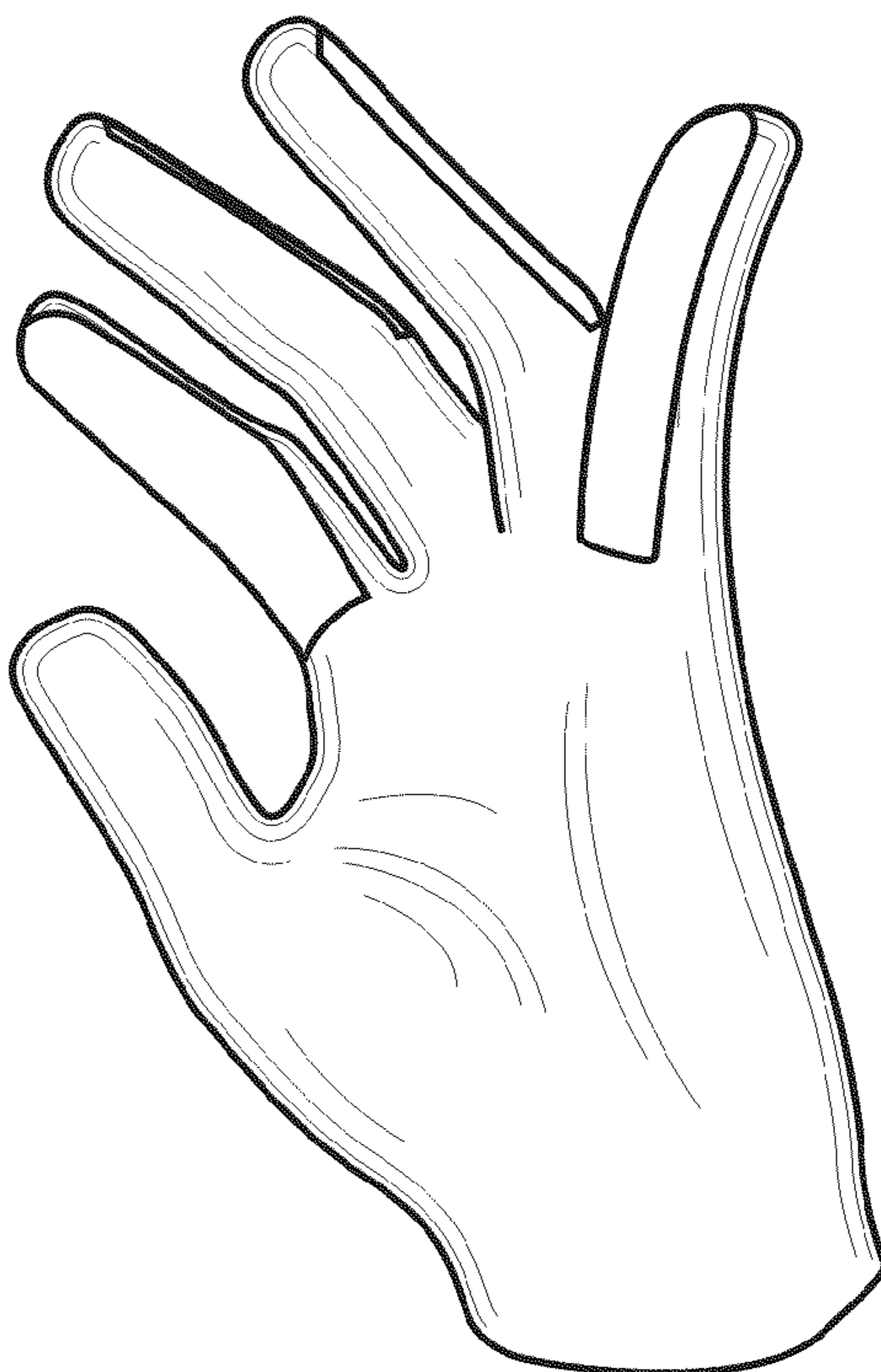

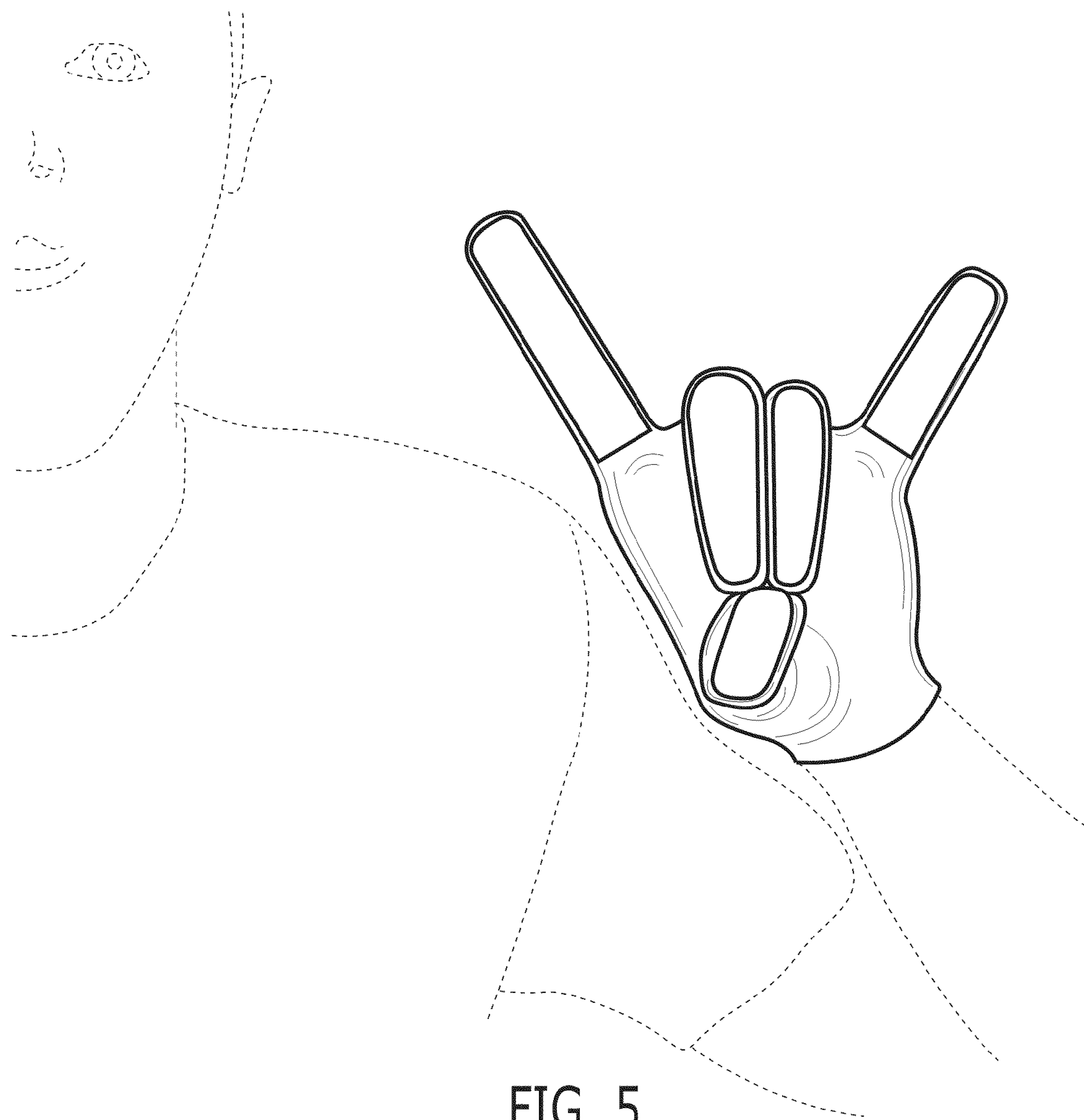

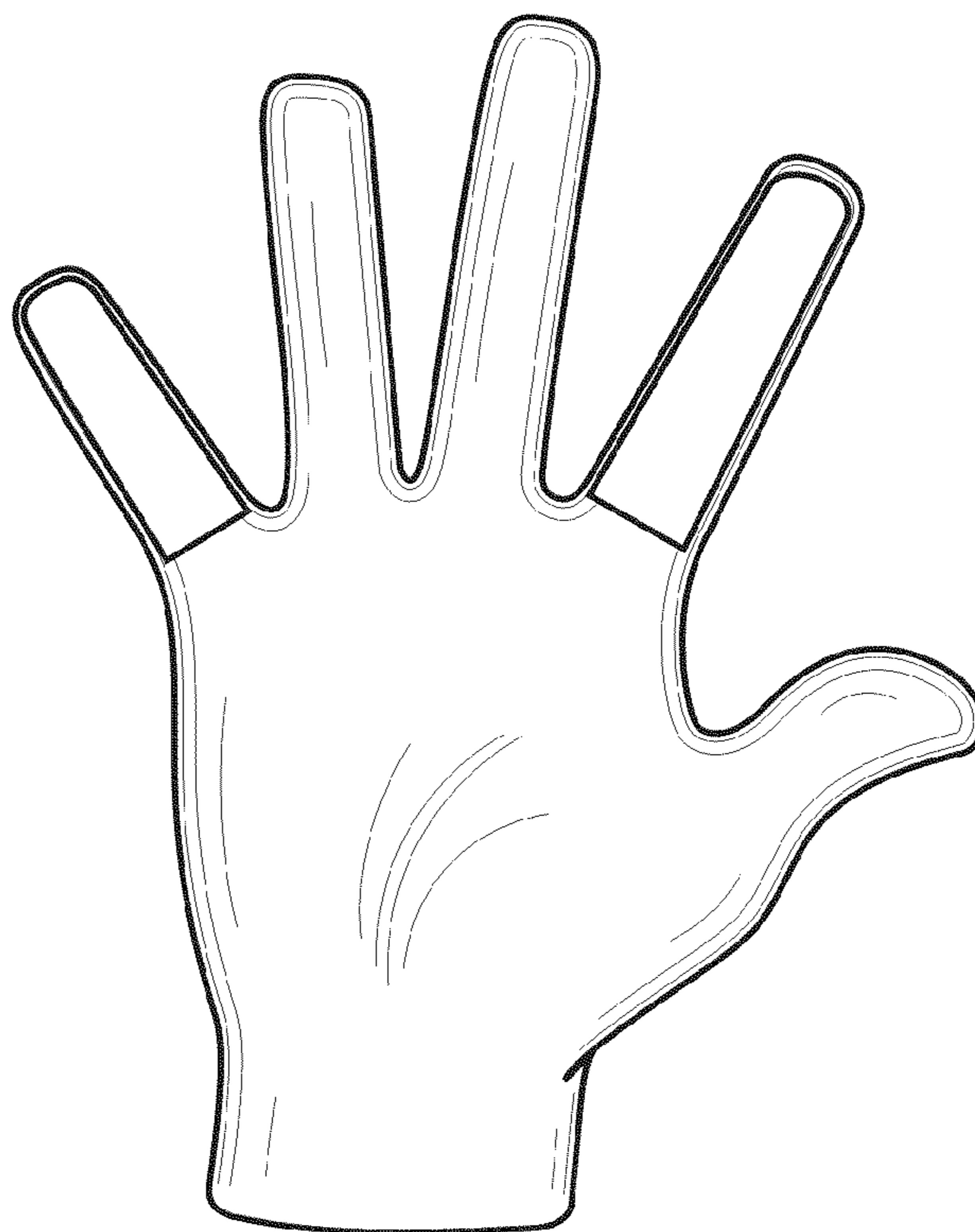

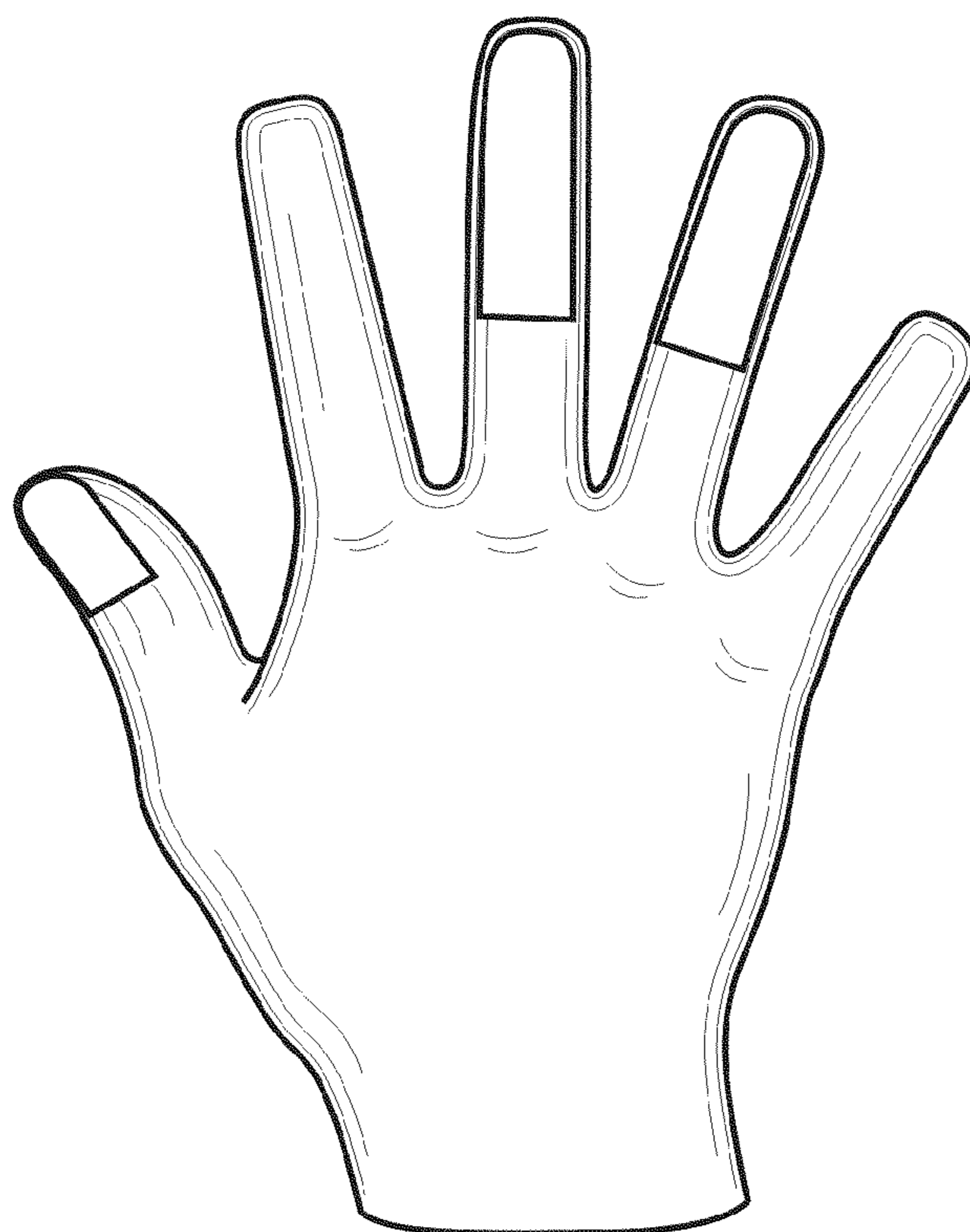

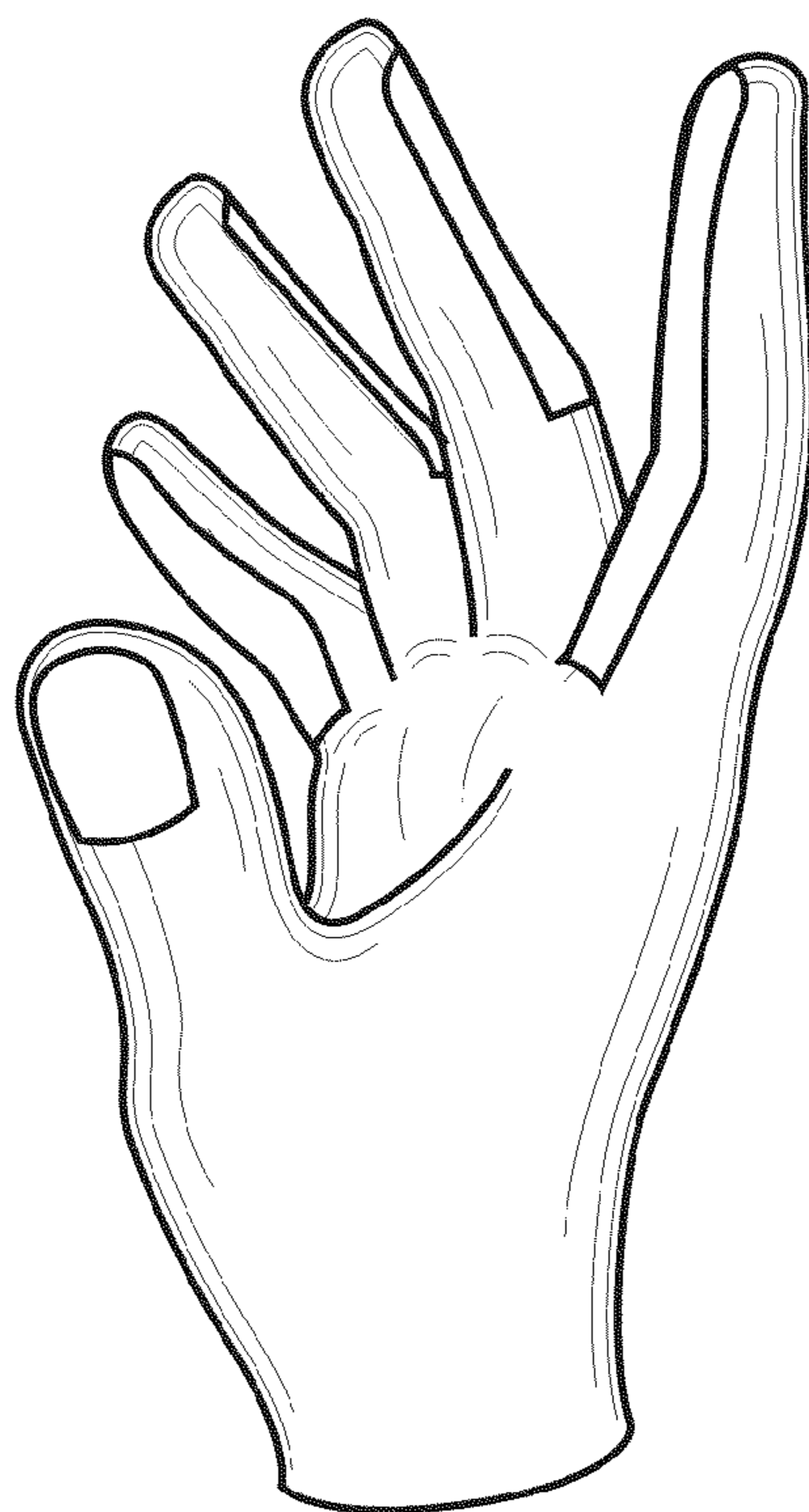

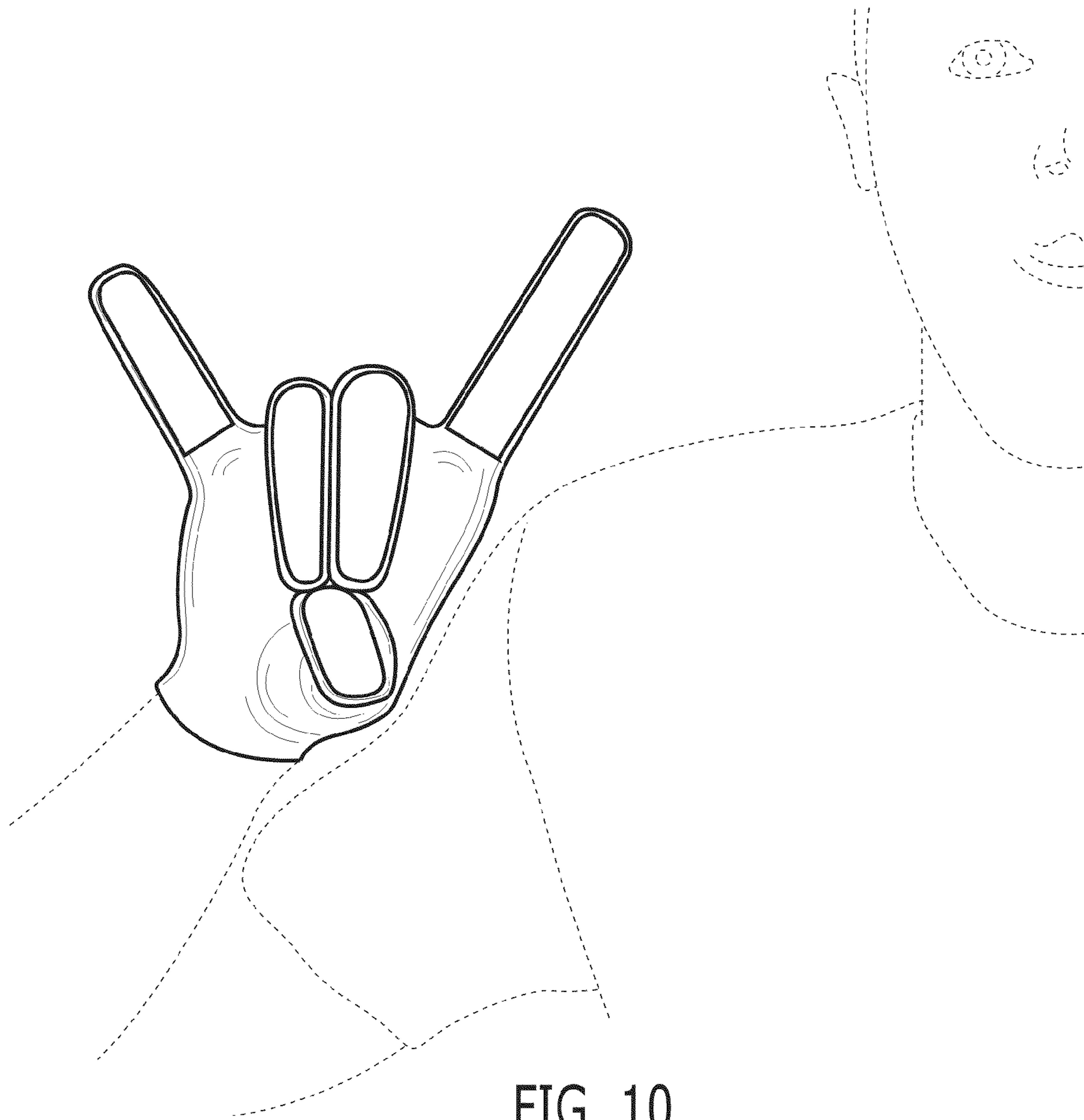

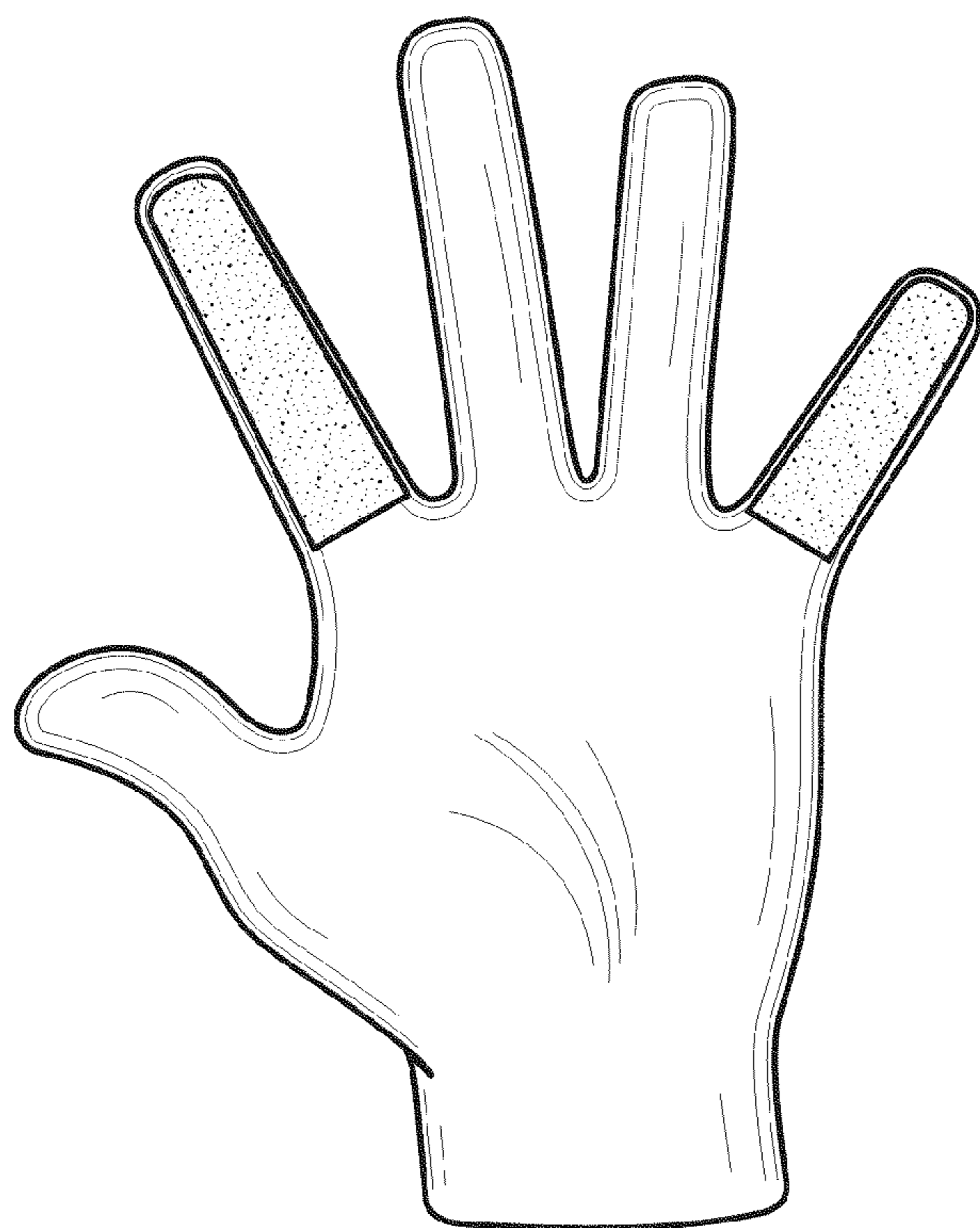

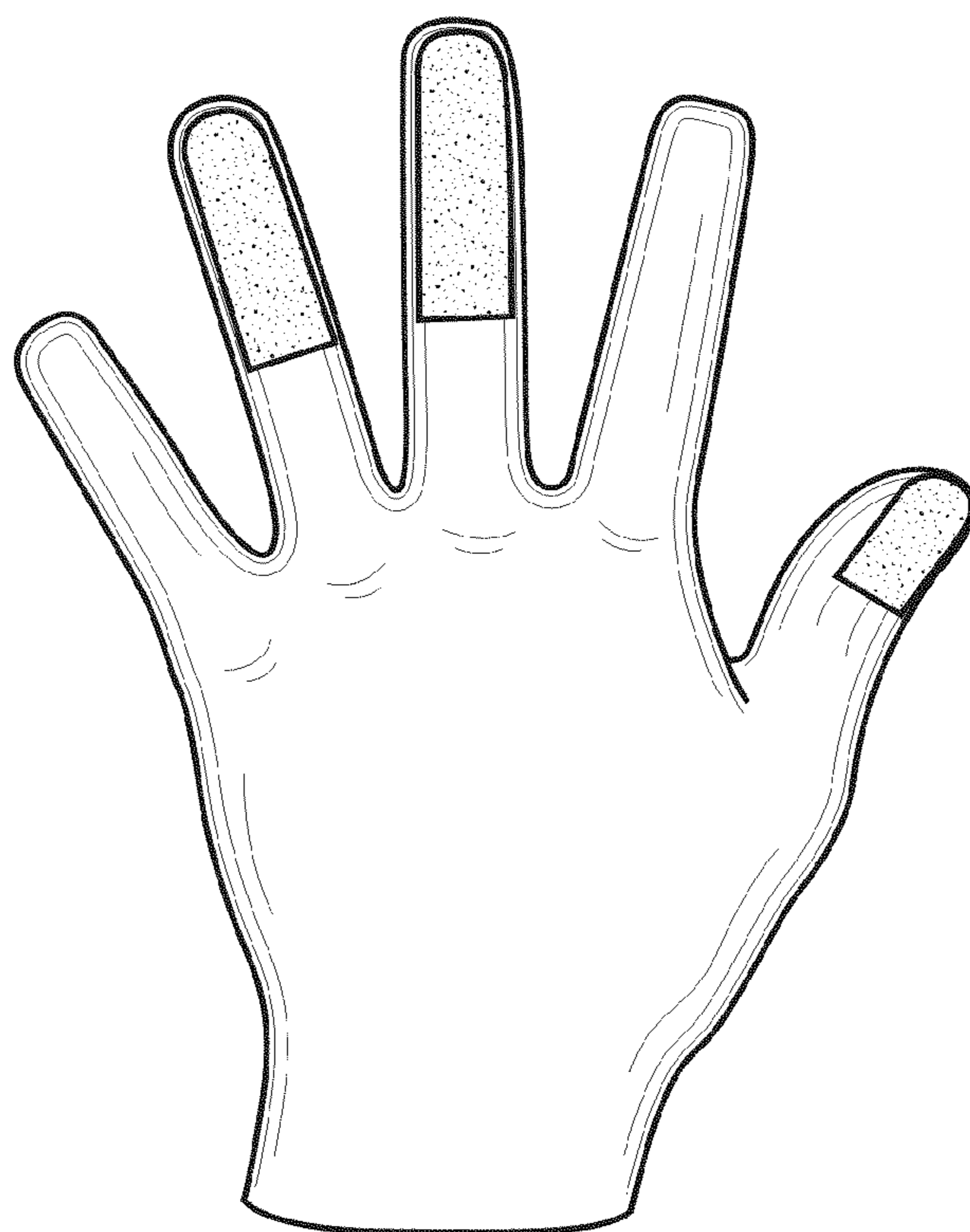

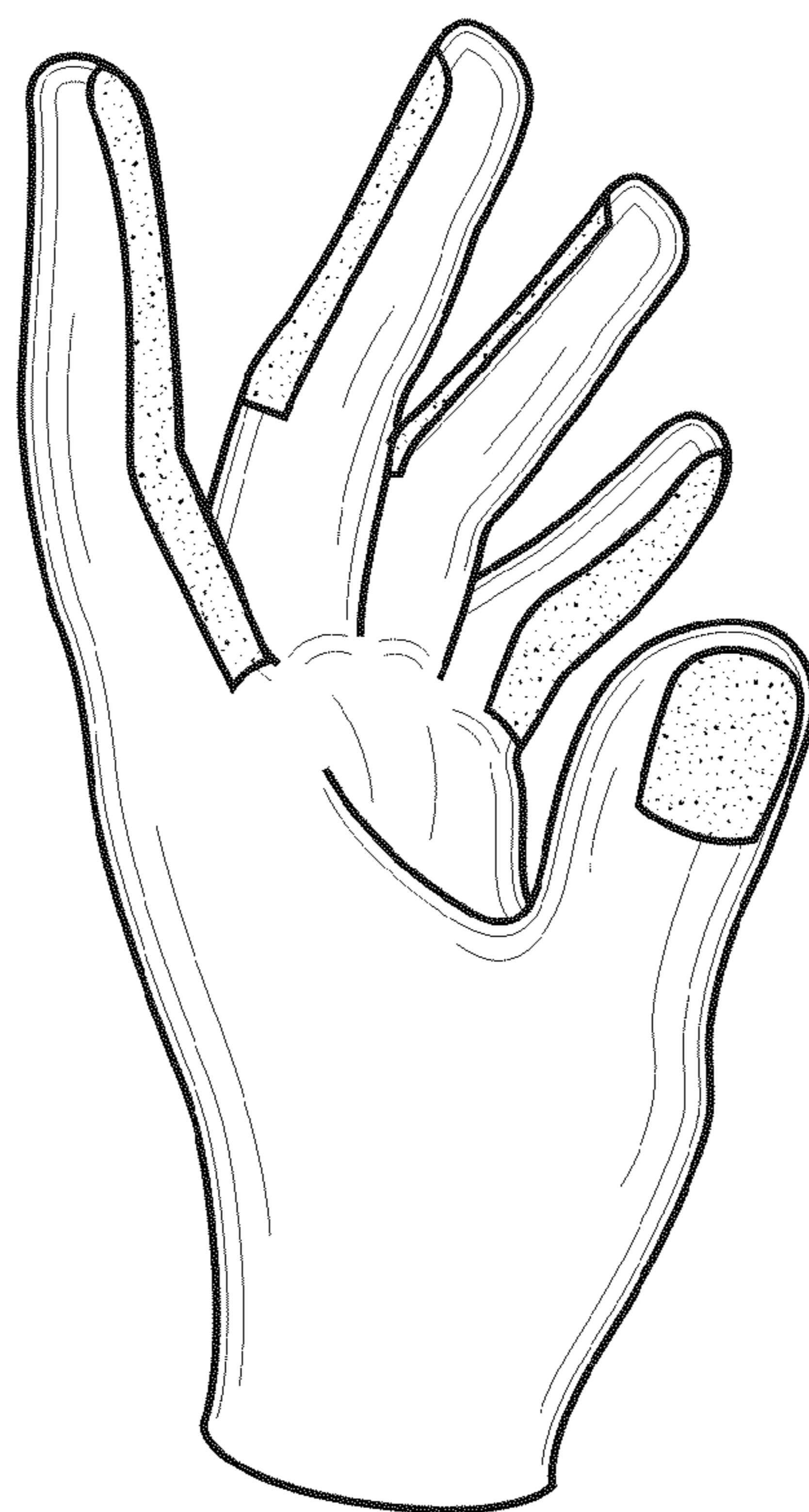

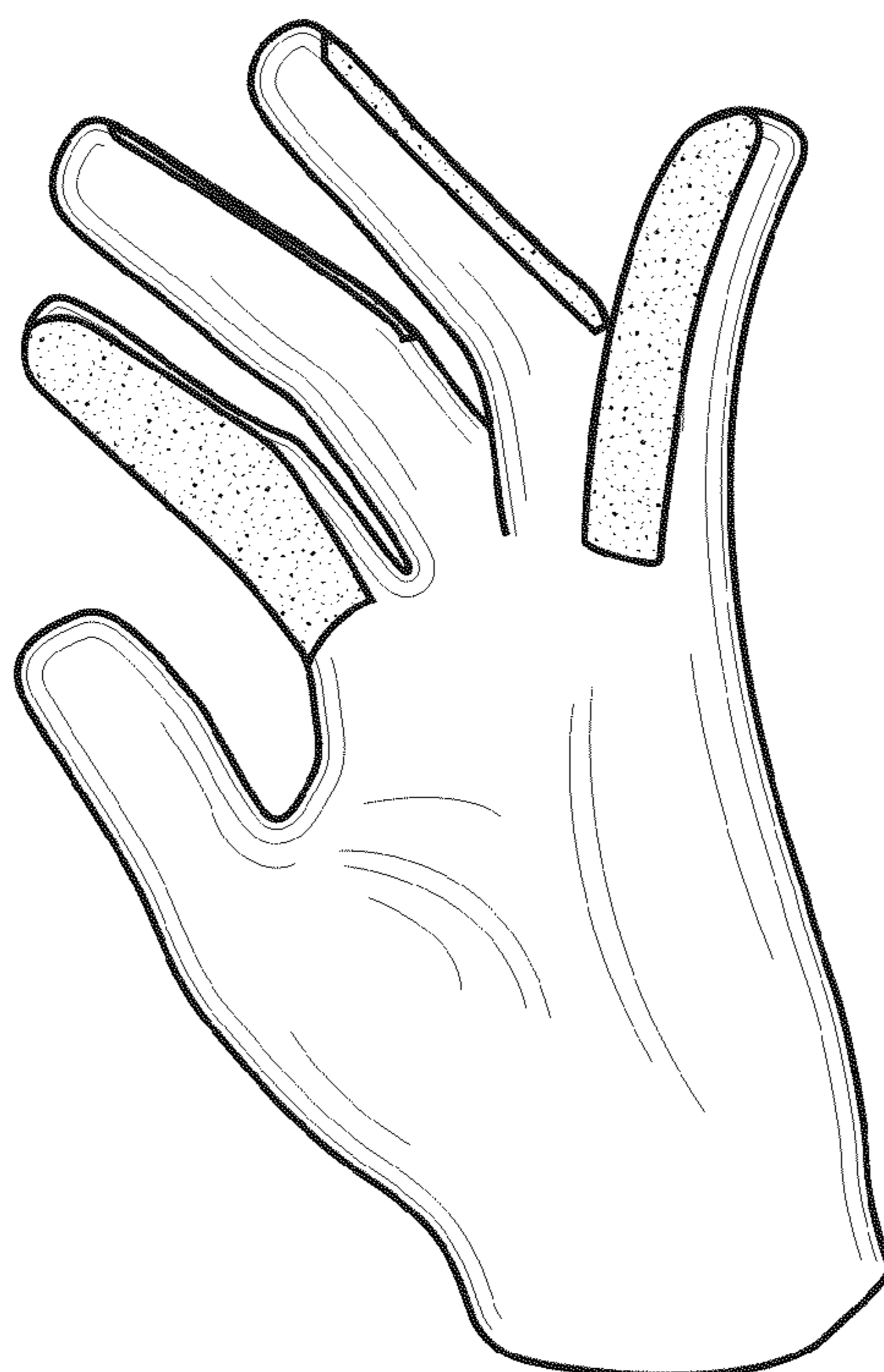

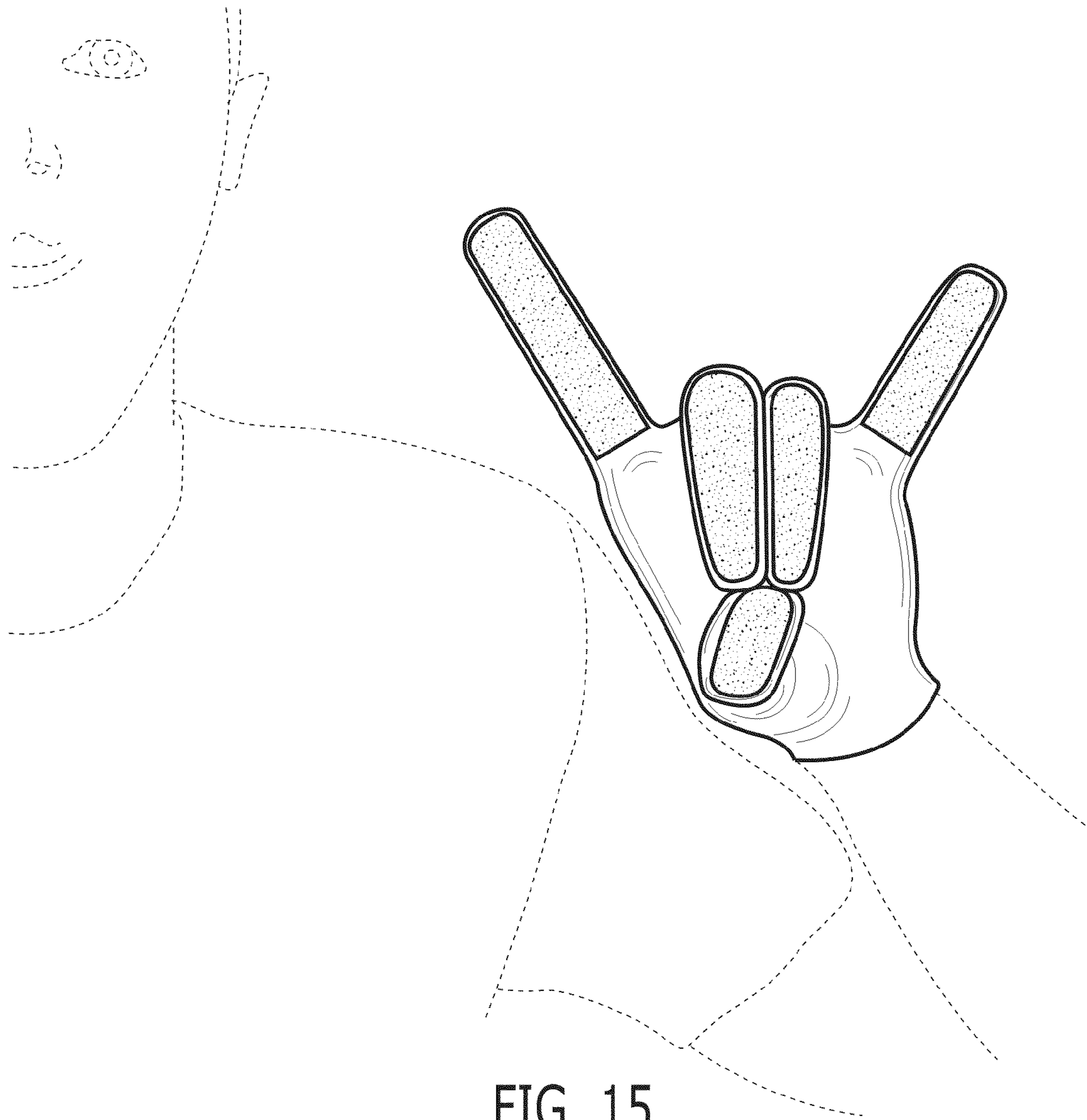

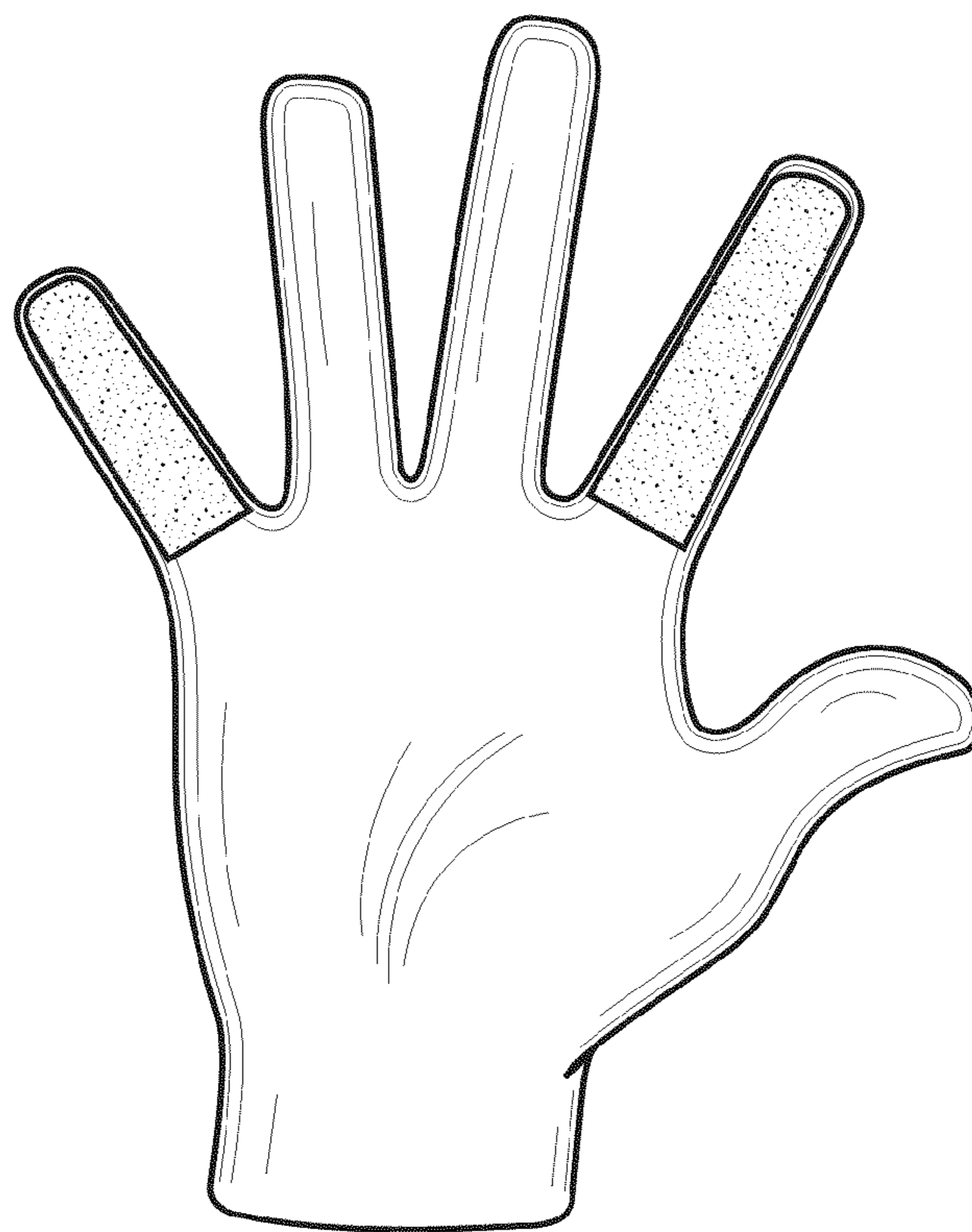

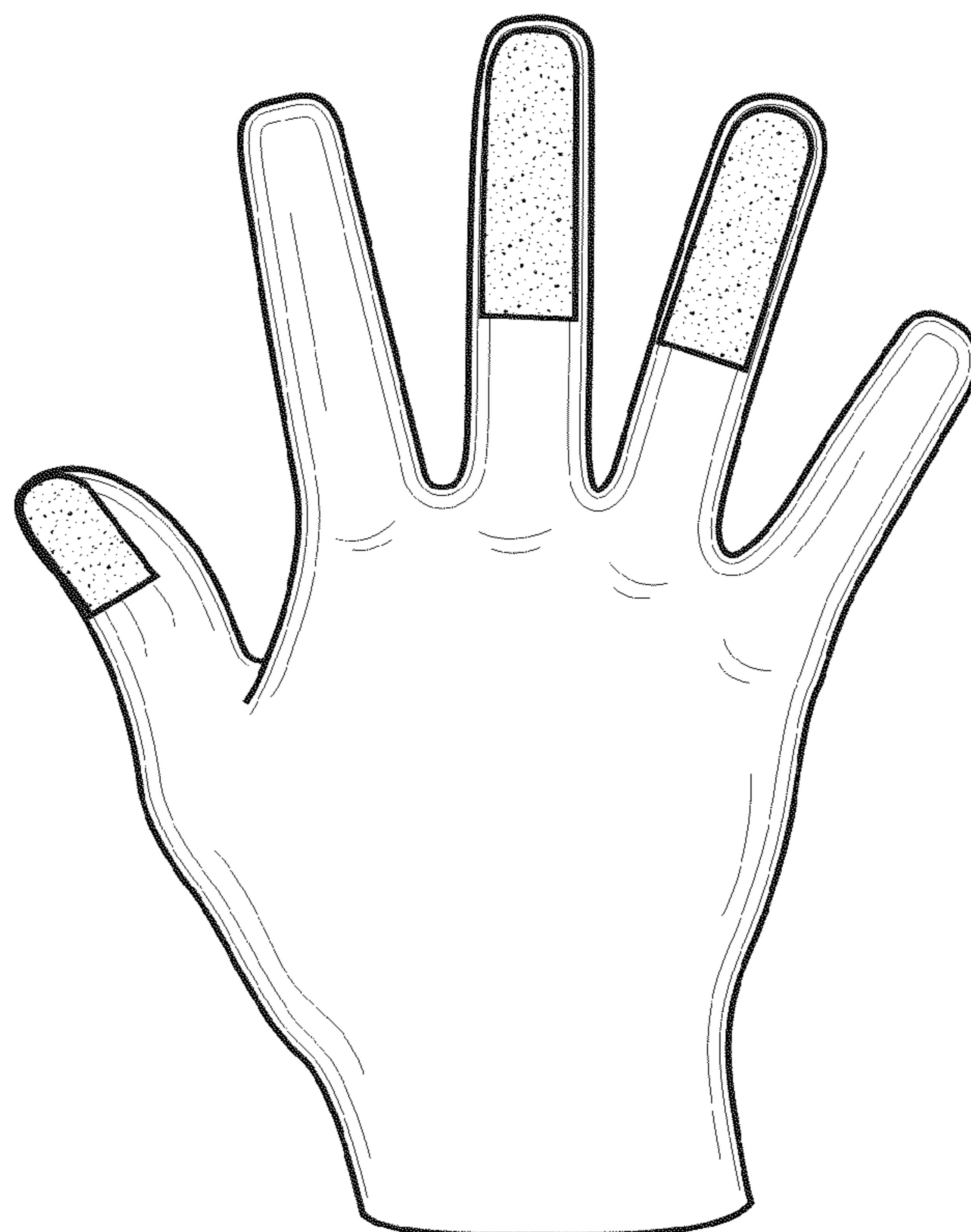

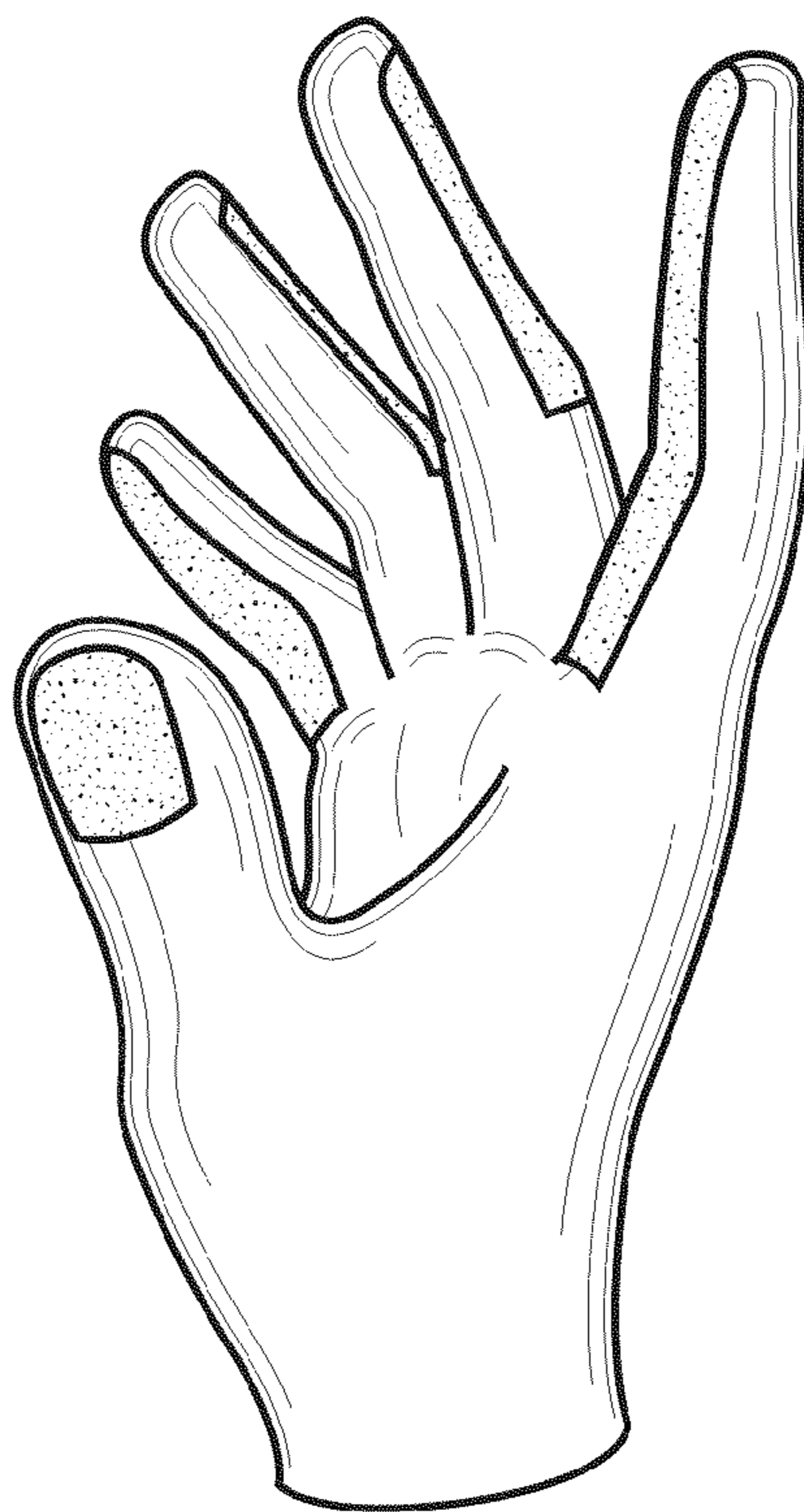

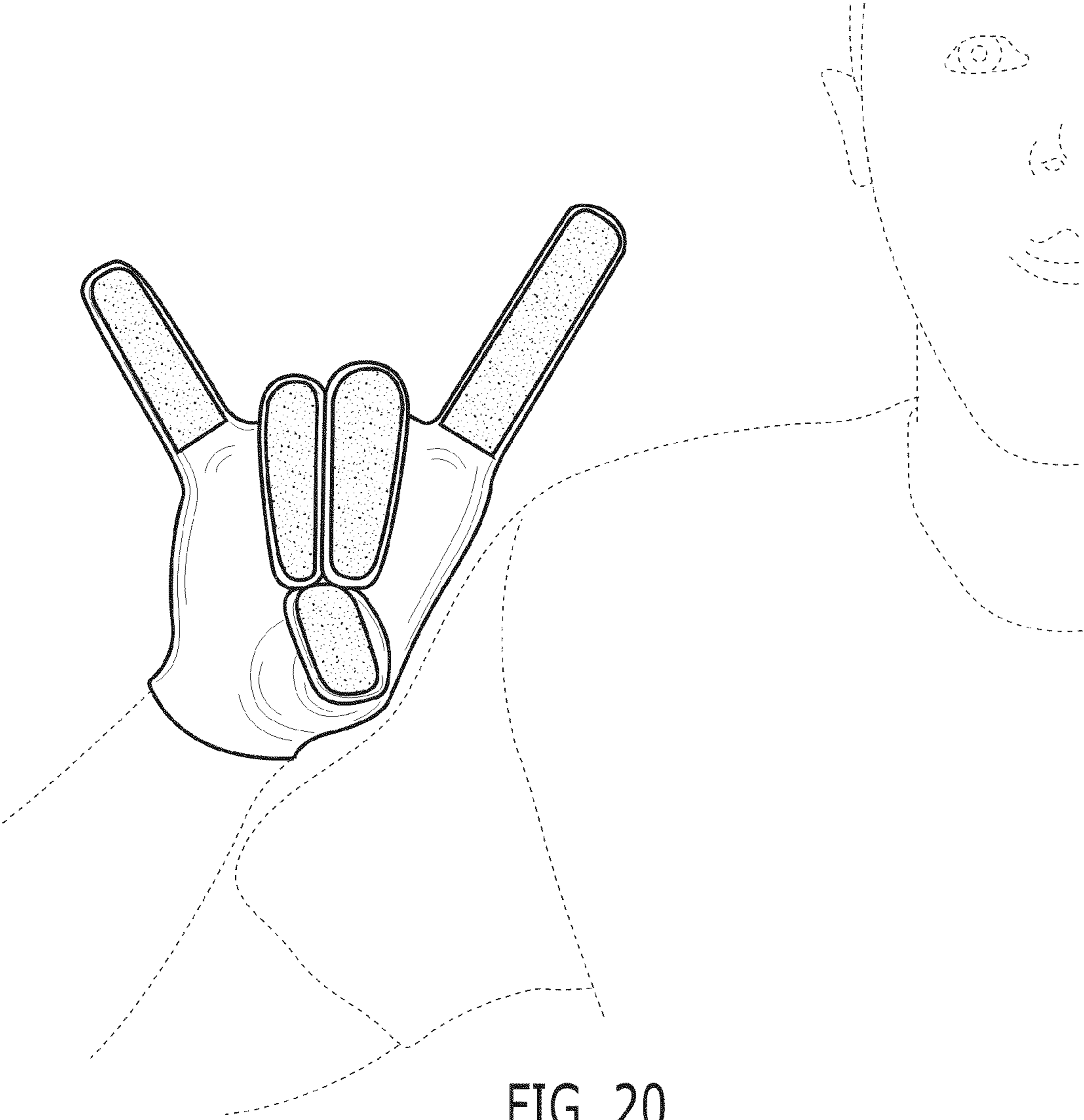
