FIG. 29 is a top view thereof;

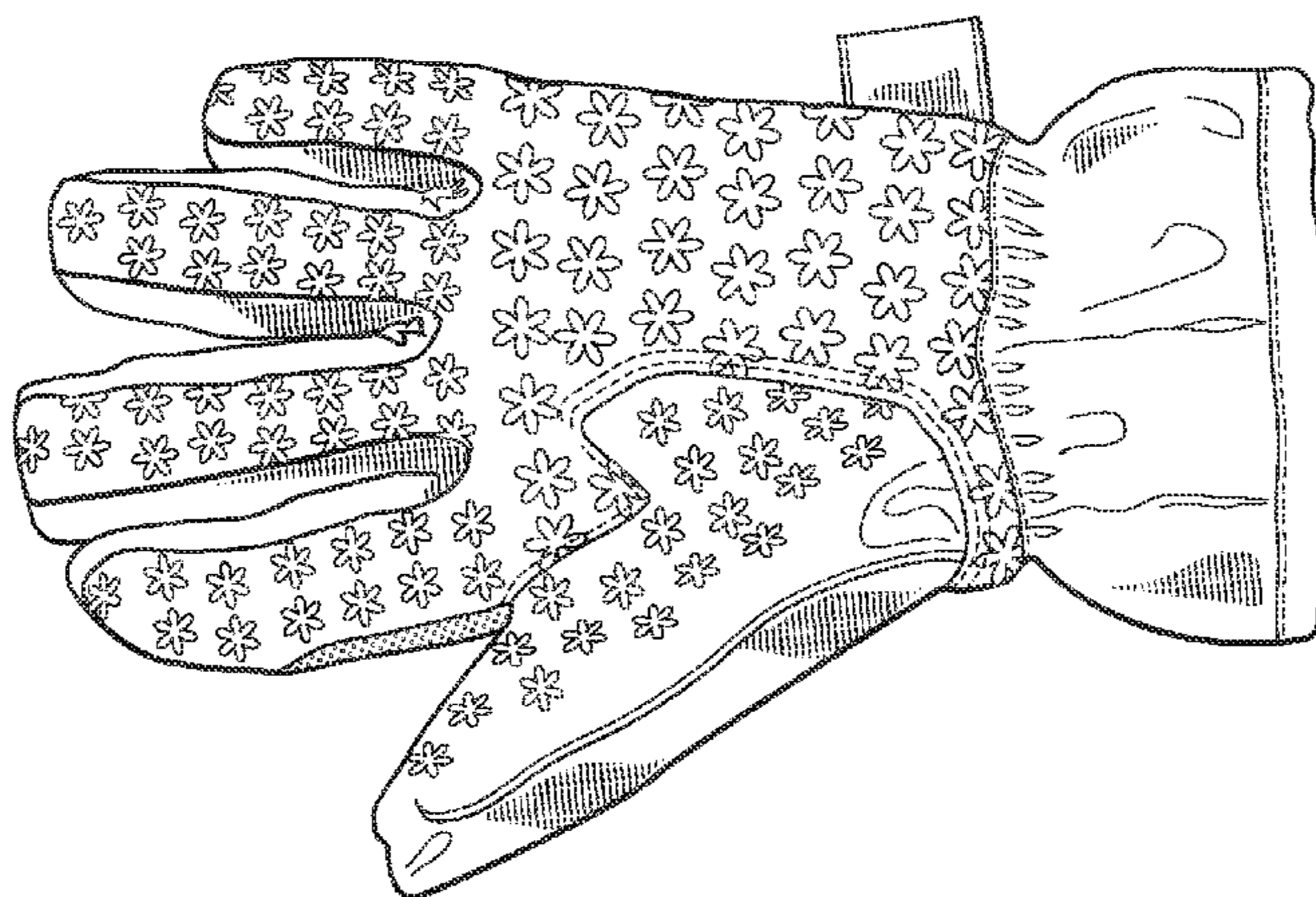
FIG. 30 is a bottom view thereof;

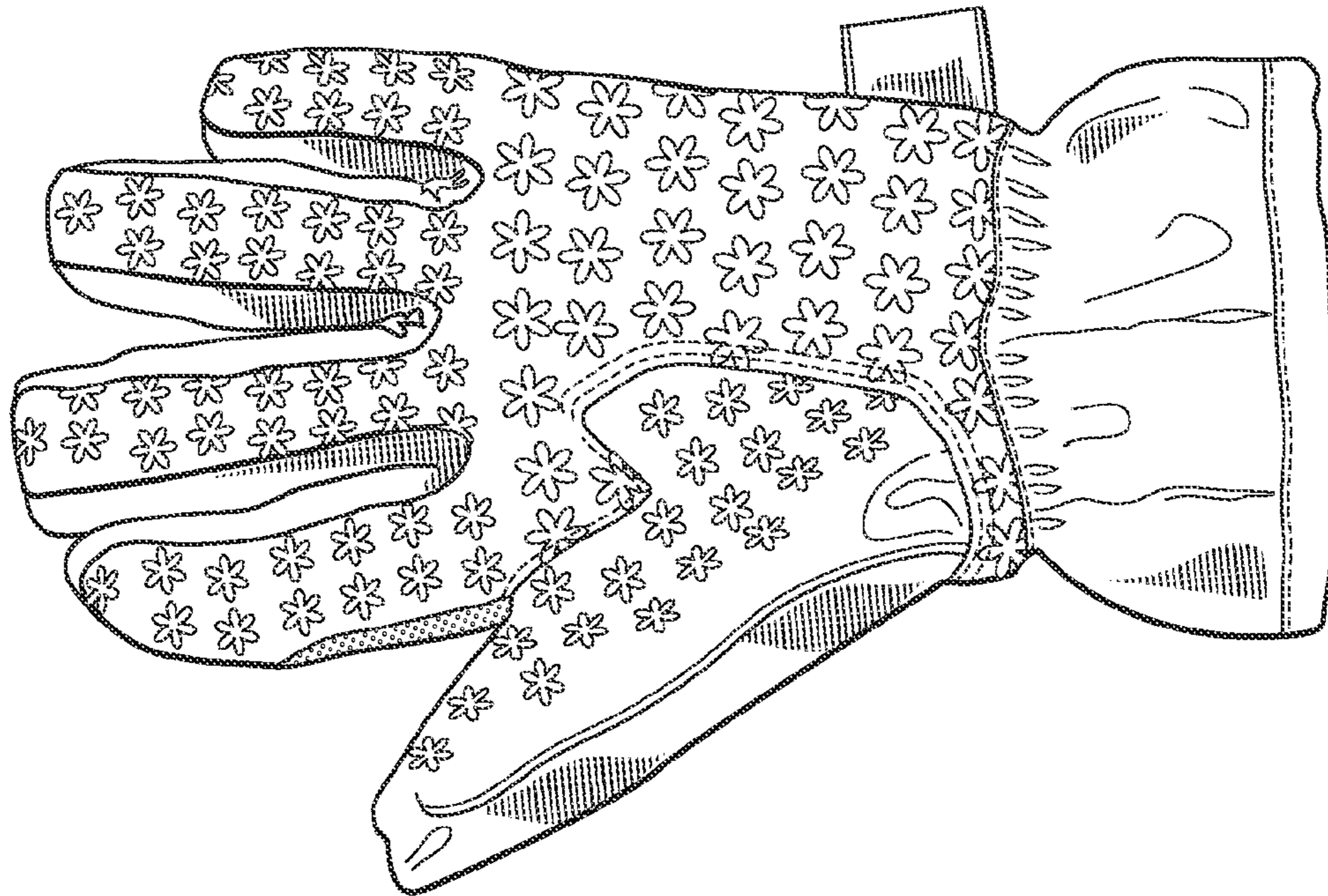

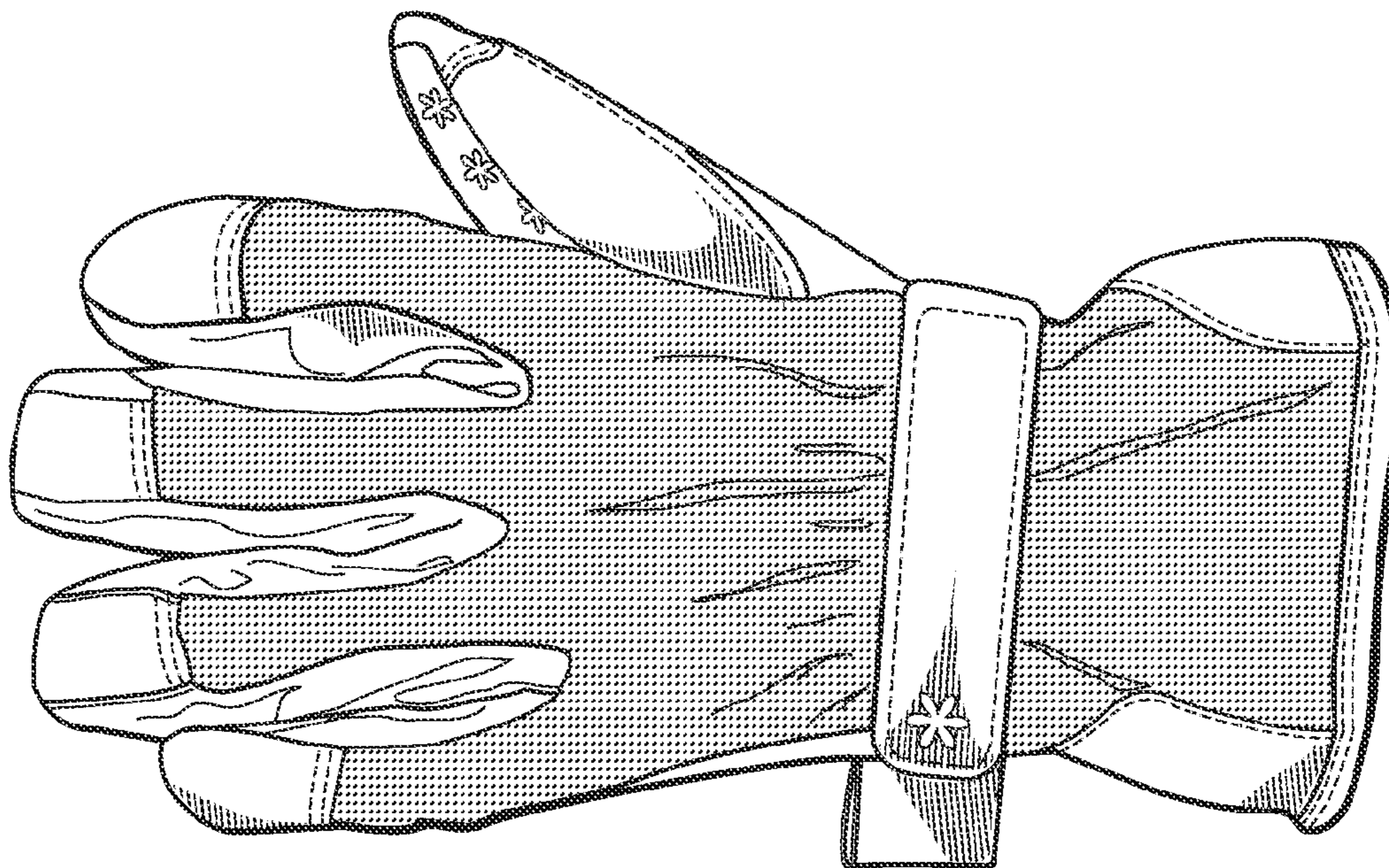

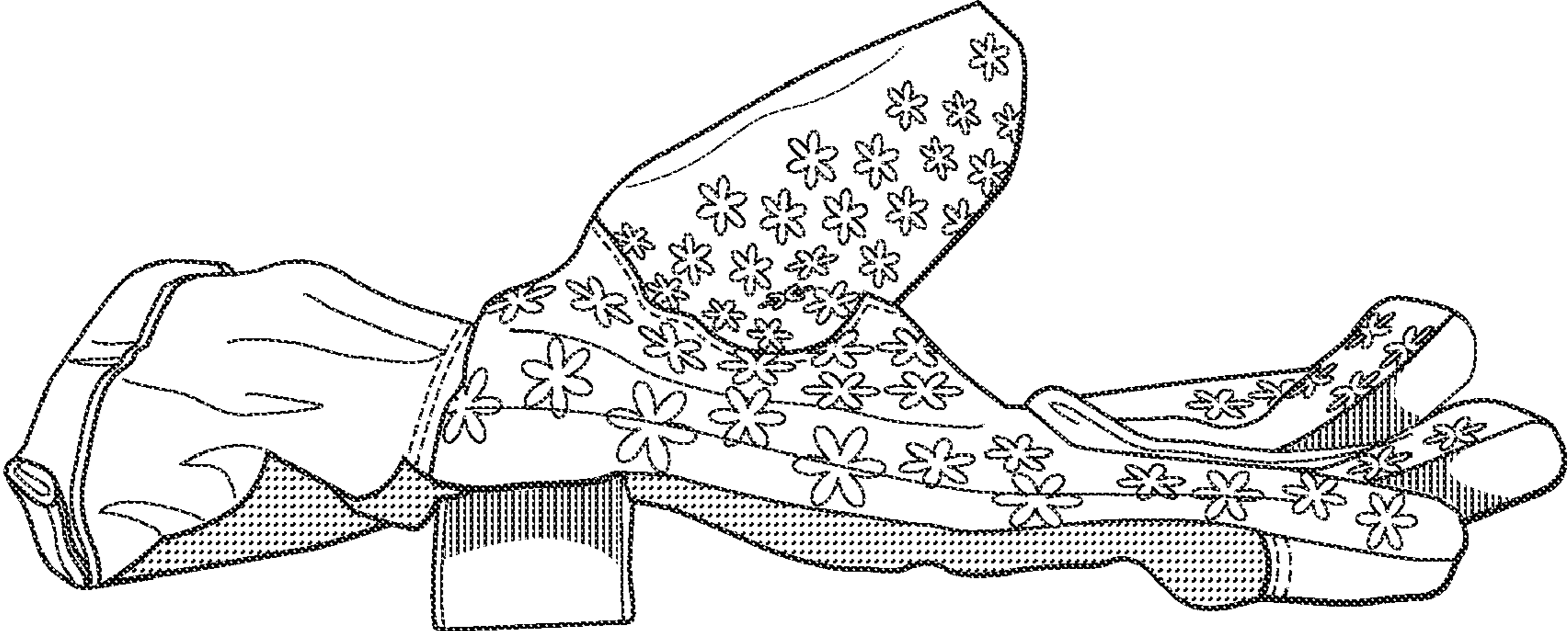

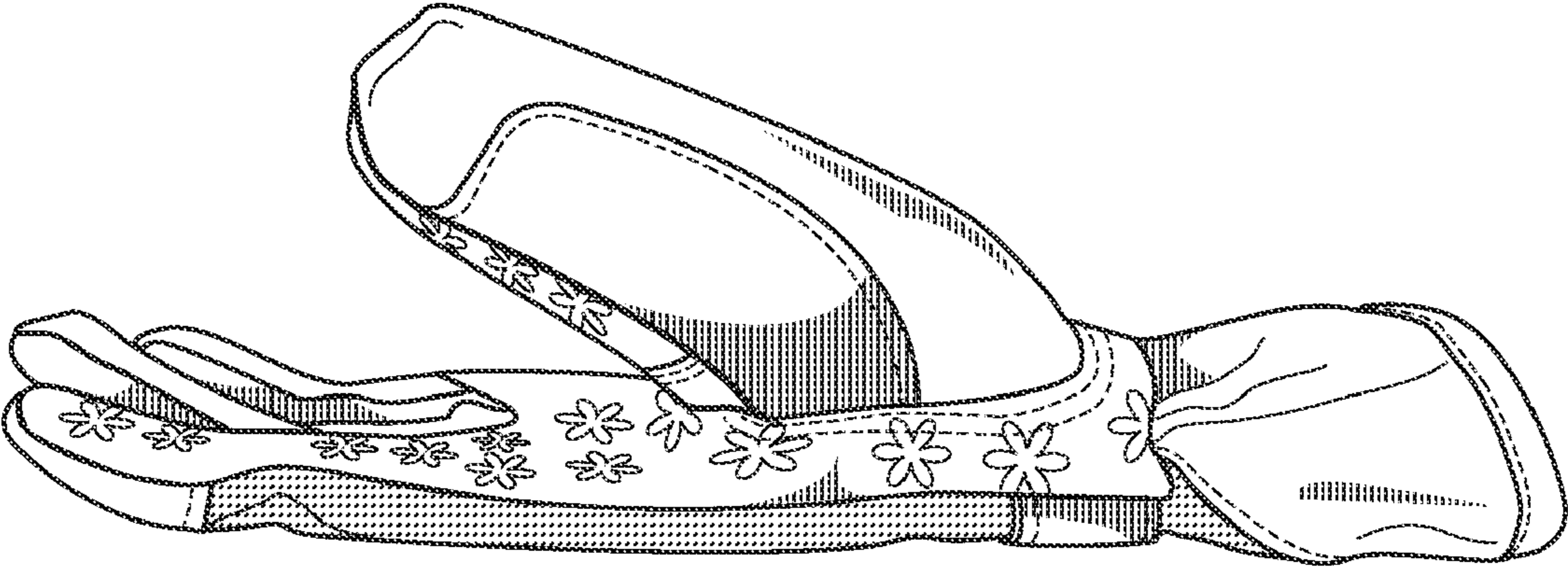
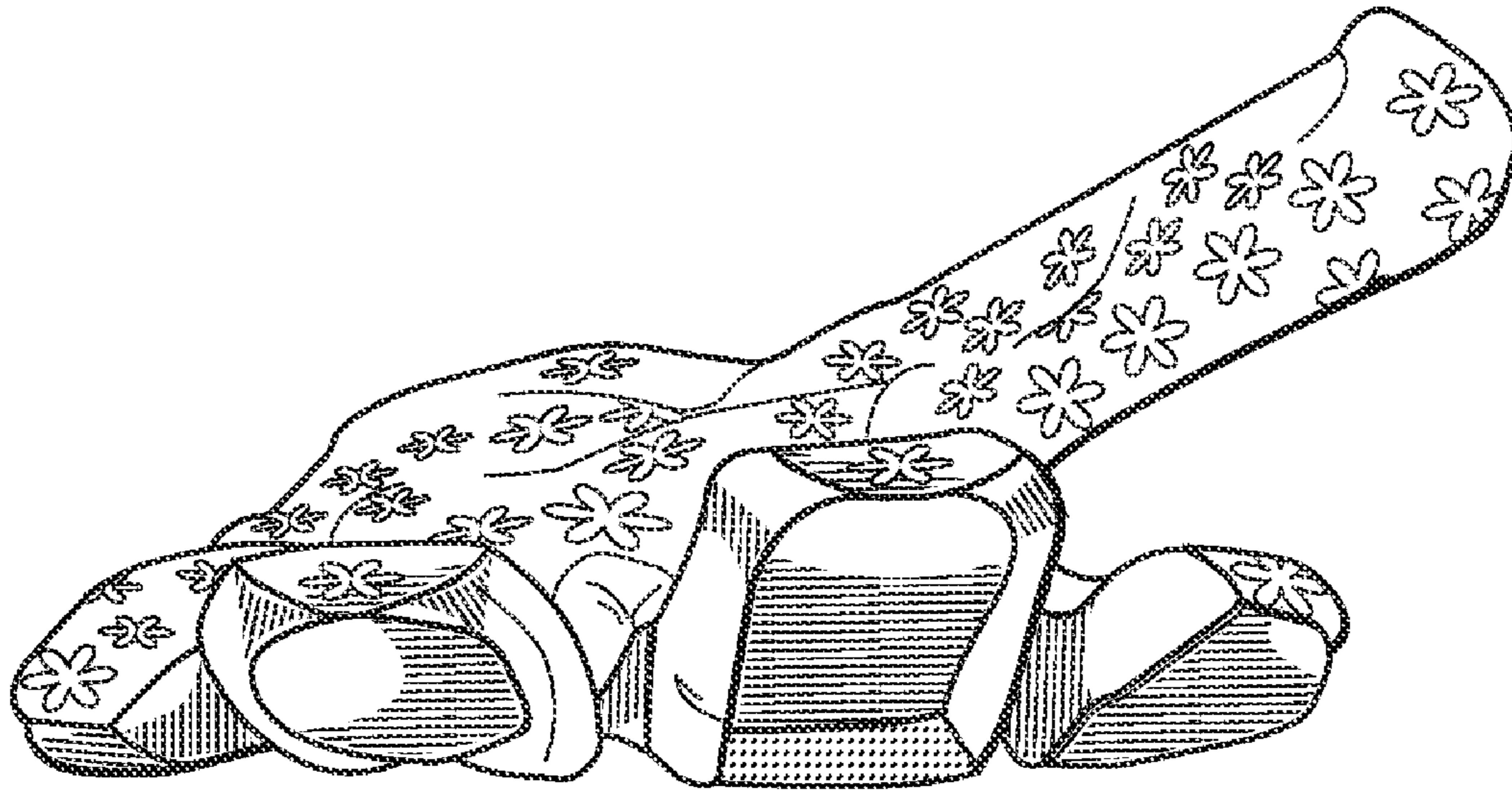
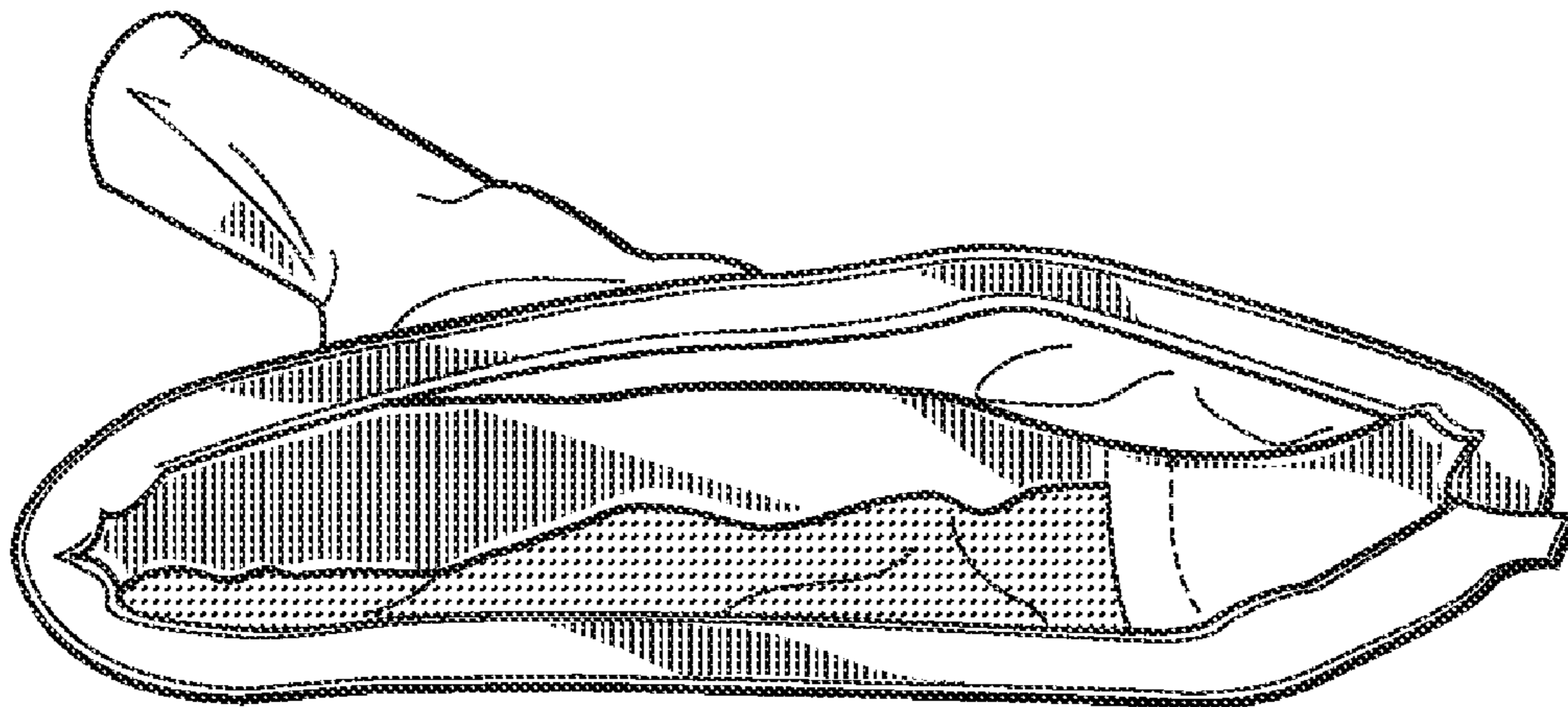

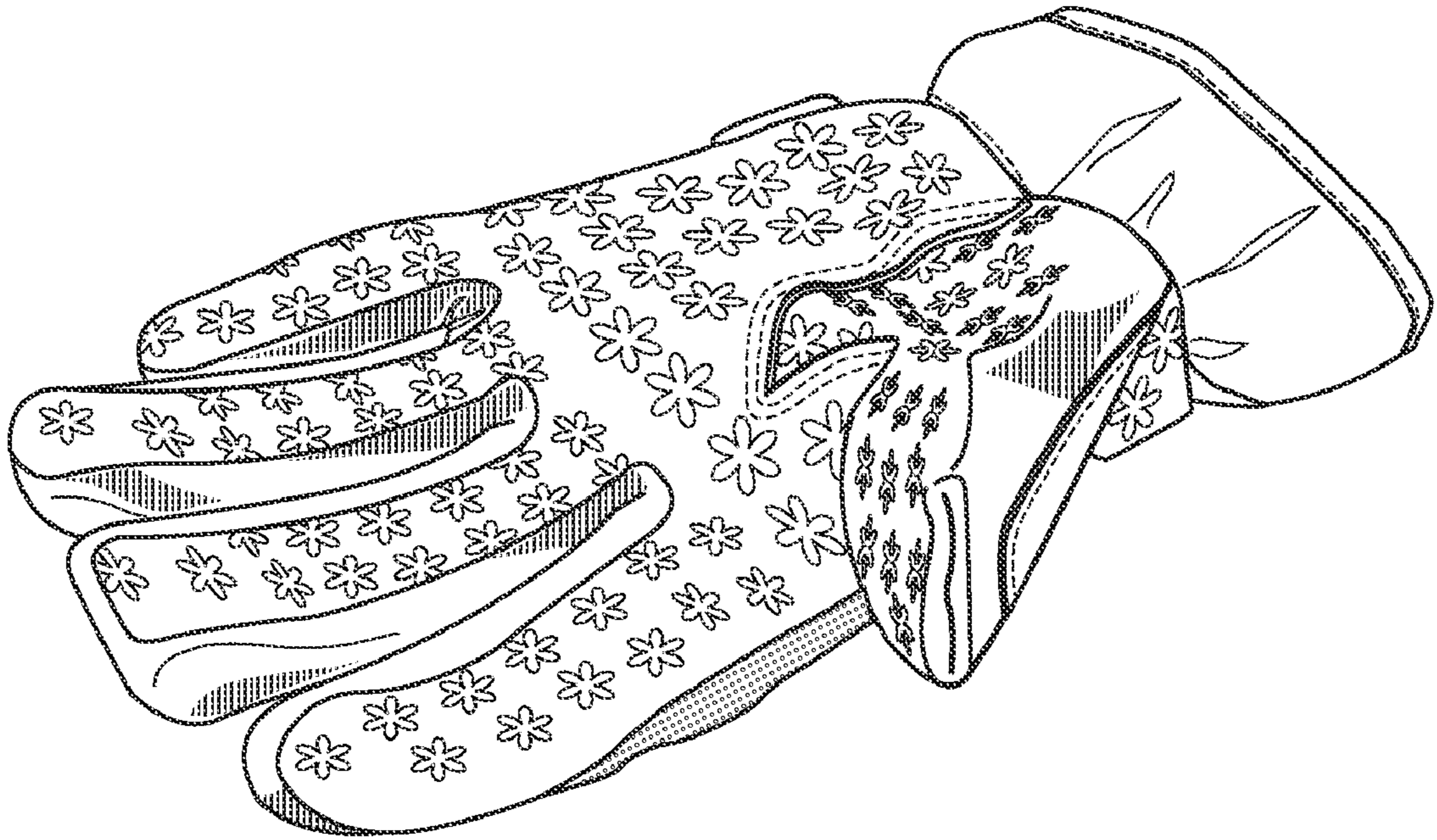

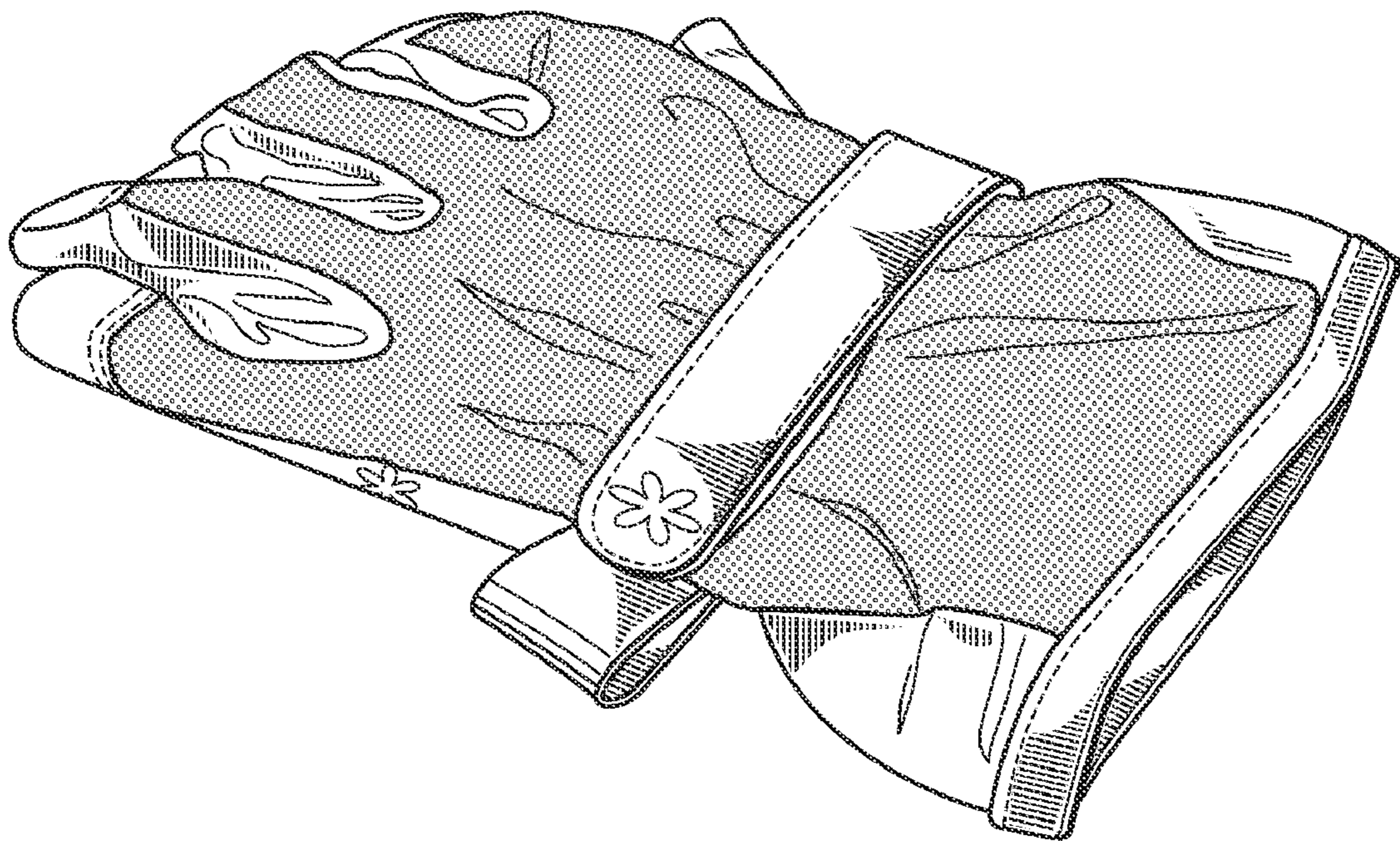

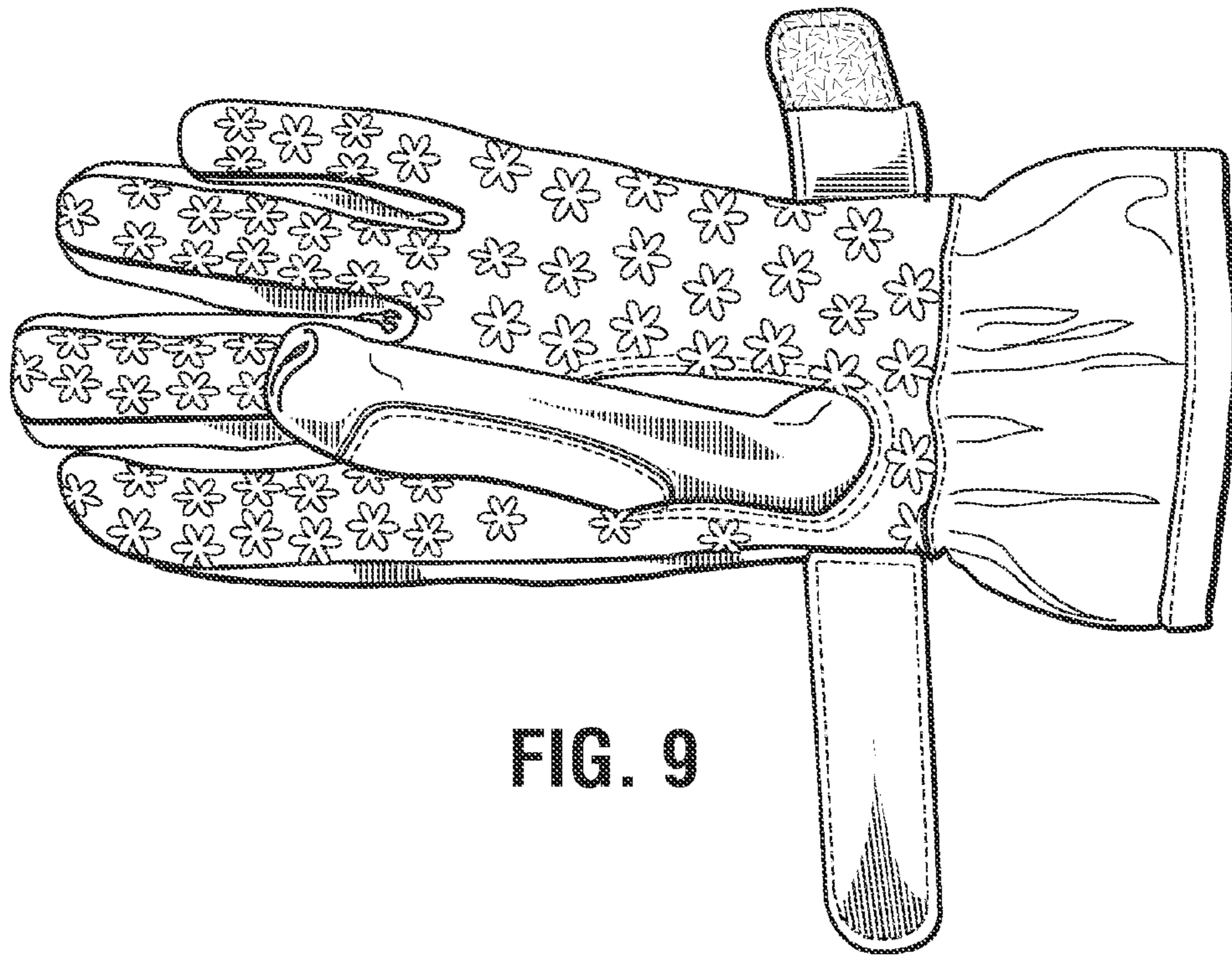

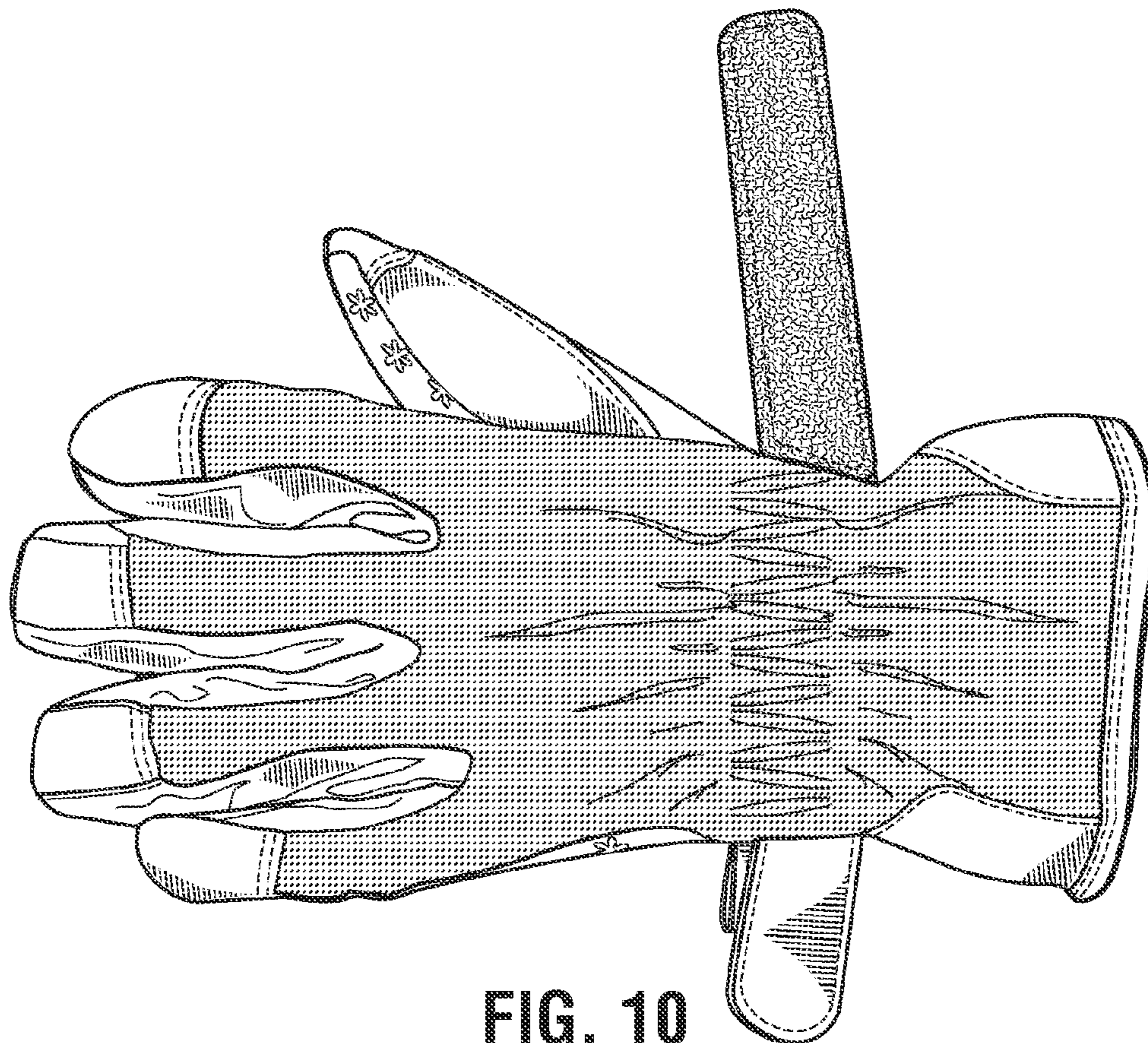

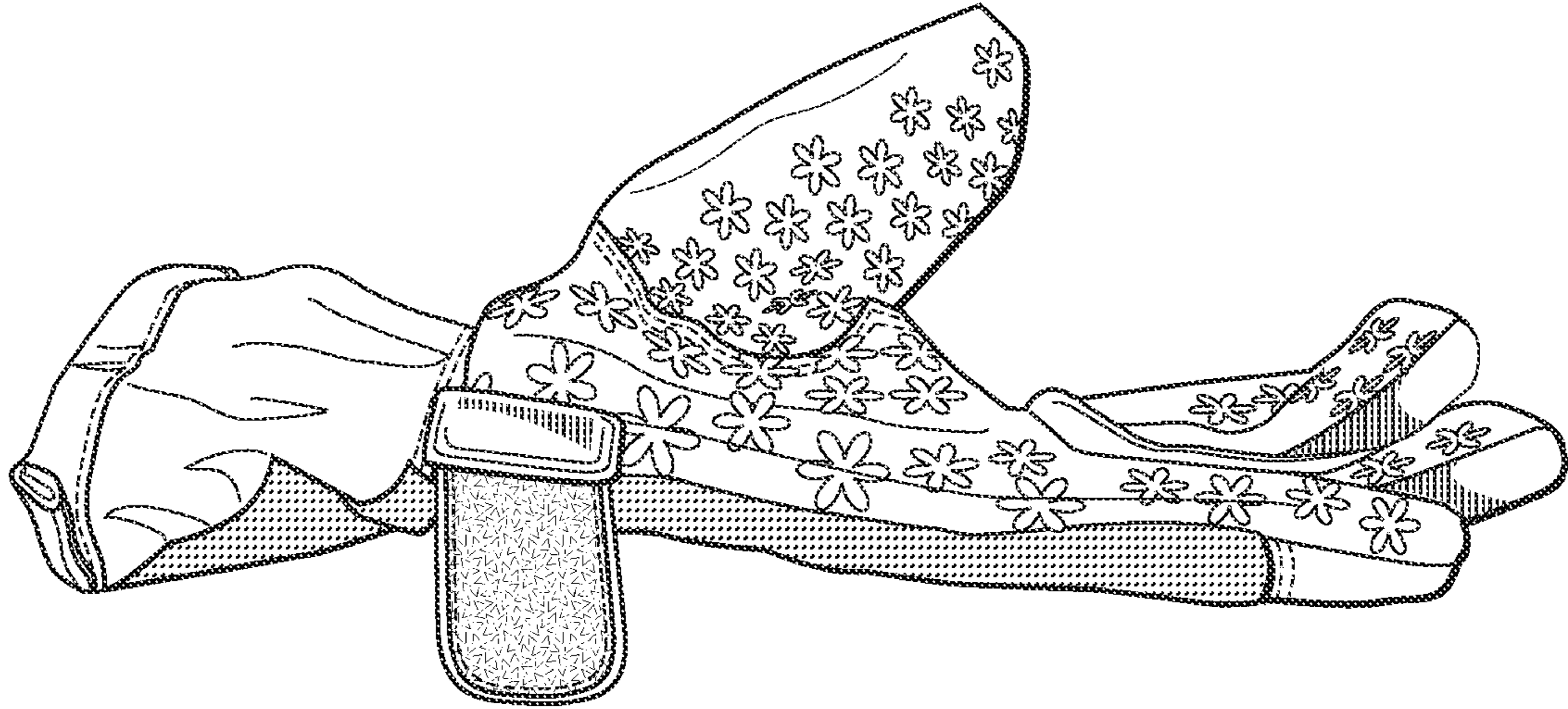

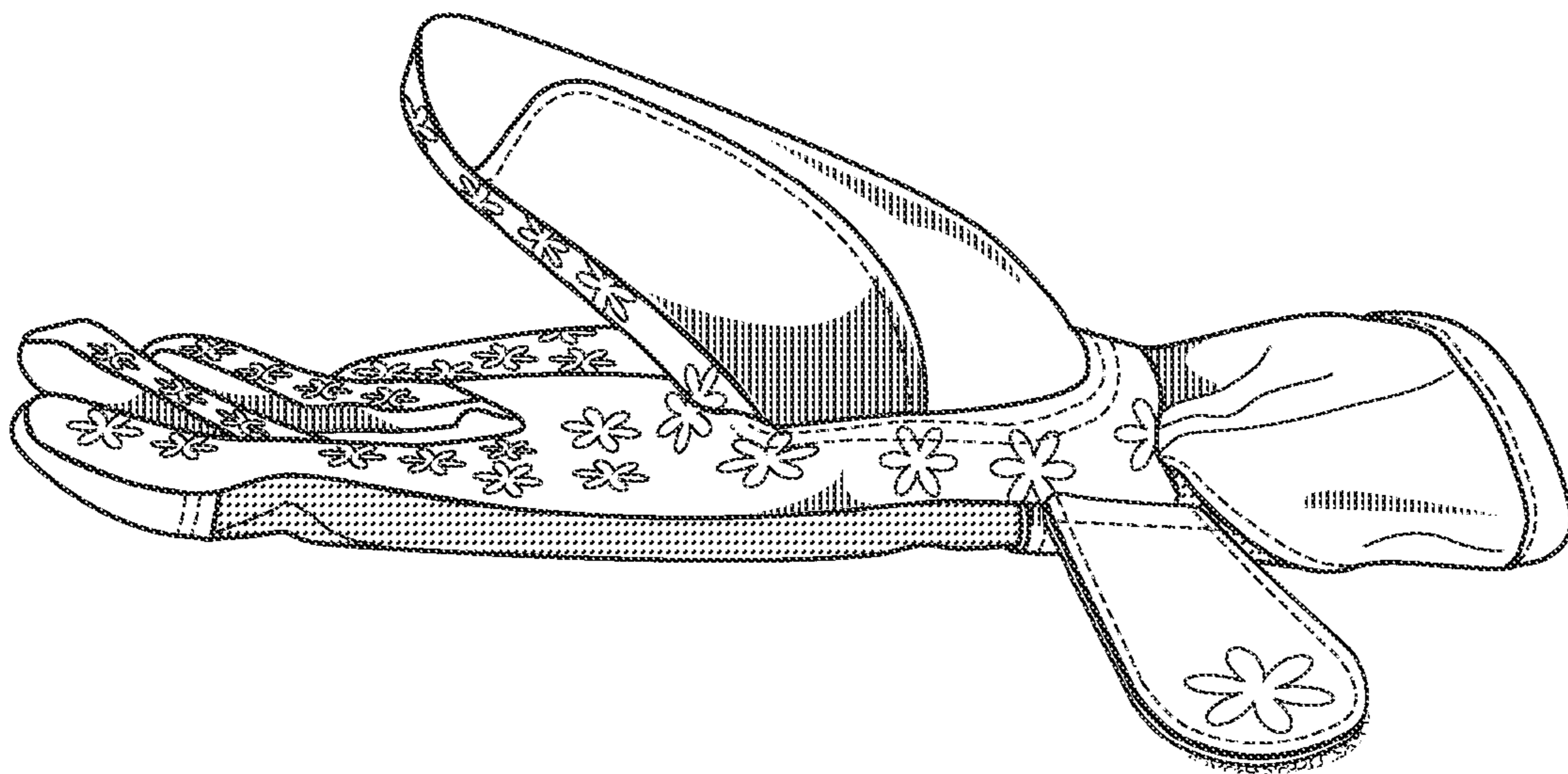

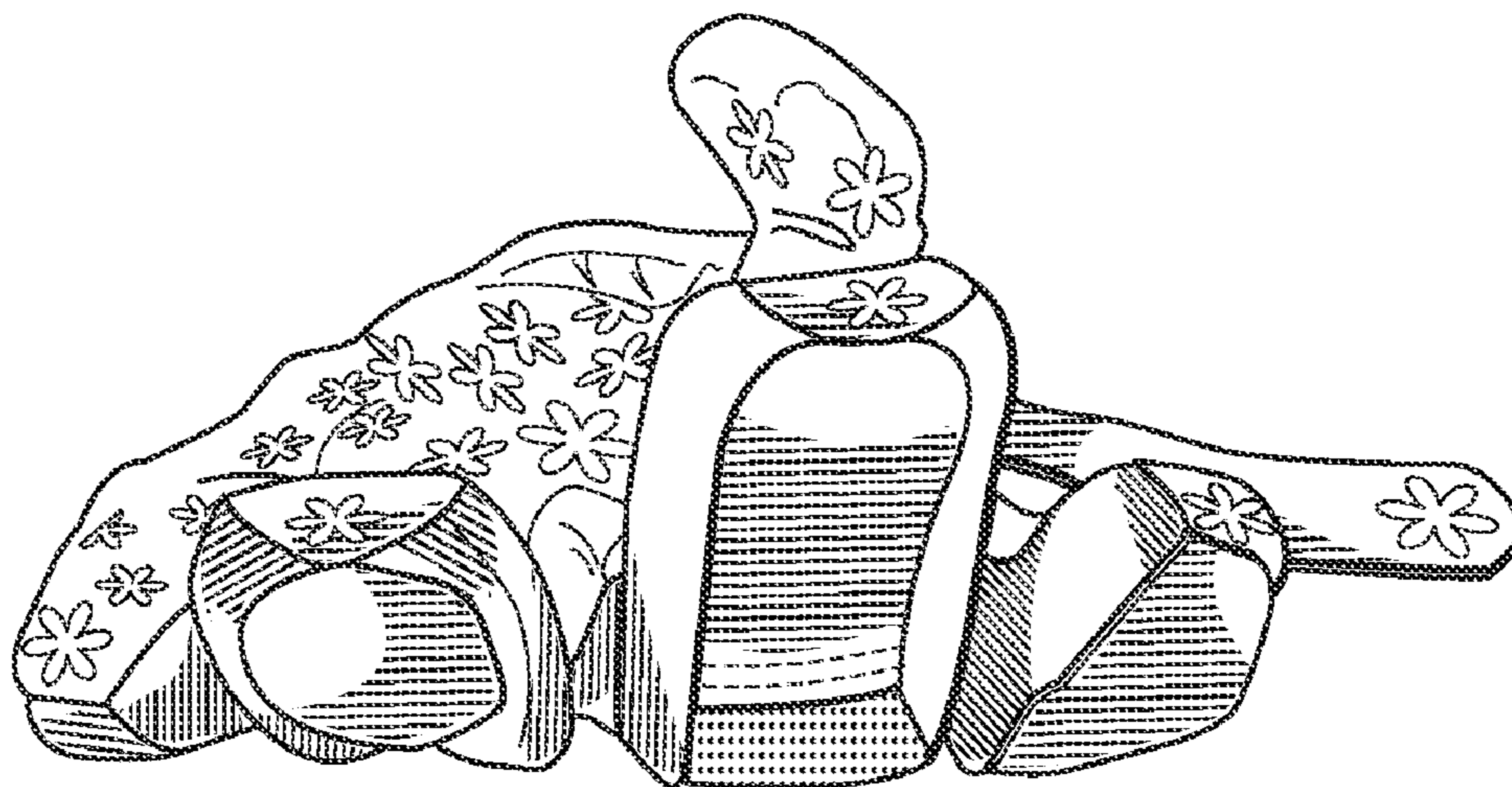

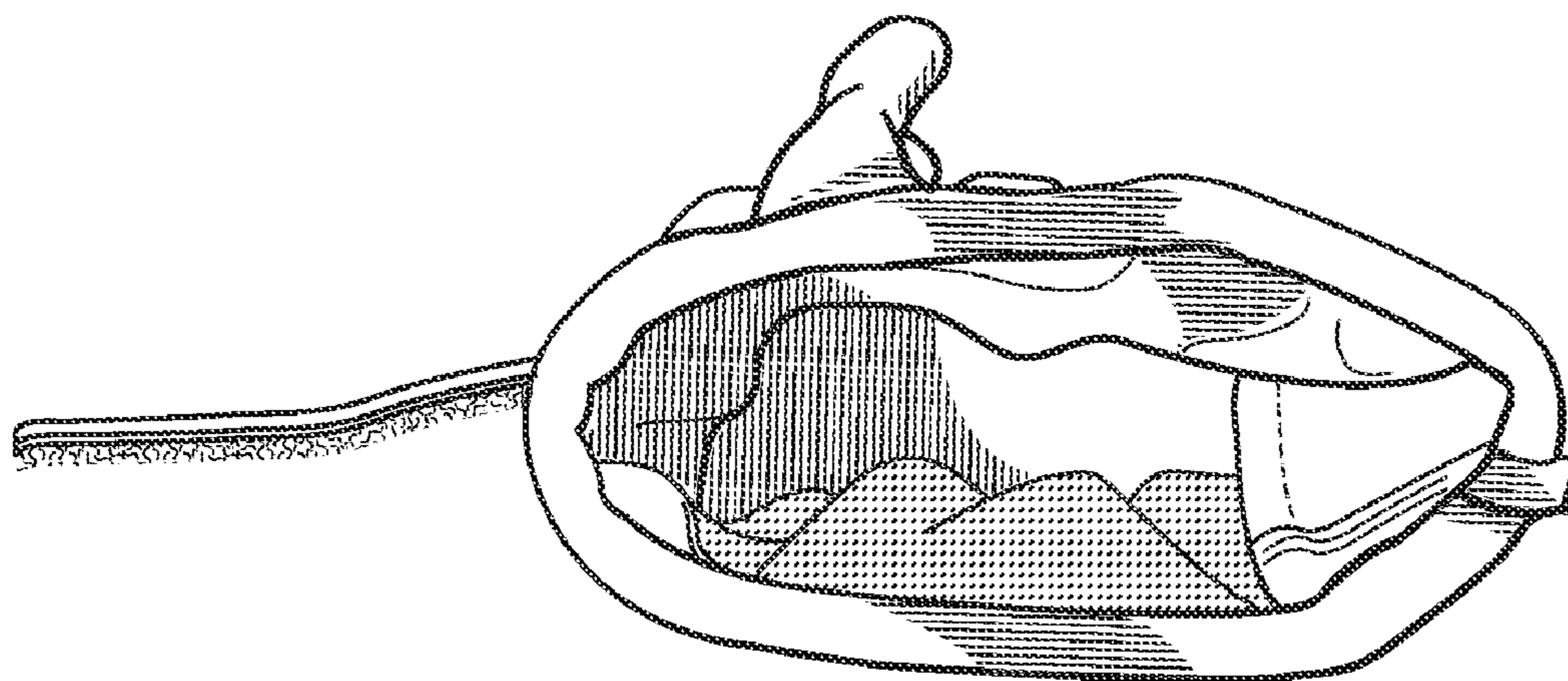

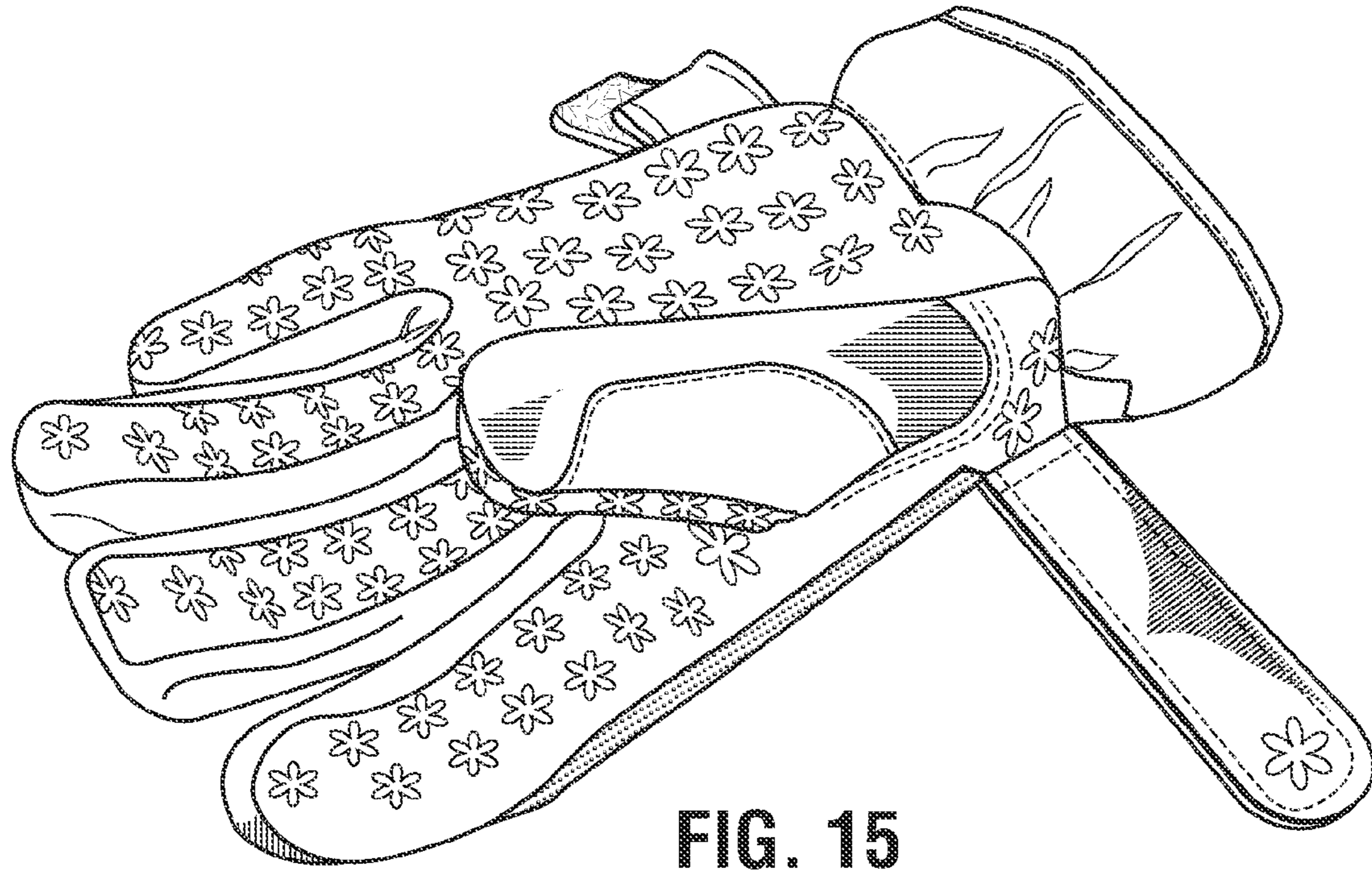

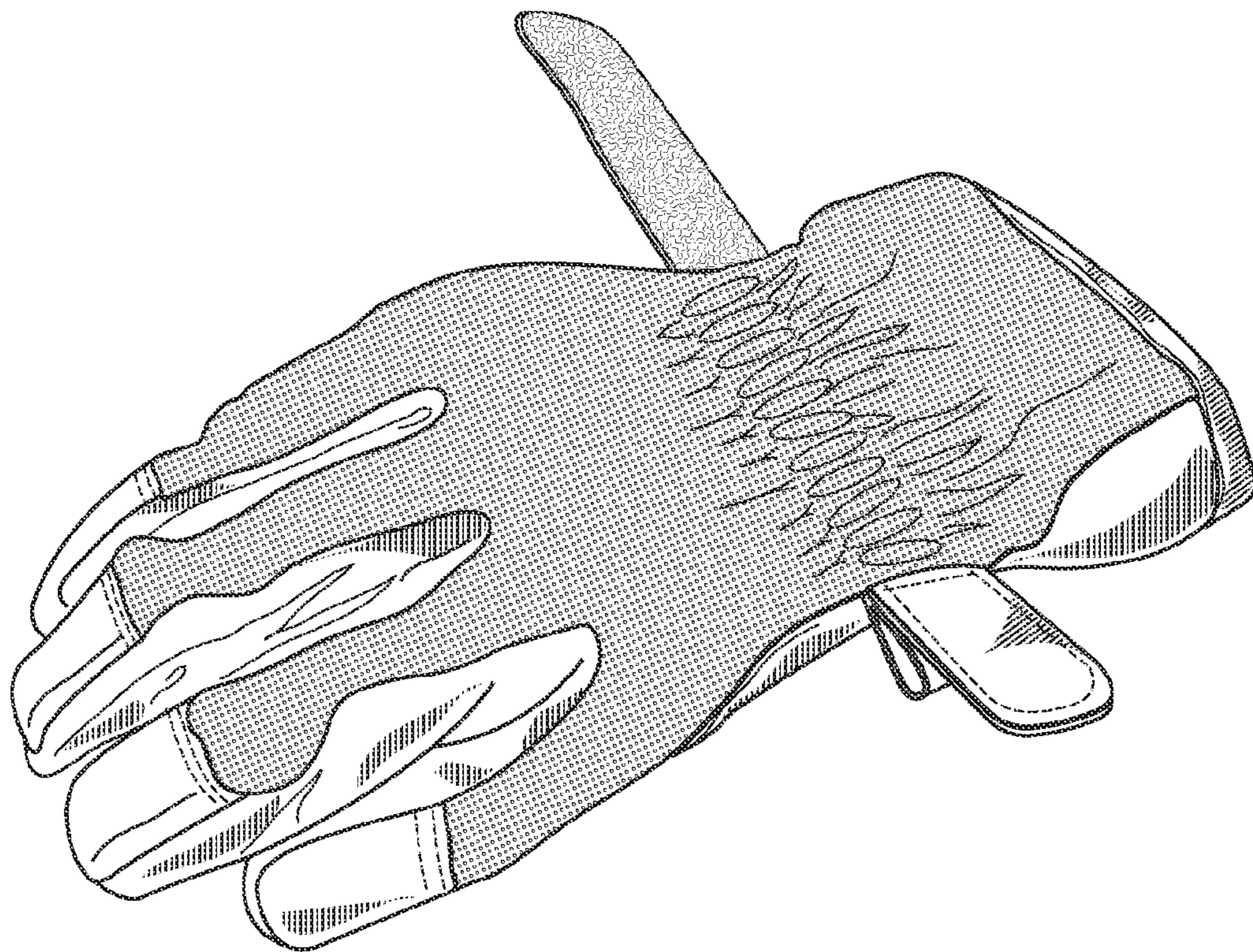

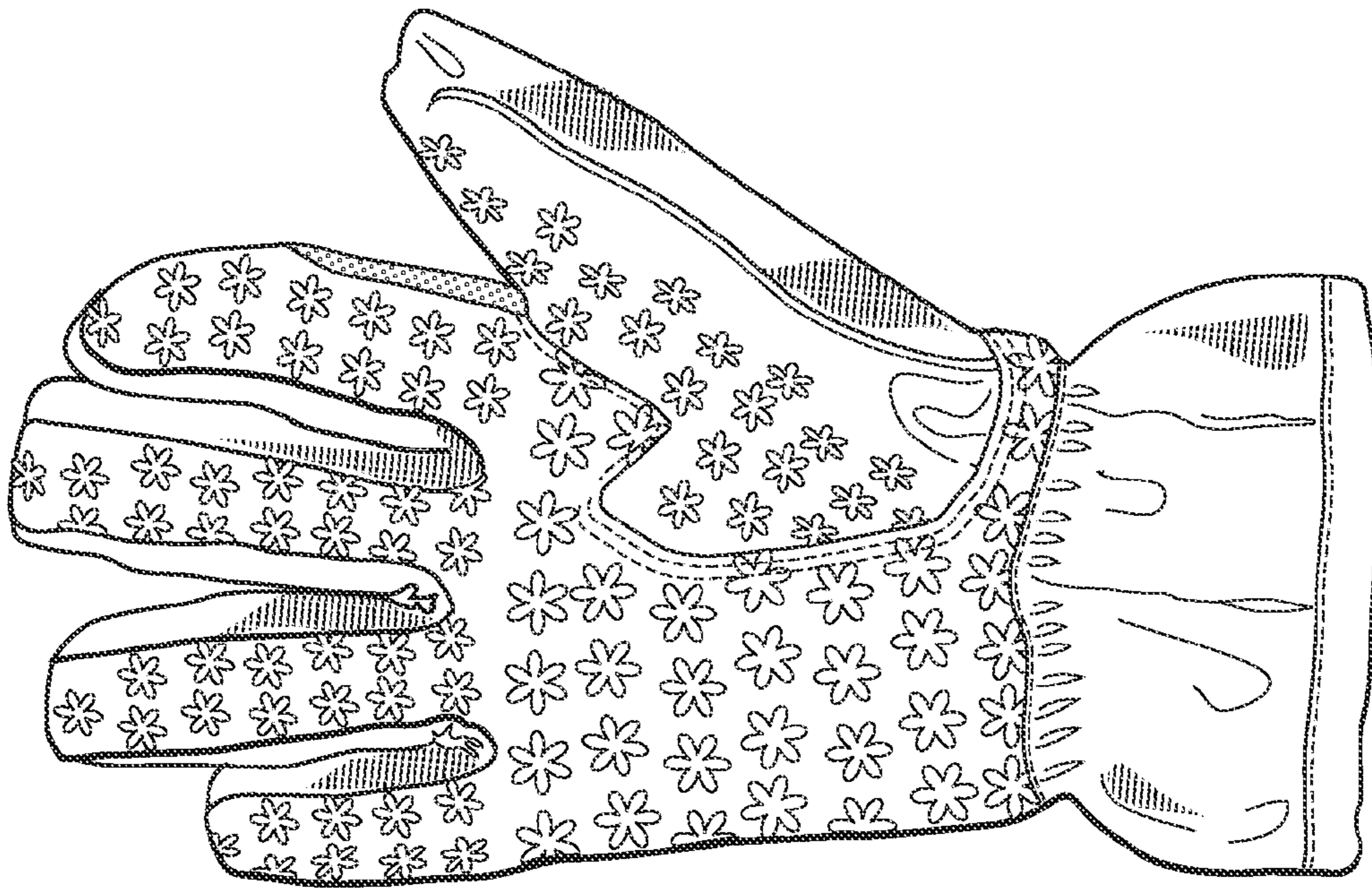

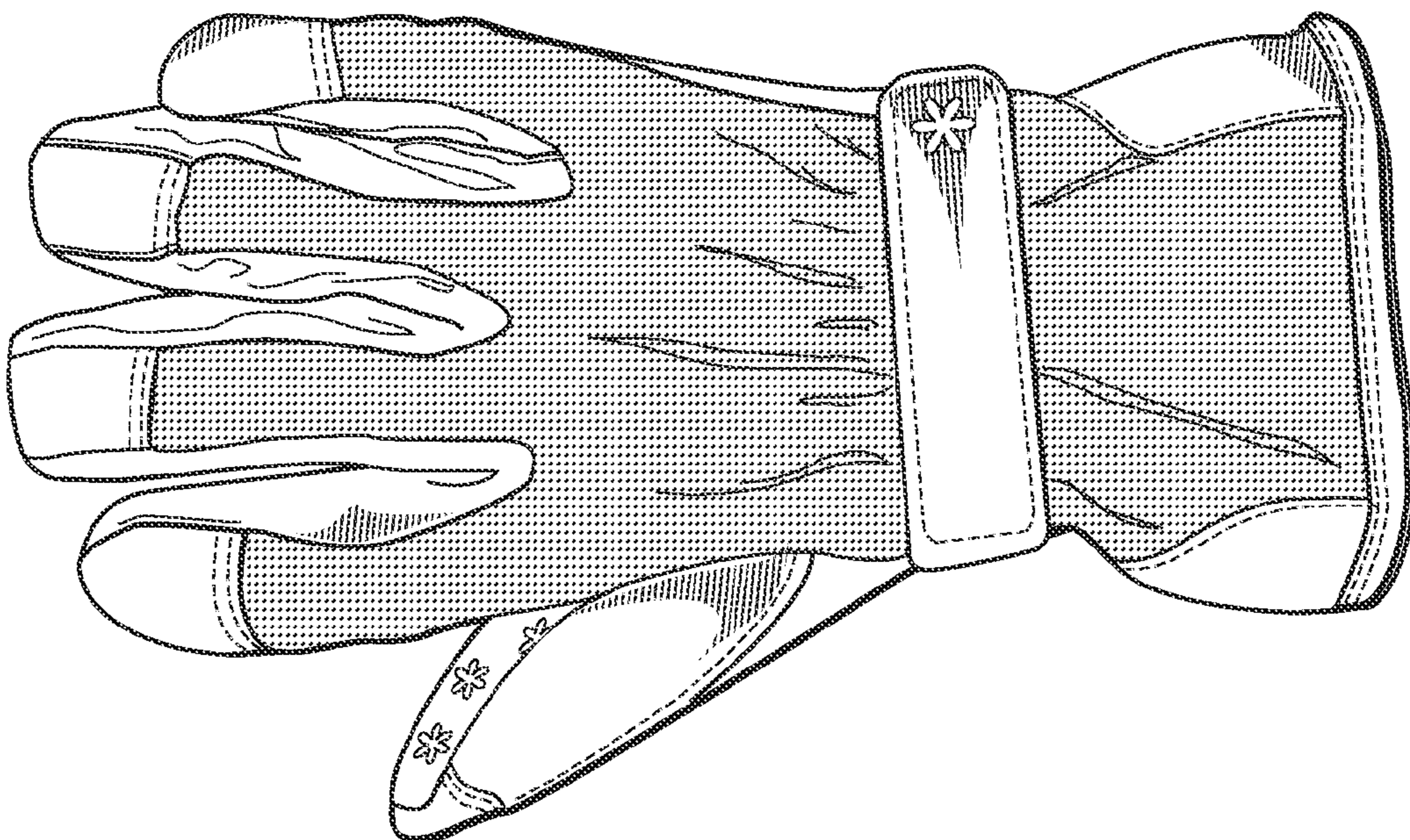

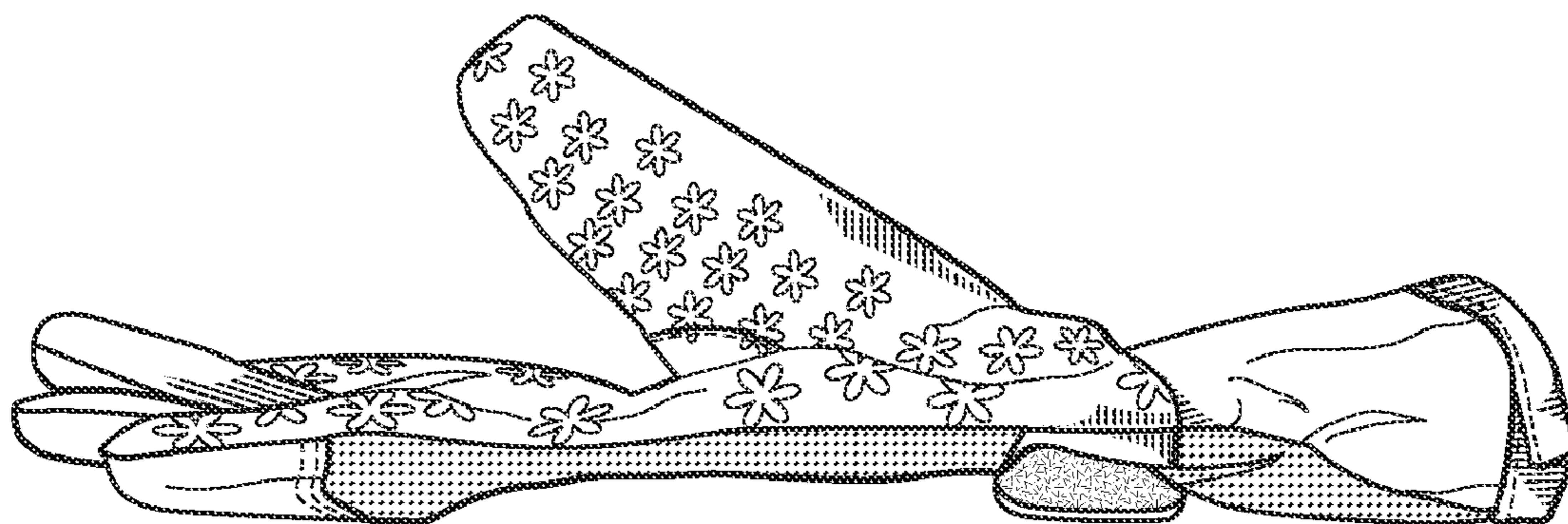

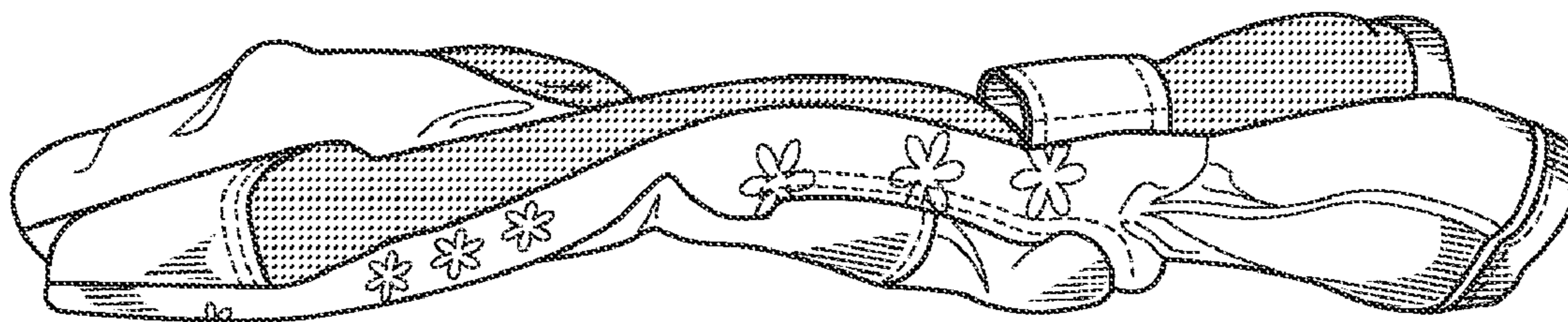

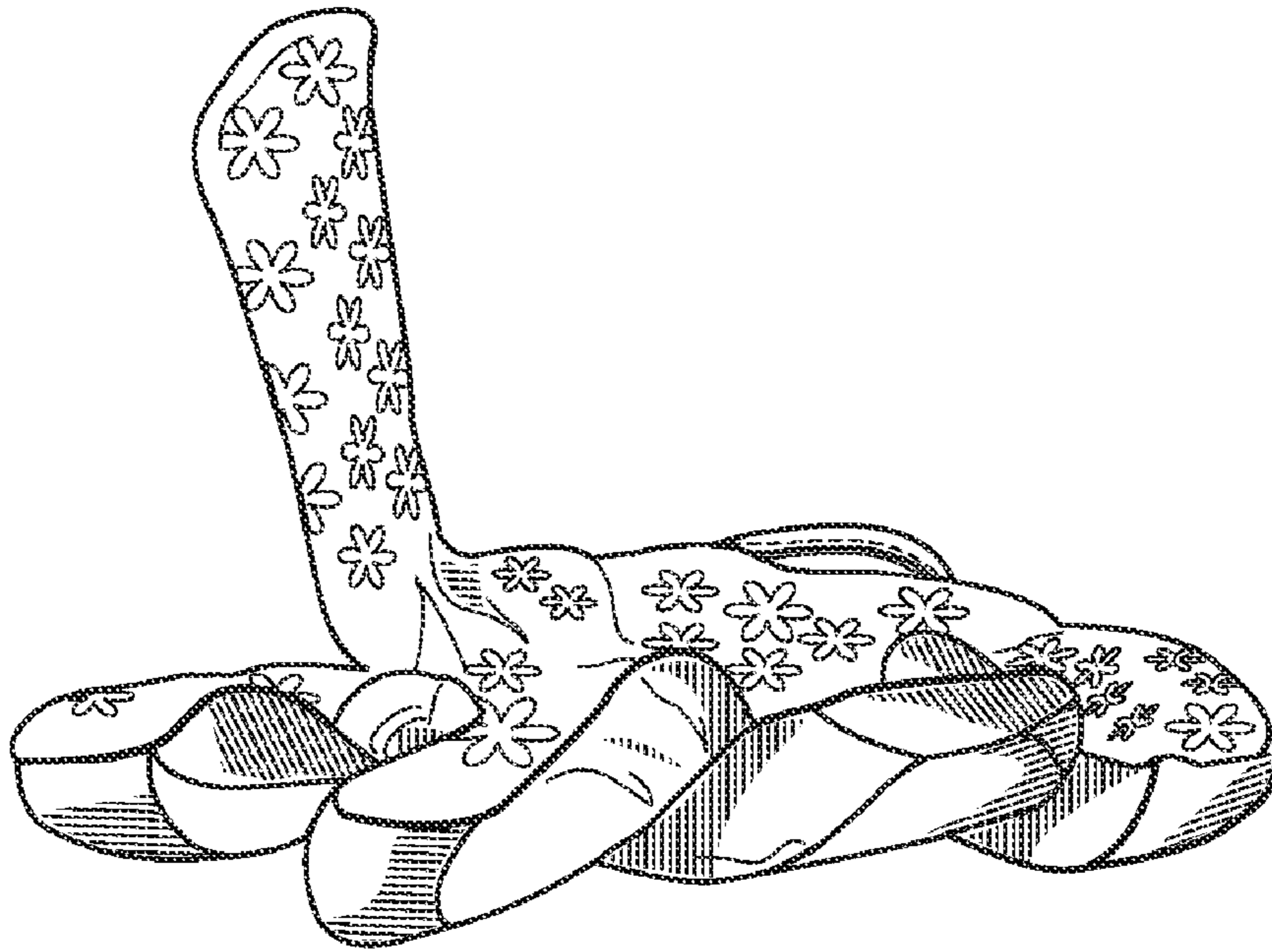

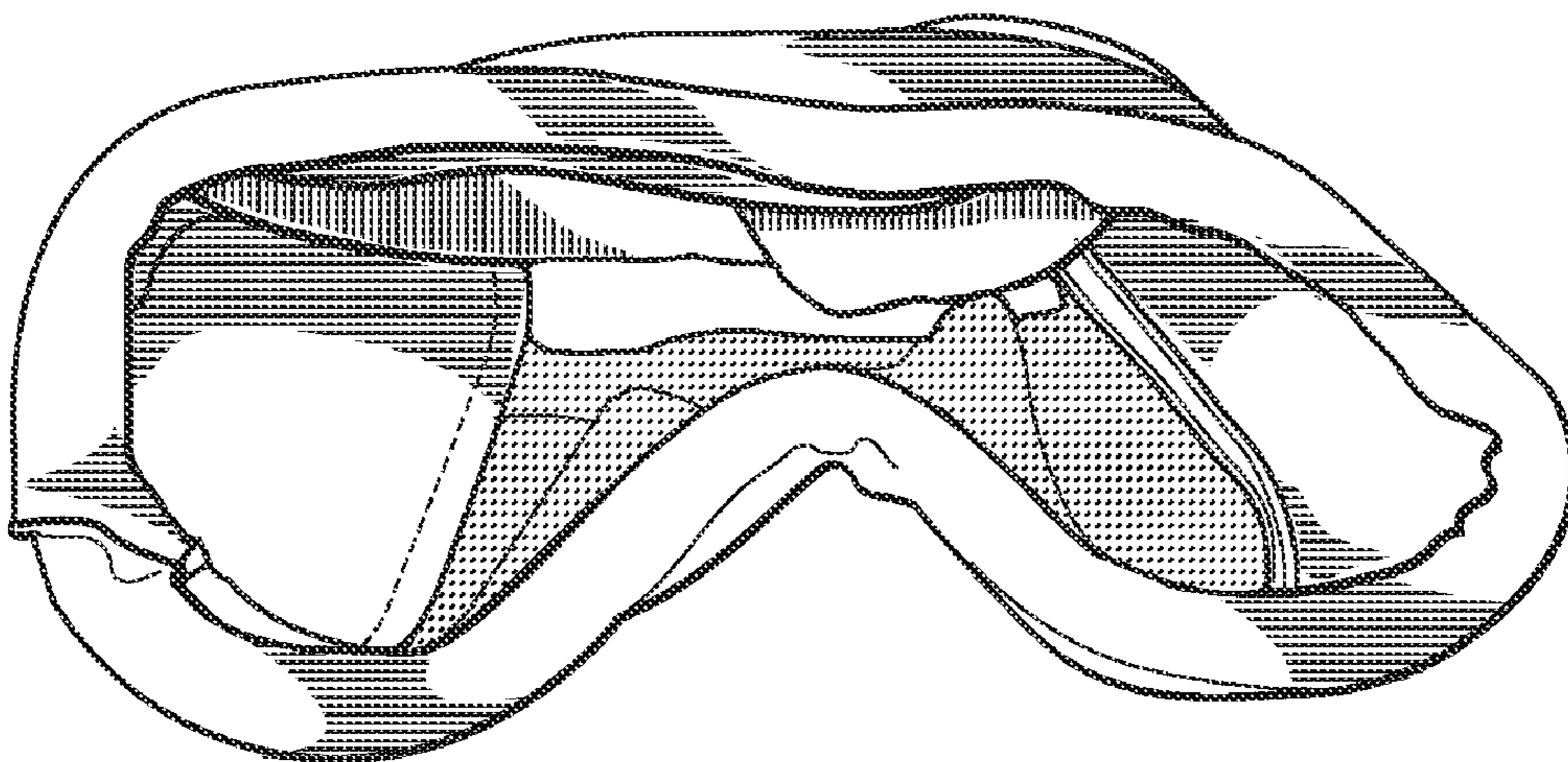
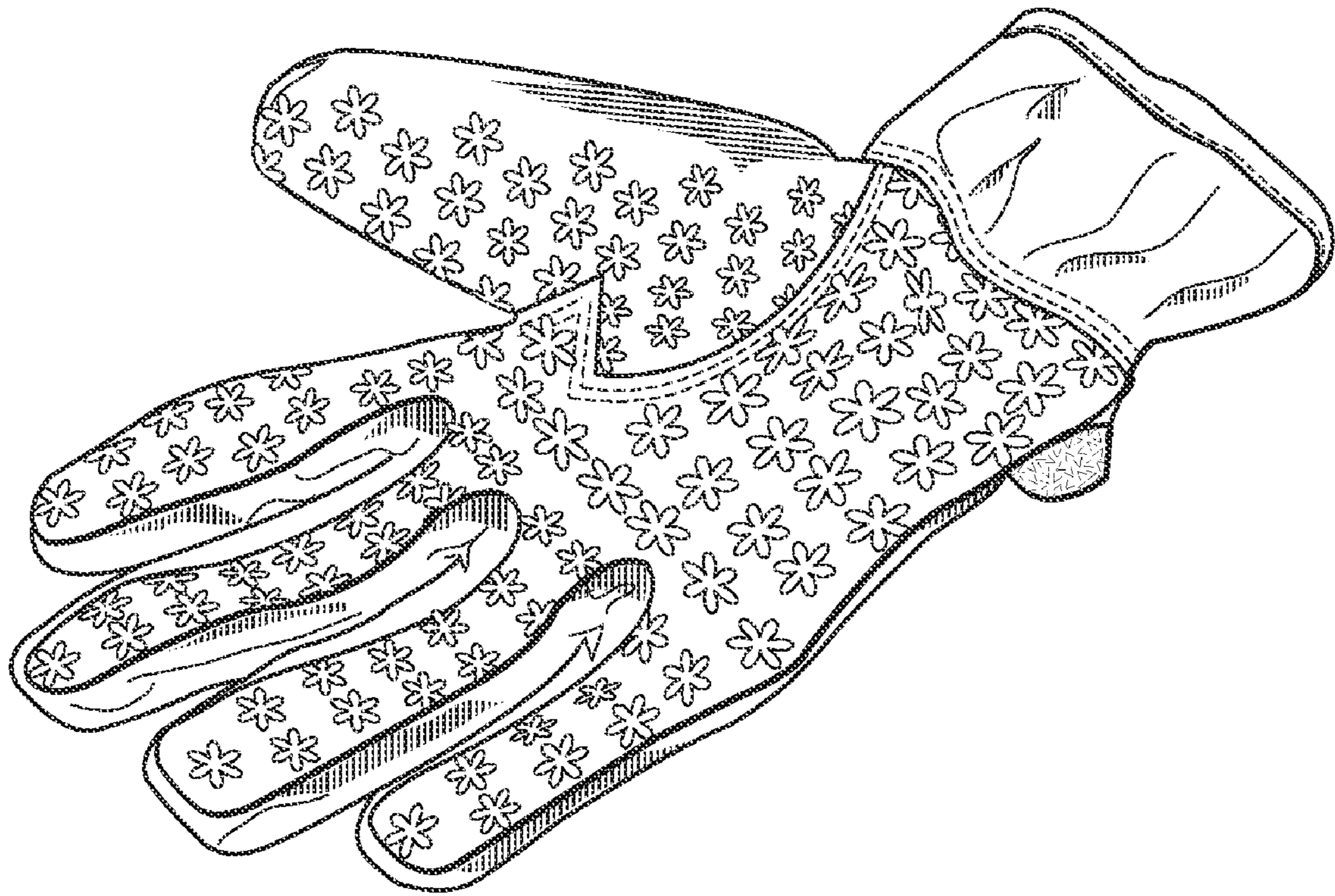
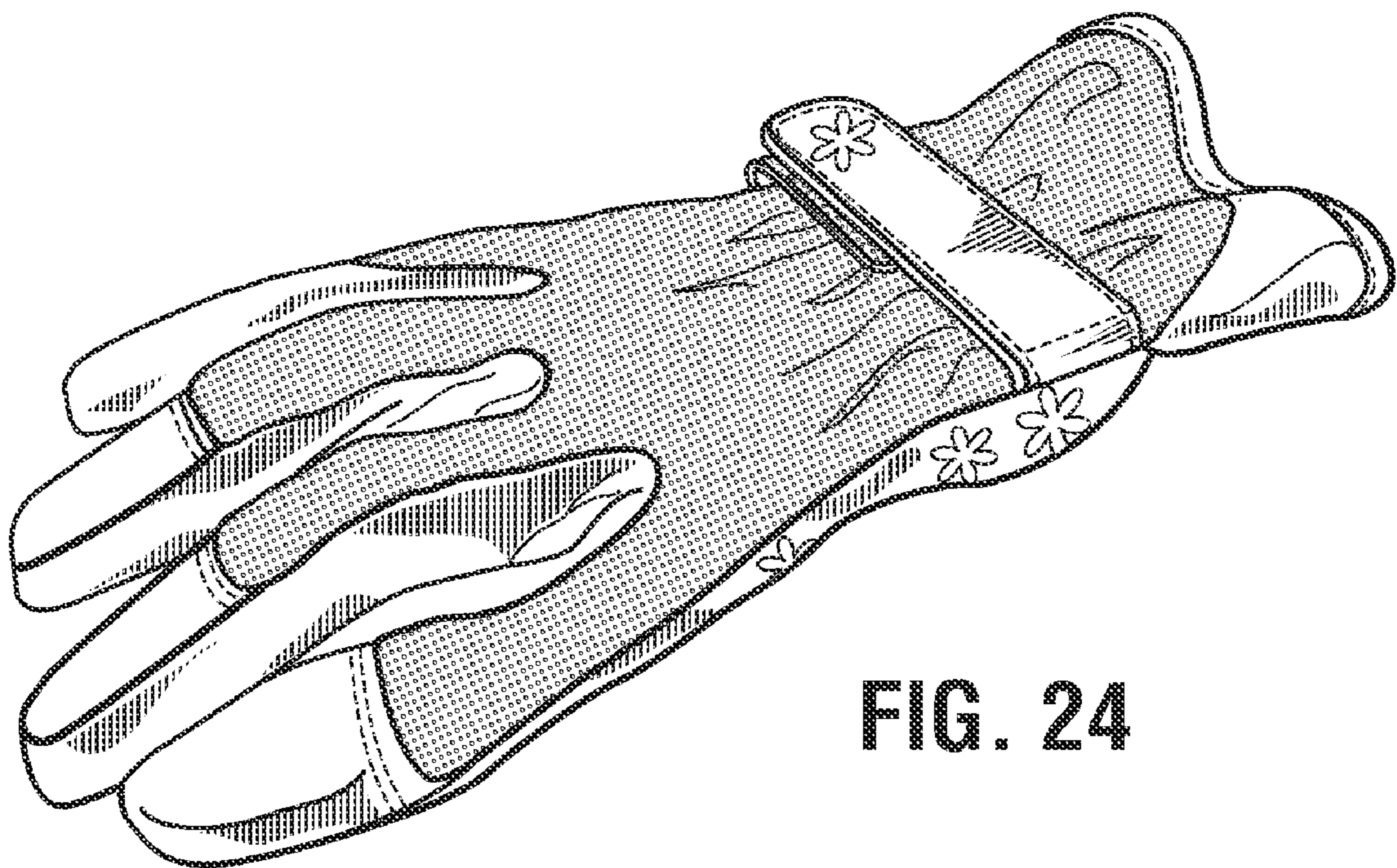

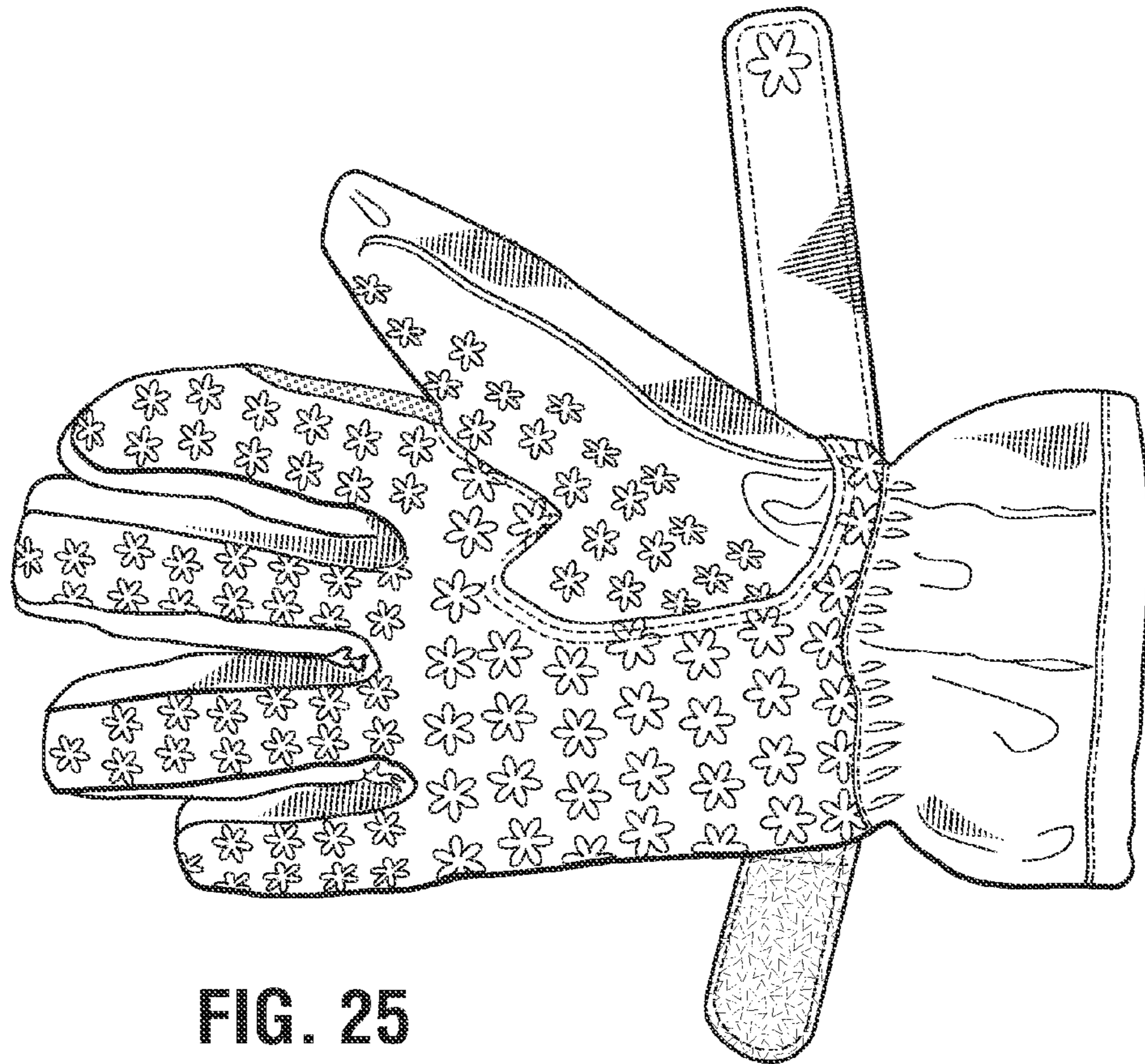

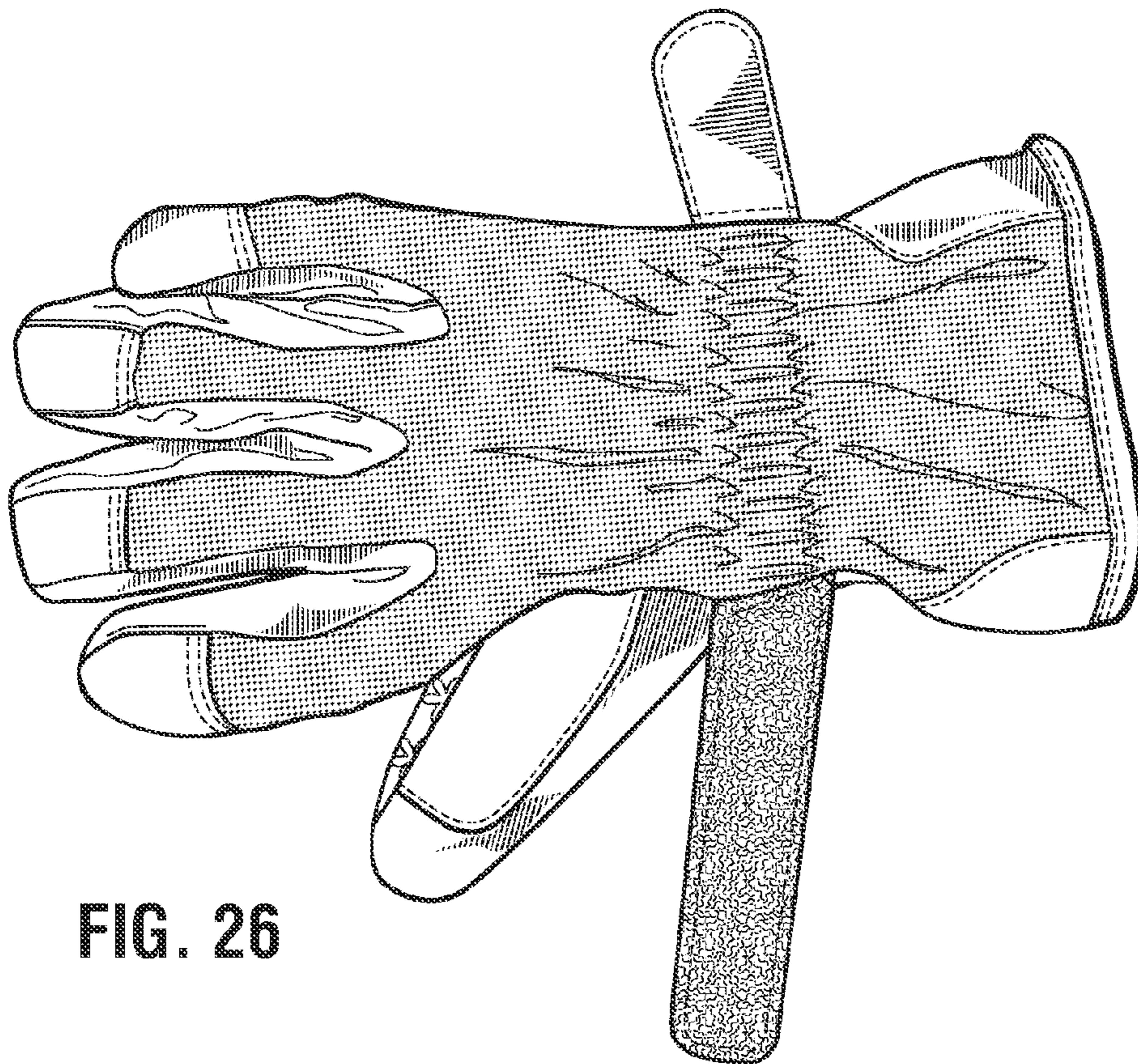

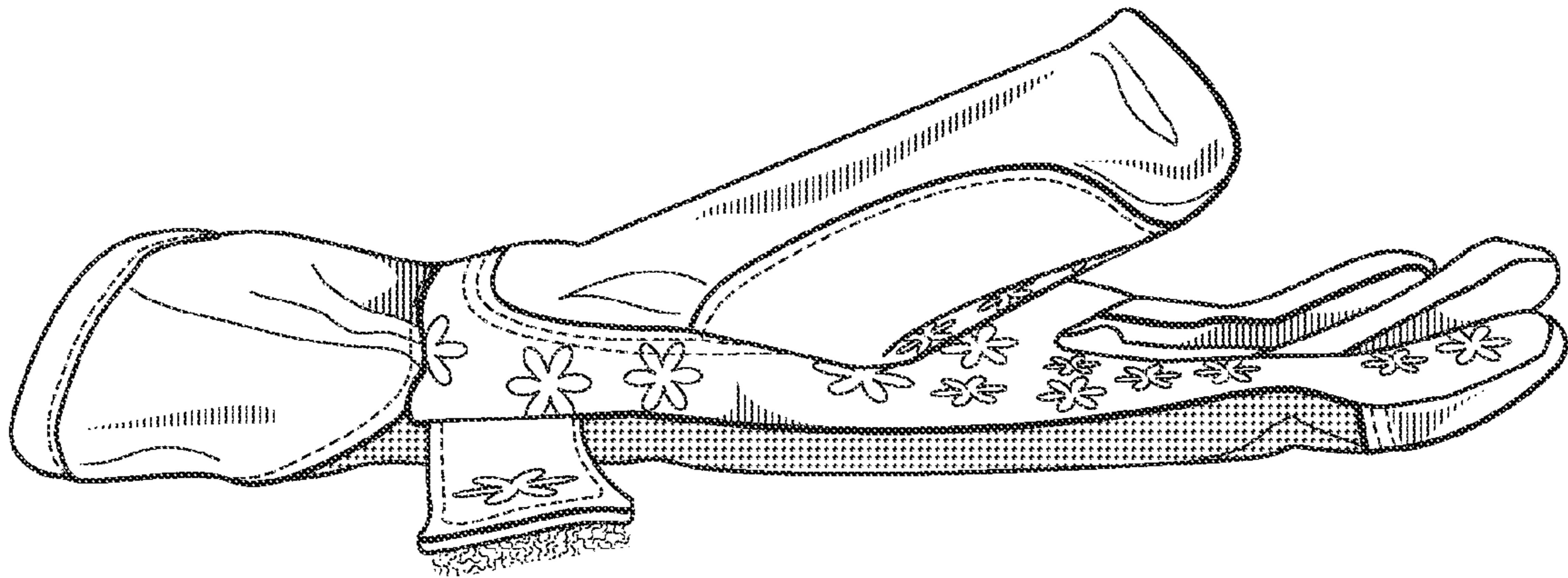

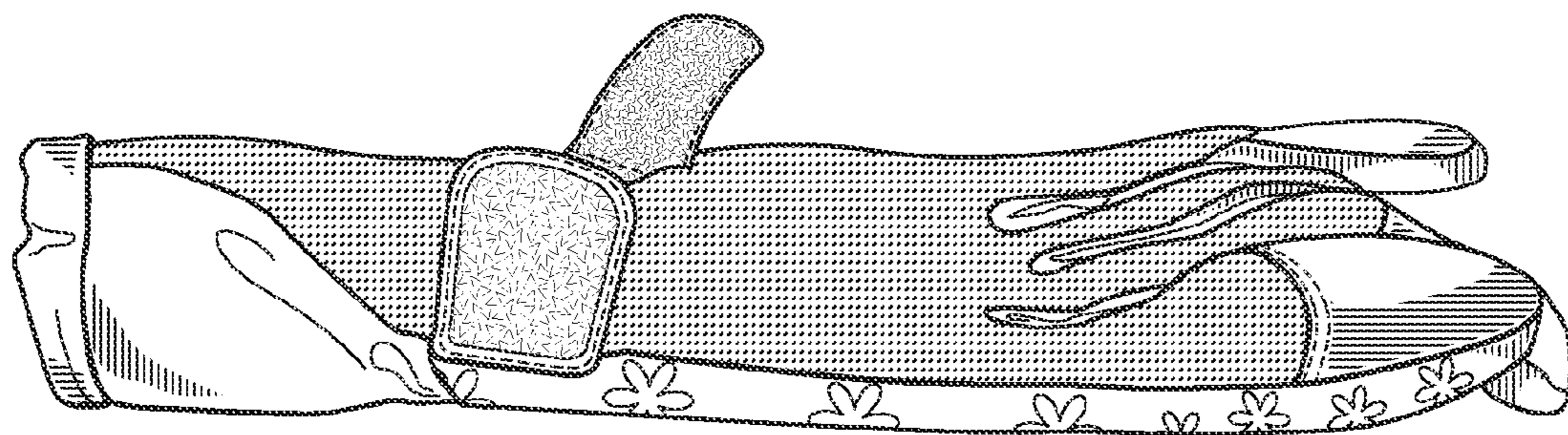

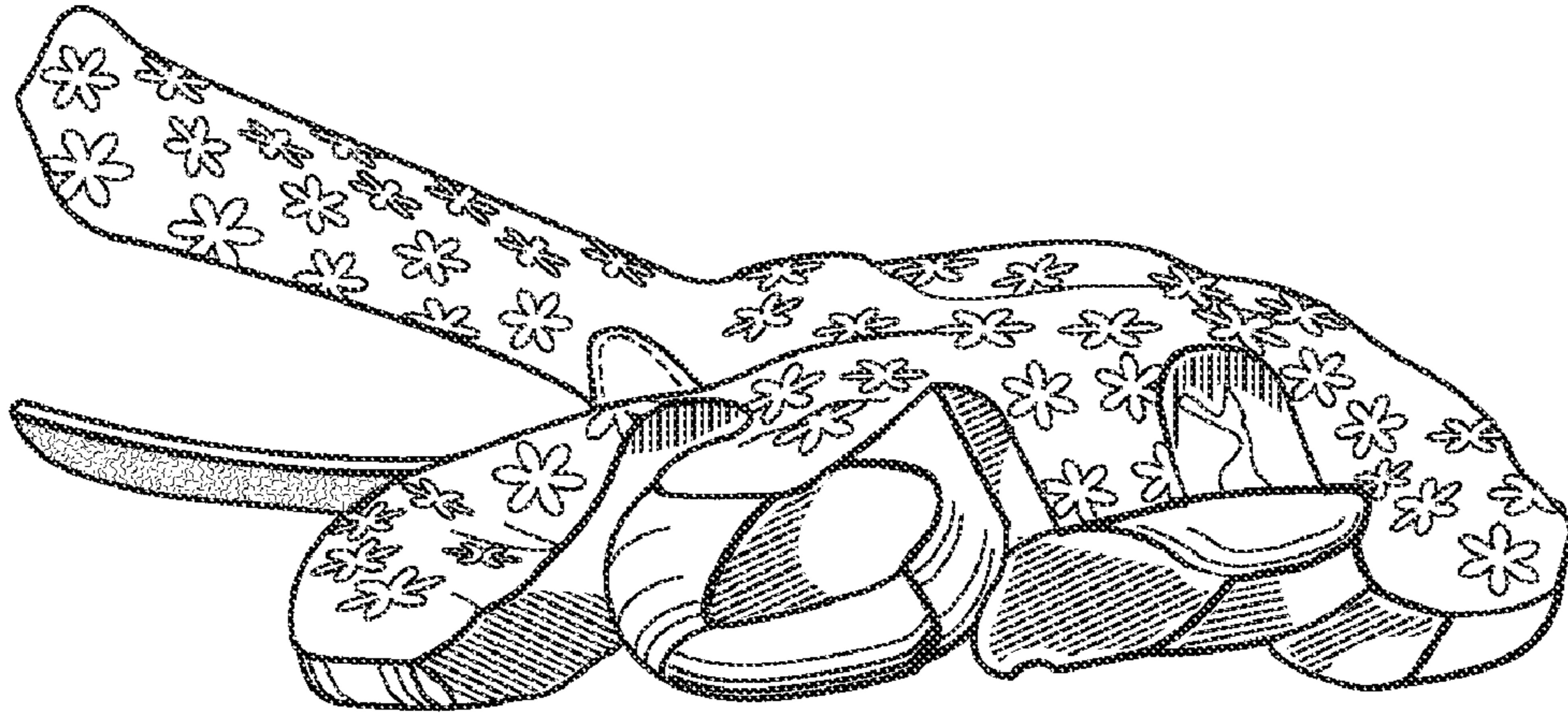

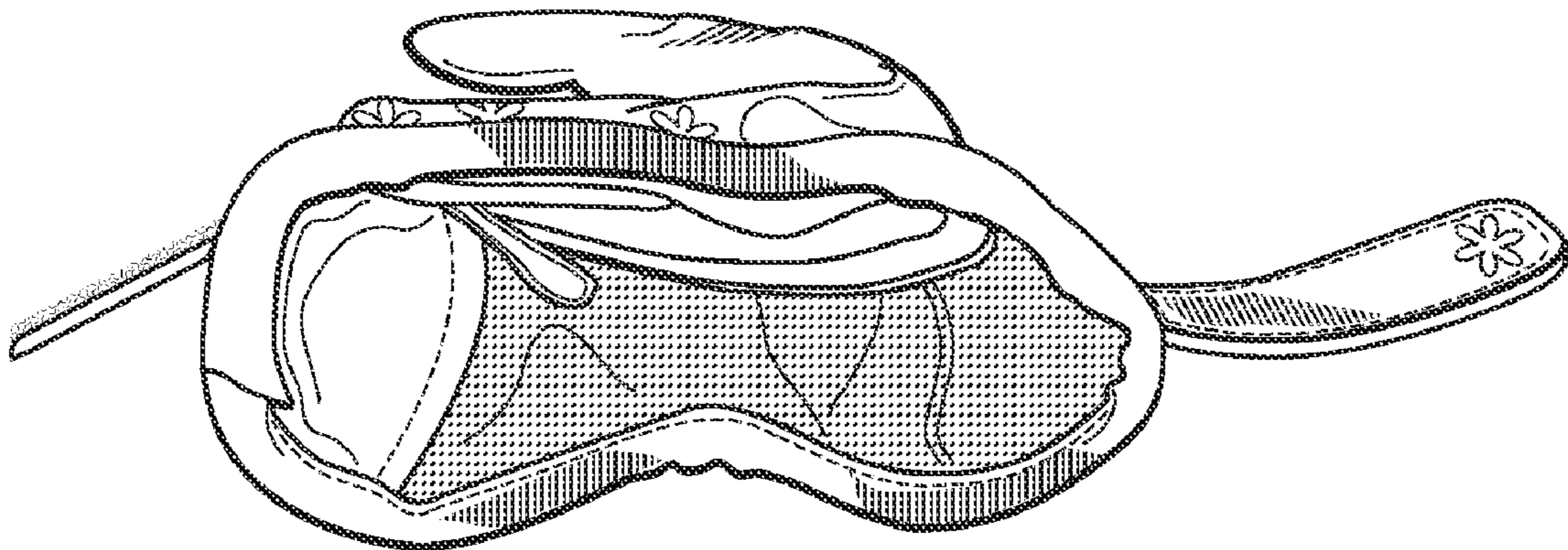

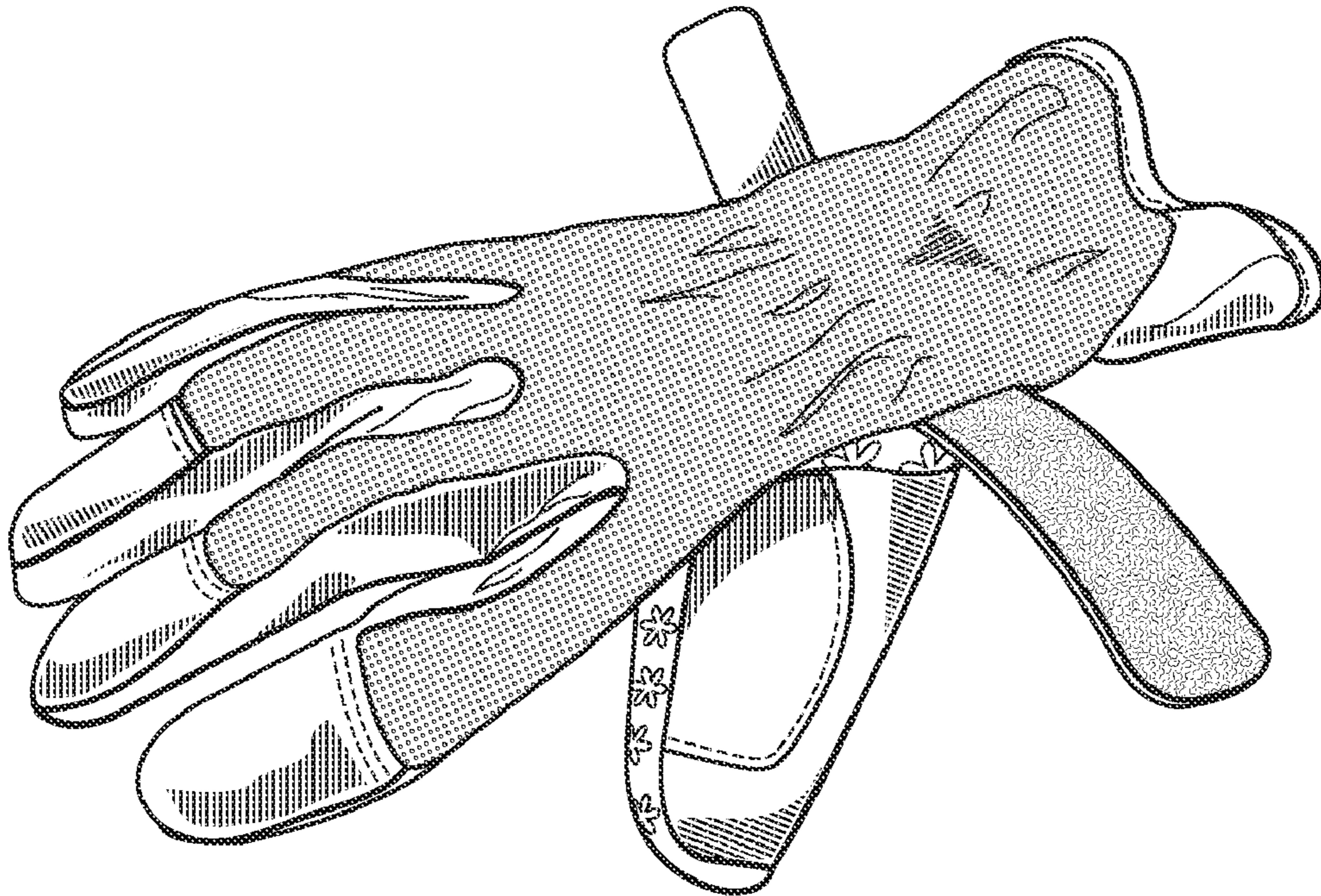

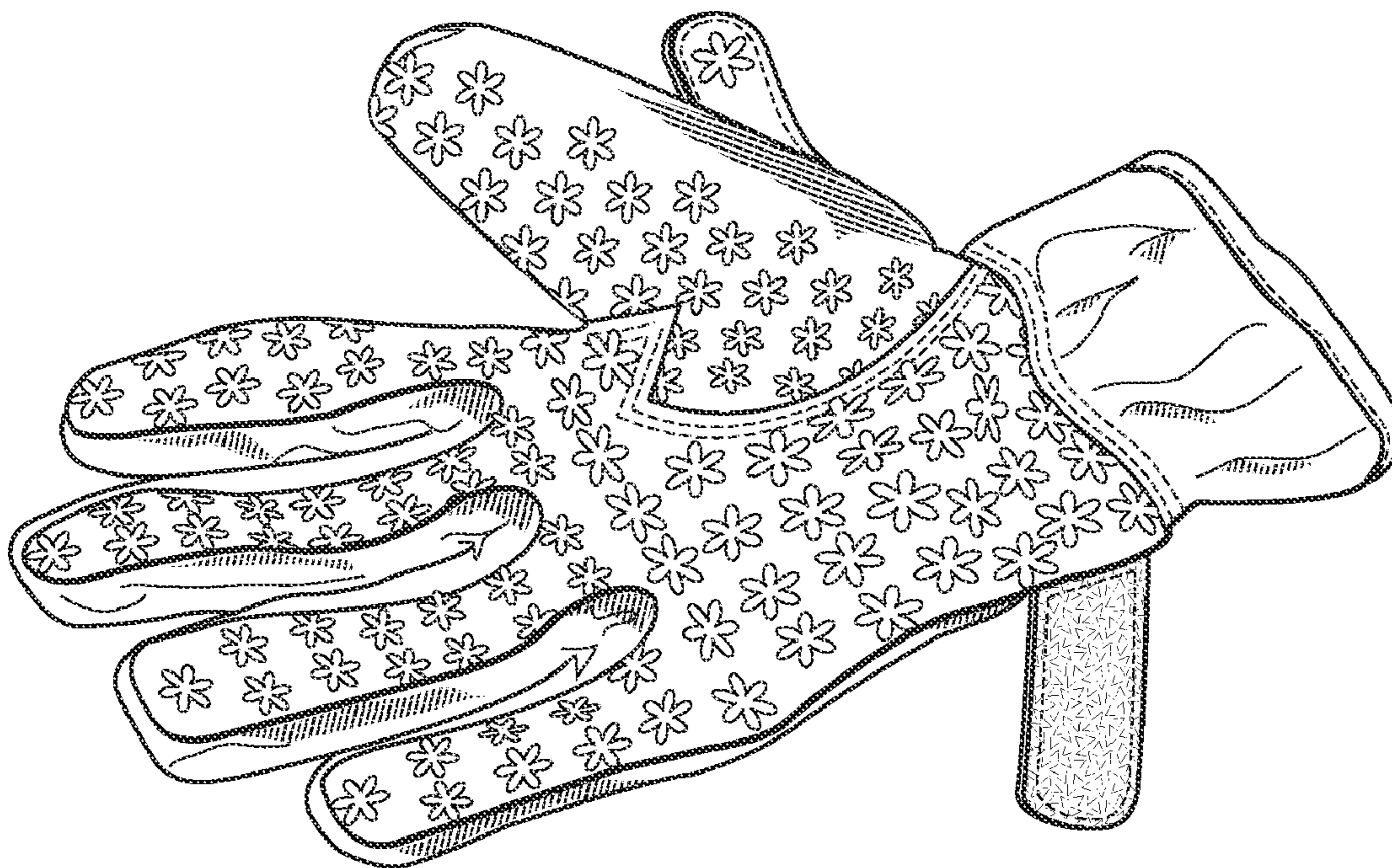
