FIG. 19 is a front view of FIG. 18;

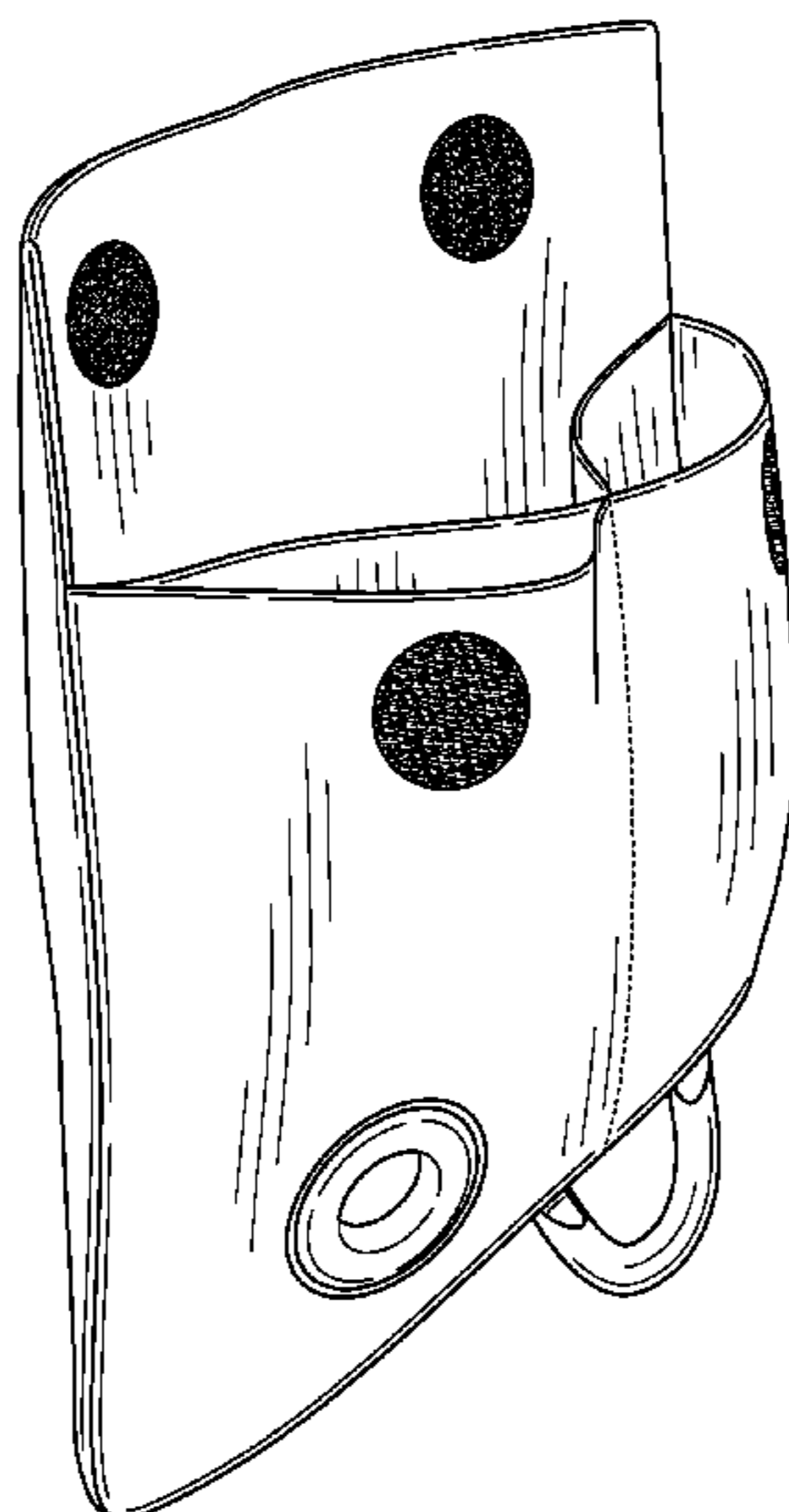
FIG. 20 is a rear view of FIG. 18;

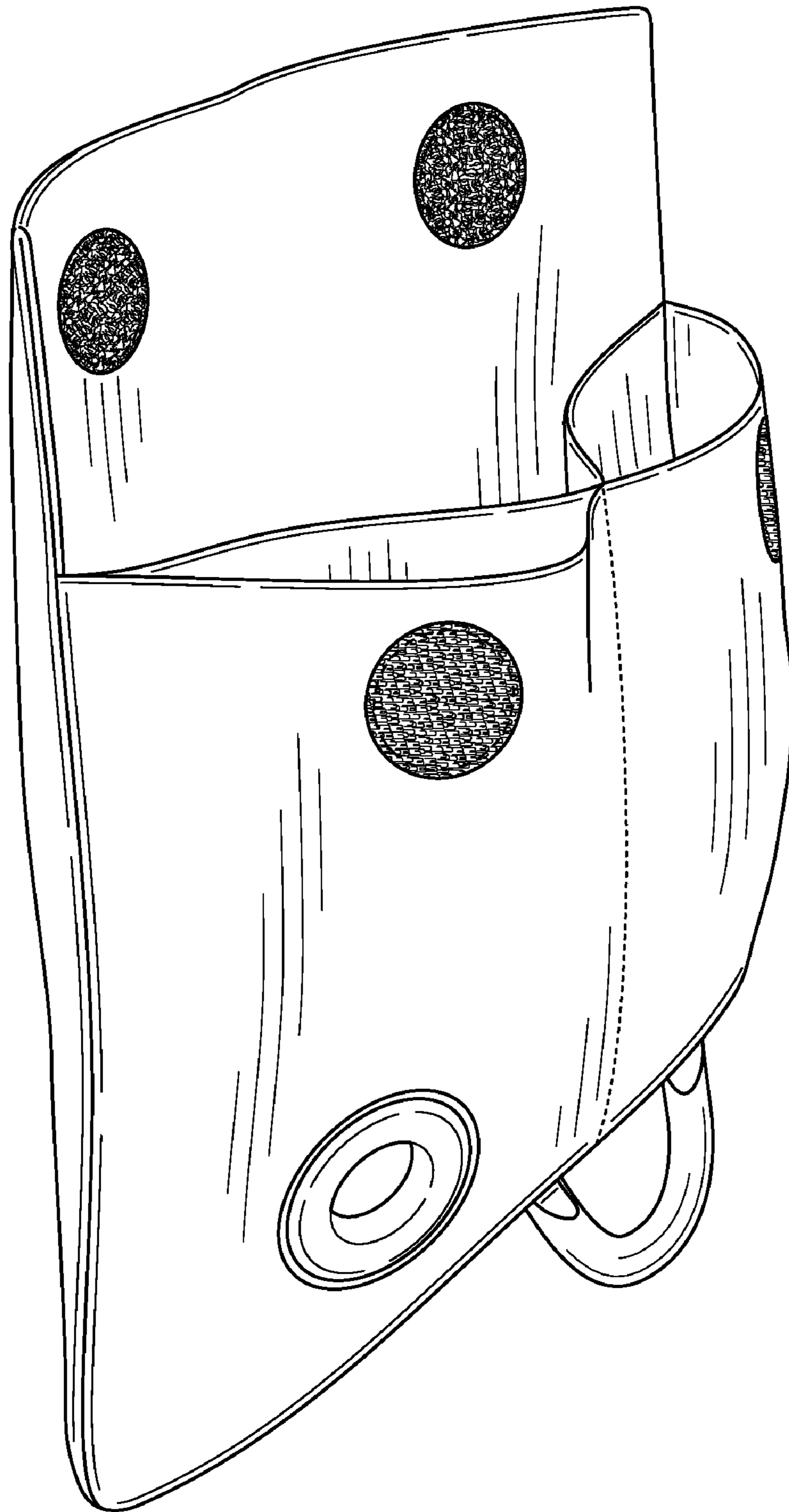

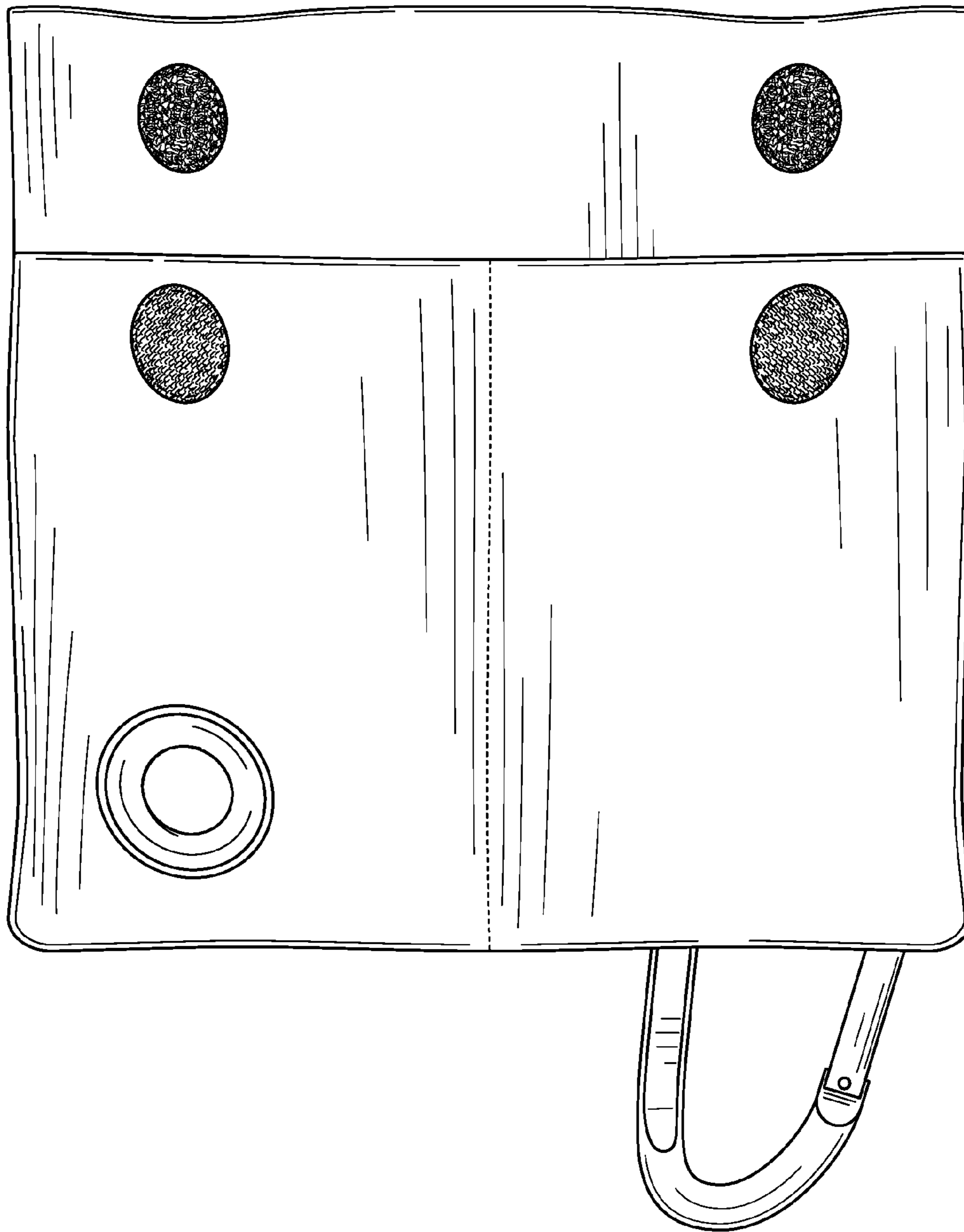

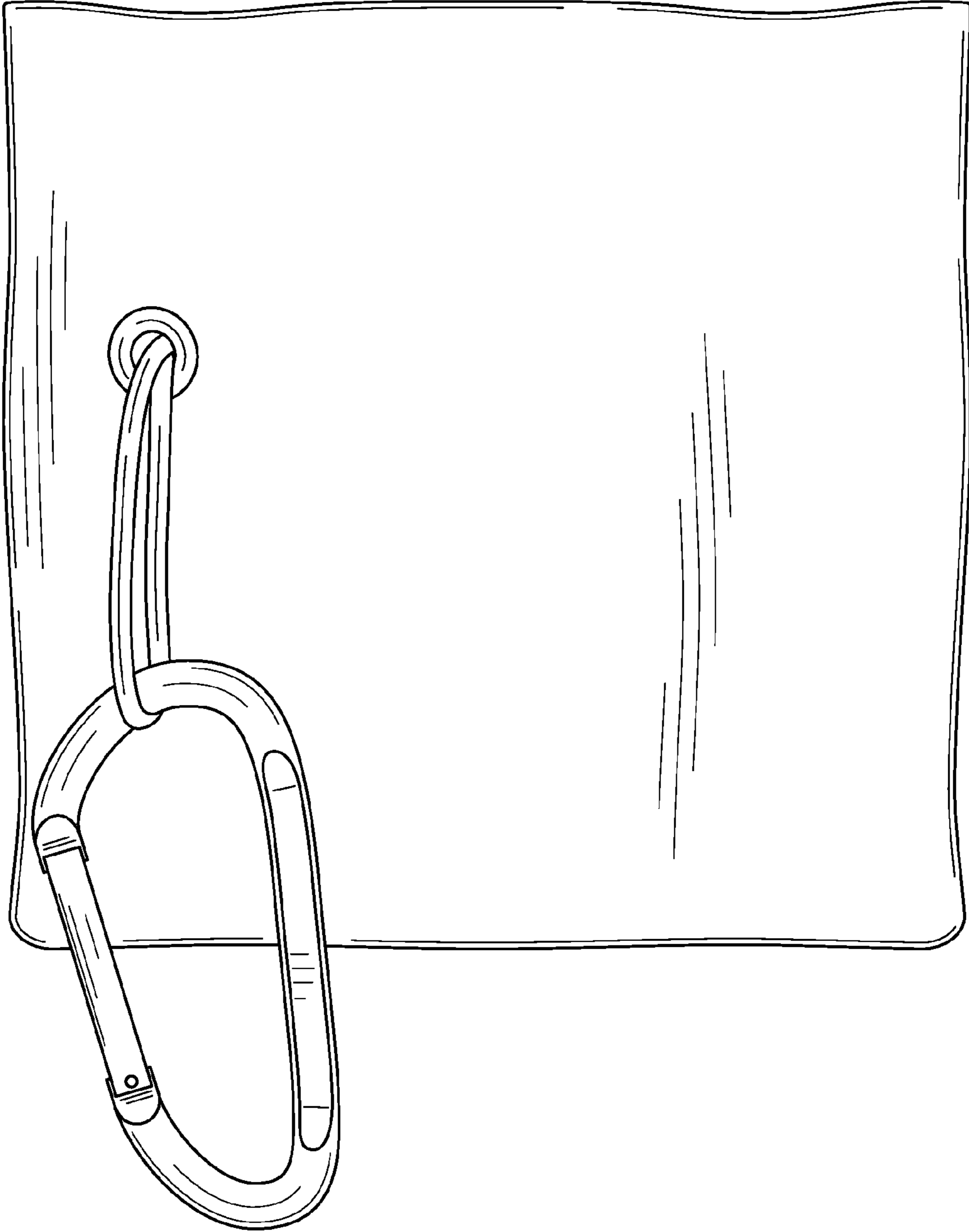

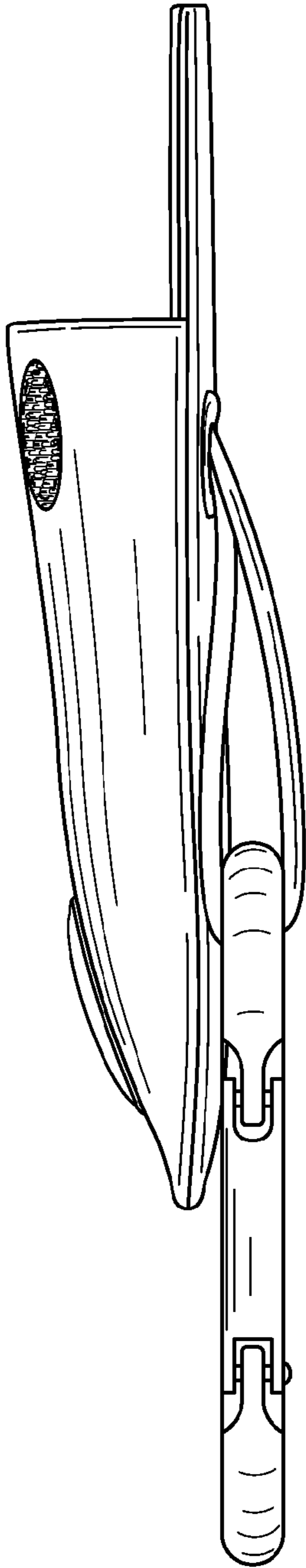

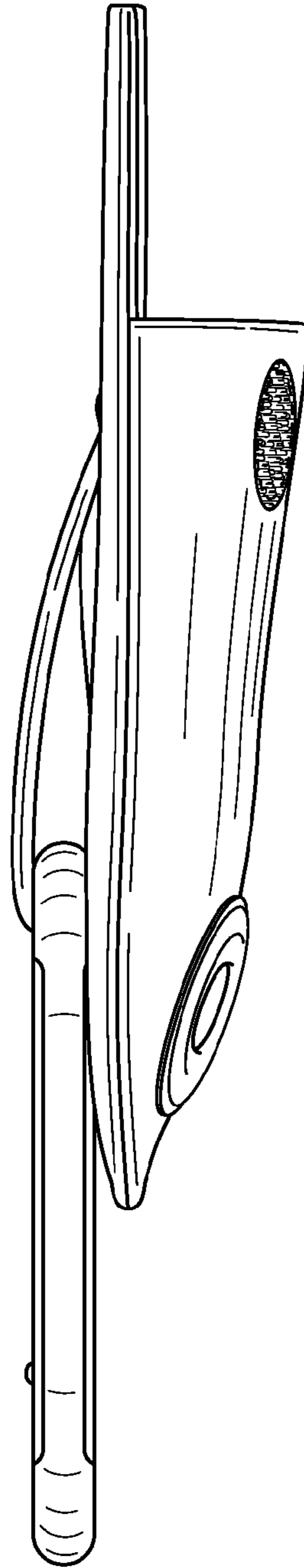

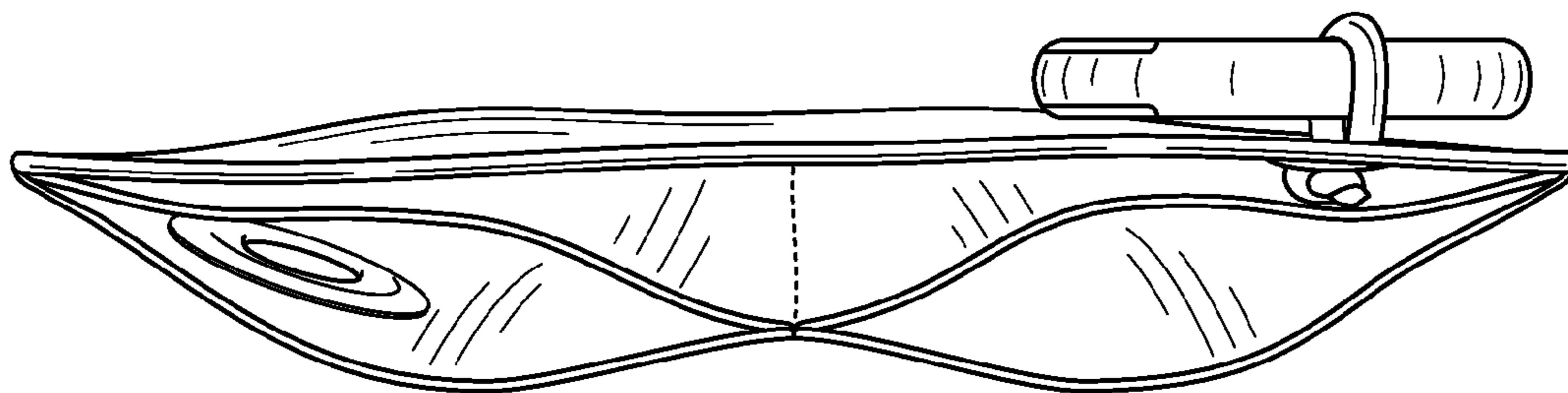

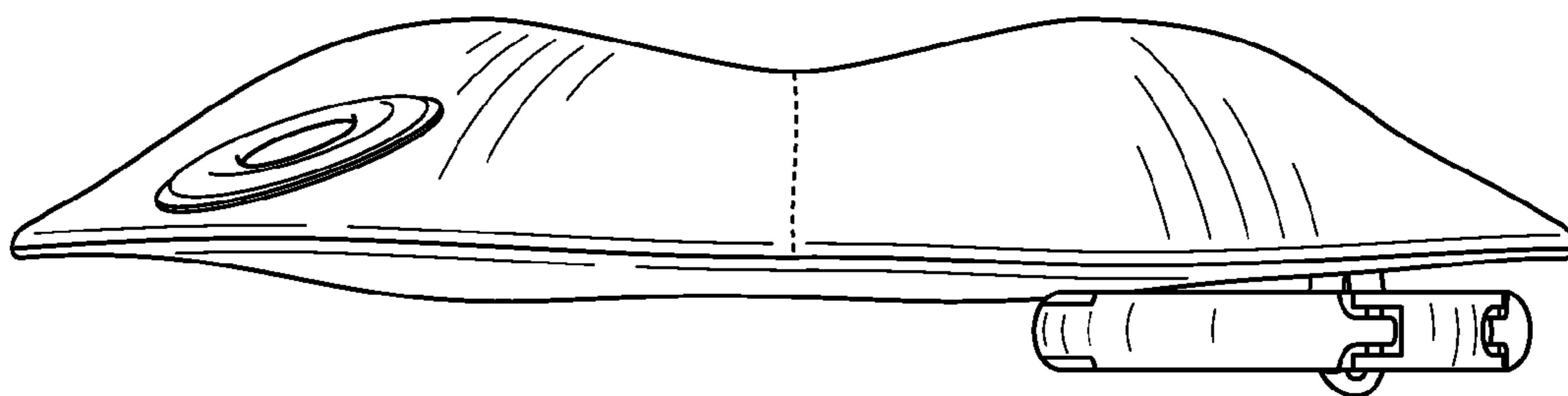

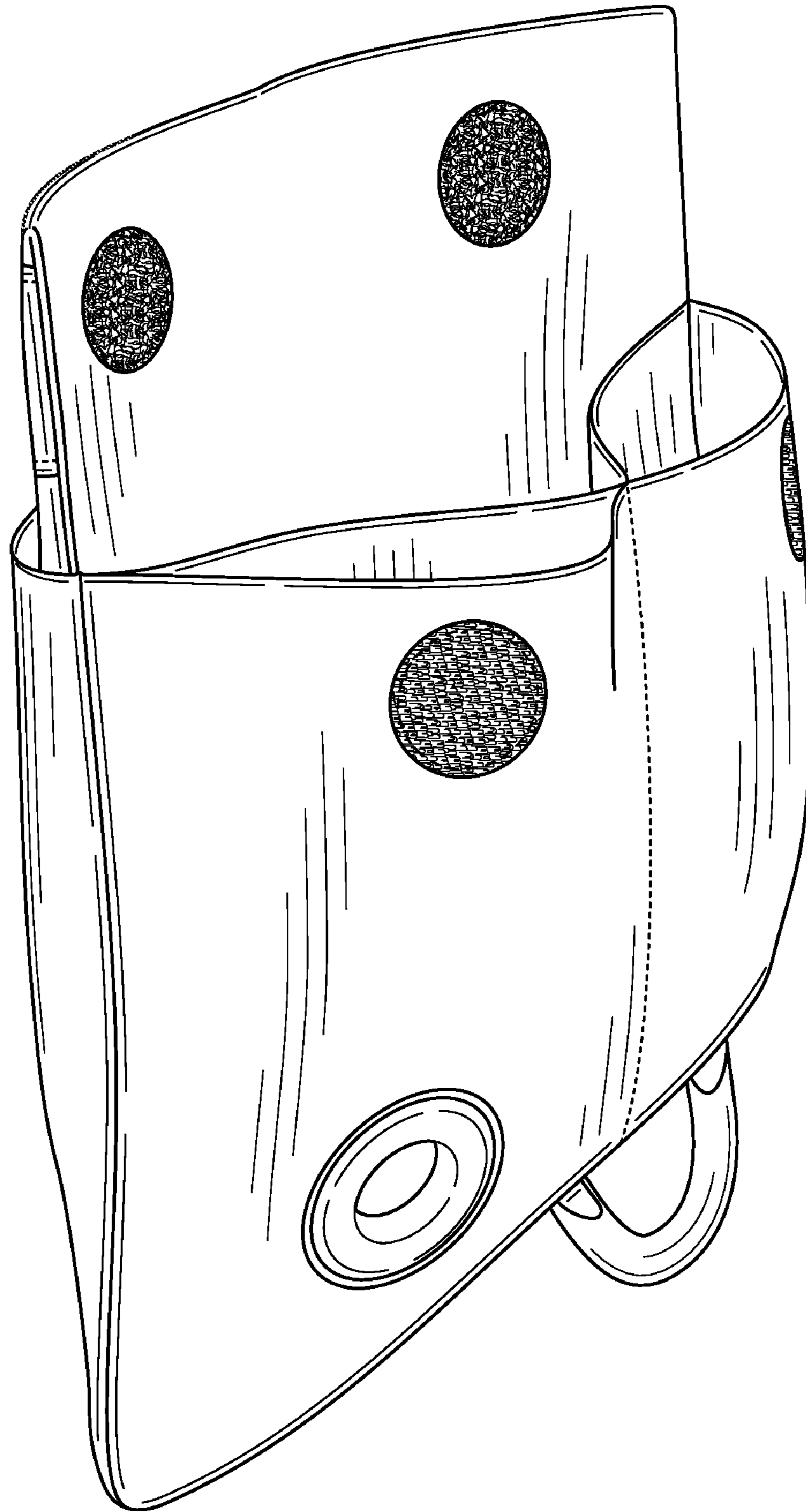

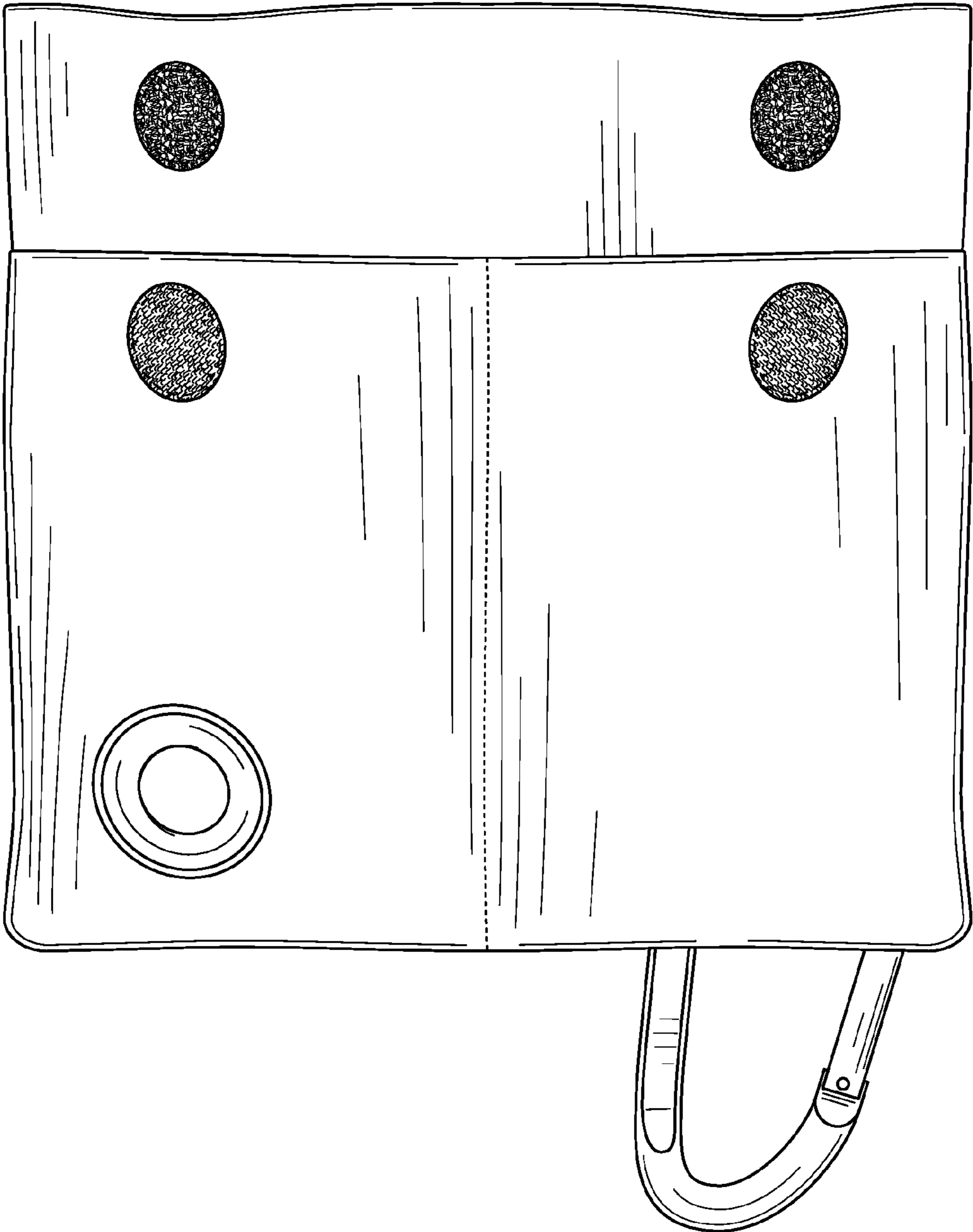

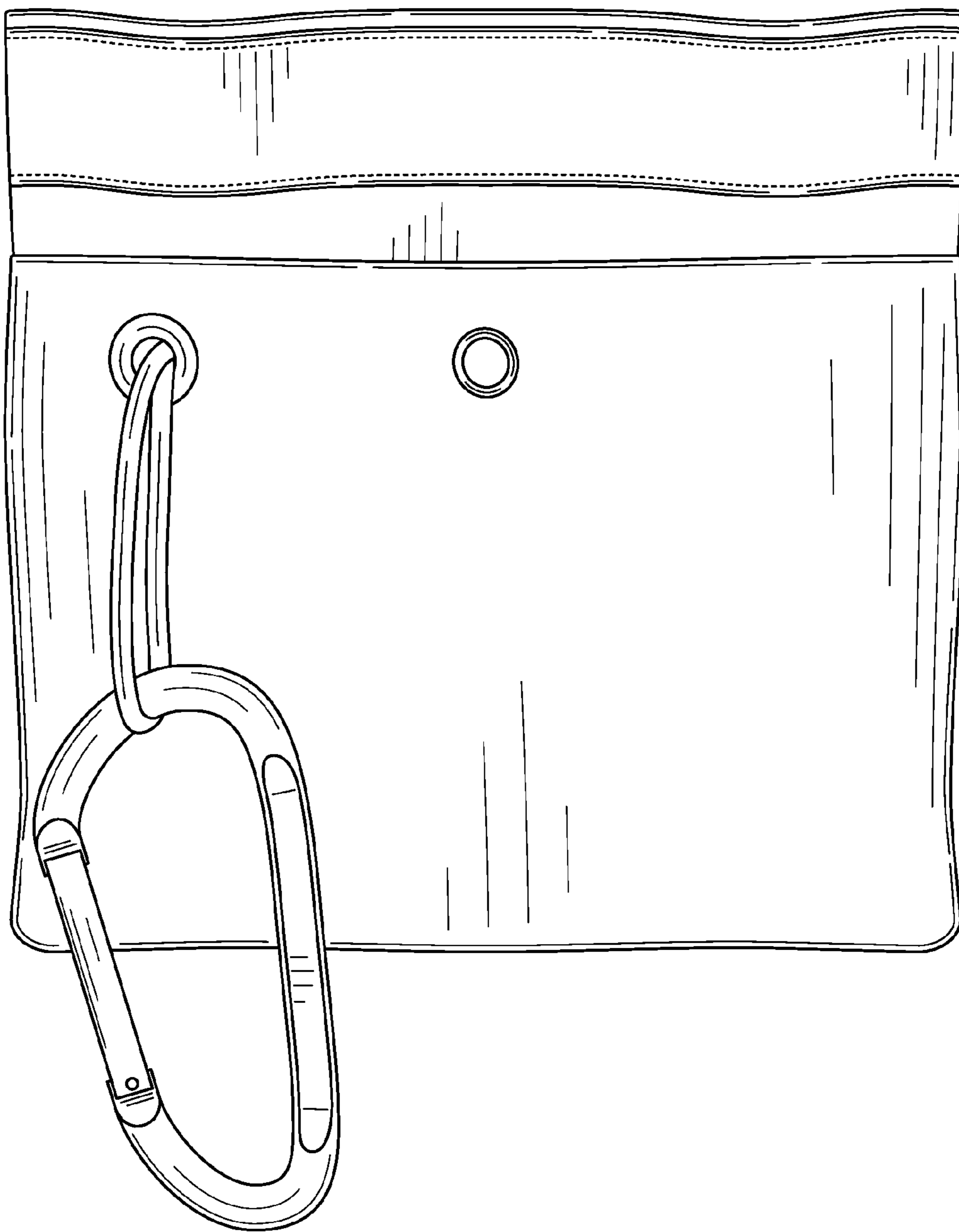

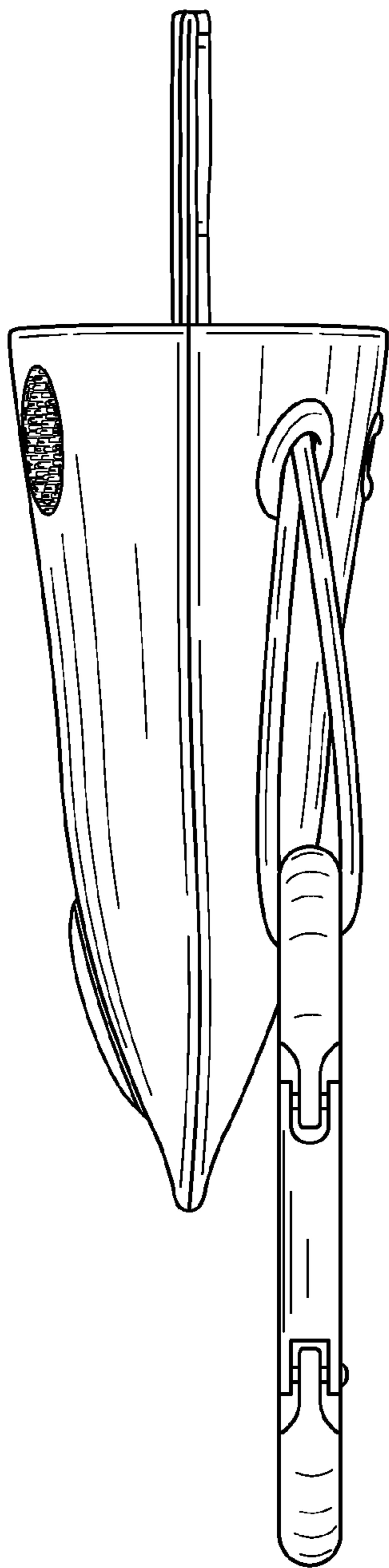

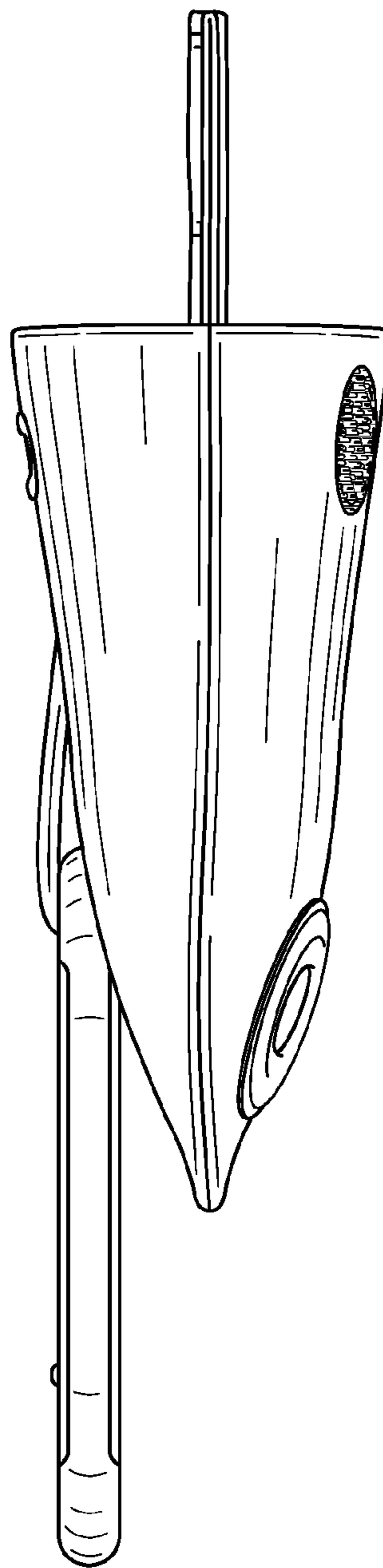

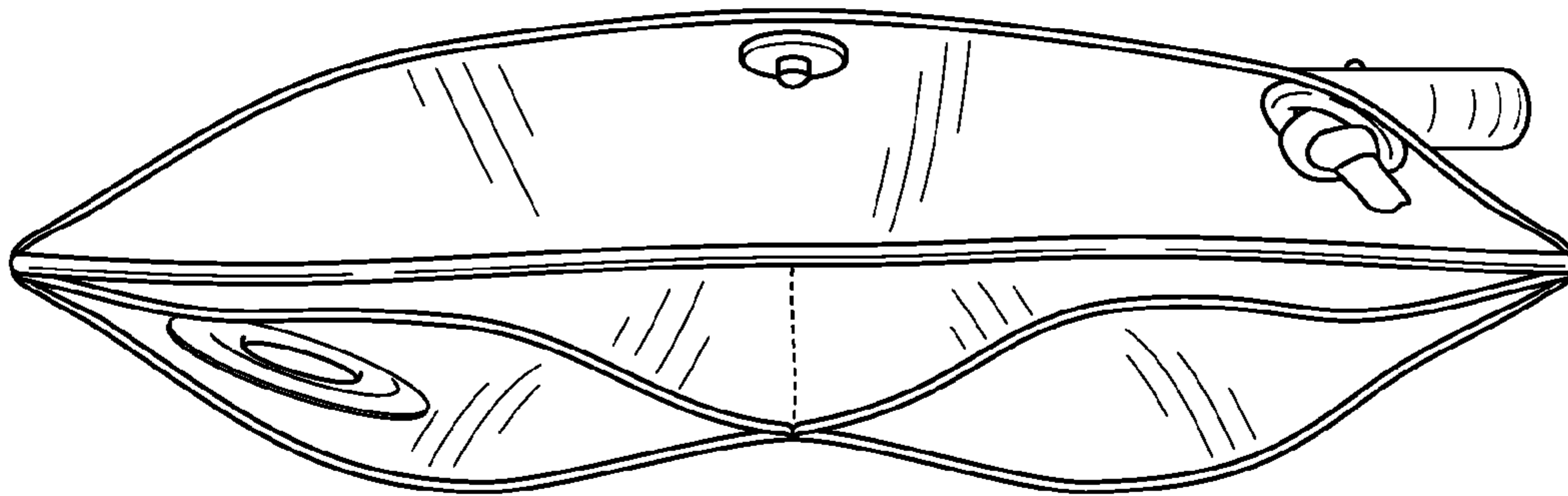

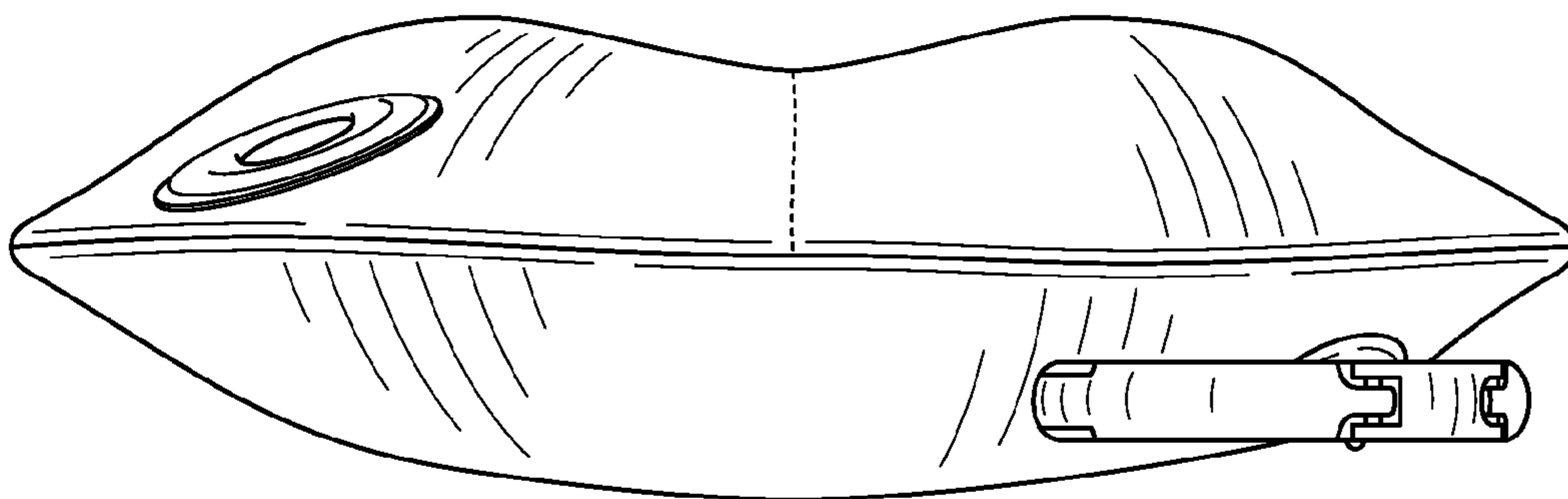

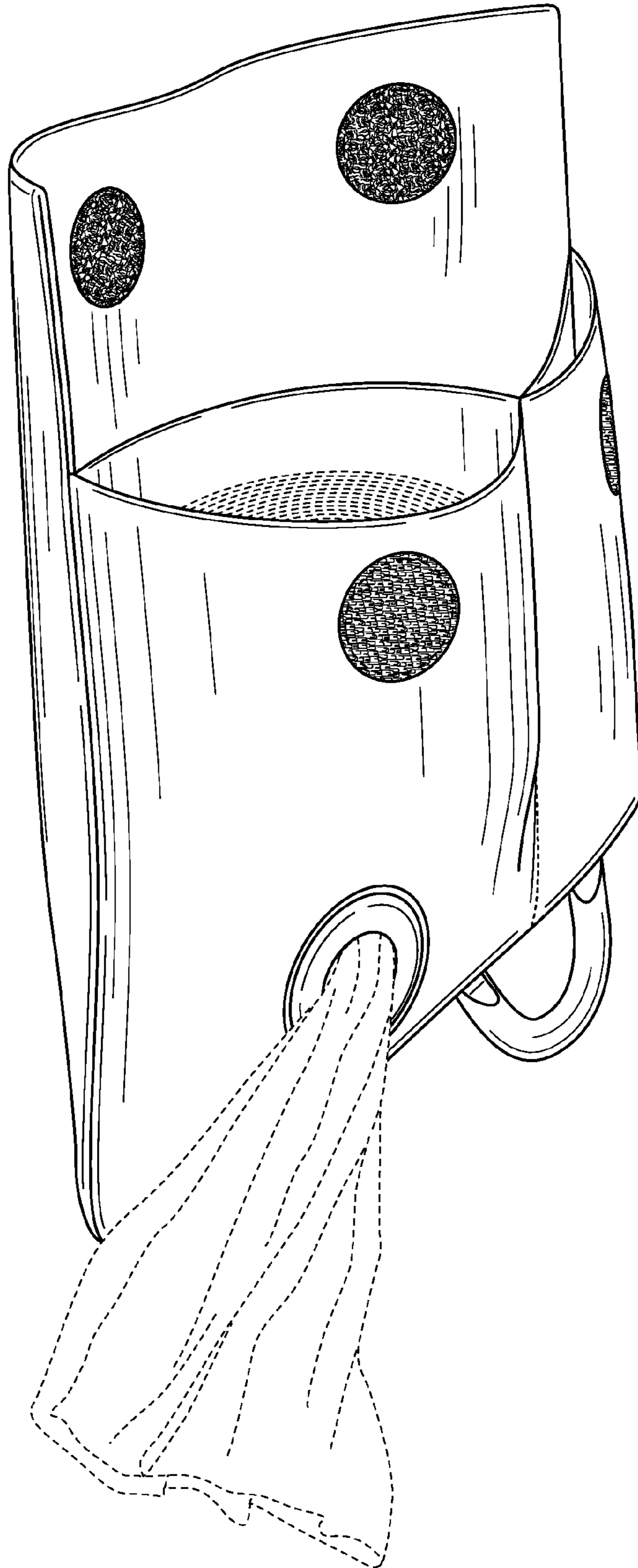

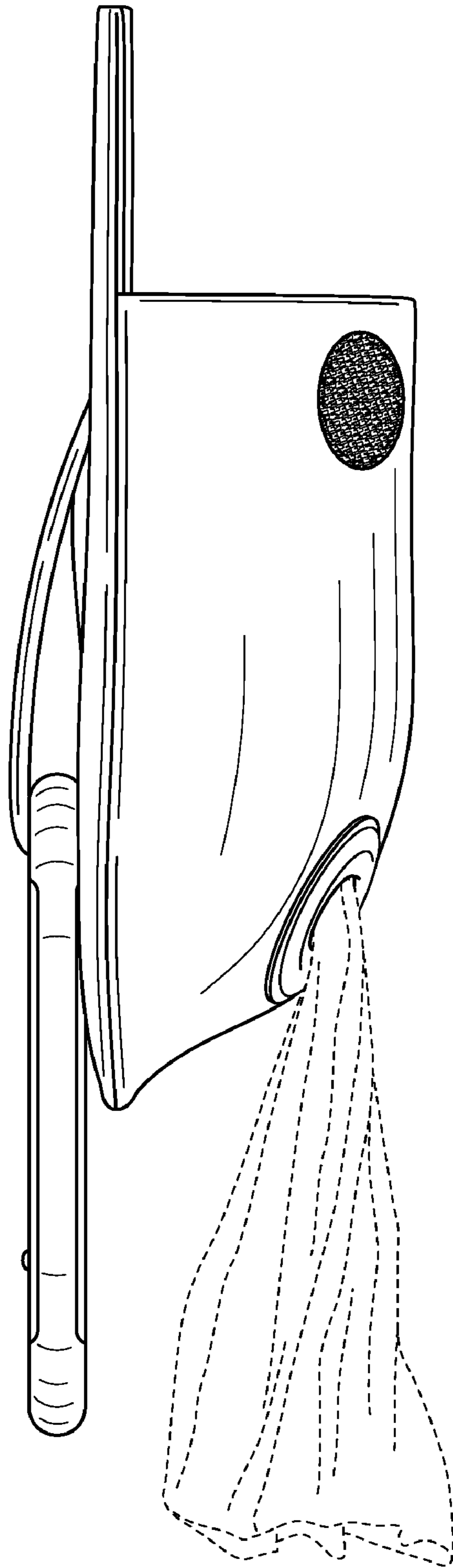

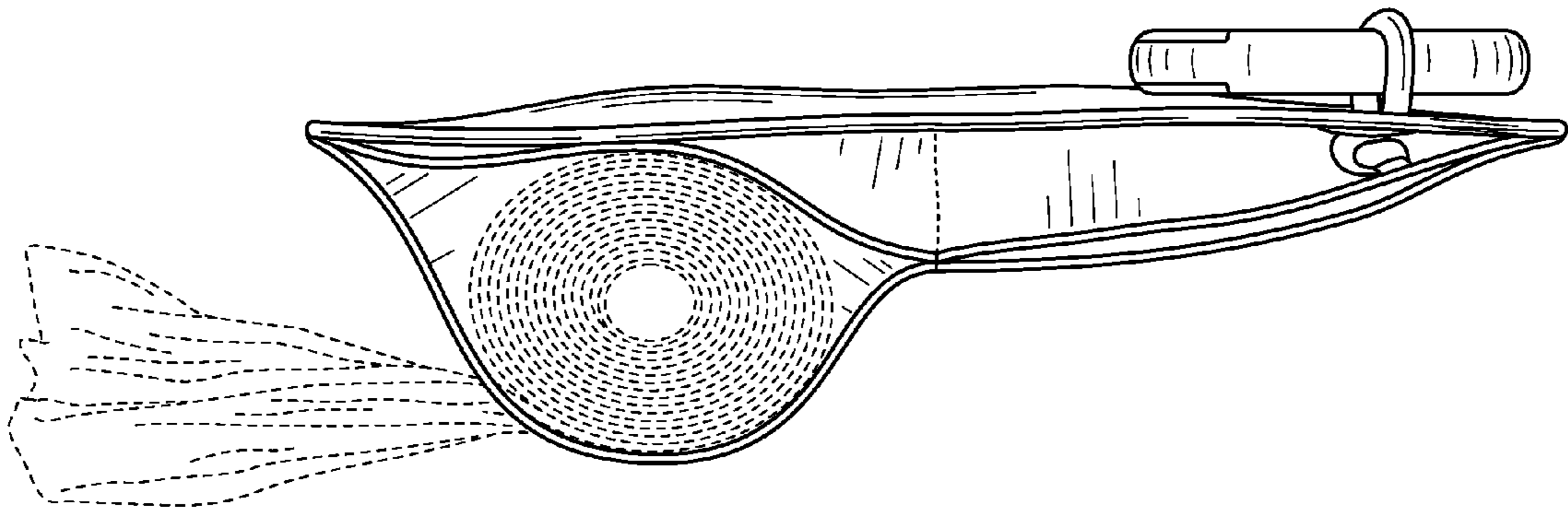

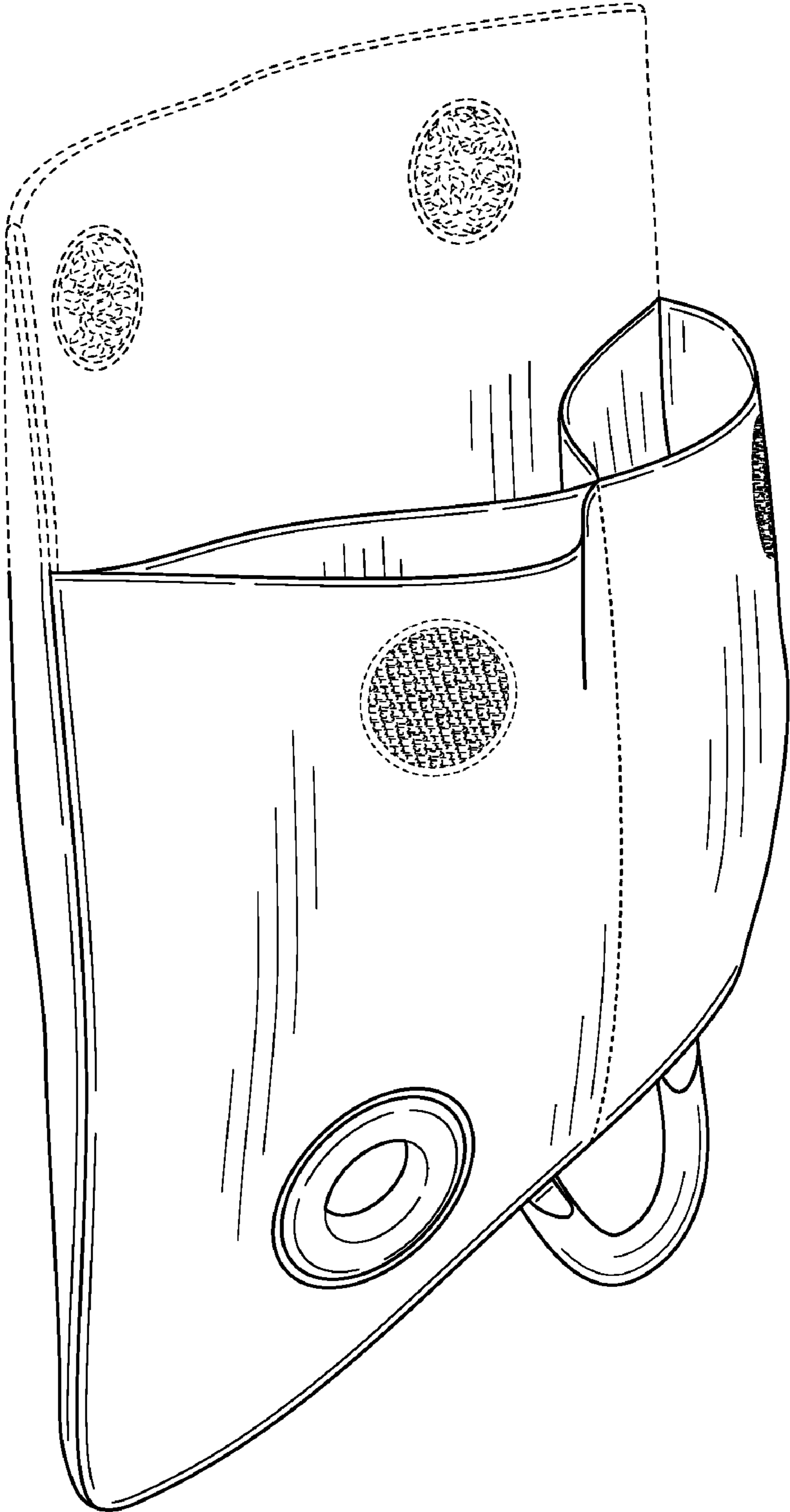

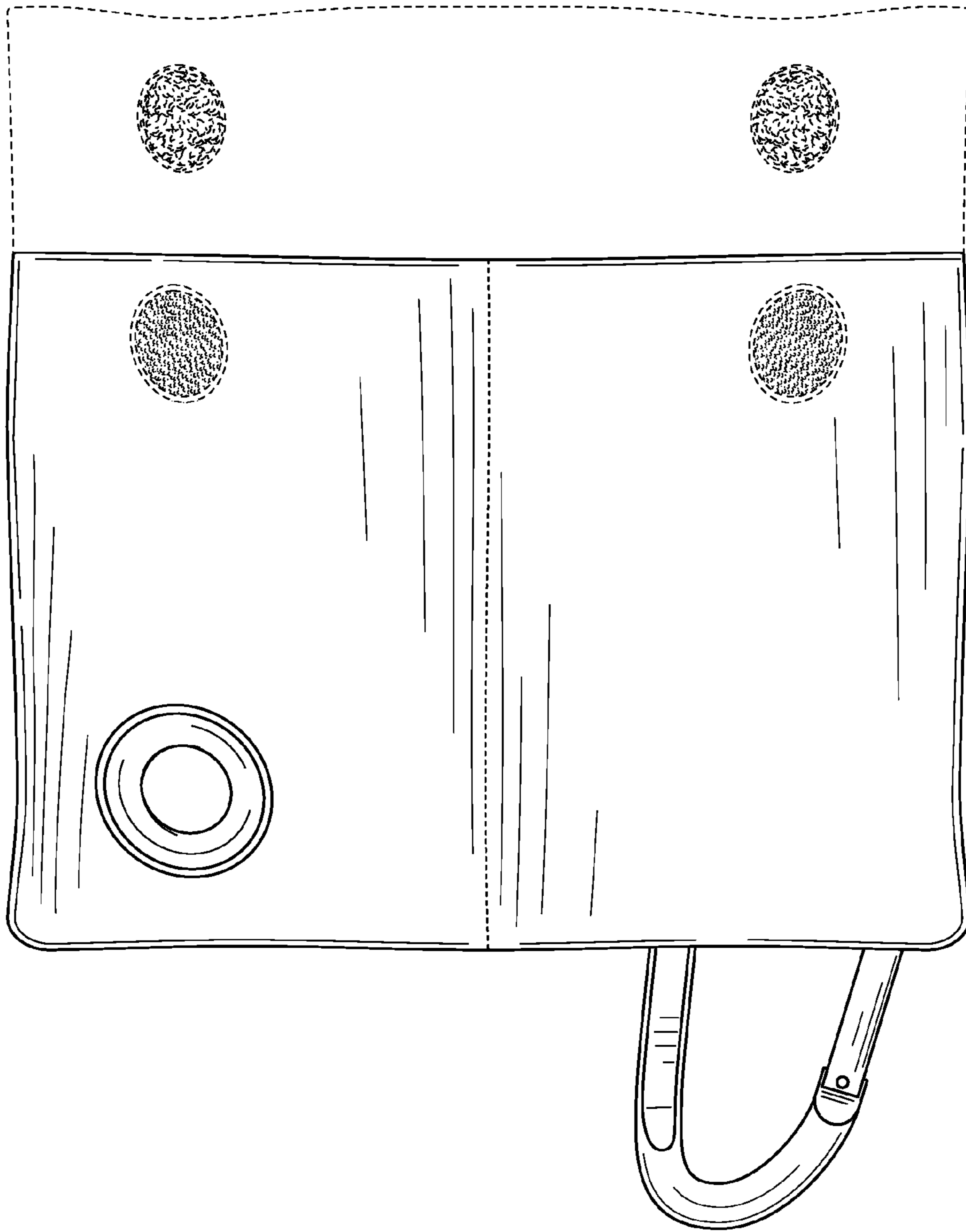

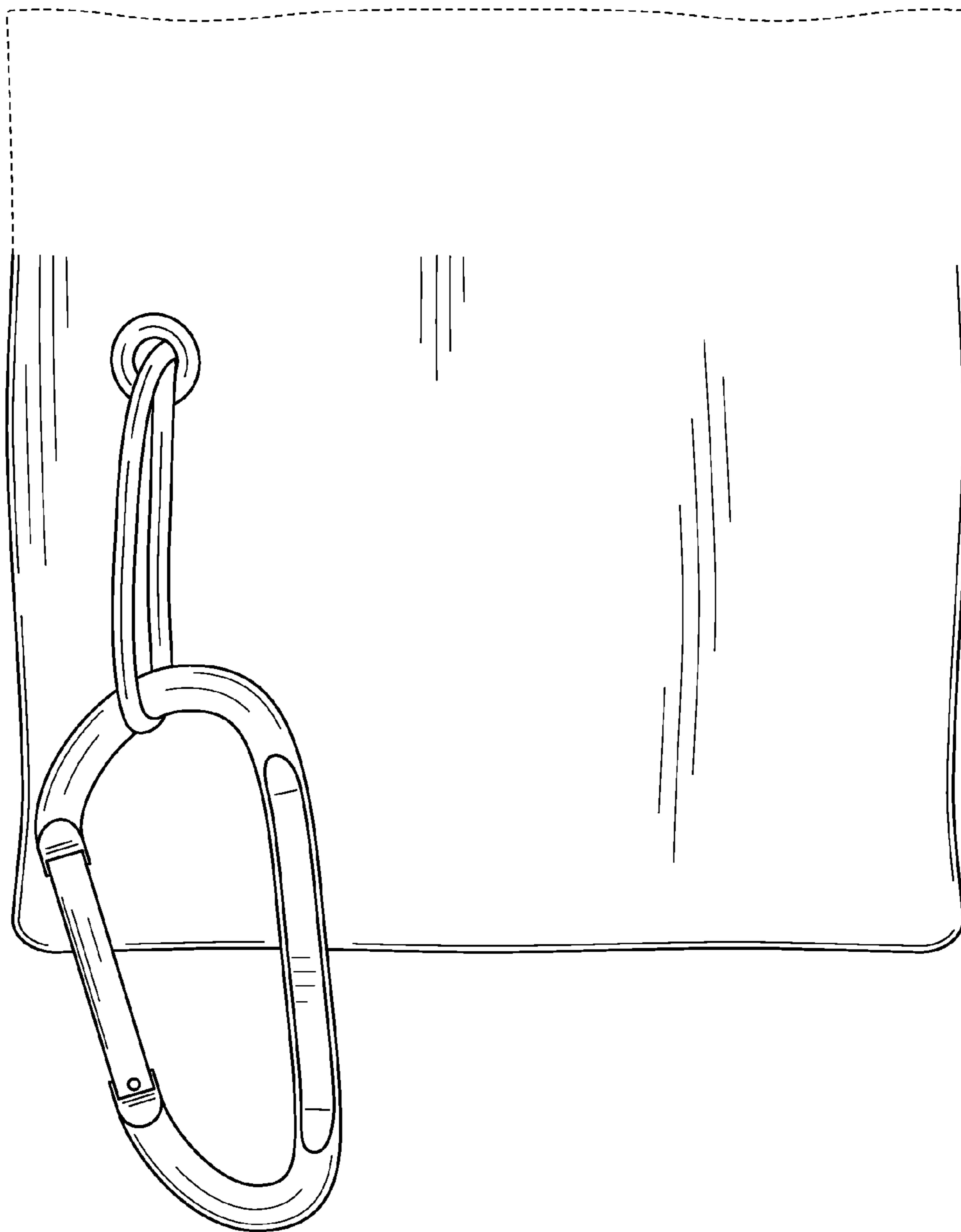

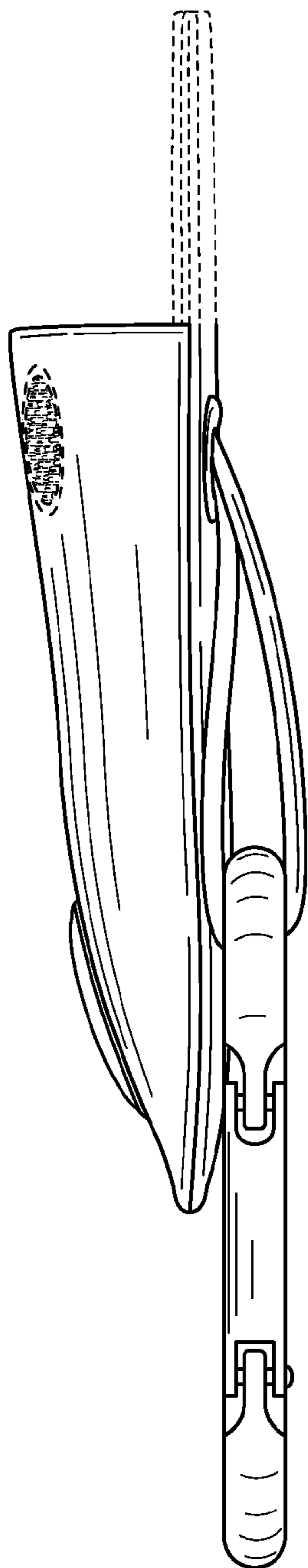

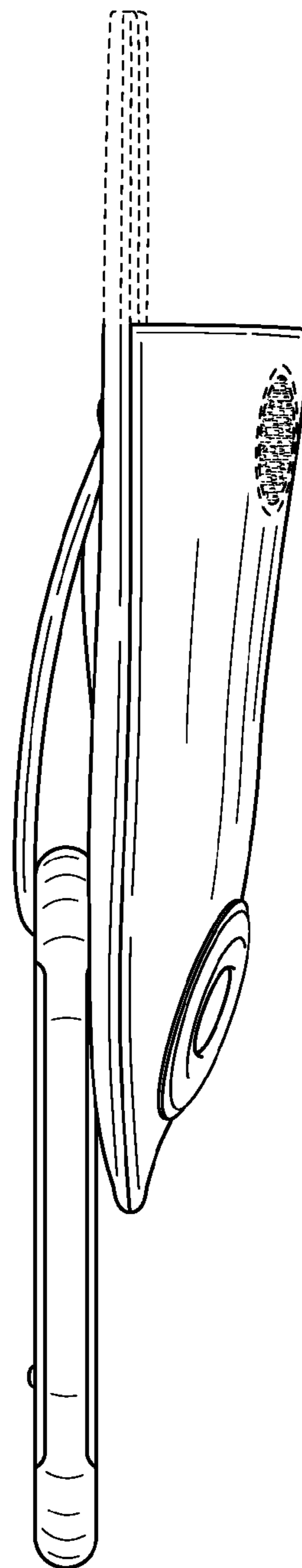
