(57) **CLAIM**

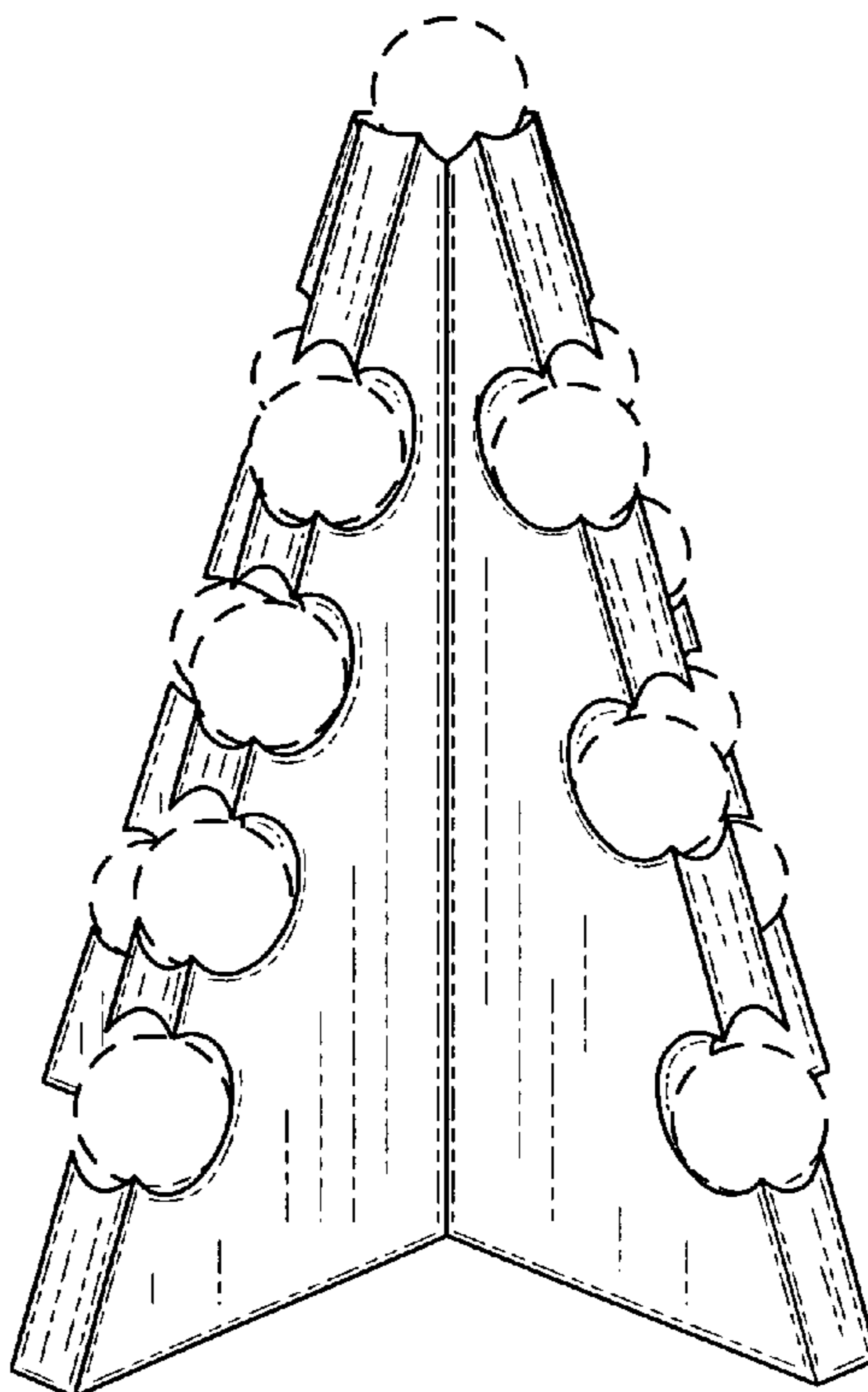
The ornamental design for a confectionary stand, as shown and described.

**DESCRIPTION**

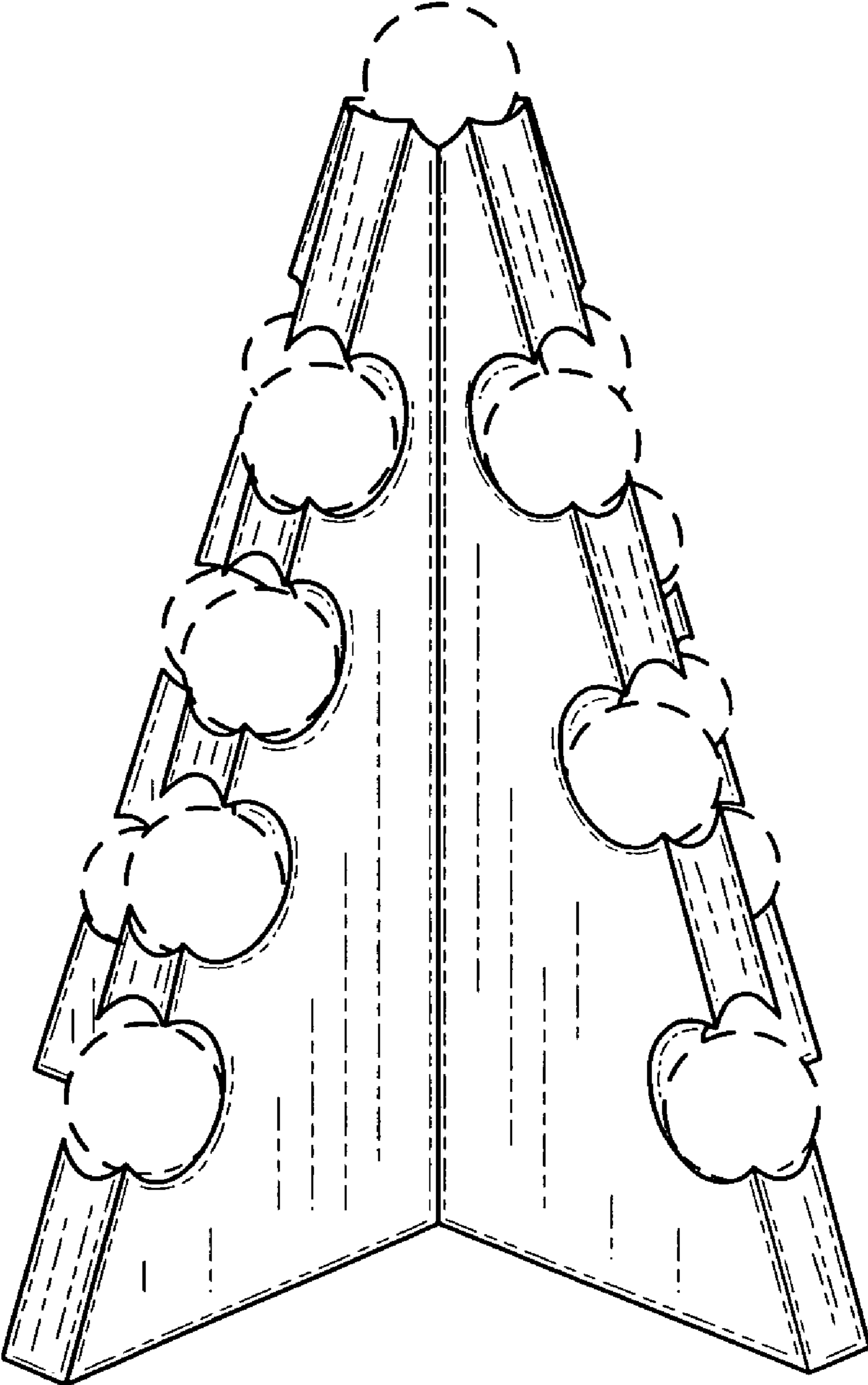

The broken lines shown in FIG. 1 are for illustrative purposes only and form no part of the claimed design.

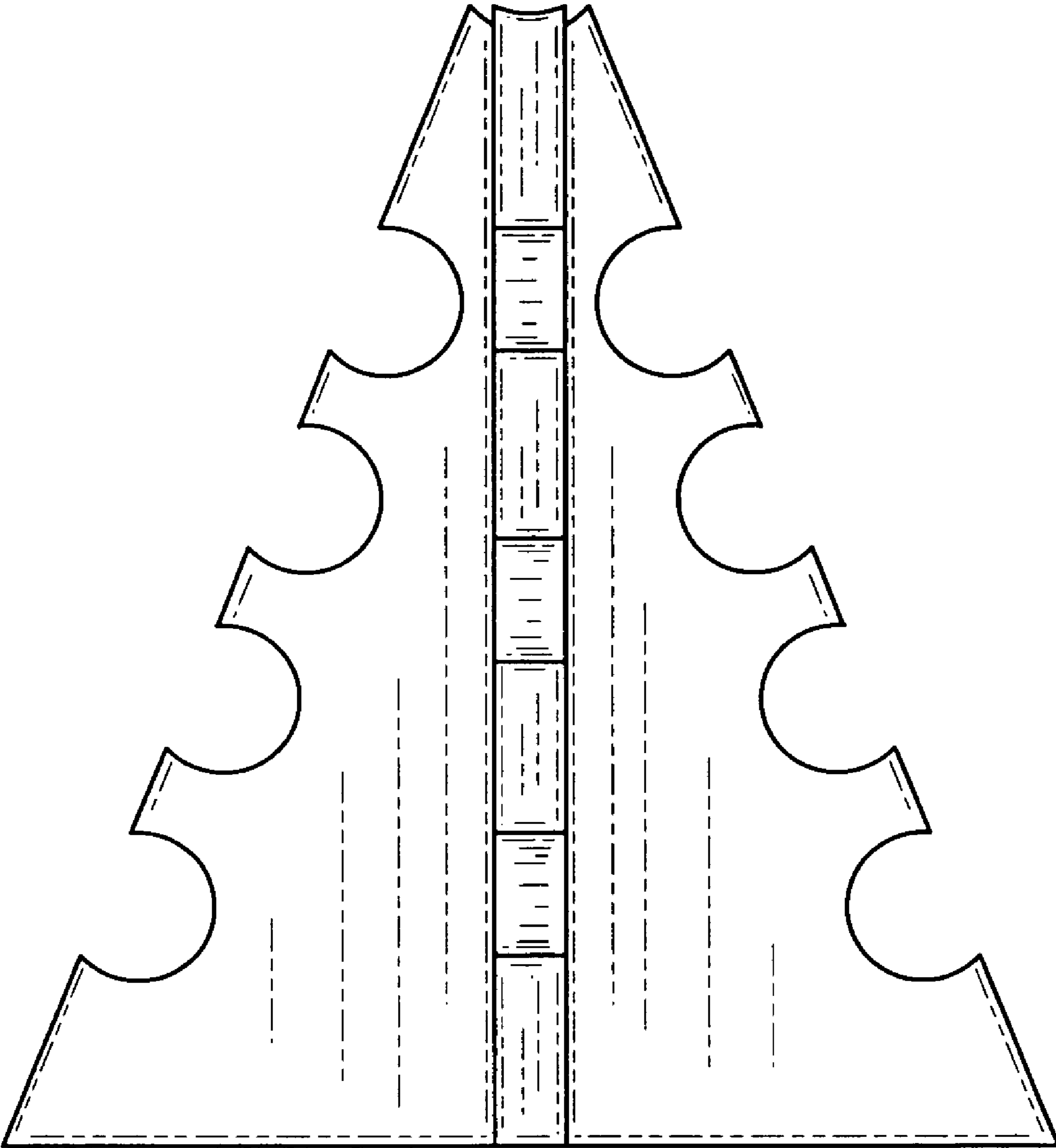

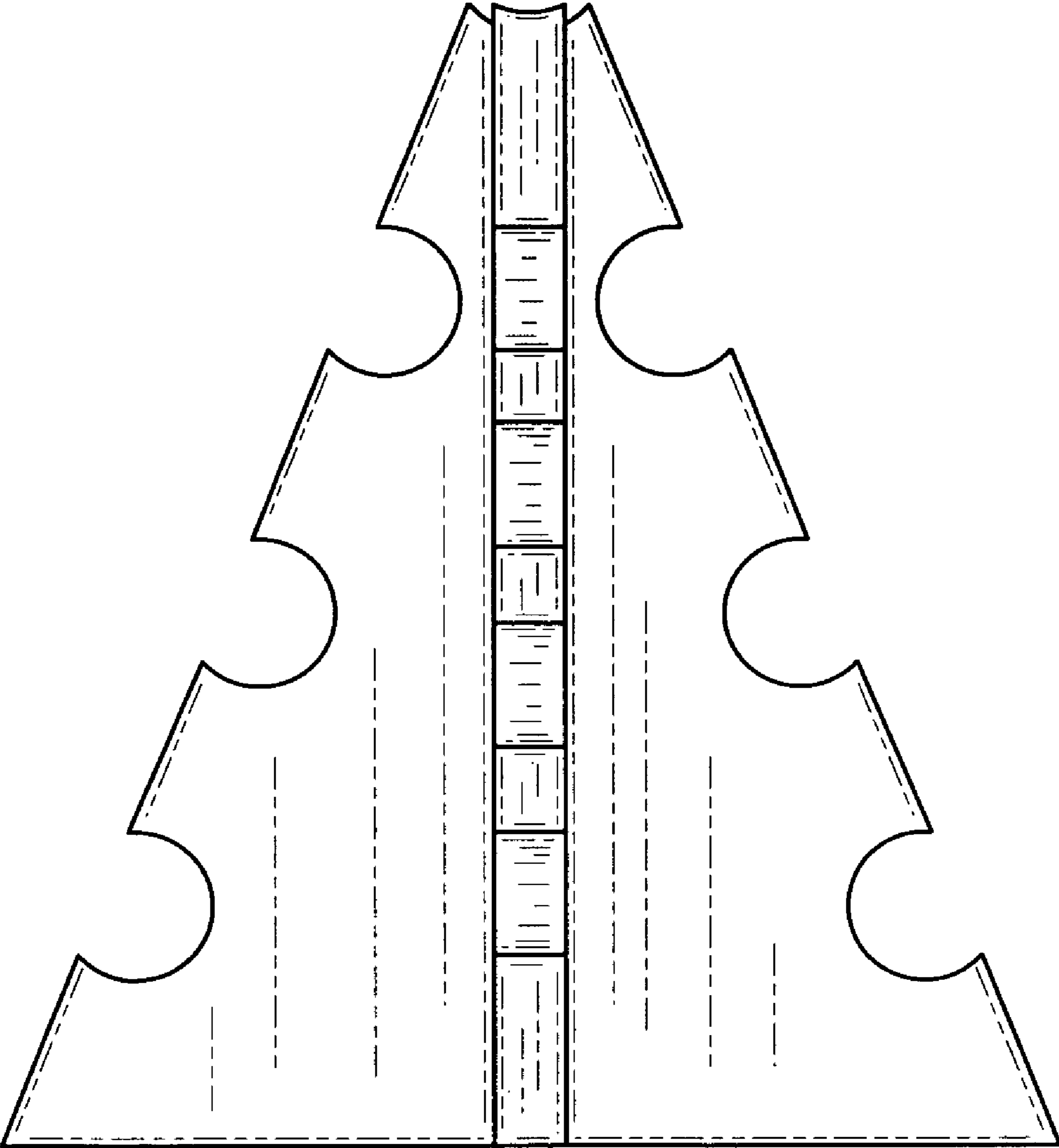

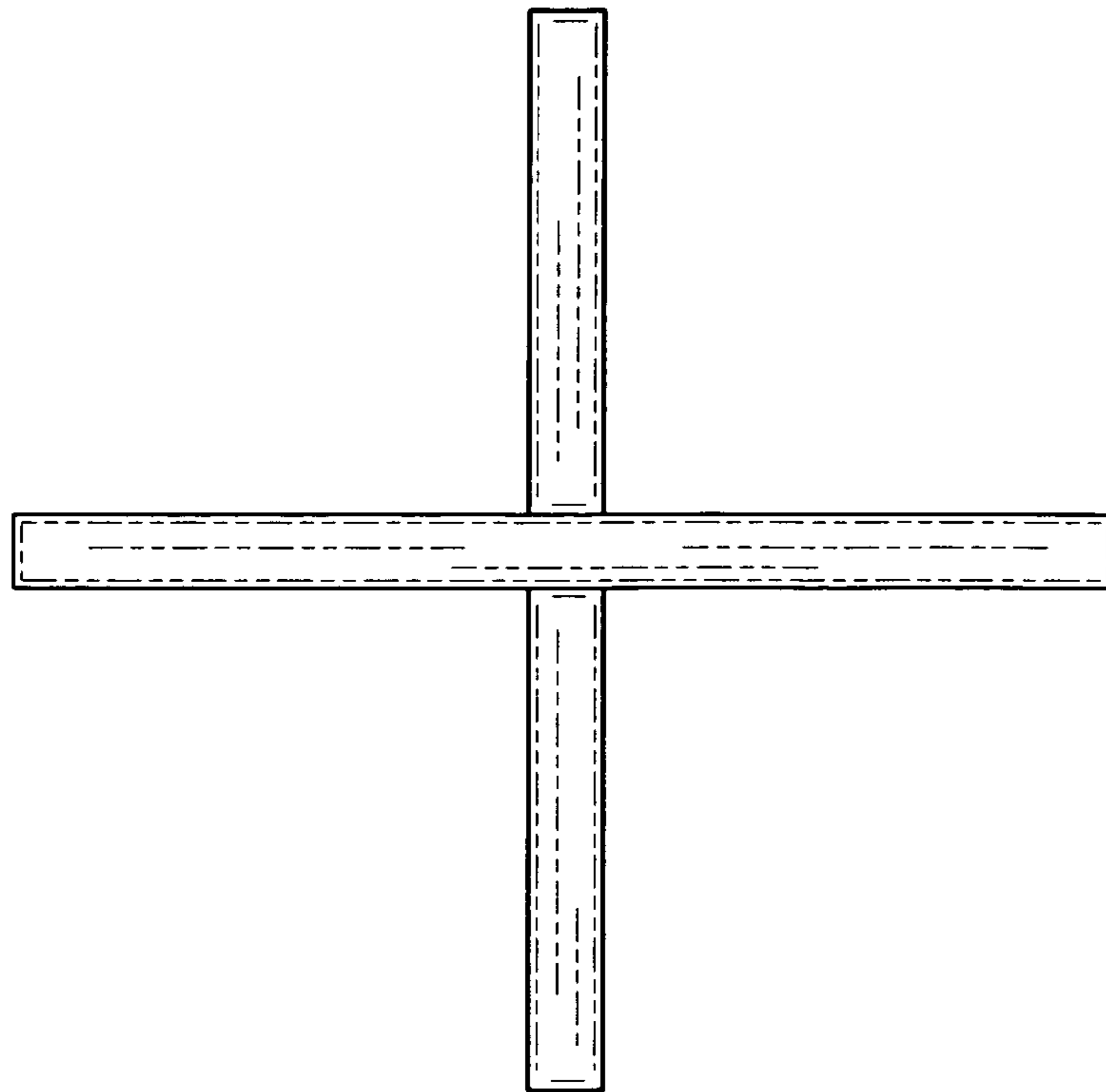
