**DESCRIPTION**

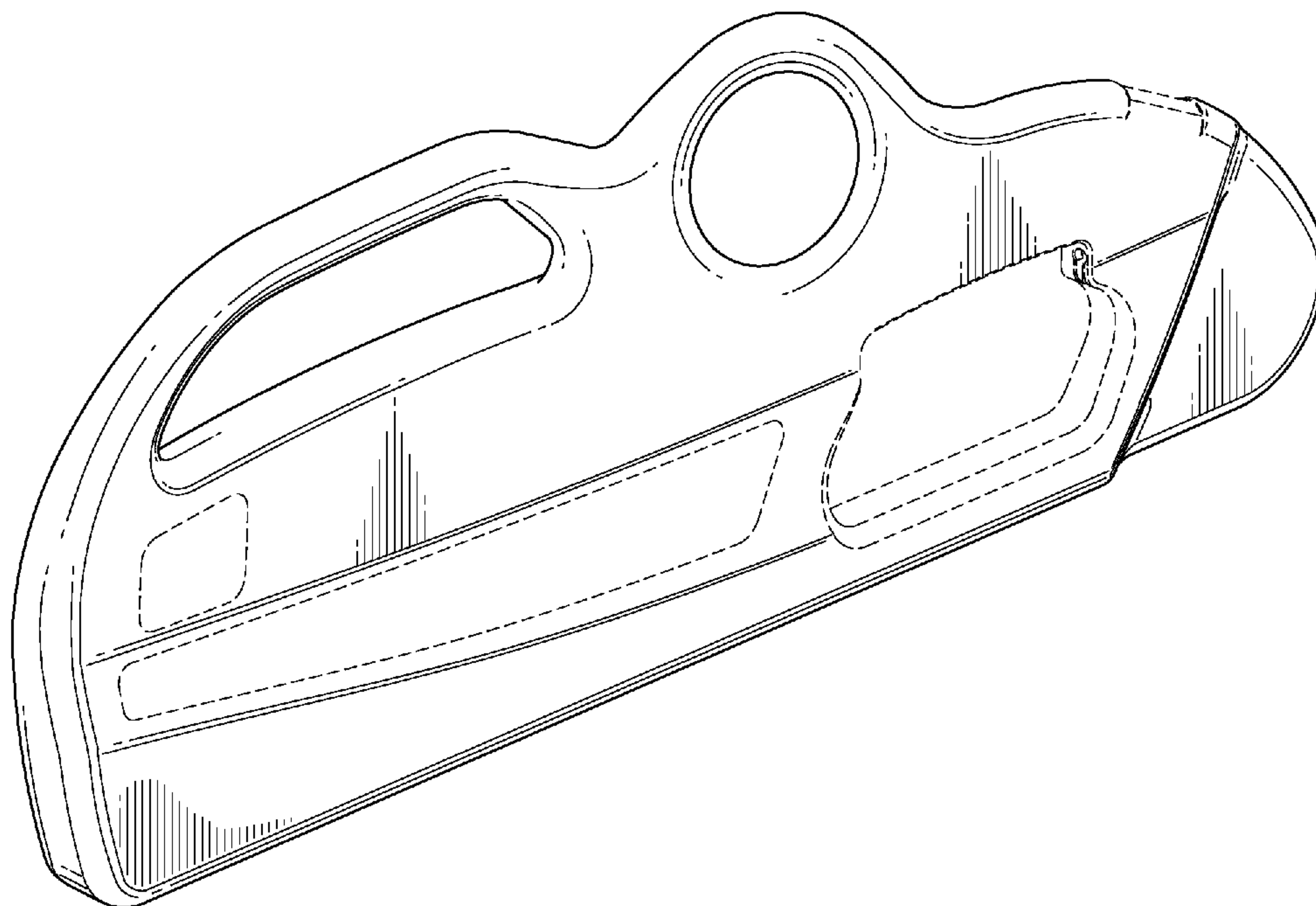
FIG. 1 is a perspective view of a siderail showing a laterally outboard side thereof.

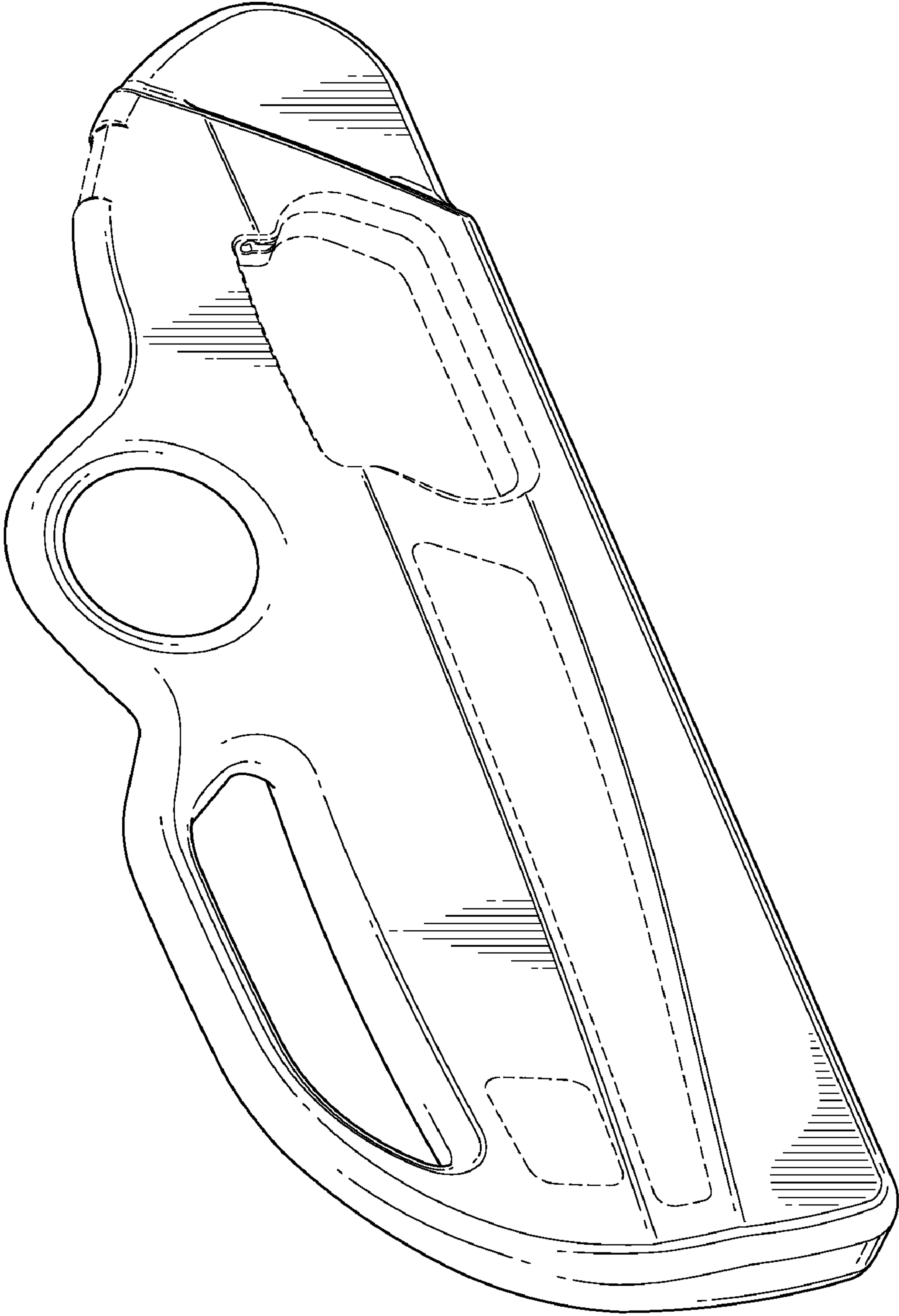

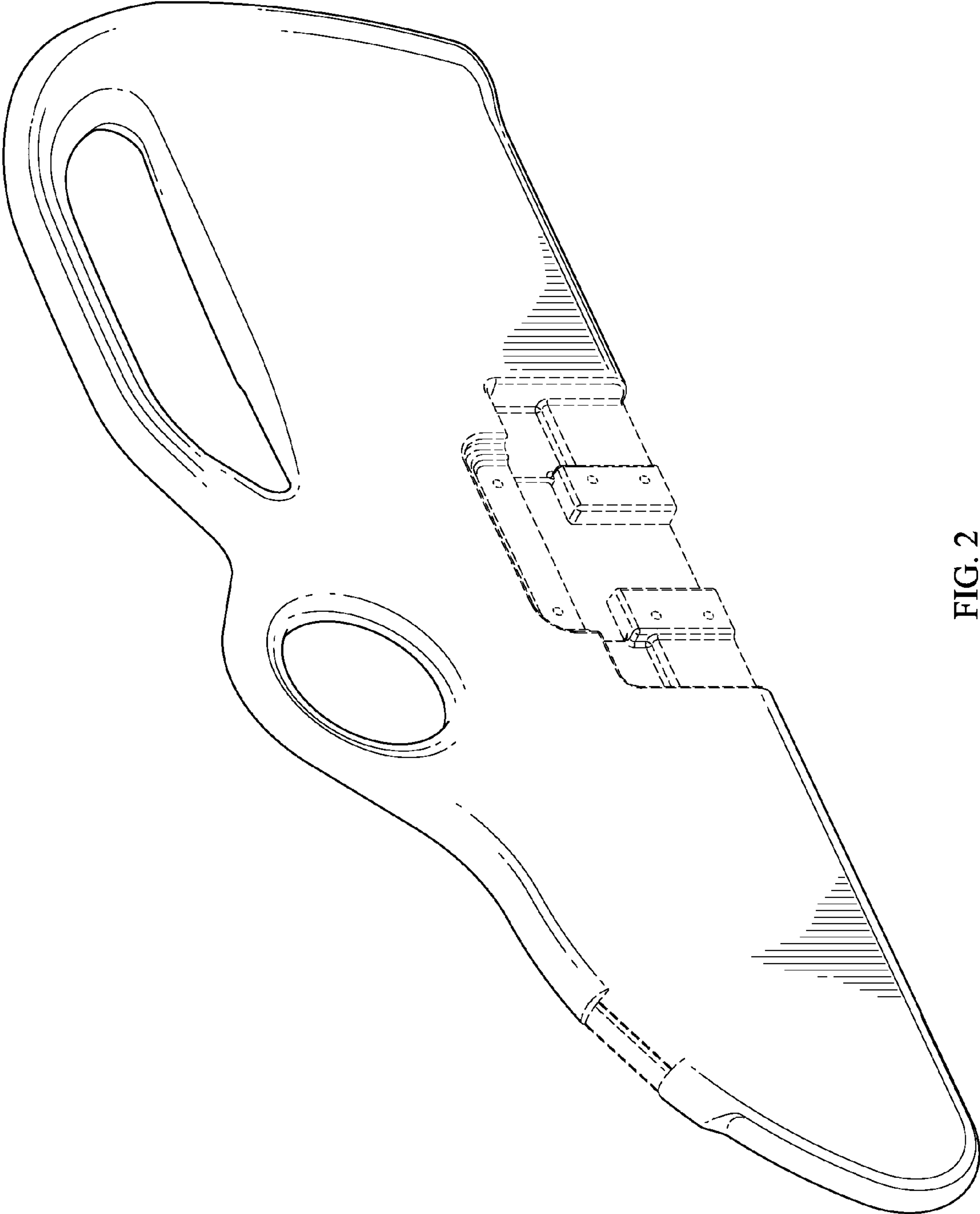

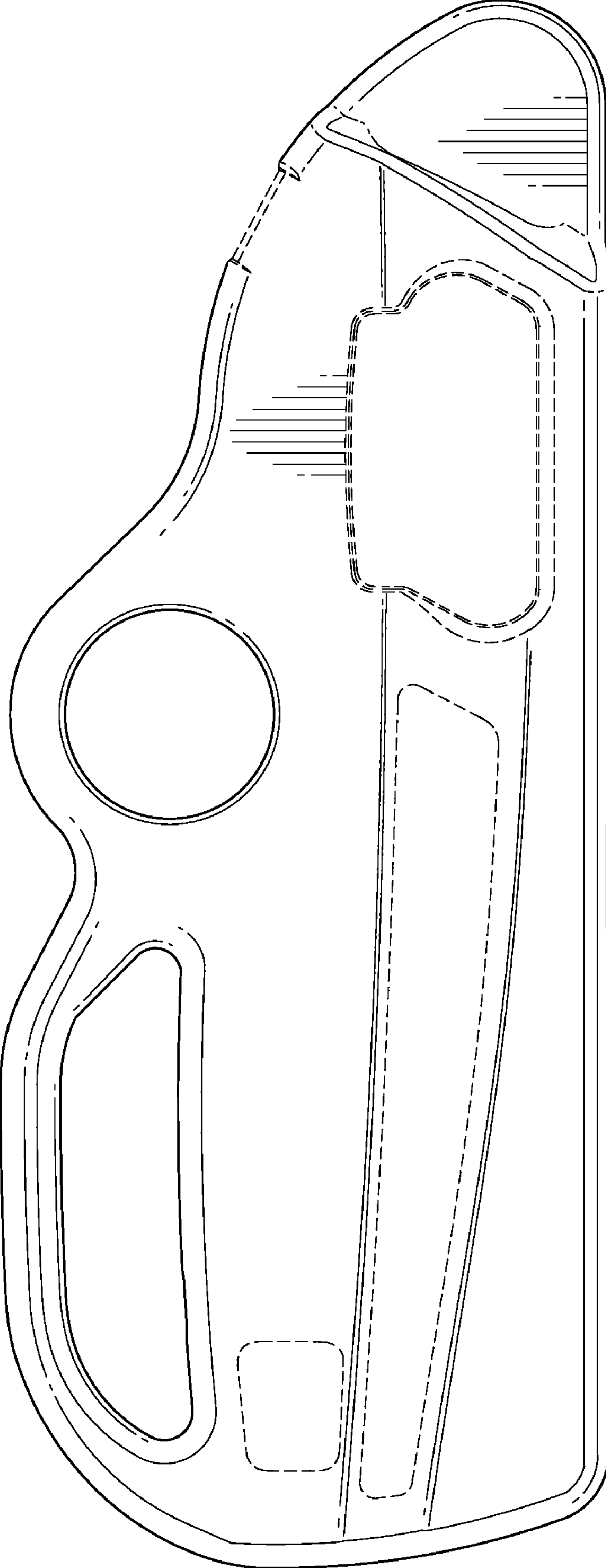

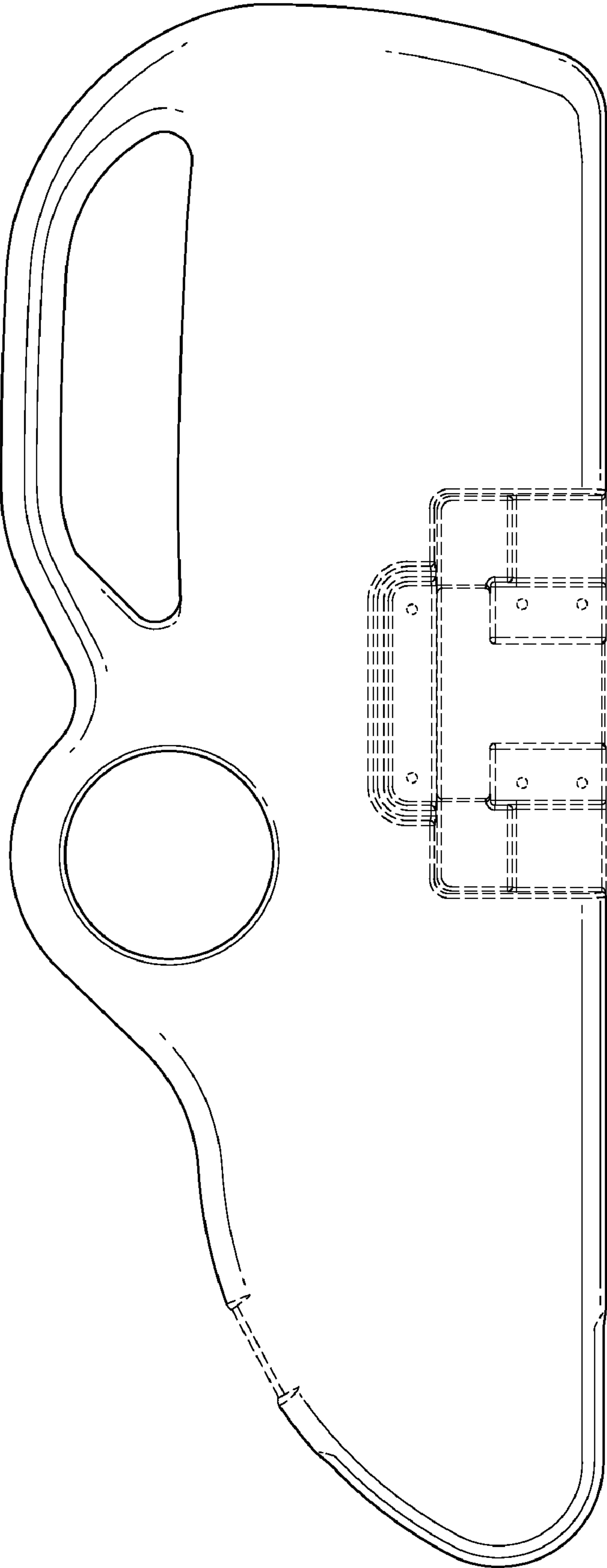
